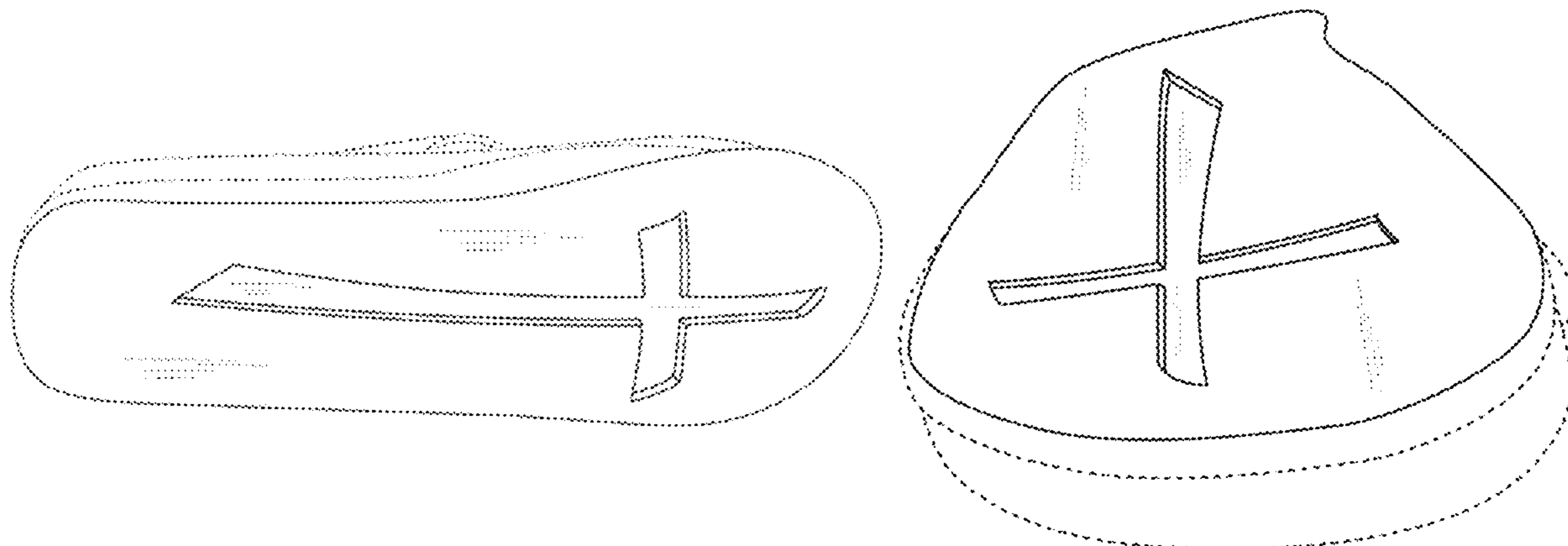
(57) **CLAIM**

I claim the ornamental design for the shoe sole, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom and inside perspective view of the shoe sole in accordance with my new design; FIG. 2 is a bottom and outside perspective view thereof; and, FIG. 3 is a bottom and front perspective view thereof. Broken lines in the figures are for purposes of illustrating portions of the shoe sole and environment that form no part of the claimed design.

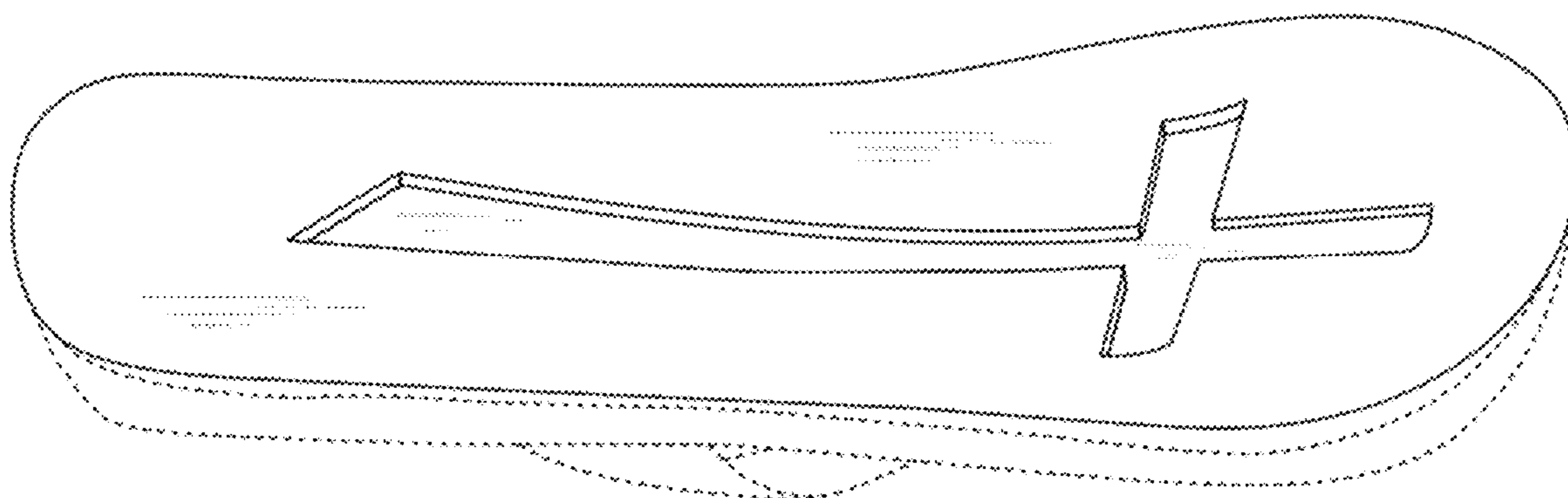

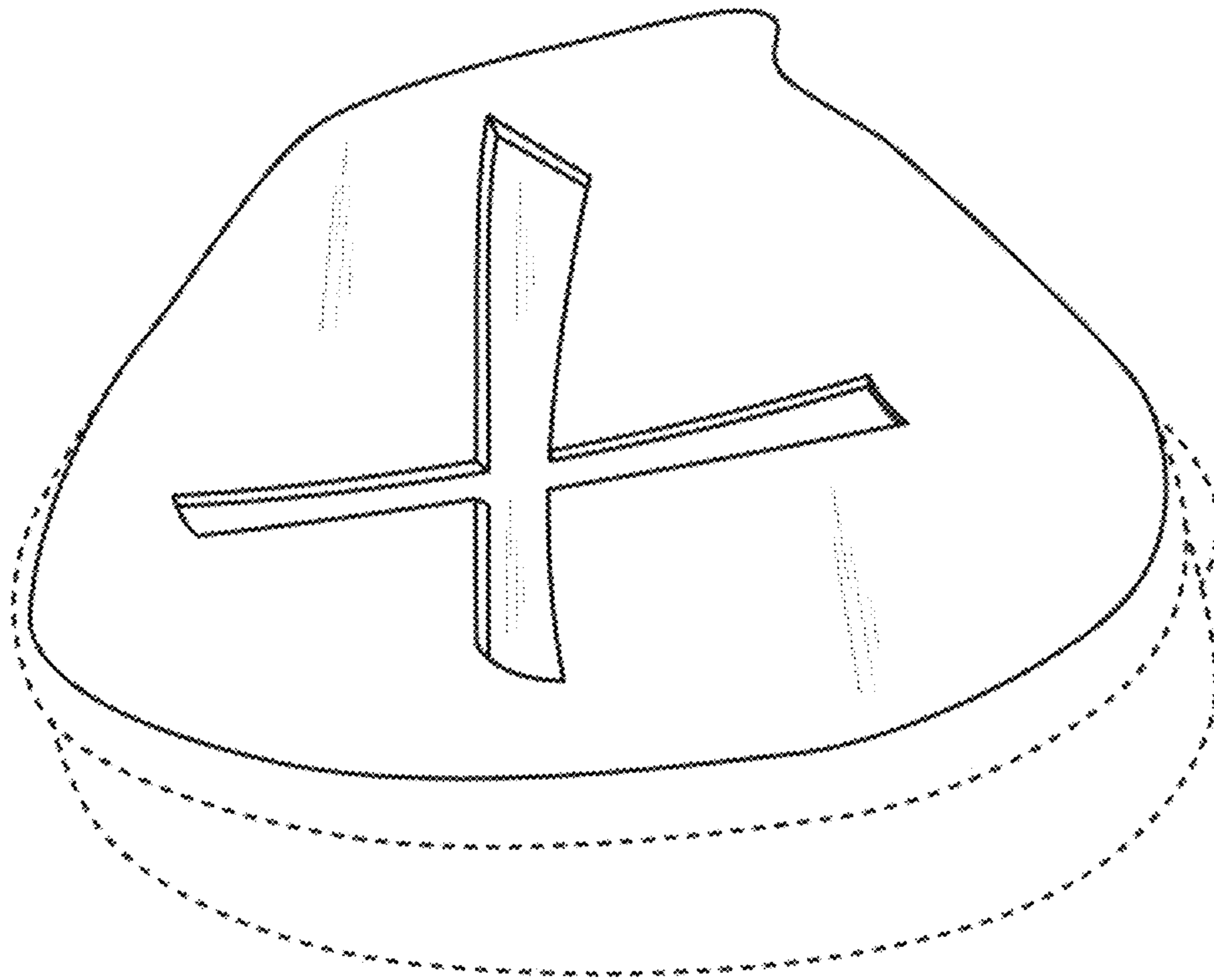
