**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe showing our new design;

FIG. 2 is a bottom view thereof;

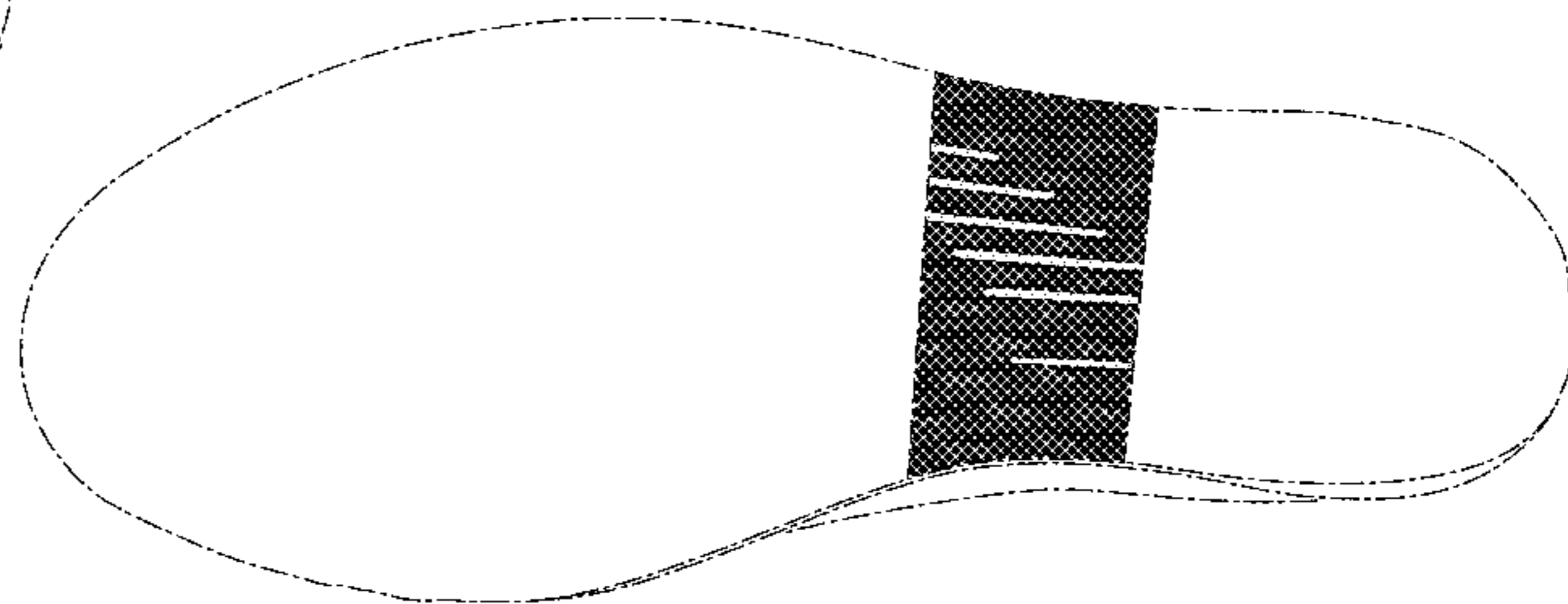
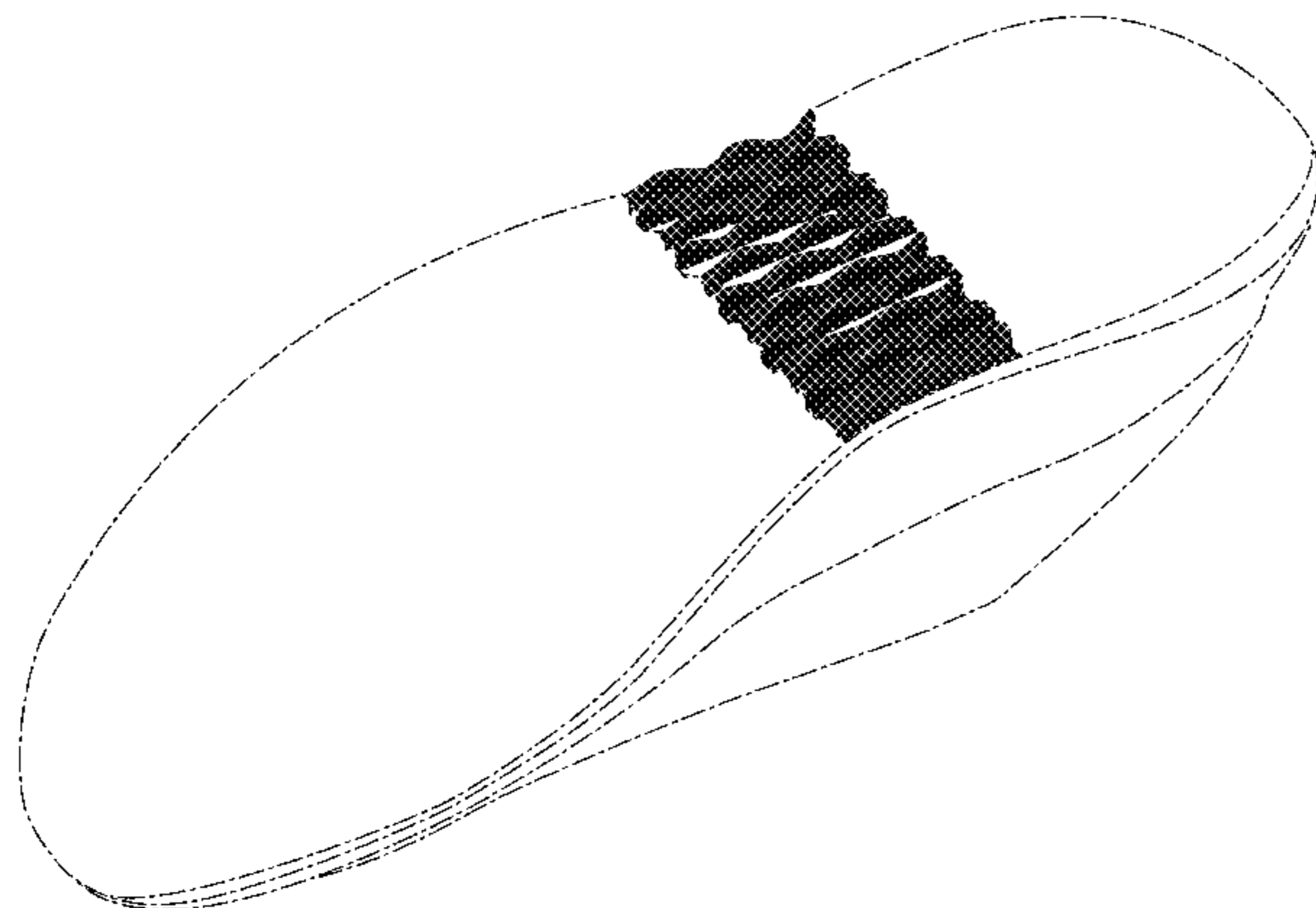
FIG. 3 is a rear perspective view thereof;

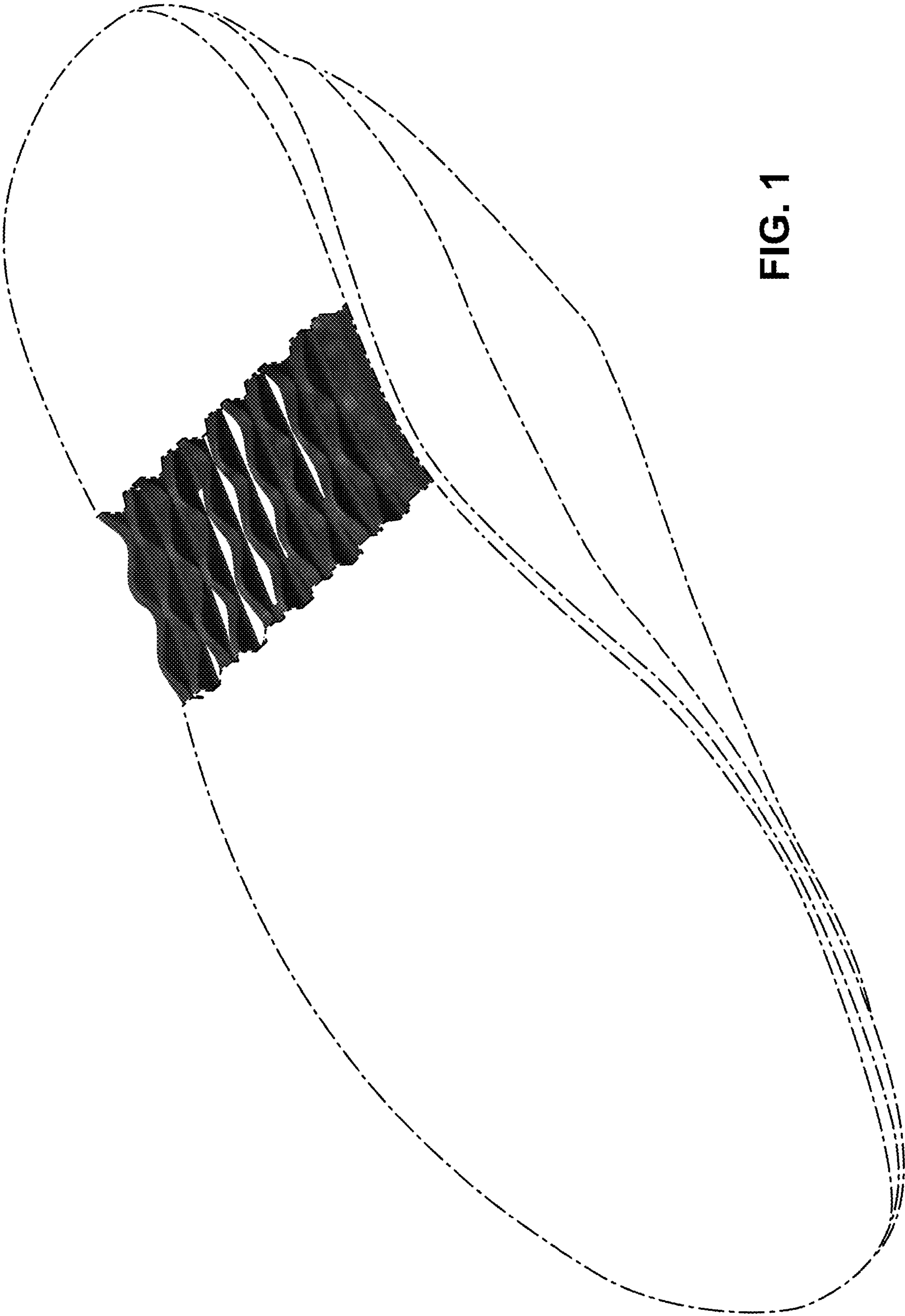

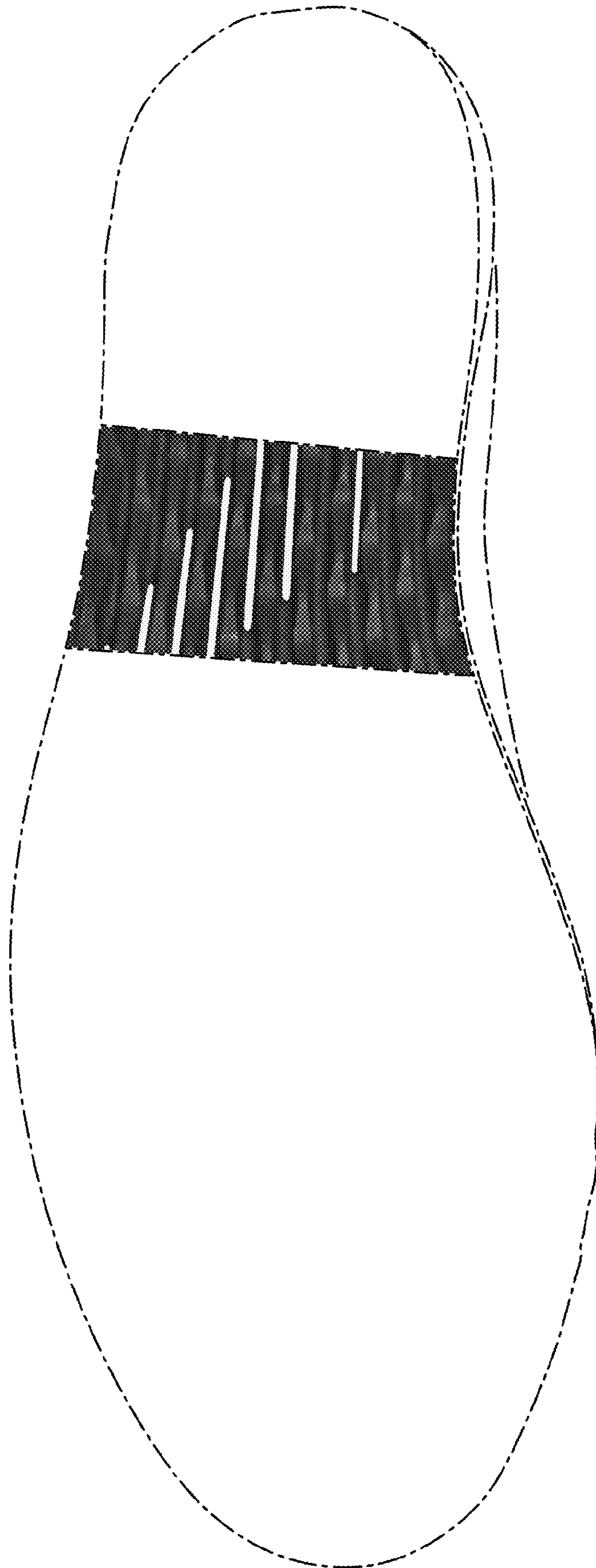

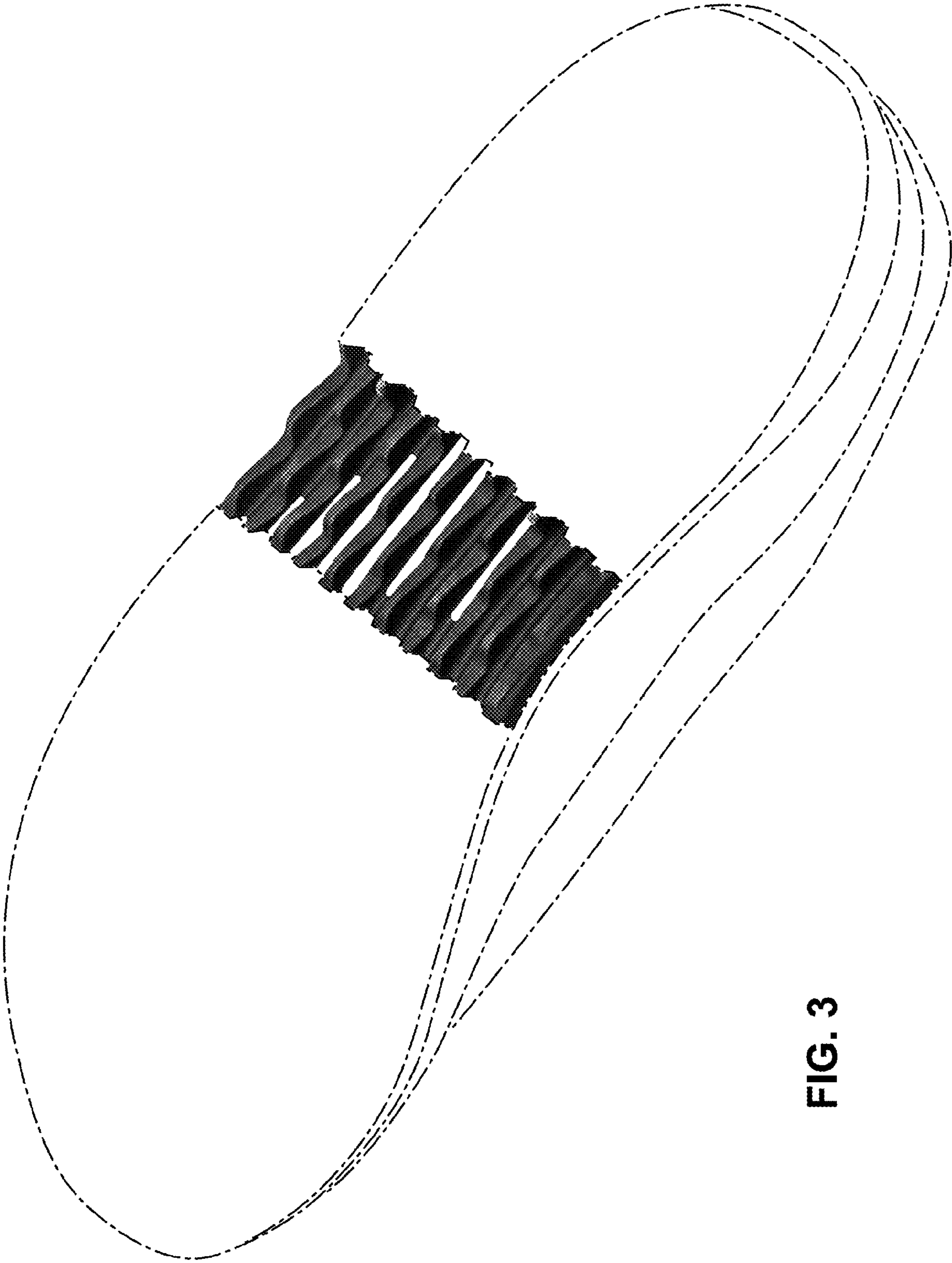

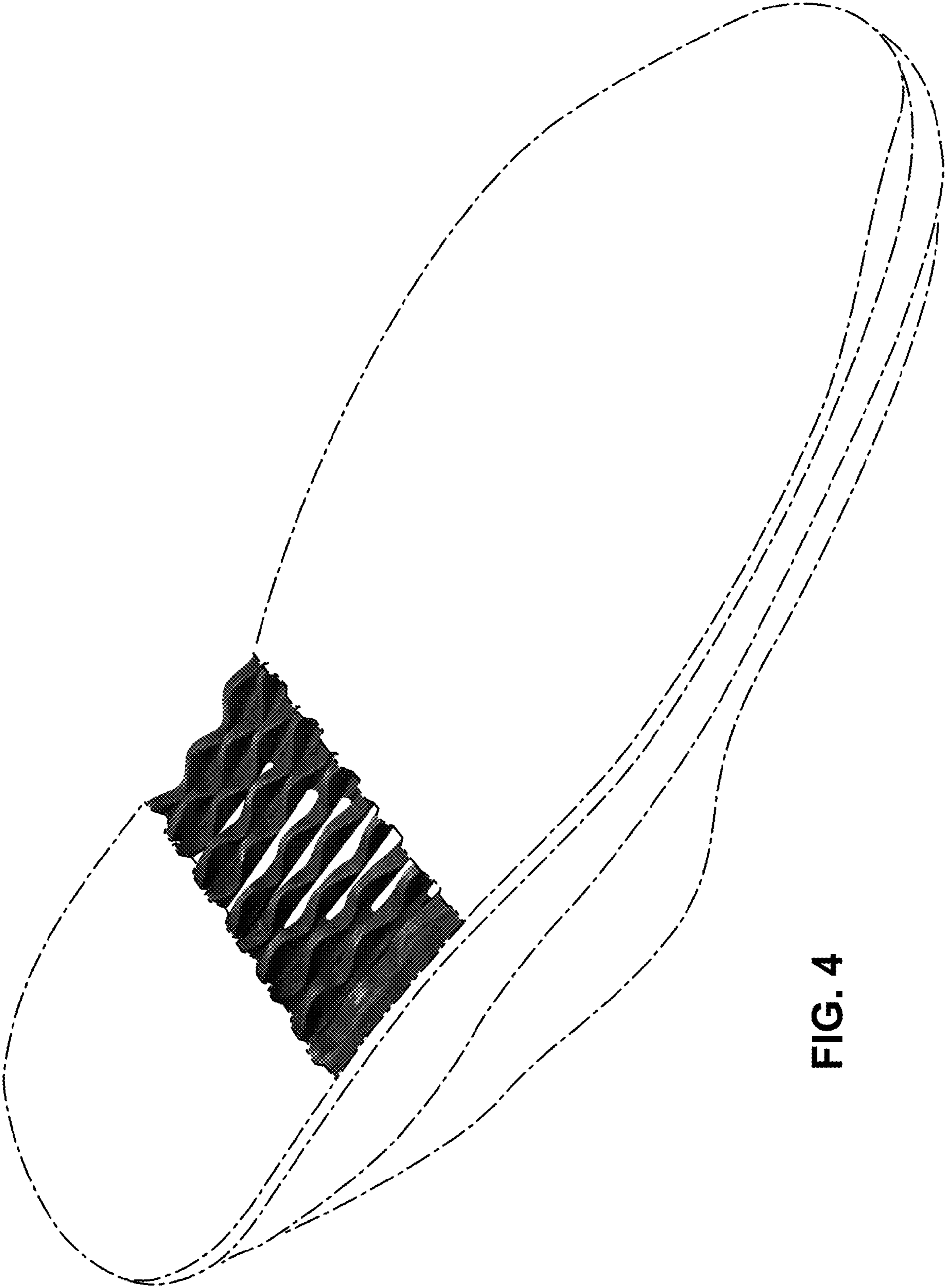

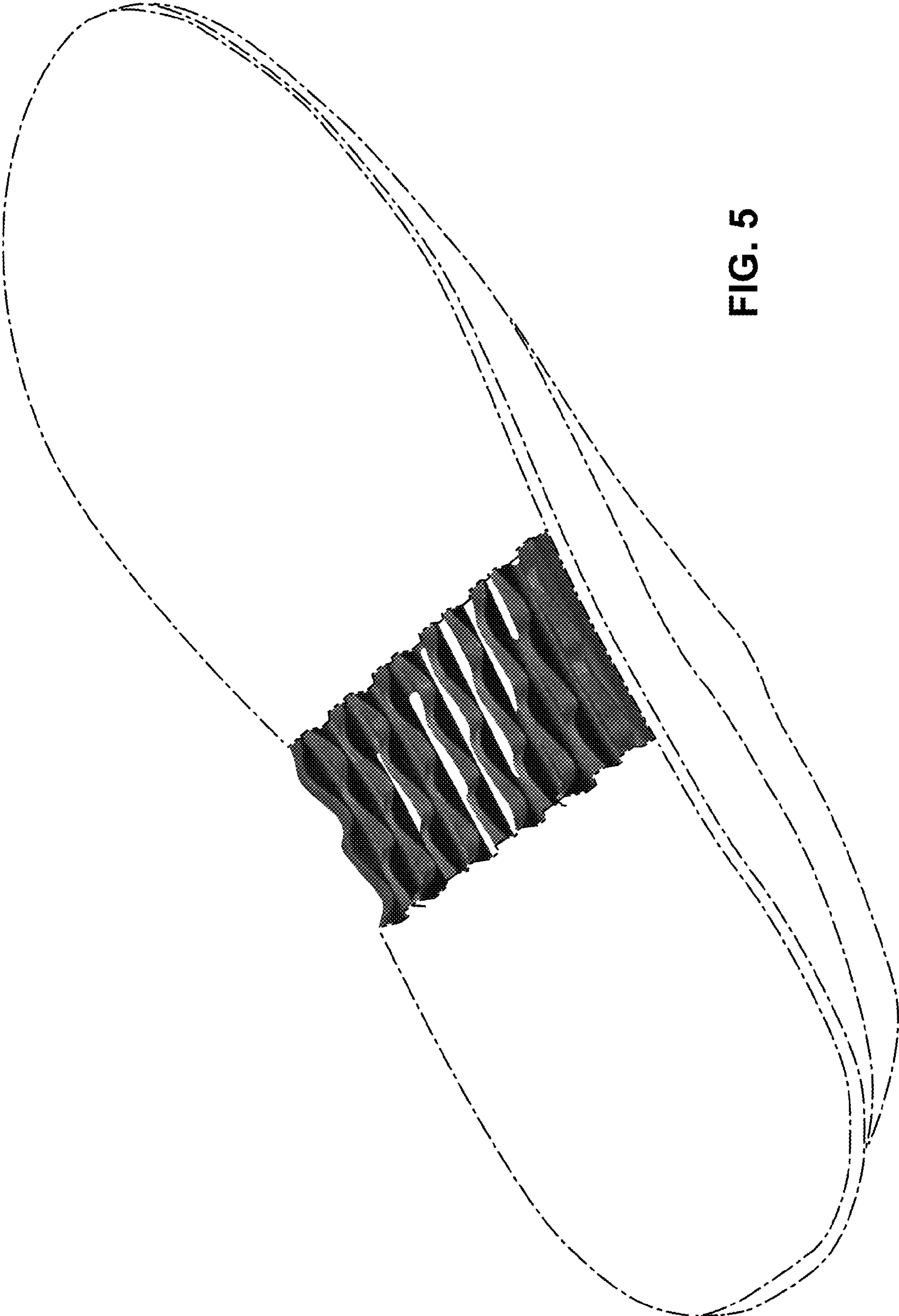
