FIG. 4 is a front perspective view thereof.

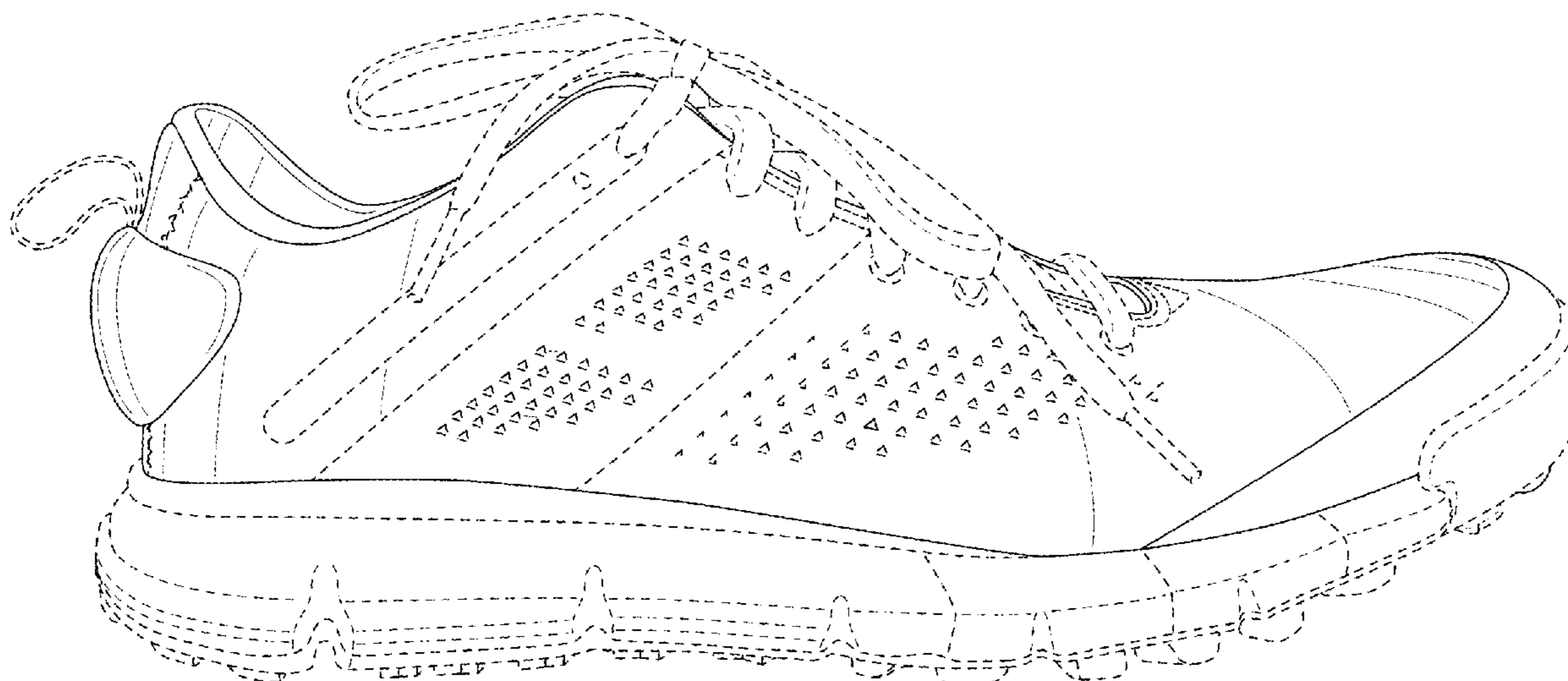
FIG. 5 is a rear perspective view thereof.

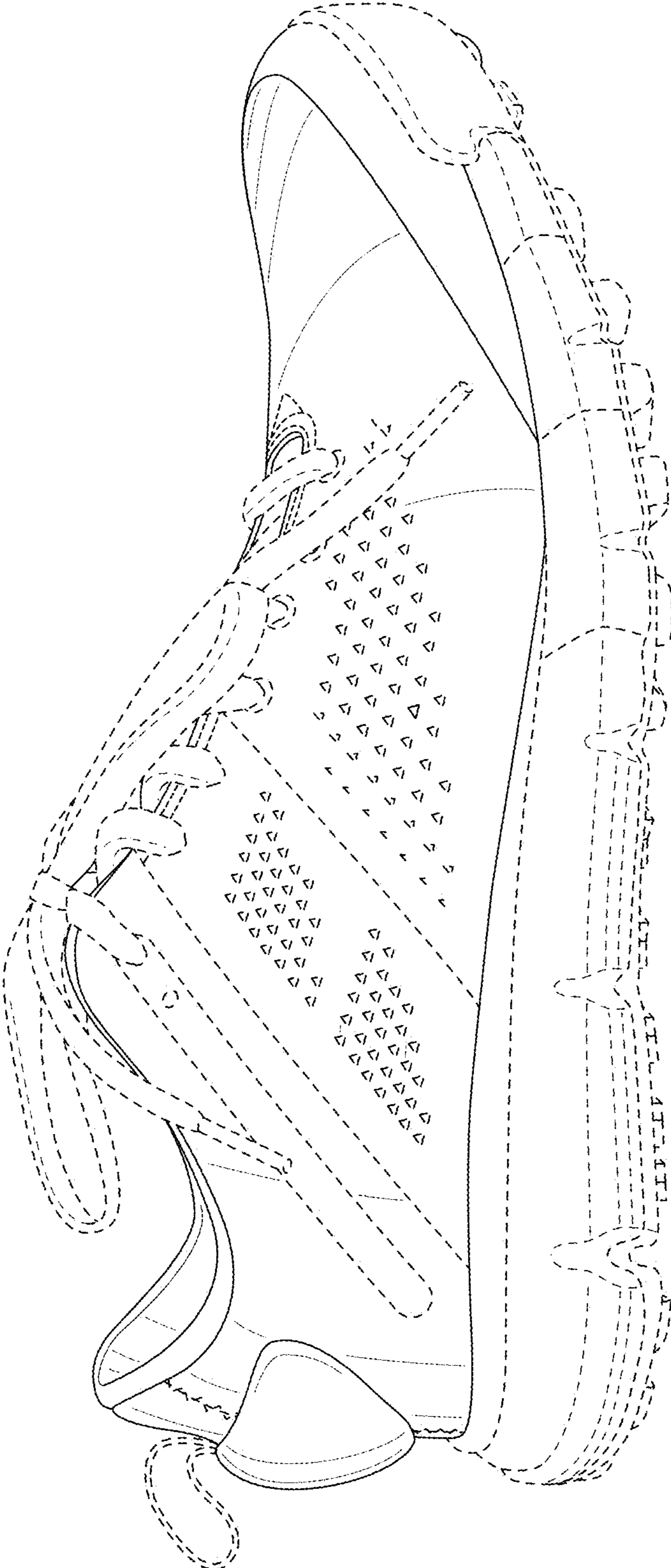
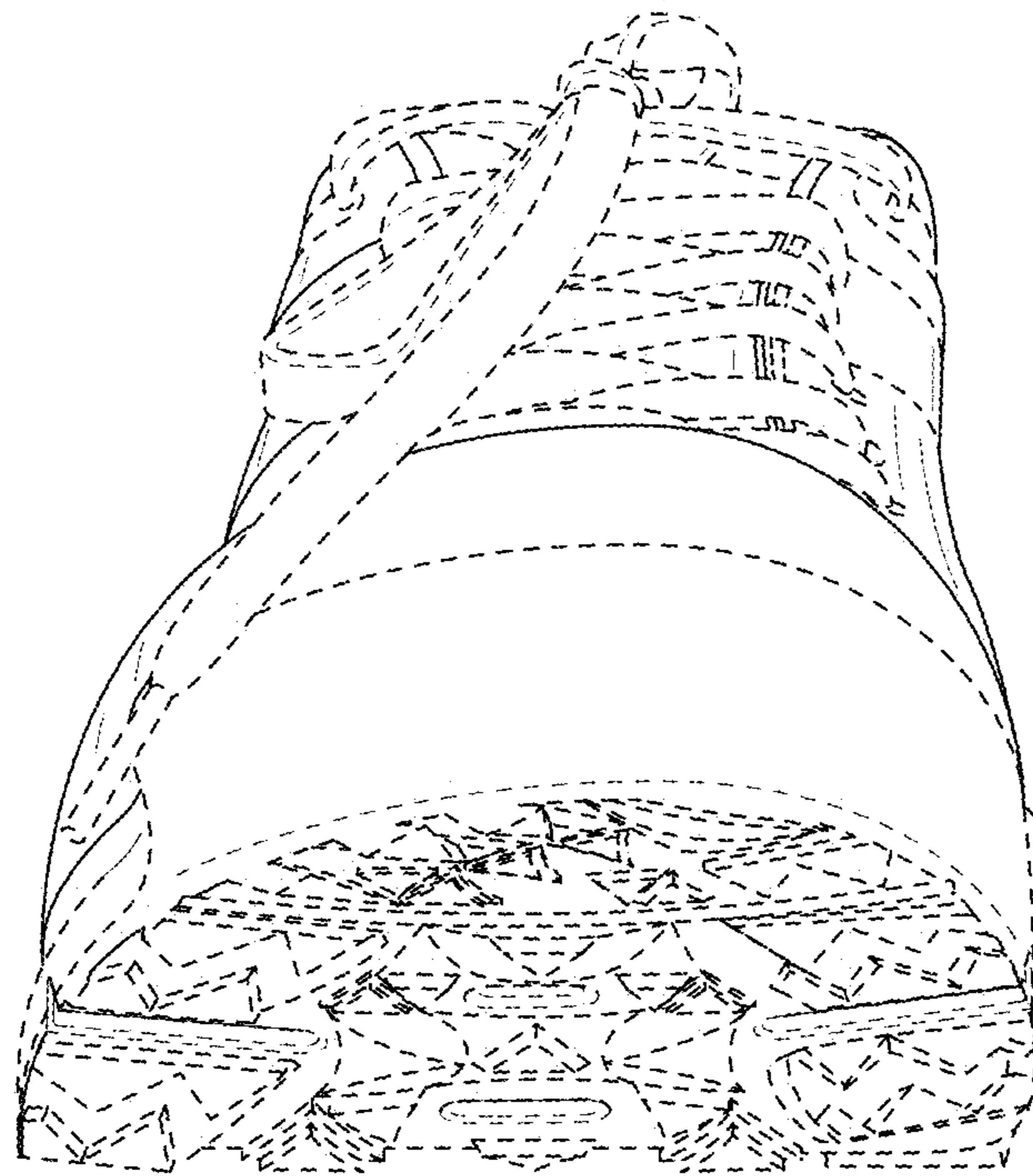


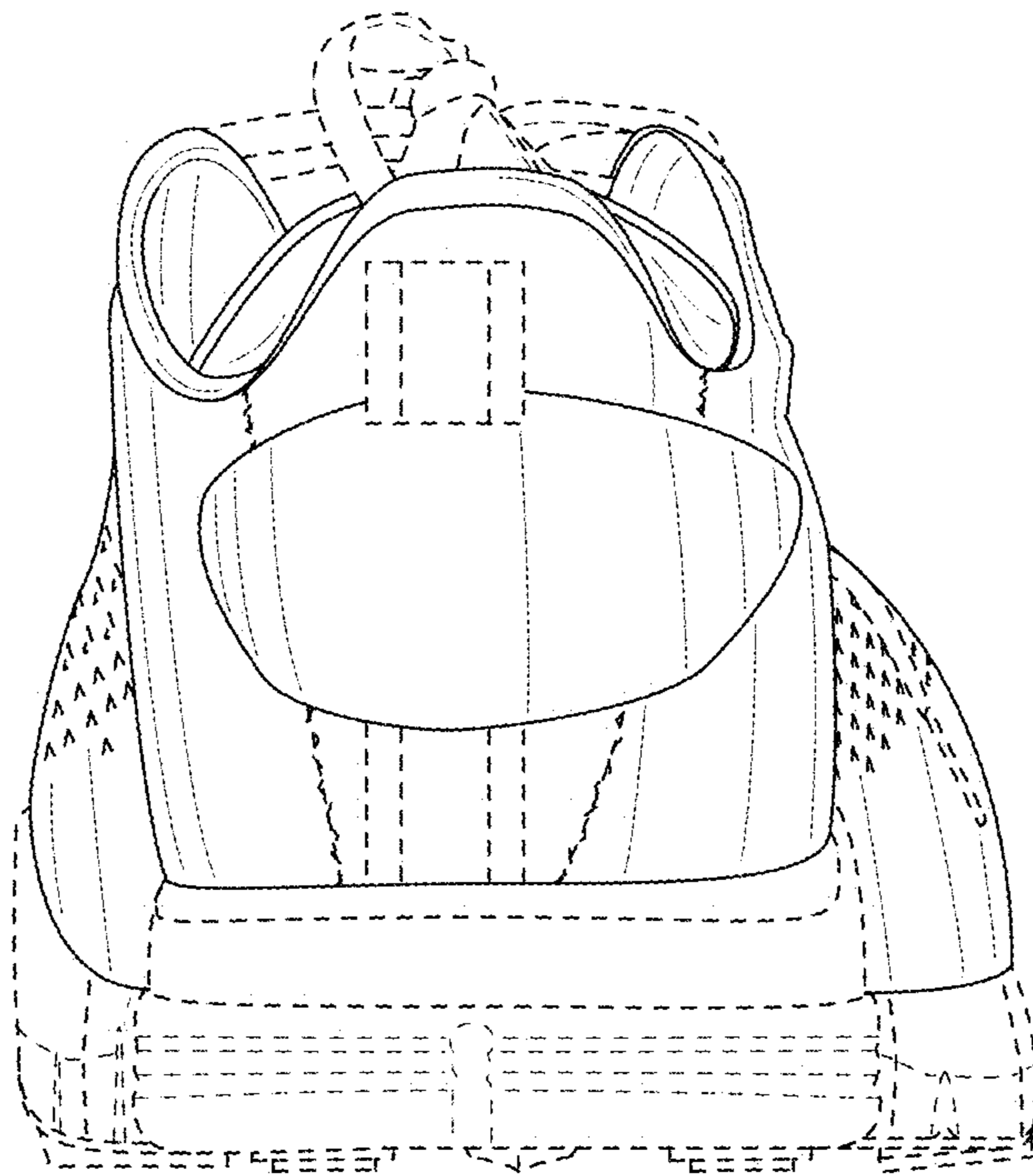

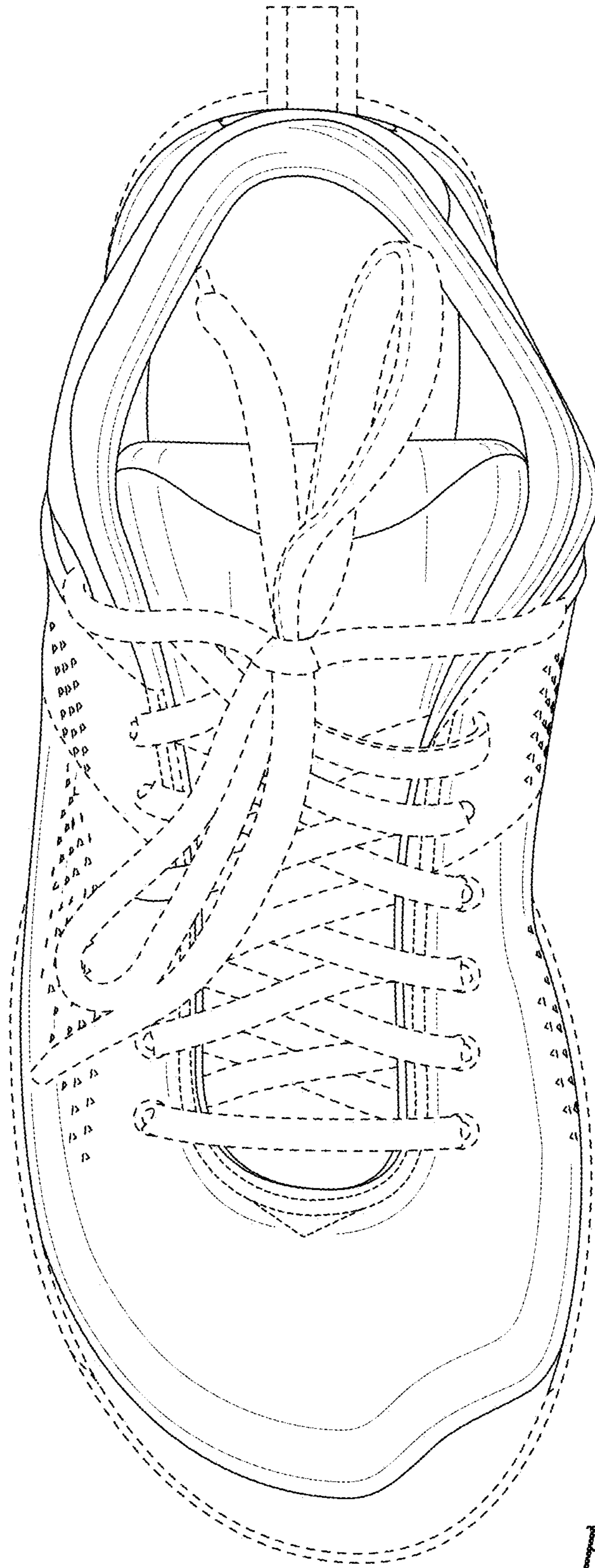

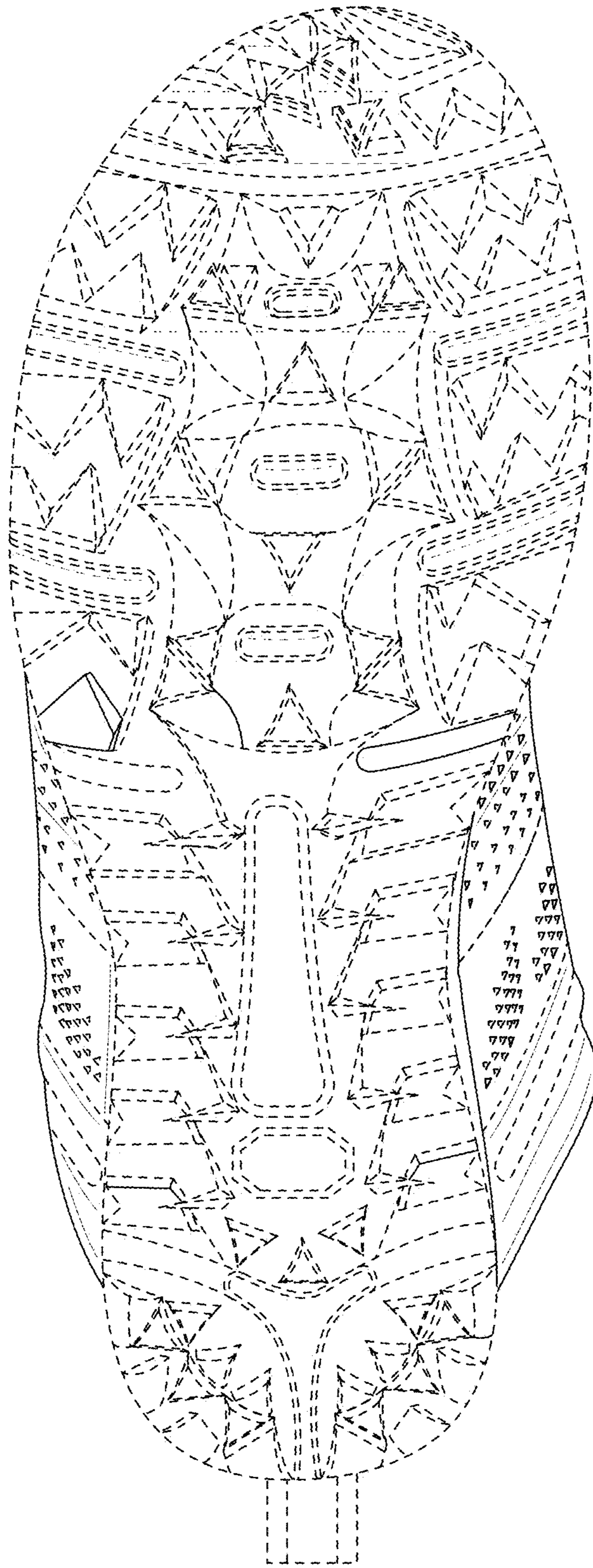
