I claim the ornamental design for a pet carrier, as shown and described.

FIG. 5 shows a left side perspective view thereof, with the straps shown in a fourth position;

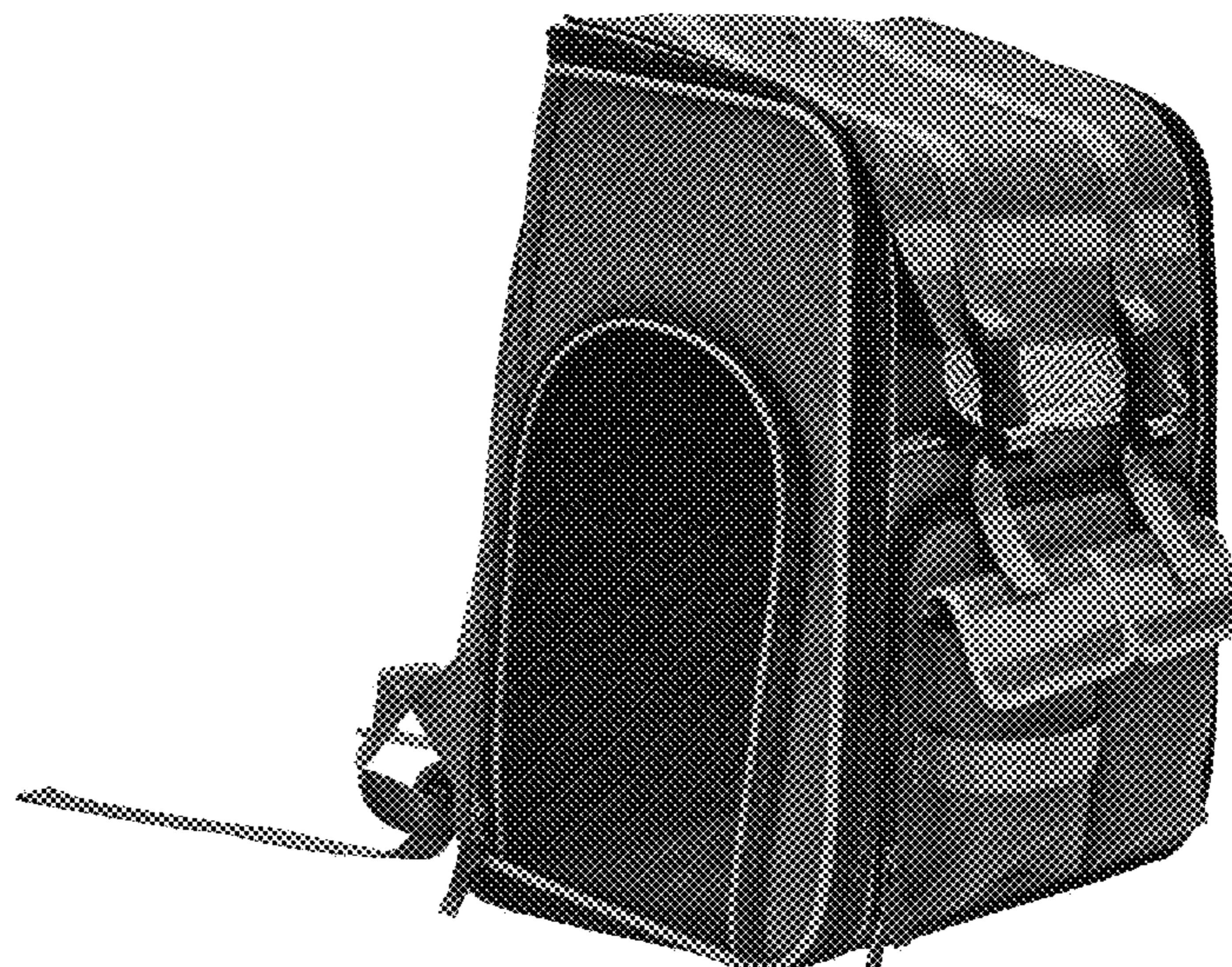
FIG. 6 shows a top perspective view thereof, with the straps shown in a fifth position;

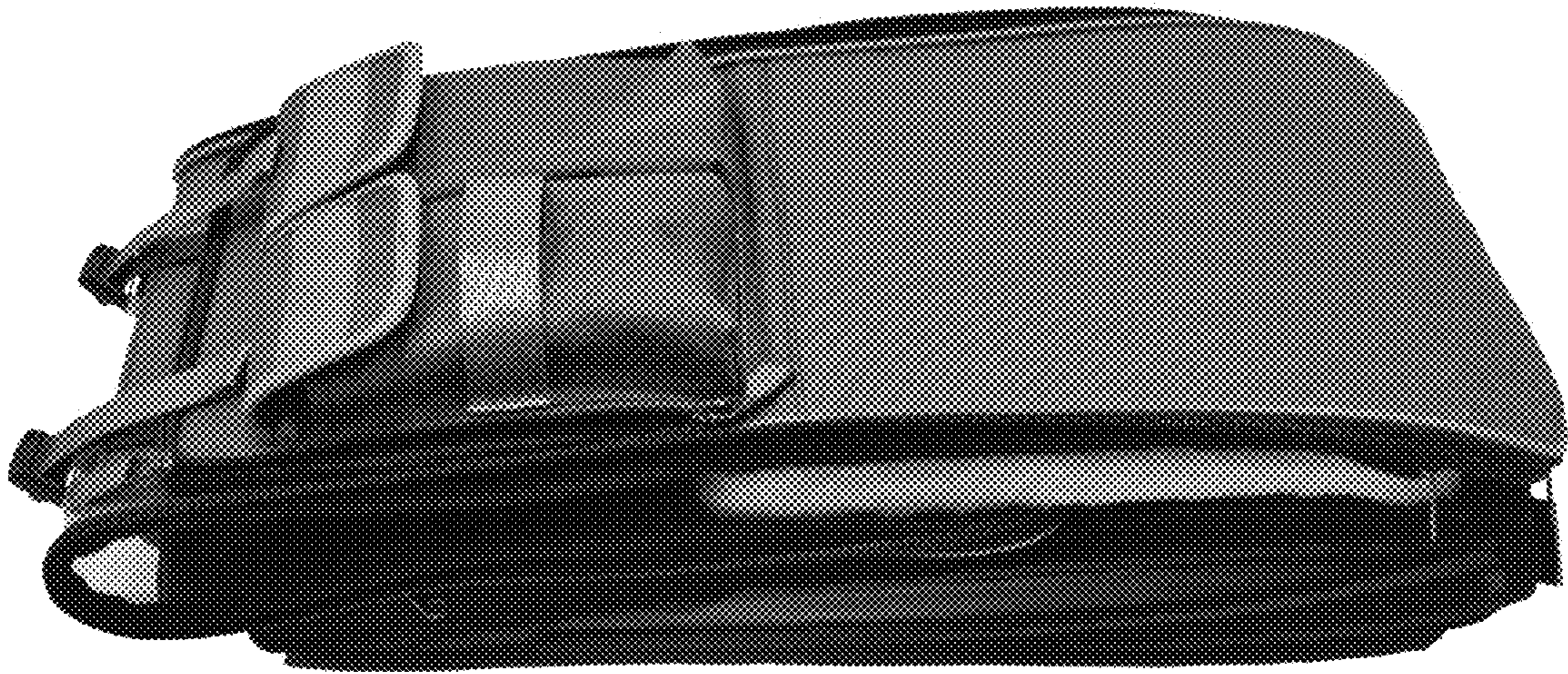
