(57) **CLAIM**

The ornamental design for a bag for storage of vacuum cleaner accessories, as shown and described.

**DESCRIPTION**

1. Bag for storage of vacuum cleaner accessories  
Figure 1.1 is a front perspective view of the bag for storage of vacuum cleaner accessories showing our new design;  
Figure 1.2 is a front view thereof;  
Figure 1.3 is a back view thereof;  
Figure 1.4 is a left side view thereof;  
Figure 1.5 is a right side view thereof;  
Figure 1.6 is a top plan view thereof;  
Figure 1.7 is a bottom plan view thereof; and  
Figure 1.8 is a front perspective thereof, with the cover of the bag shown in an open condition of use.

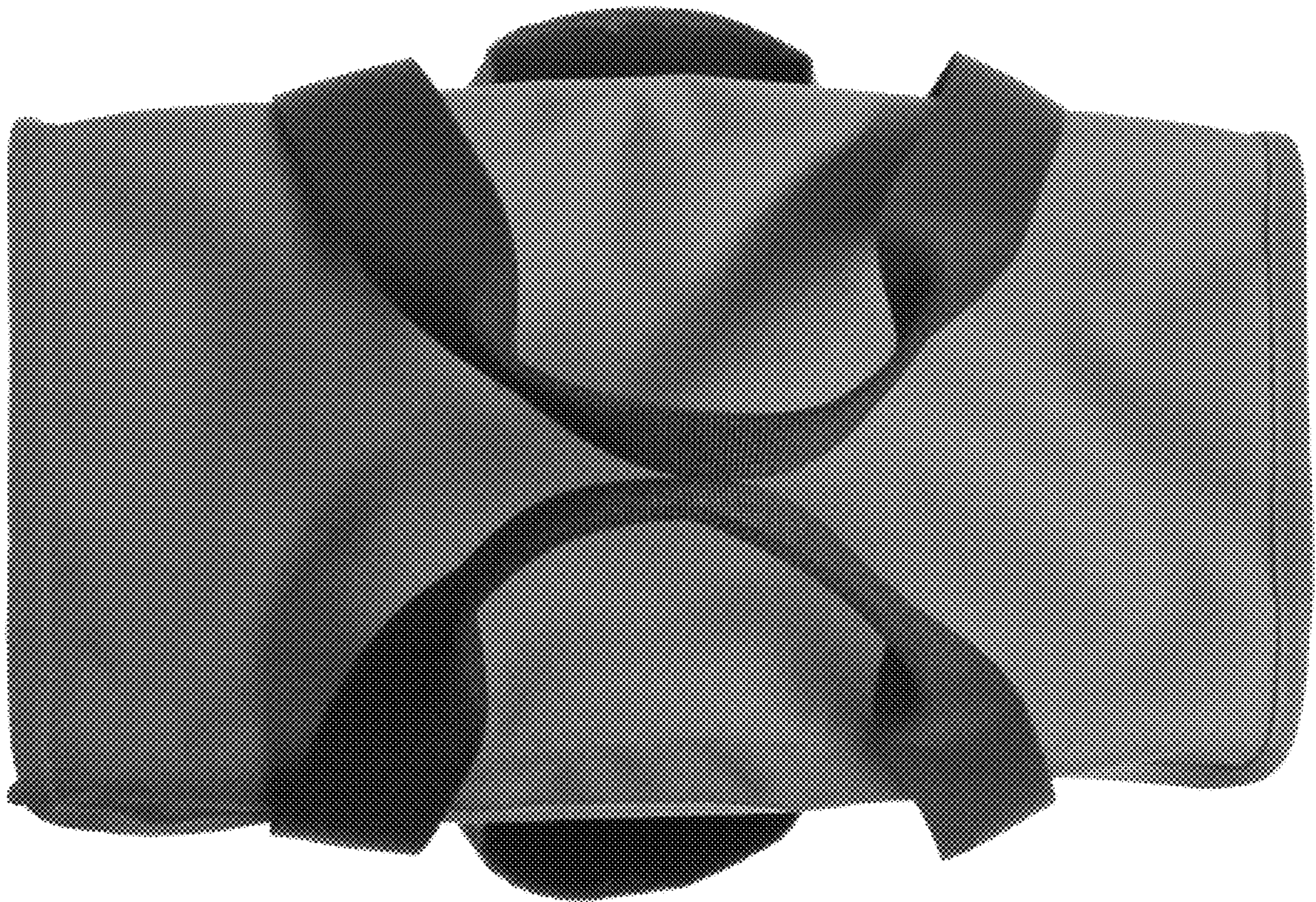
