(57) **CLAIM**

The ornamental design for a pet sanitation bag and accessory caddy, as shown and described.

**DESCRIPTION**

FIG. 11 is a top plan view thereof.

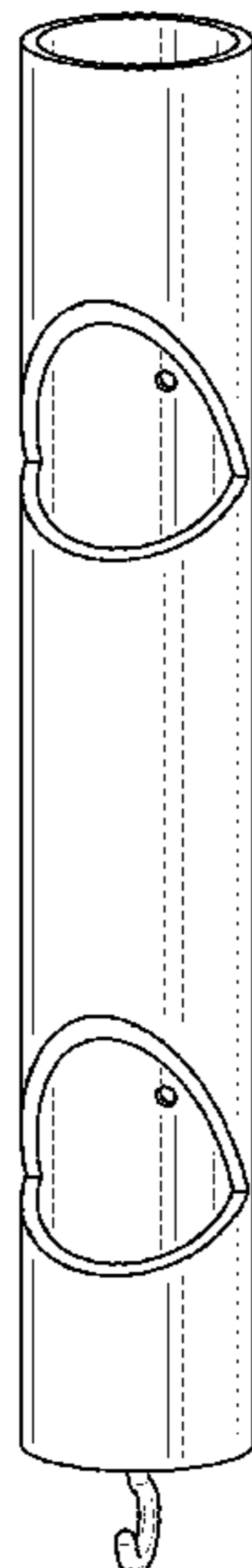
FIG. 12 is a bottom plan view thereof.

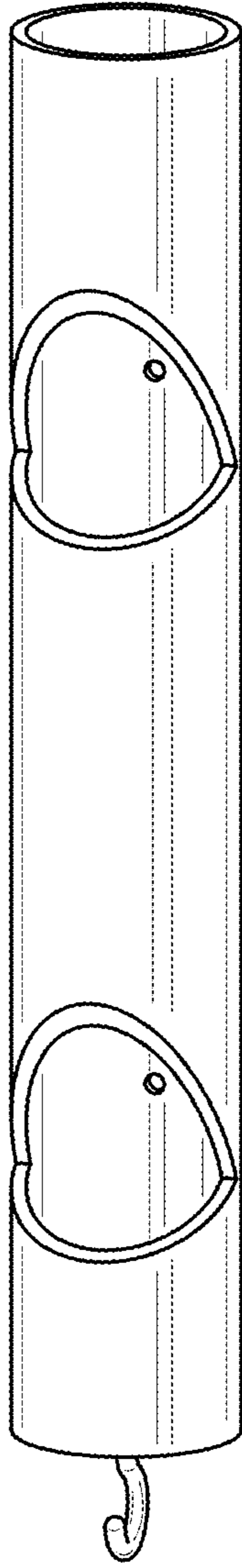
FIG. 13 is a left side elevational view thereof; and,

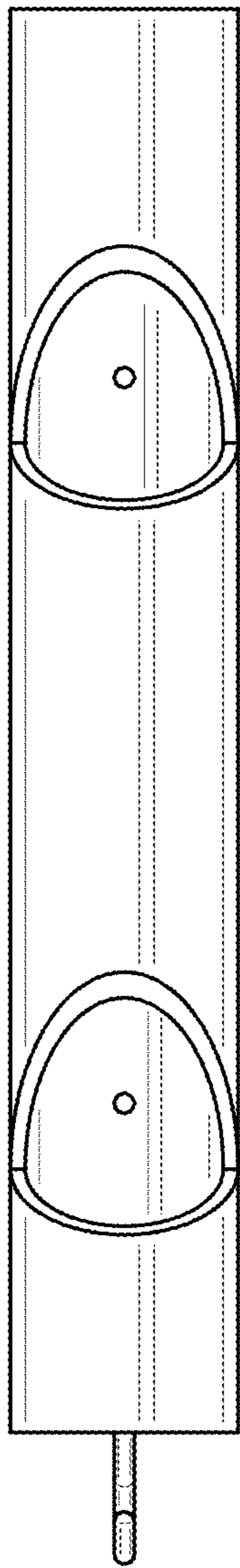

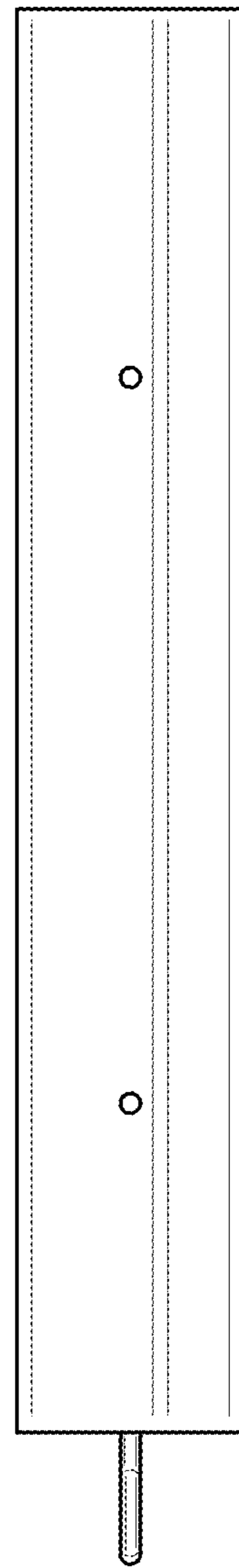
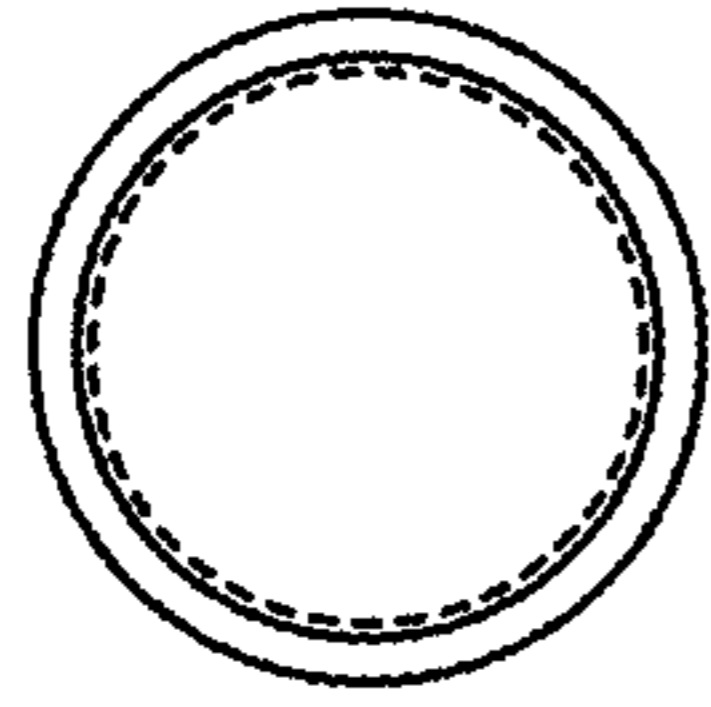
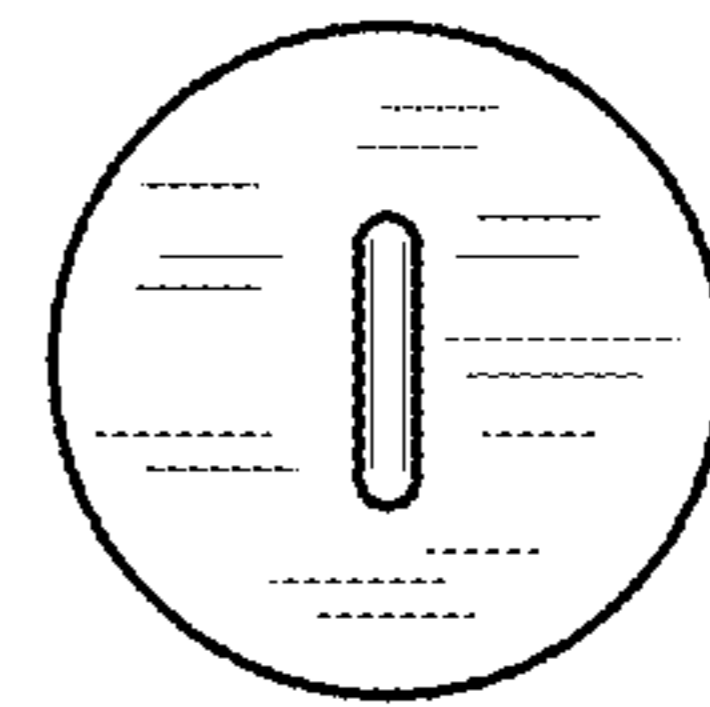

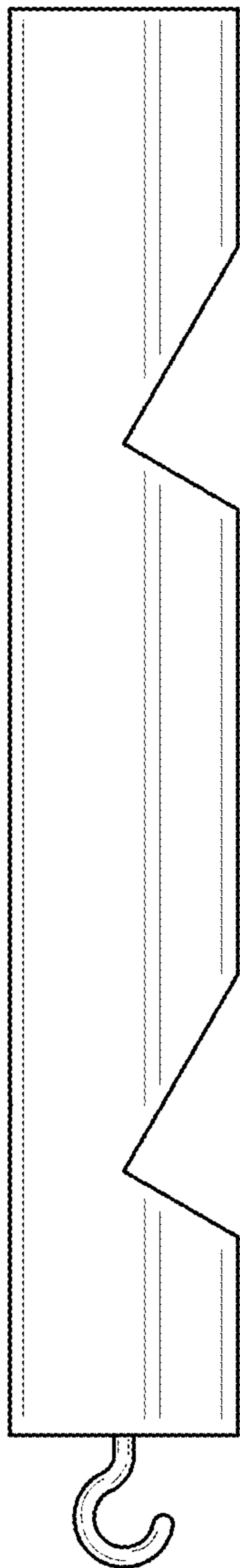

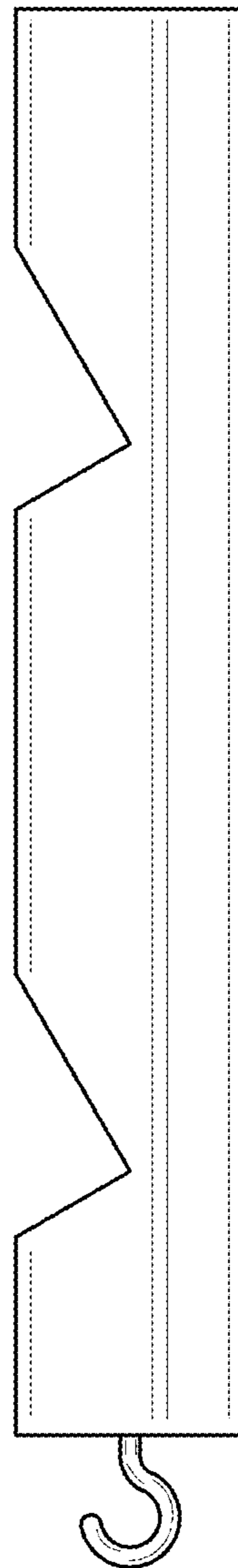

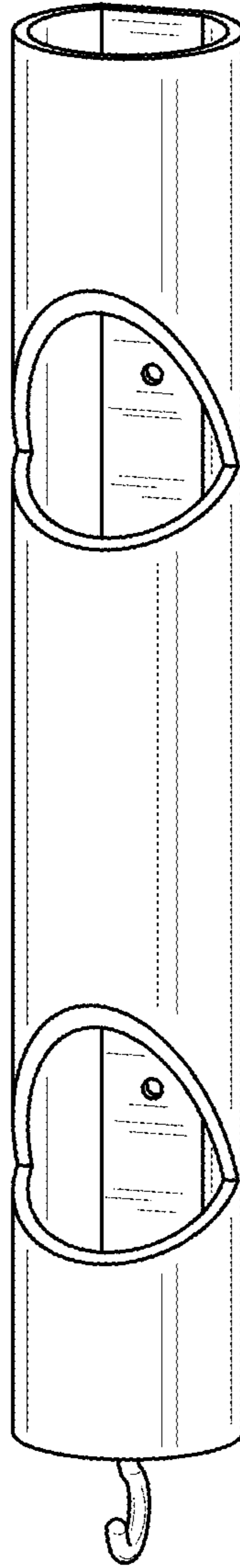

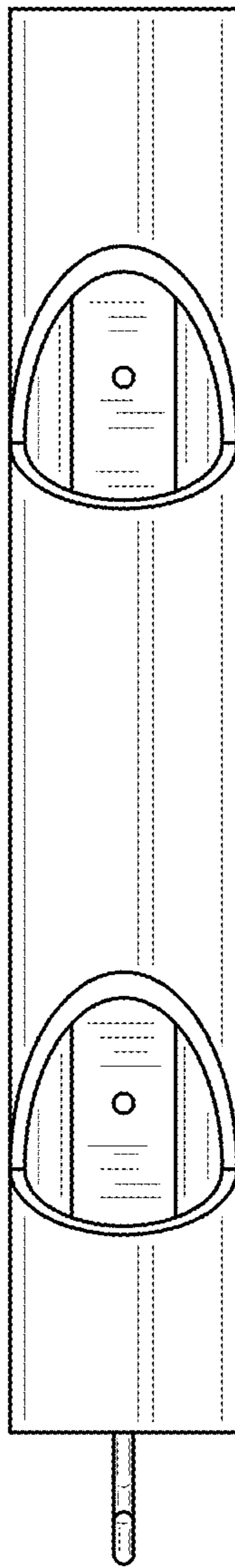

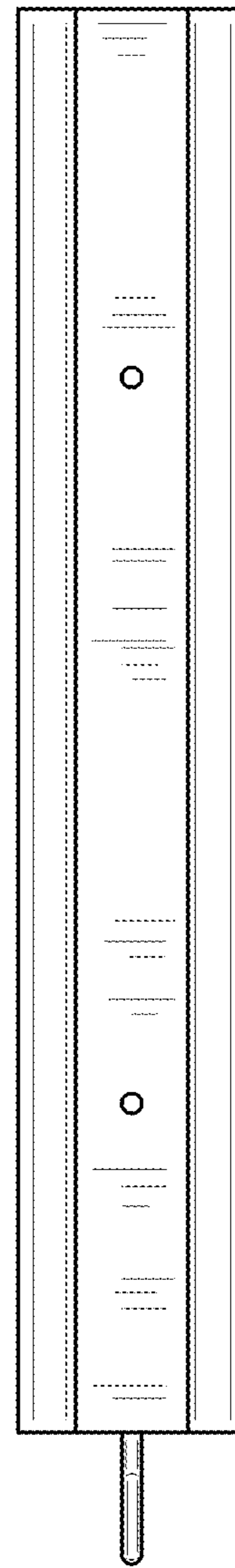

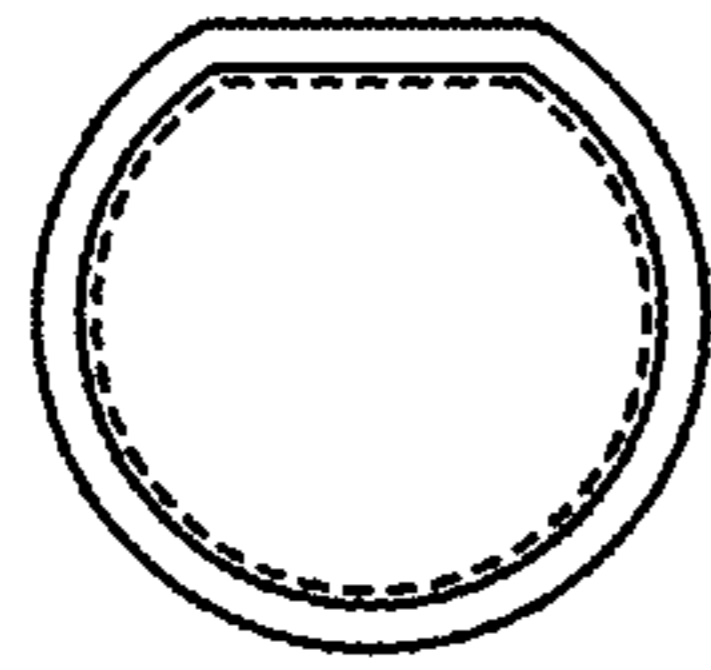

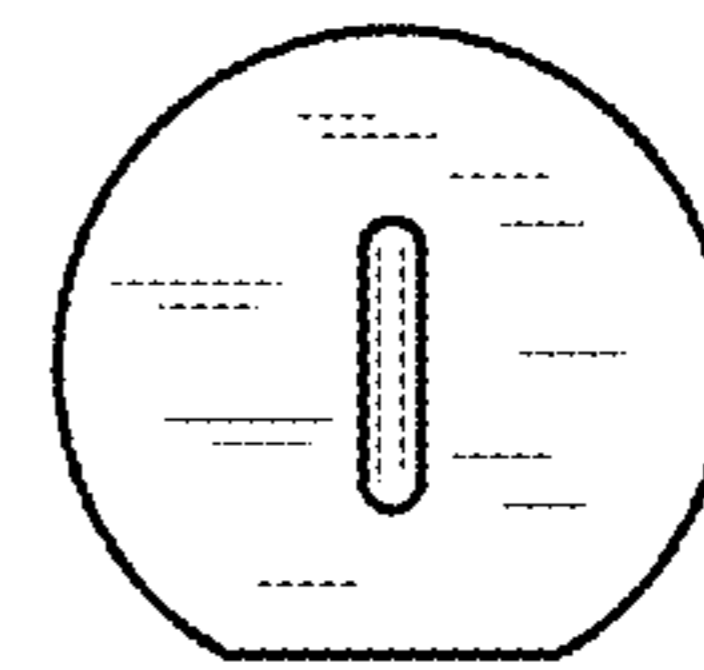

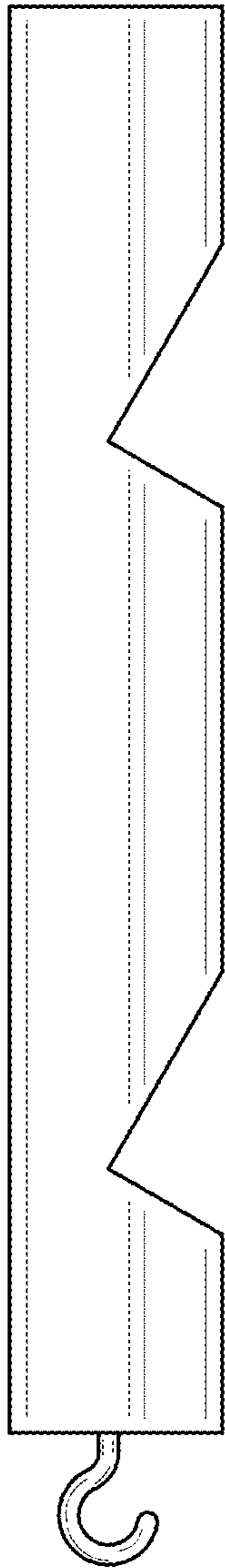

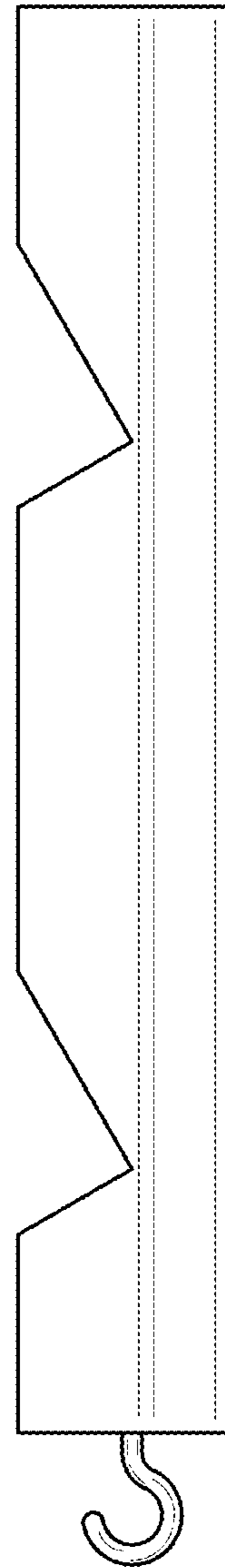
