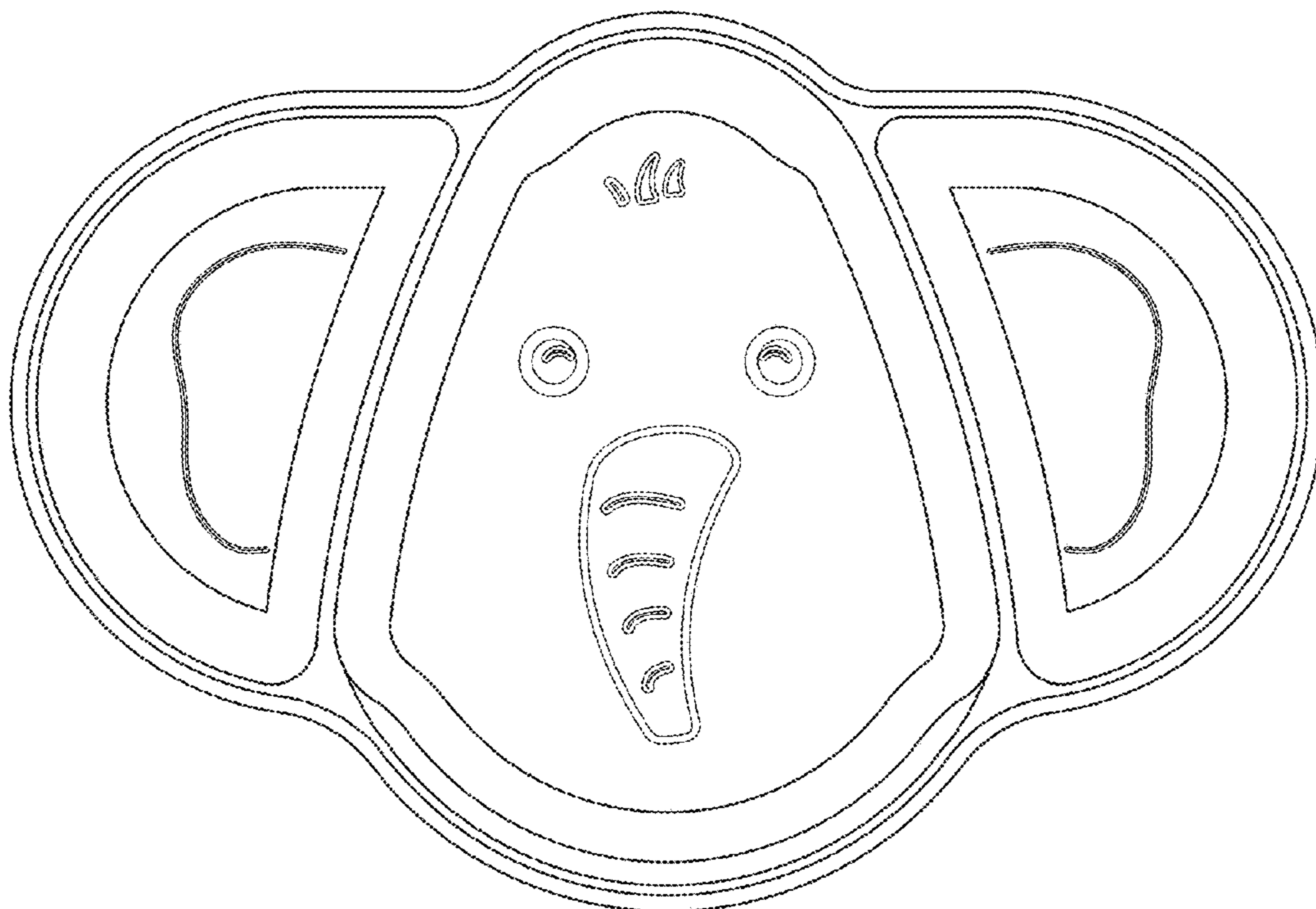
FIG. 1 is a front elevational view of a placemat with suction showing my new design;

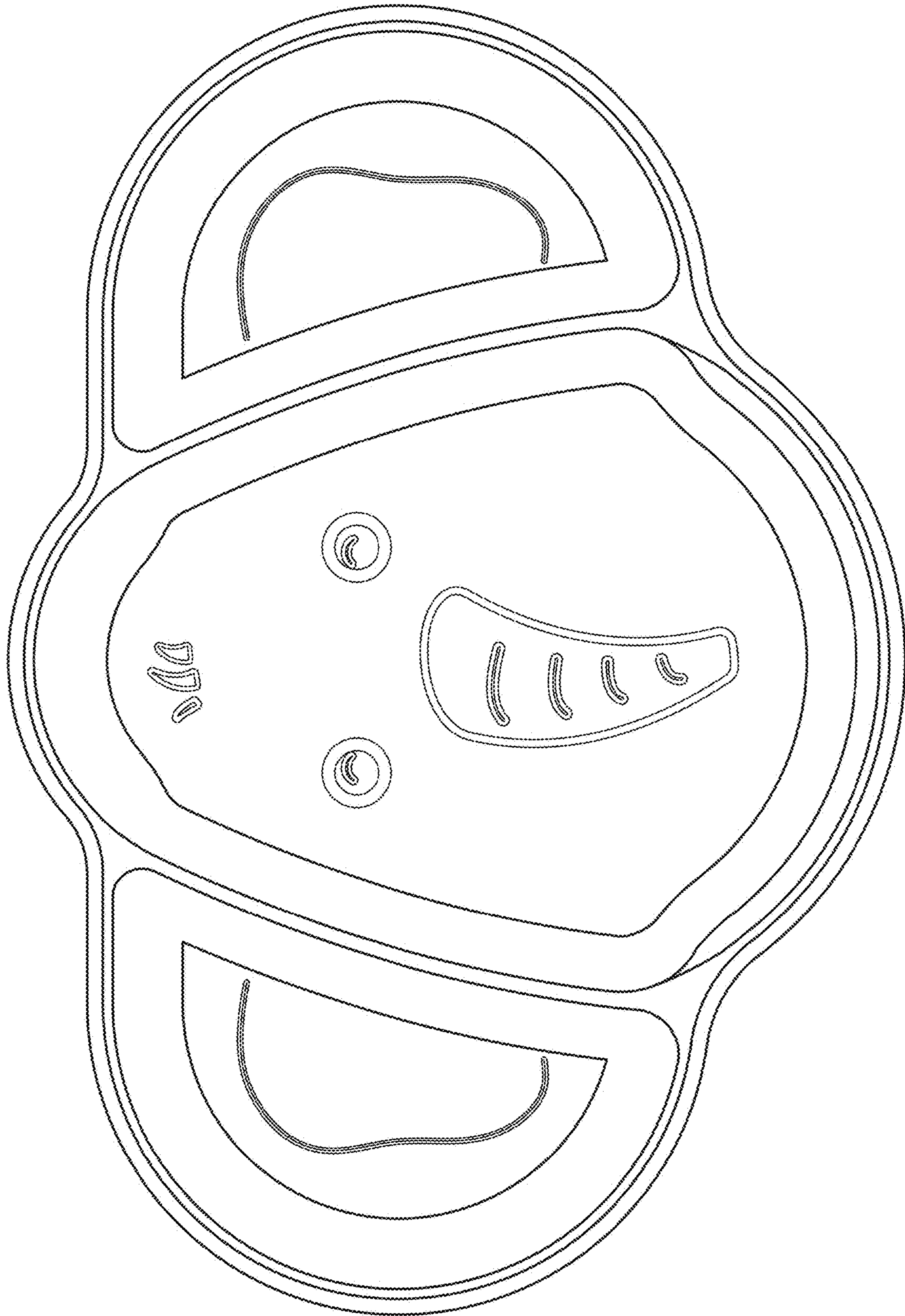

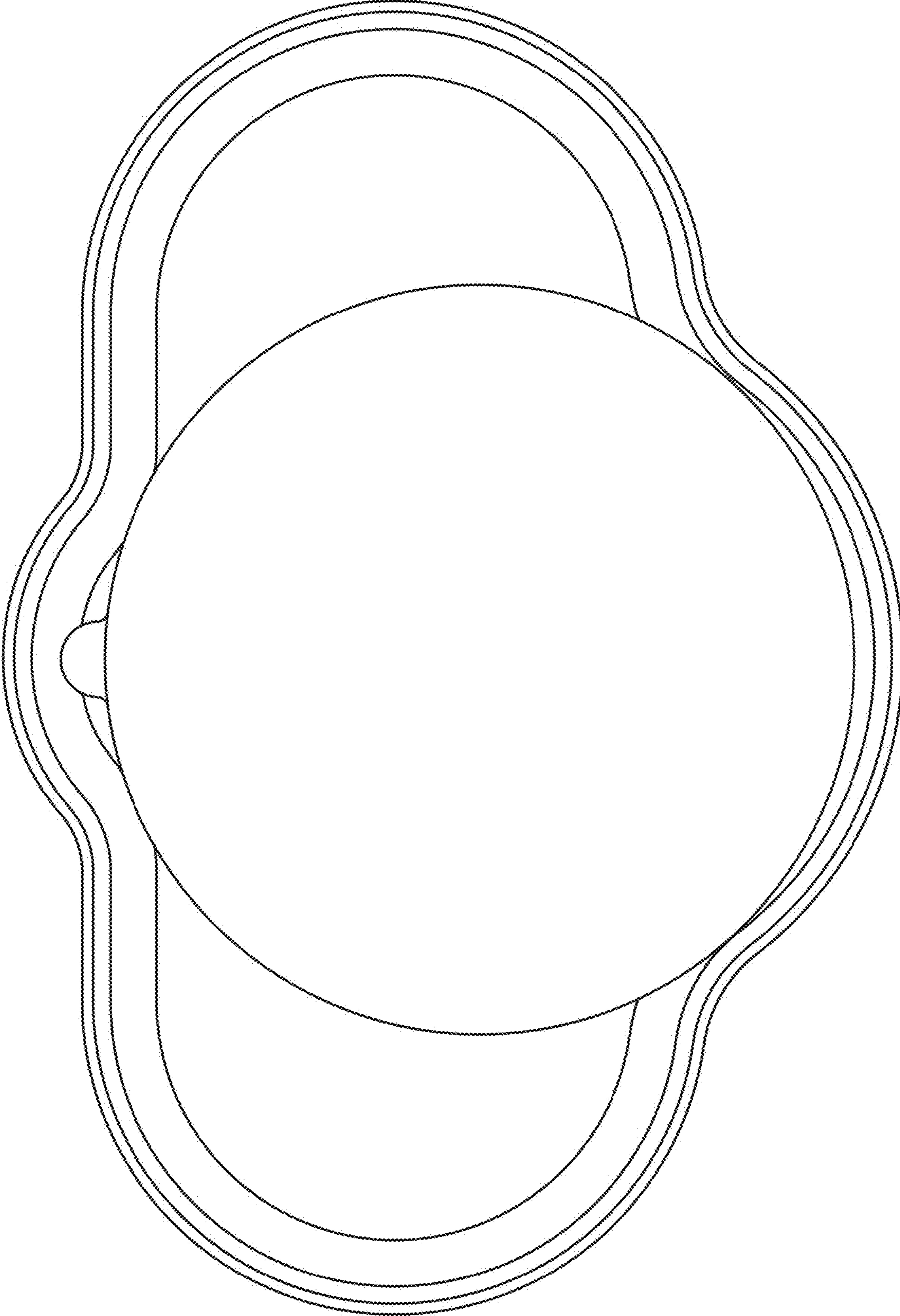

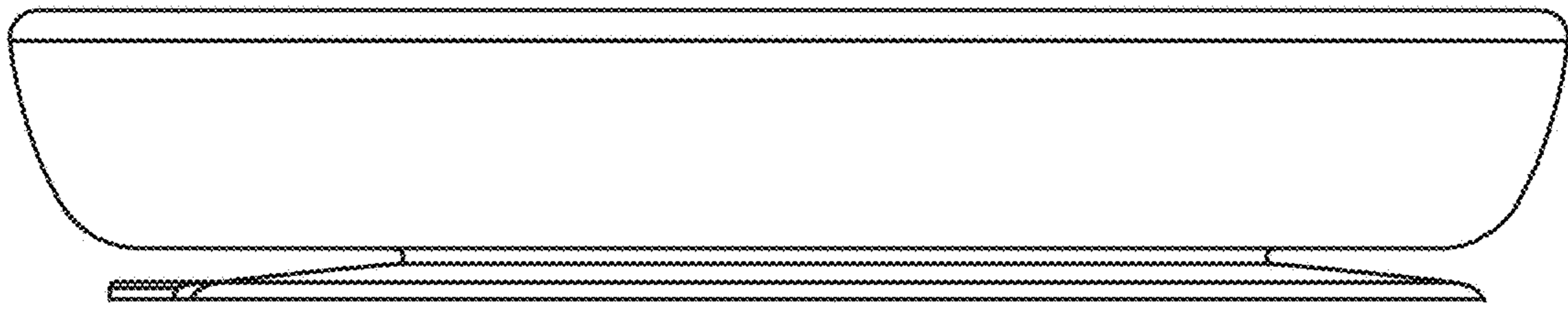

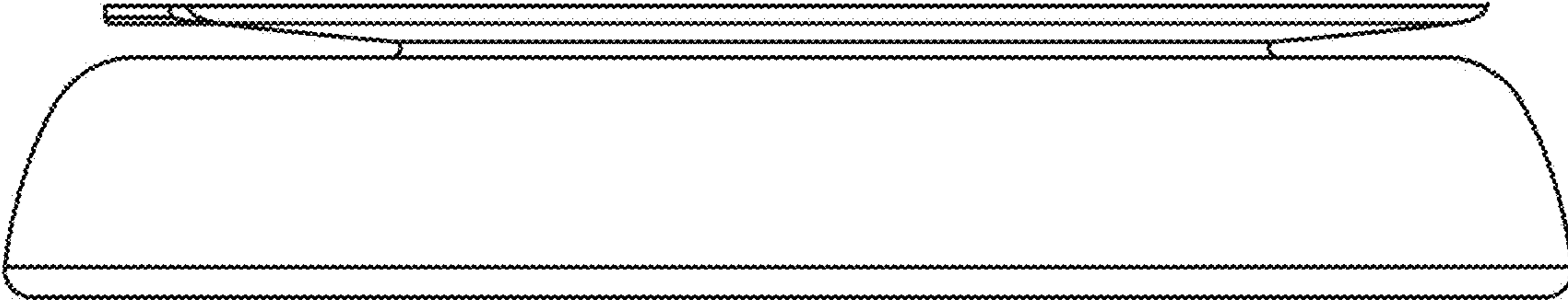

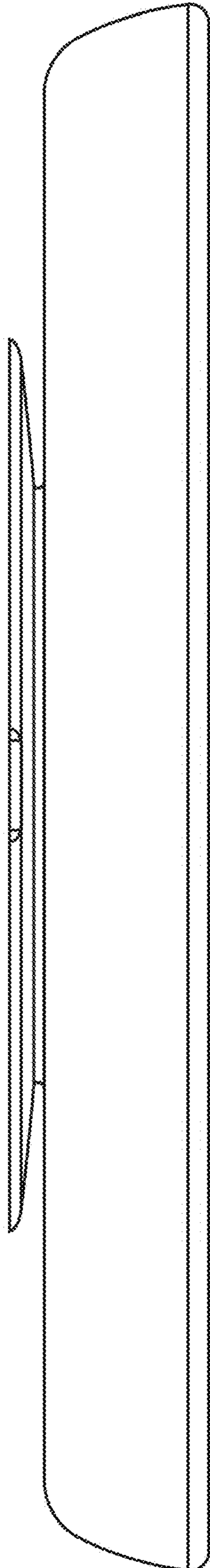

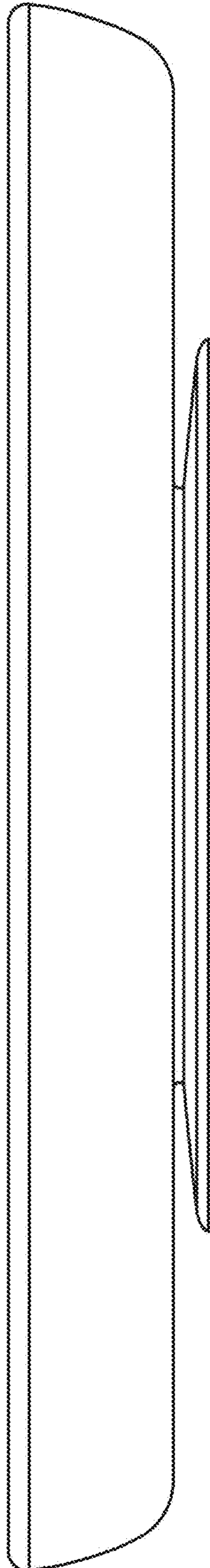

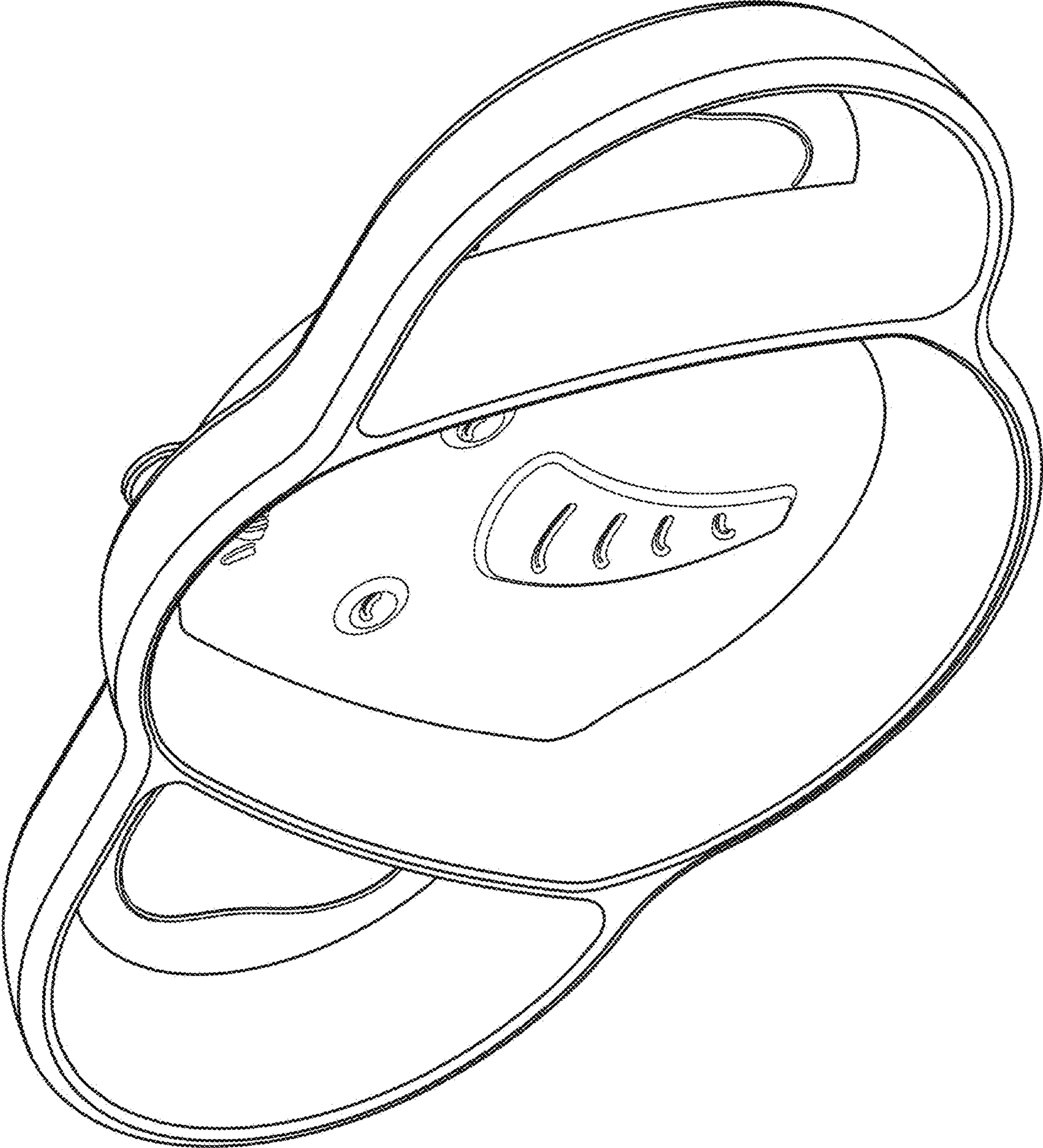

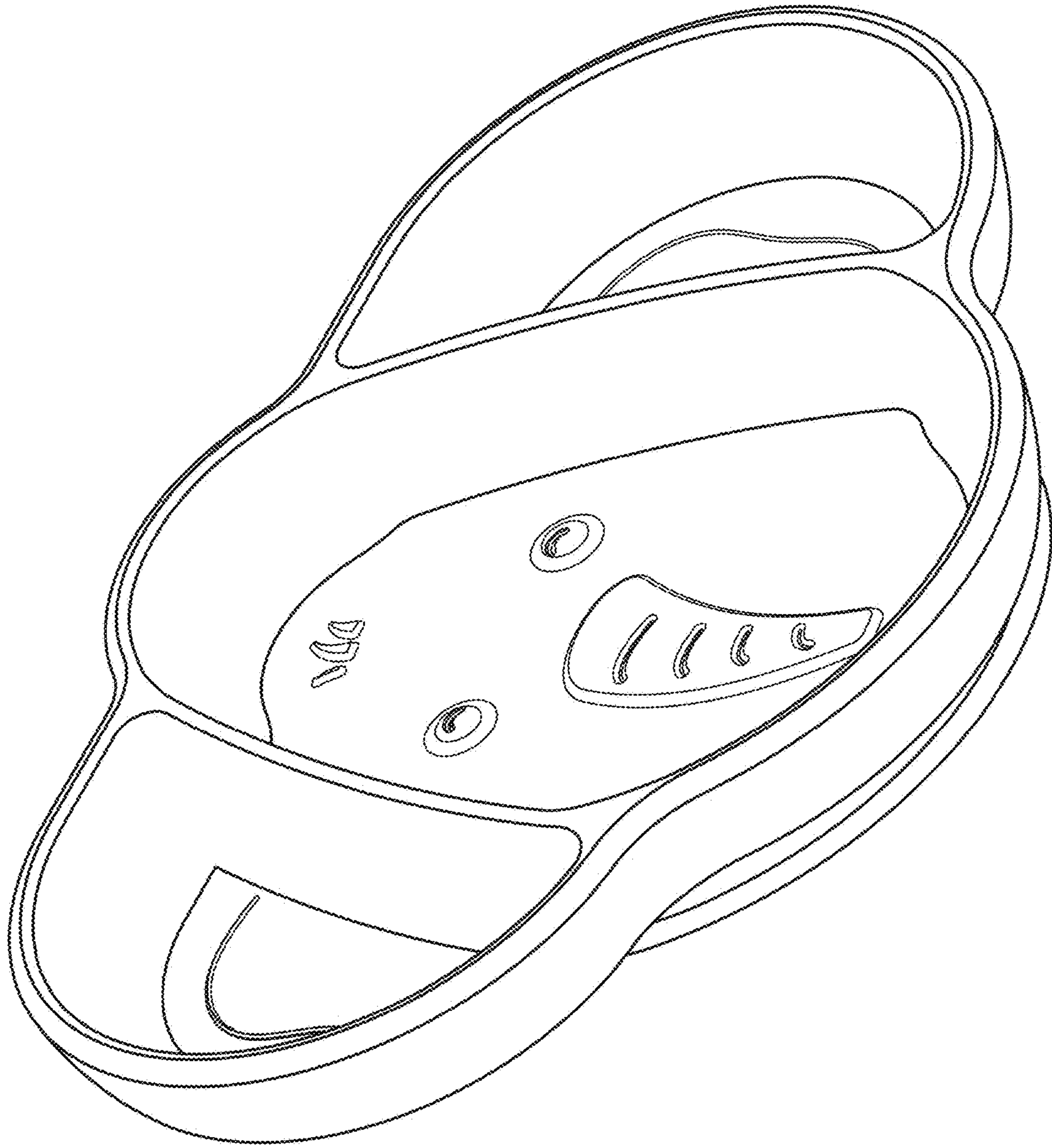

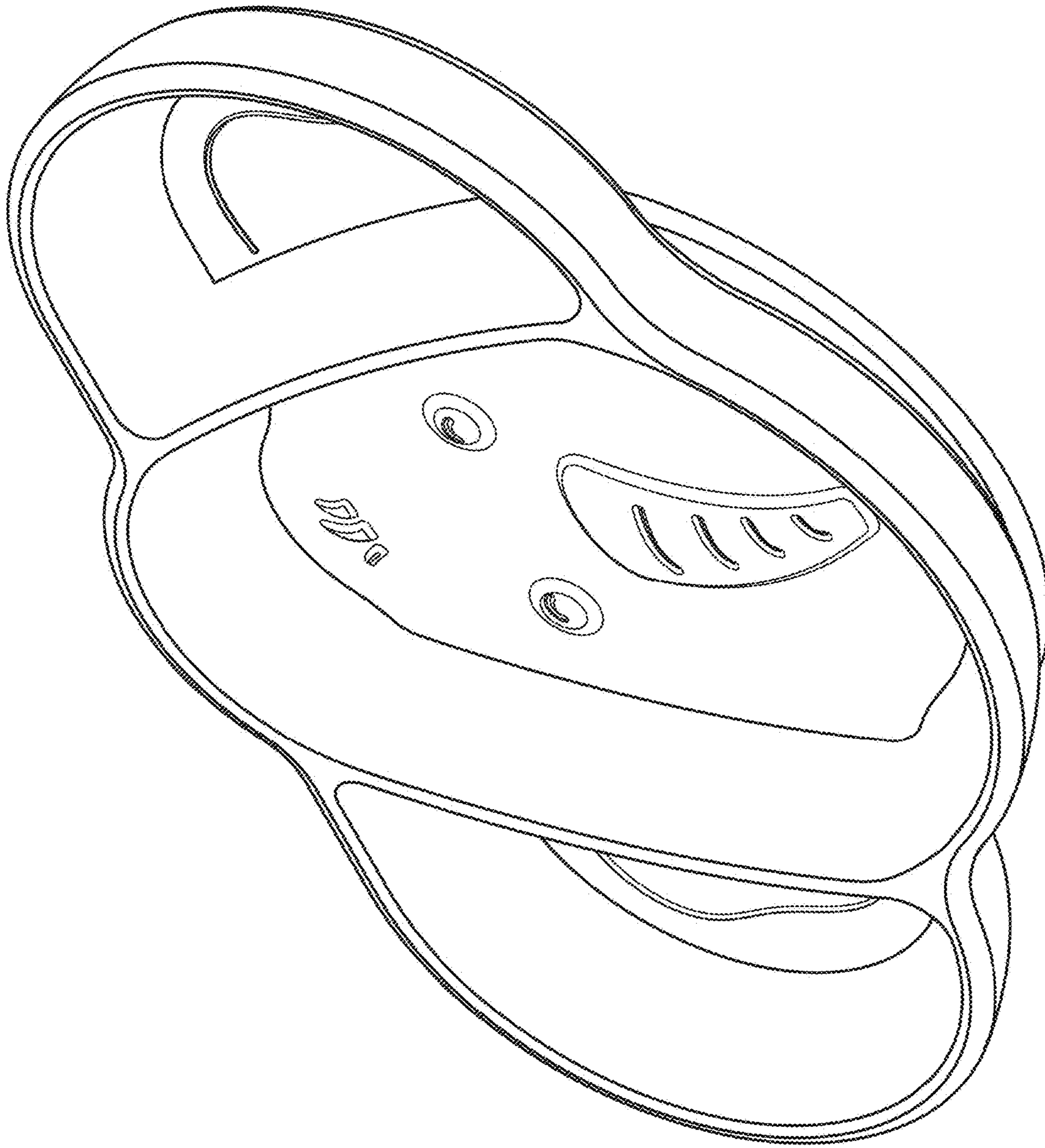
