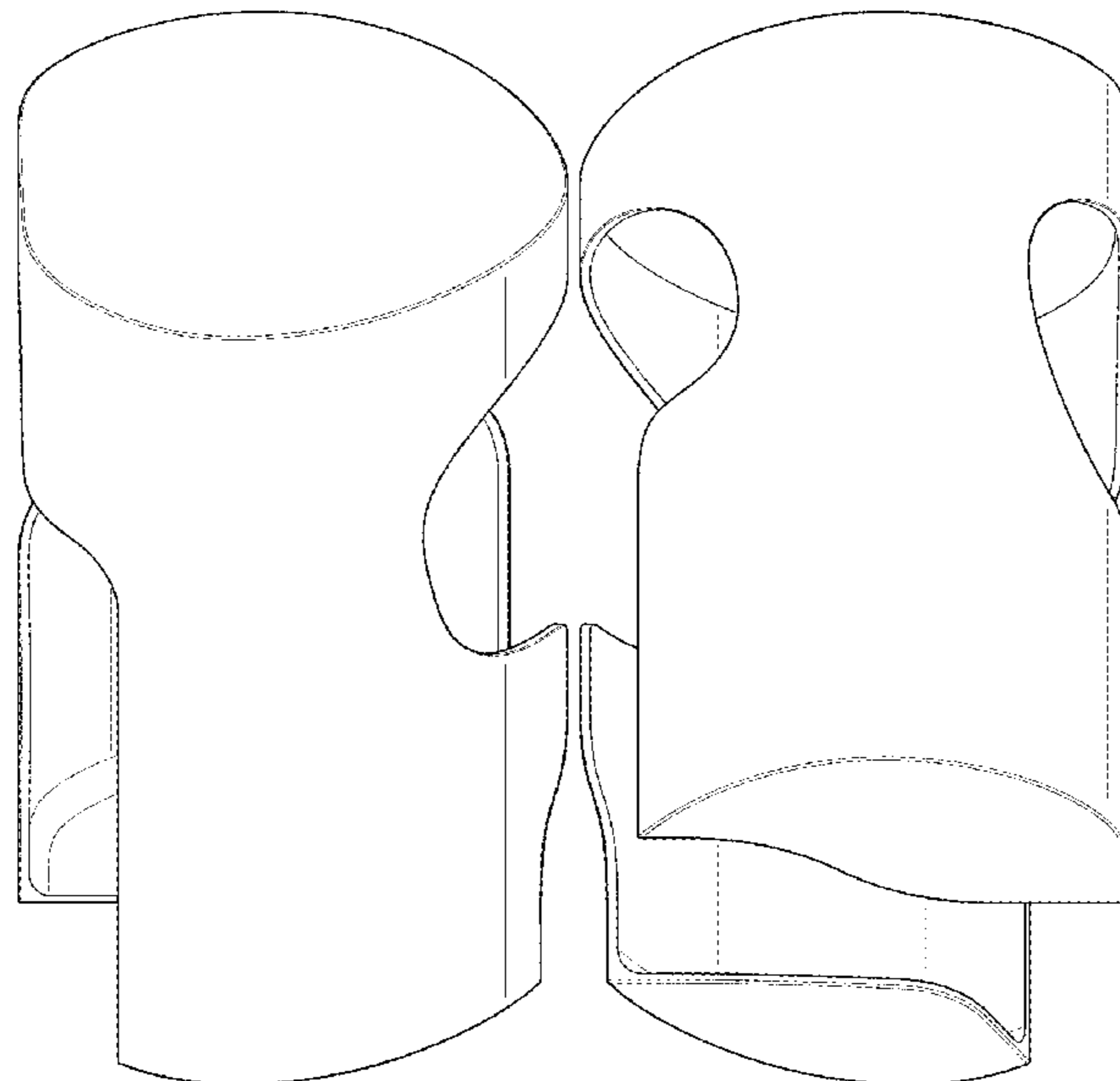
I claim the ornamental design for a table, as shown and described.

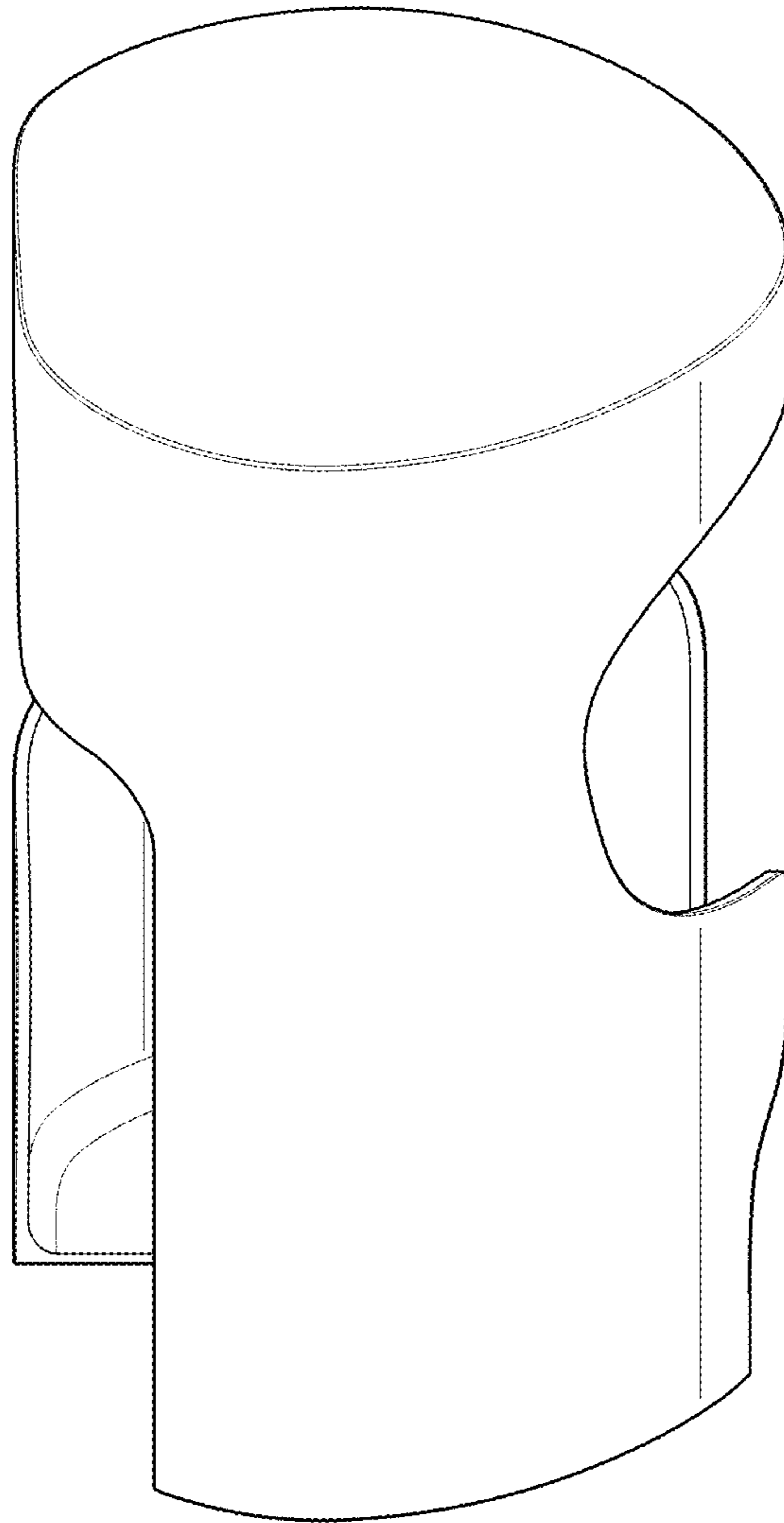

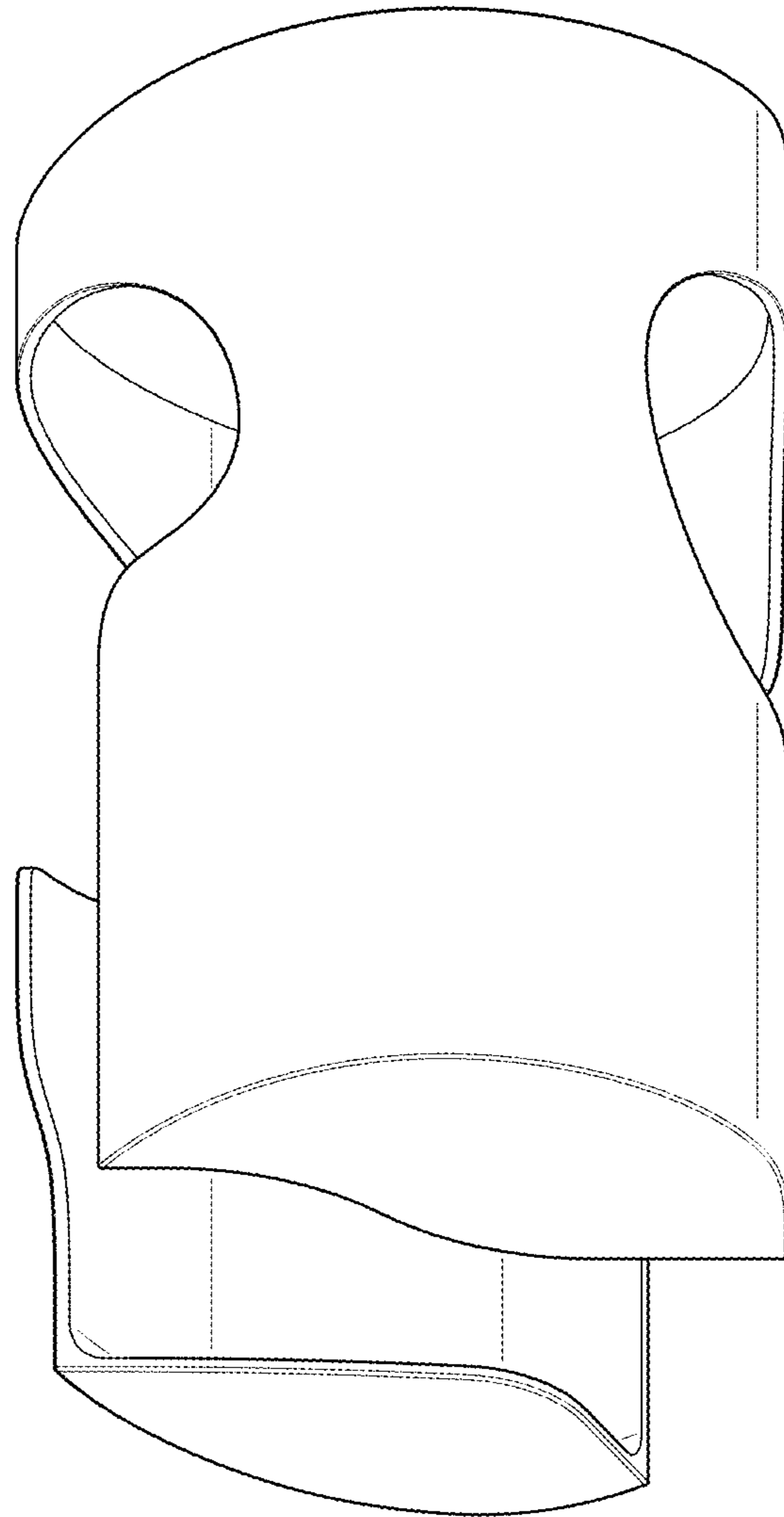

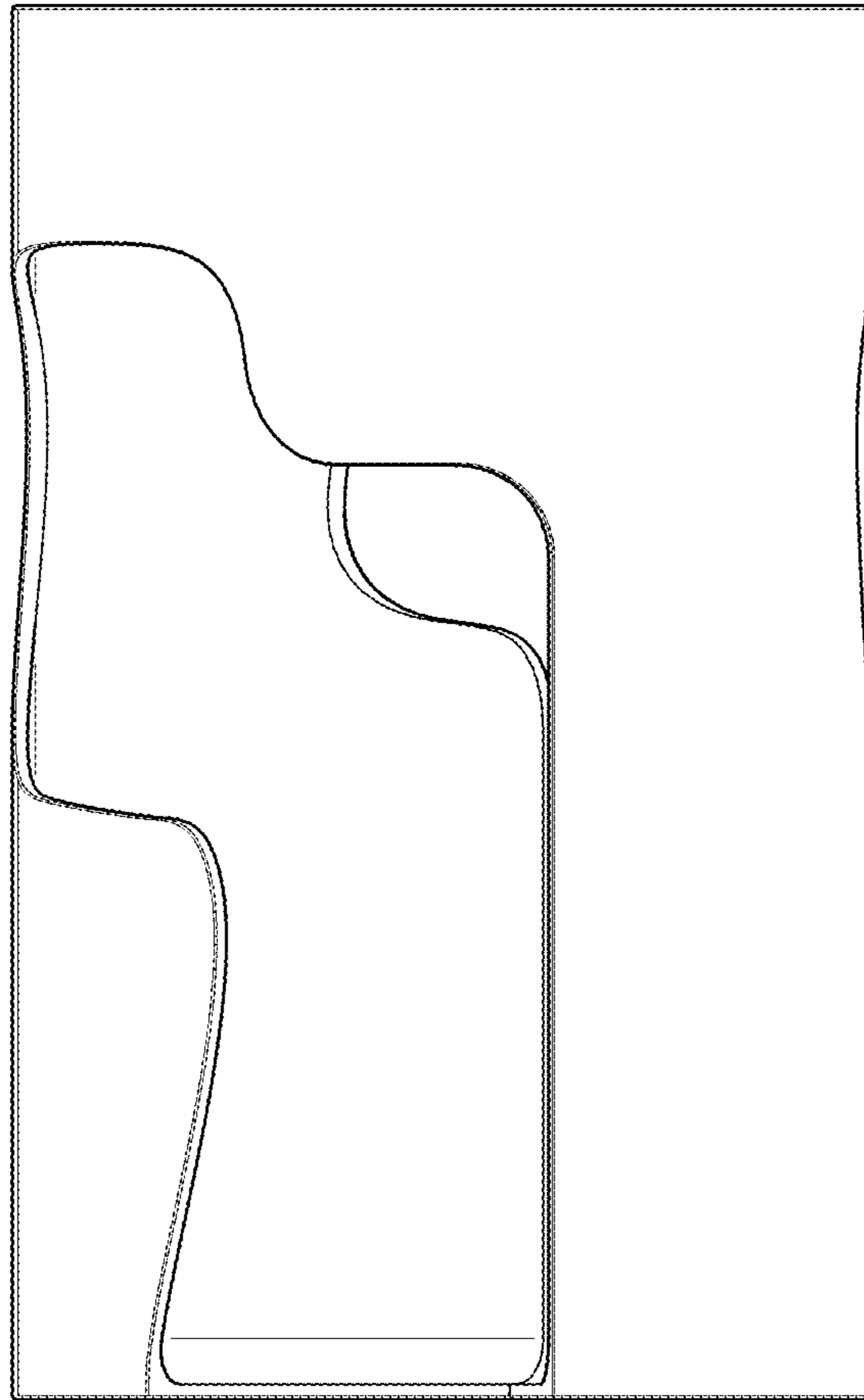

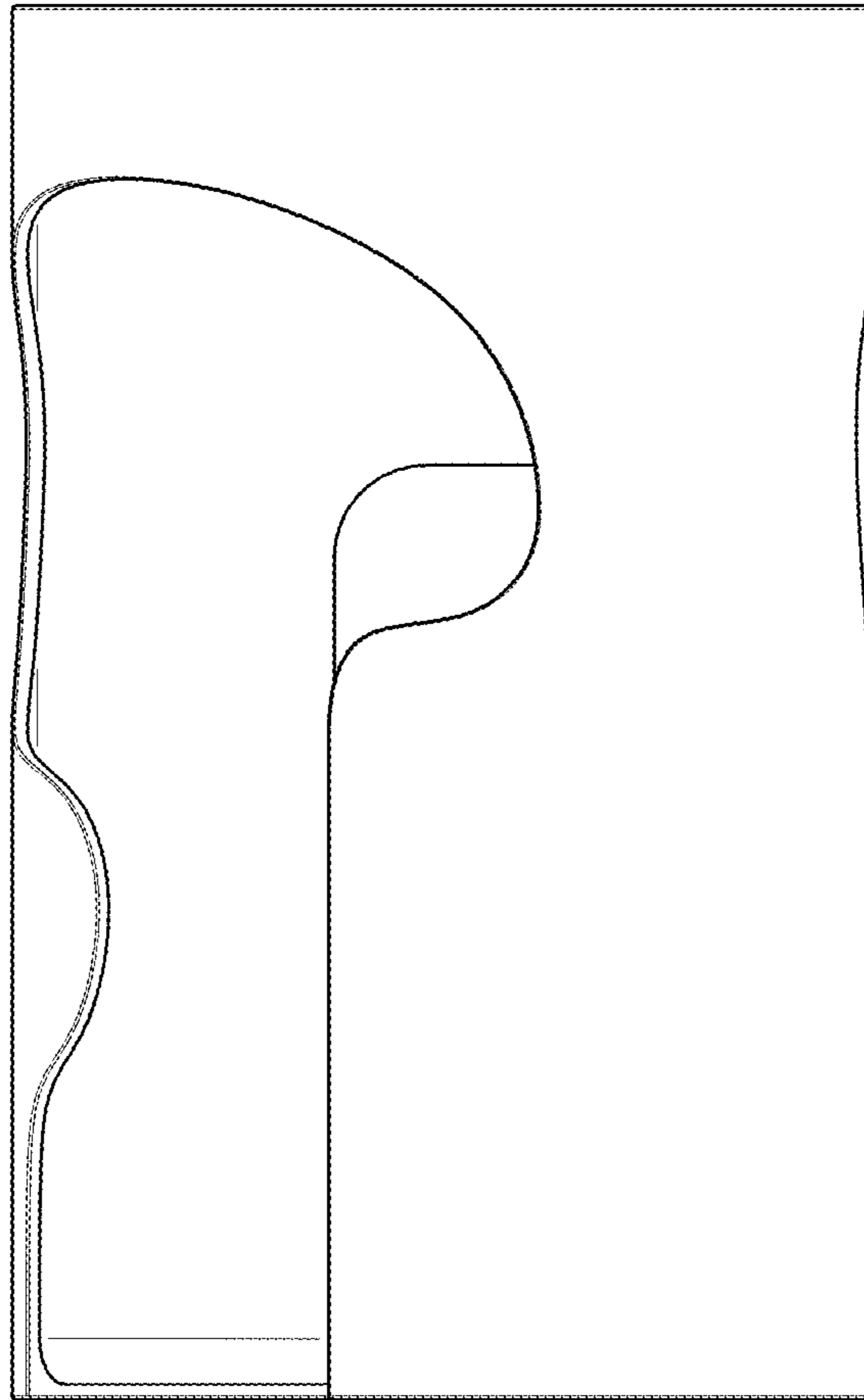

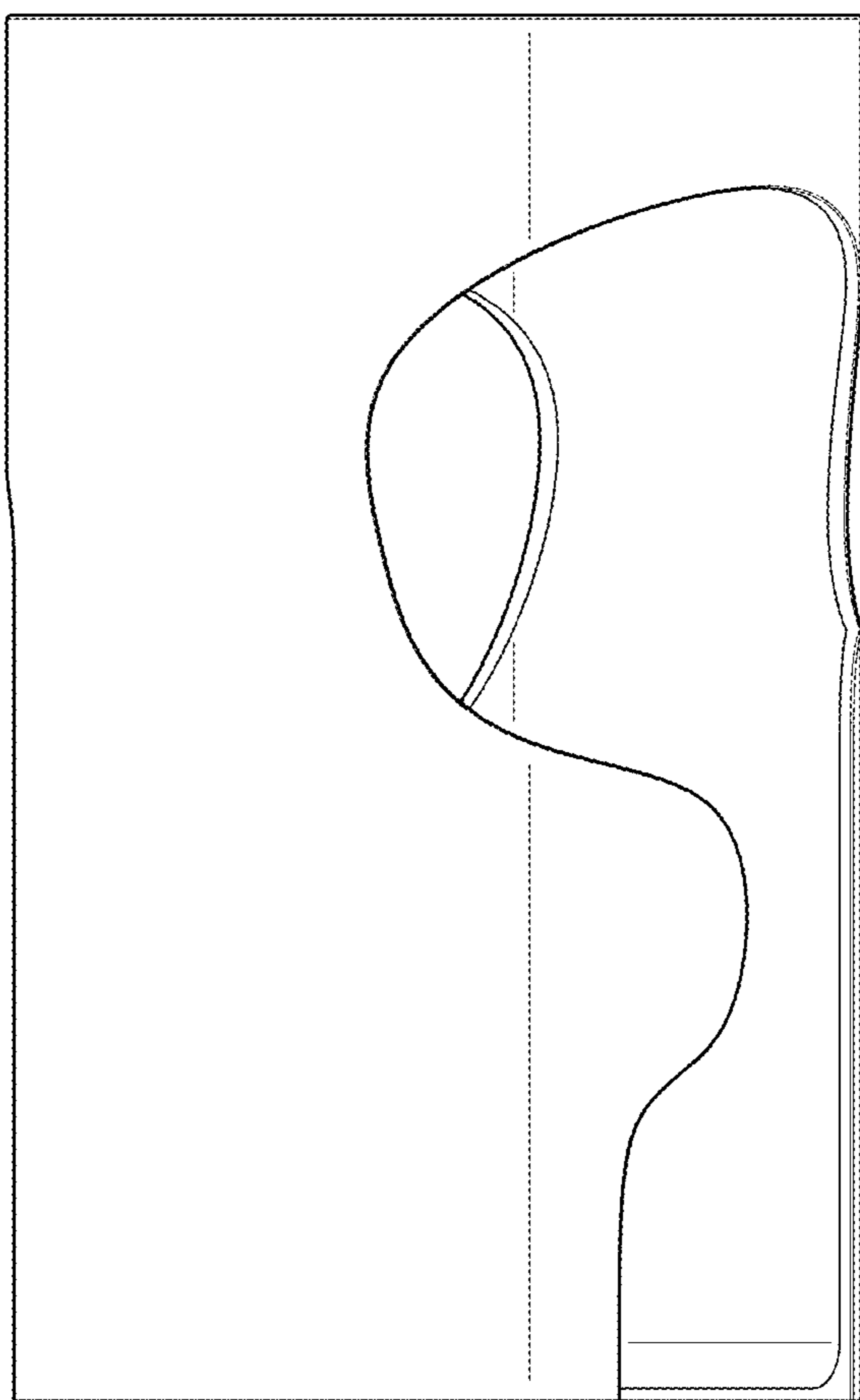

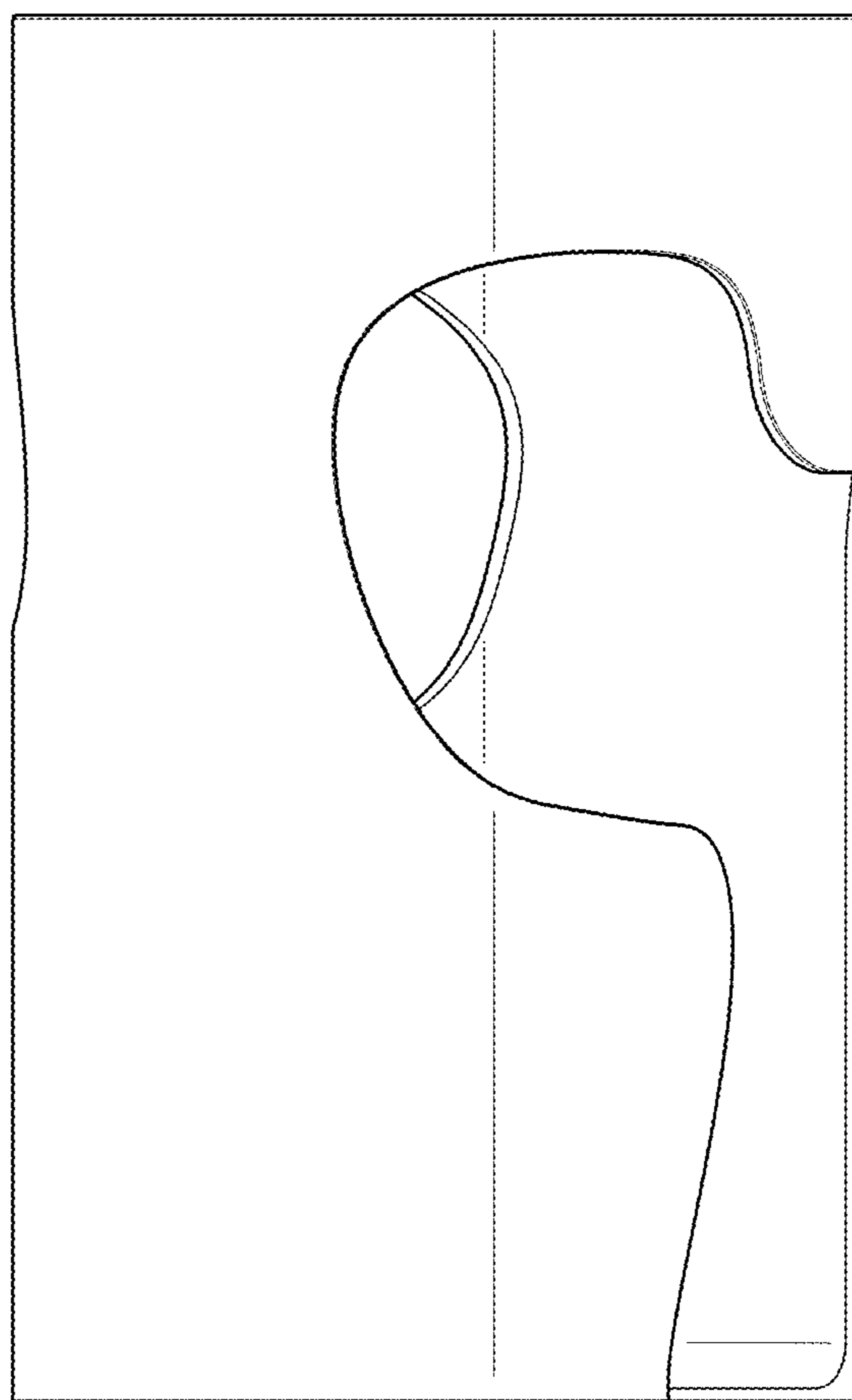

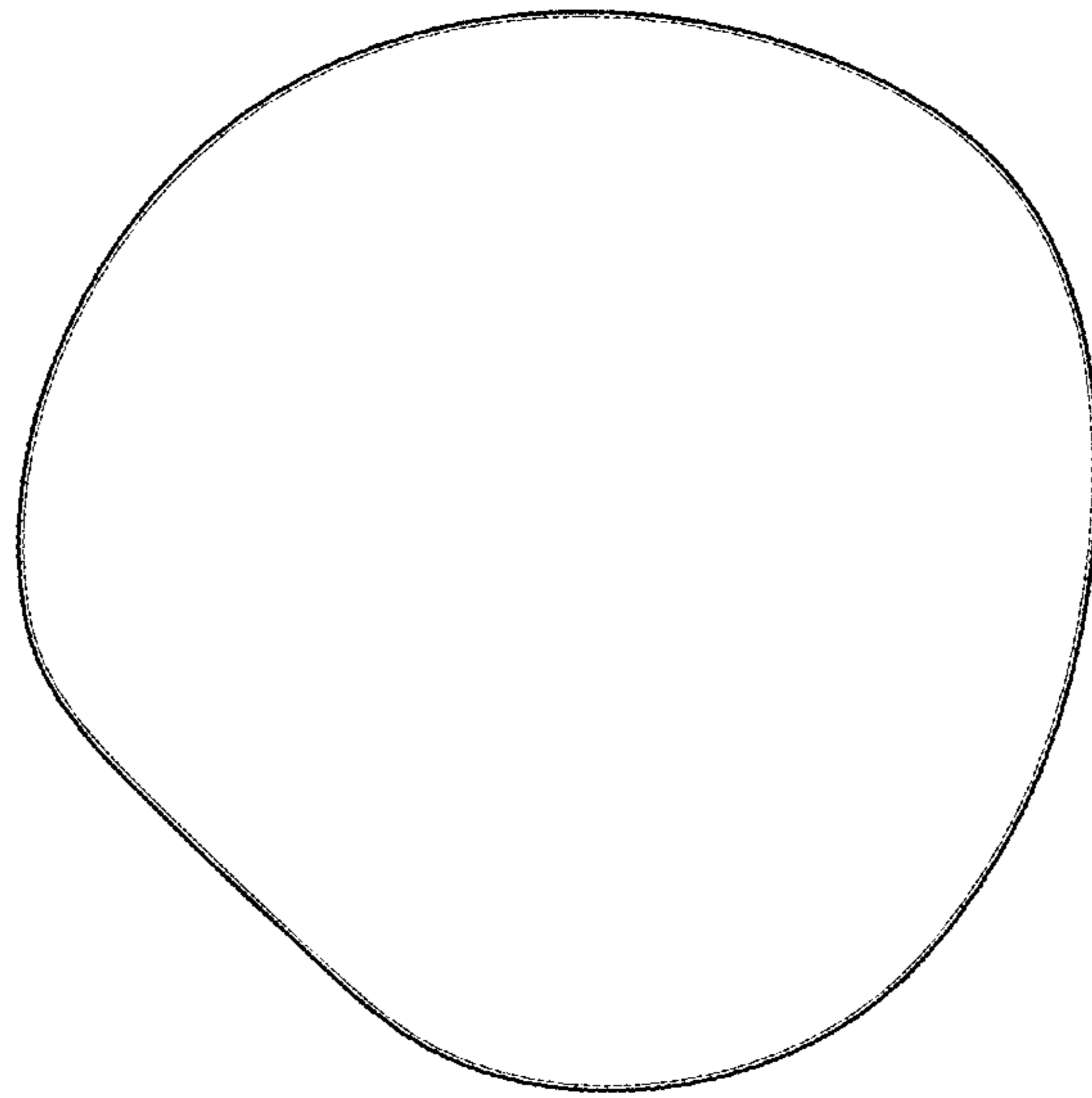

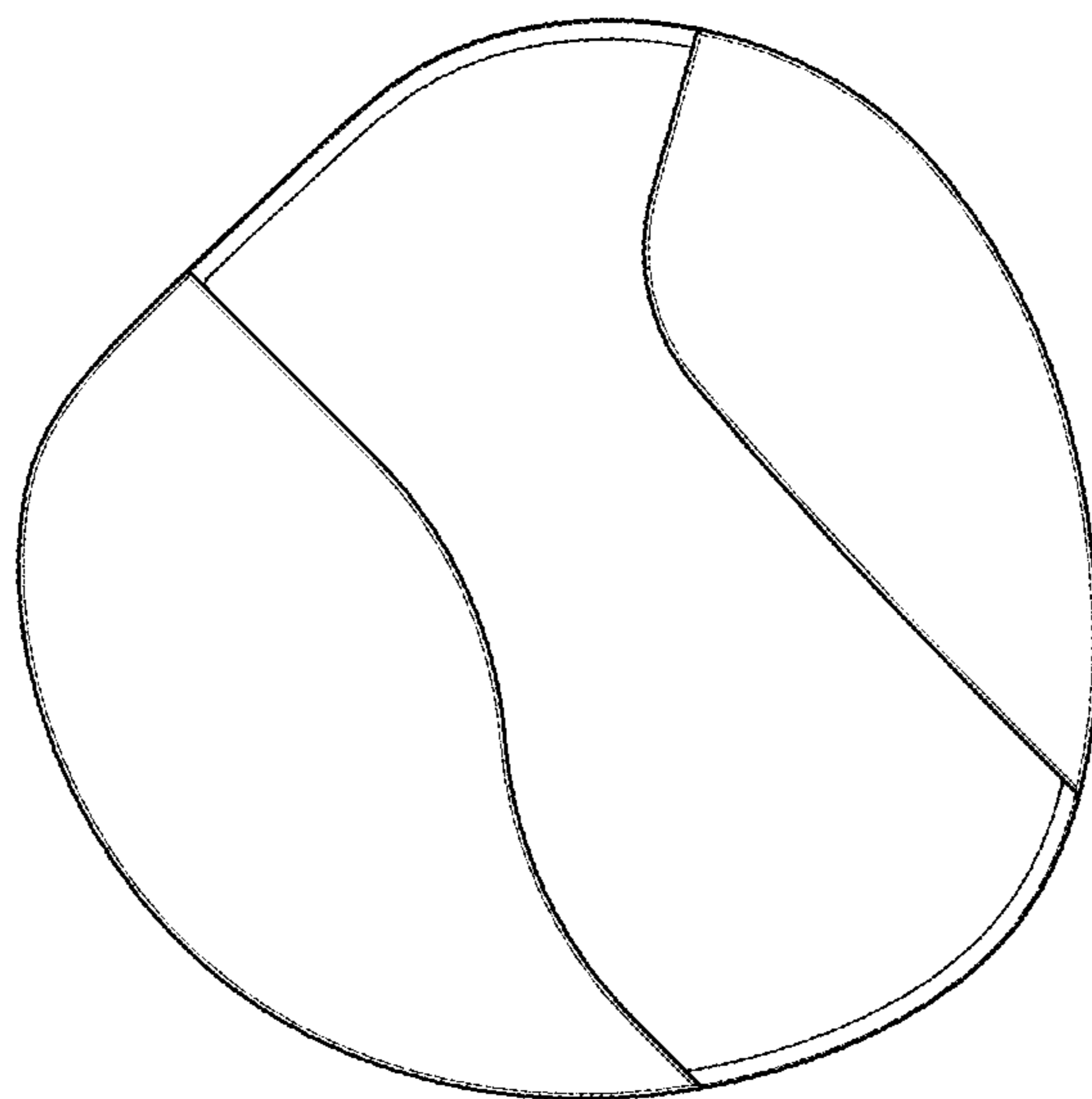

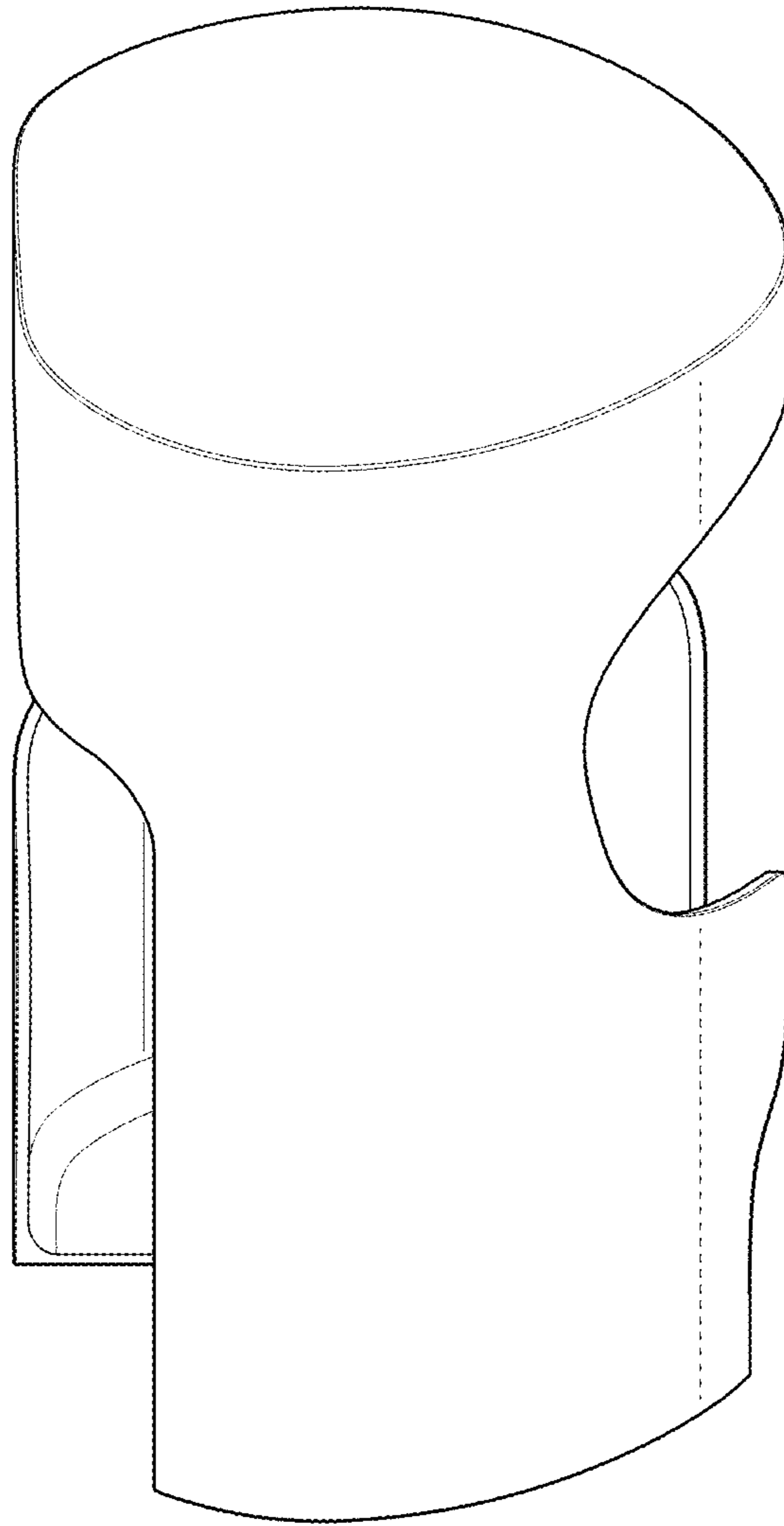

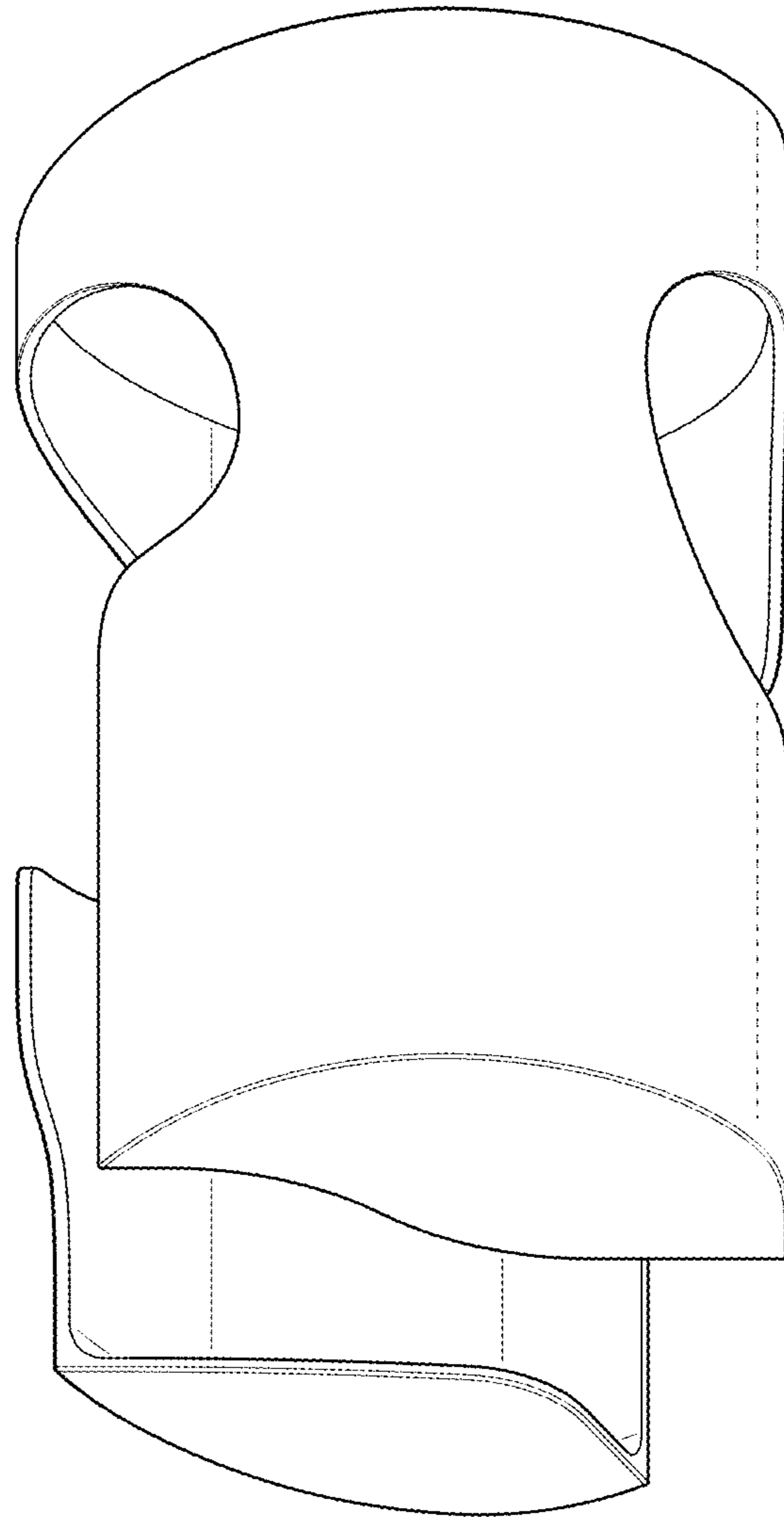

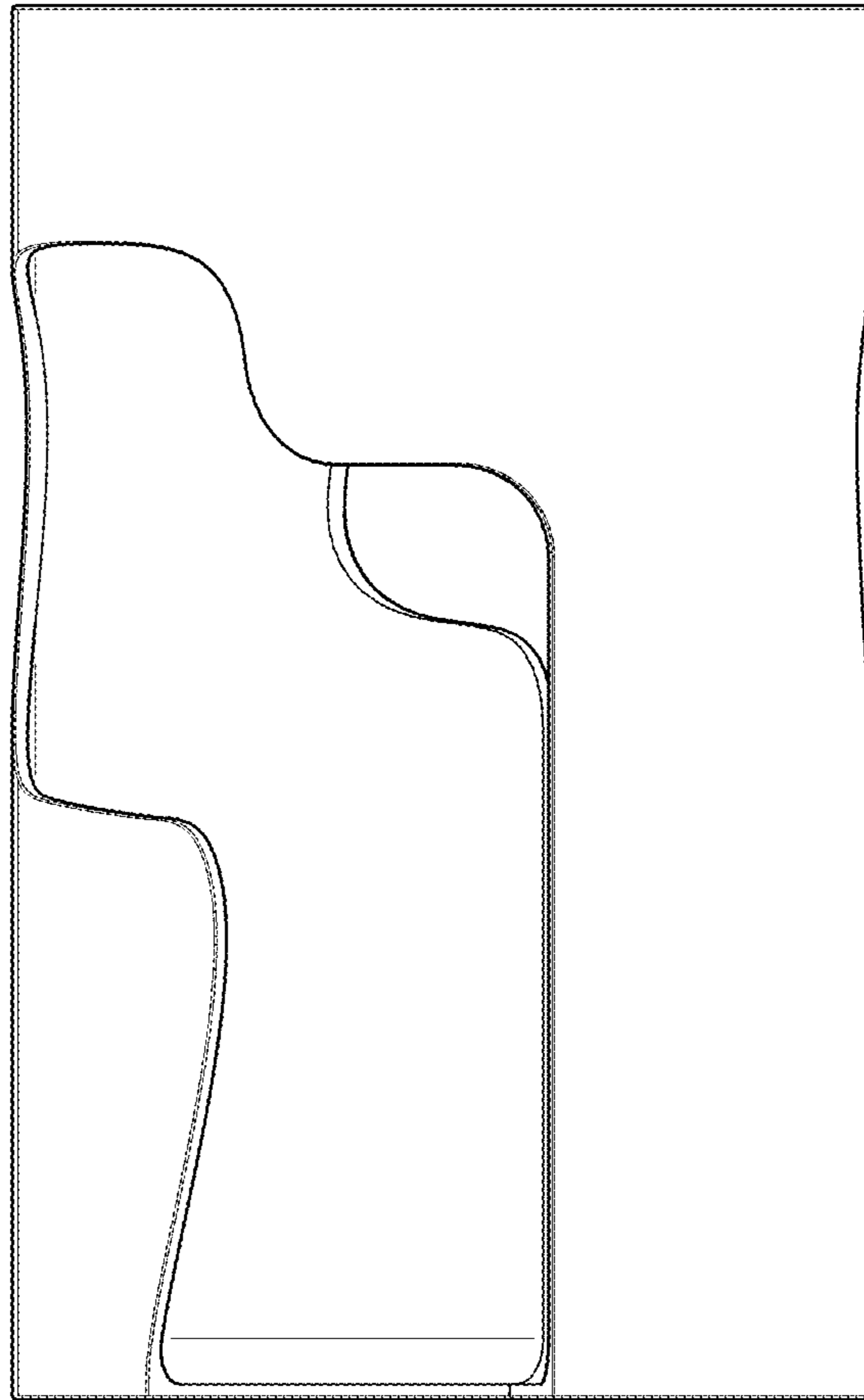

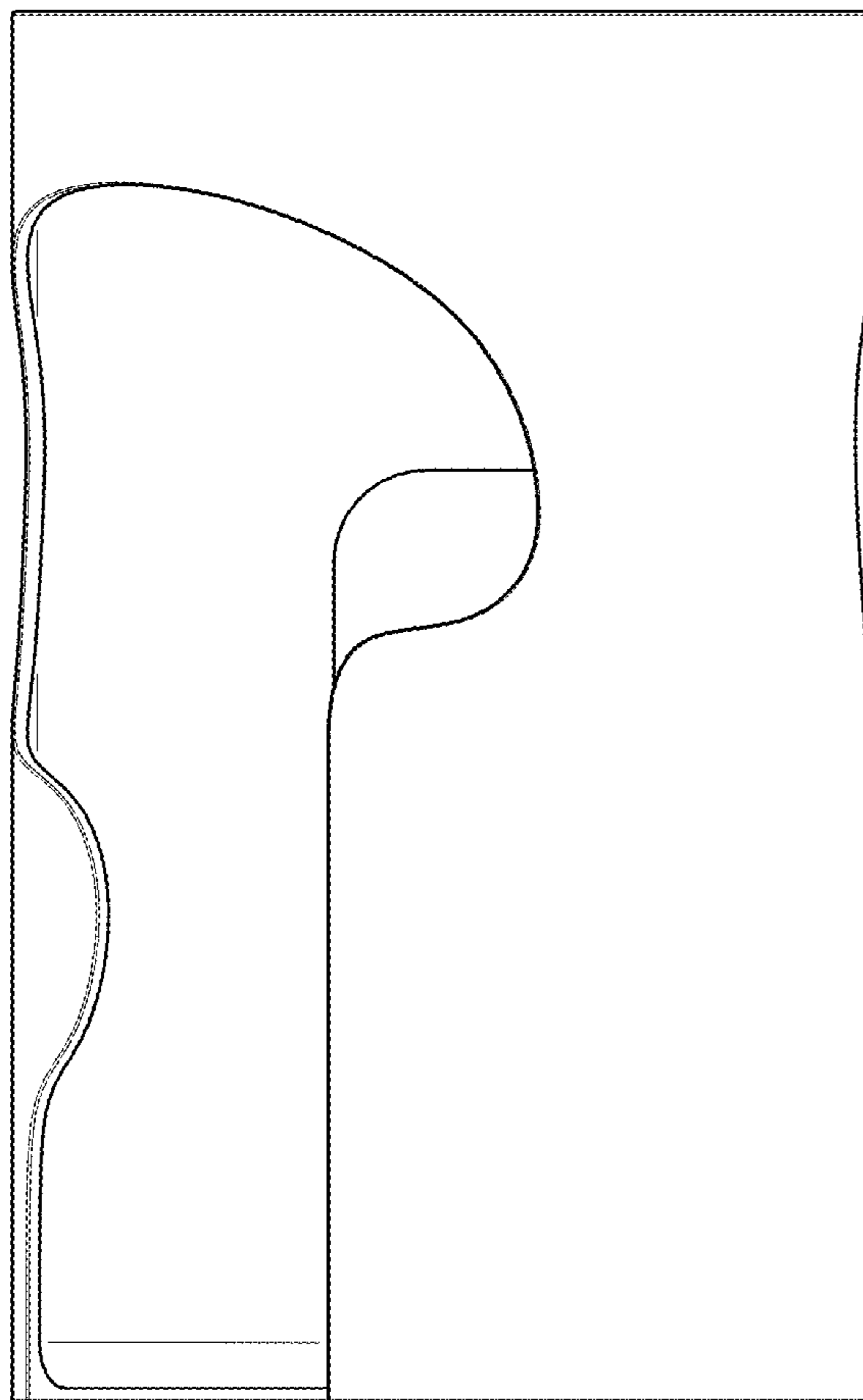

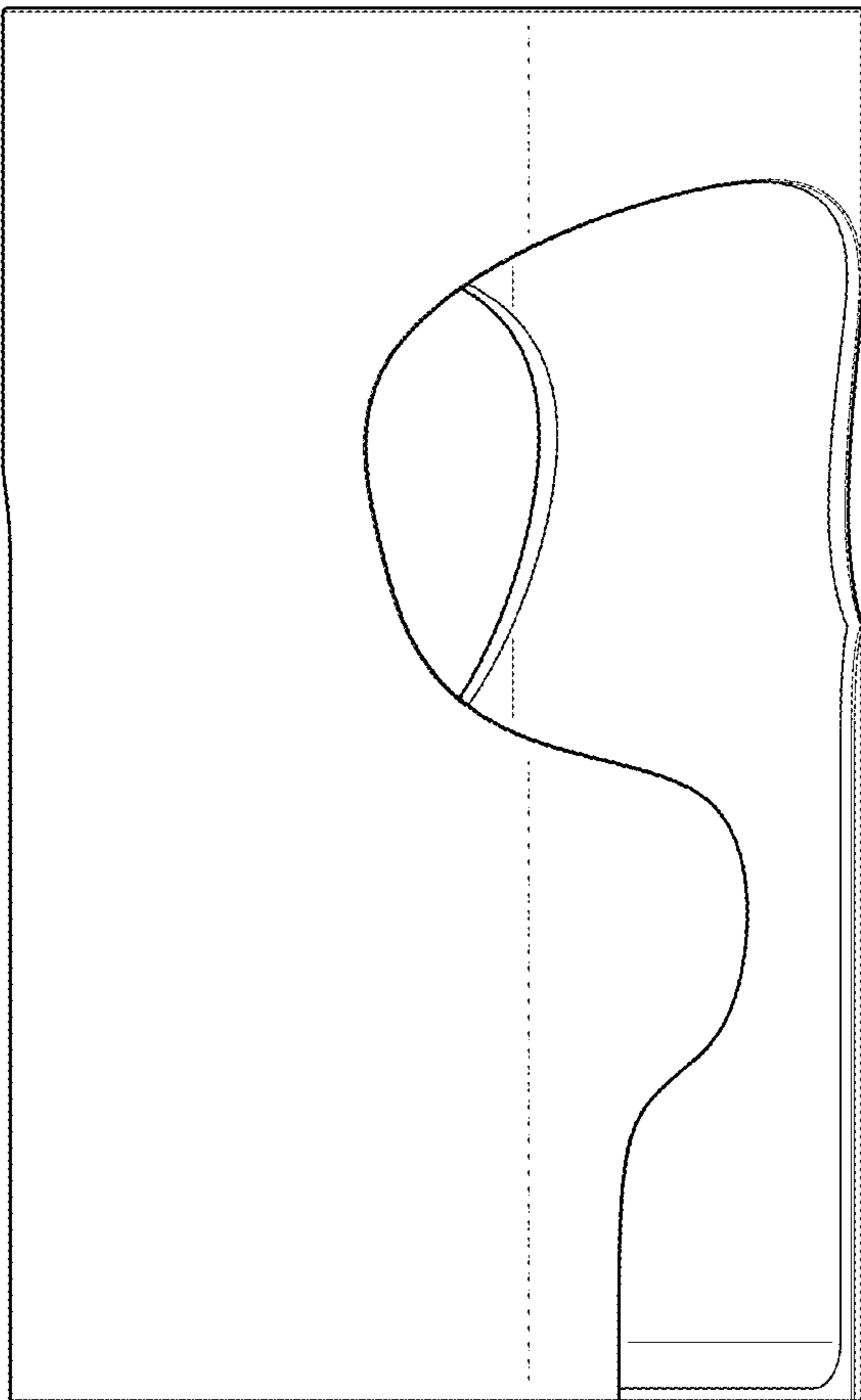

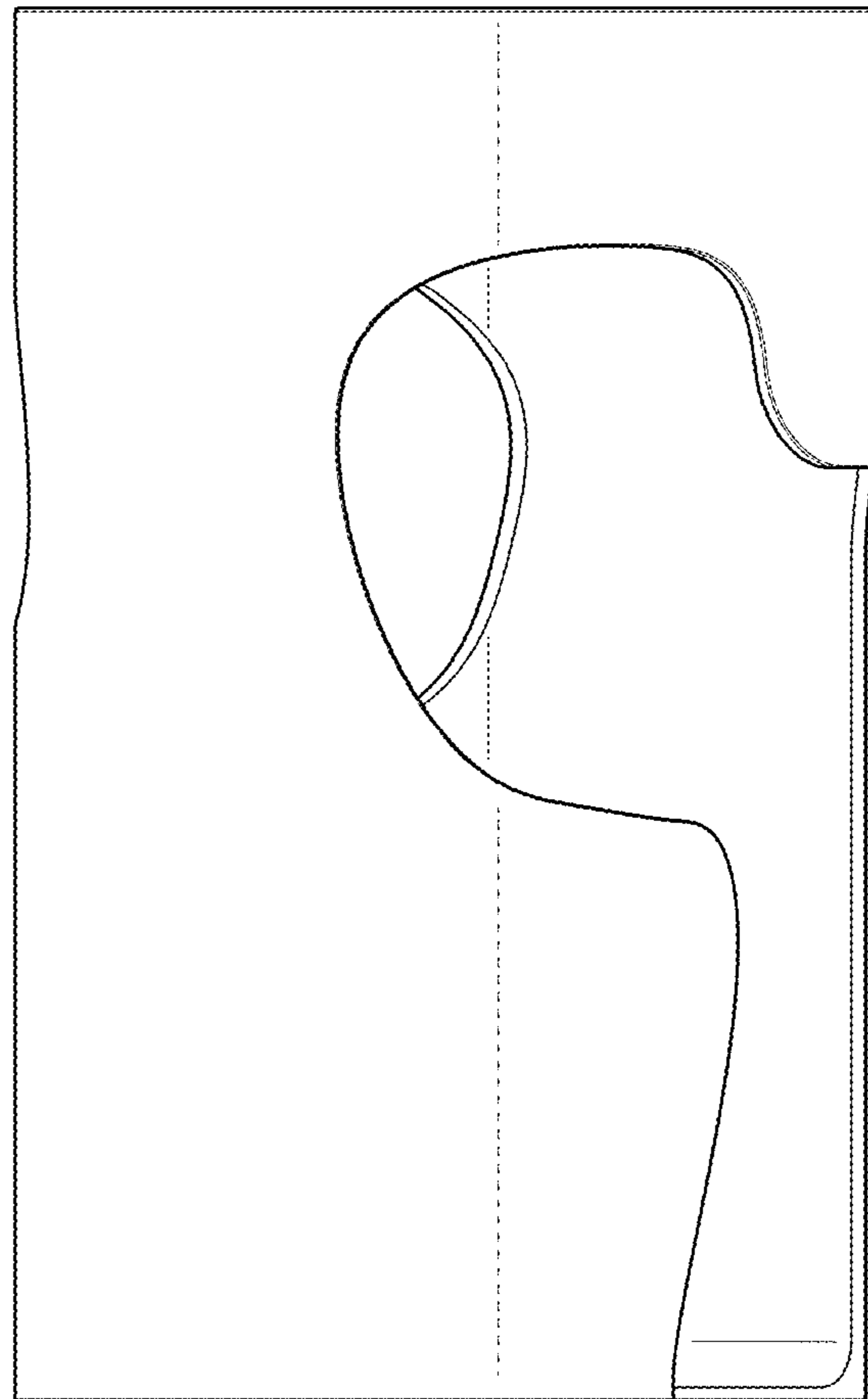

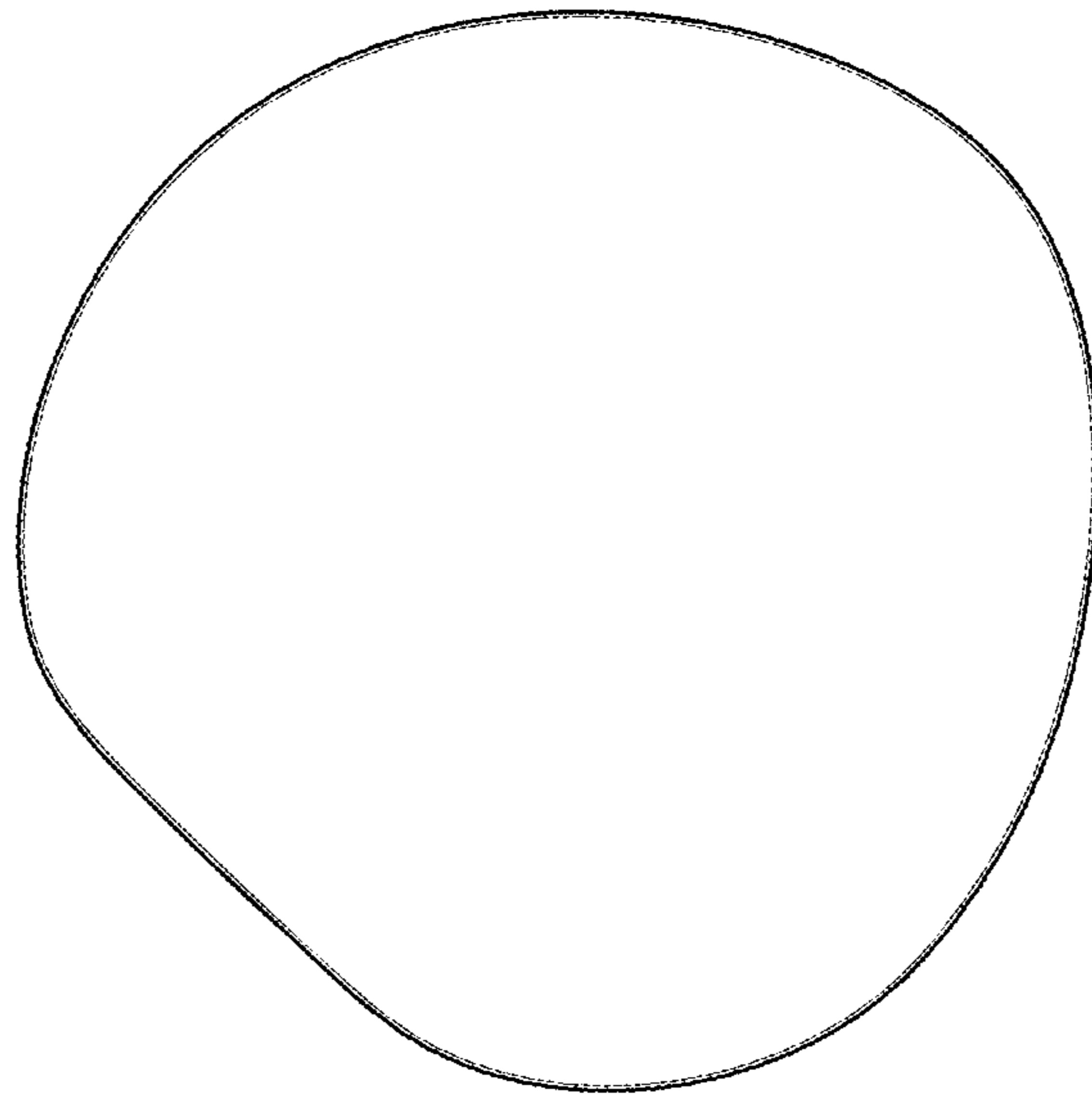

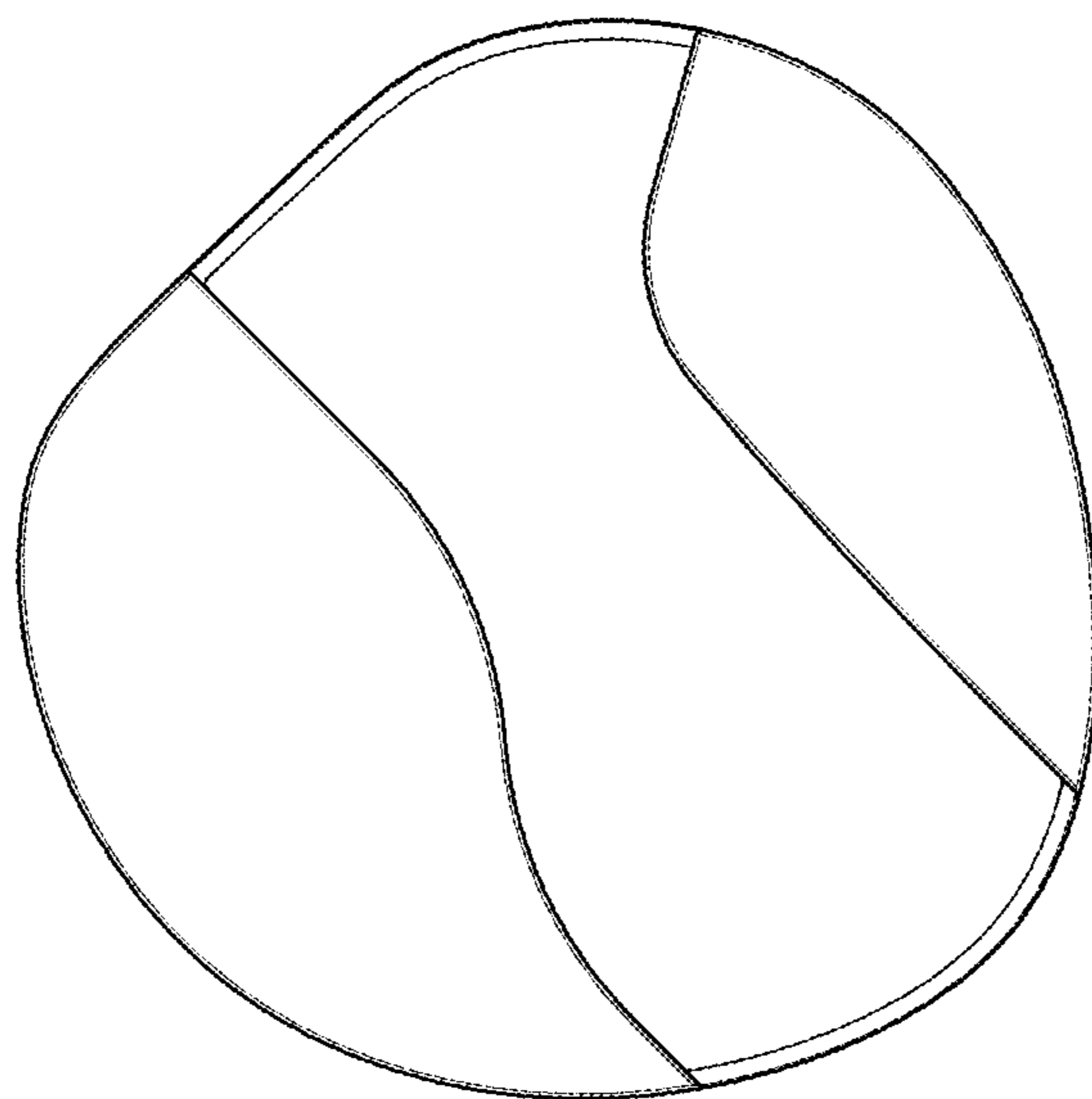
