**DESCRIPTION**

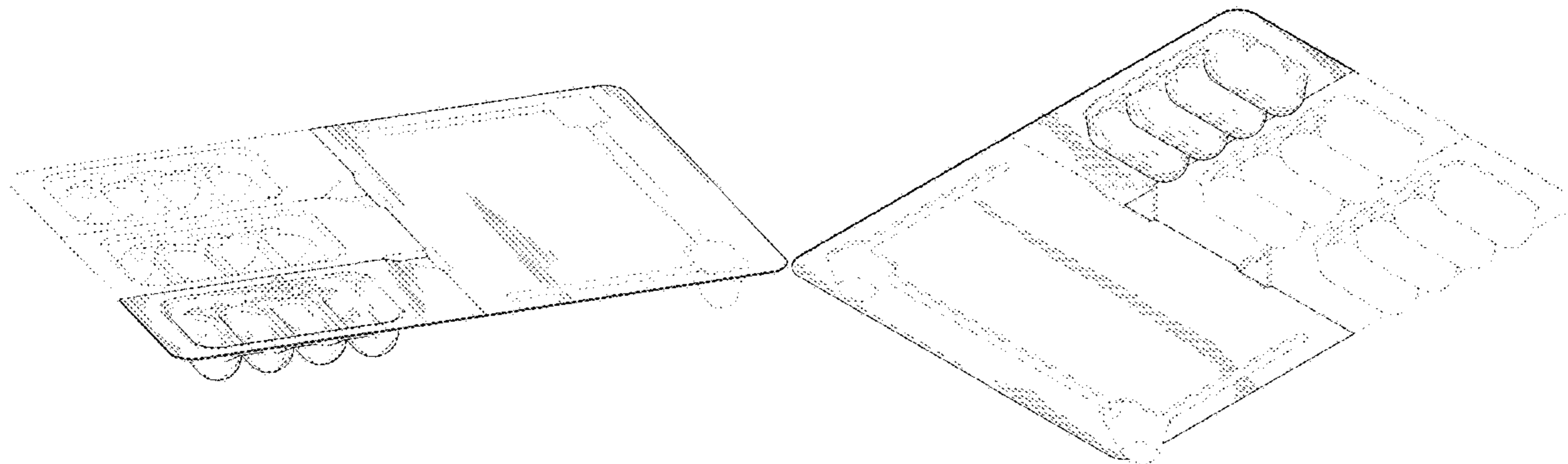
FIG. 1 is a top perspective view of a blister package according to the present invention;

 FIG. 6 is a rear elevational view thereof;

 FIG. 8 is a left side elevational view thereof; and  
 FIG. 9 is a top perspective view of a second embodiment of FIG. 1 with a protective lidding seal extending across an upper surface of the blister package;  
 FIG. 10 is a bottom perspective view of FIG. 9;  
 FIG. 11 is a top plan view of FIG. 9;  
 FIG. 12 is a bottom plan view of FIG. 9;  
 FIG. 13 is a front elevational view of FIG. 9;  
 FIG. 14 is a rear elevational view of FIG. 9;  
 FIG. 15 is a right side elevational view of FIG. 9; and,  
 FIG. 16 is a left side elevational view of FIG. 9.

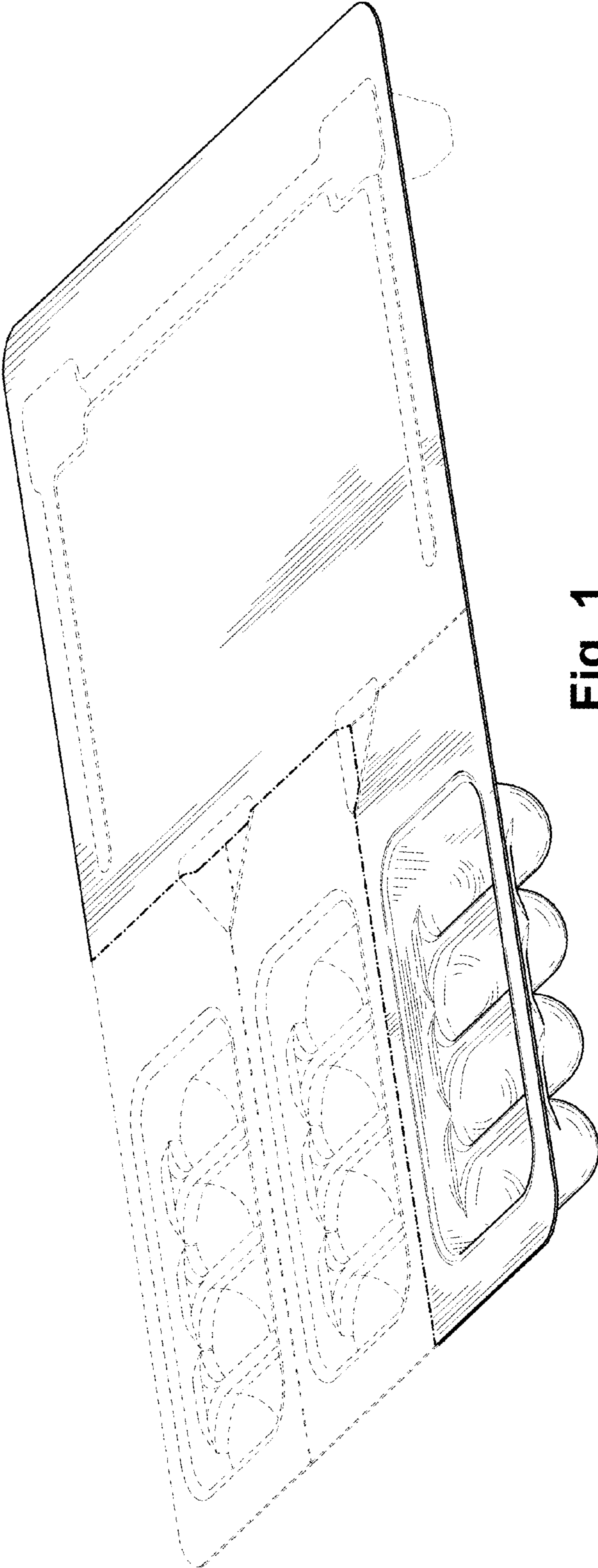

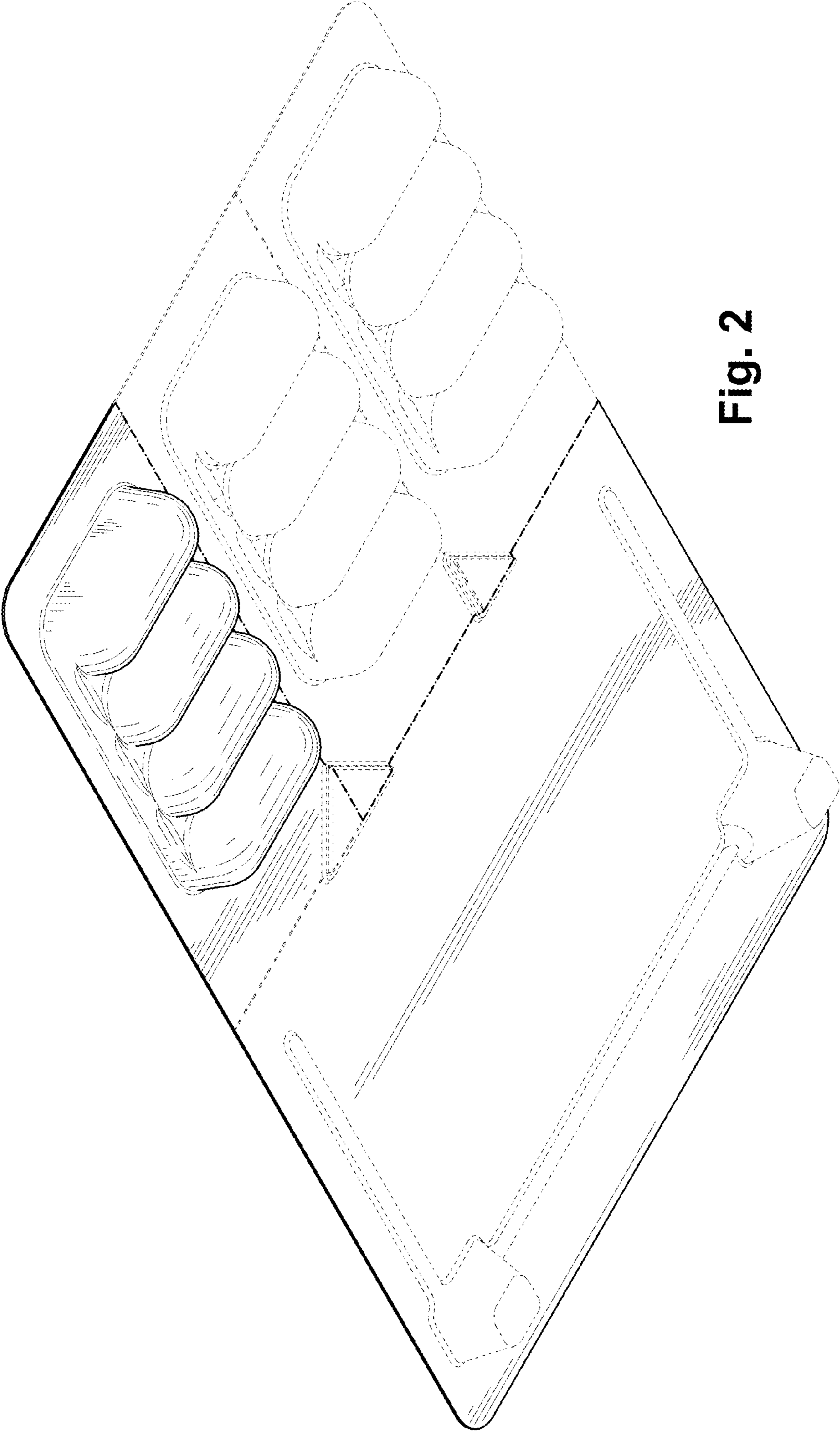
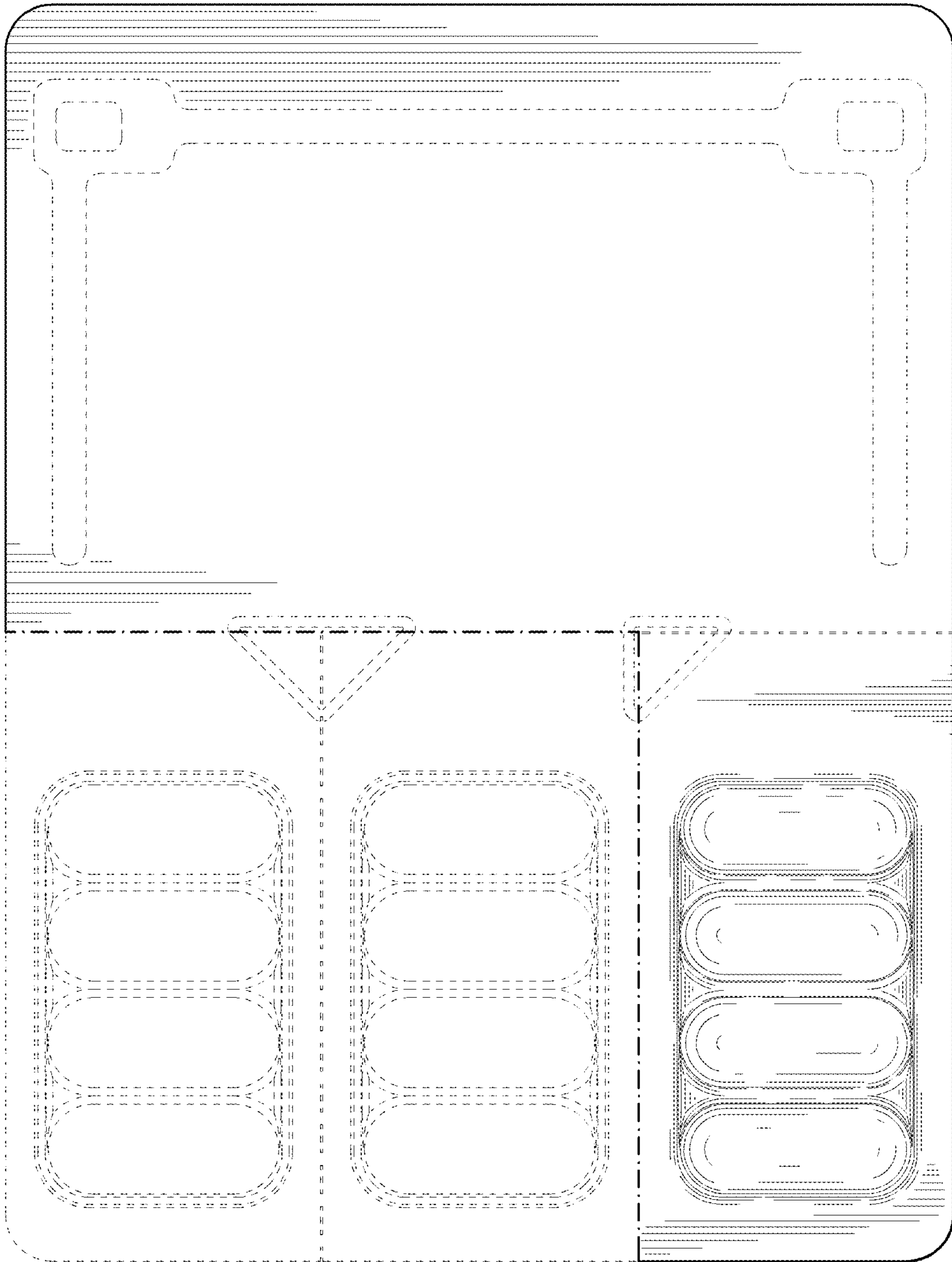

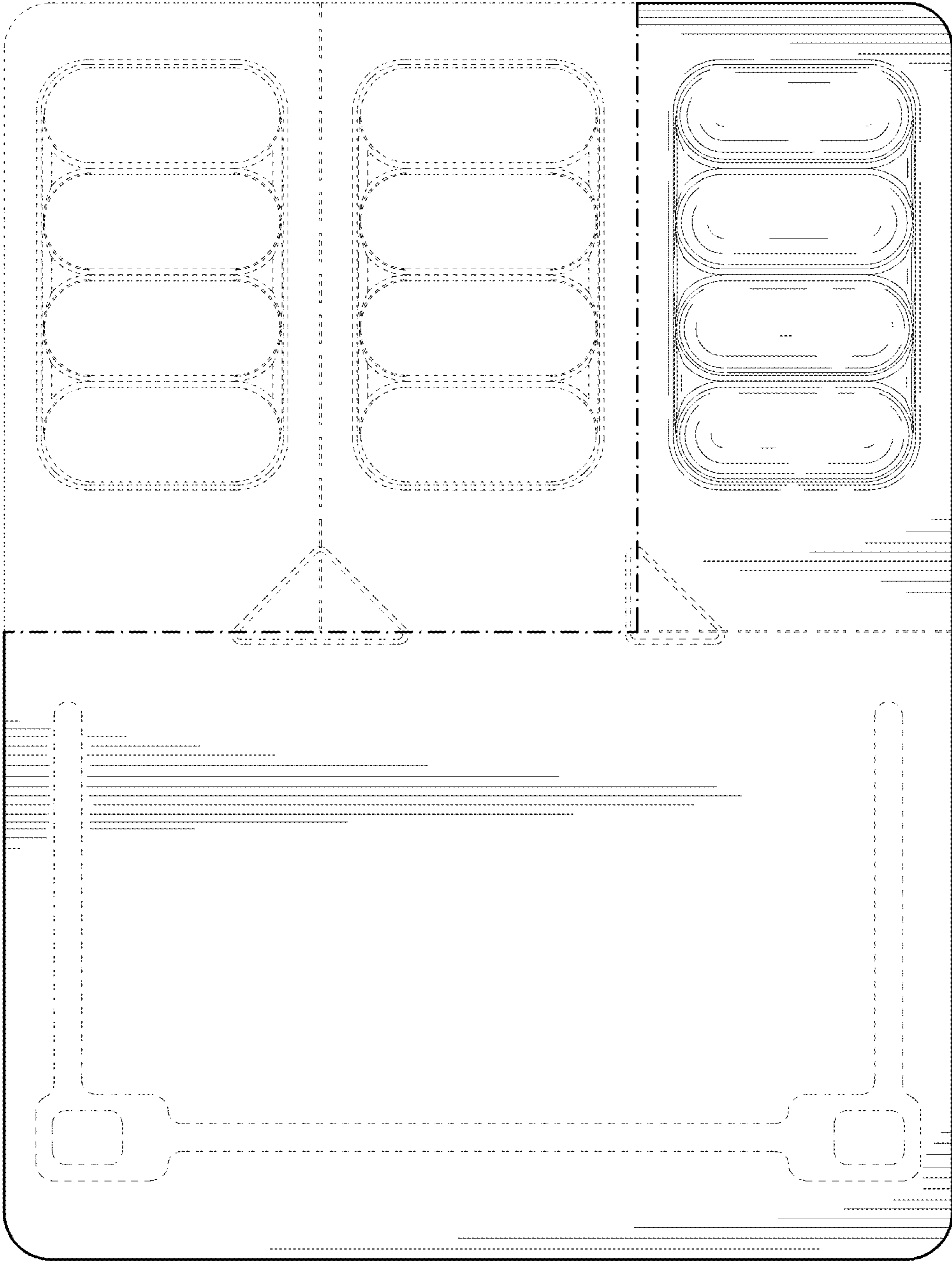
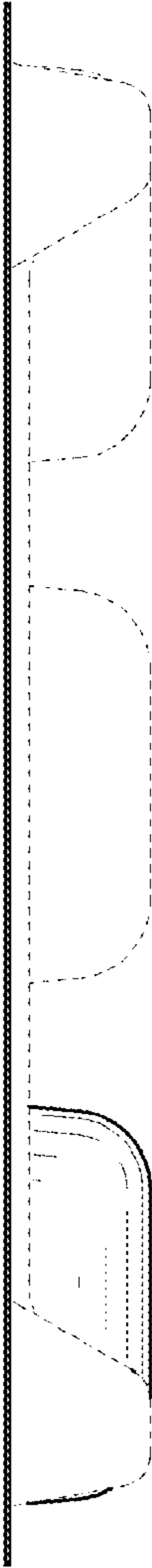


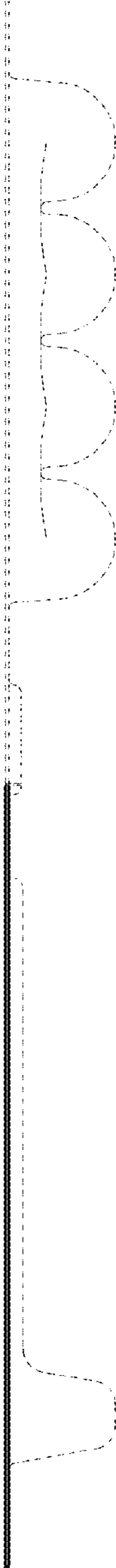

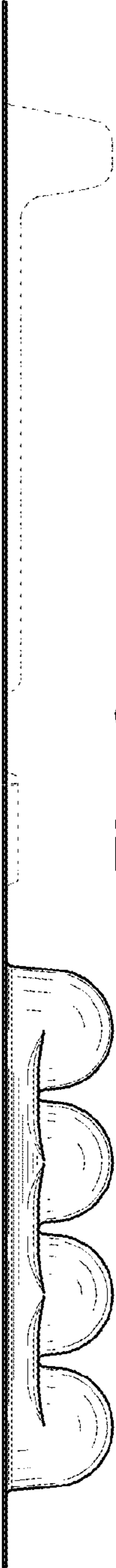

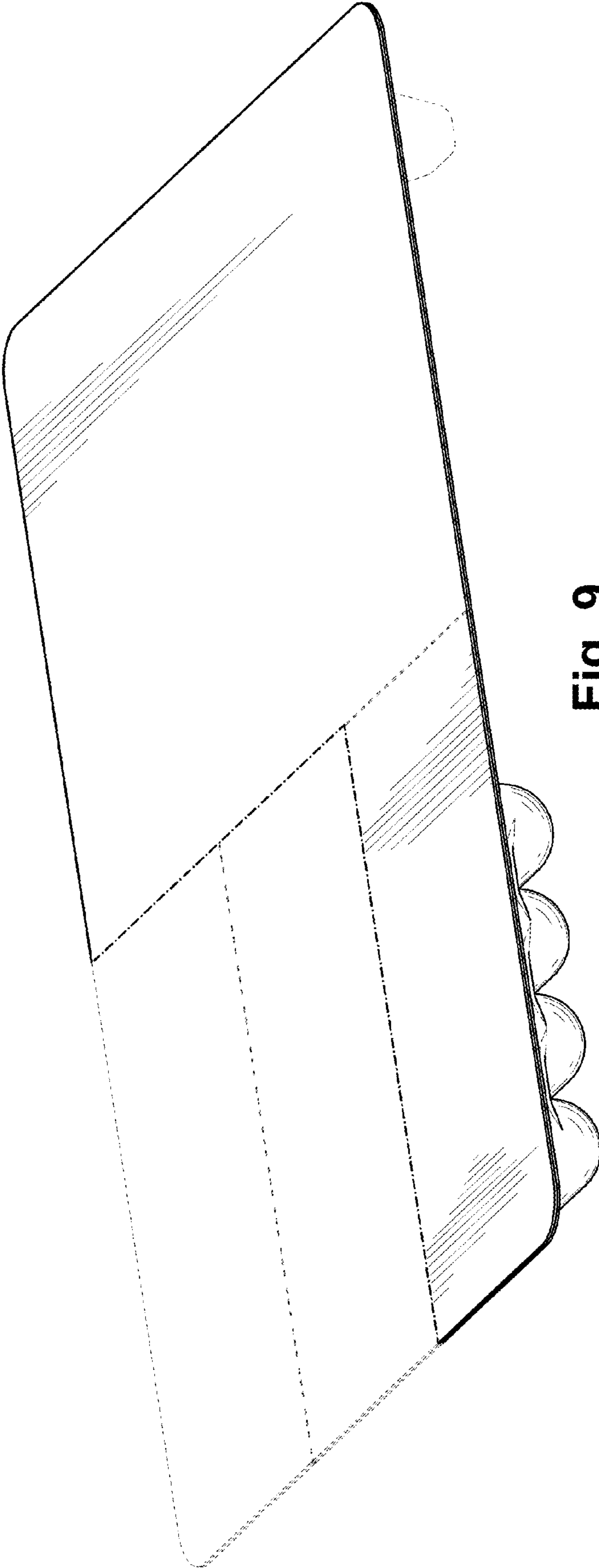

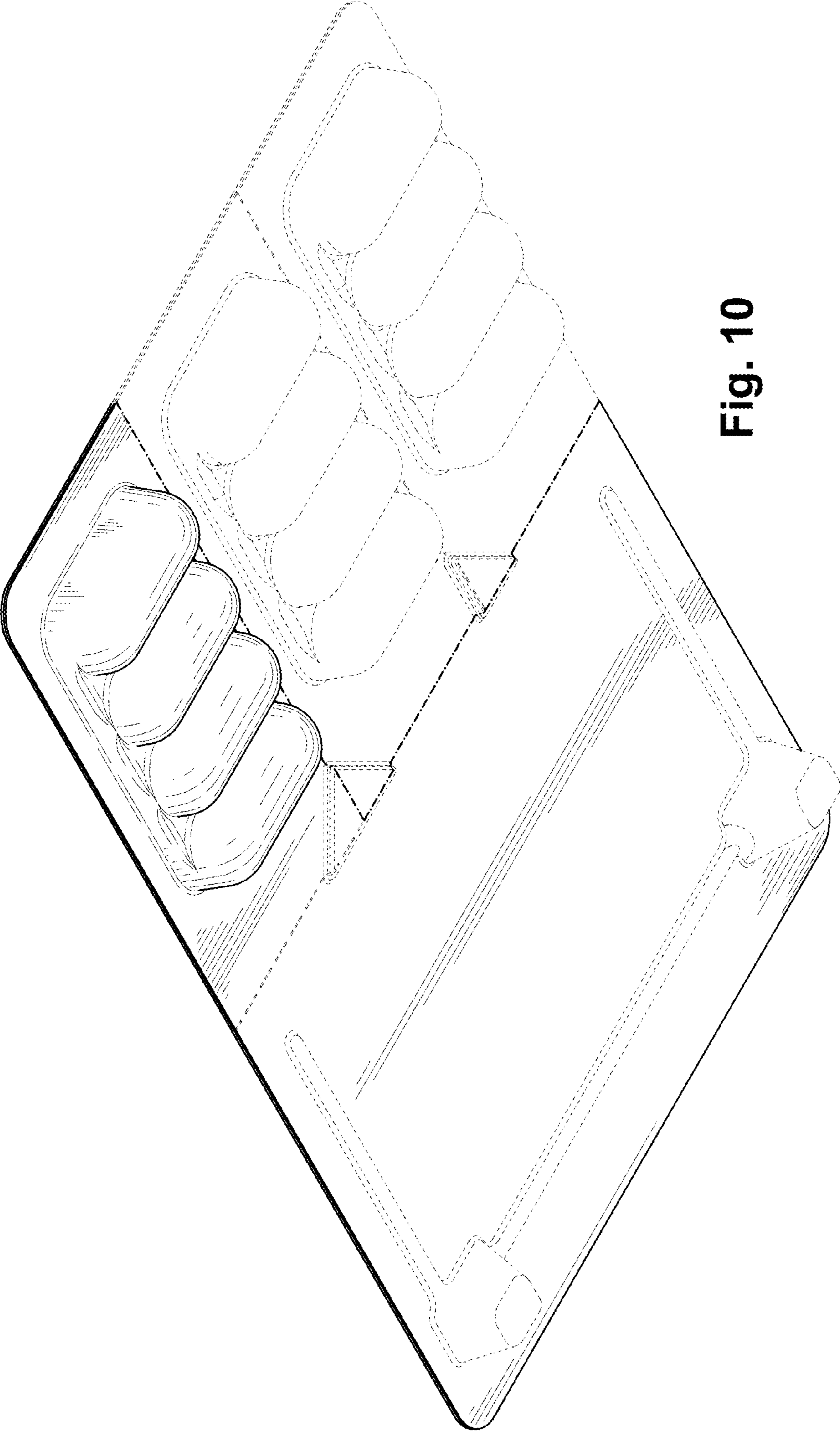
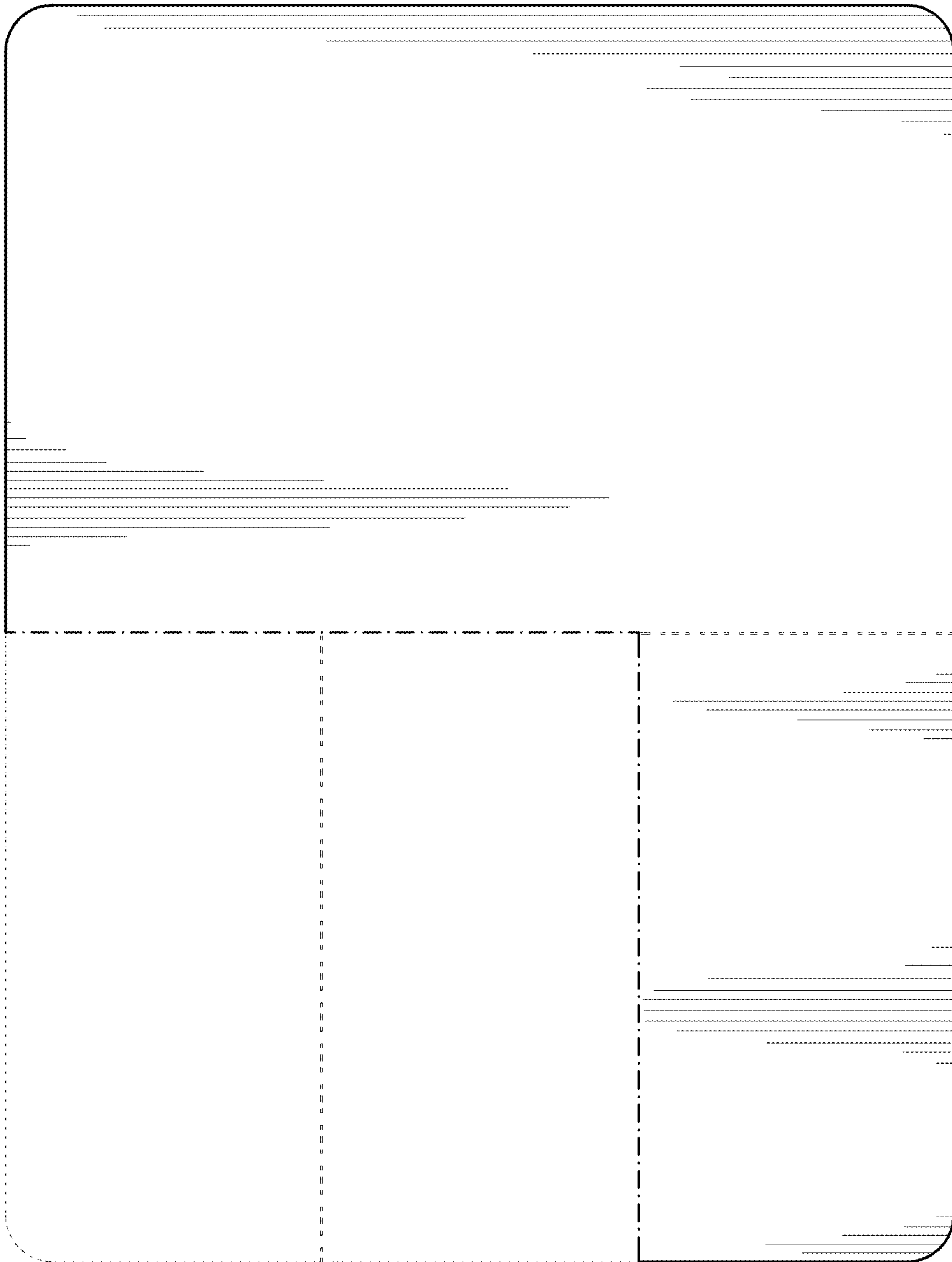

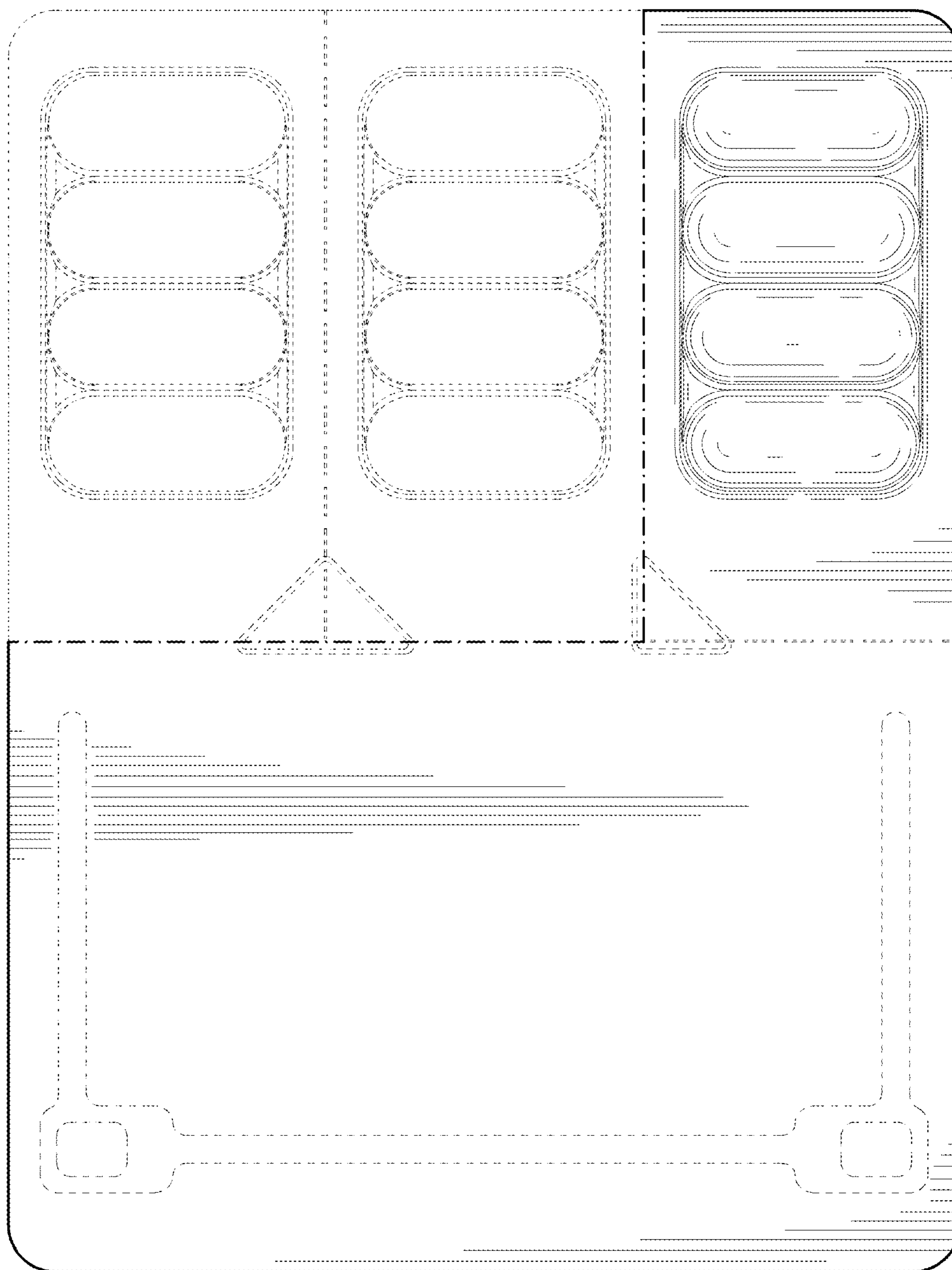
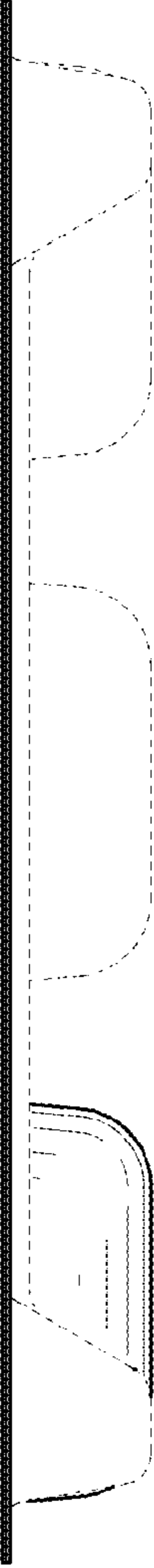


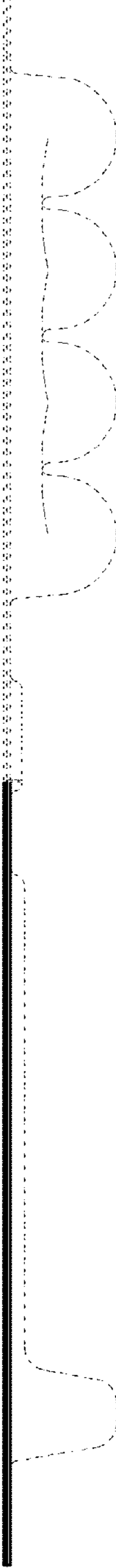

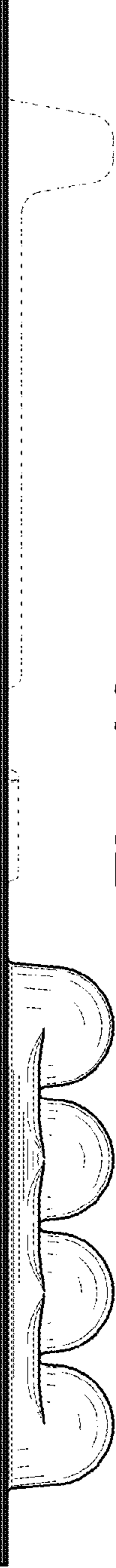
