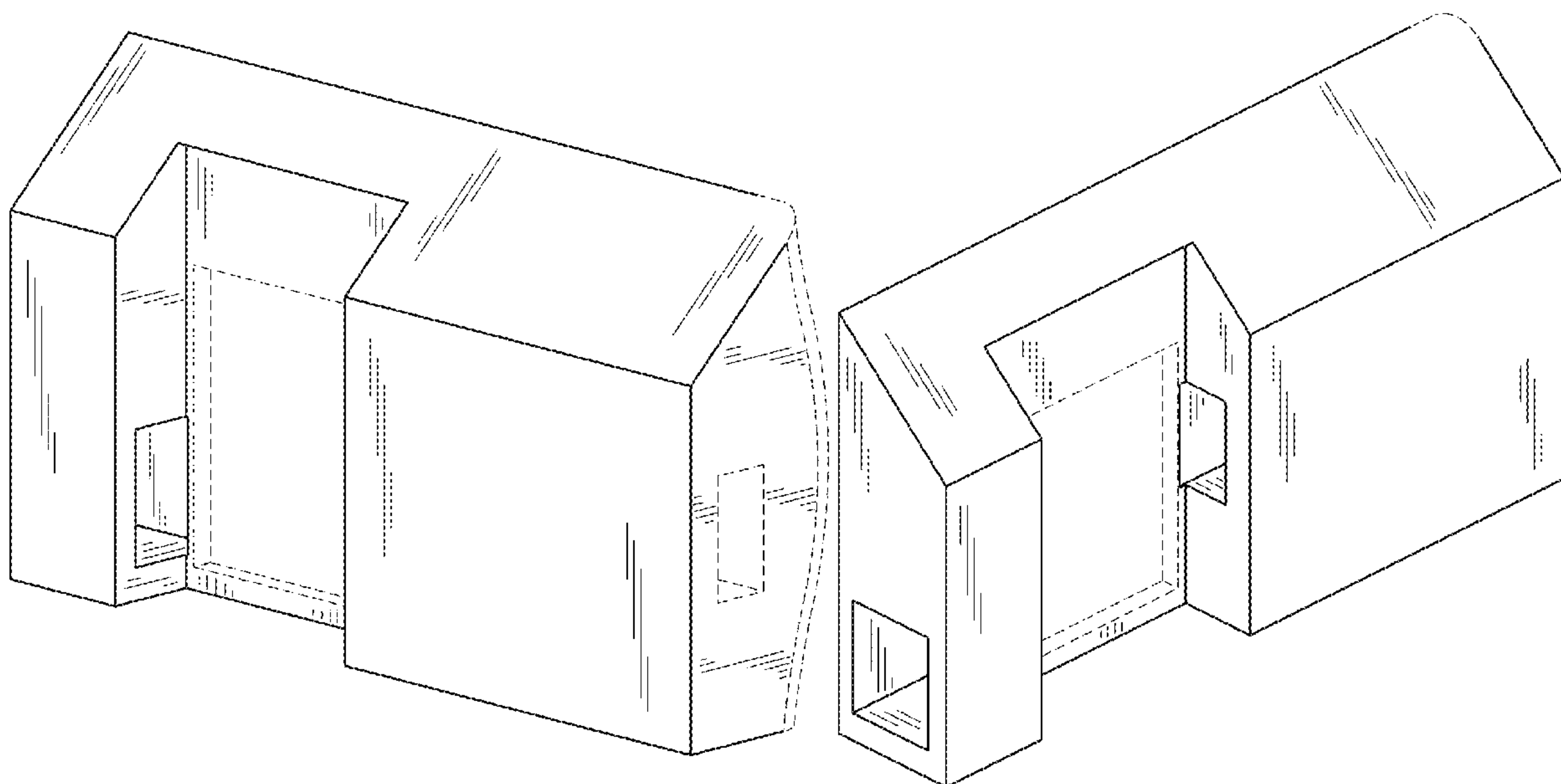
(57) **CLAIM**

The ornamental design for a component housing for water  
detection assembly, substantially as shown and described.

**DESCRIPTION**

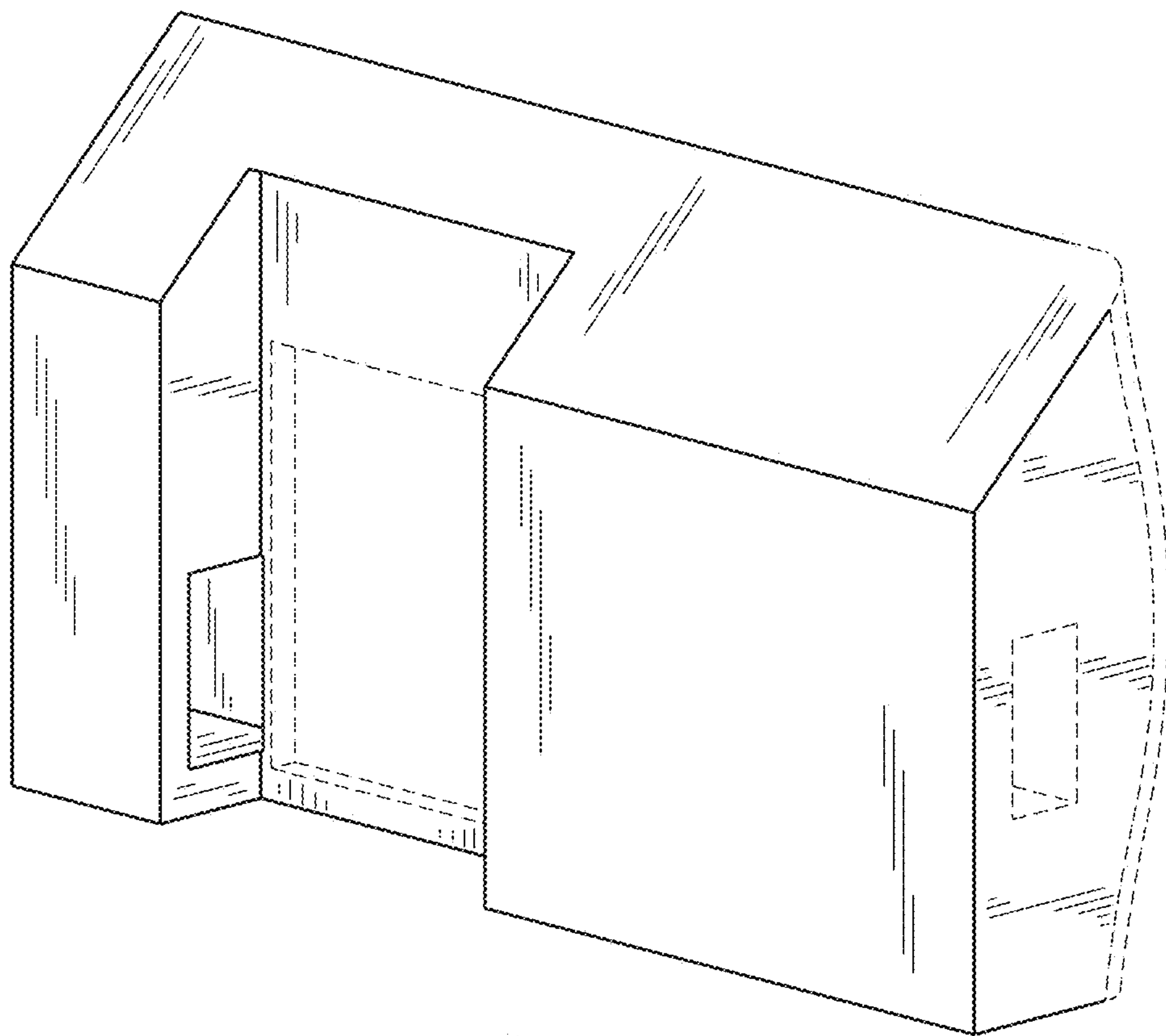

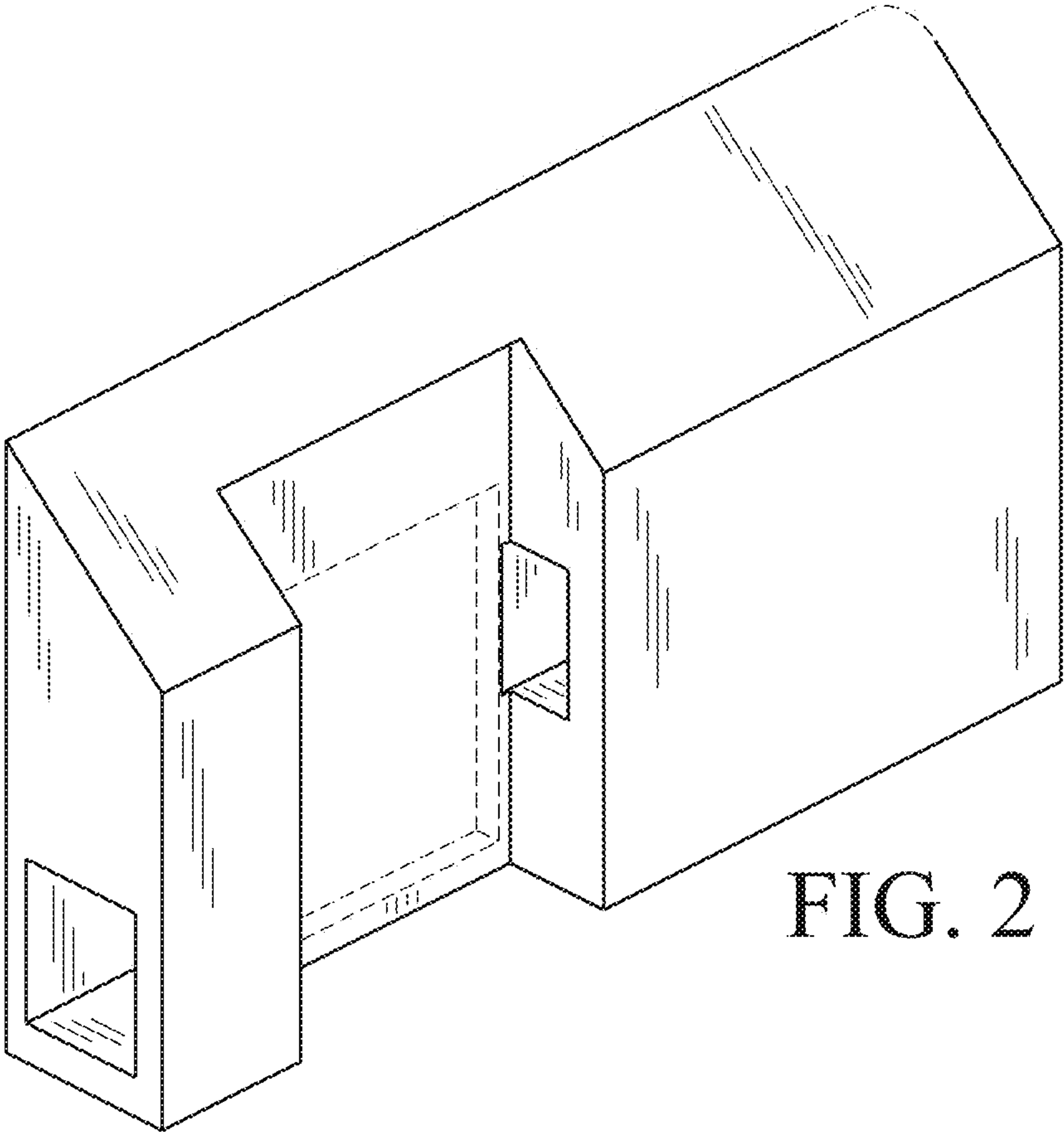

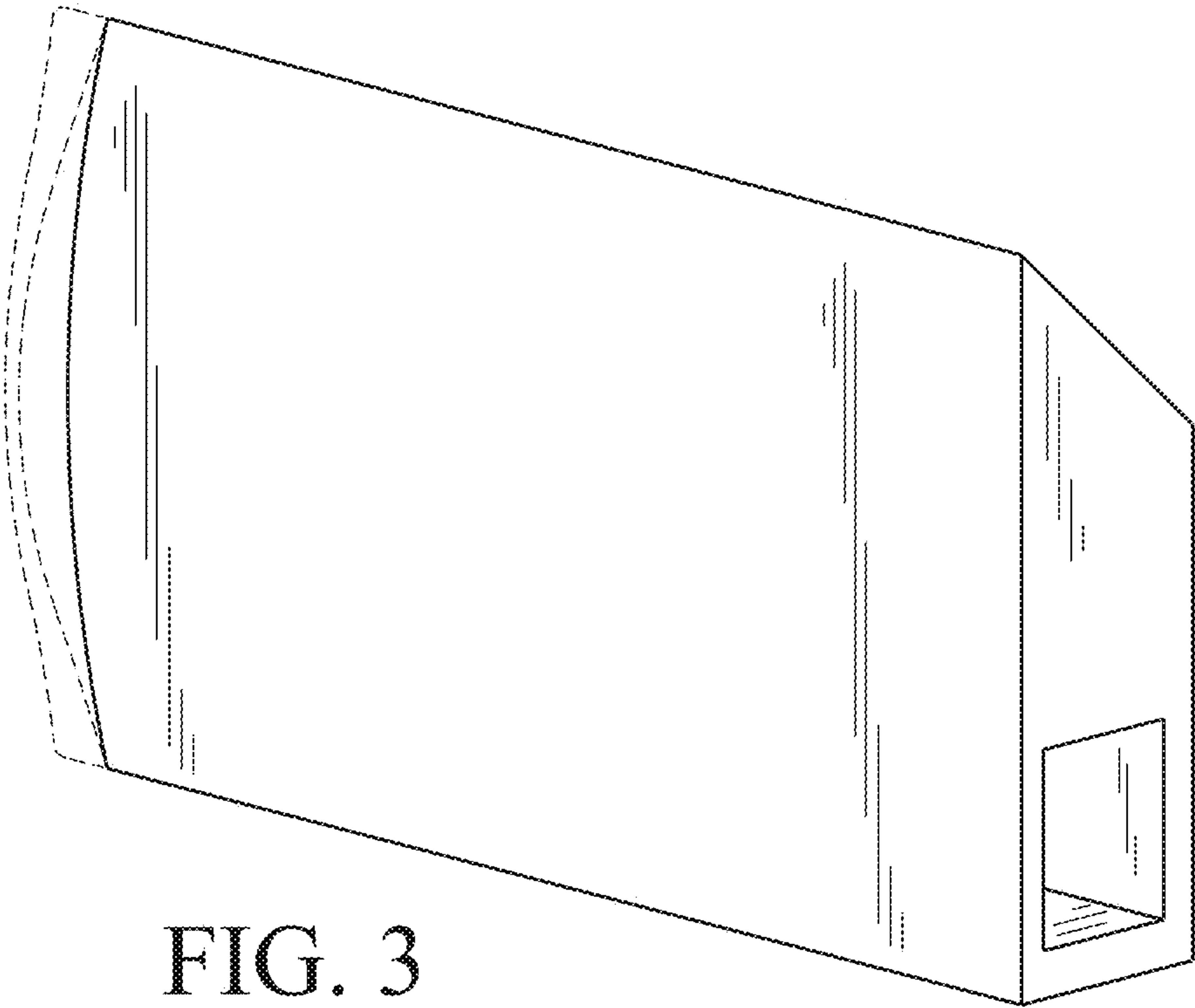

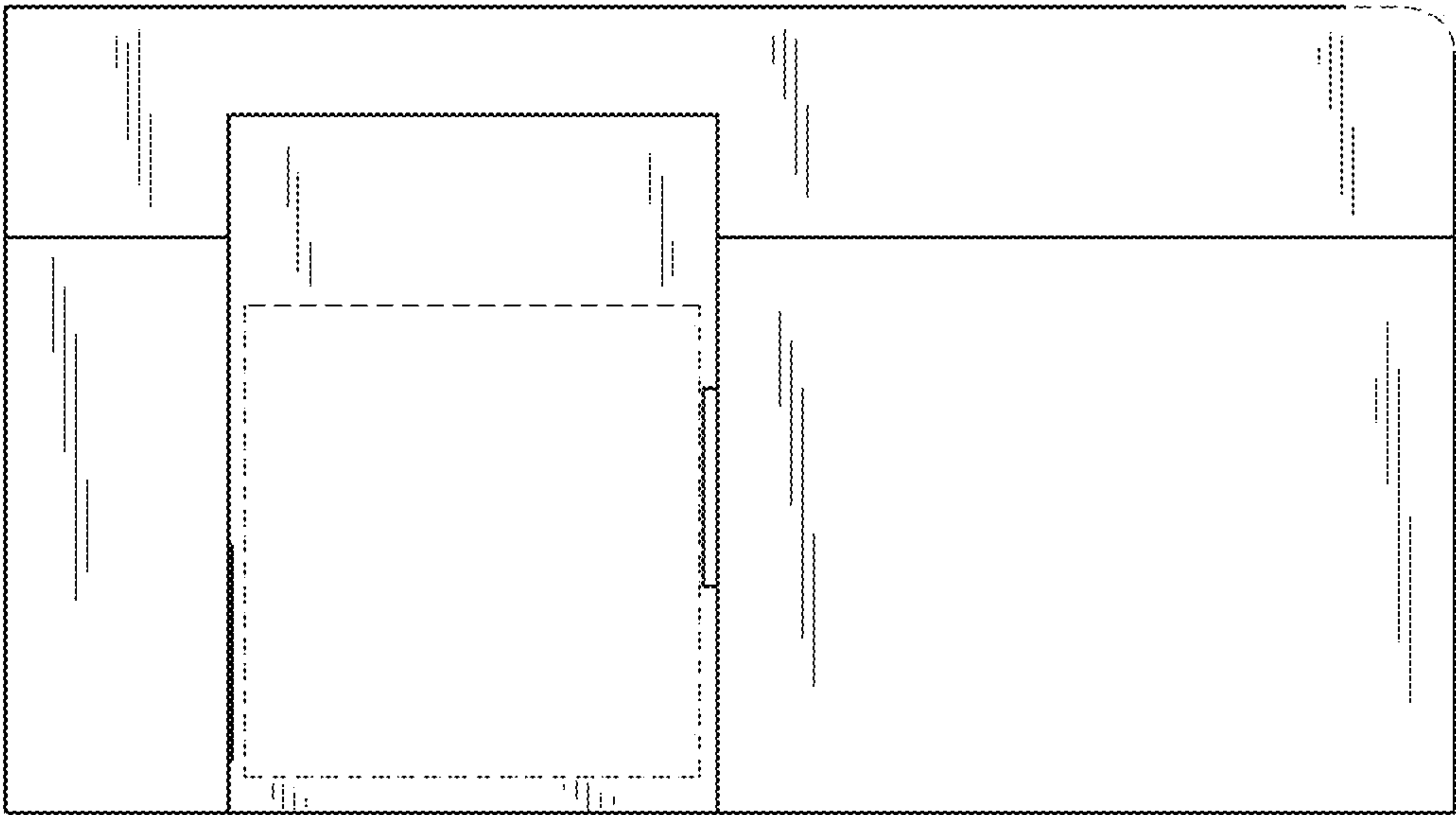

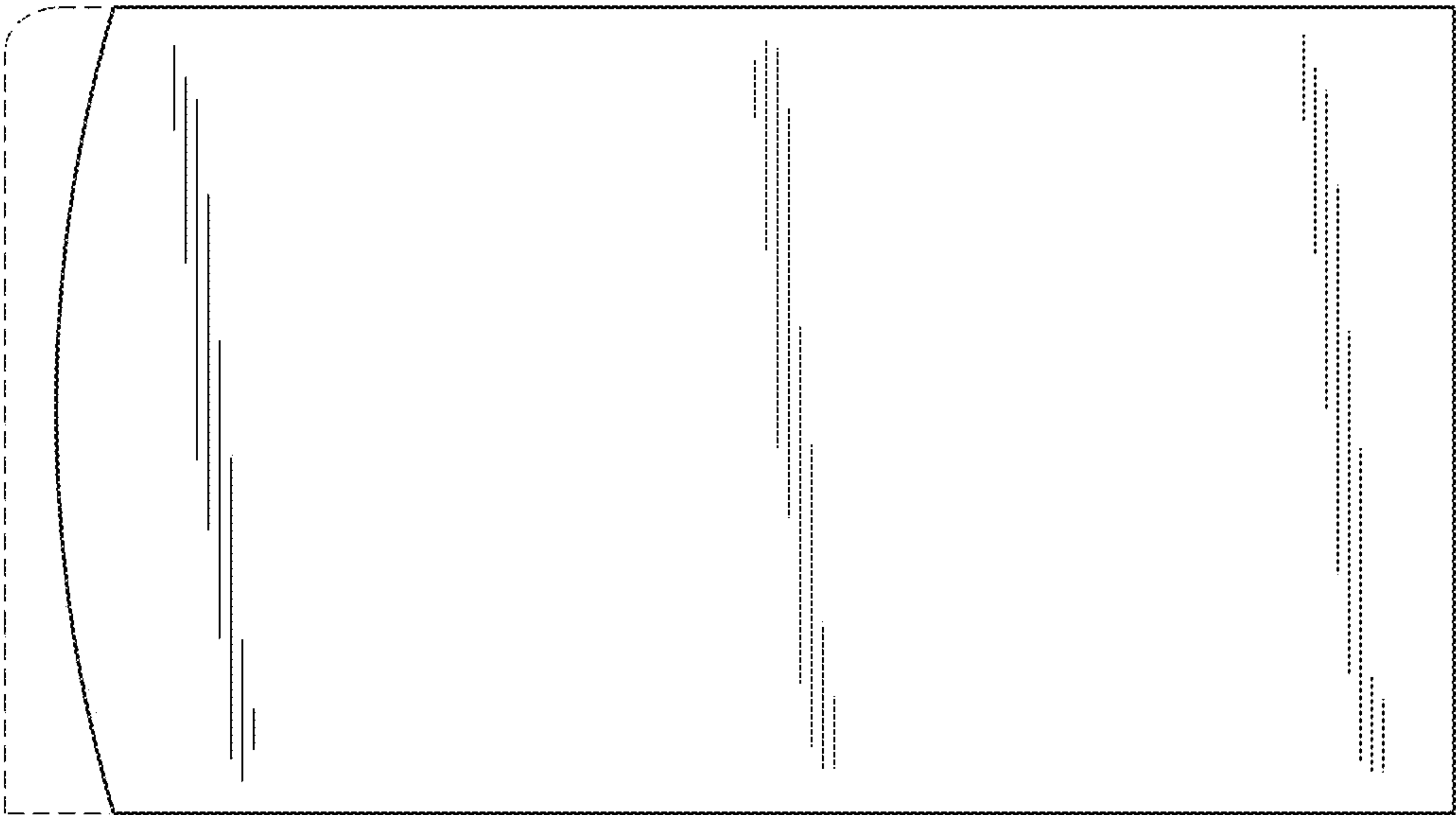

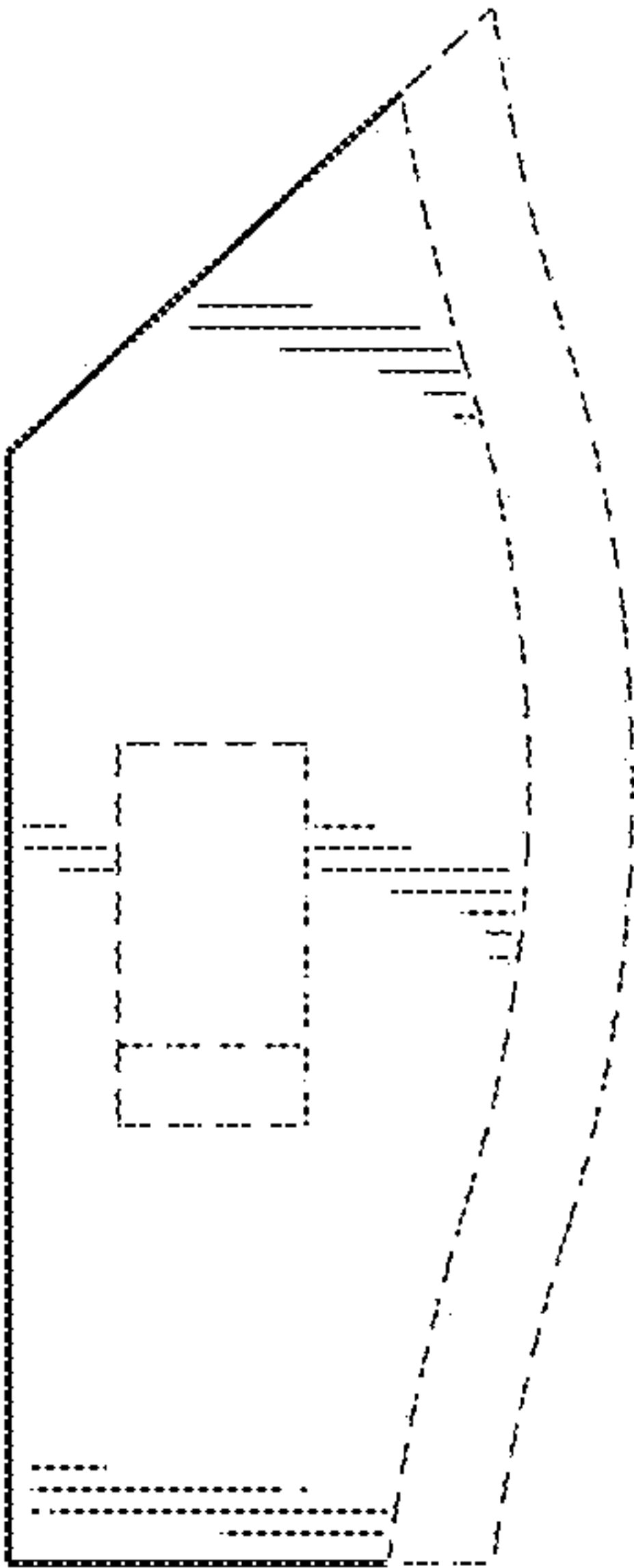
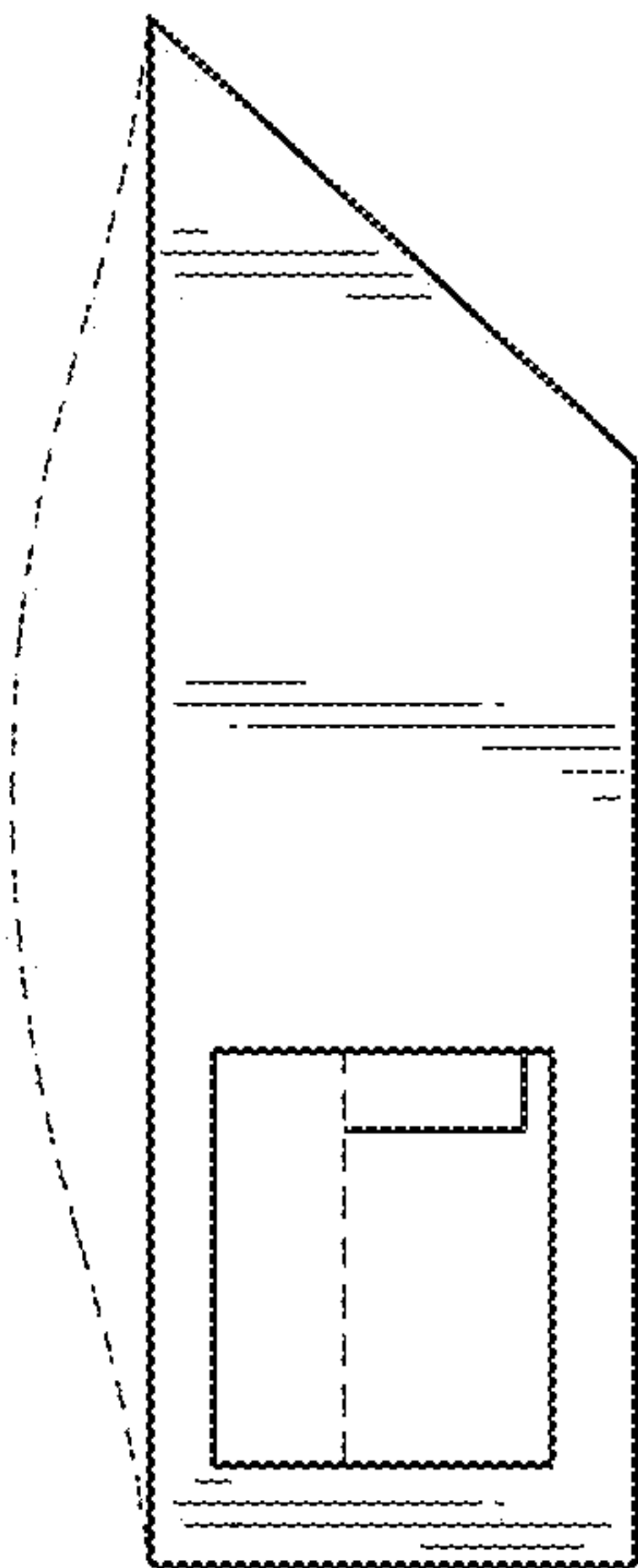

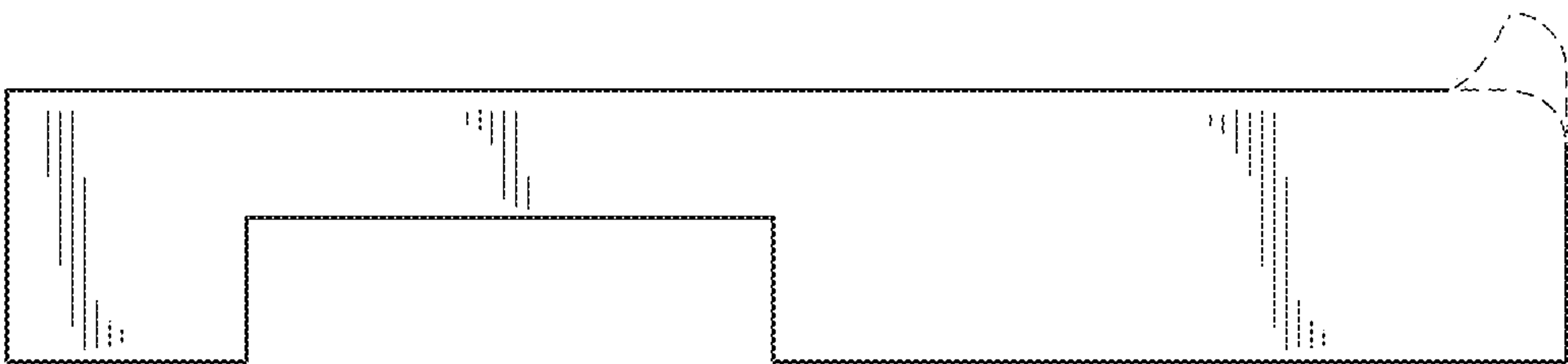

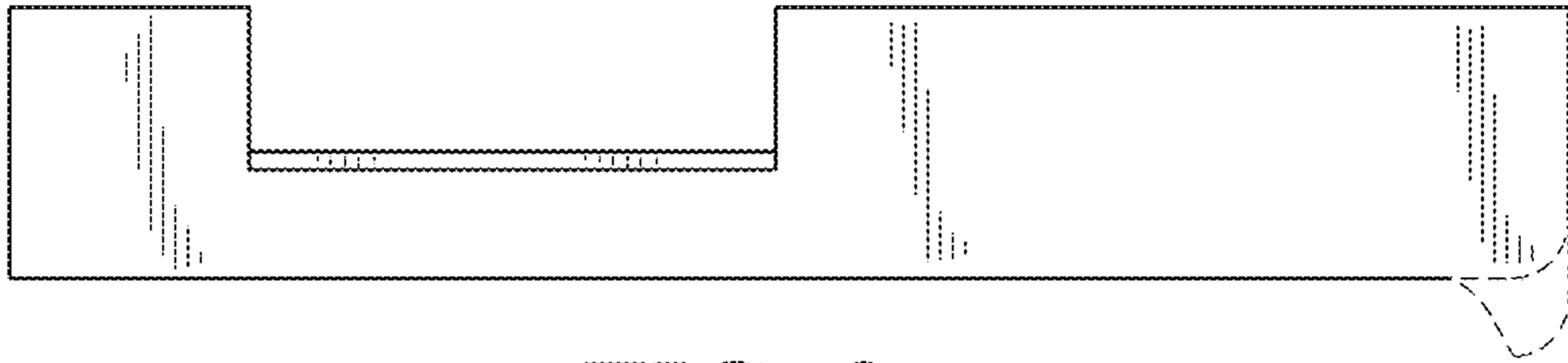
