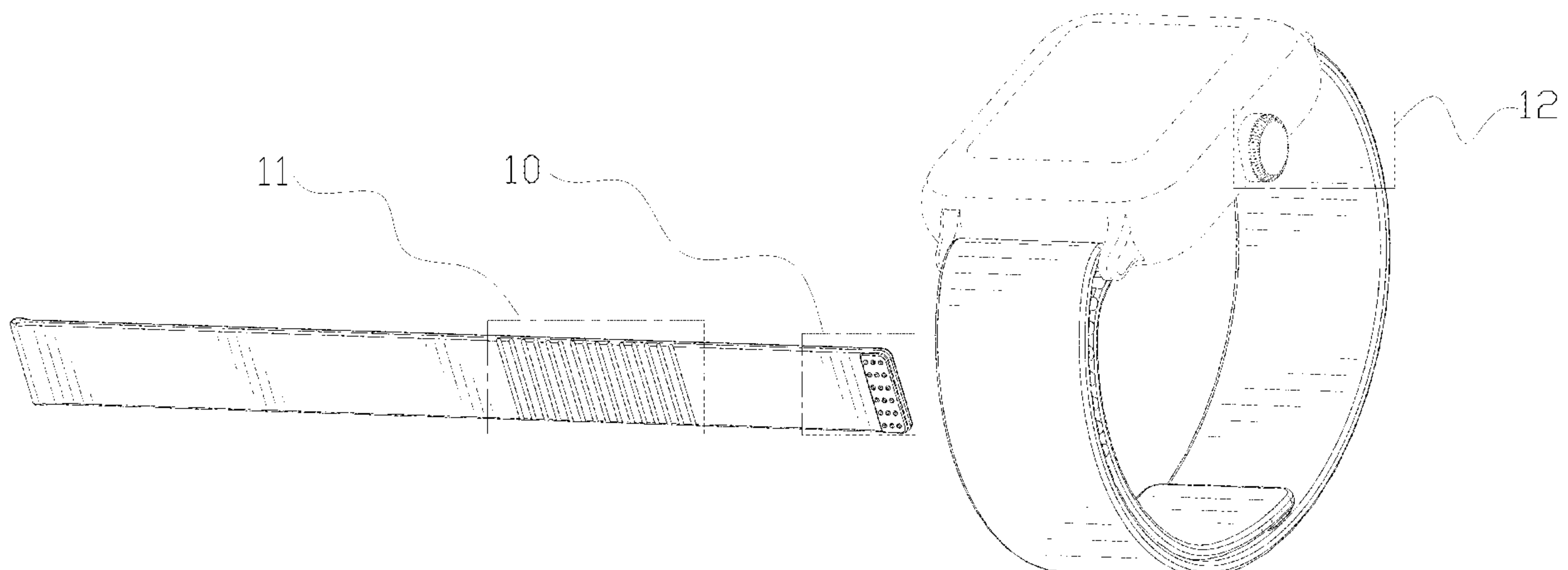
(57) **CLAIM**

The ornamental design for a strap, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a strap showing my new design;
FIG. 2 is another perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a top plan view thereof;
FIG. 8 is a bottom plan view thereof;
FIG. 9 is a perspective view of the strap where the strap is in a configuration of use;
FIG. 10 is an enlarged view of portion 10 shown in FIG. 1;
FIG. 11 is an enlarged view of portion 11 shown in FIG. 1; and,
FIG. 12 is an enlarged view of portion 12 shown in FIG. 9.
The broken lines in the drawings illustrate portions of the strap that form no part of the claimed design. The other broken lines in FIG. 9 and FIG. 10, showing a watch device, represent environmental subject matter only and form no part of the claimed design.

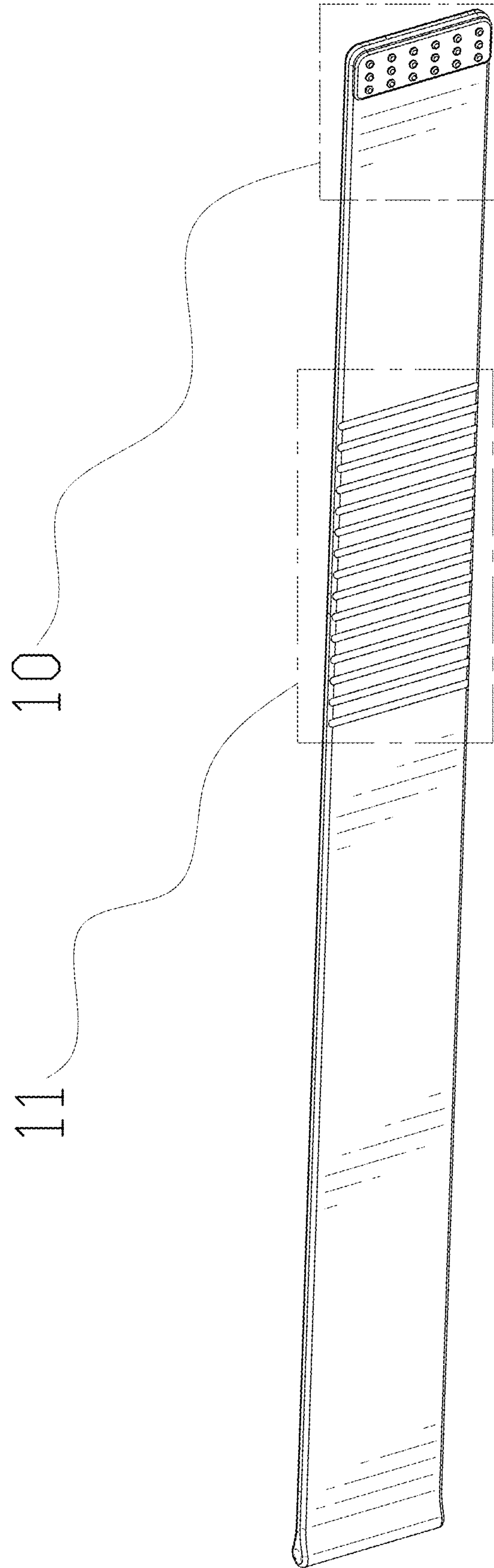

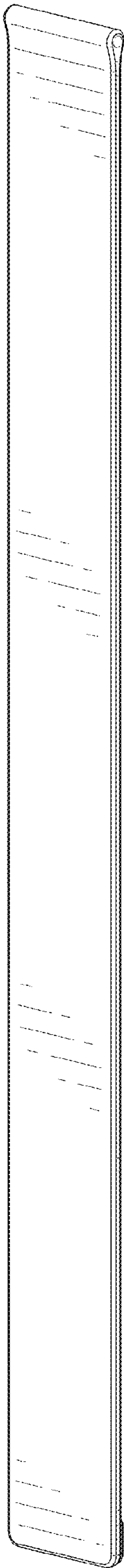

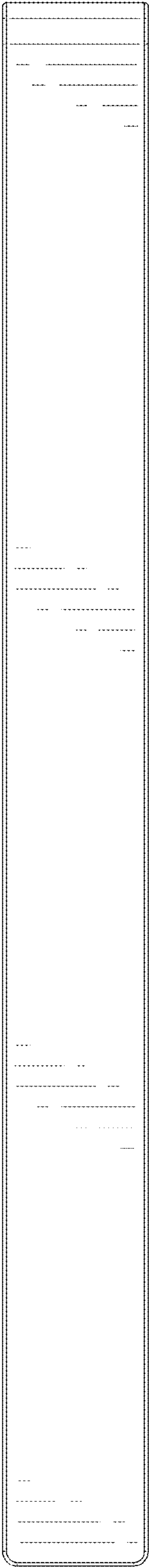

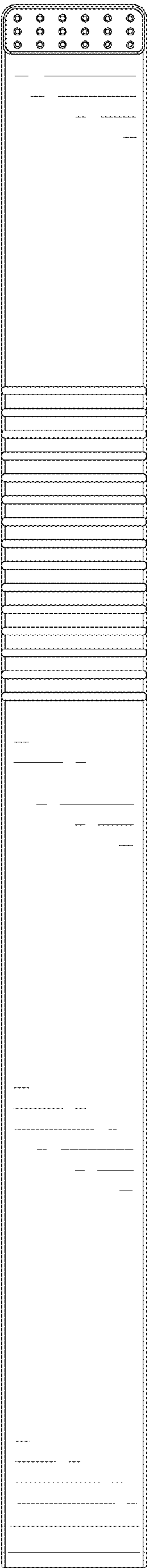

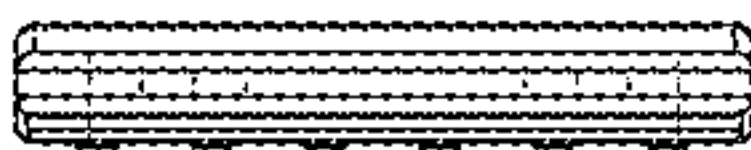

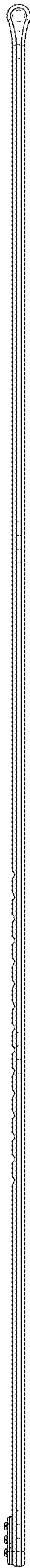

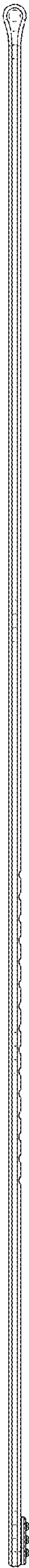

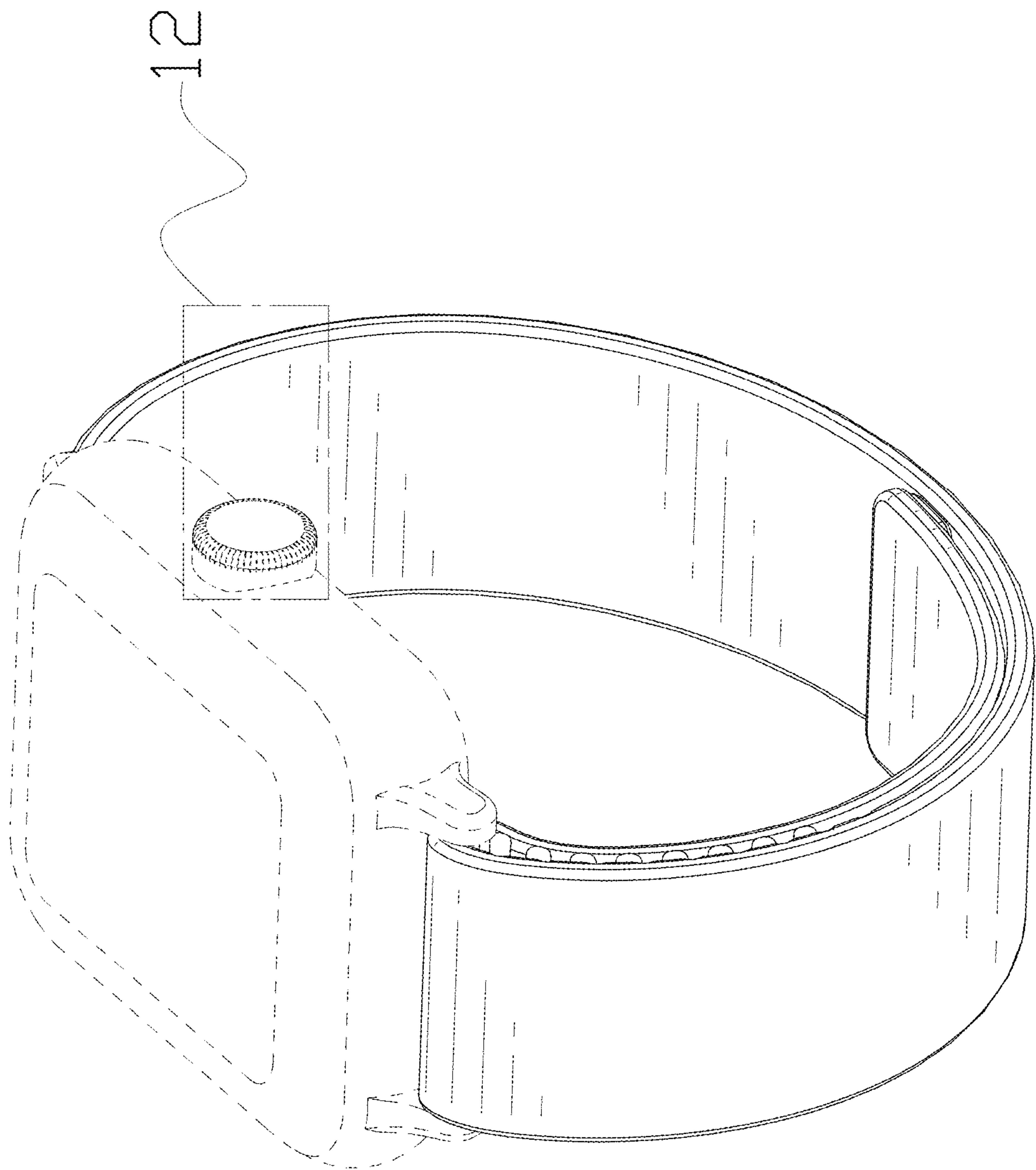

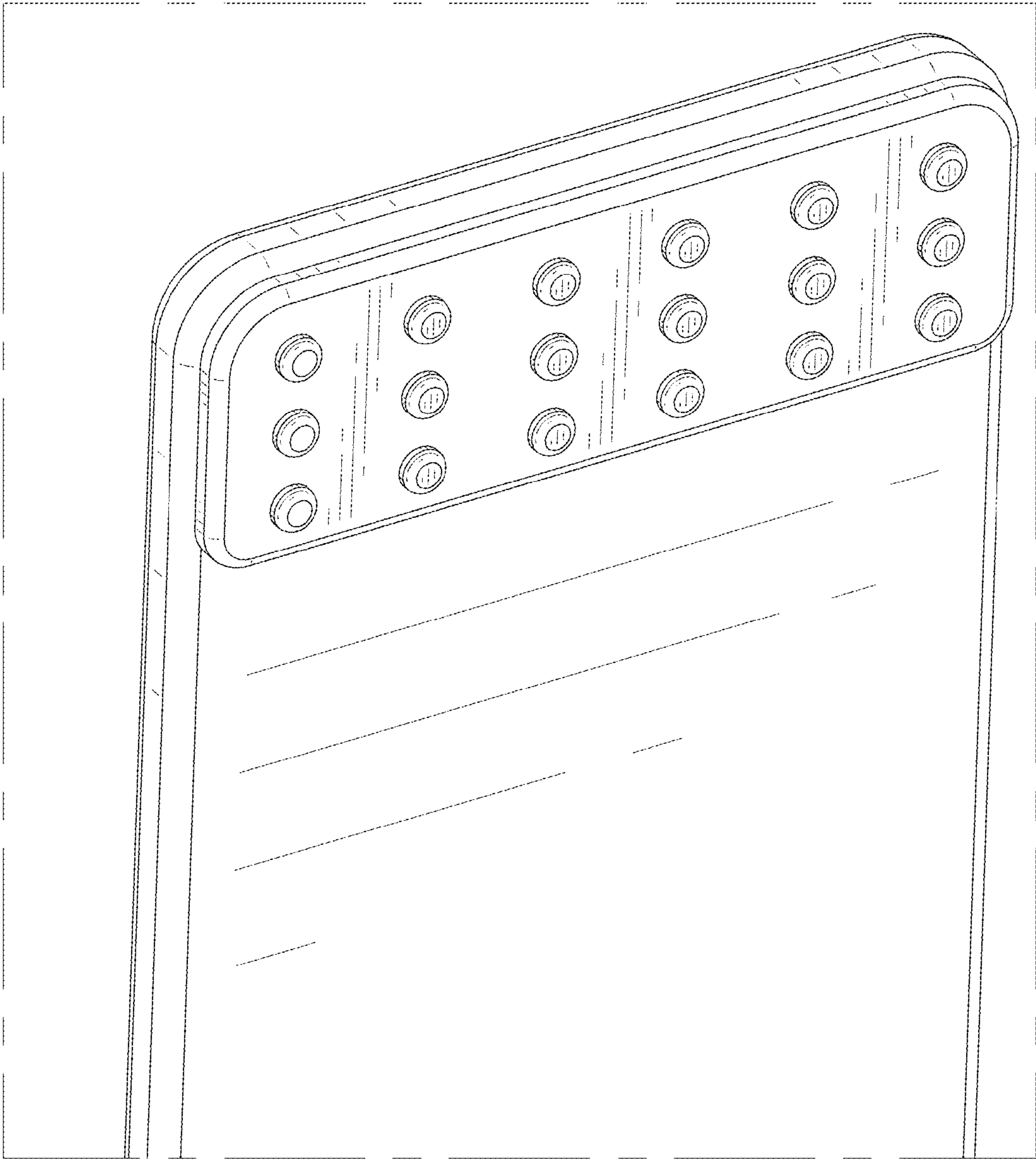

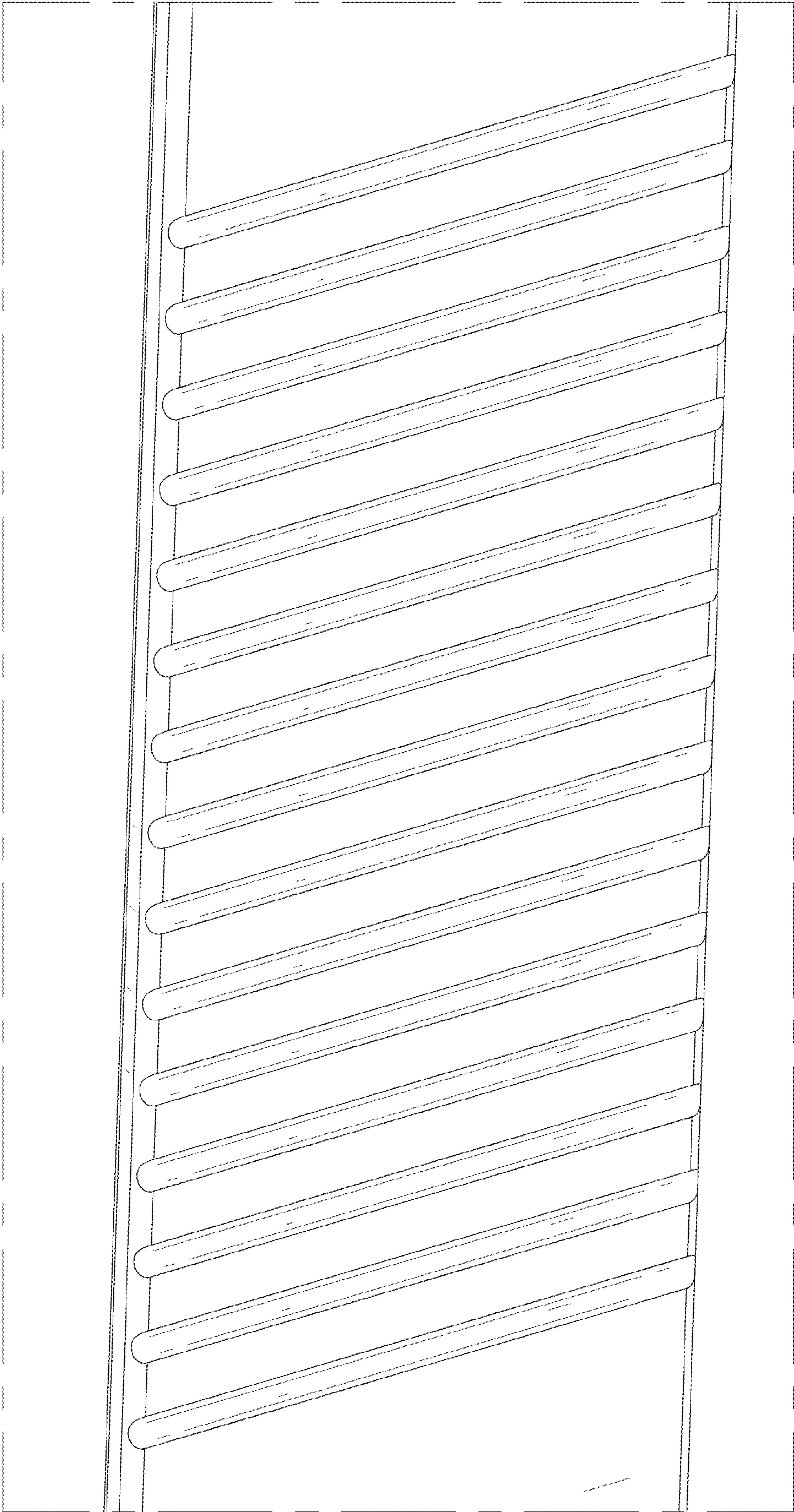

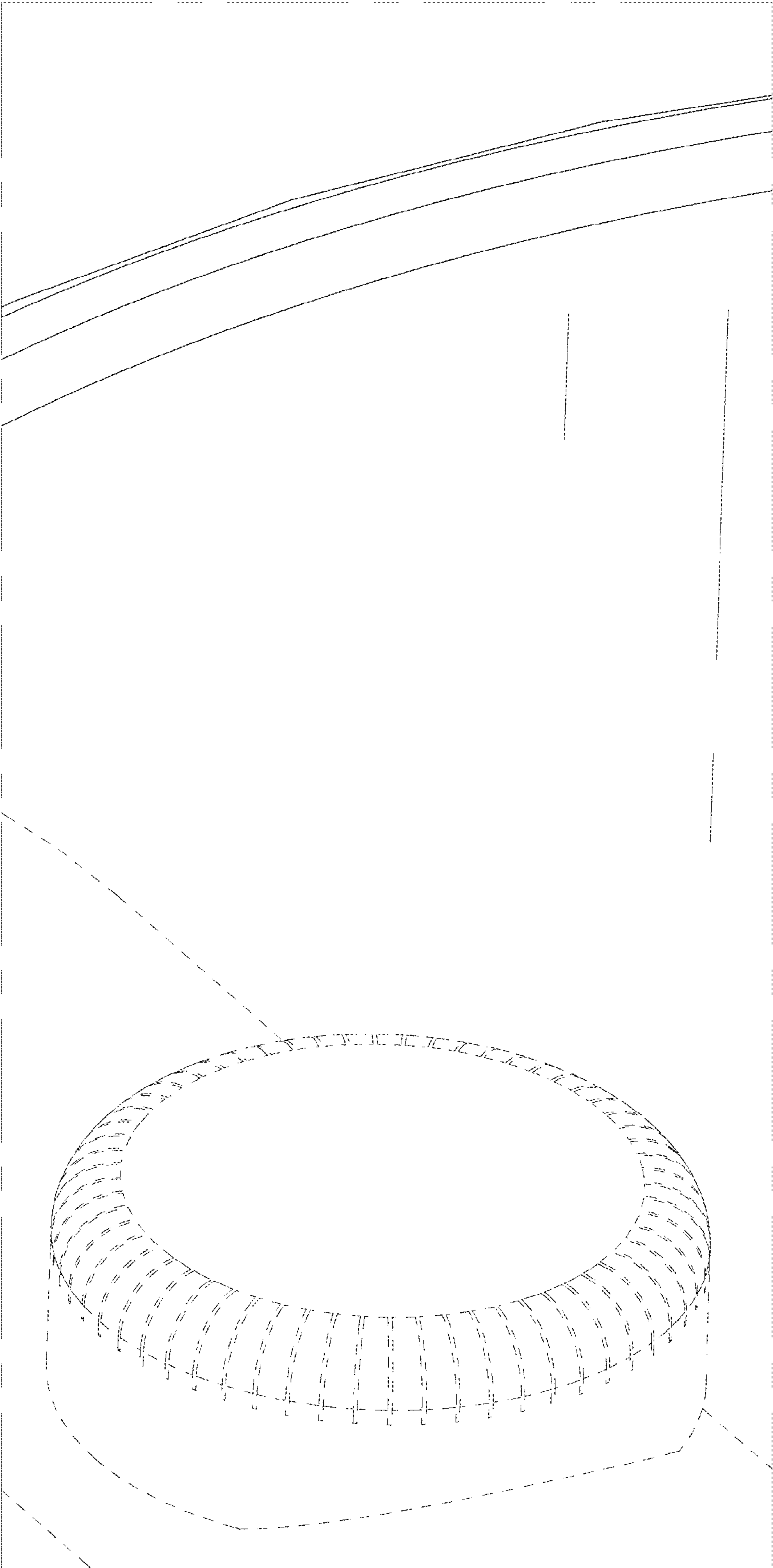
