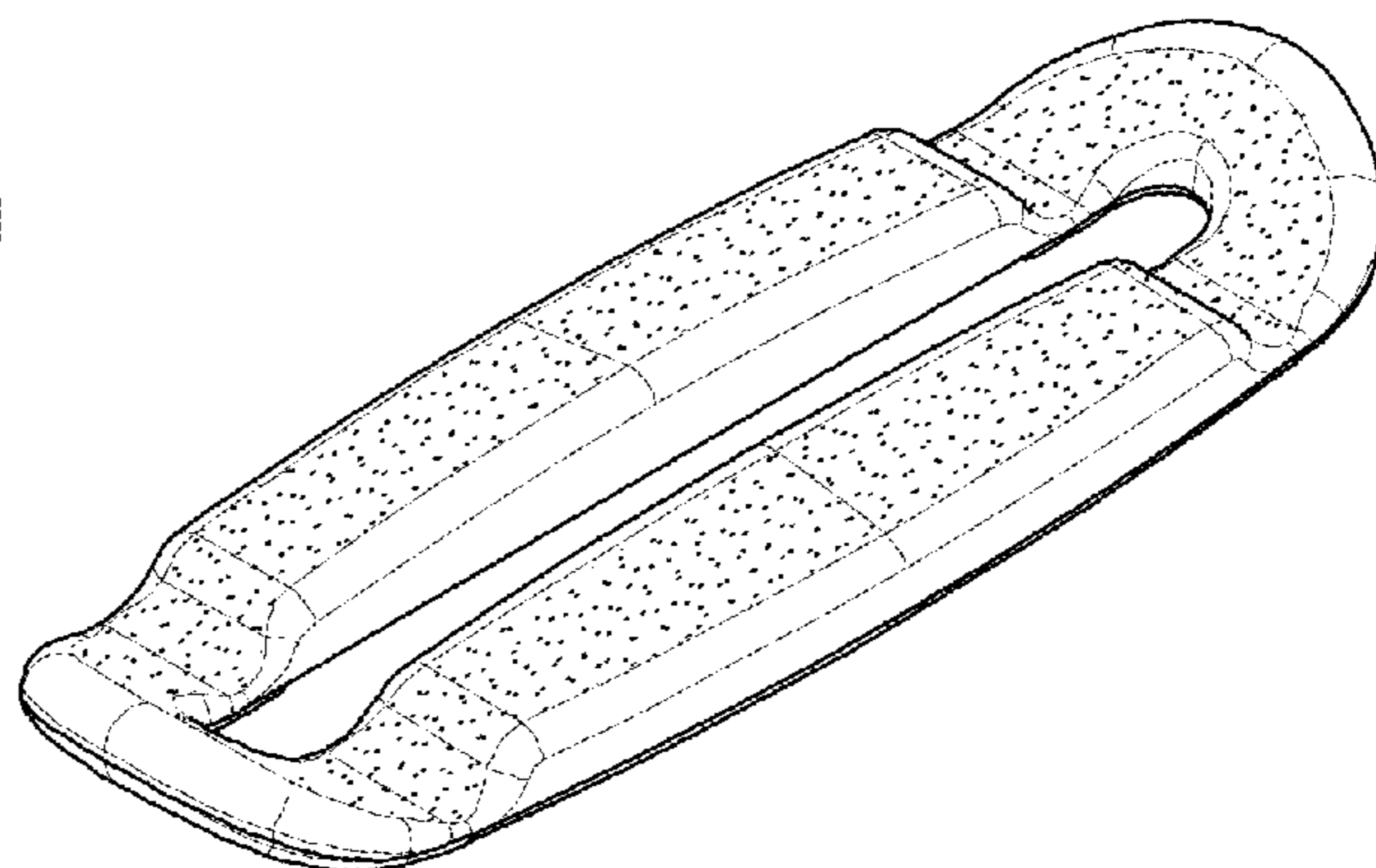
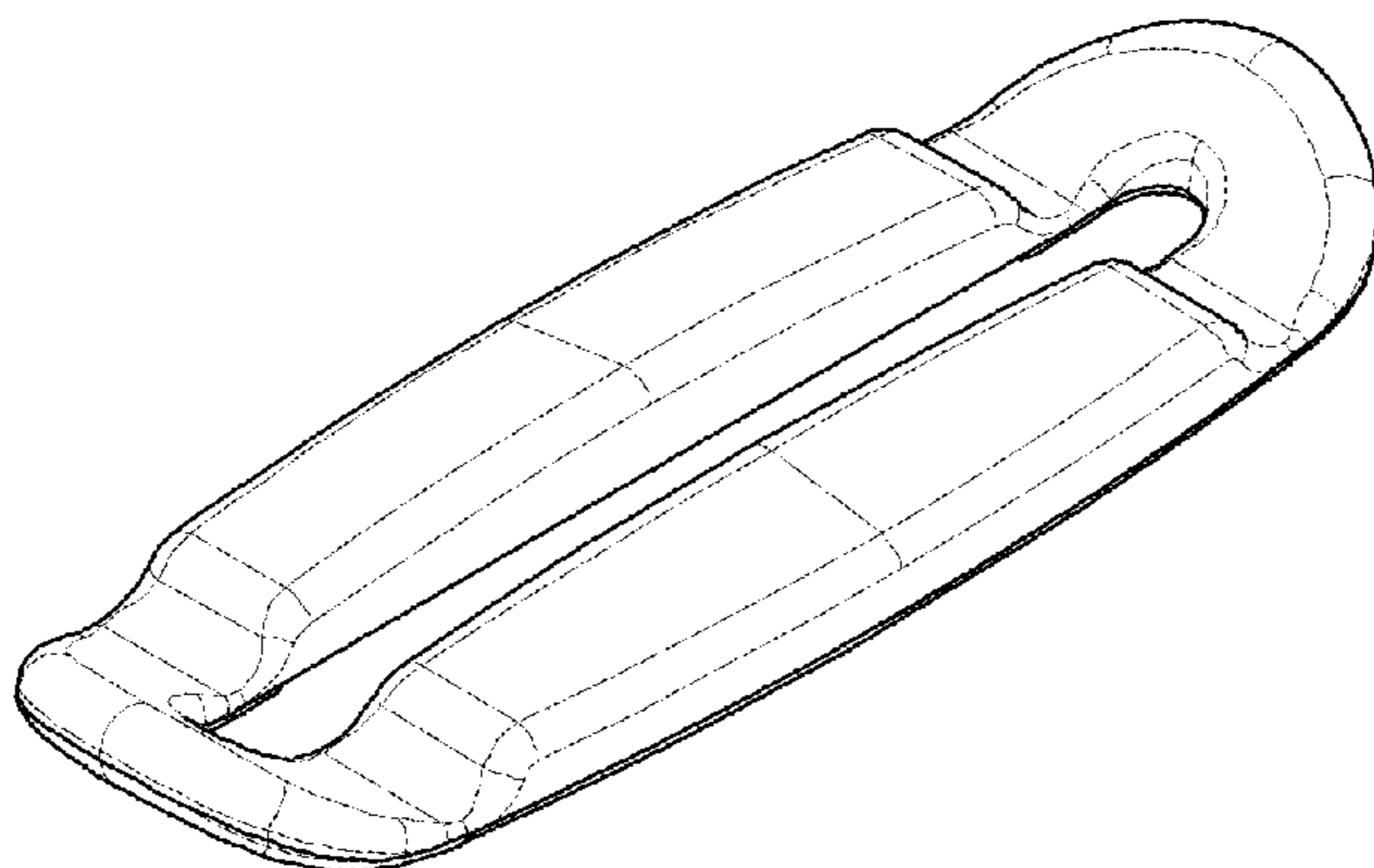
(57) **CLAIM**

The ornamental design for a link for a strap, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a link for a strap showing our new design;
 FIG. 2 is a front elevation view thereof;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a bottom plan view thereof;
 FIG. 5 is a left side elevation view thereof;
 FIG. 6 is a right side elevation view thereof;
 FIG. 7 is a front perspective view of another embodiment of the link for a strap;
 FIG. 8 is a front elevation view thereof;
 FIG. 9 is a top plan view thereof;
 FIG. 10 is a bottom plan view thereof;
 FIG. 11 is a left side elevation view thereof; and,
 FIG. 12 is a right side elevation view thereof.
 In FIGS. 7-12, the areas of stippling represent regions having a textured surface, while the rest of the surfaces are smooth.

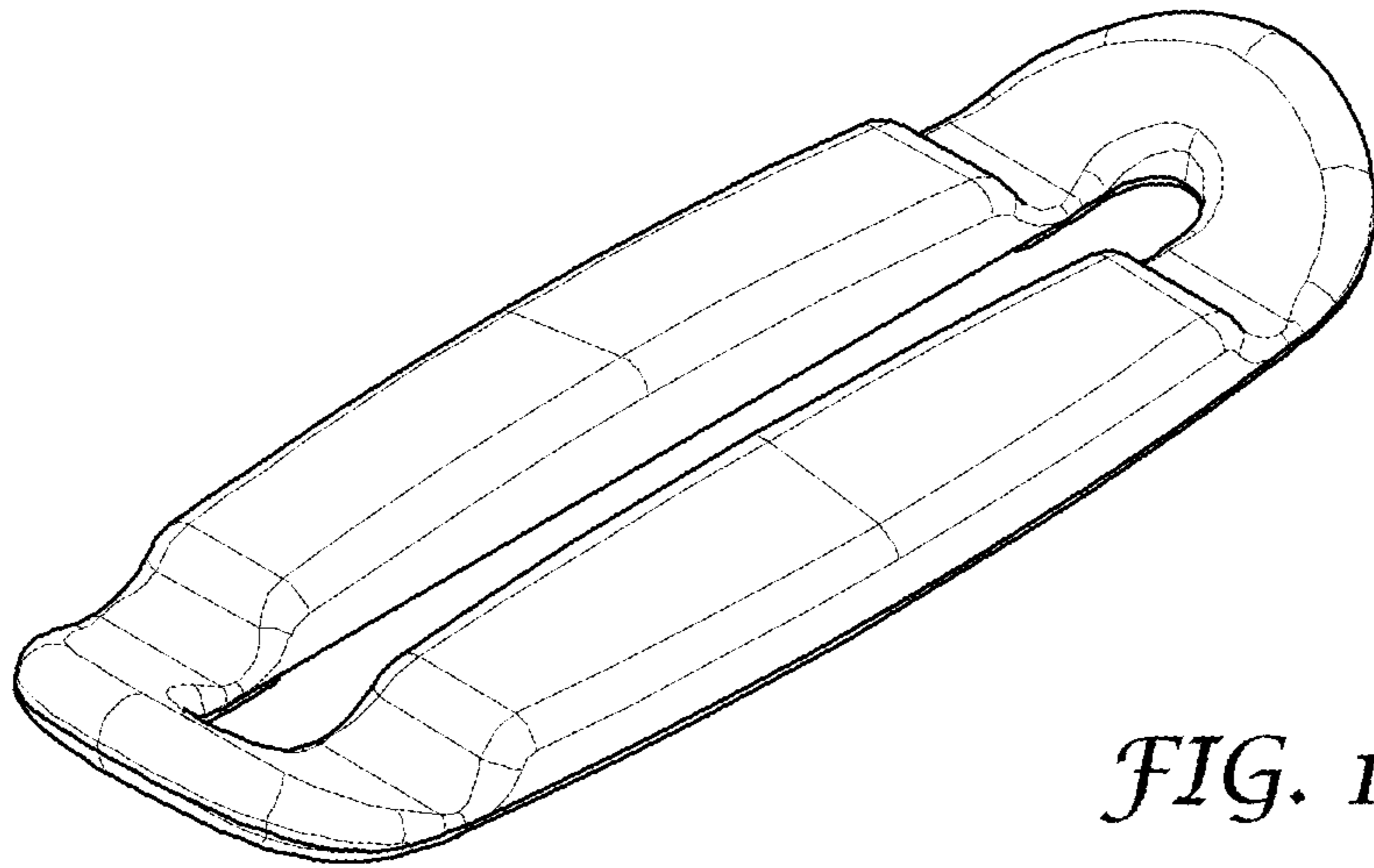

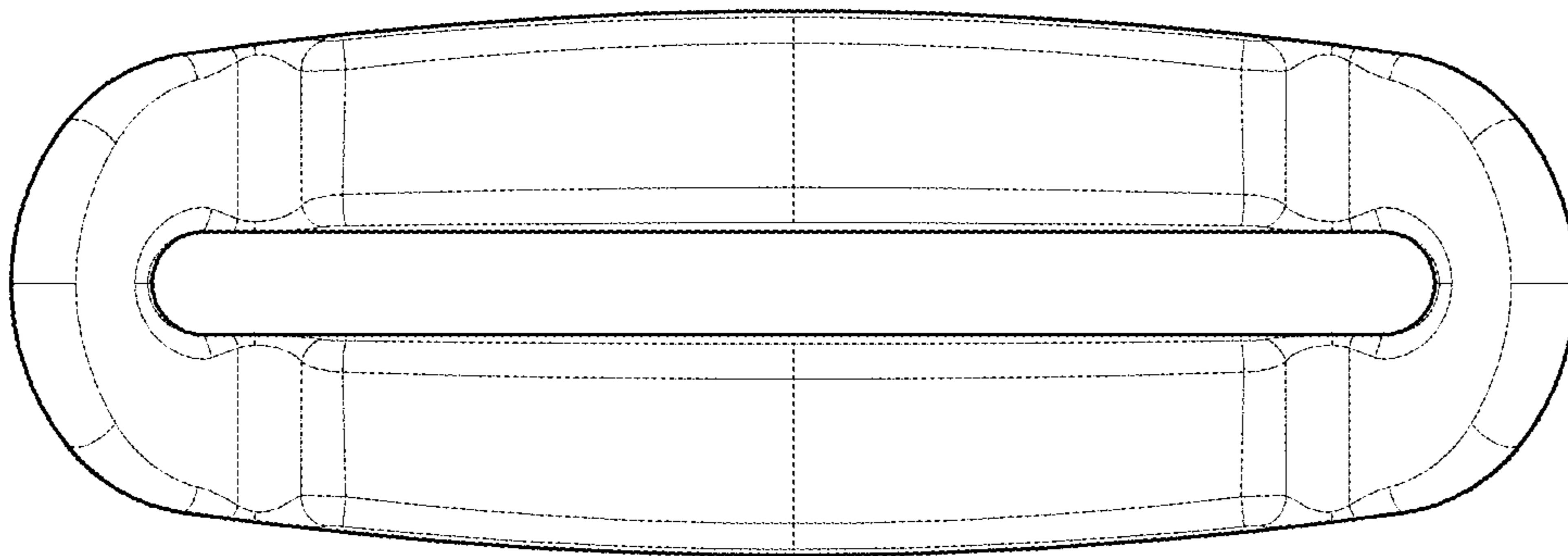

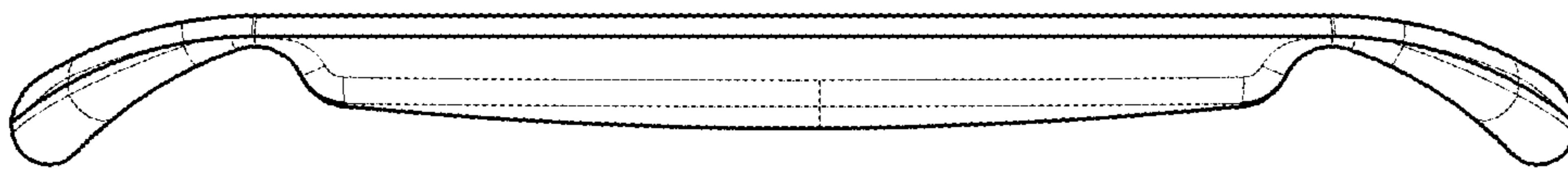

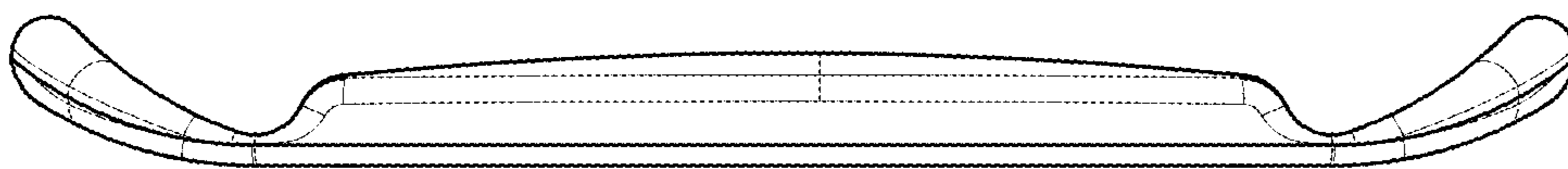

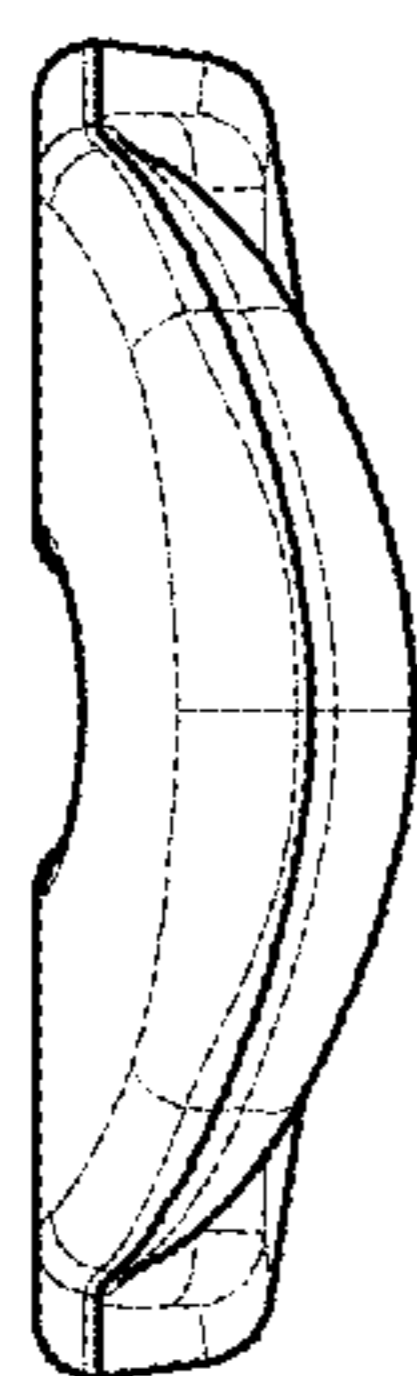

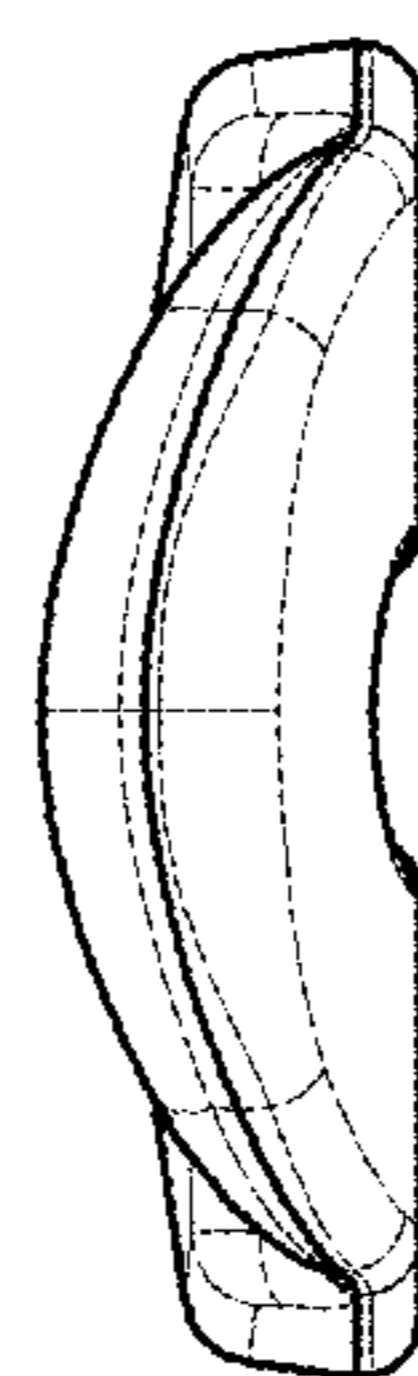

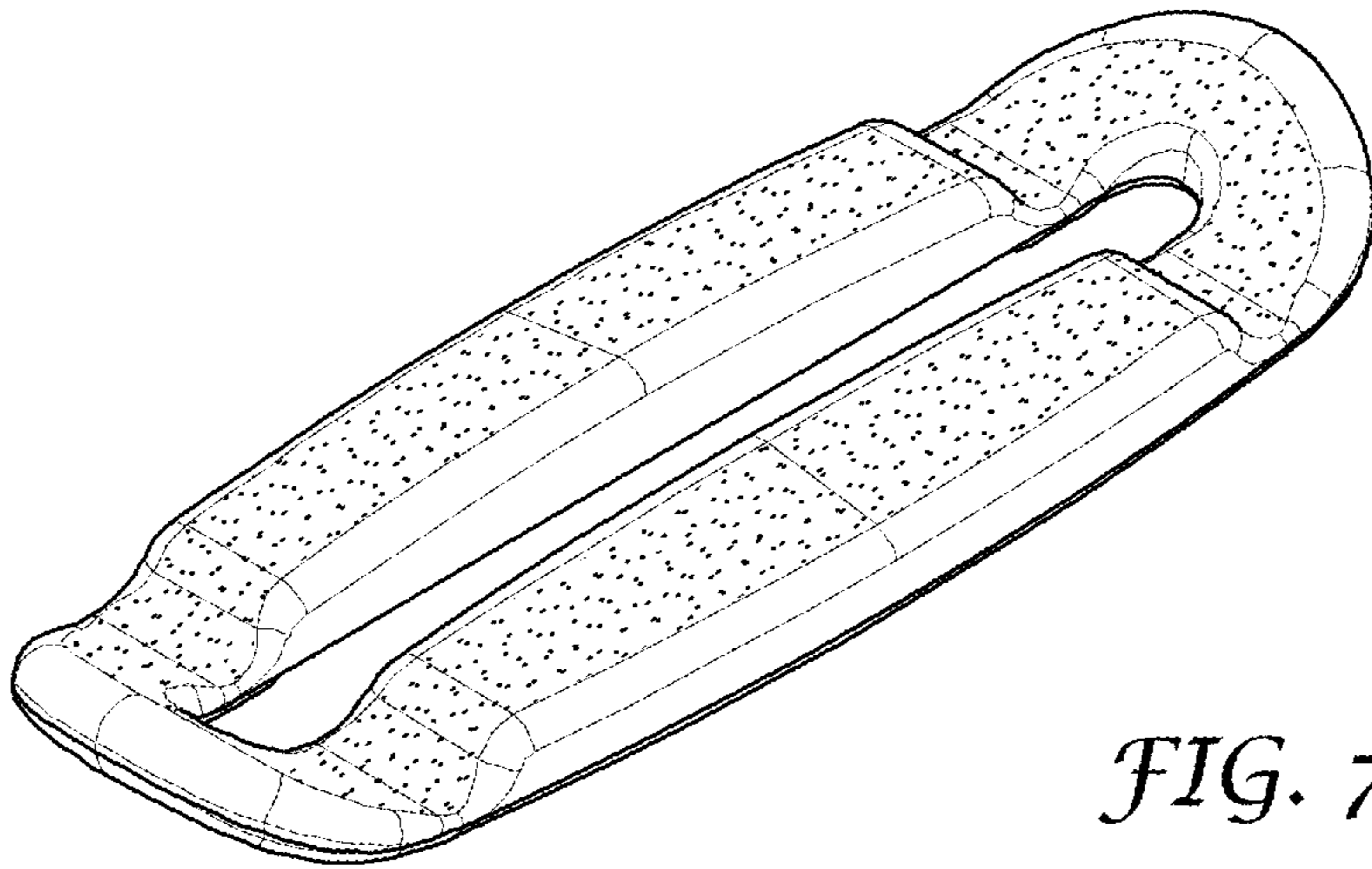

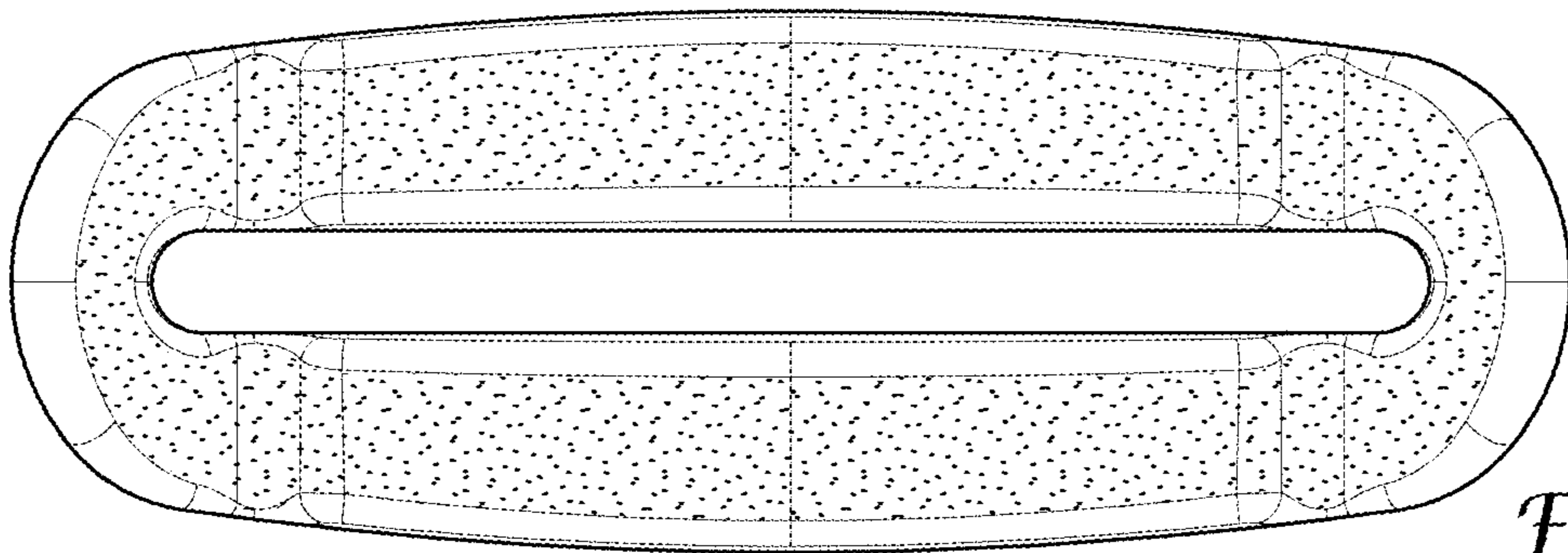

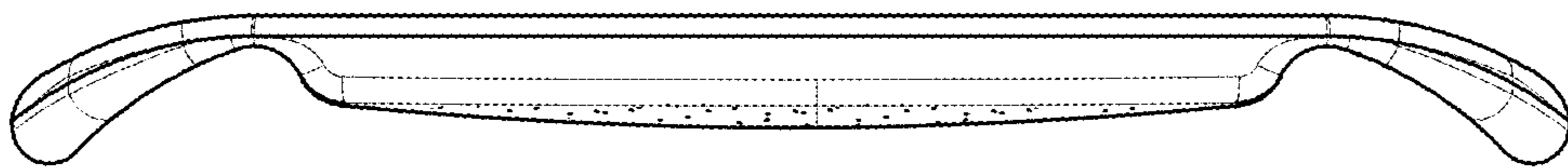

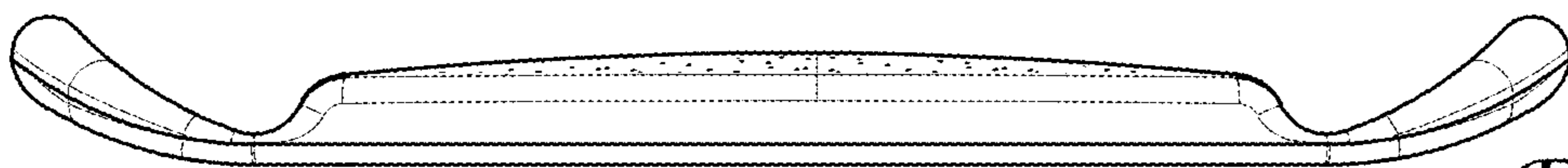

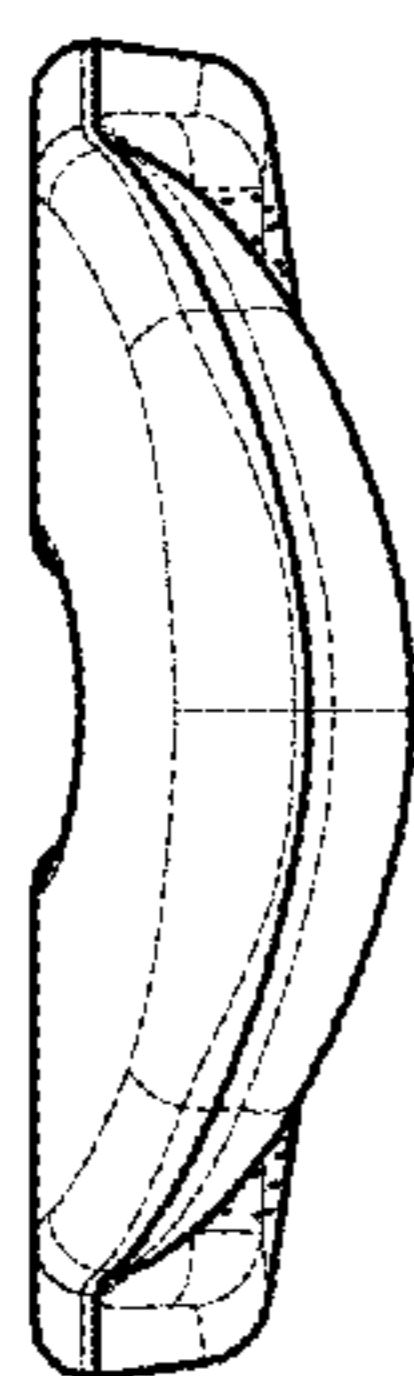

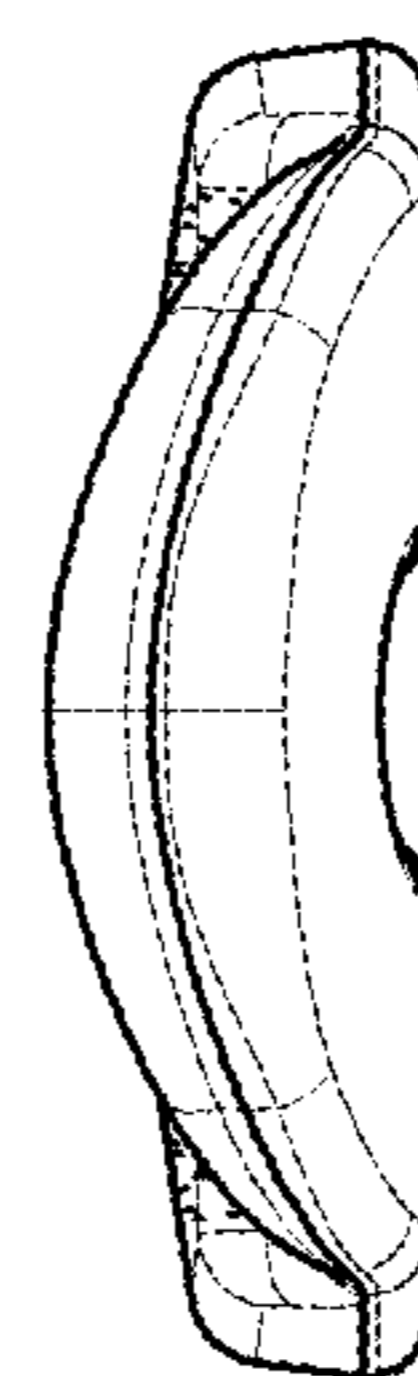
