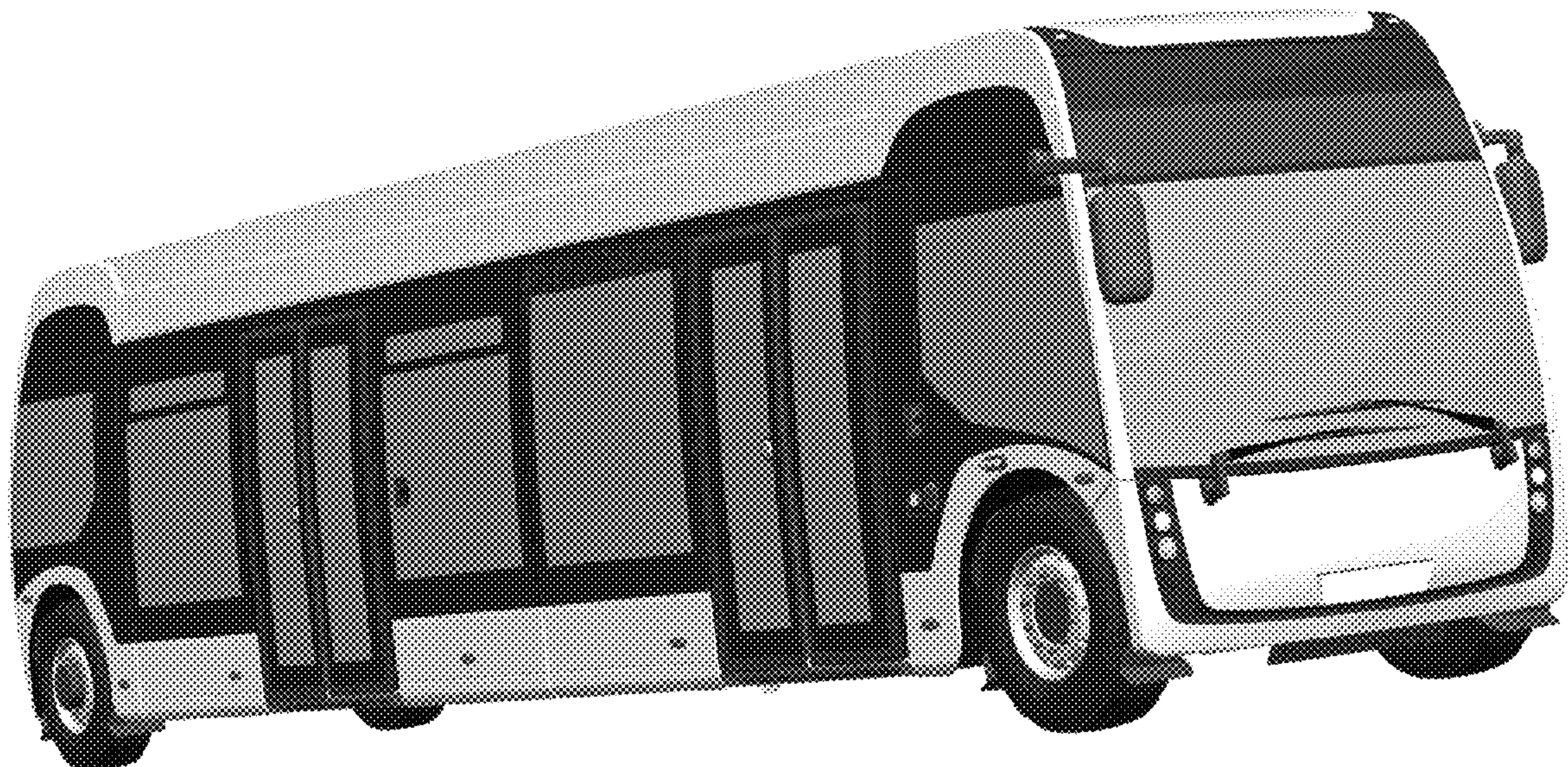
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front perspective view of a bus in accordance with the present design;  
FIG. 2 is a front elevational view thereof;

FIG. 4 is a rear perspective view thereof;  
FIG. 5 is a left side elevational thereof; and,  
FIG. 6 is a right side elevational thereof.

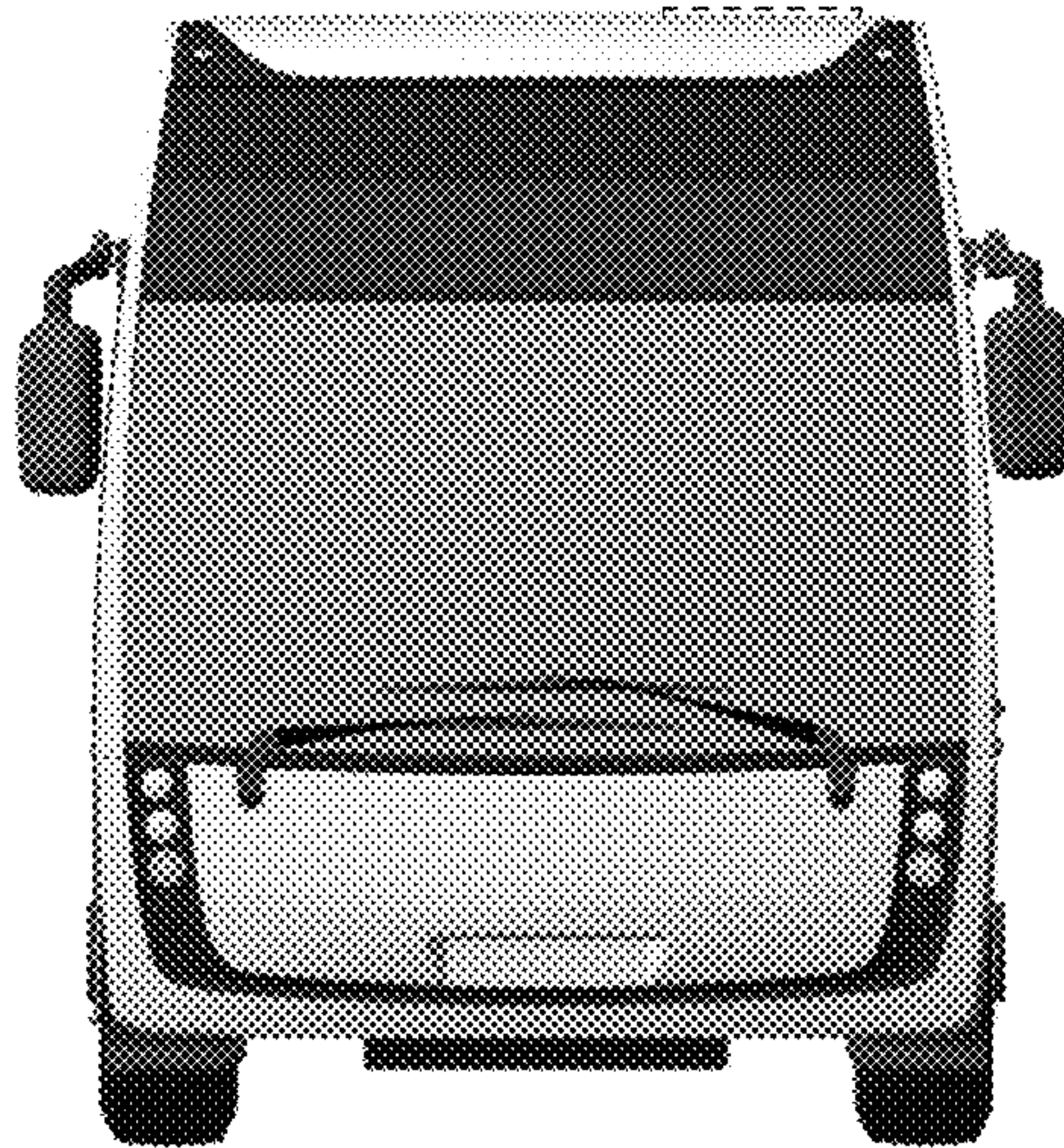

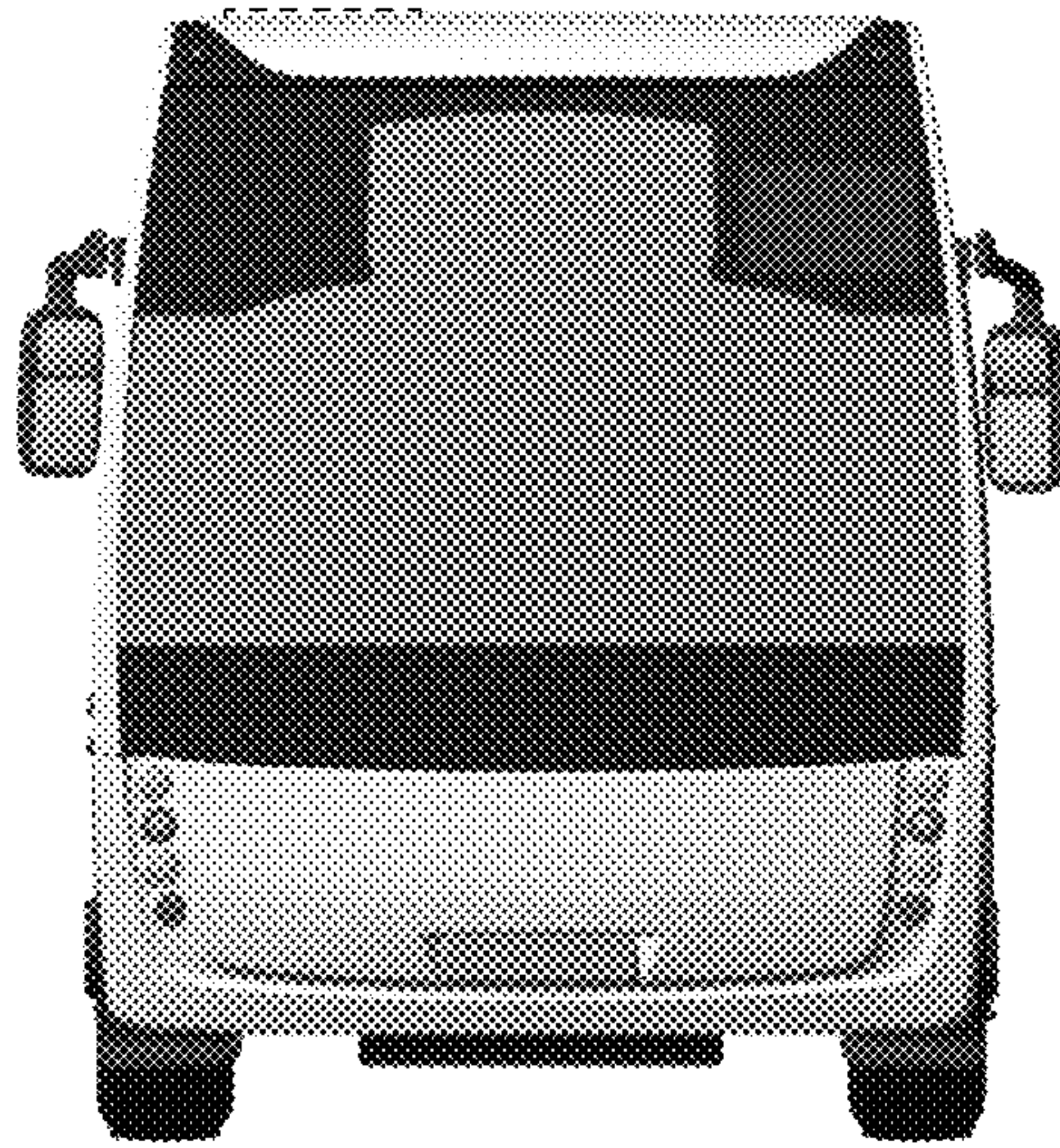

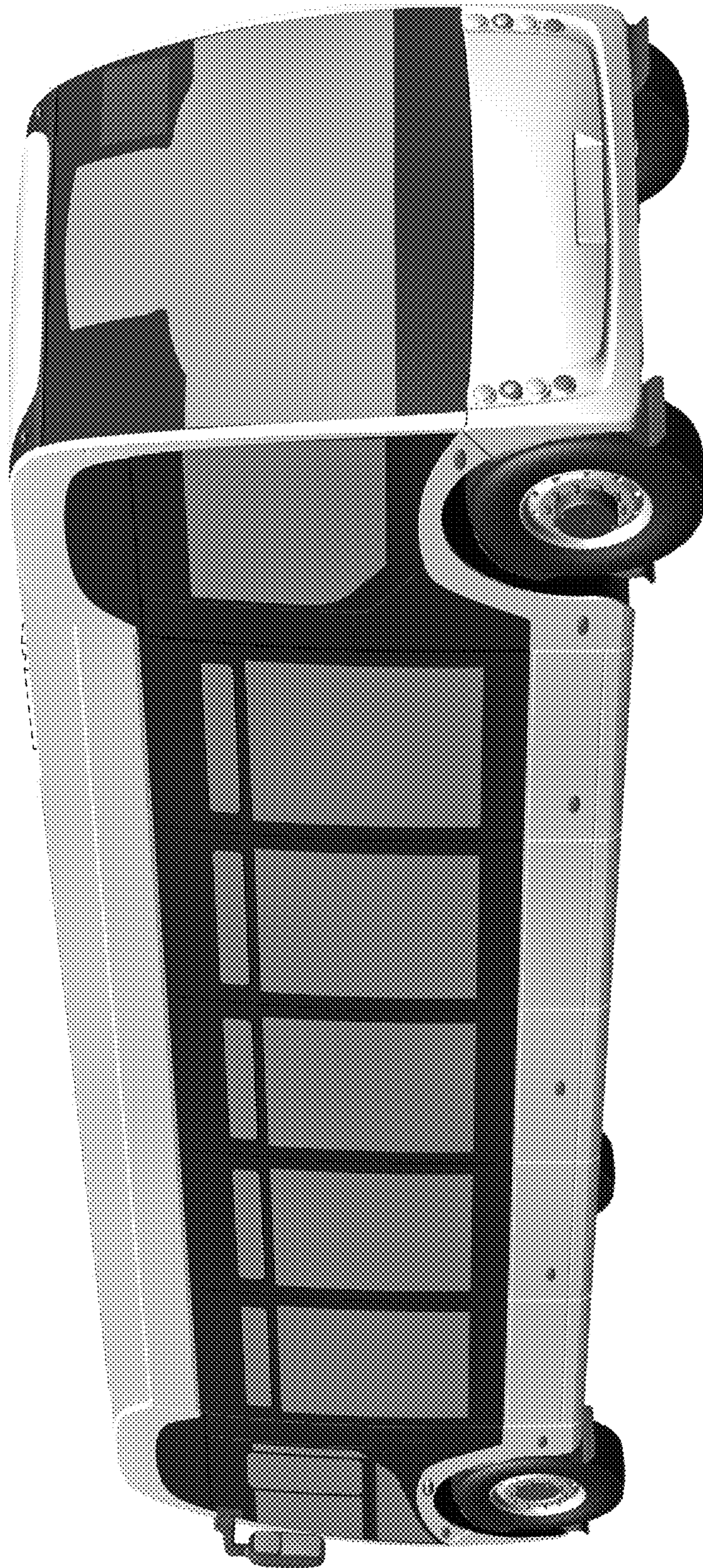

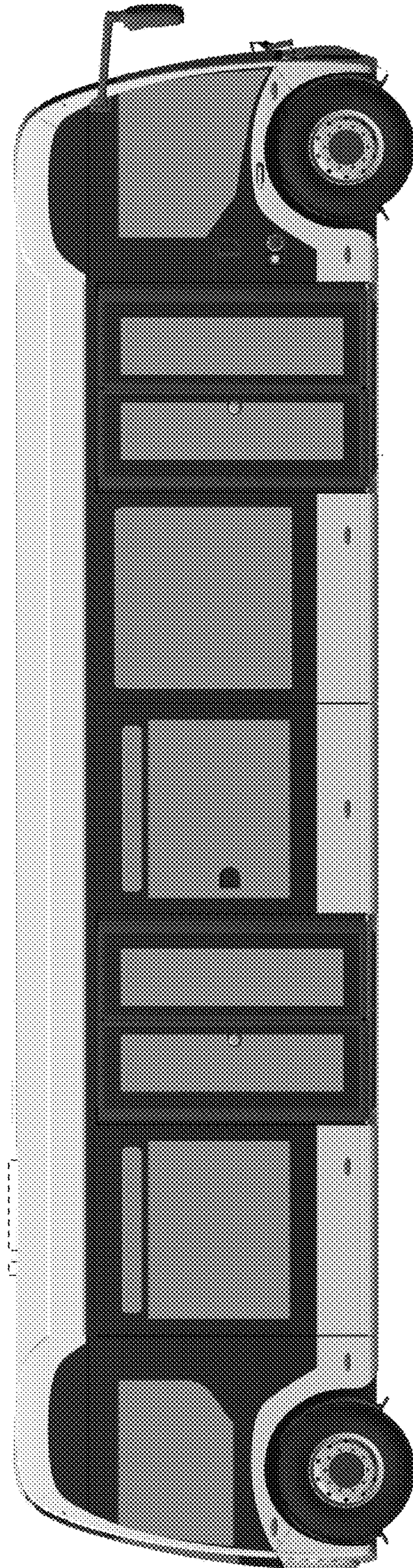

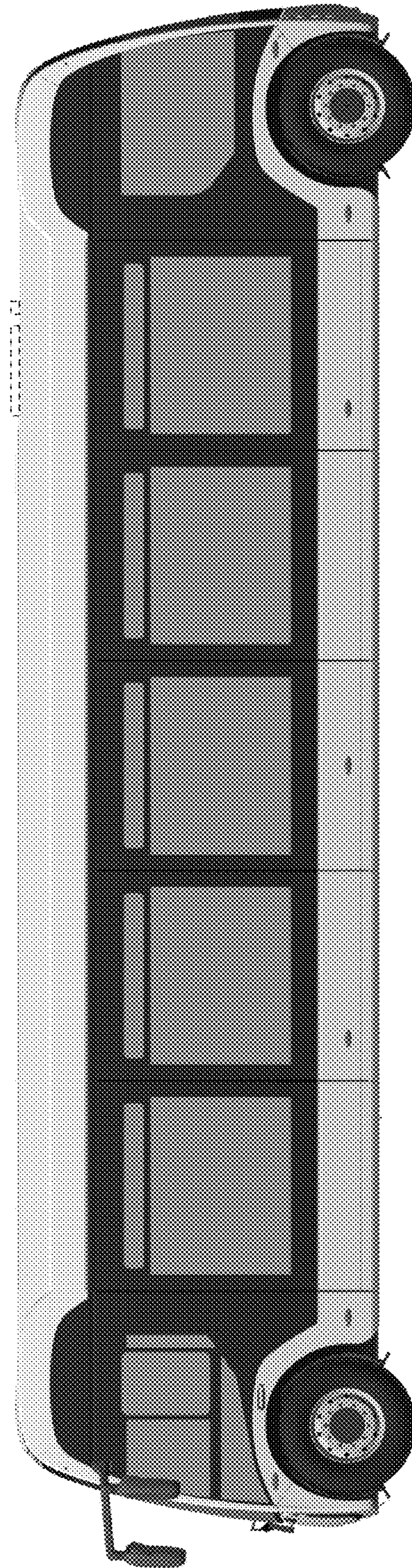
