(57) **CLAIM**

The ornamental design for a tire, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tire, it being understood that the tread is repeated throughout the circumference of the tire, it being understood that the dashed lines show environmental features of the tire.

FIG. 2 is a front view of the embodiment of FIG. 1.

FIG. 3 is a right side view of the embodiment of FIG. 1, the left side view having similarly shaped and sized features as the right side view.

FIG. 4 is a cross-sectional view taken along line 4-4 of FIG. 2.

FIG. 5 is a cross-sectional view taken along line 5-5 of FIG. 2.

FIG. 6 is a cross-sectional view taken along line 6-6 of FIG. 2.

FIG. 7 is a perspective view of a tire, it being understood that the tread is repeated throughout the circumference of the tire.

FIG. 8 is a front view of the embodiment of FIG. 7.

FIG. 9 is a right side view of the embodiment of FIG. 7, the left side view having similarly shaped and sized features as the right side view.

FIG. 10 is a cross-sectional view taken along line 10-10 of FIG. 8.

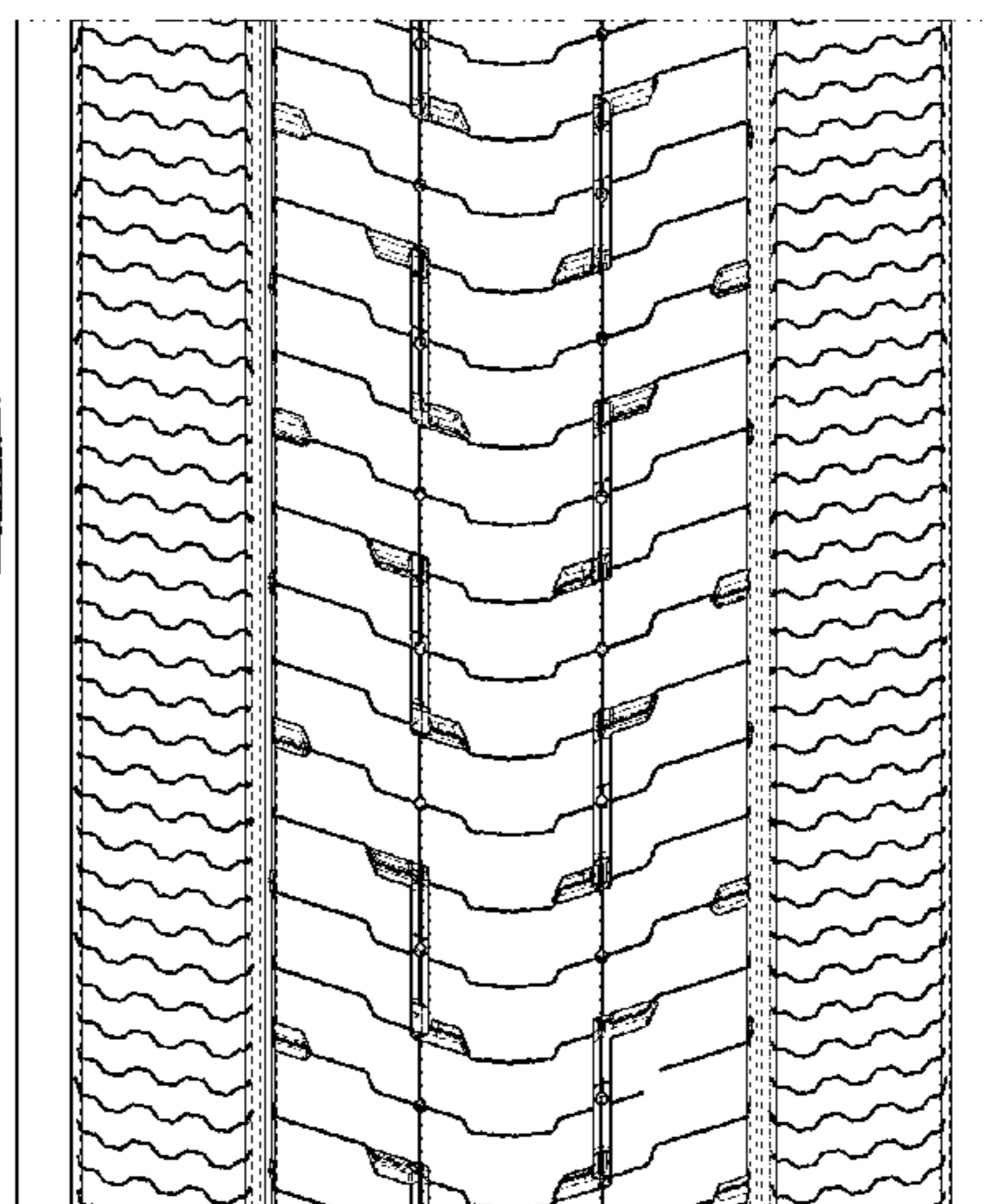
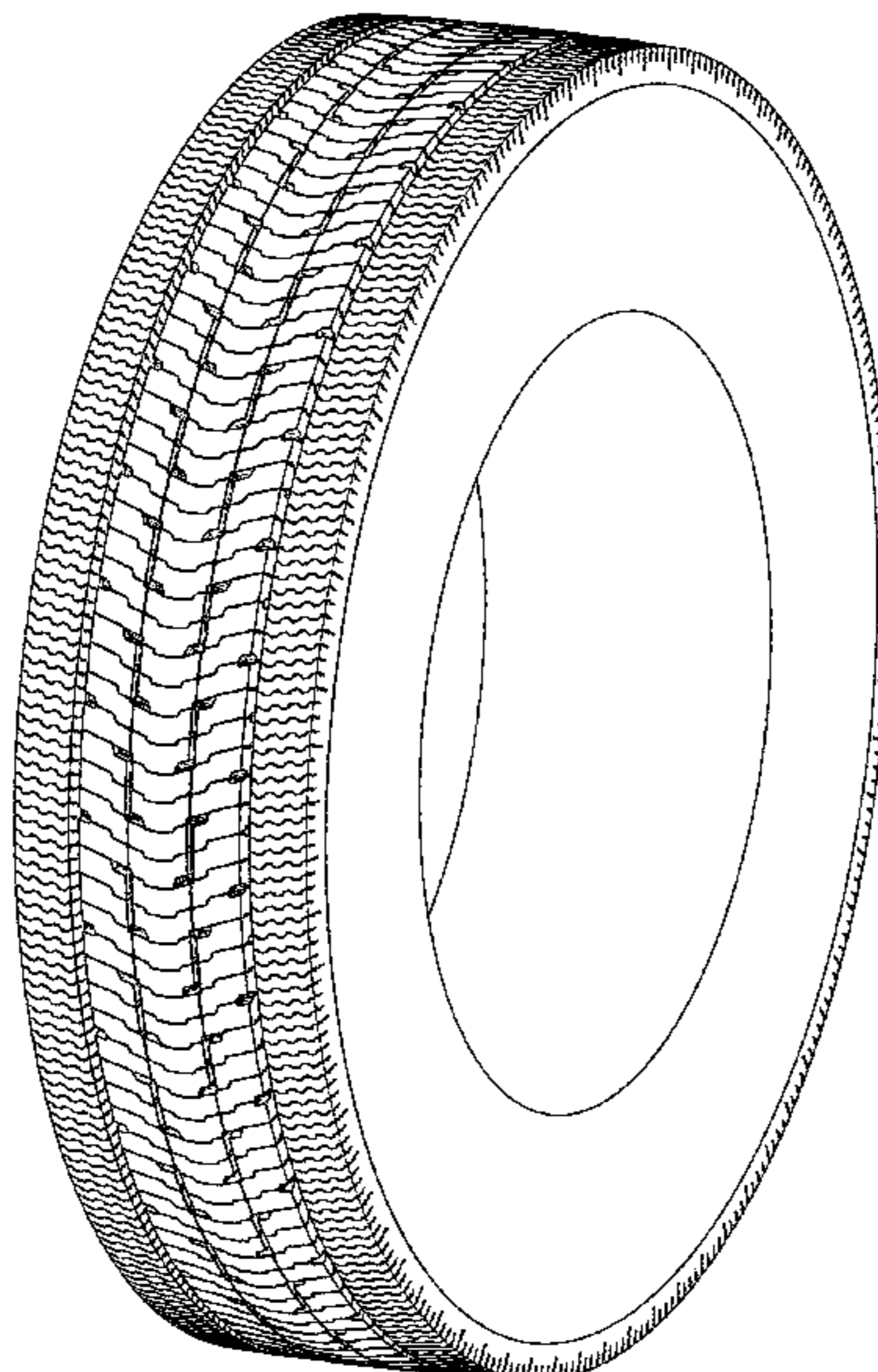
FIG. 11 is a cross-sectional view taken along line 11-11 of FIG. 8.

FIG. 12 is a cross-sectional view taken along line 12-12 of FIG. 8; and,

FIG. 13 is a close up view of a portion of the tread of FIG. 8 that shows some of the tread features in more detail, it being understood that the tread continues on above and below the dashed and dotted lines.

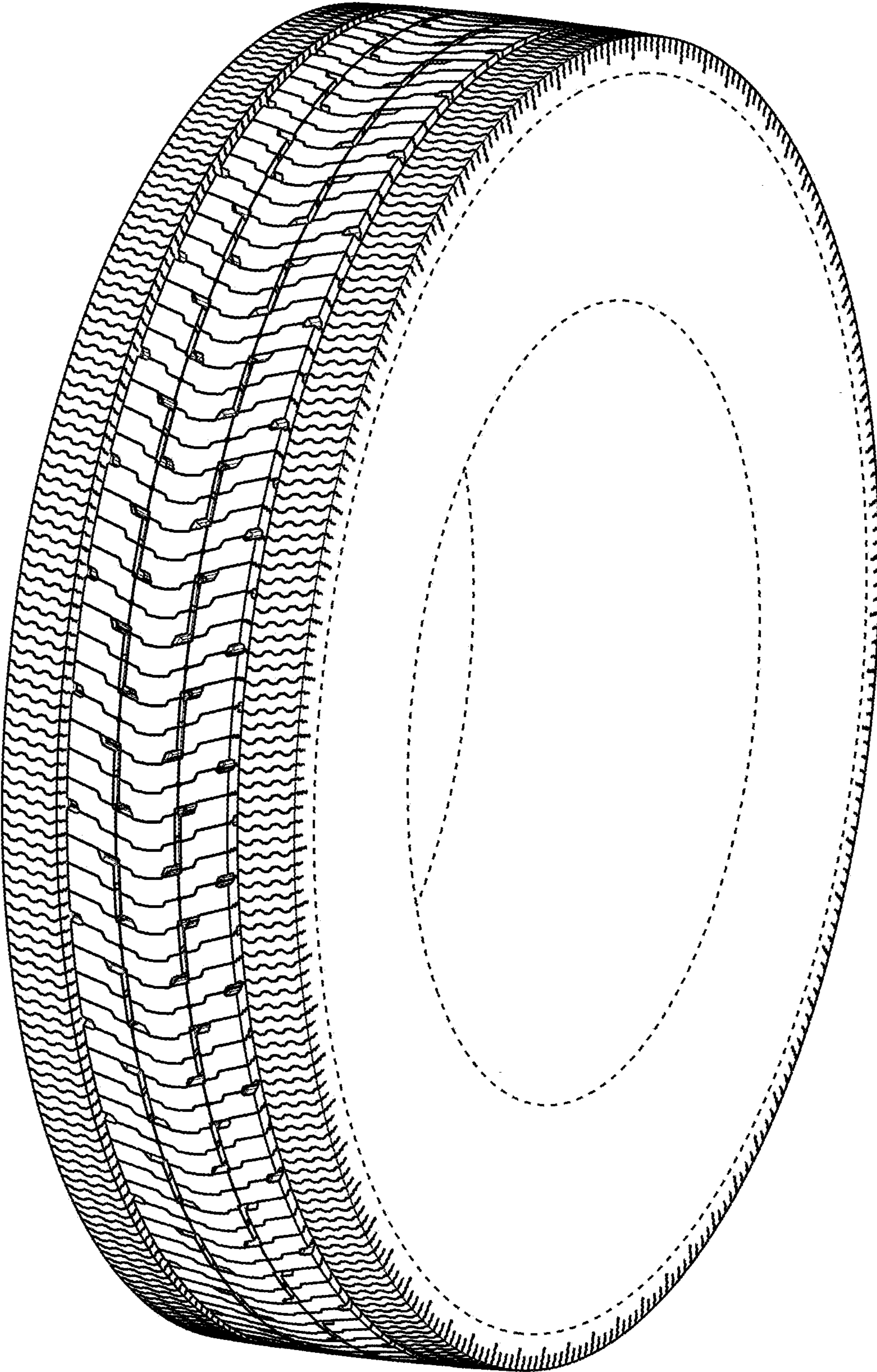

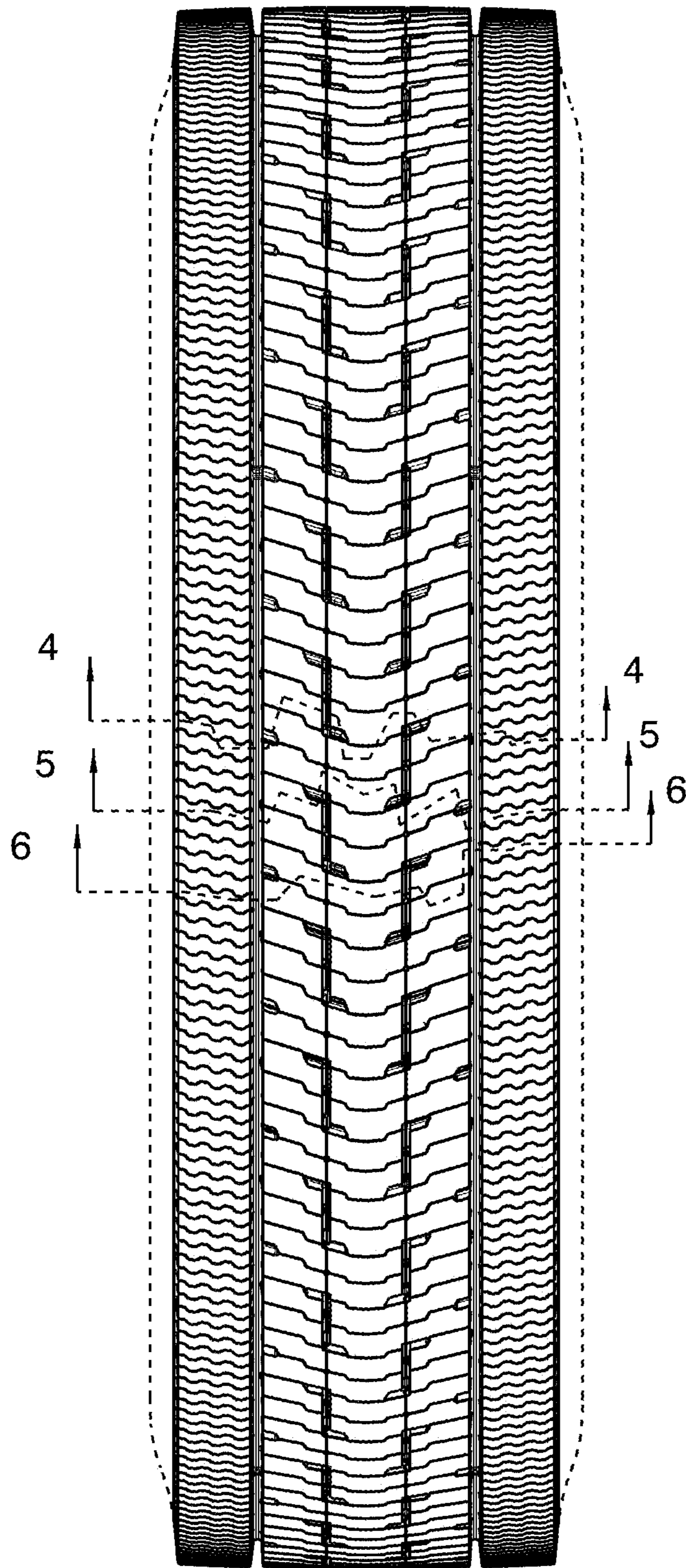

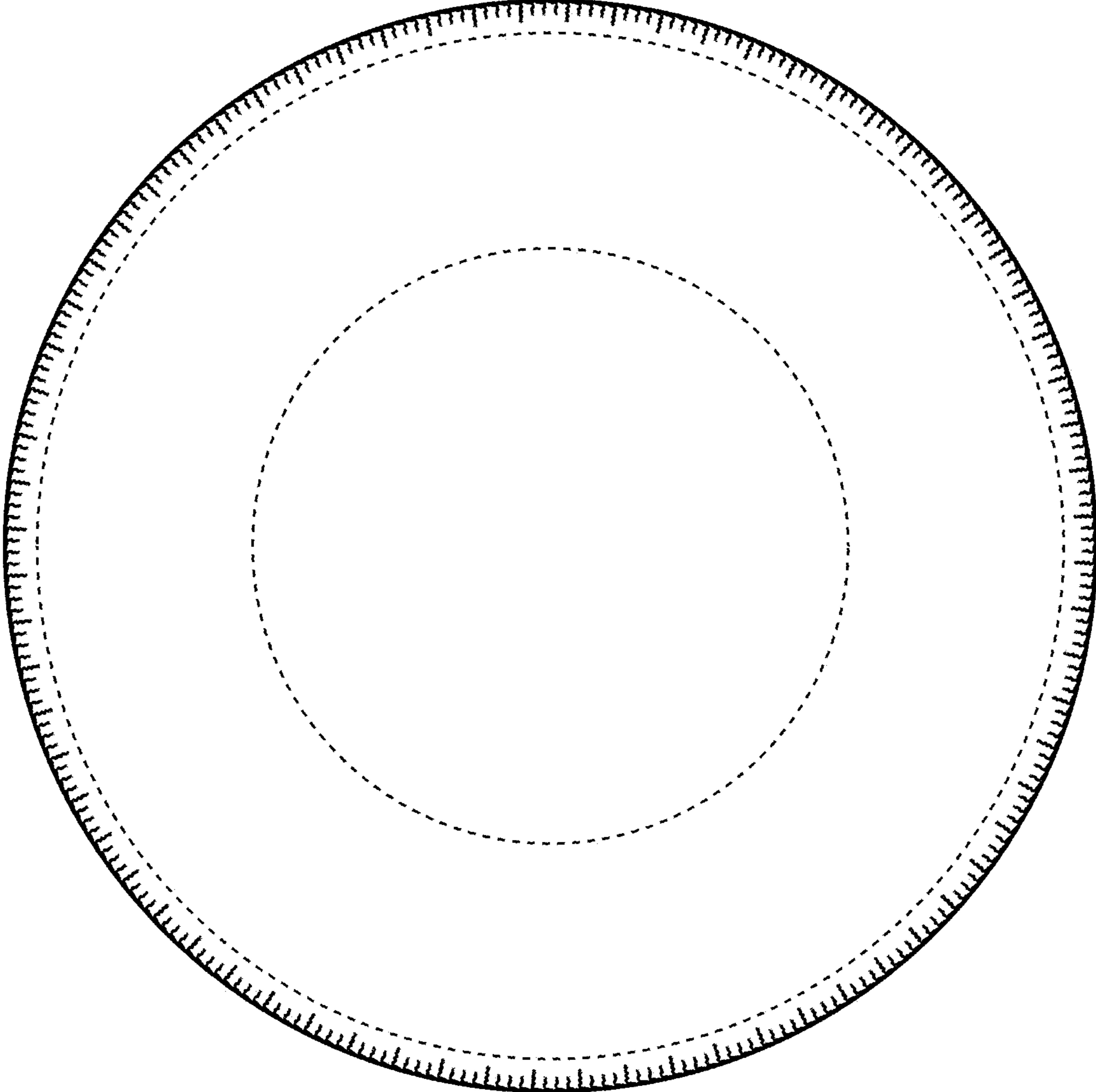

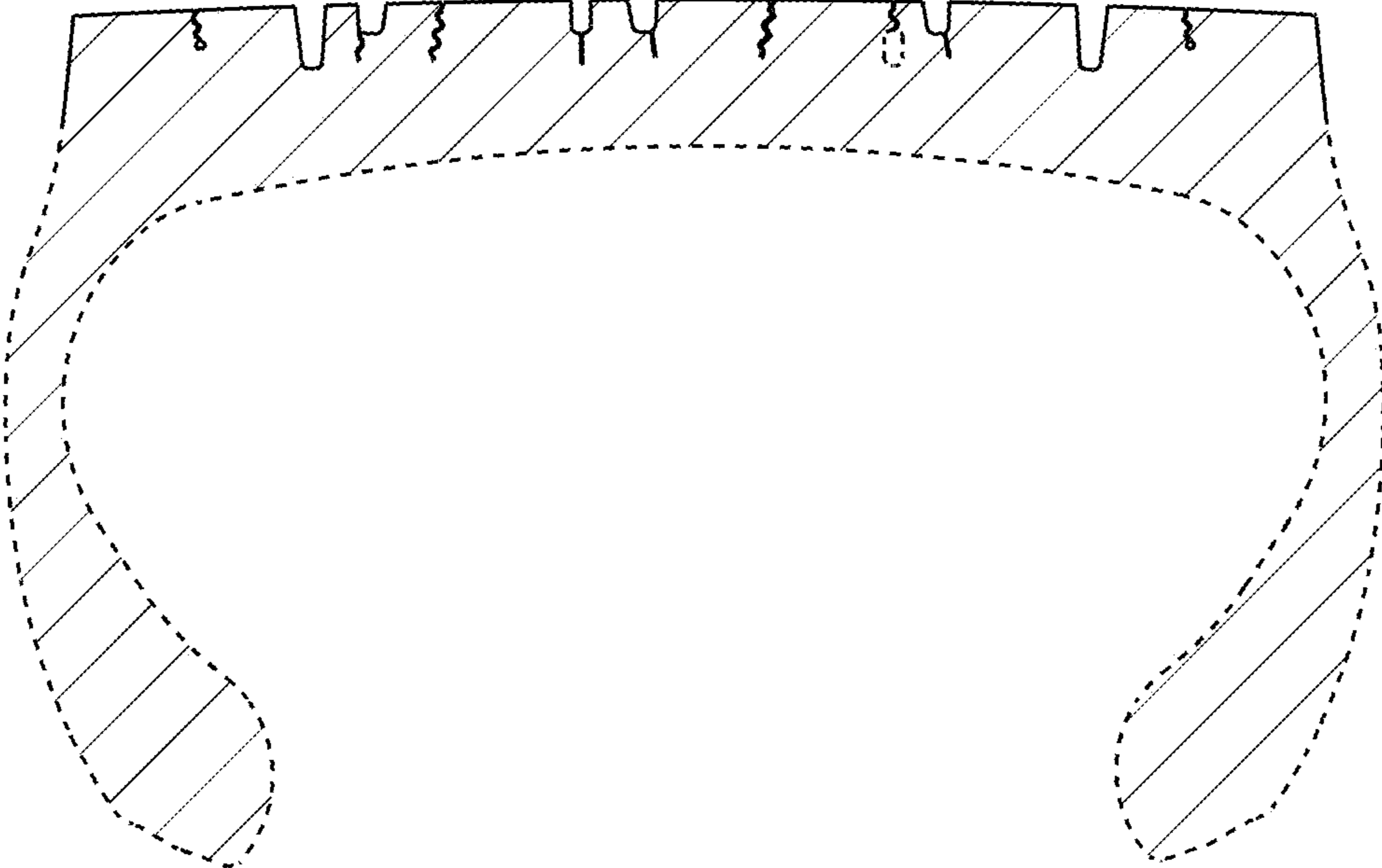

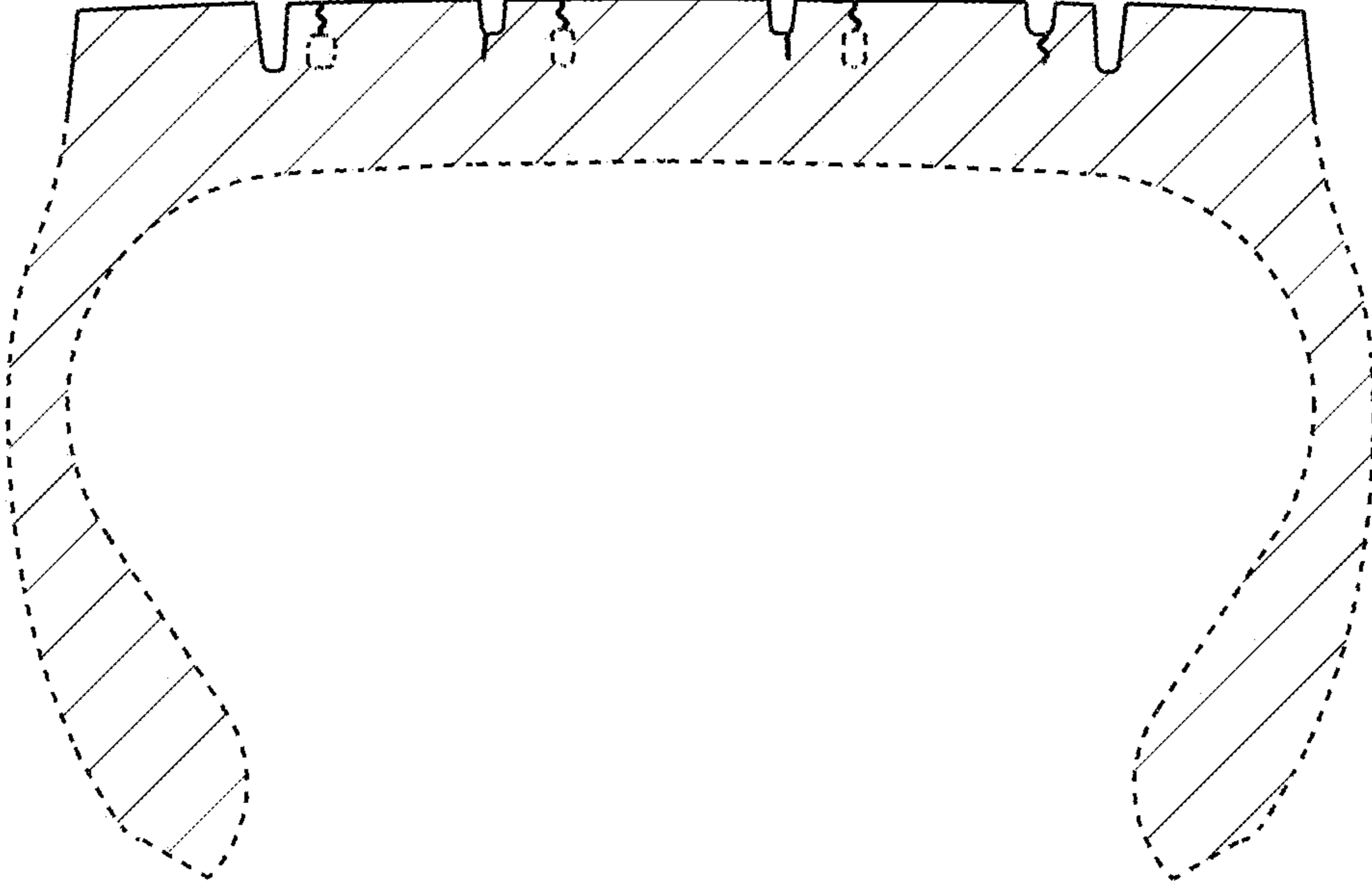

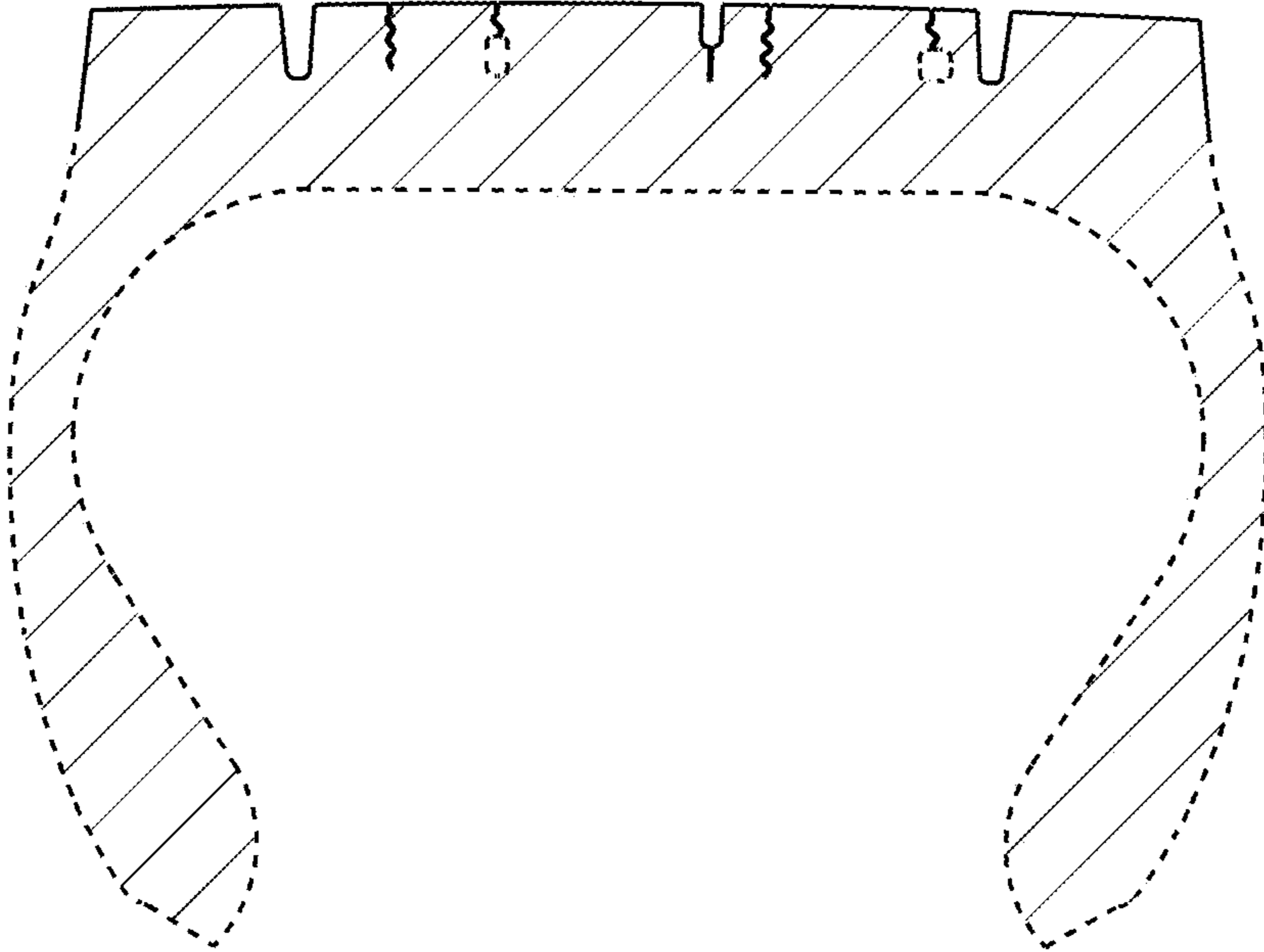

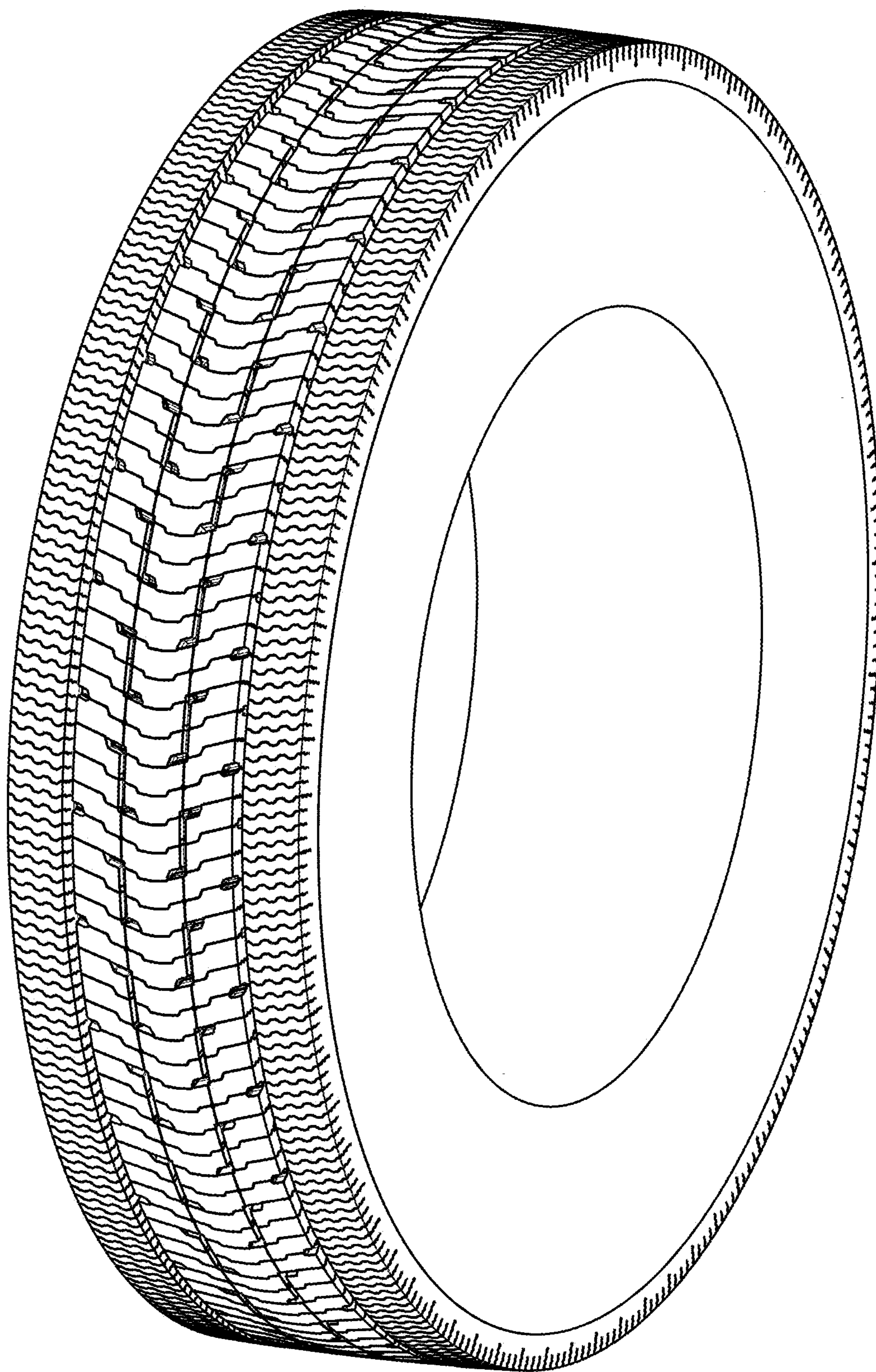

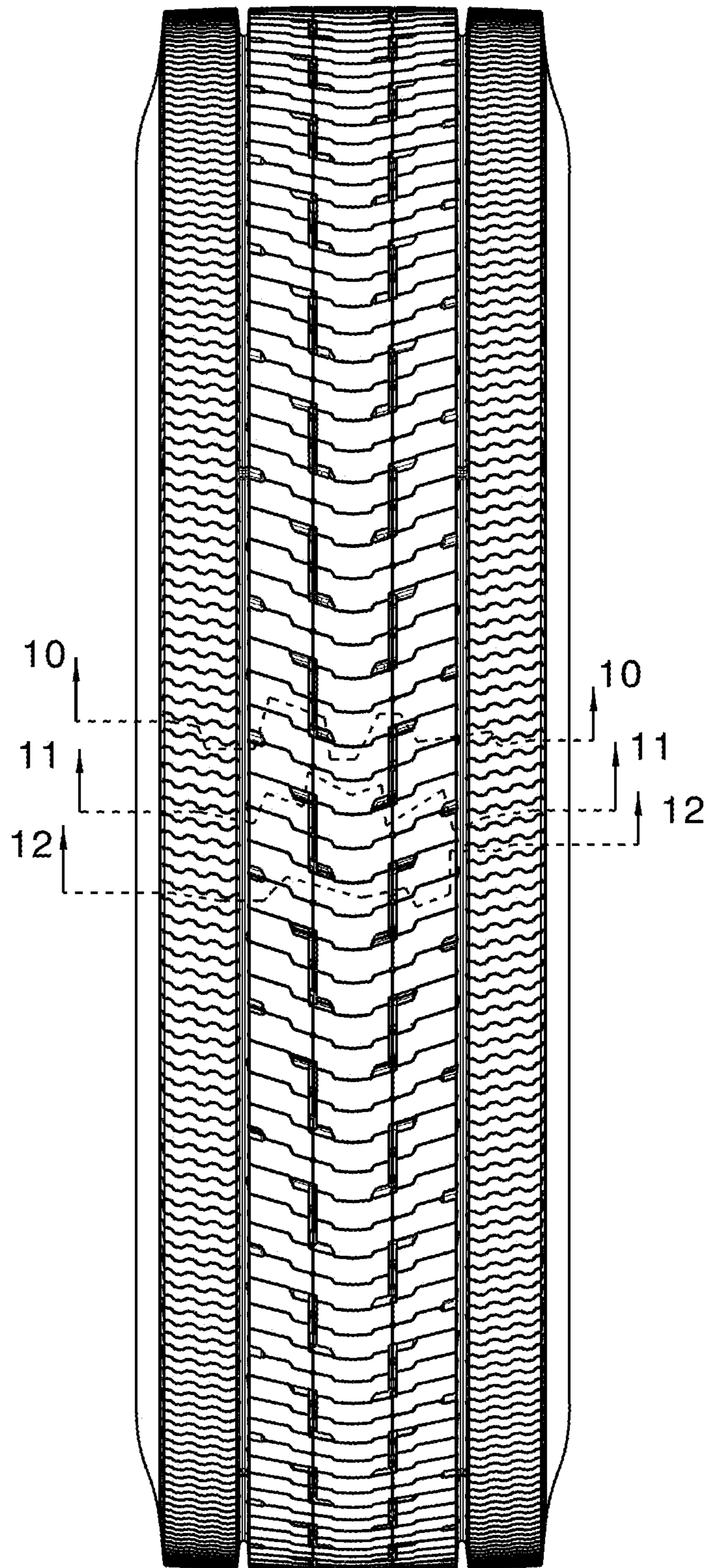

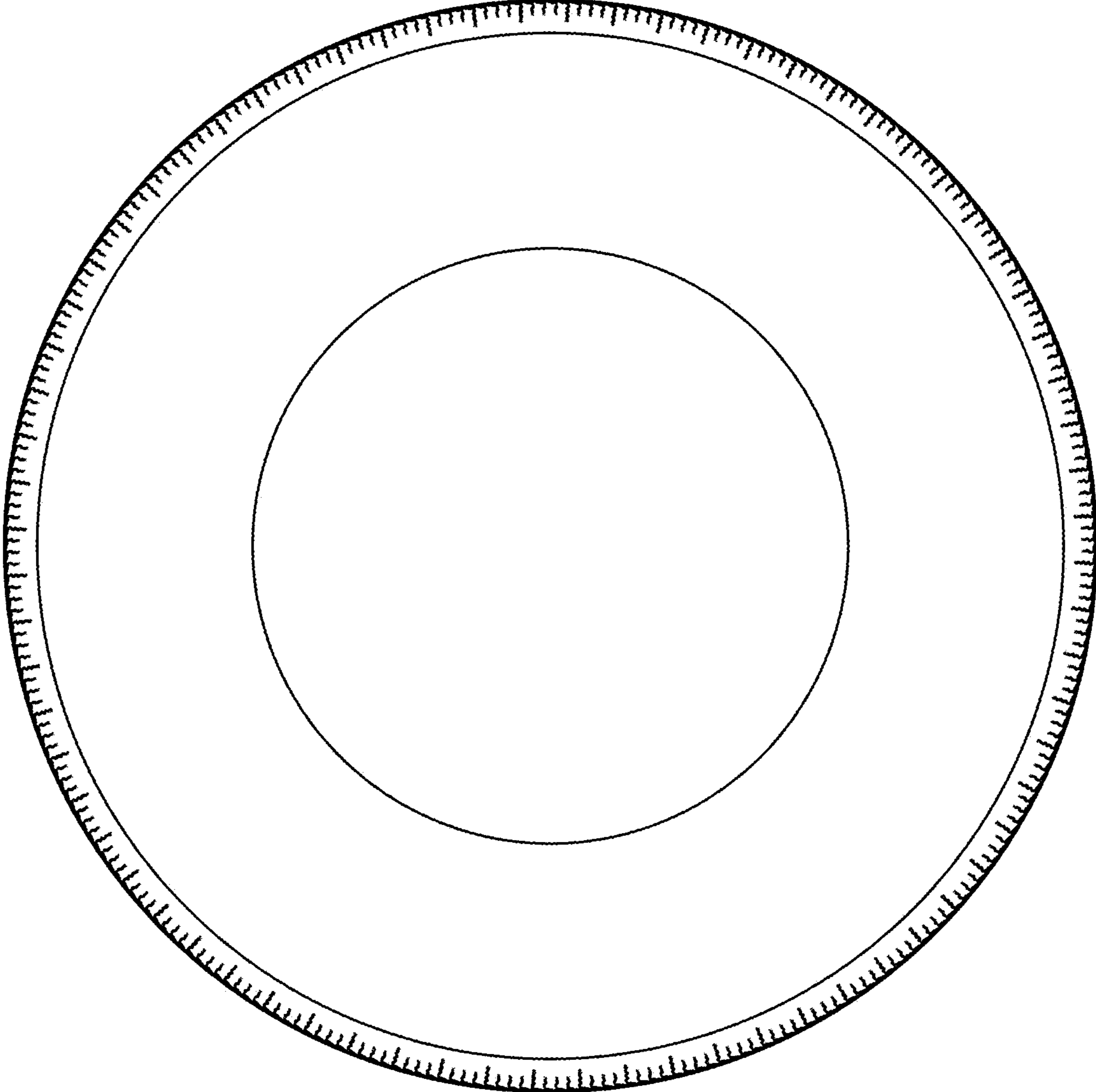

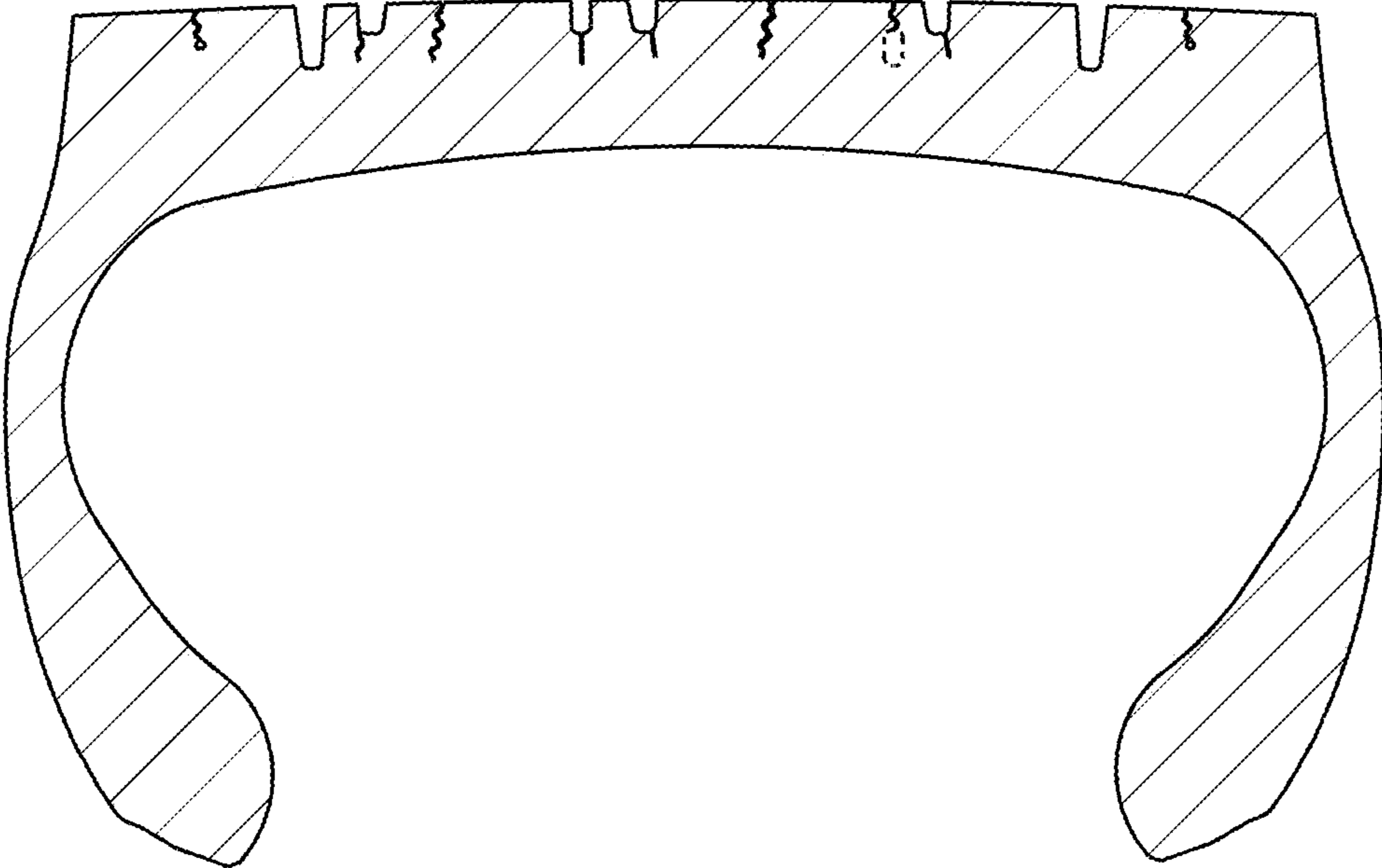

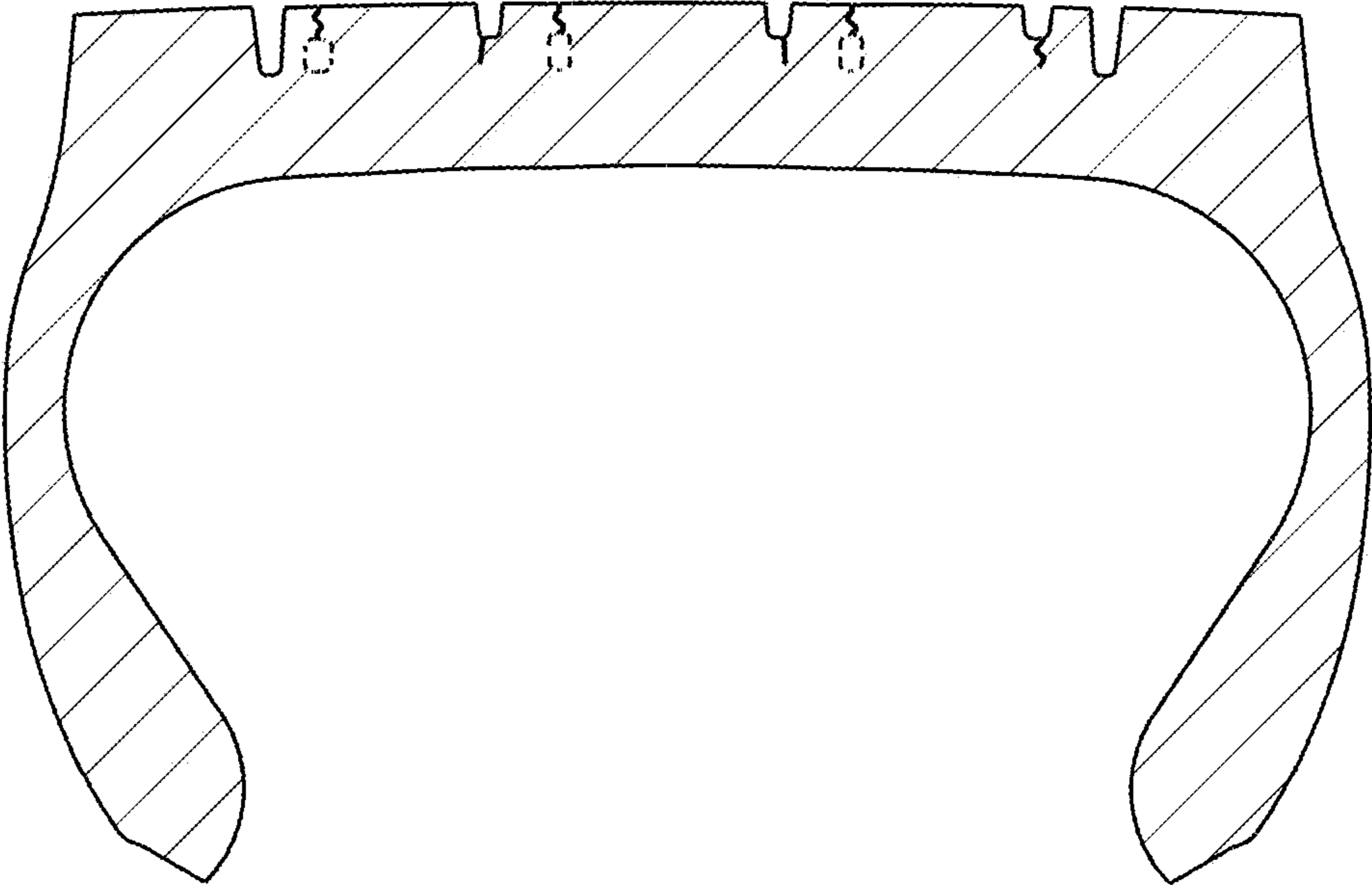

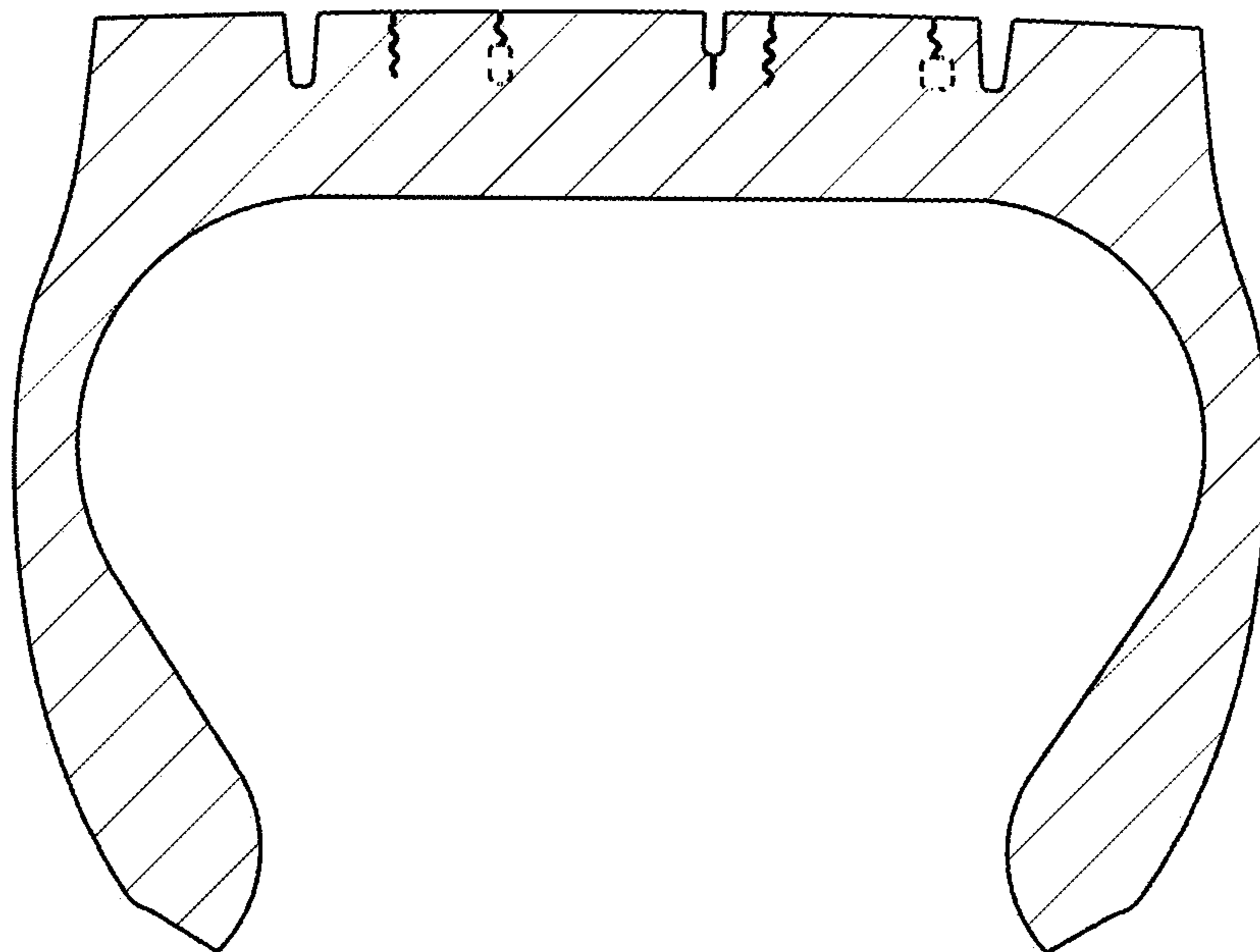

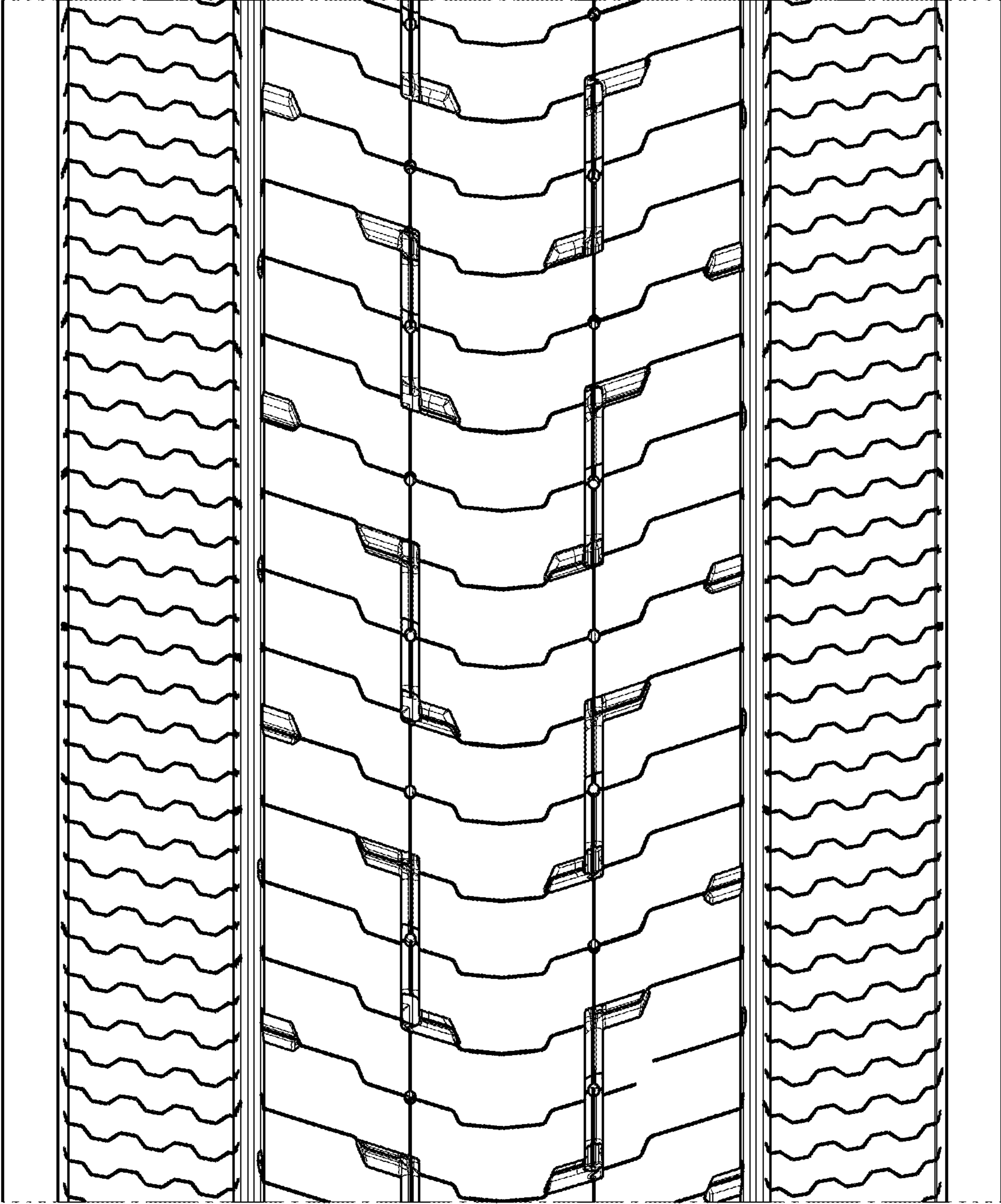
