FIG. 1 is a right side perspective view of tire showing my new design;

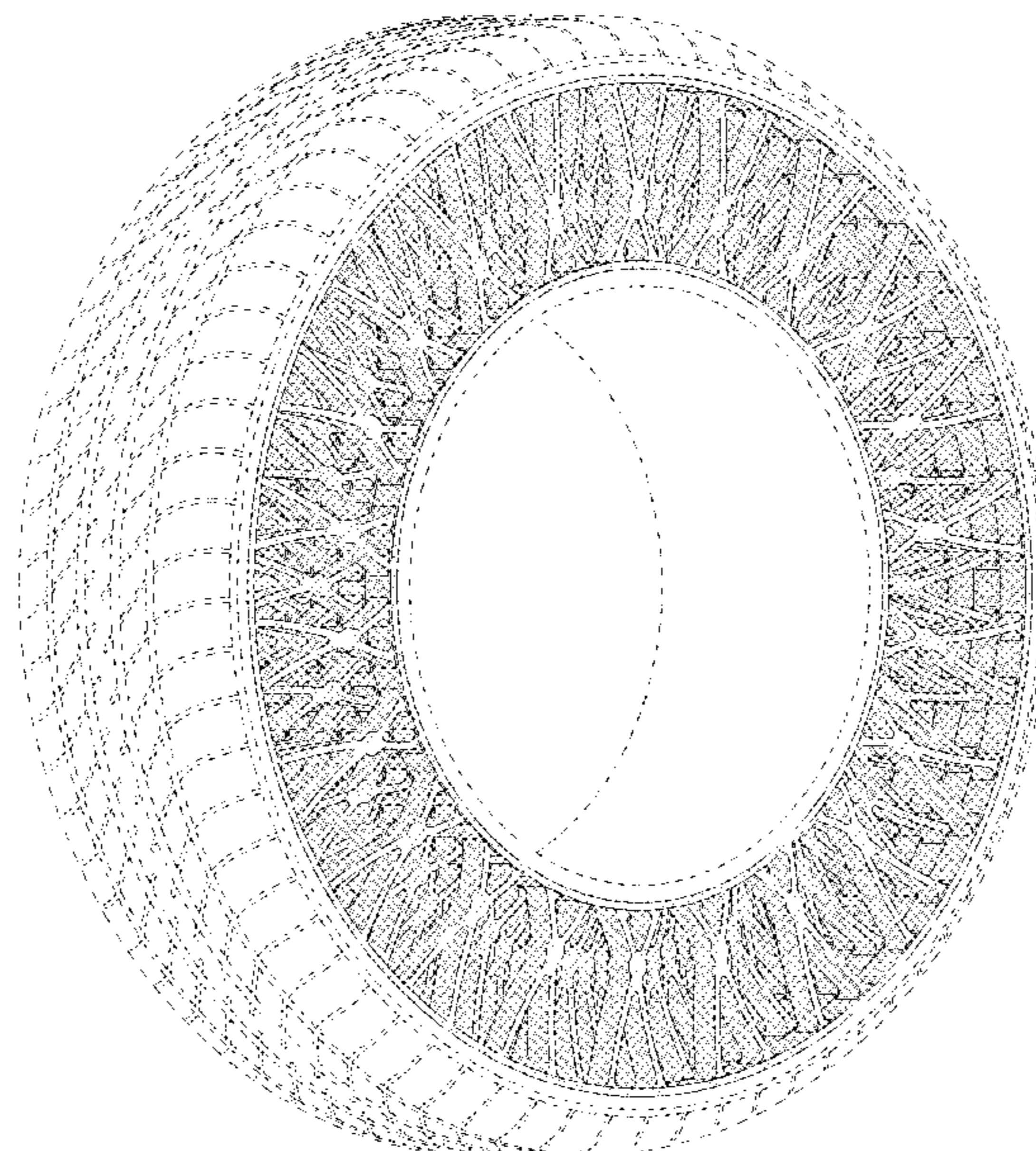
FIG. 2 is a second right side perspective view thereof;

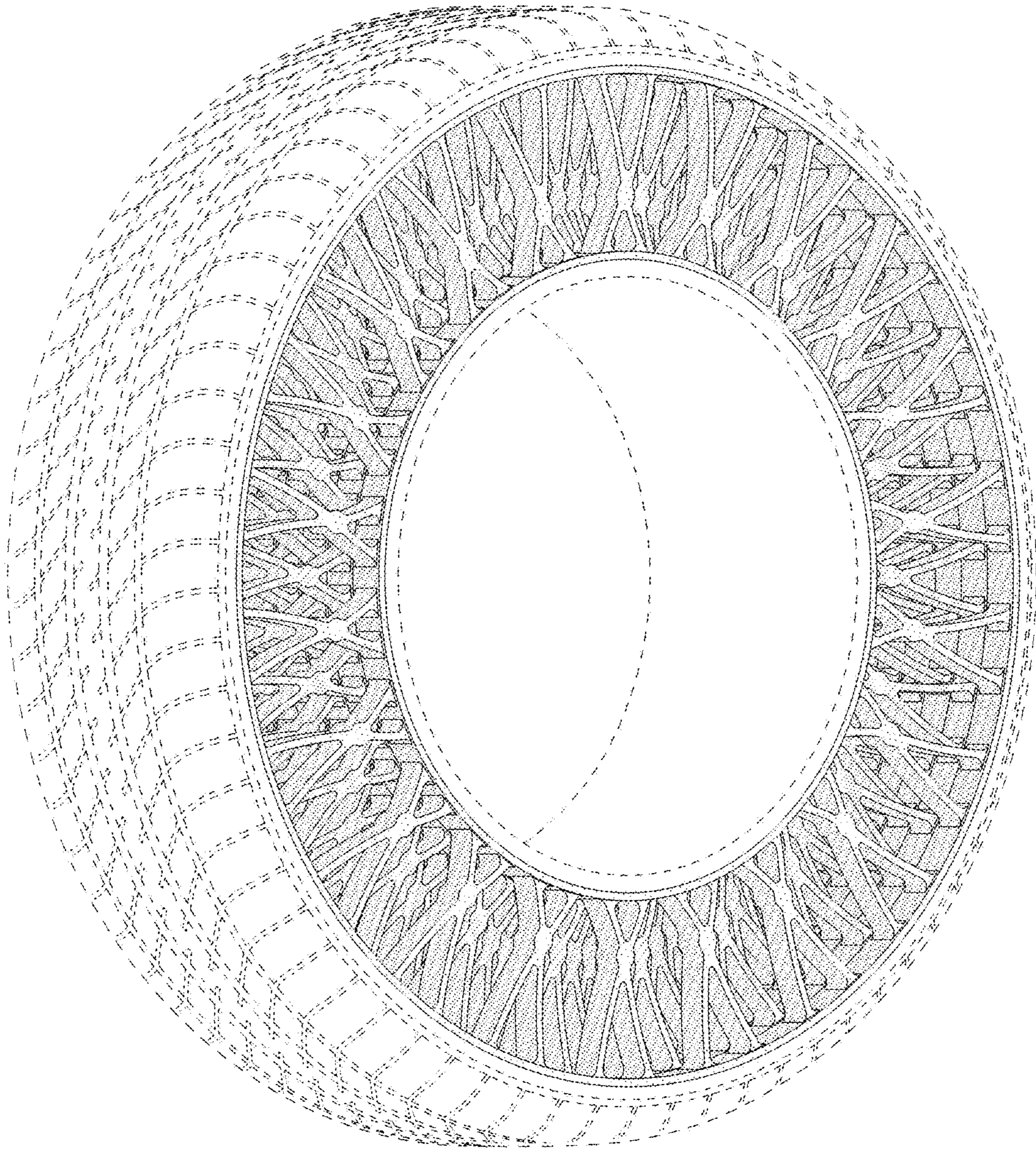

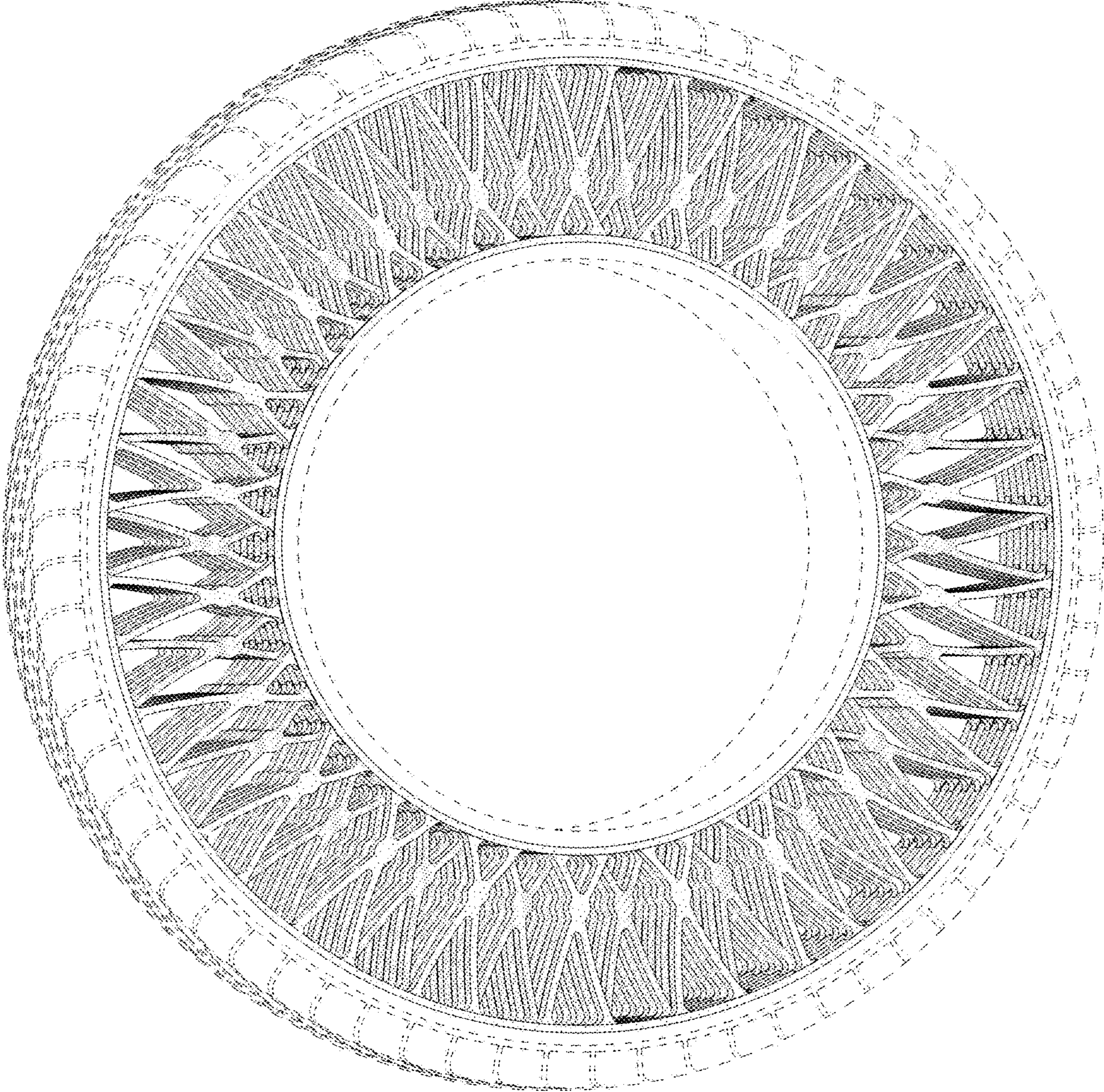

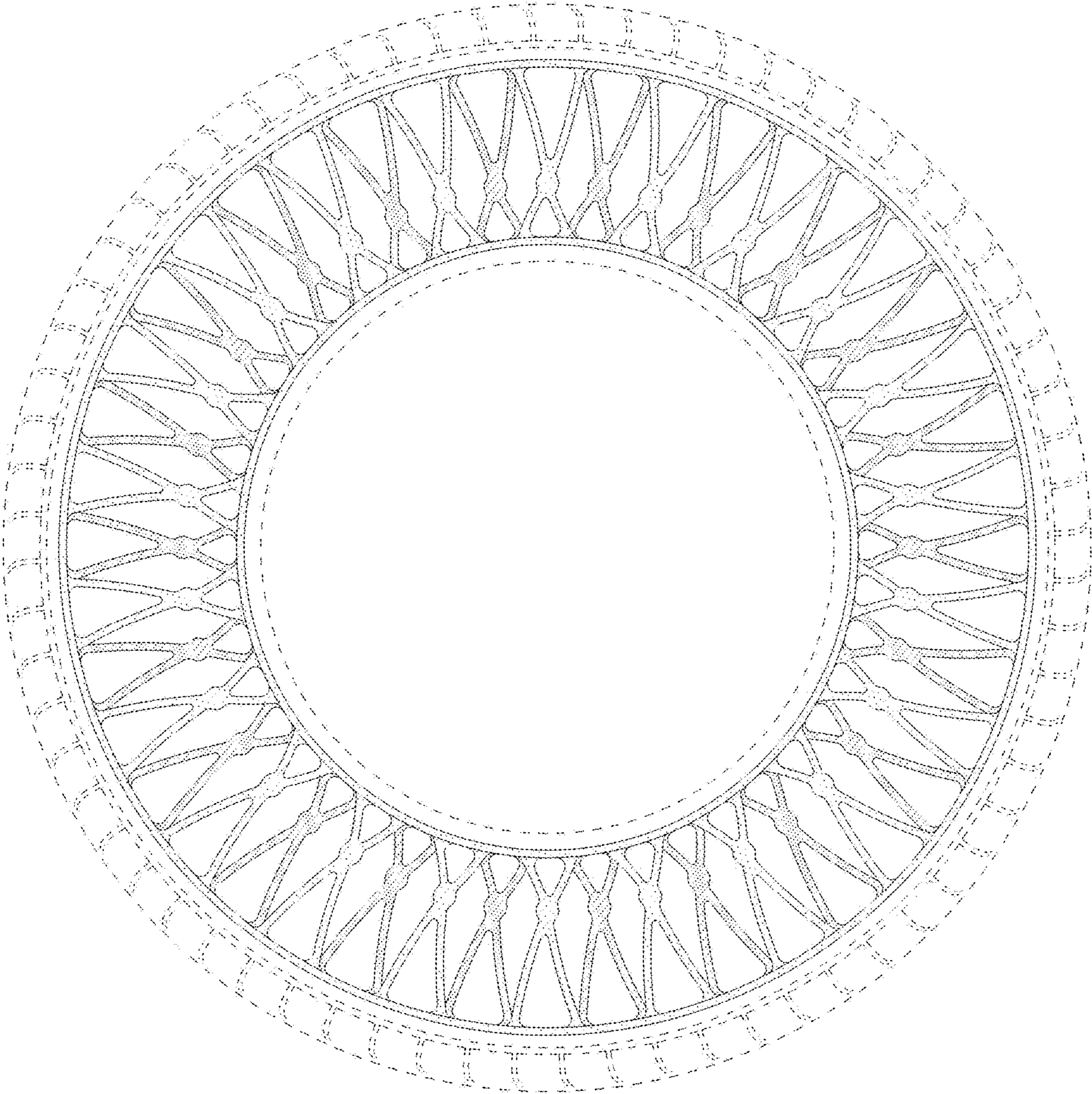

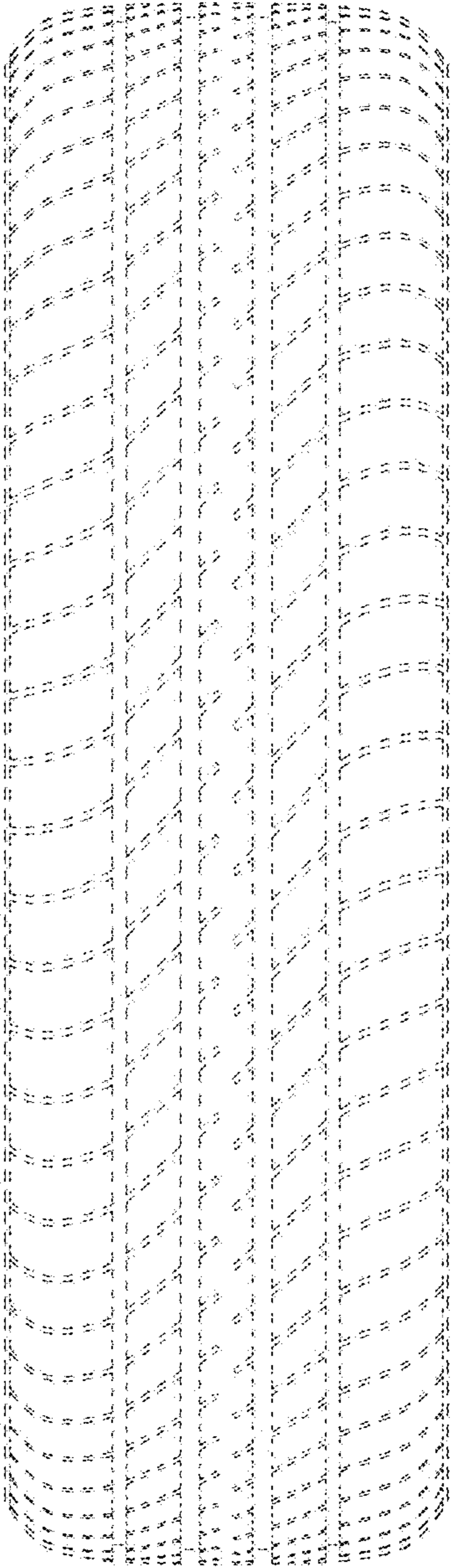
