(57) **CLAIM**

The ornamental design for a display screen or portion thereof with animated graphical user interface for a cooking device, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen or portion thereof showing the first image of a sequence of the animated graphical user interface, according to a first embodiment of the invention;

FIG. 2 is a front view of the display screen or portion thereof showing the second image of the sequence of FIG. 1;

FIG. 3 is a front view of the display screen or portion thereof showing the third image of the sequence of FIG. 1;

FIG. 4 is a front view of the display screen or portion thereof showing the fourth image of the sequence of FIG. 1;

FIG. 5 is a front view of the display screen or portion thereof showing the fifth image of the sequence of FIG. 1;

FIG. 6 is a front view of a display screen or portion thereof showing the first image of the sequence of the animated graphical user interface, according to a second embodiment of the invention;

FIG. 7 is a front view of the display screen or portion thereof showing the second image of the sequence of FIG. 6;

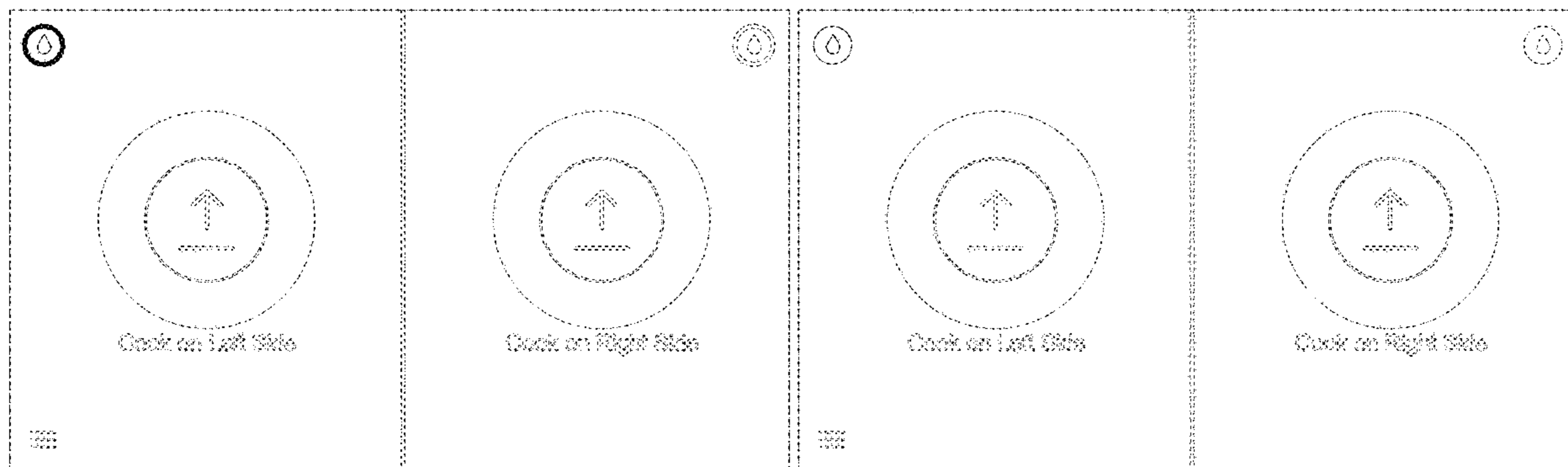
FIG. 8 is a front view of the display screen or portion thereof showing the third image of the sequence of FIG. 6;

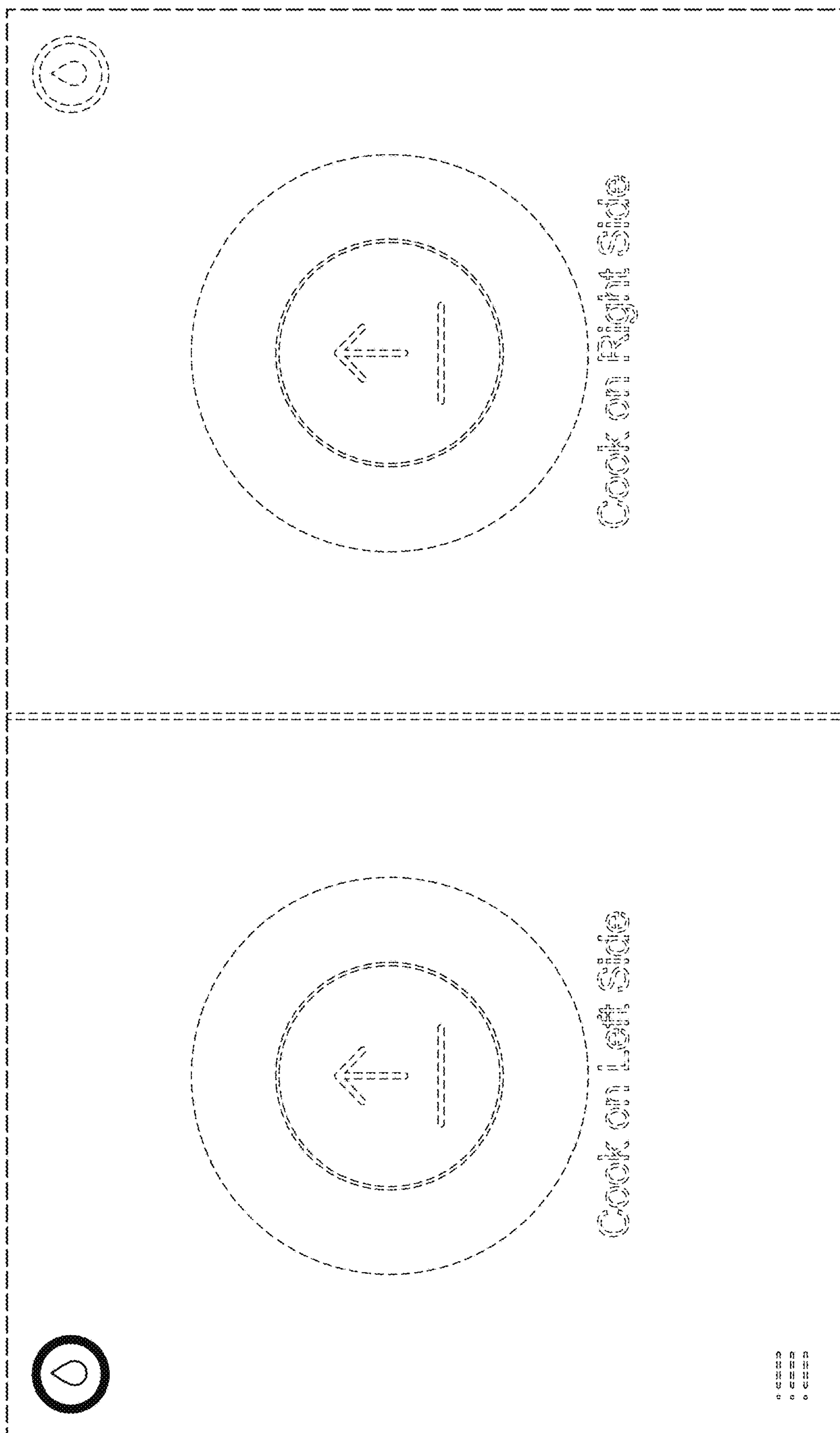

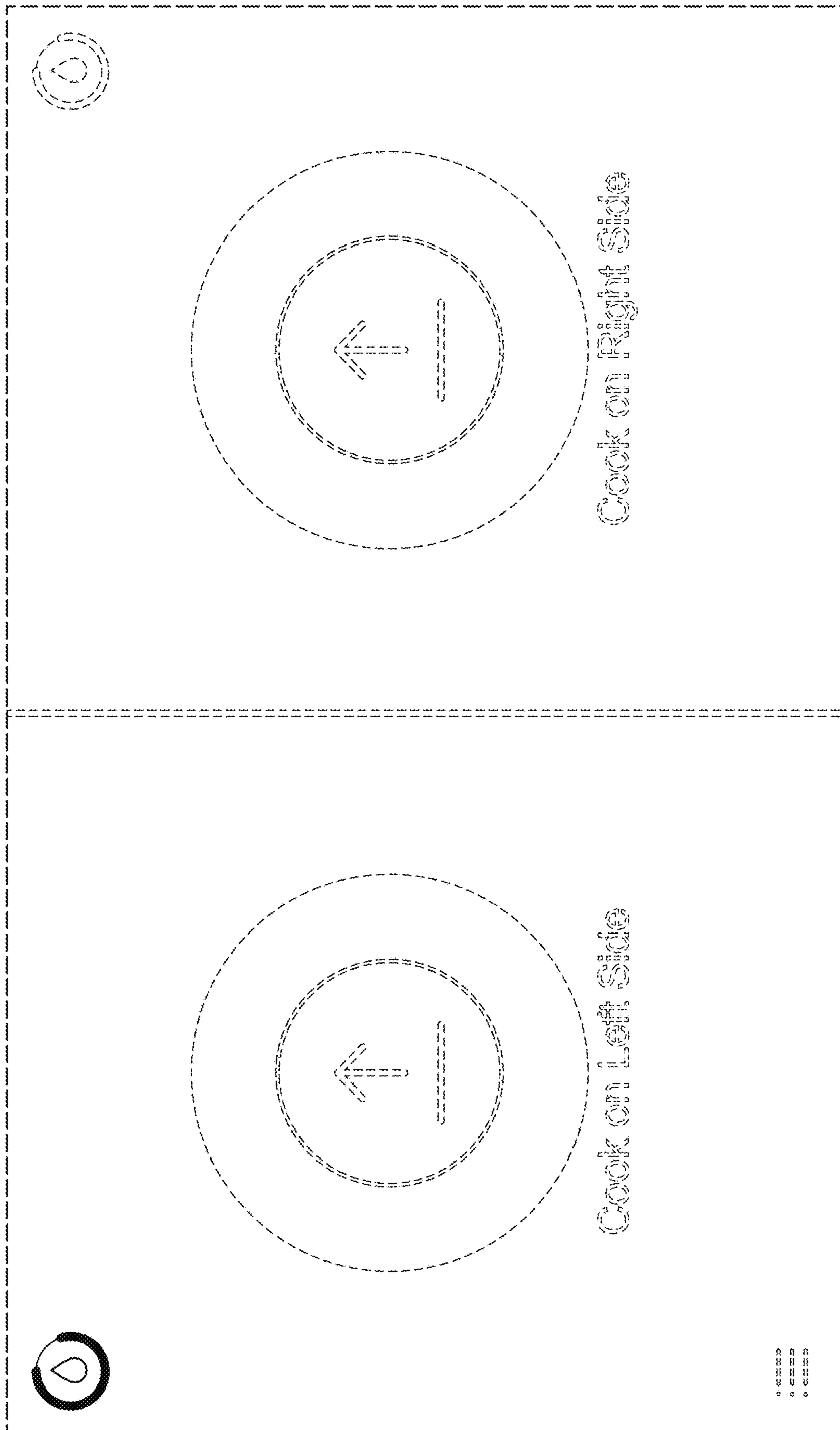

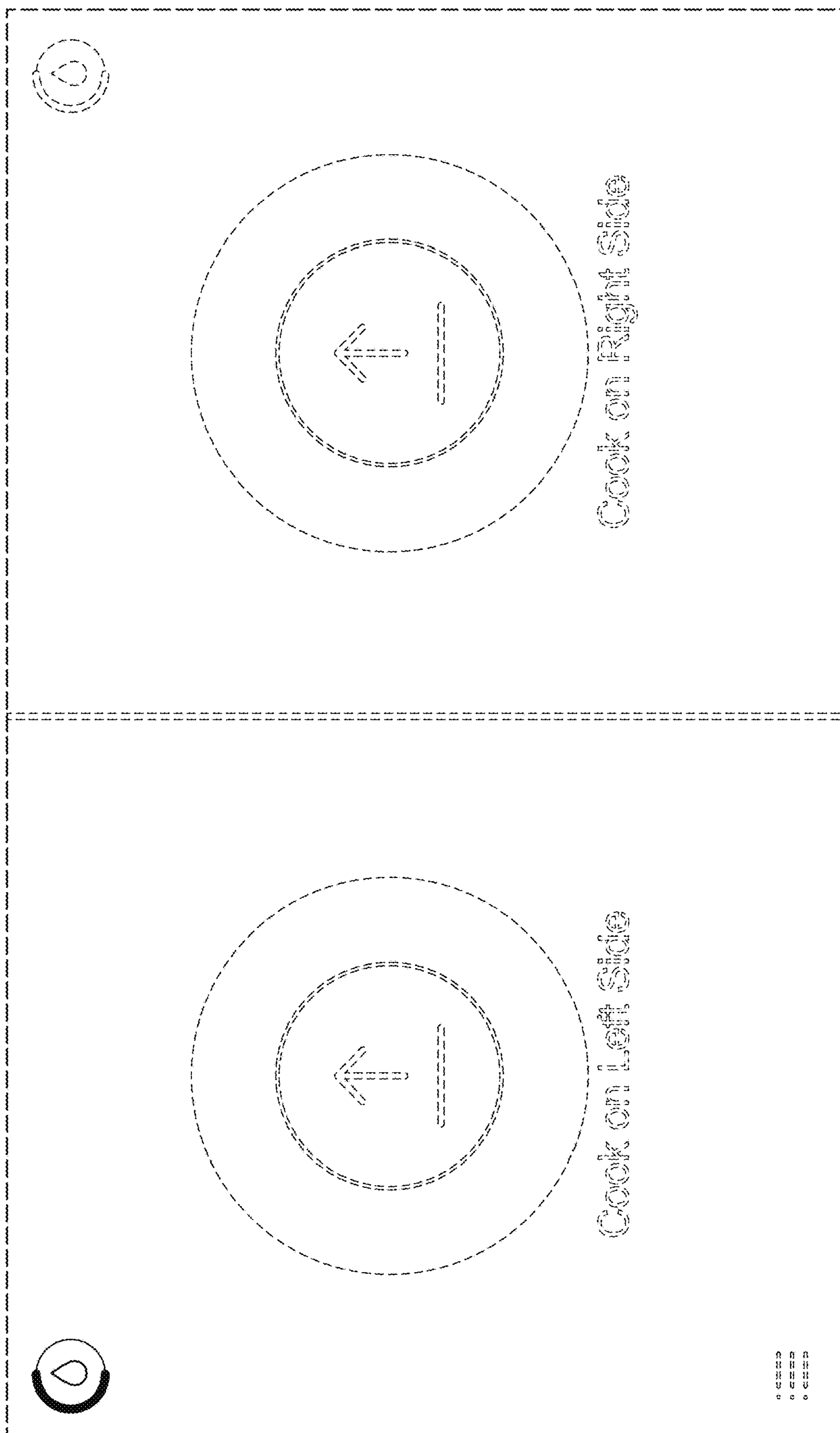

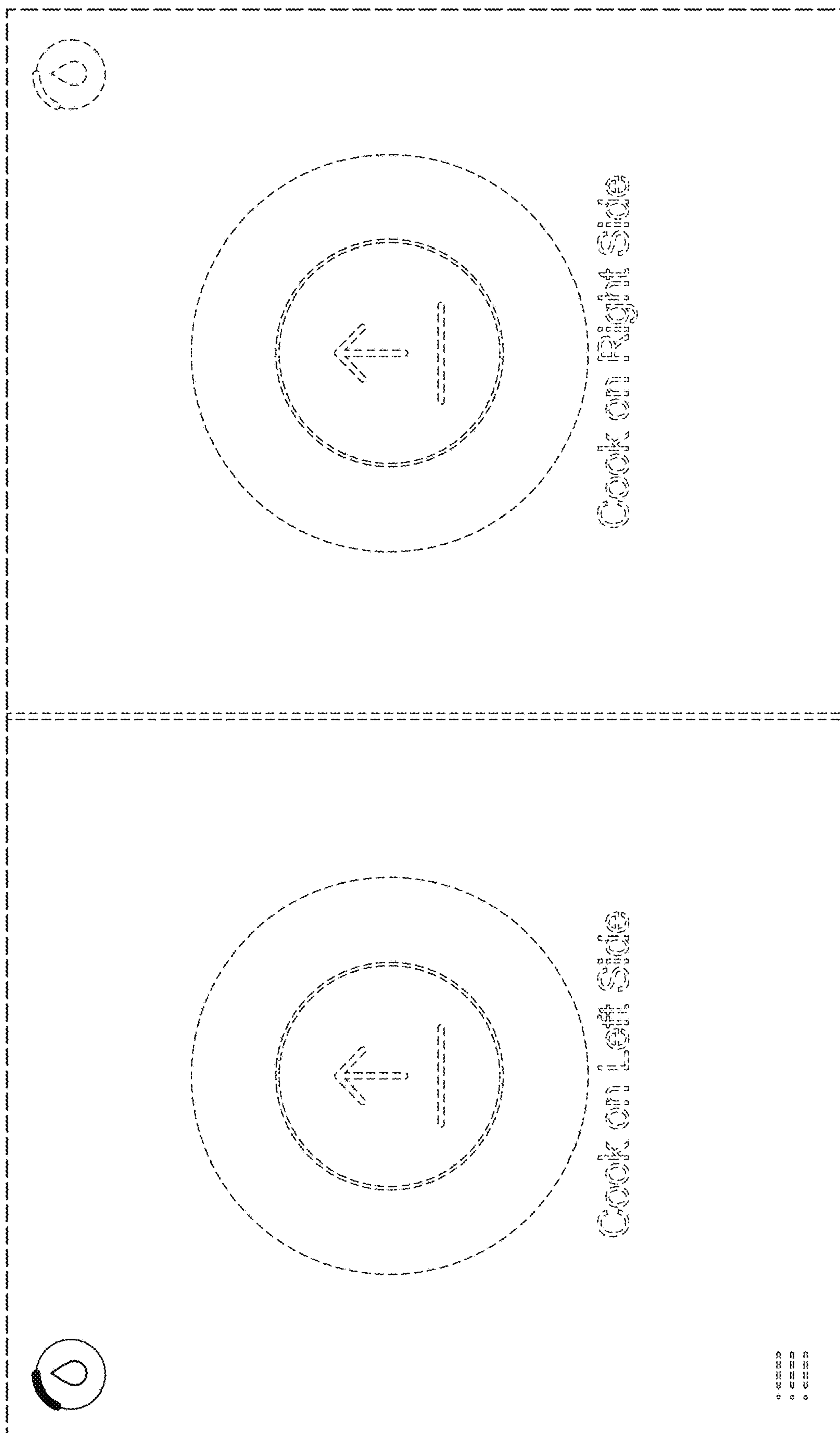

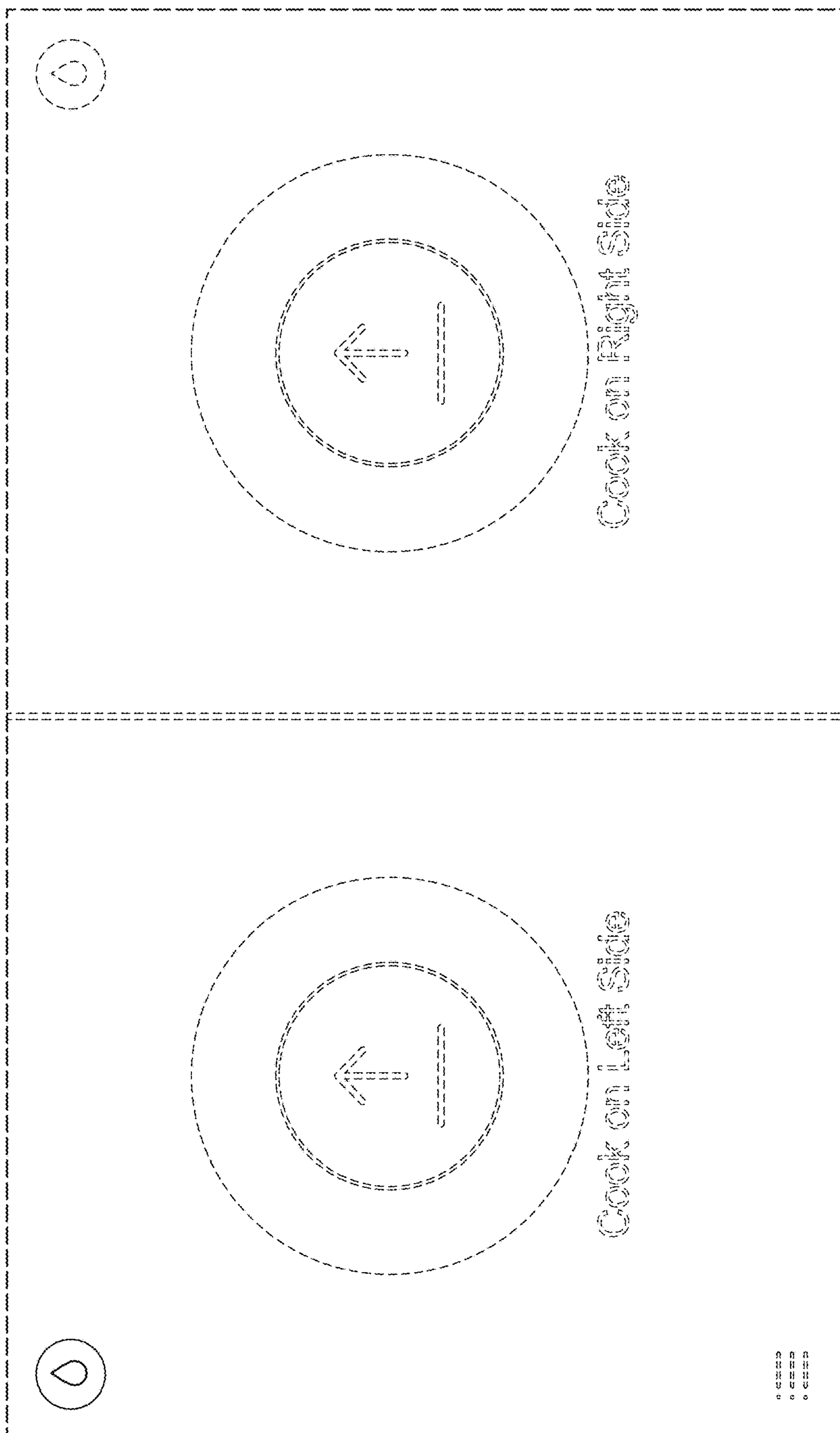

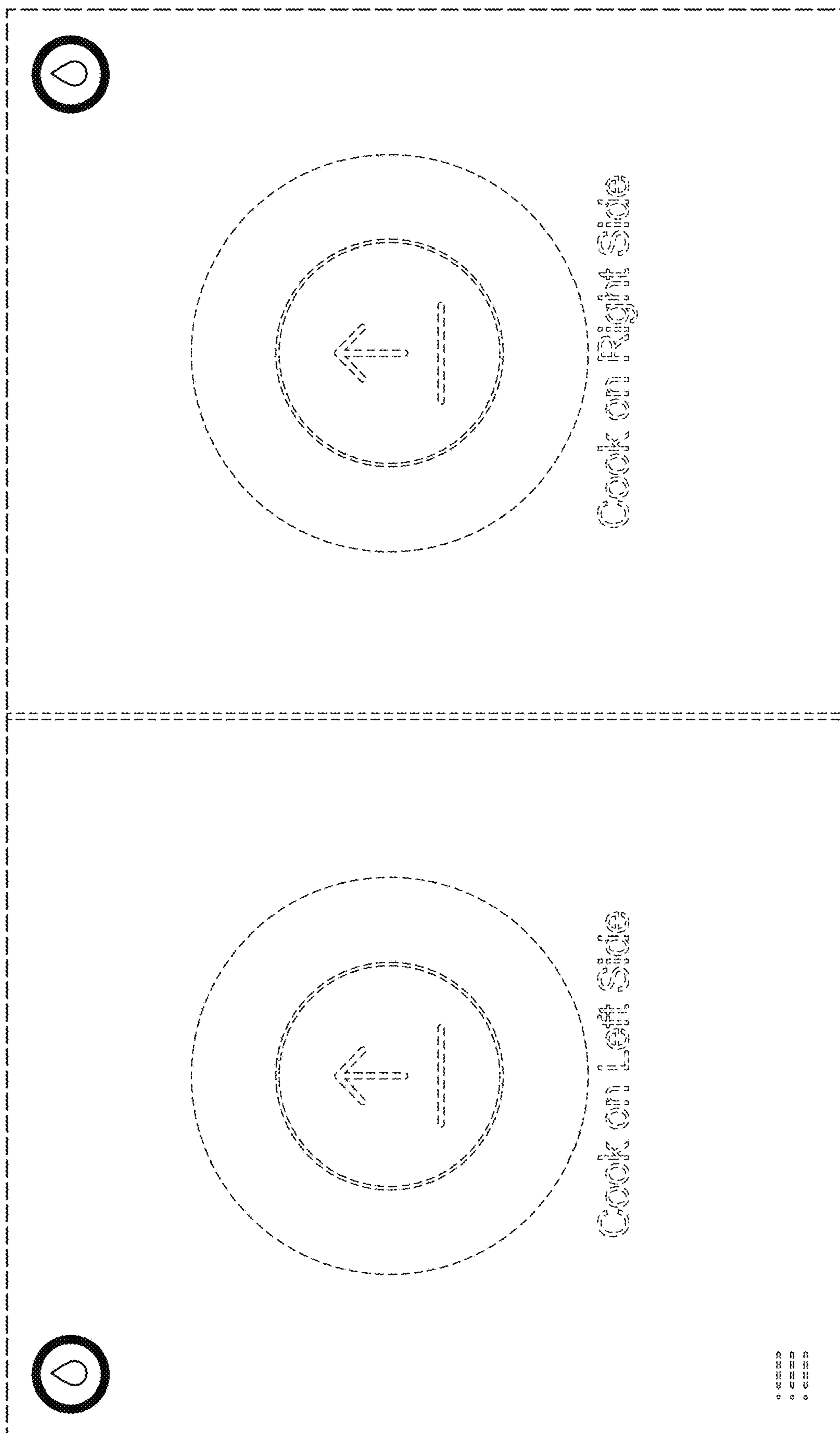

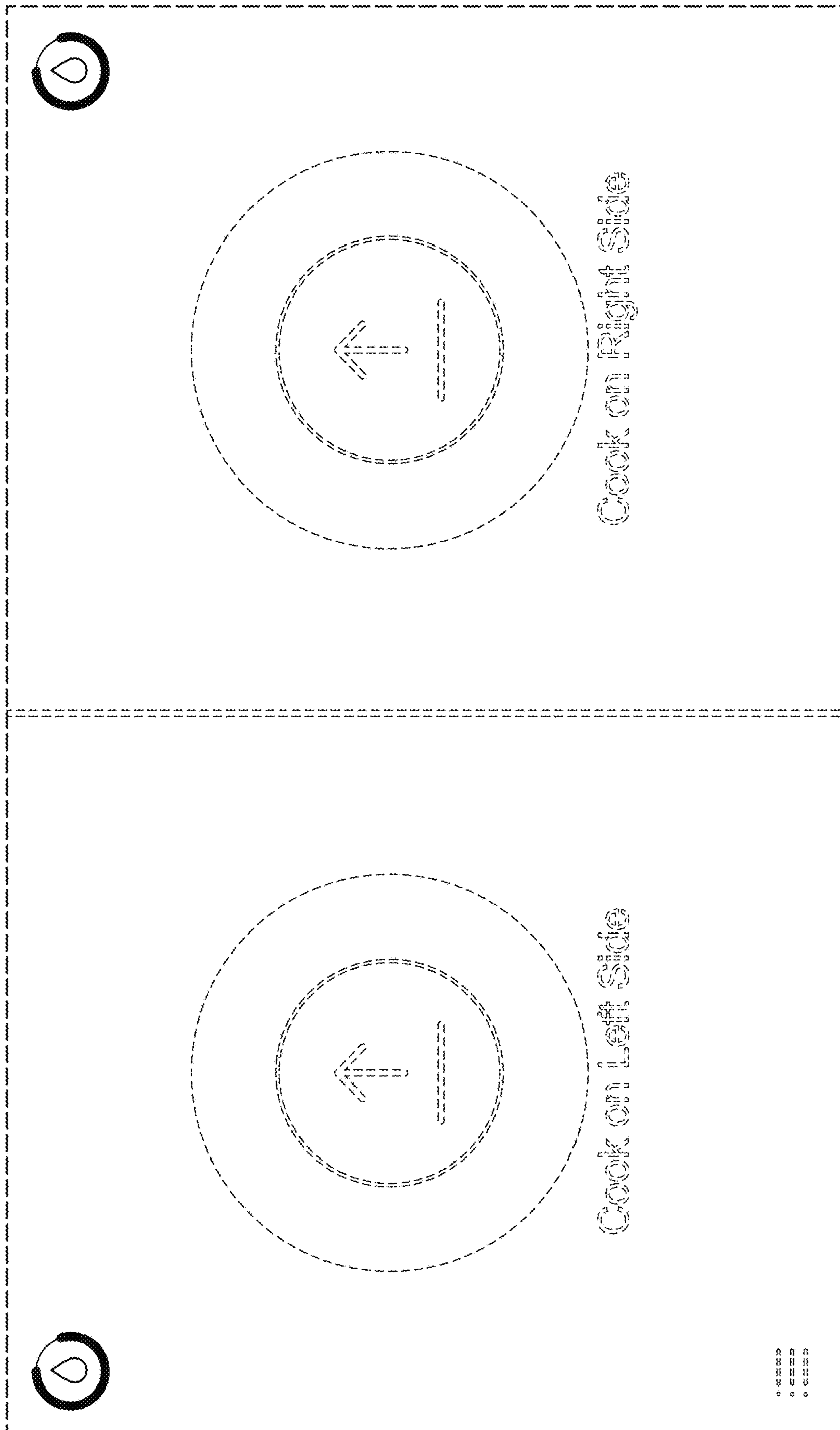

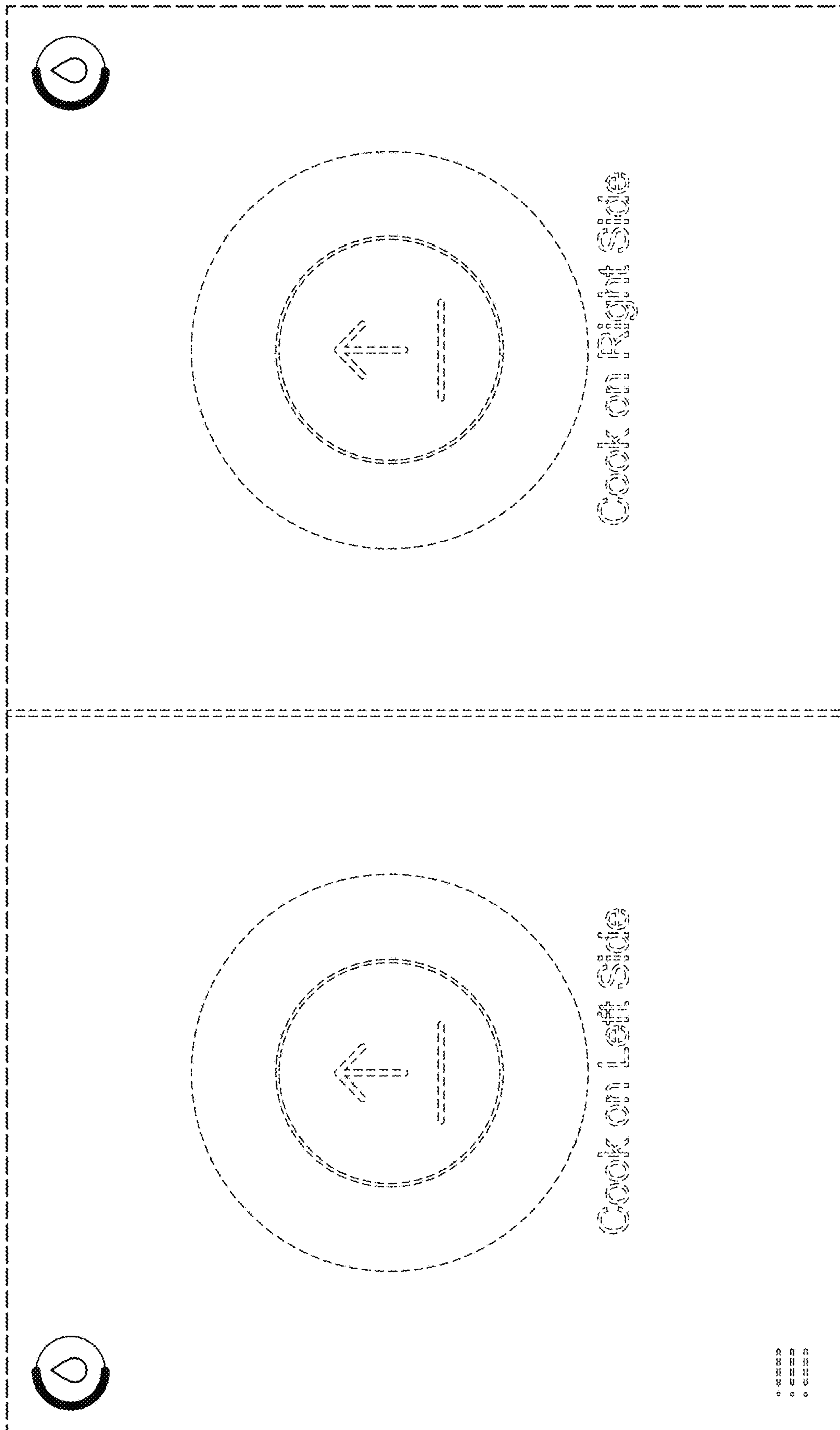

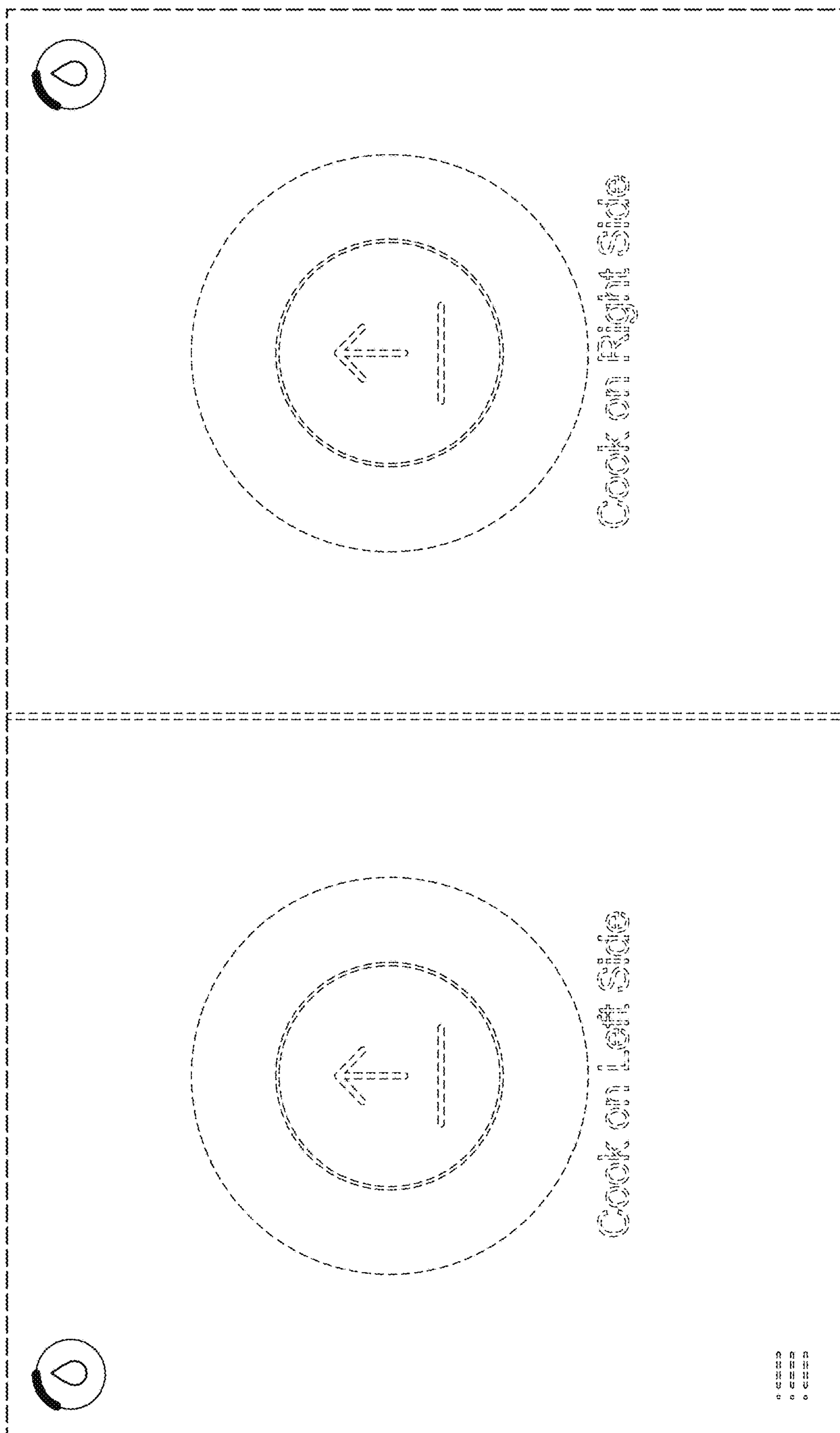

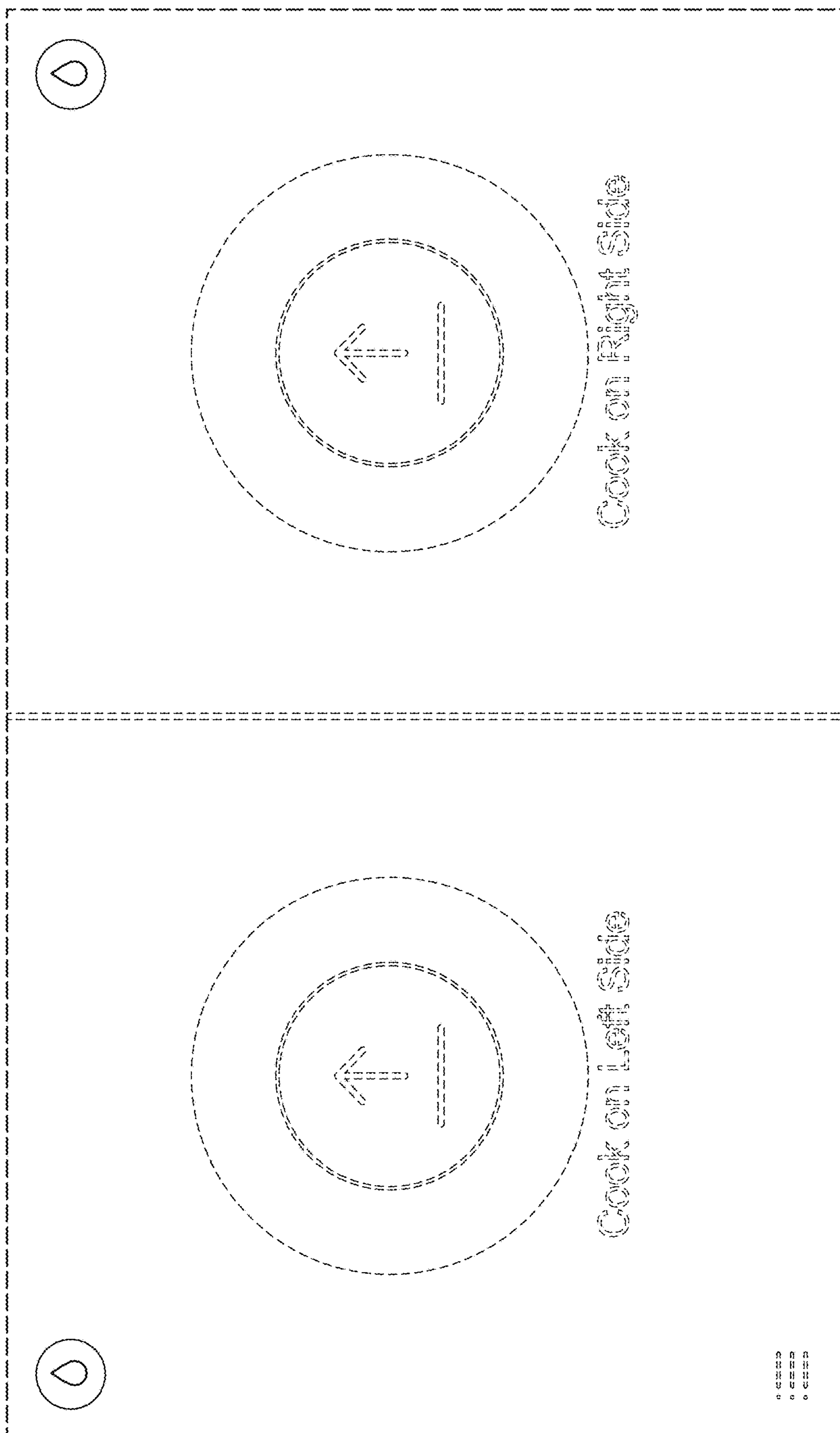
