The ornamental design for a computer screen with a graphical user interface, as shown and described.

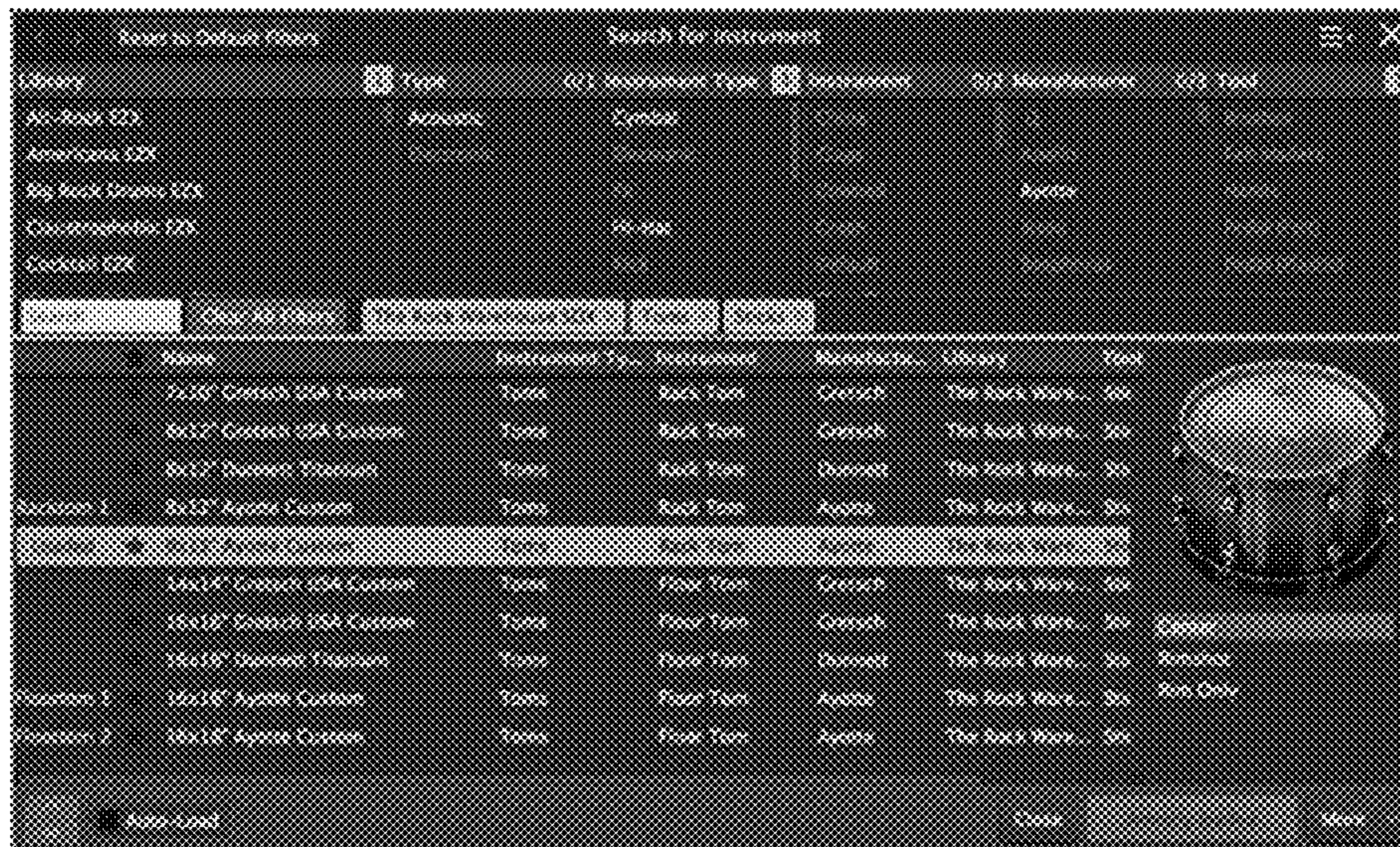
DESCRIPTION


