1.10 : Front view of the tenth image thereof;

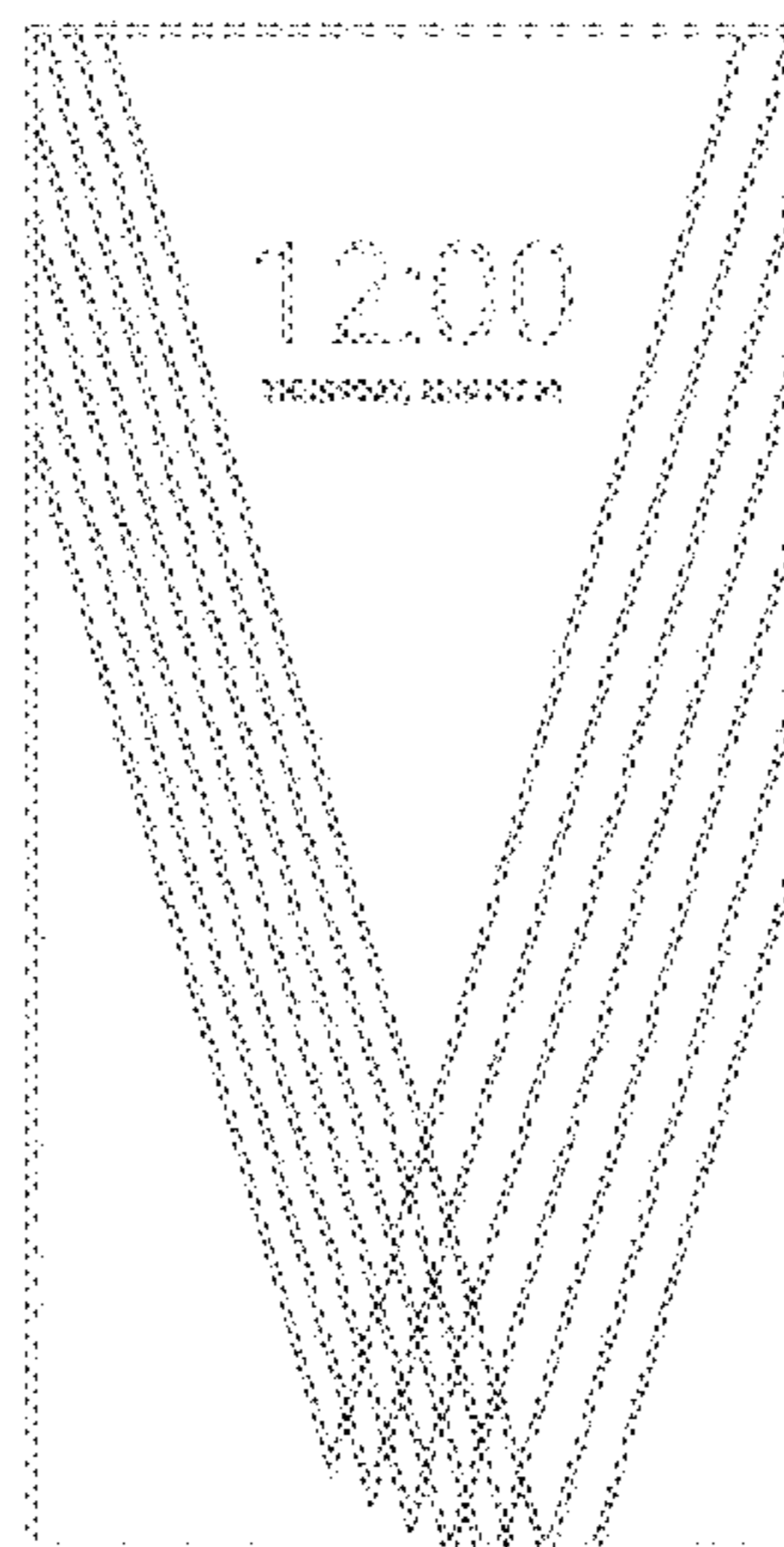
1.11 : Front view of the eleventh image thereof; and

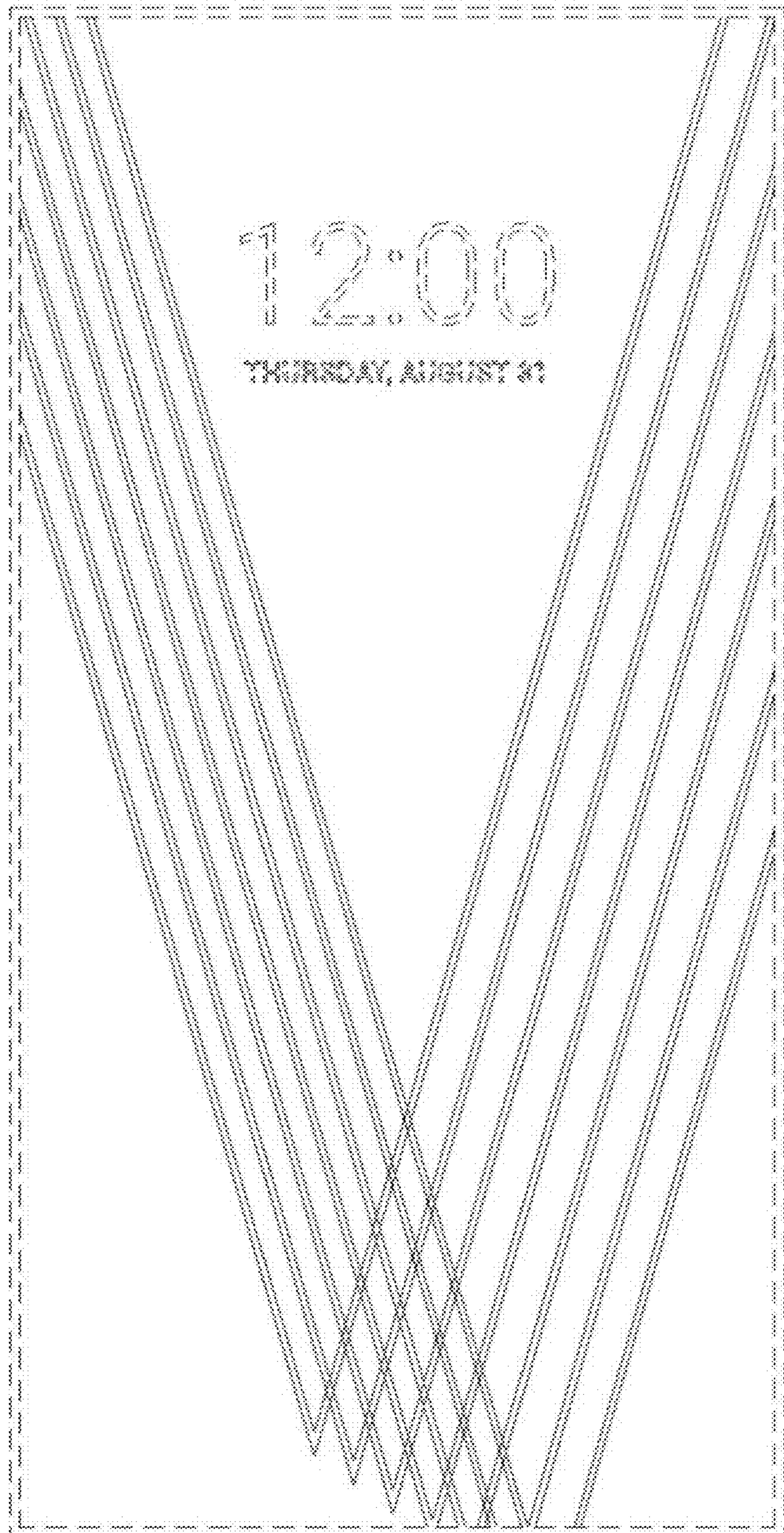

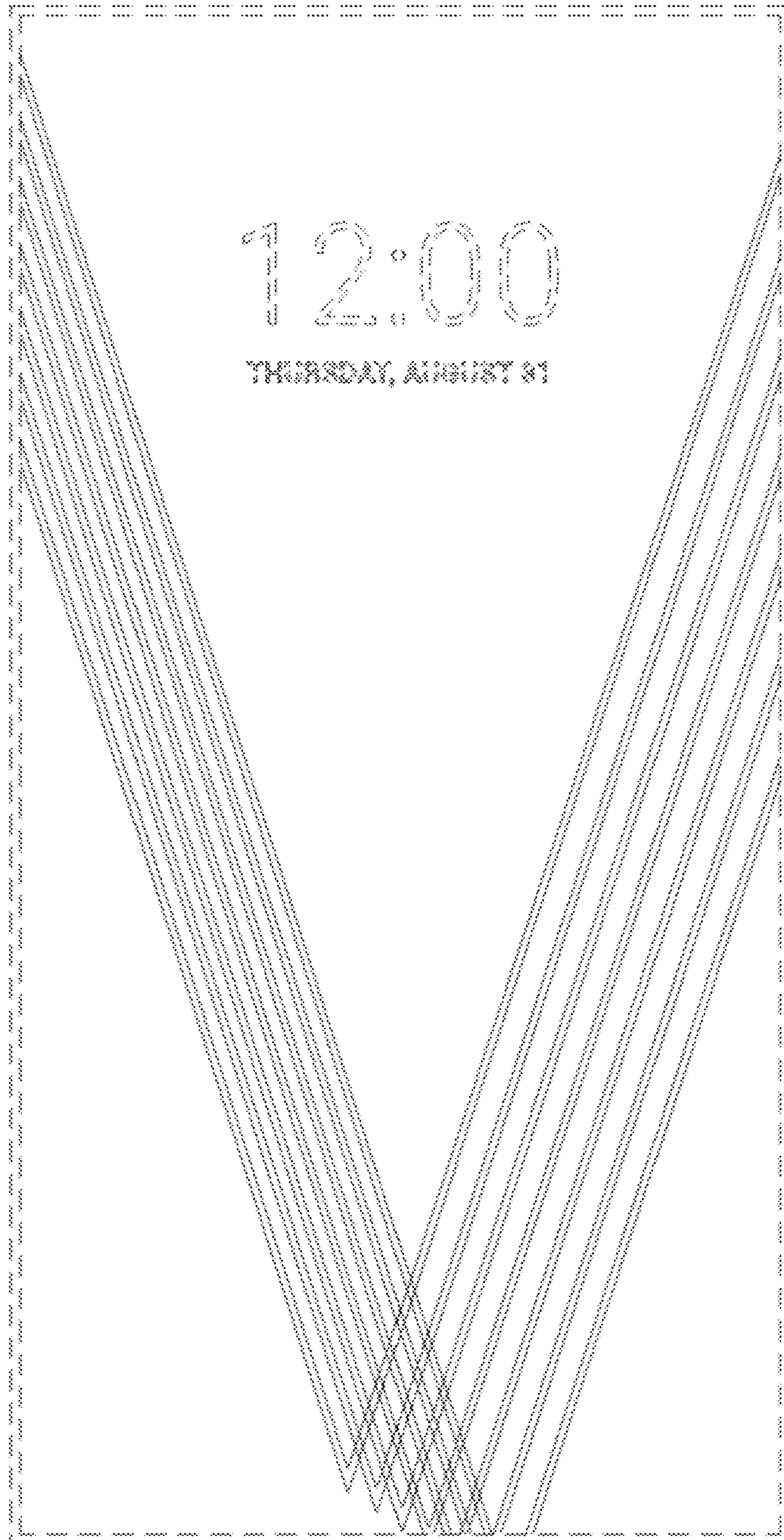

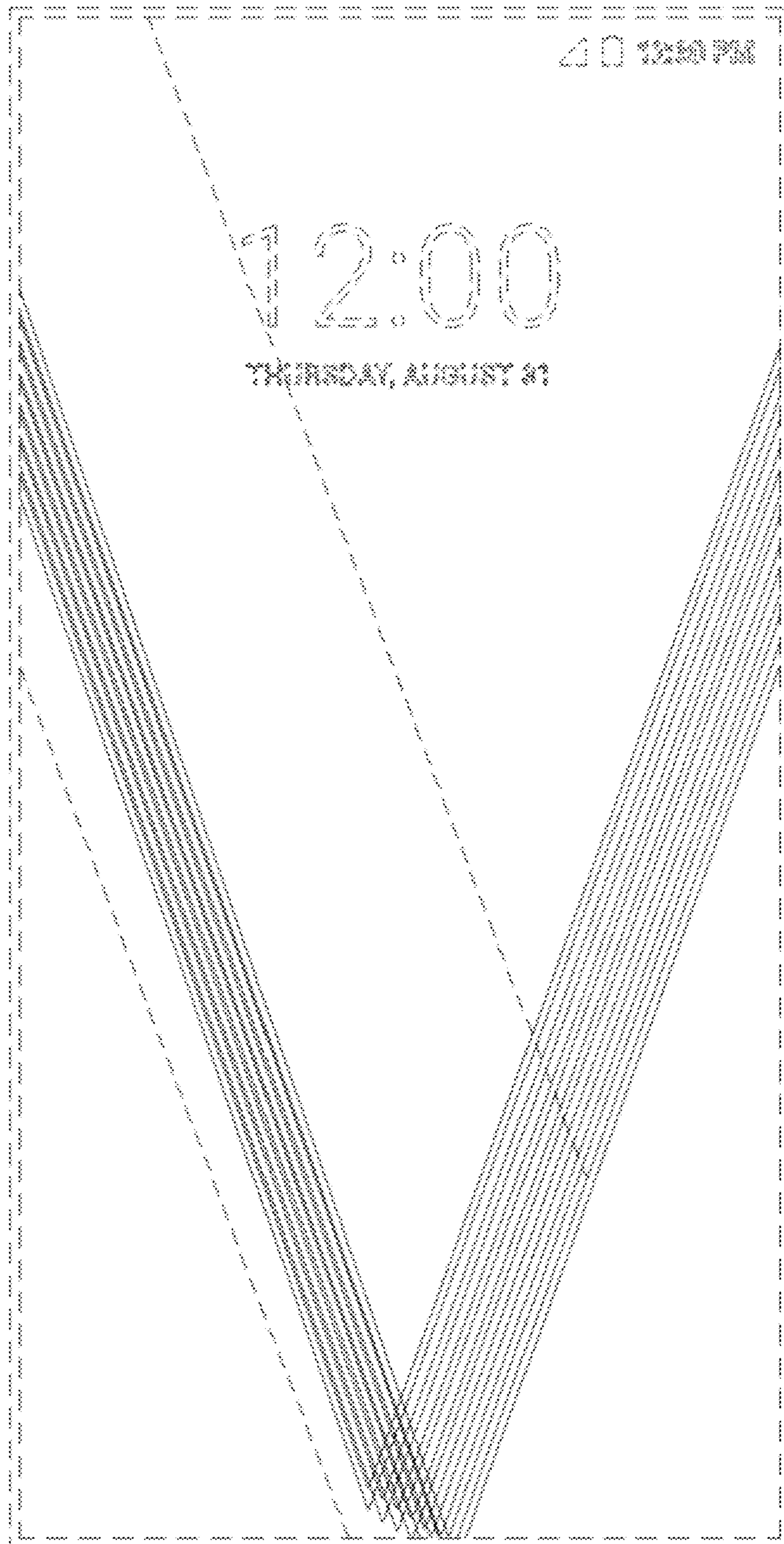

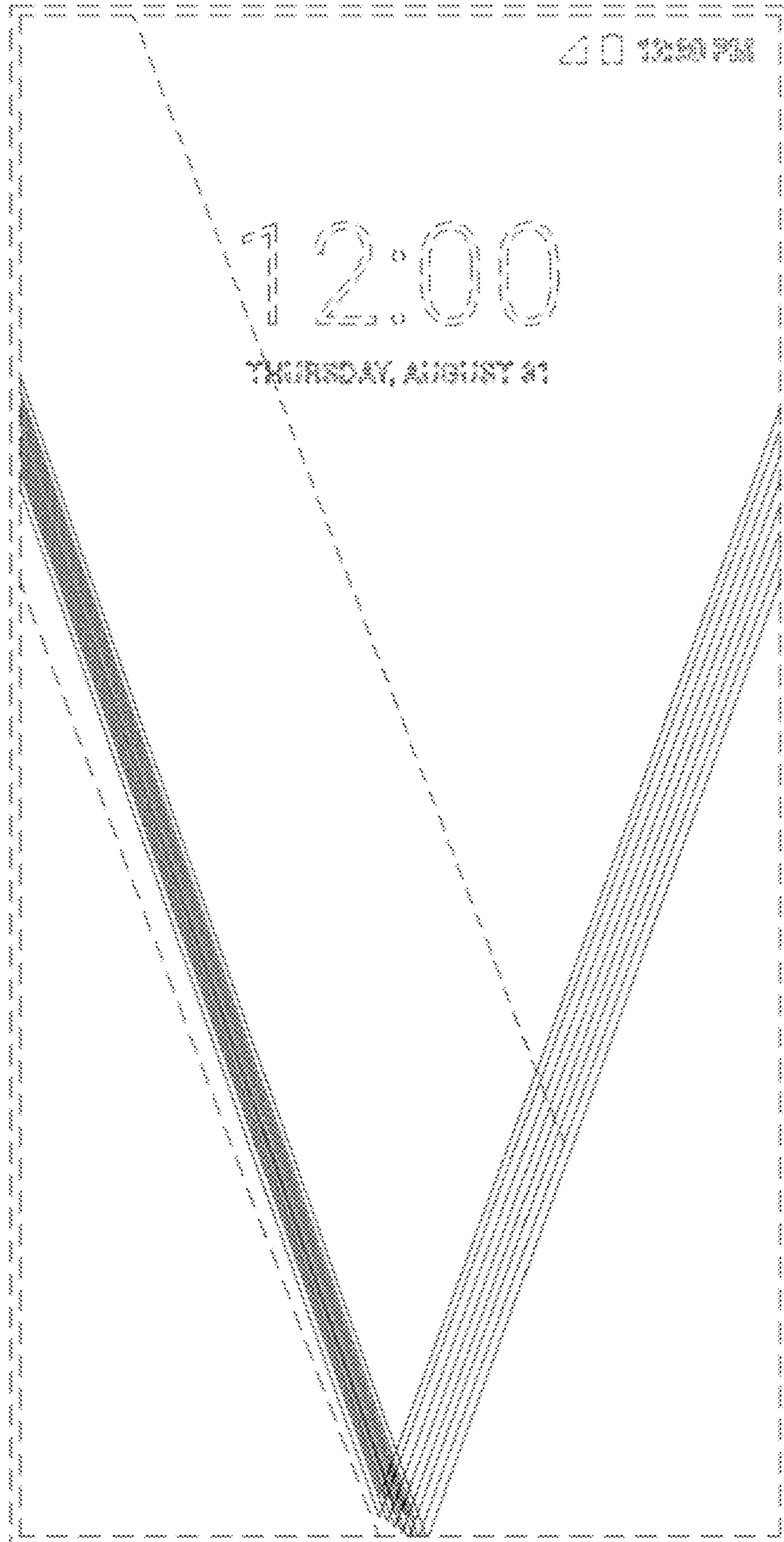

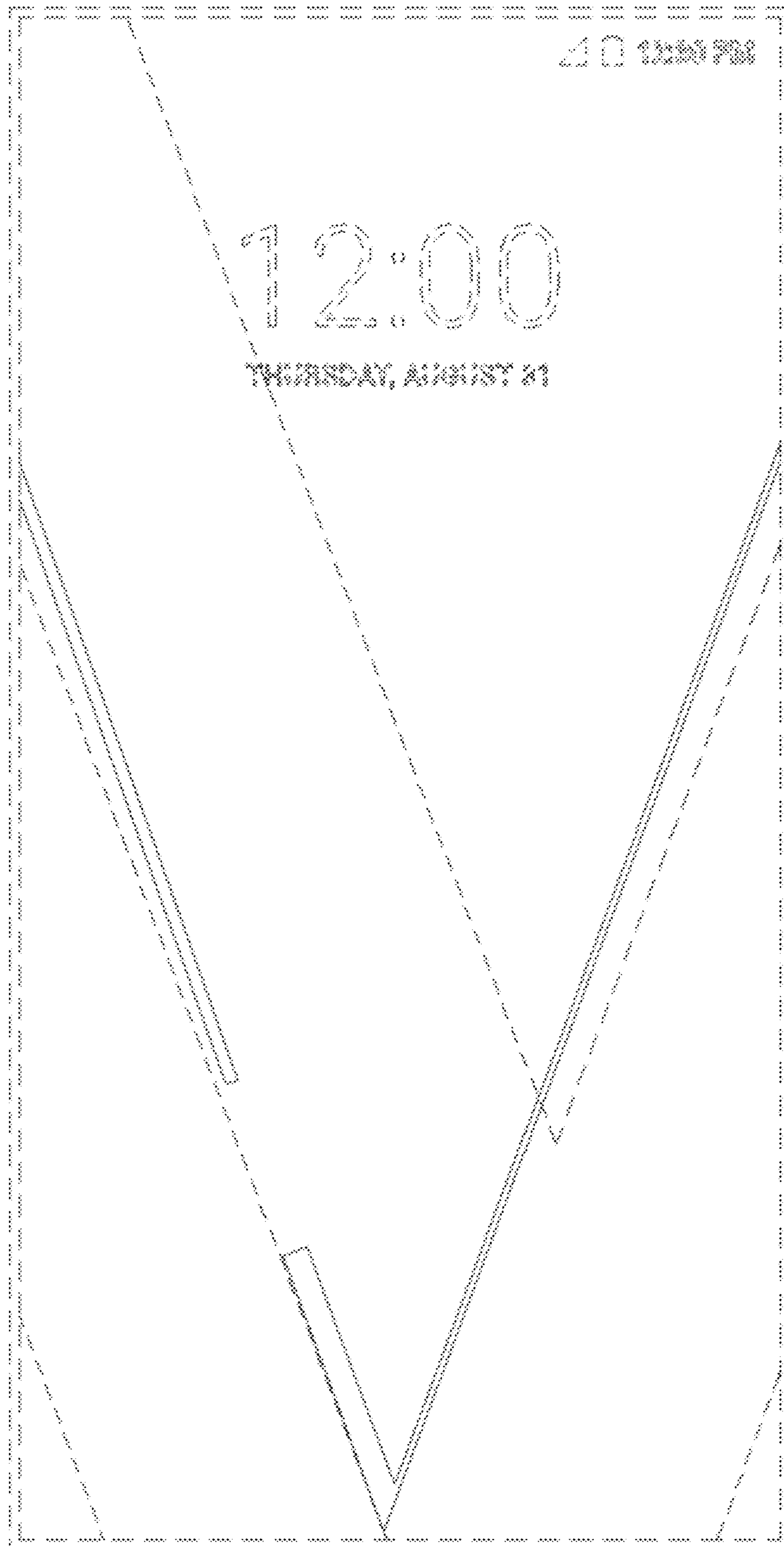

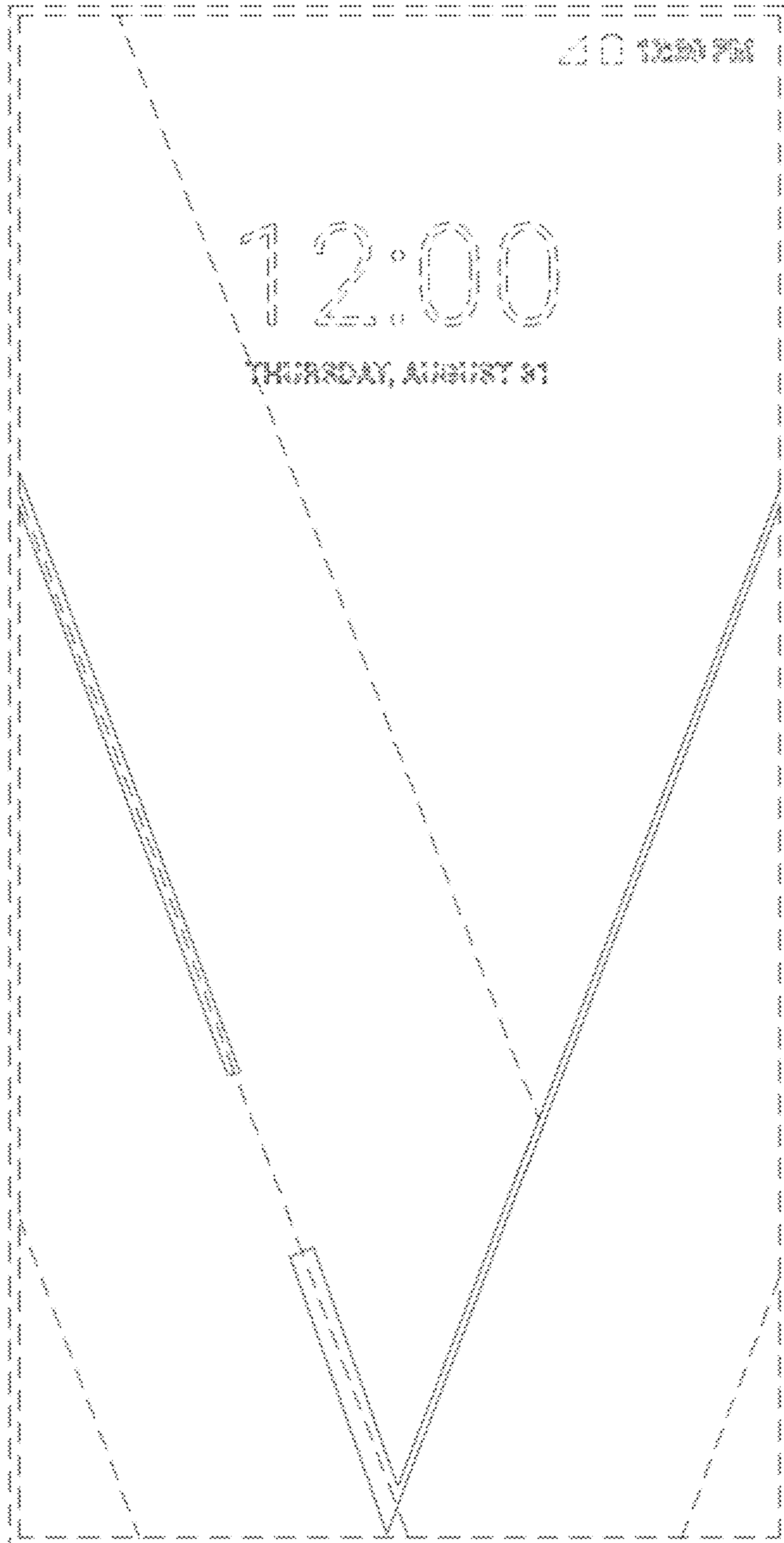

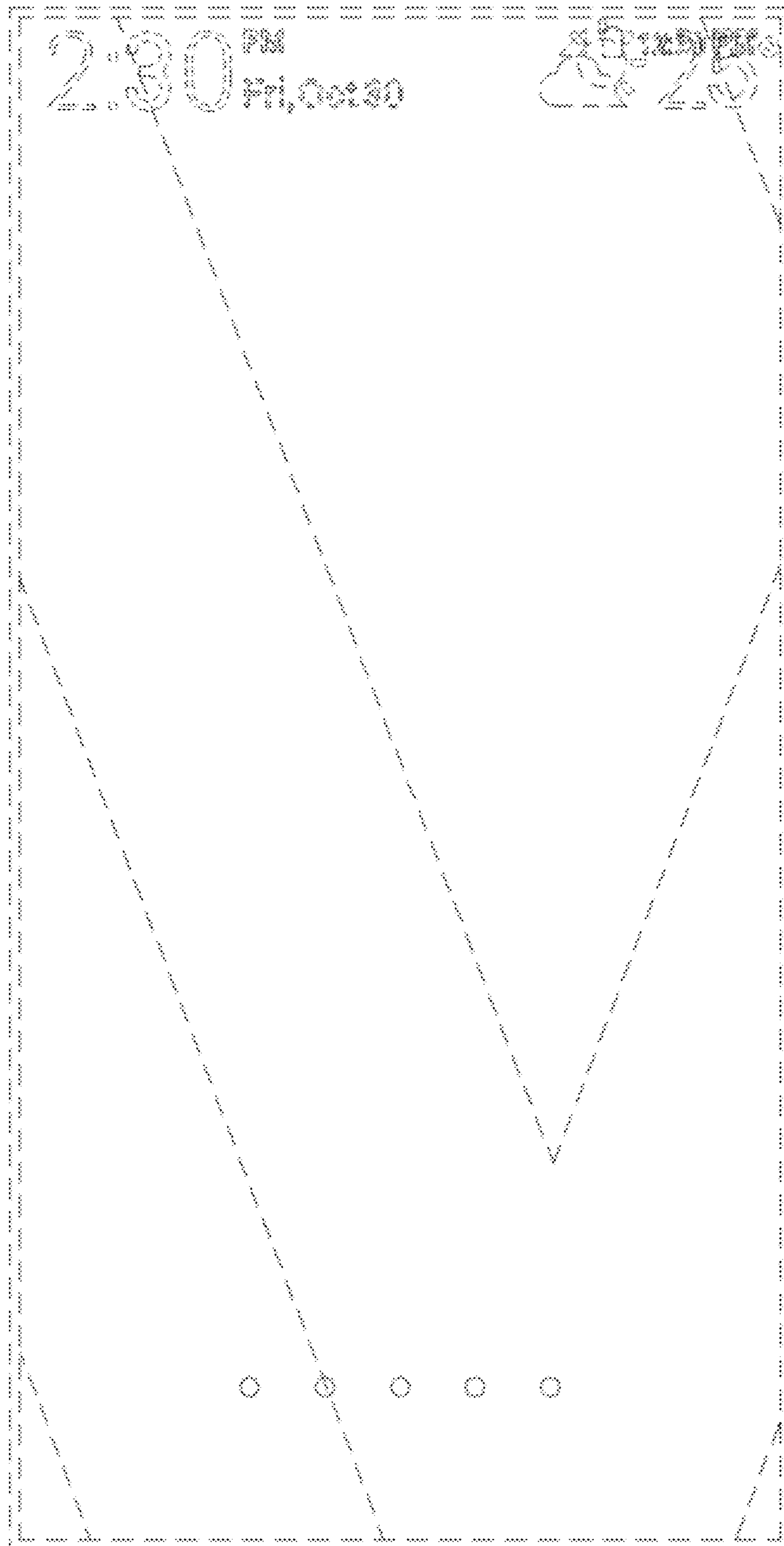

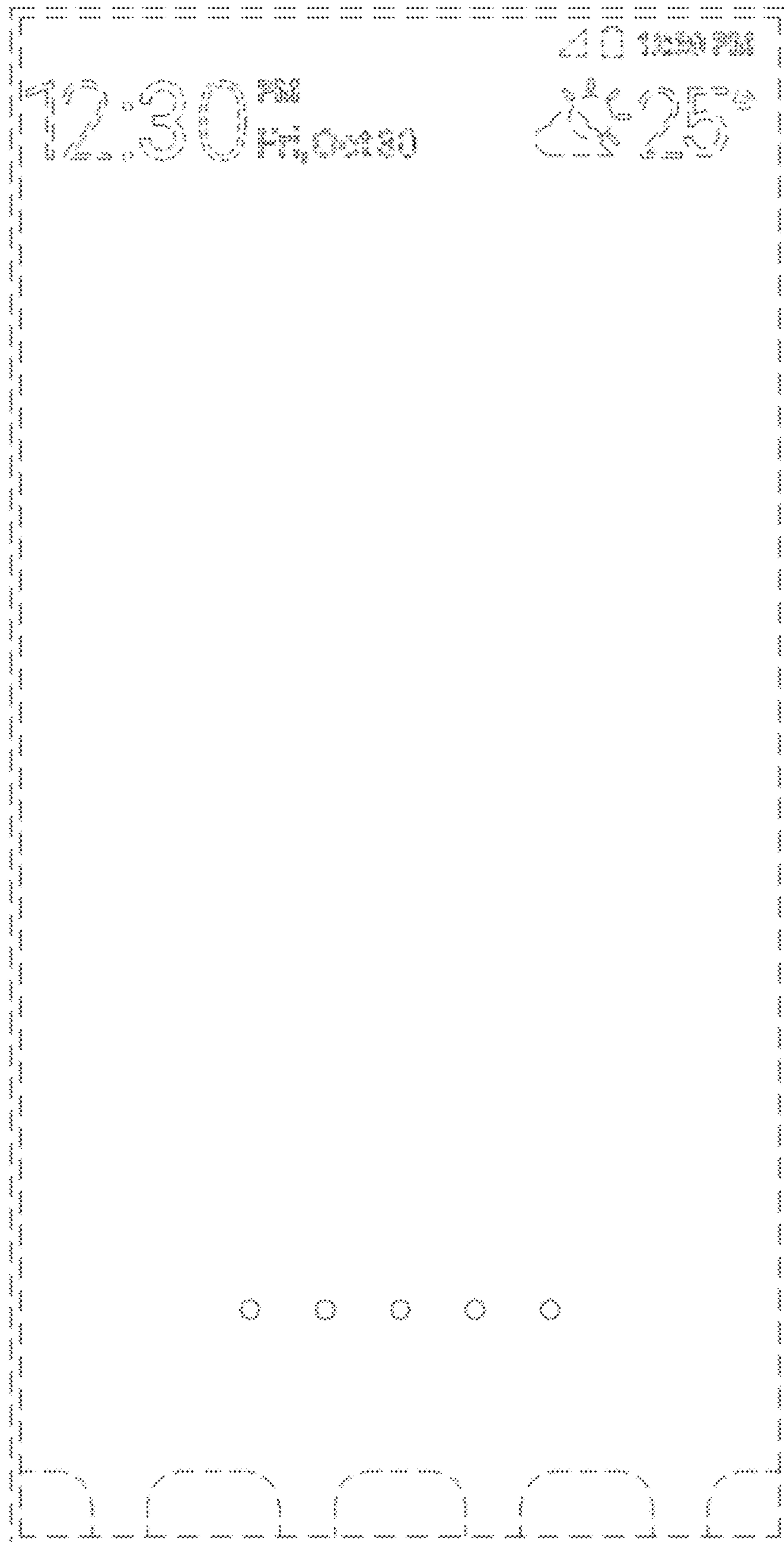

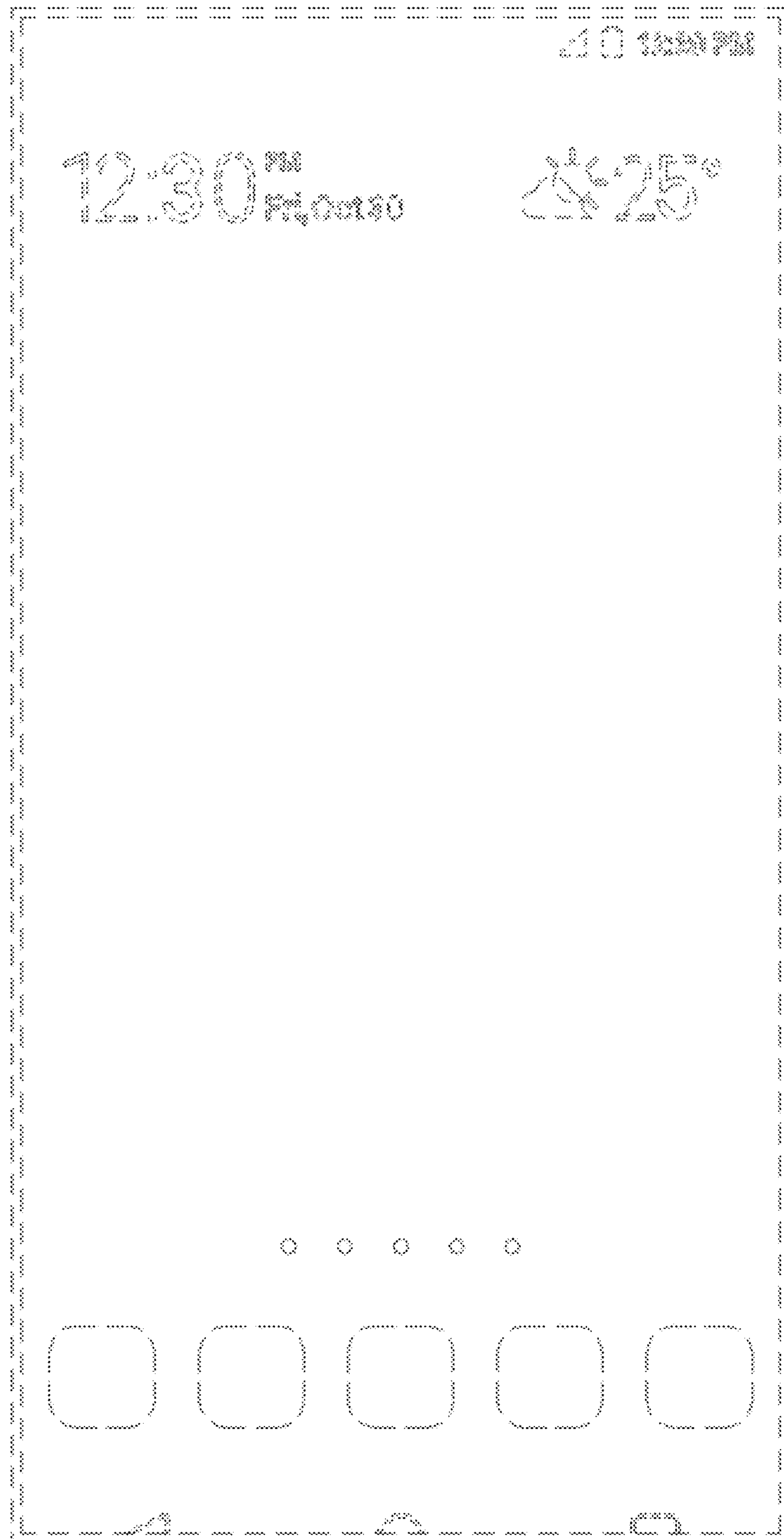
