(57) **CLAIM**

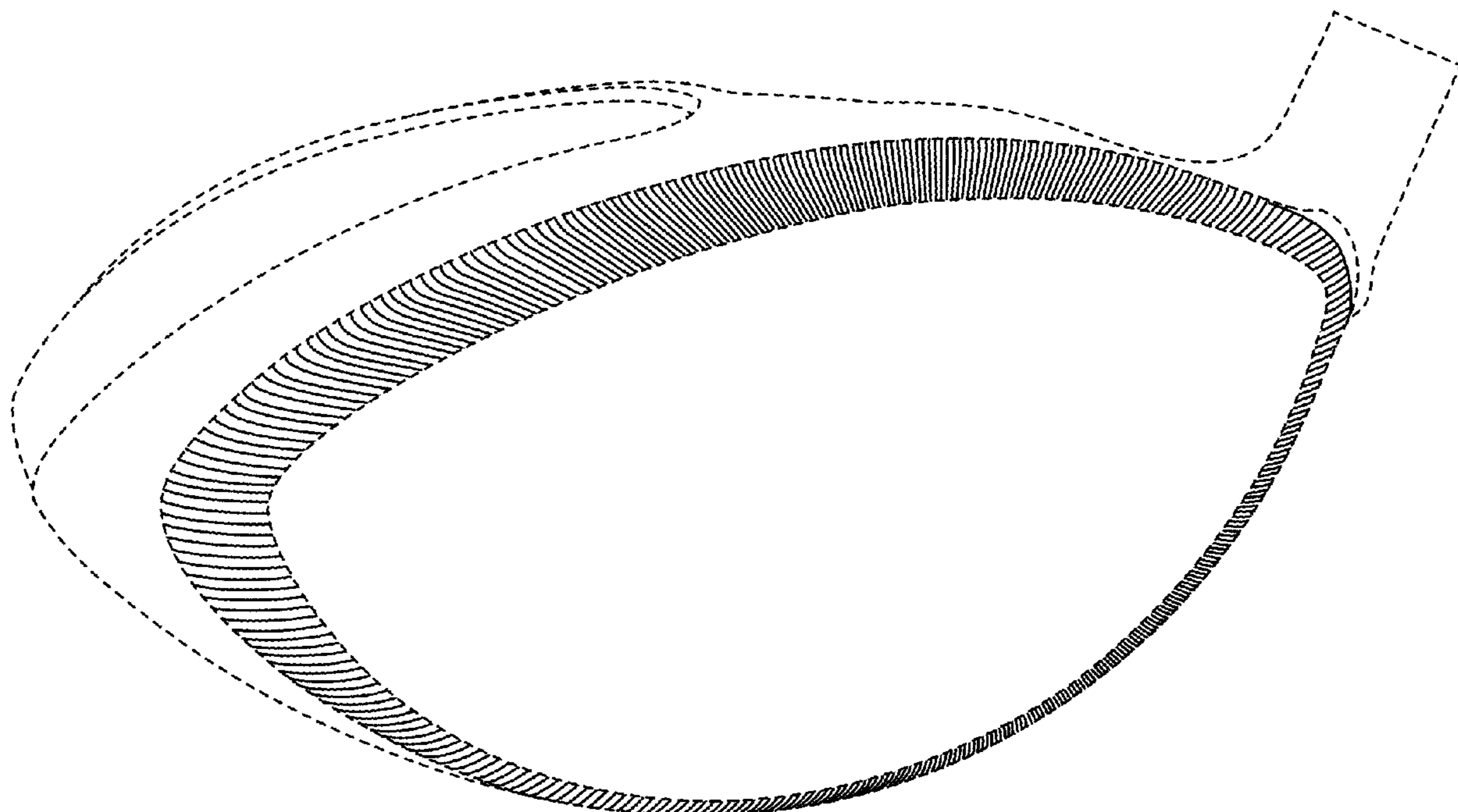
The ornamental design for a golf club head, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a golf club head employing an ornamental design in accordance with the present invention;  
FIG. 2 is a front elevational view of the golf club head of FIG. 1;  
FIG. 3 is a rear elevational view of the golf club head of FIG. 1;  
FIG. 4 is a right side elevational view of the golf club head of FIG. 1;  
FIG. 5 is a left side elevational view of the golf club head of FIG. 1;

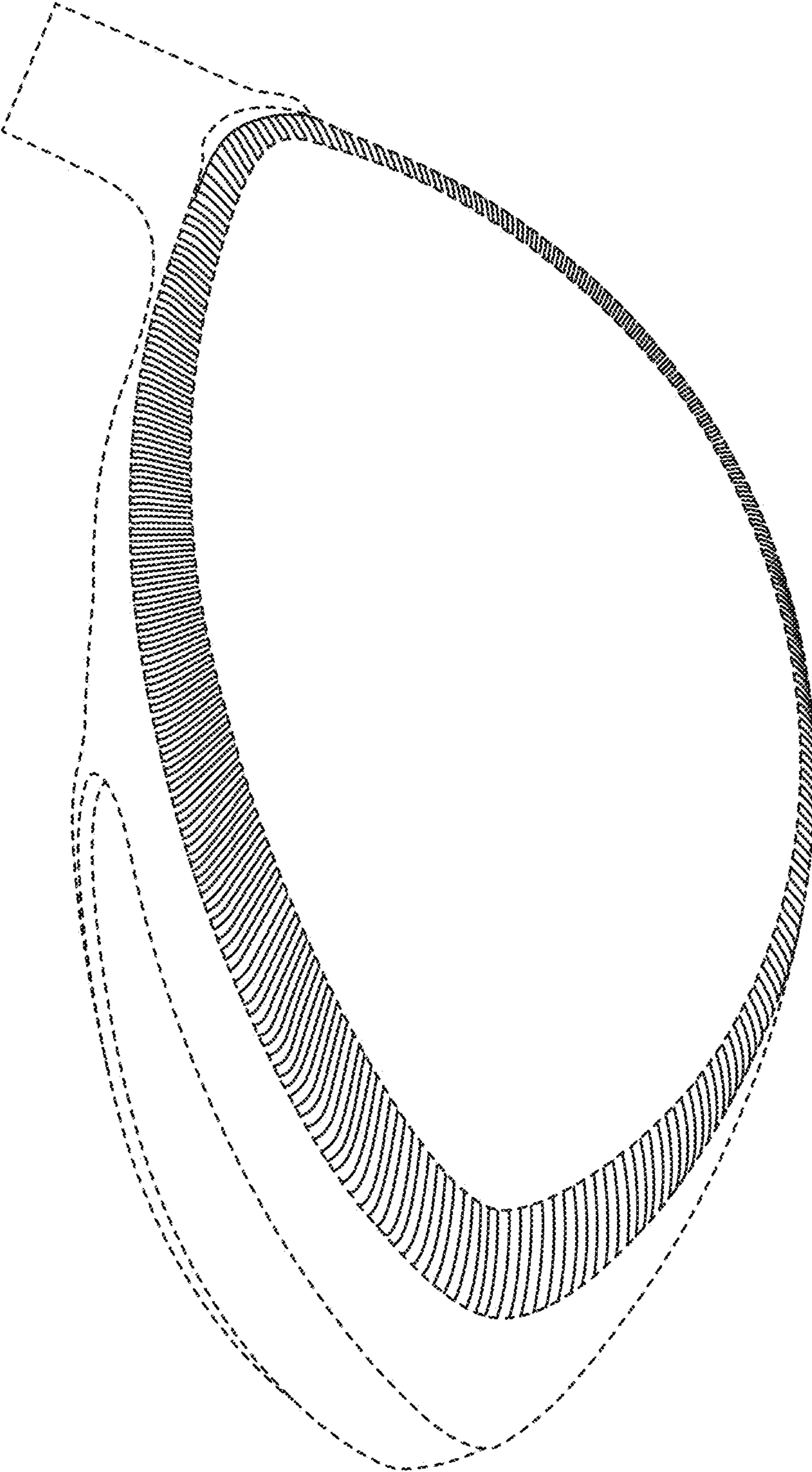

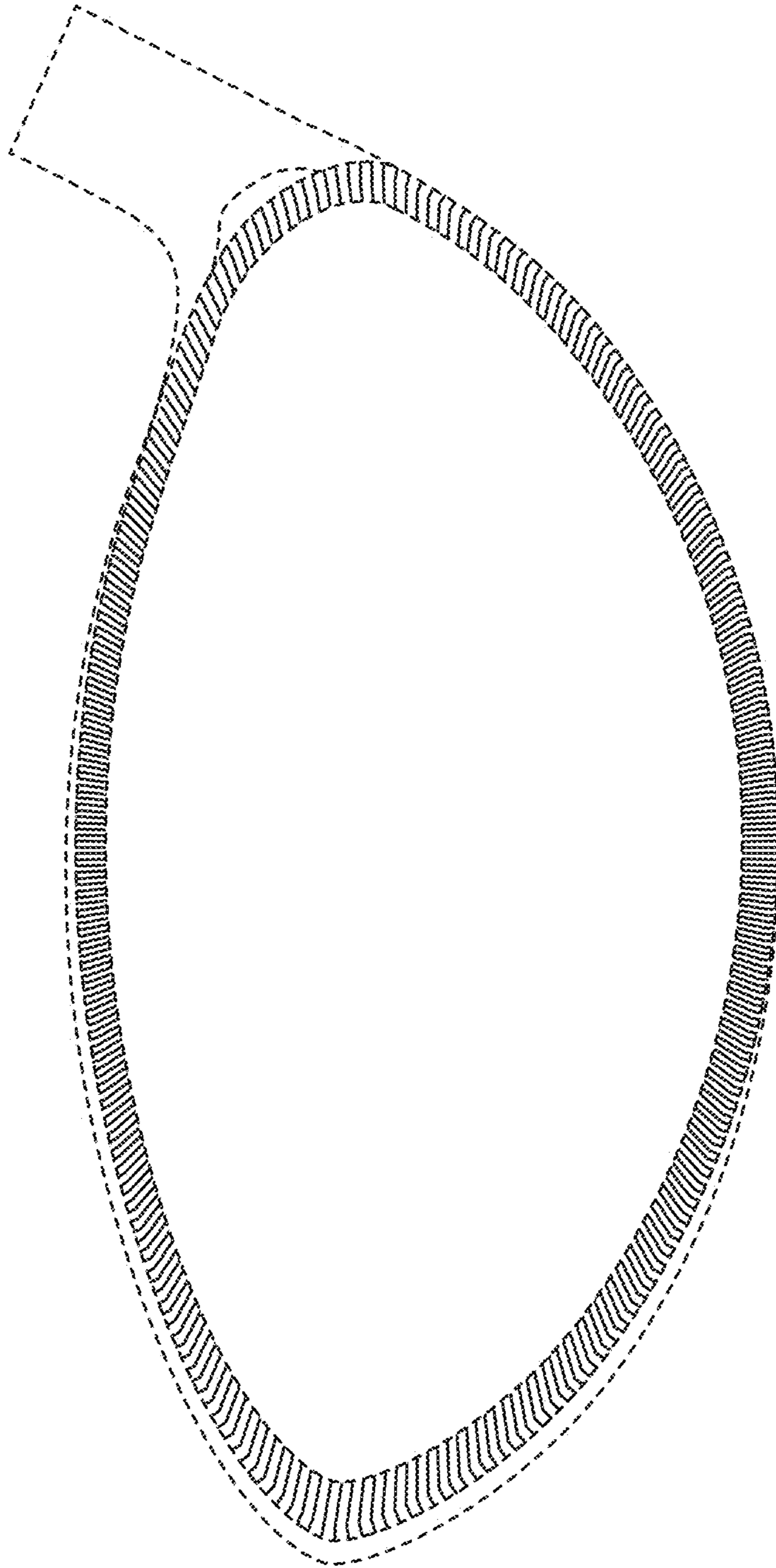

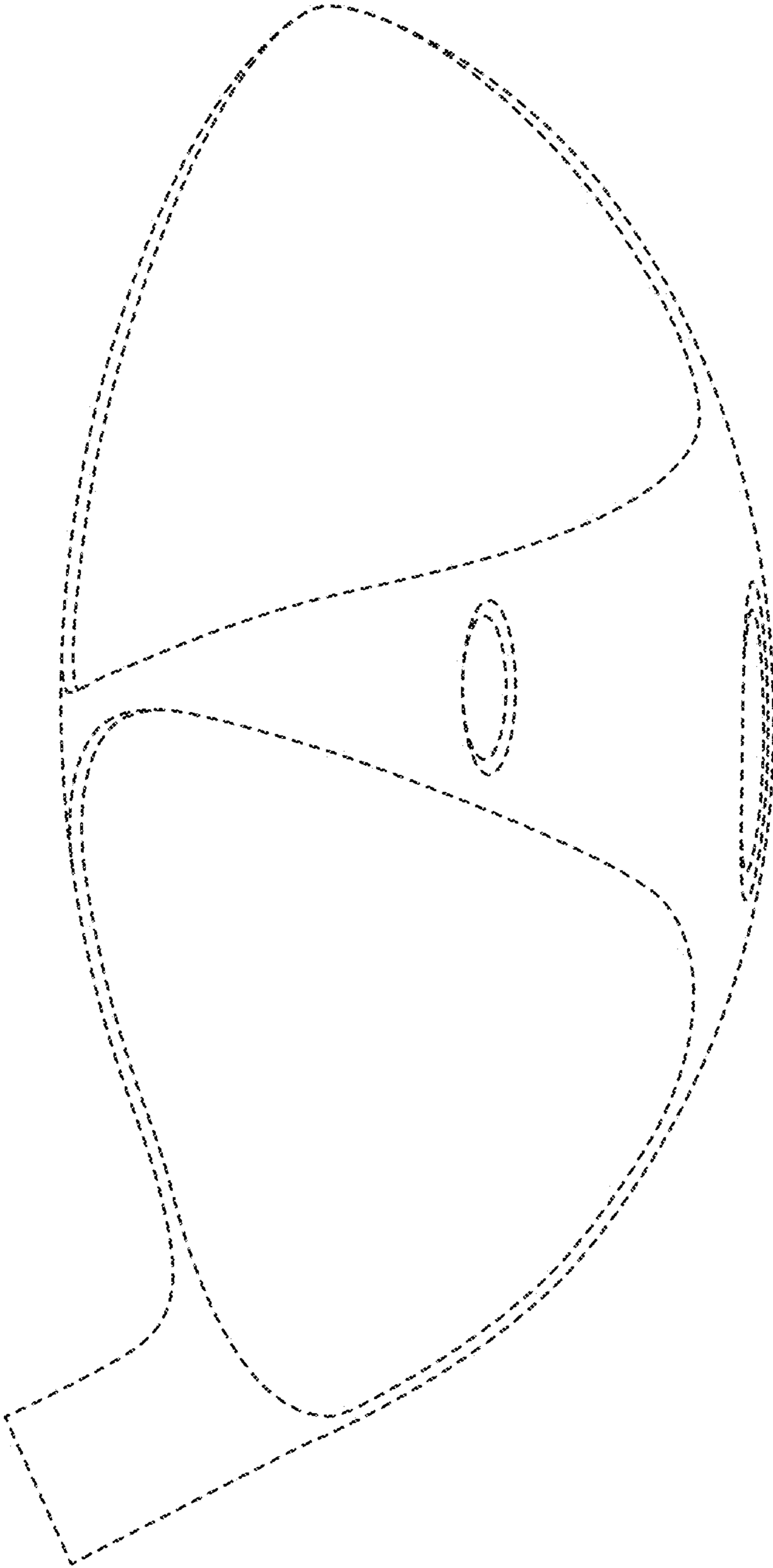

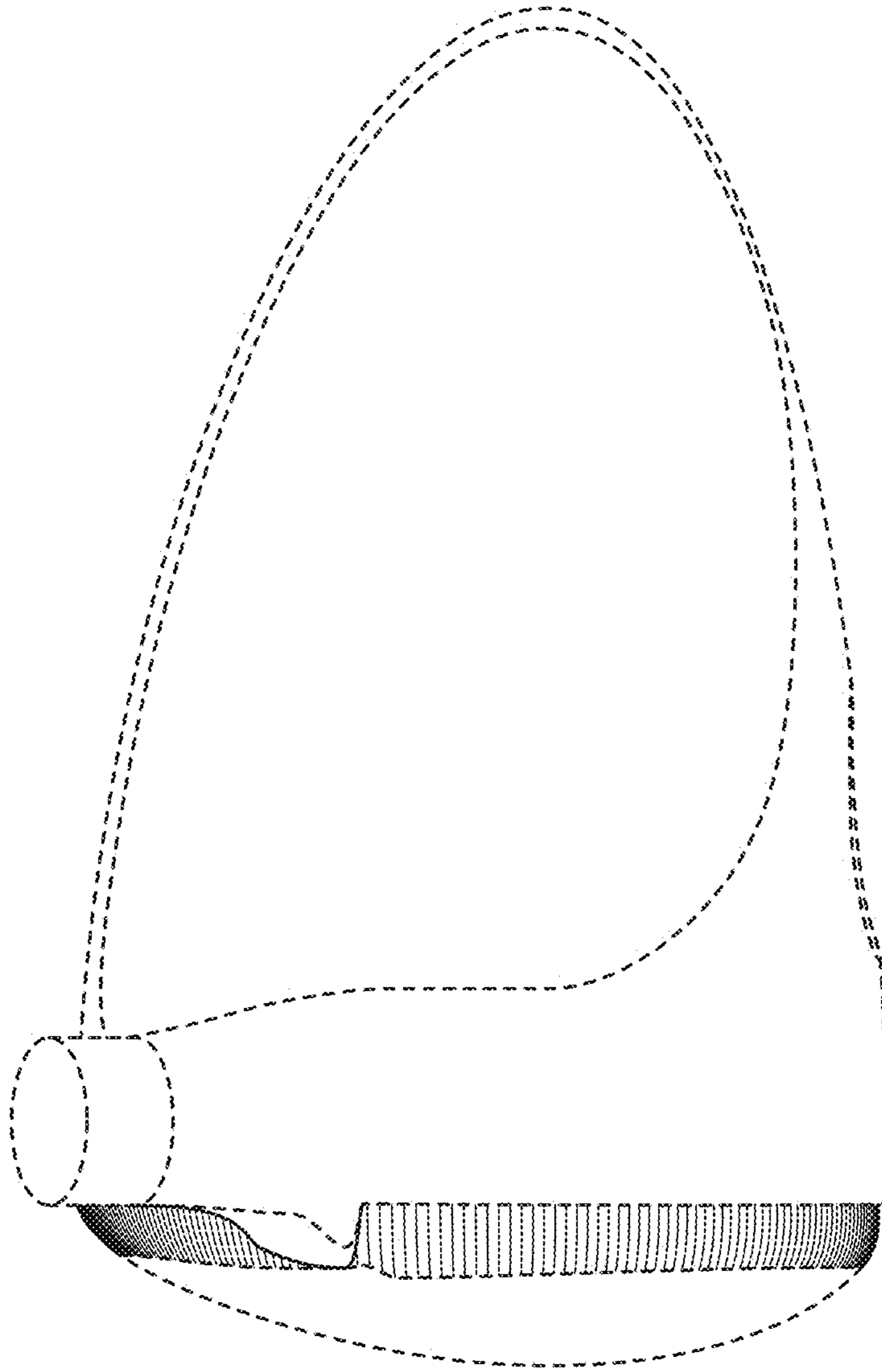

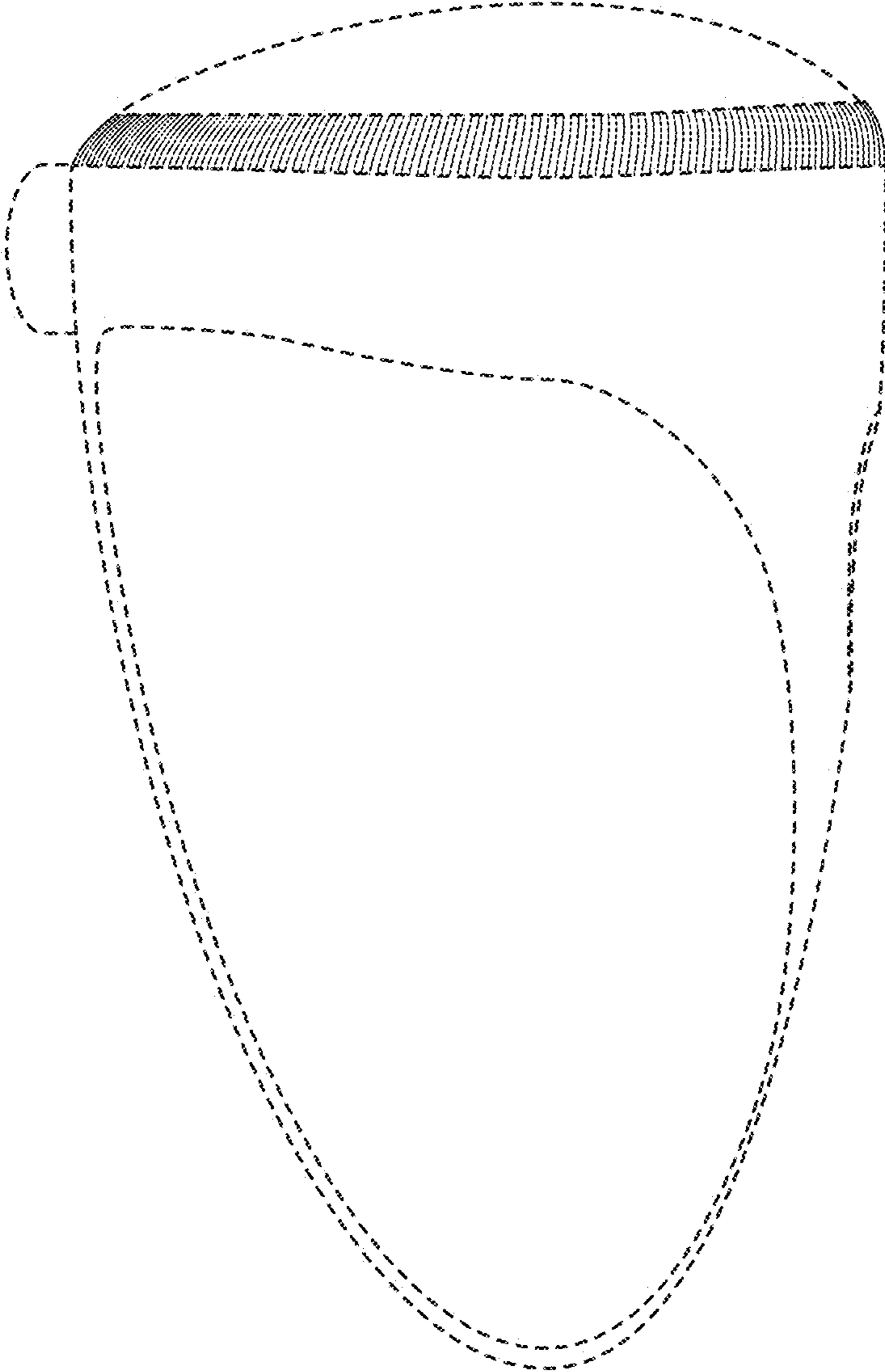

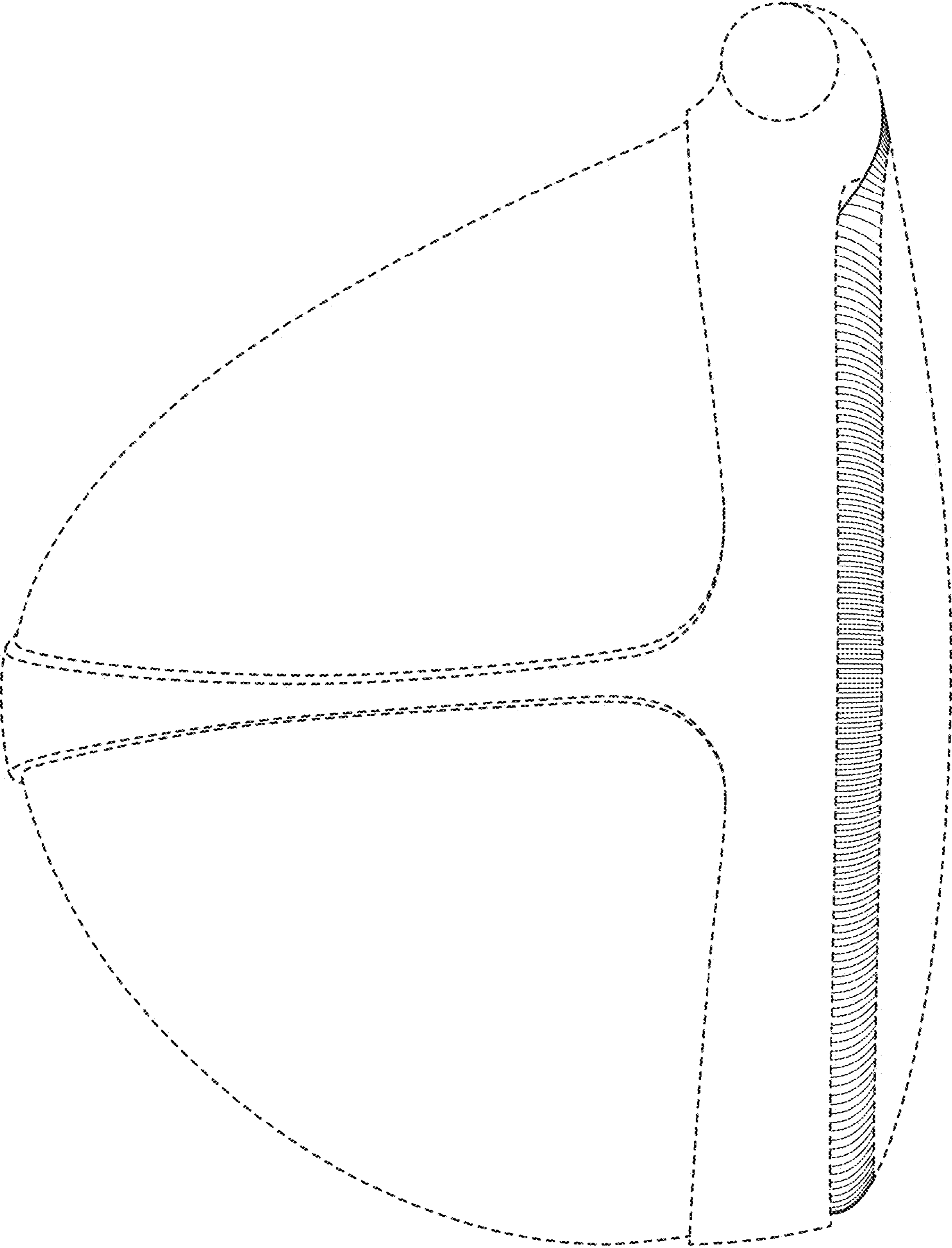

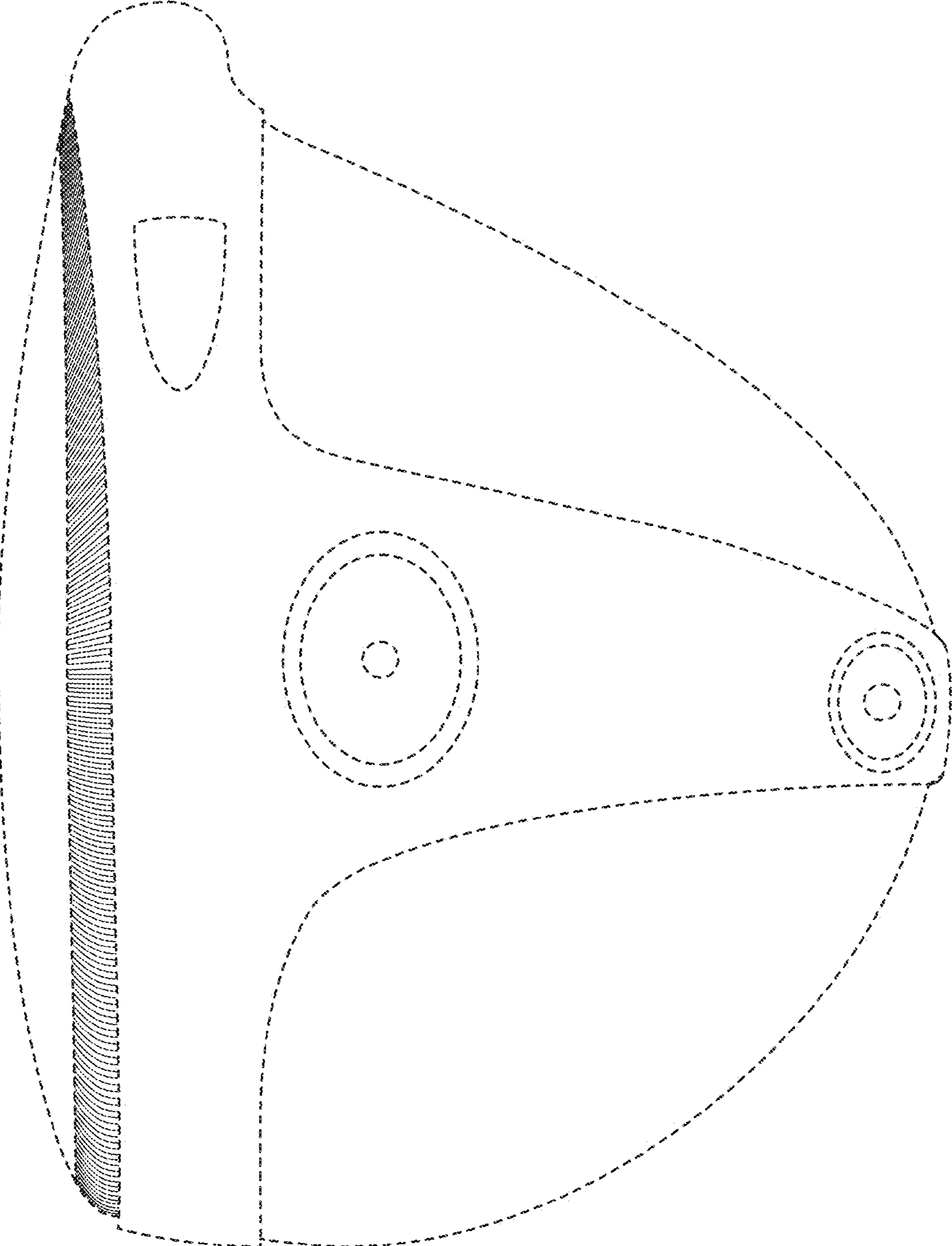
