The ornamental design for air purifier, as shown and described.

DESCRIPTION

FIG. 1.1 is a perspective front view of an air purifier according to the present design;

FIG. 1.2 is a vertical right side view thereof;

FIG. 1.3 is a bottom view thereof;

FIG. 1.4 is a vertical left side view thereof;

FIG. 1.5 is a top view thereof; and

FIG. 1.6 is a horizontal side view thereof.

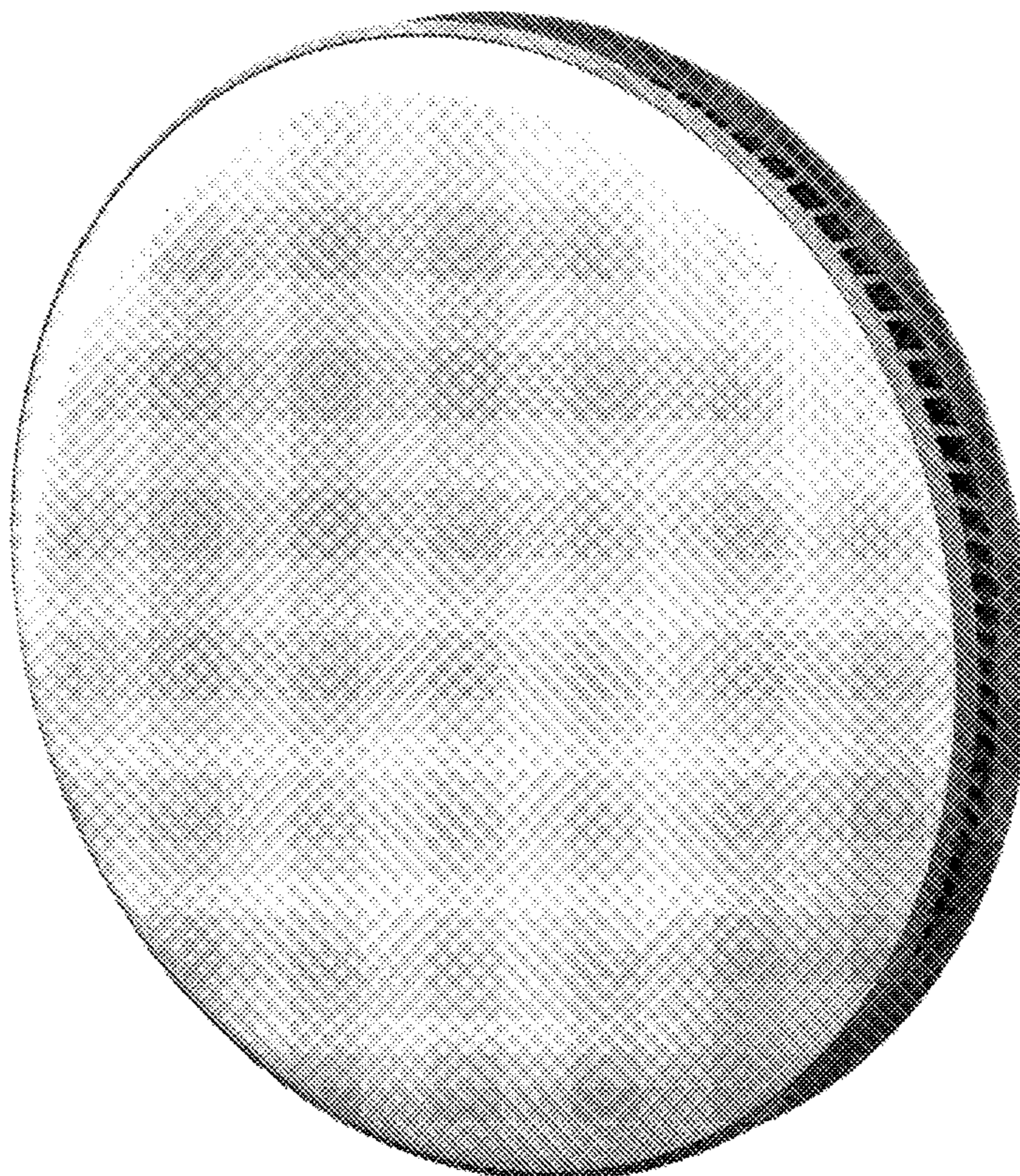

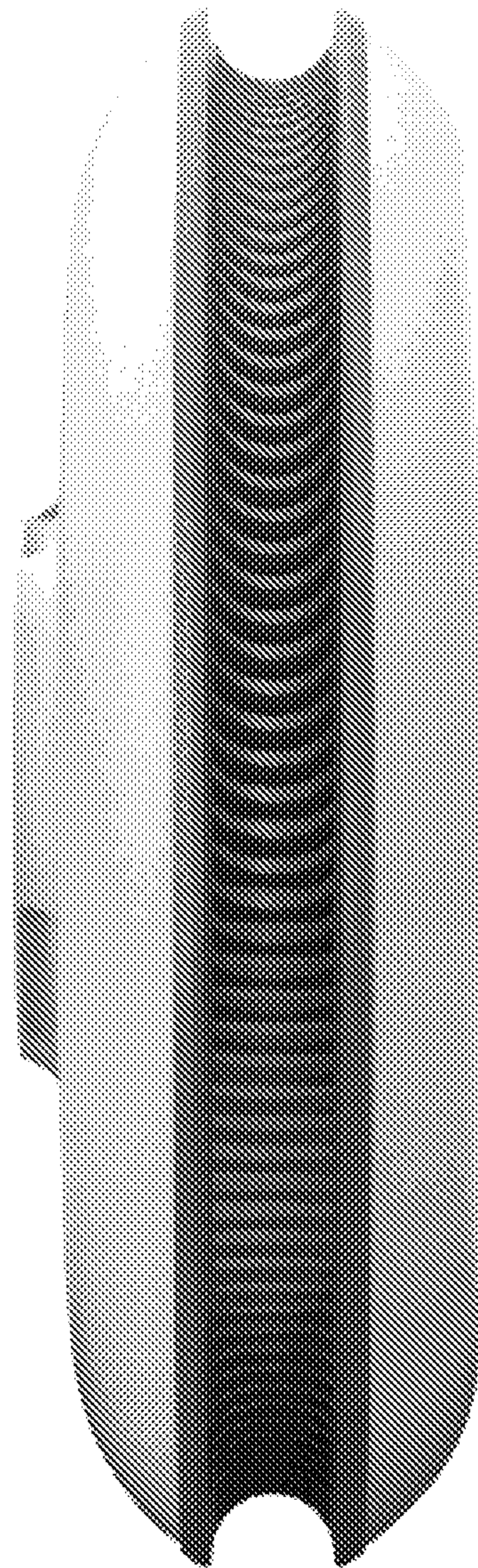

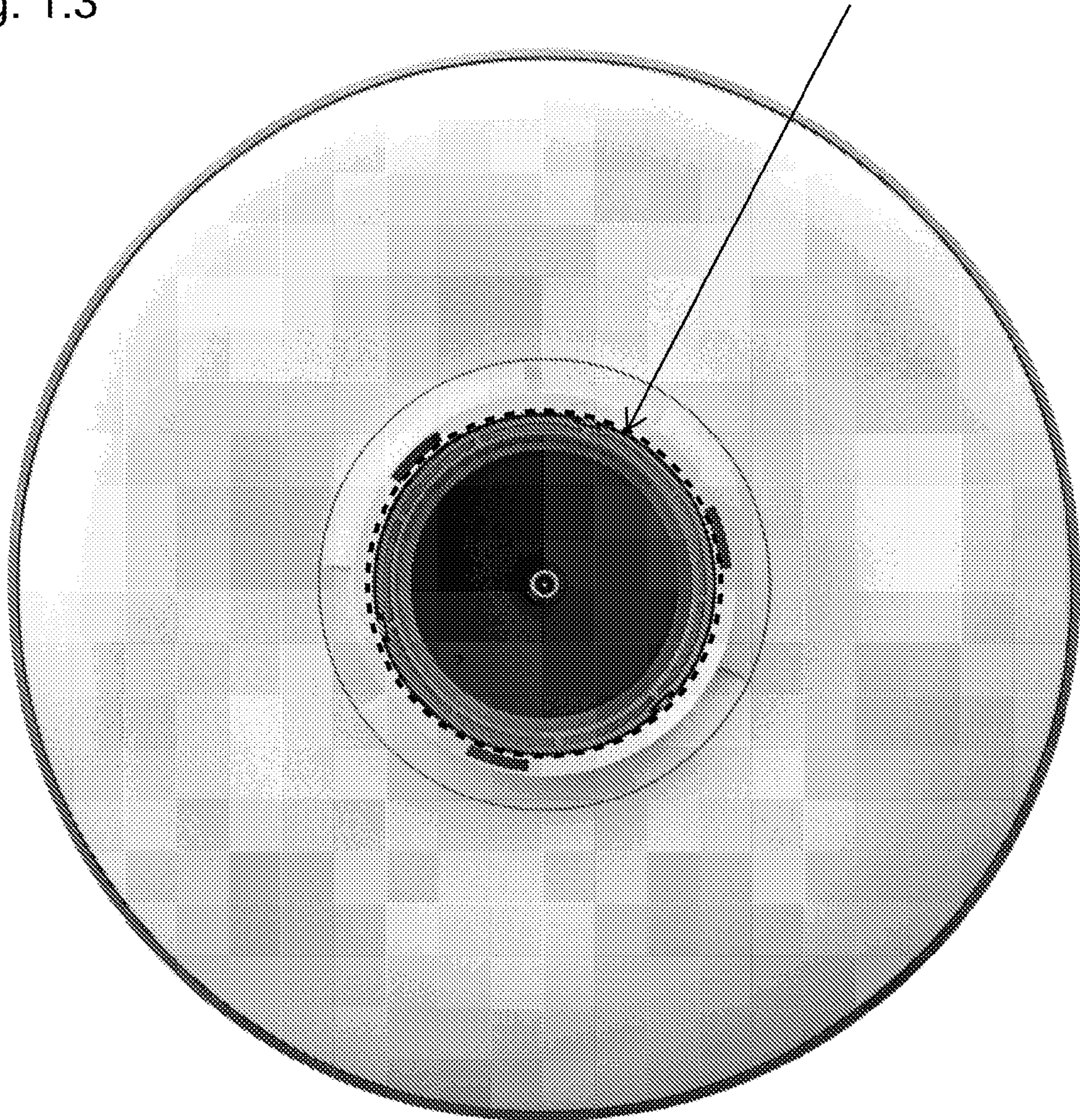

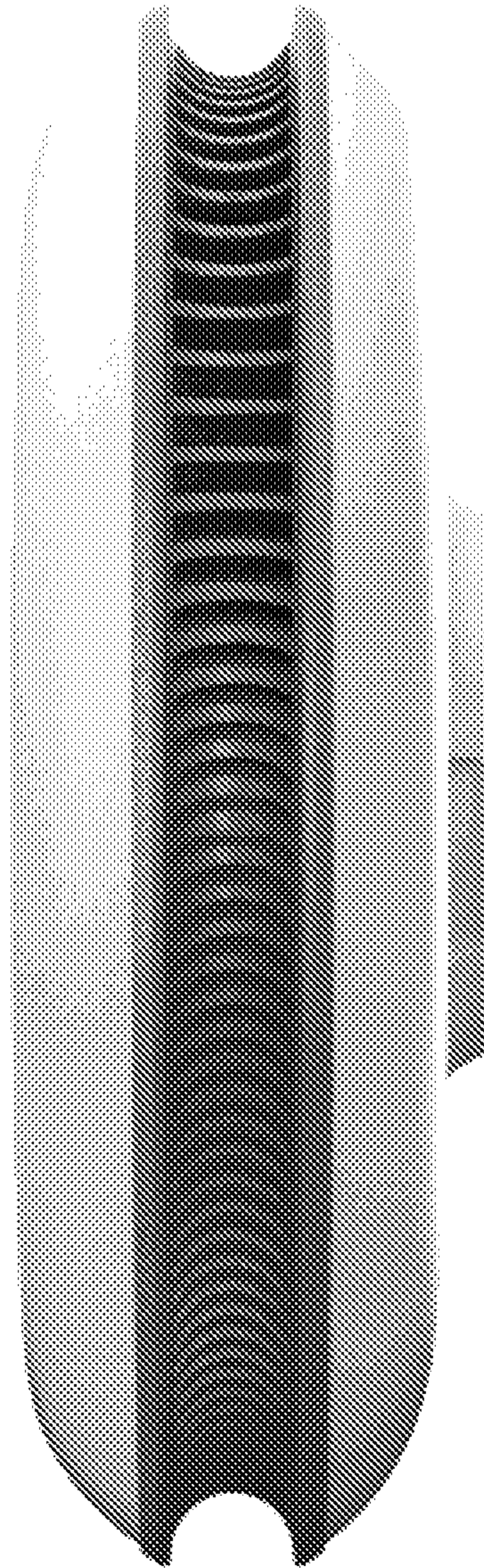

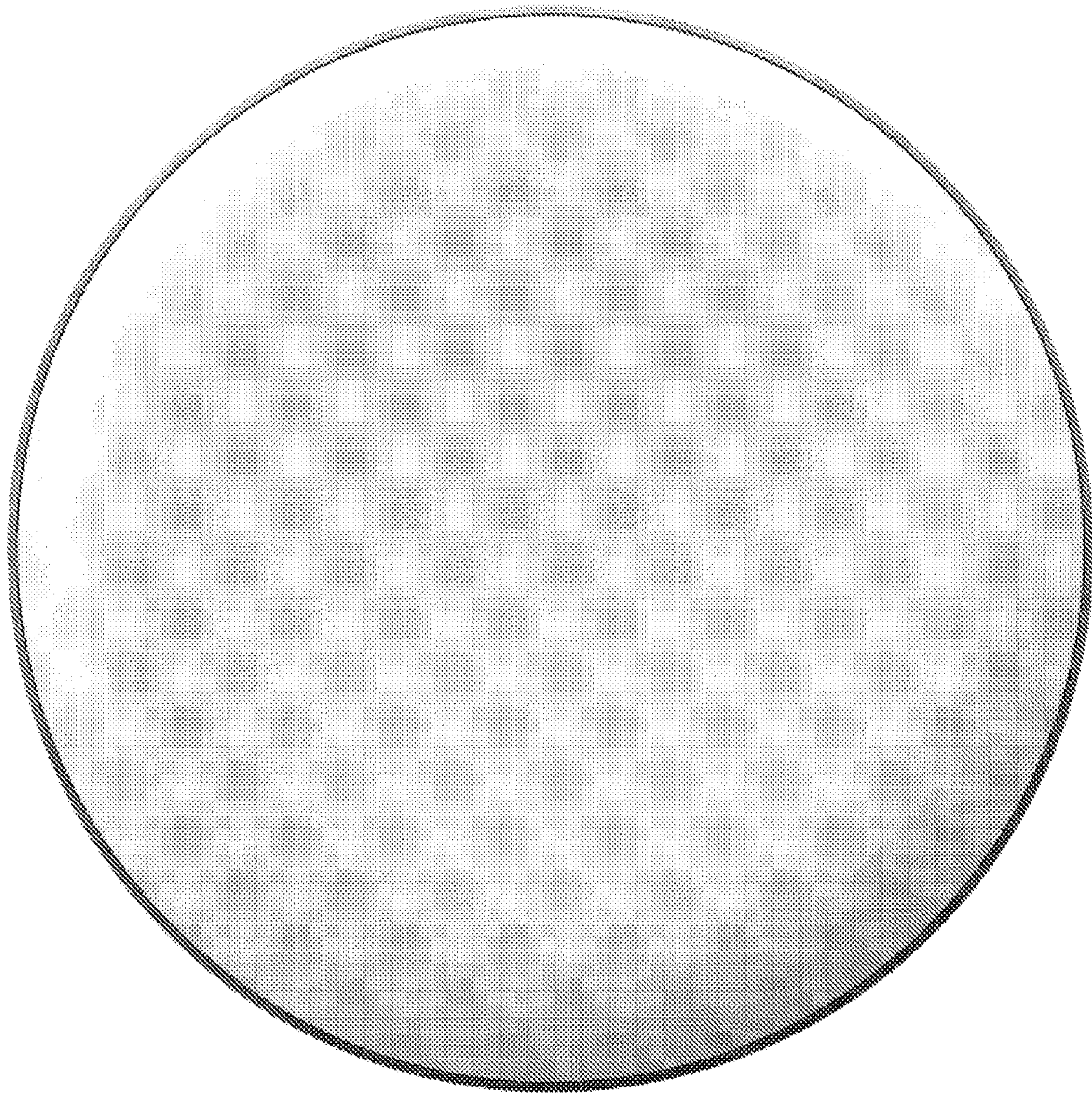
