(57) **CLAIM**

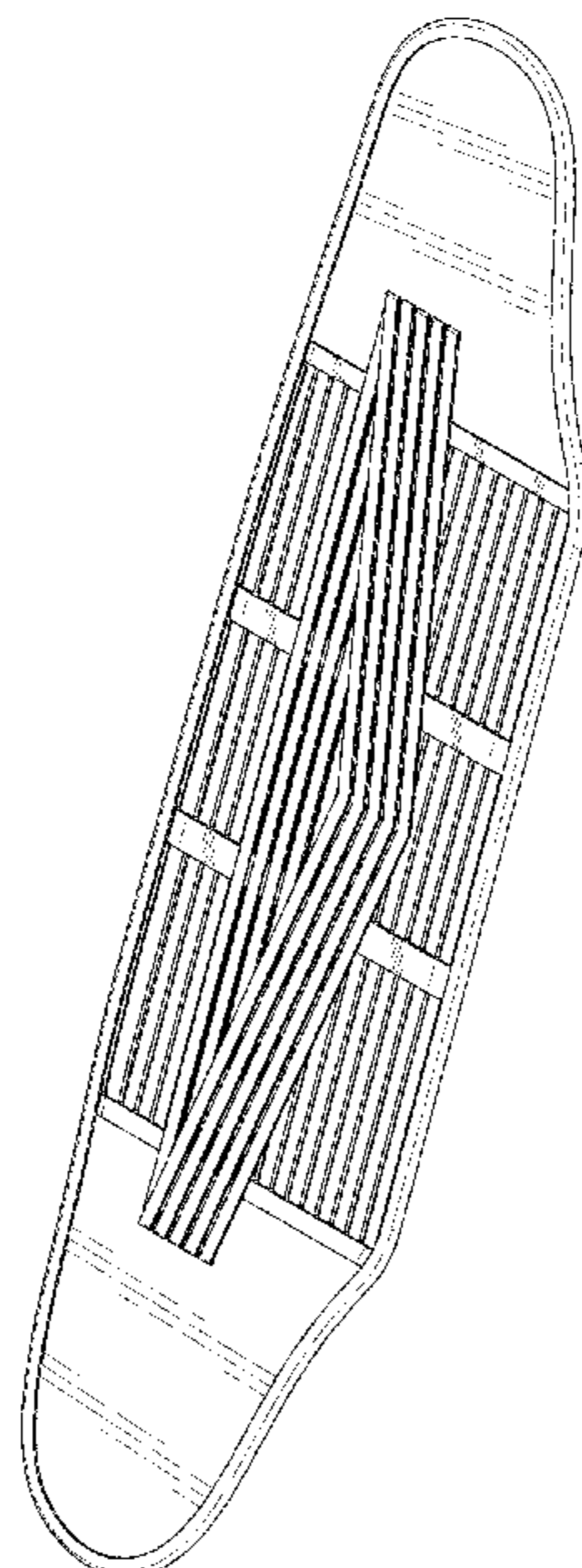
The ornamental design for a postpartum belly wrap, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a postpartum belly wrap showing my new design;

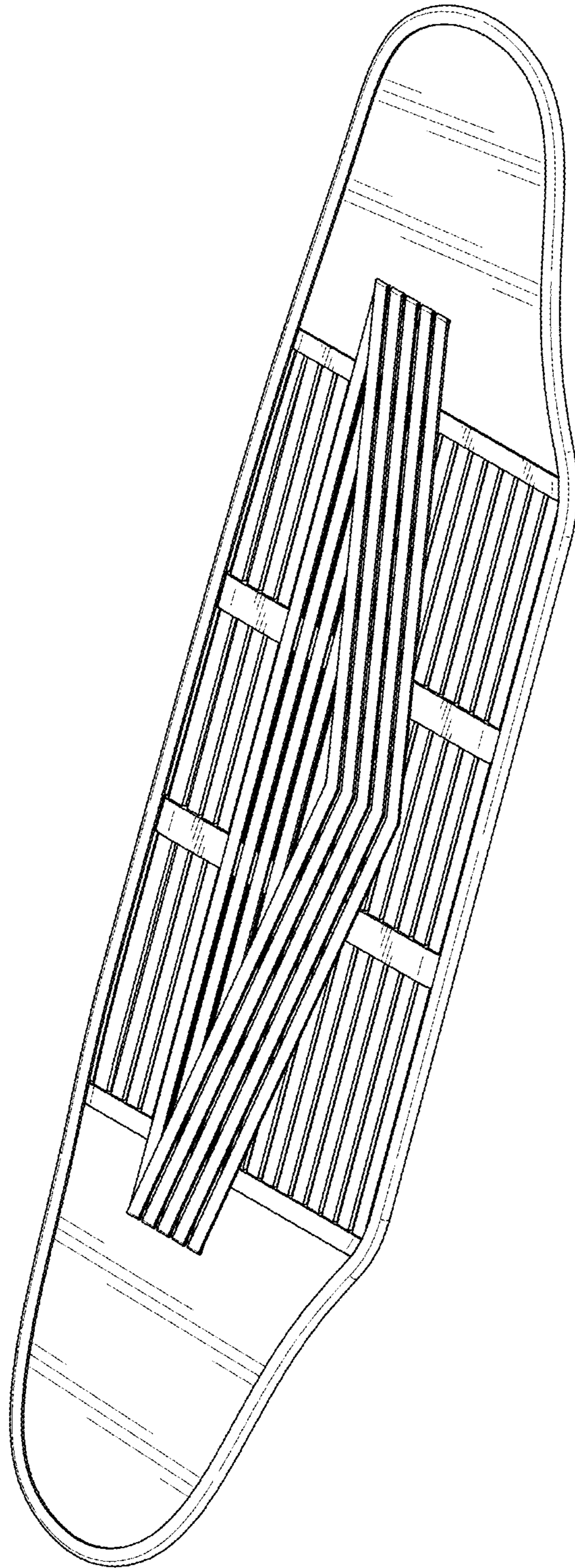

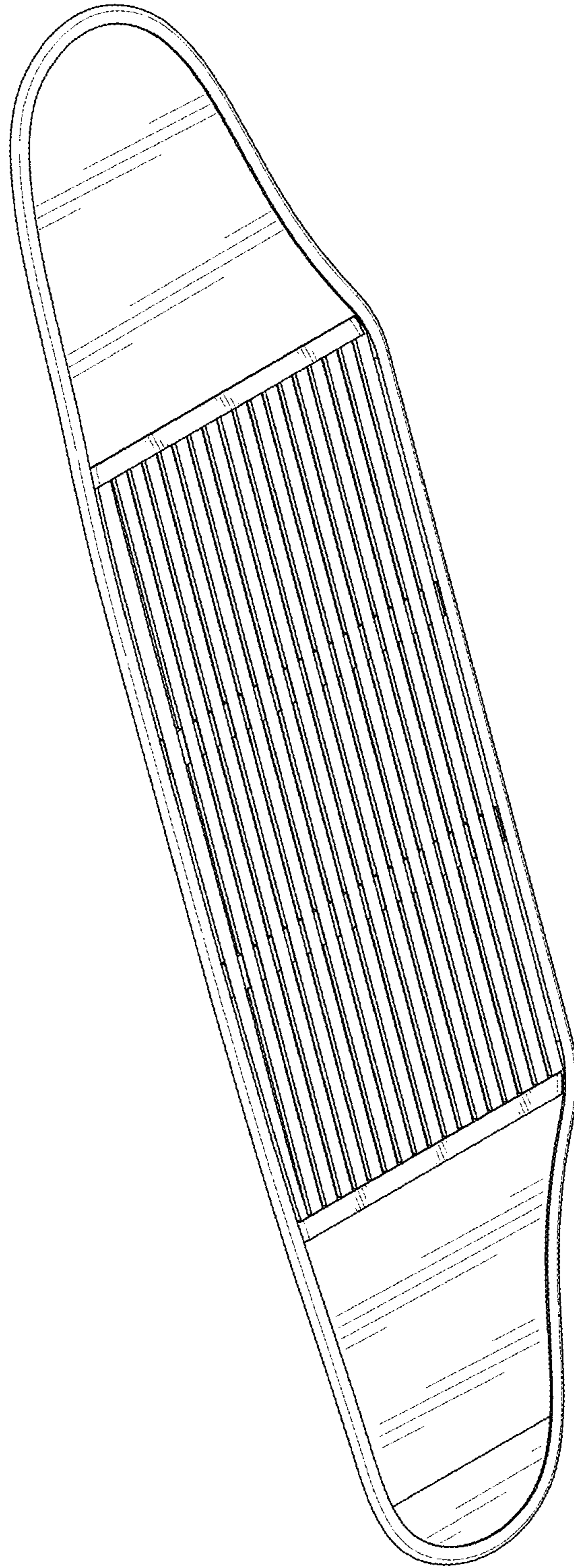

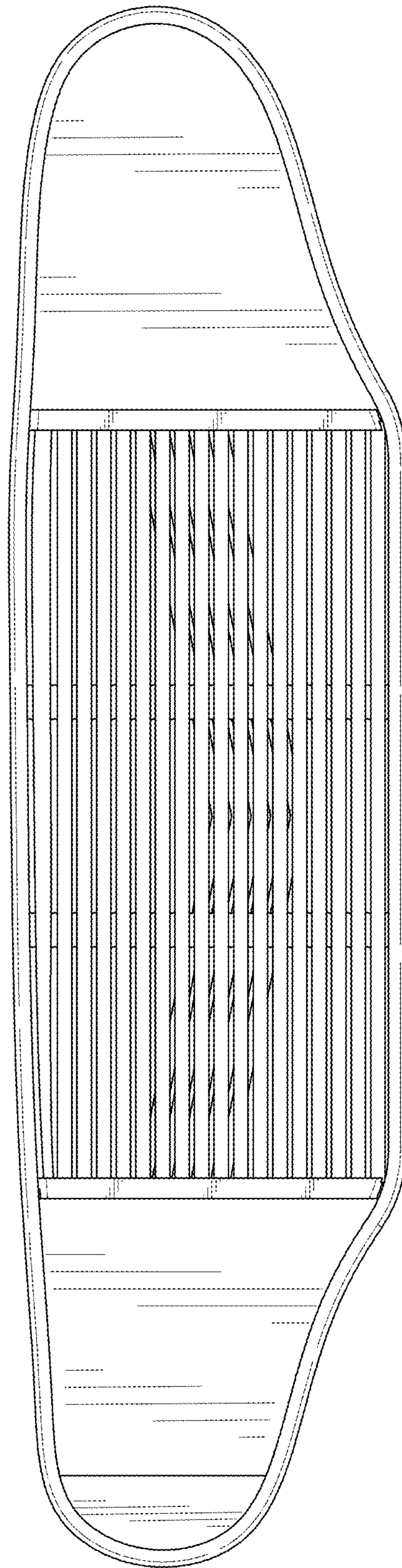

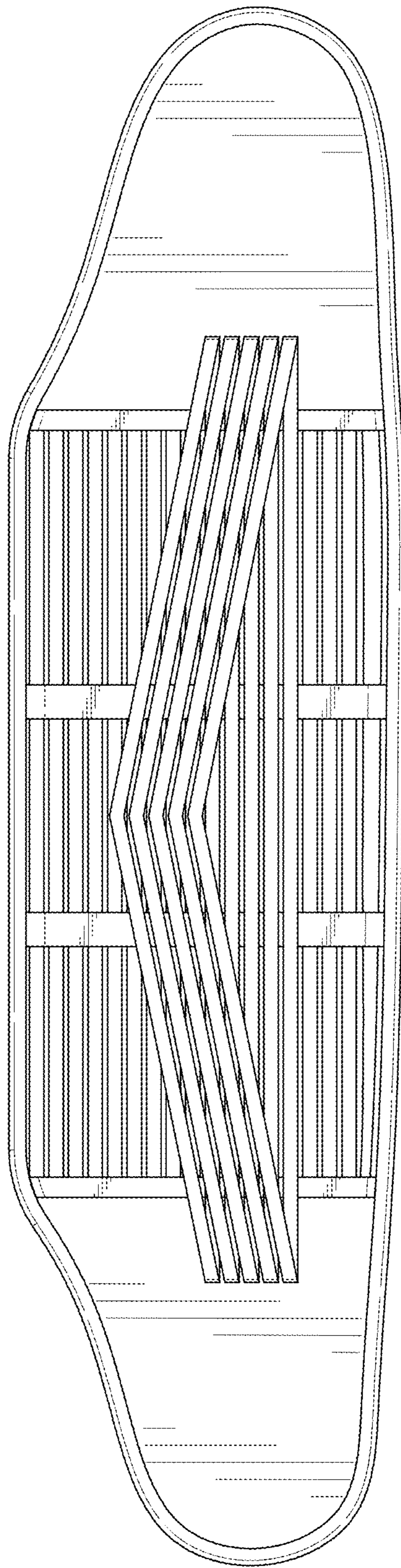

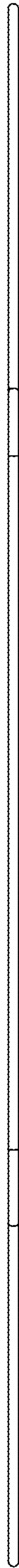

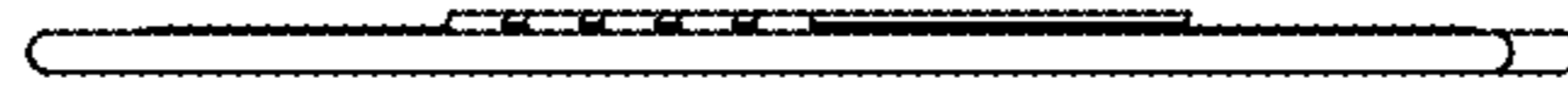

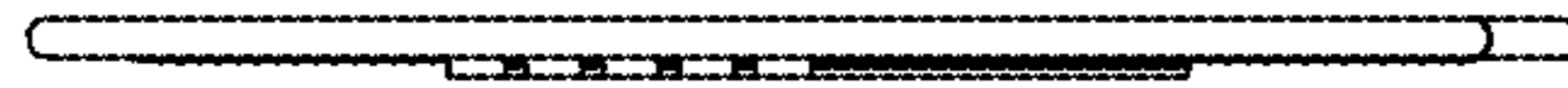

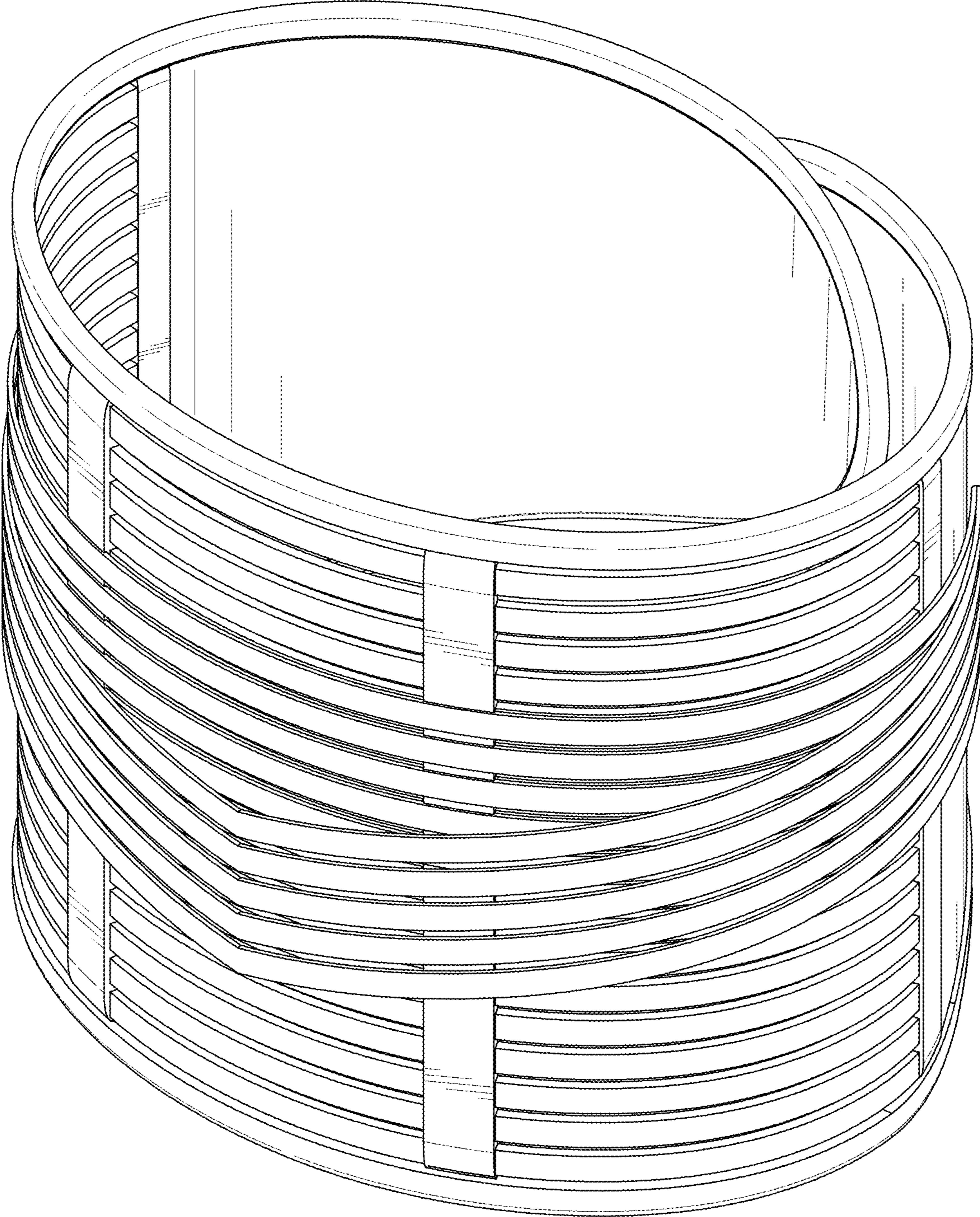
