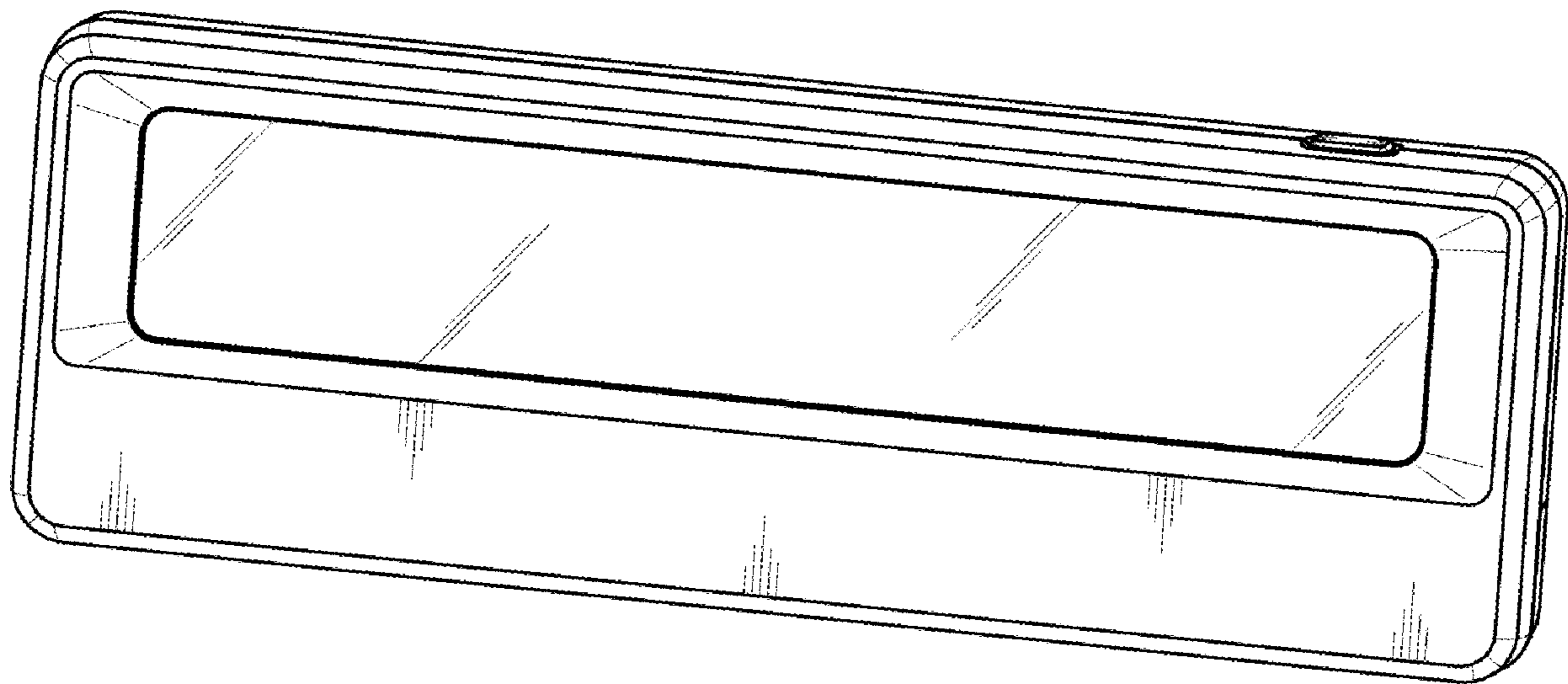
The ornamental design for a lamp, as shown and described.

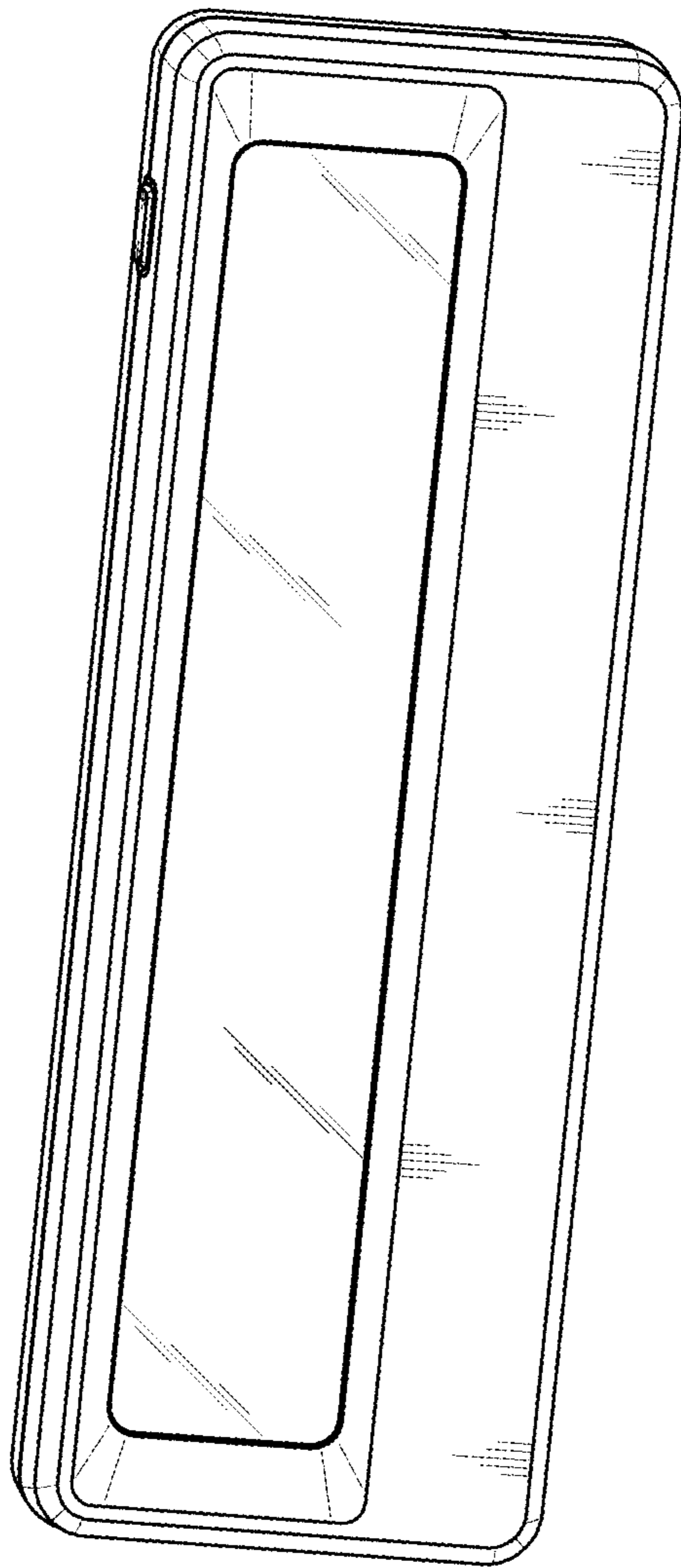

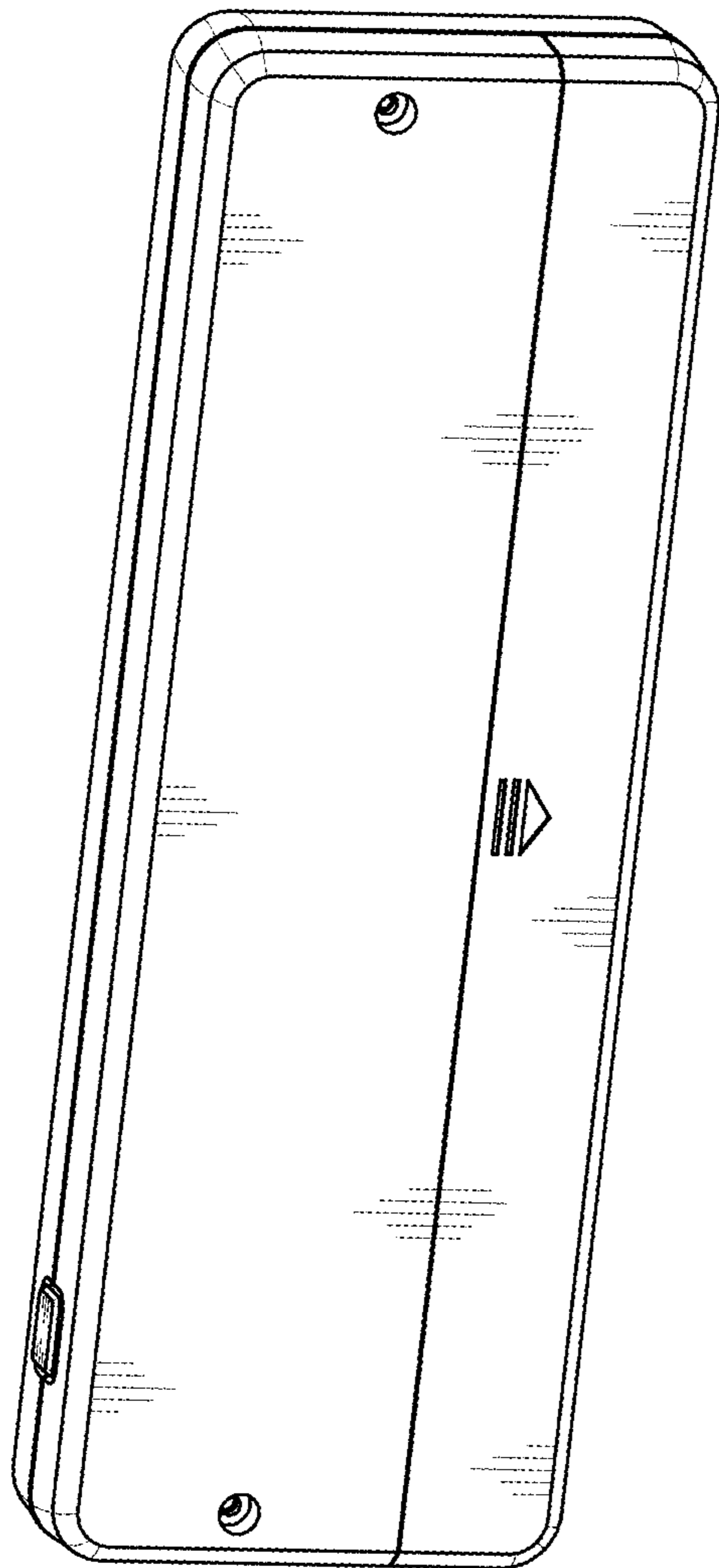

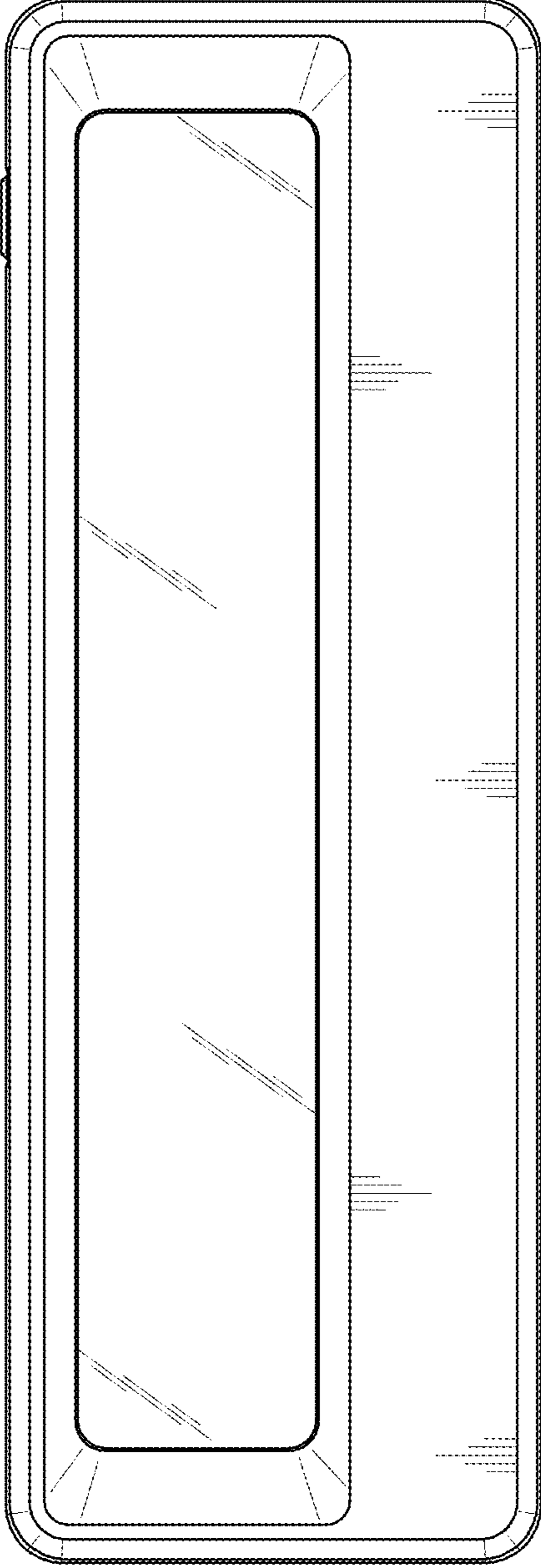

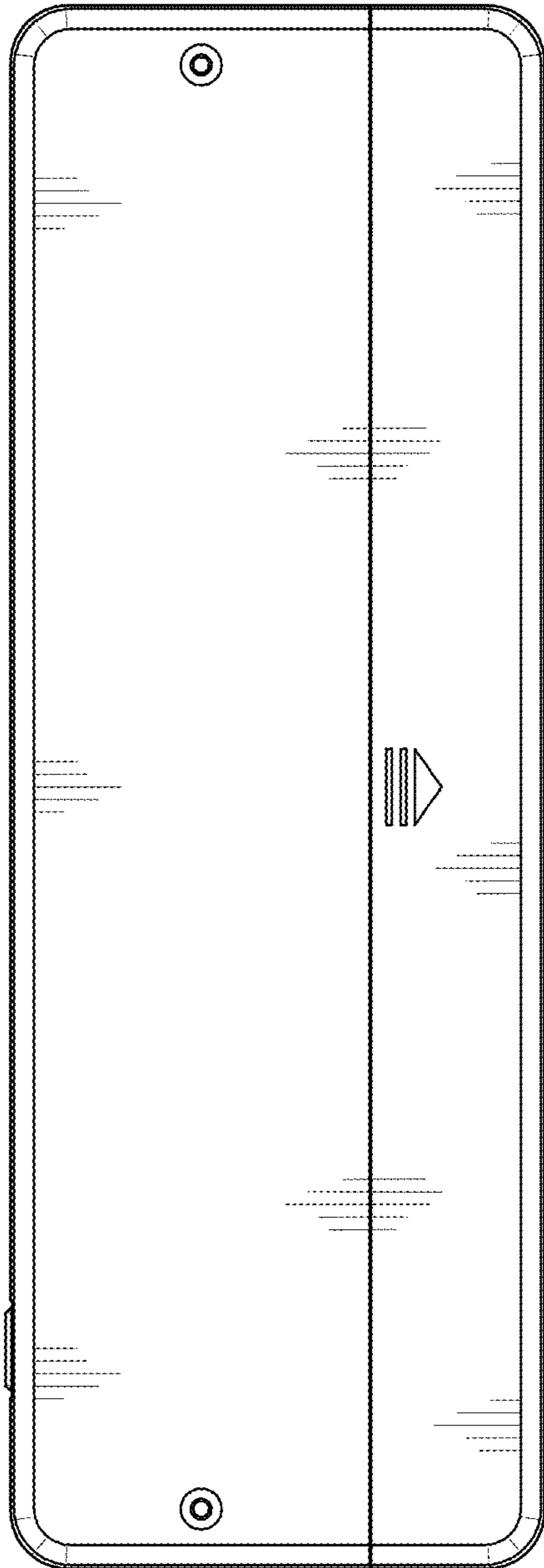

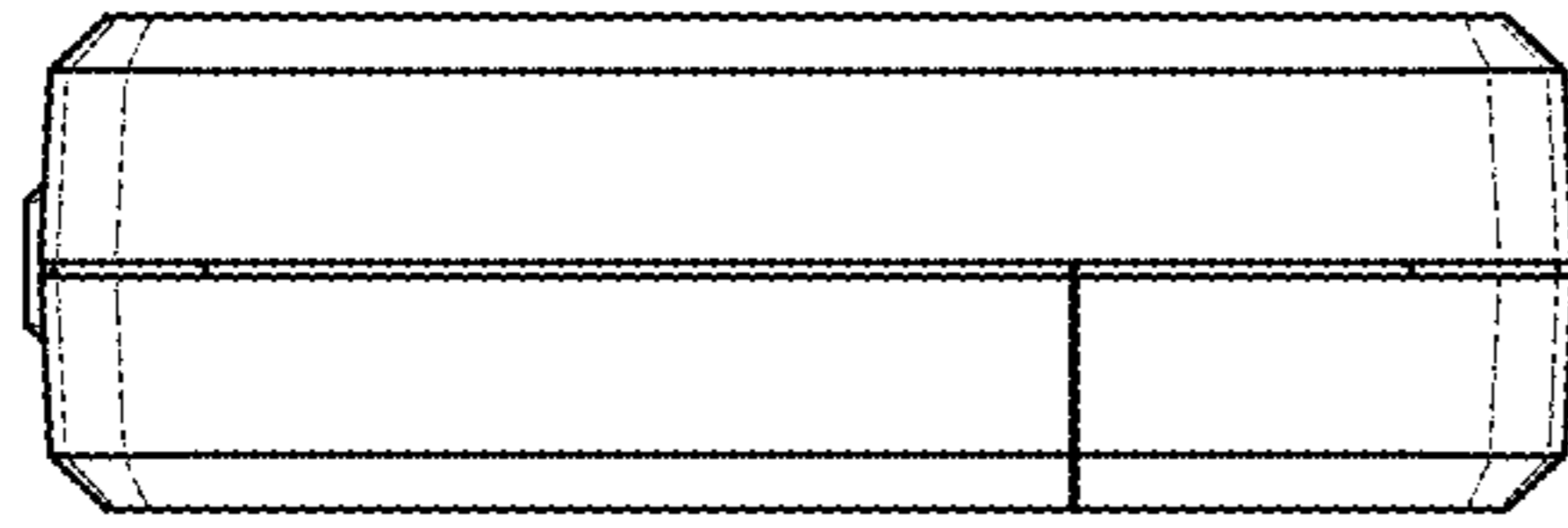

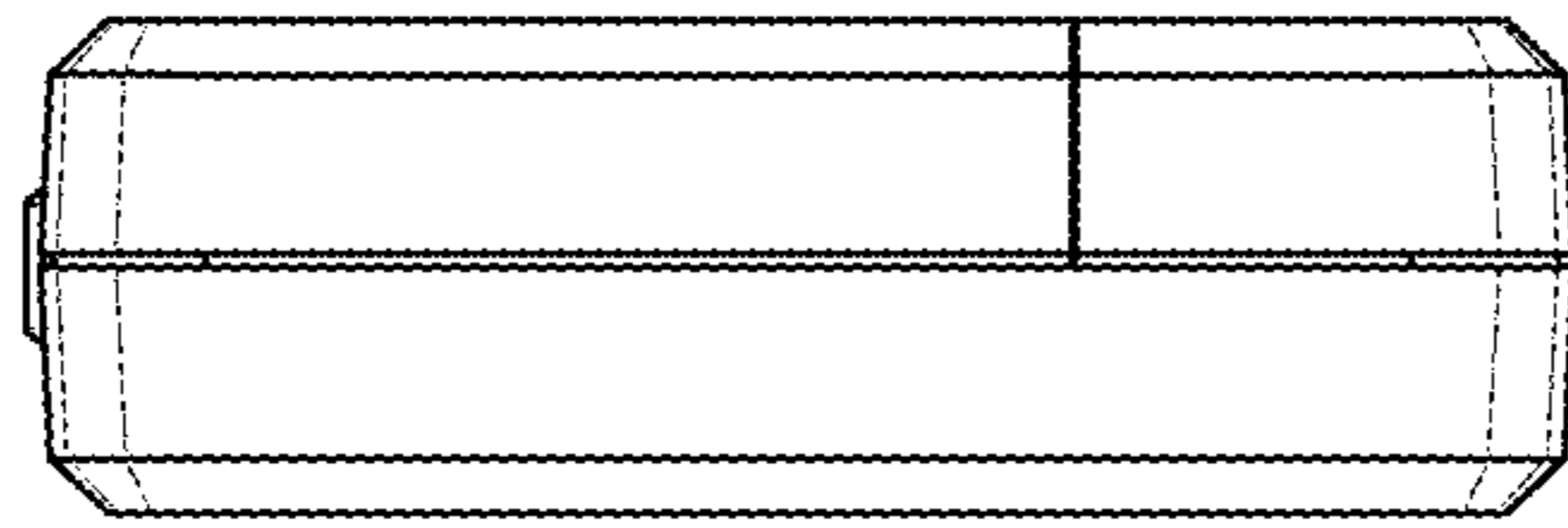

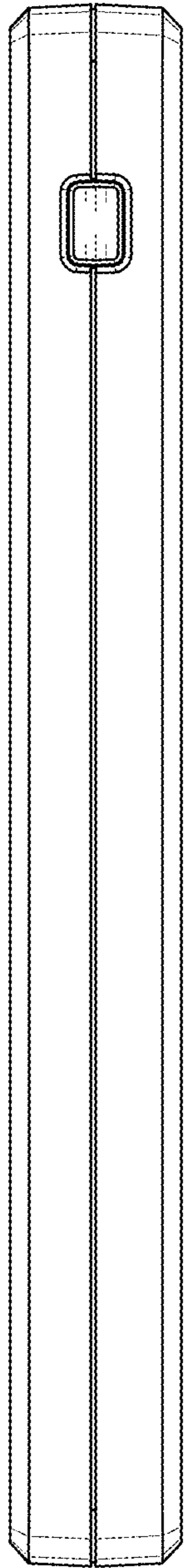

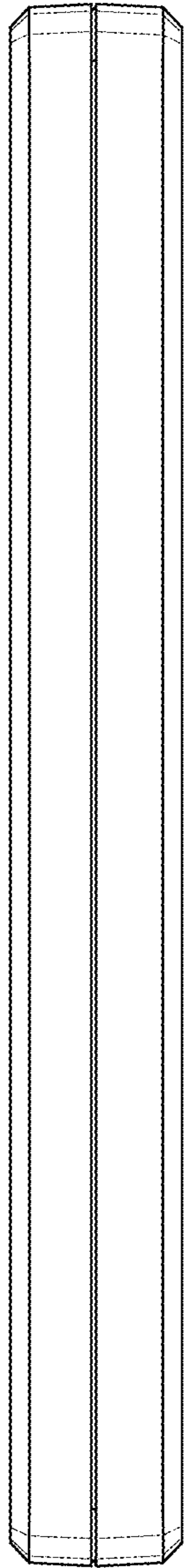
