DESCRIPTION

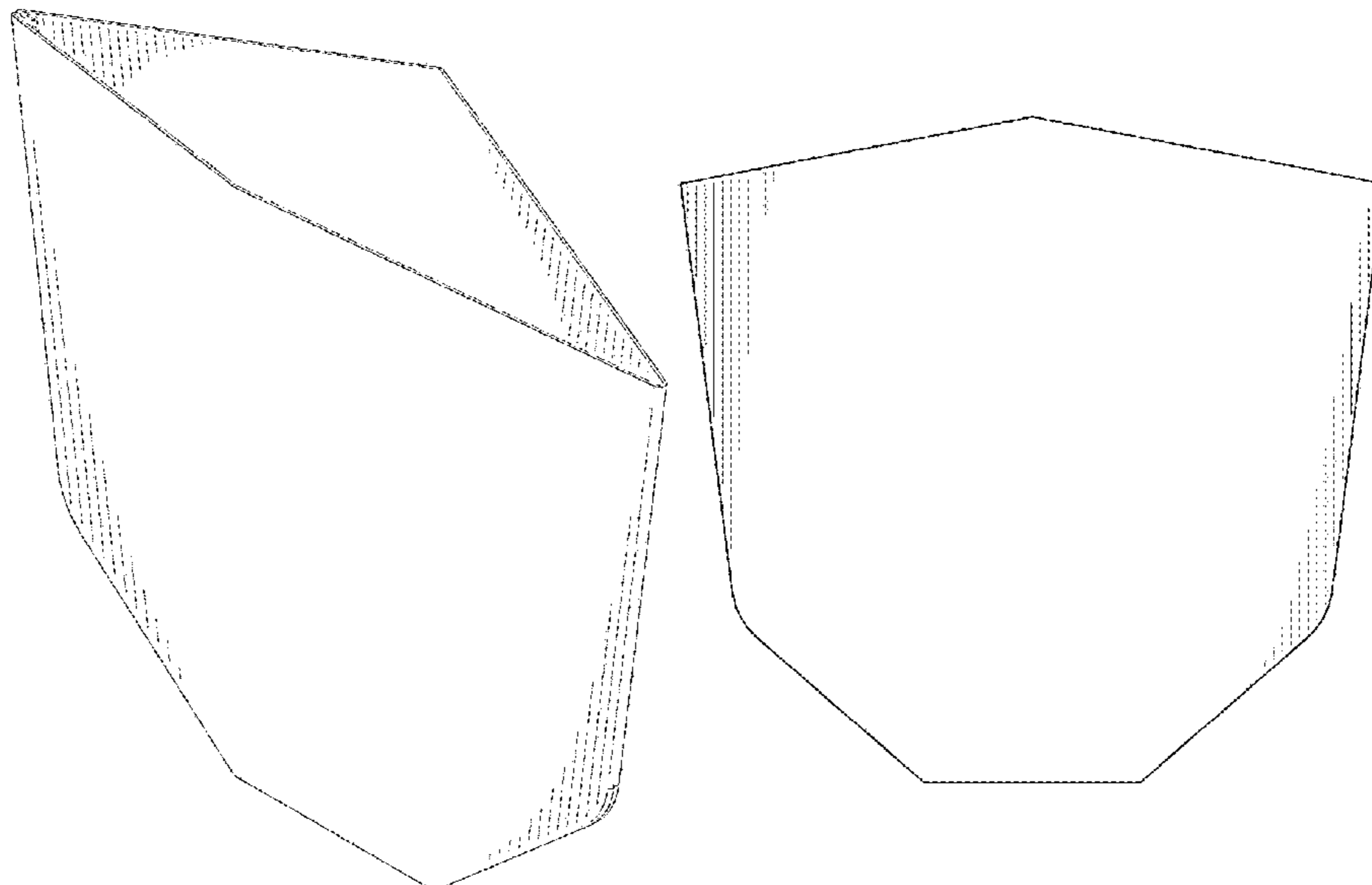
FIG. 1 is a front, right side perspective view of a paper handkerchief in an expanded state;
 FIG. 2 is a front, right side perspective view of the paper handkerchief in a compressed state;
 FIG. 3 is a front, left side perspective view of the paper handkerchief as in FIG. 2;
 FIG. 4 is a front elevational view of the paper handkerchief as in FIG. 2, the rear elevational view being a mirror image thereof;
 FIG. 5 is a top plan view of the paper handkerchief as in FIG. 2;
 FIG. 6 is a bottom plan view of the paper handkerchief as in FIG. 2;
 FIG. 7 is a left side elevational view of the paper handkerchief as in FIG. 2; and,
 FIG. 8 is a right side elevational view of the paper handkerchief as in FIG. 2.

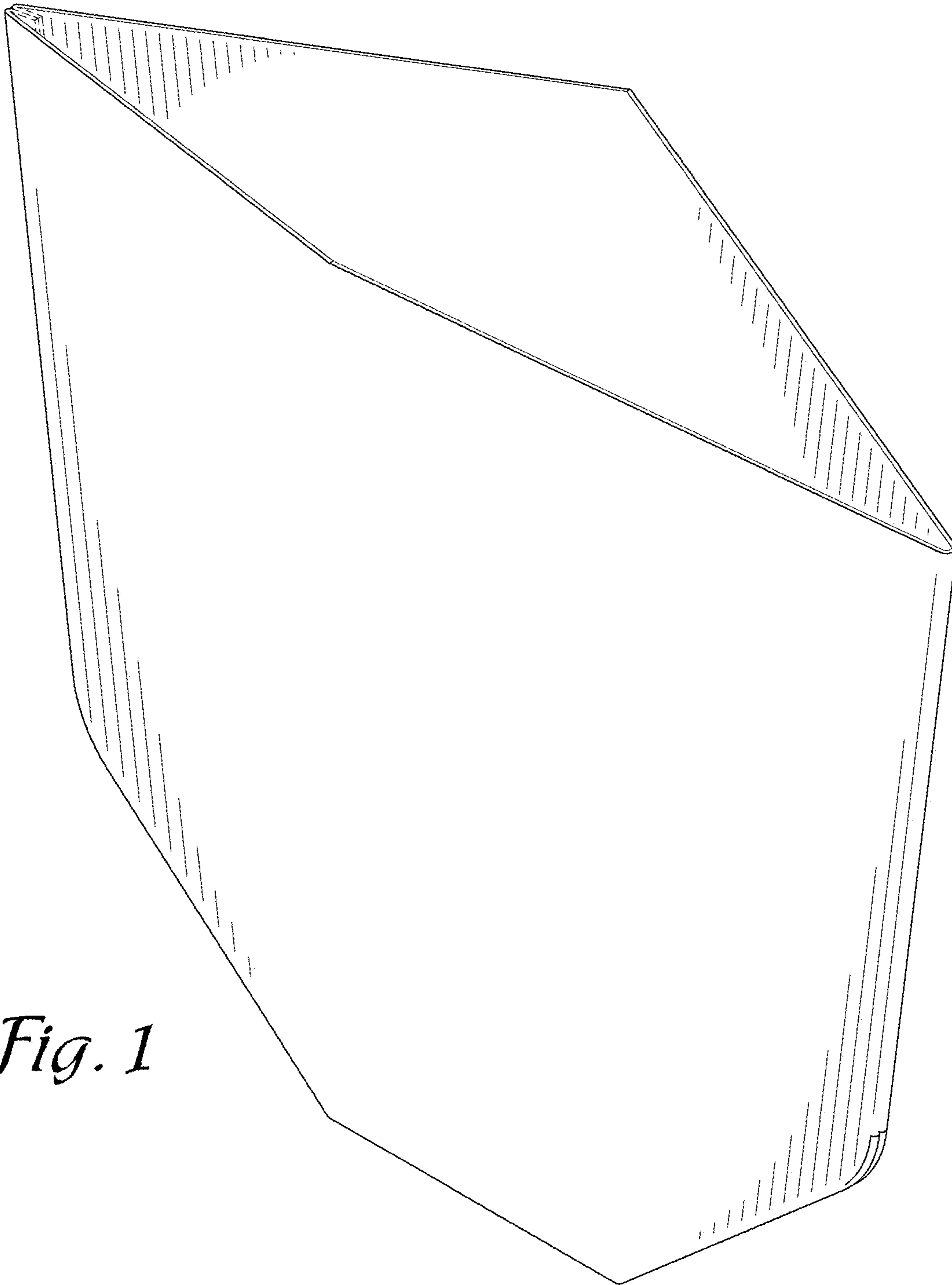

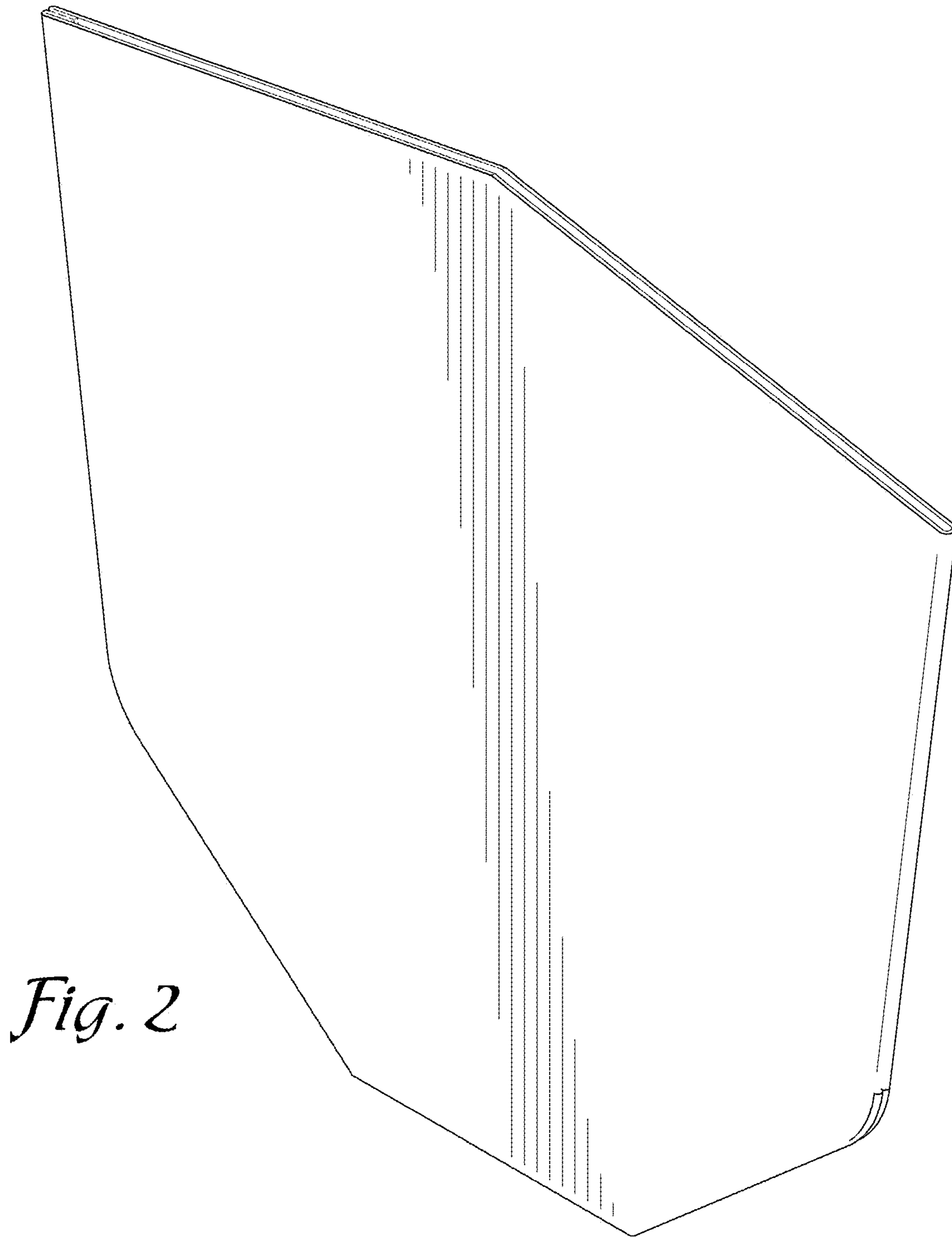

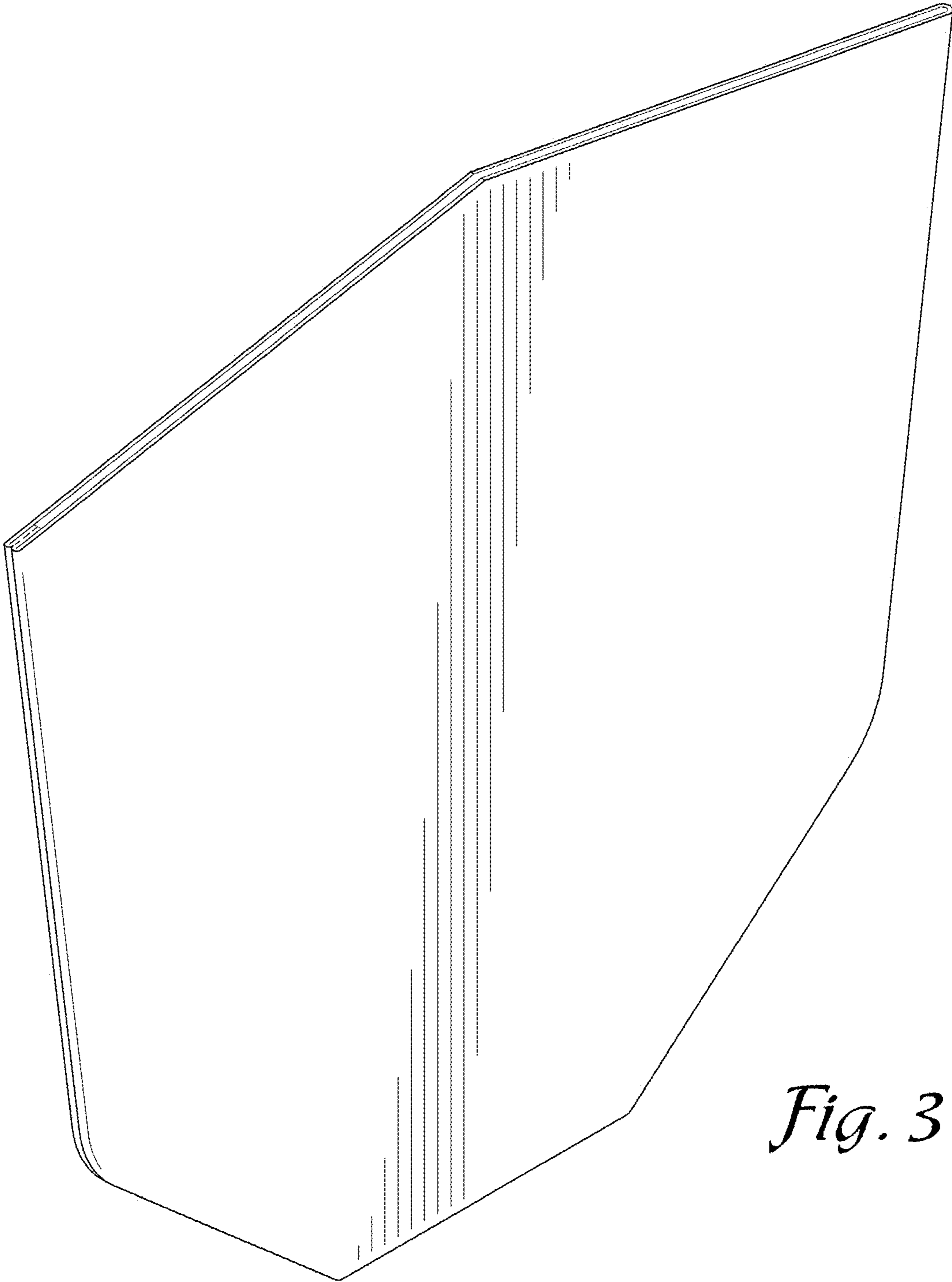
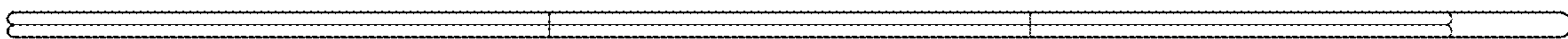
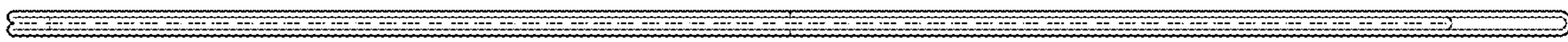
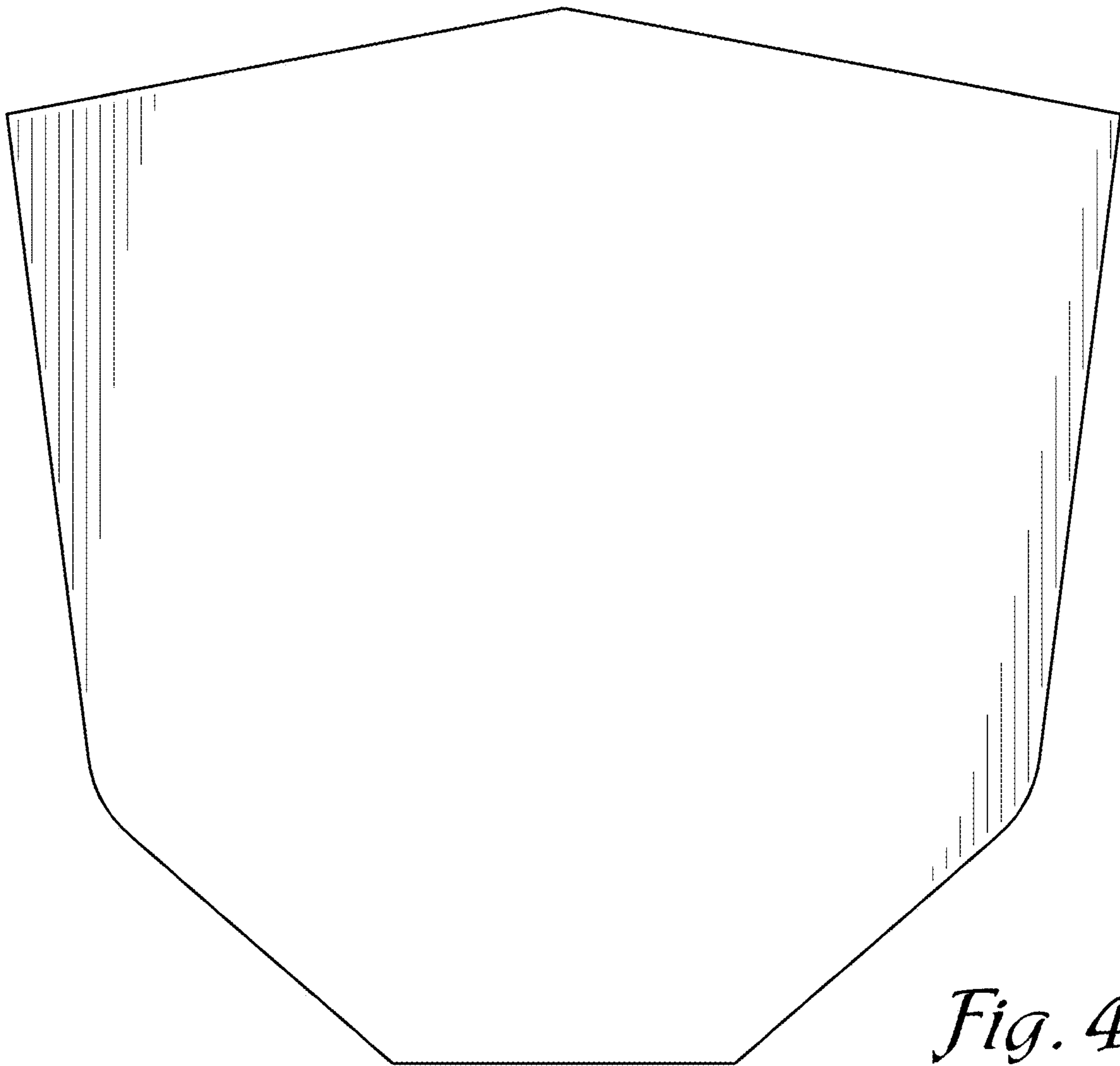

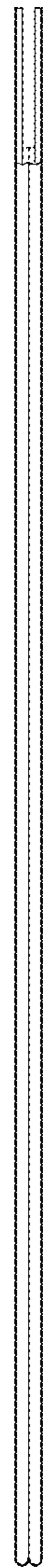

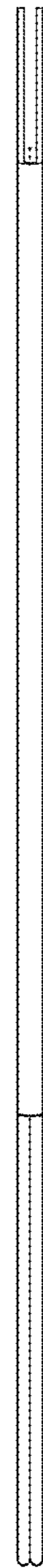
