**DESCRIPTION**

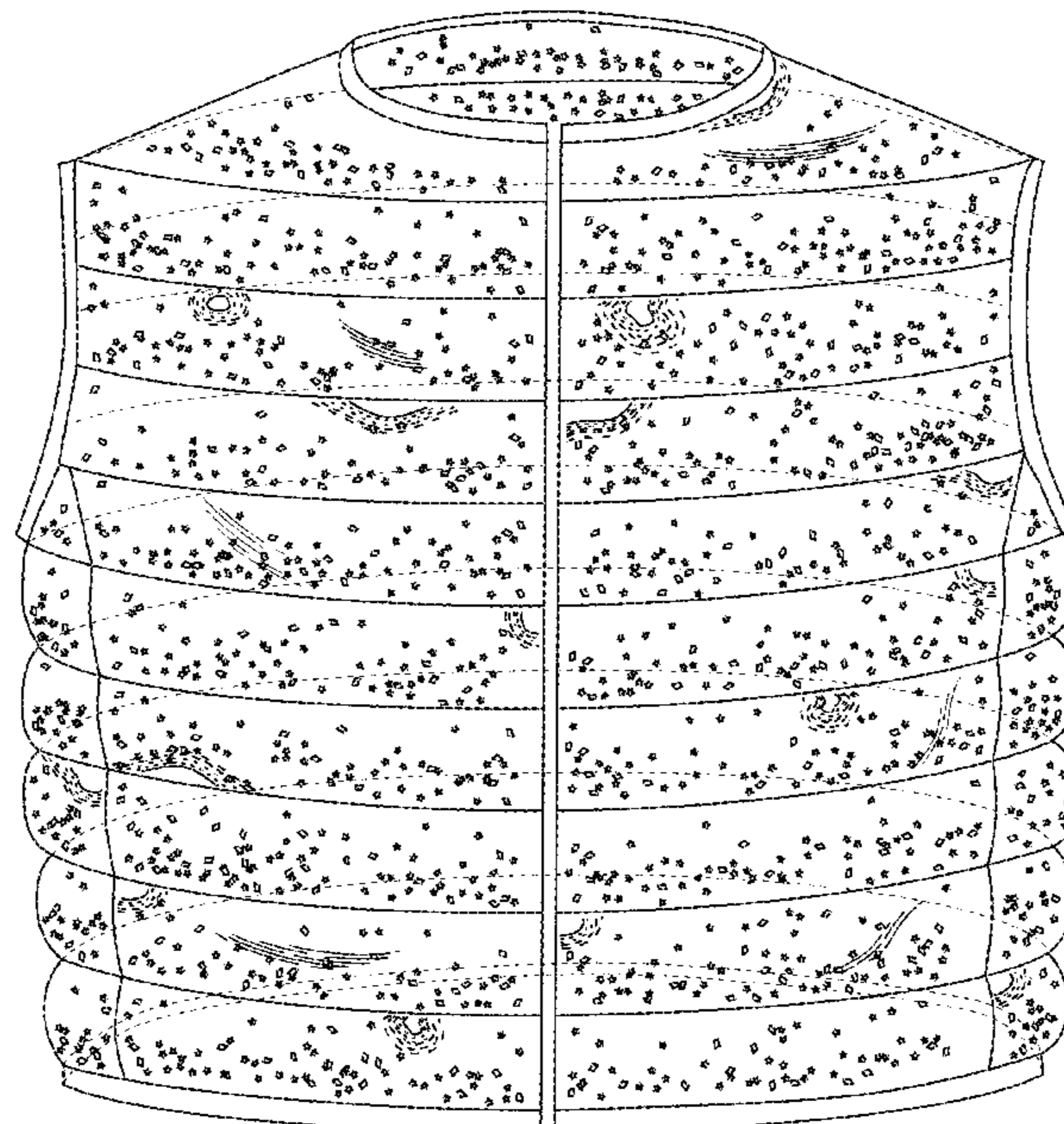

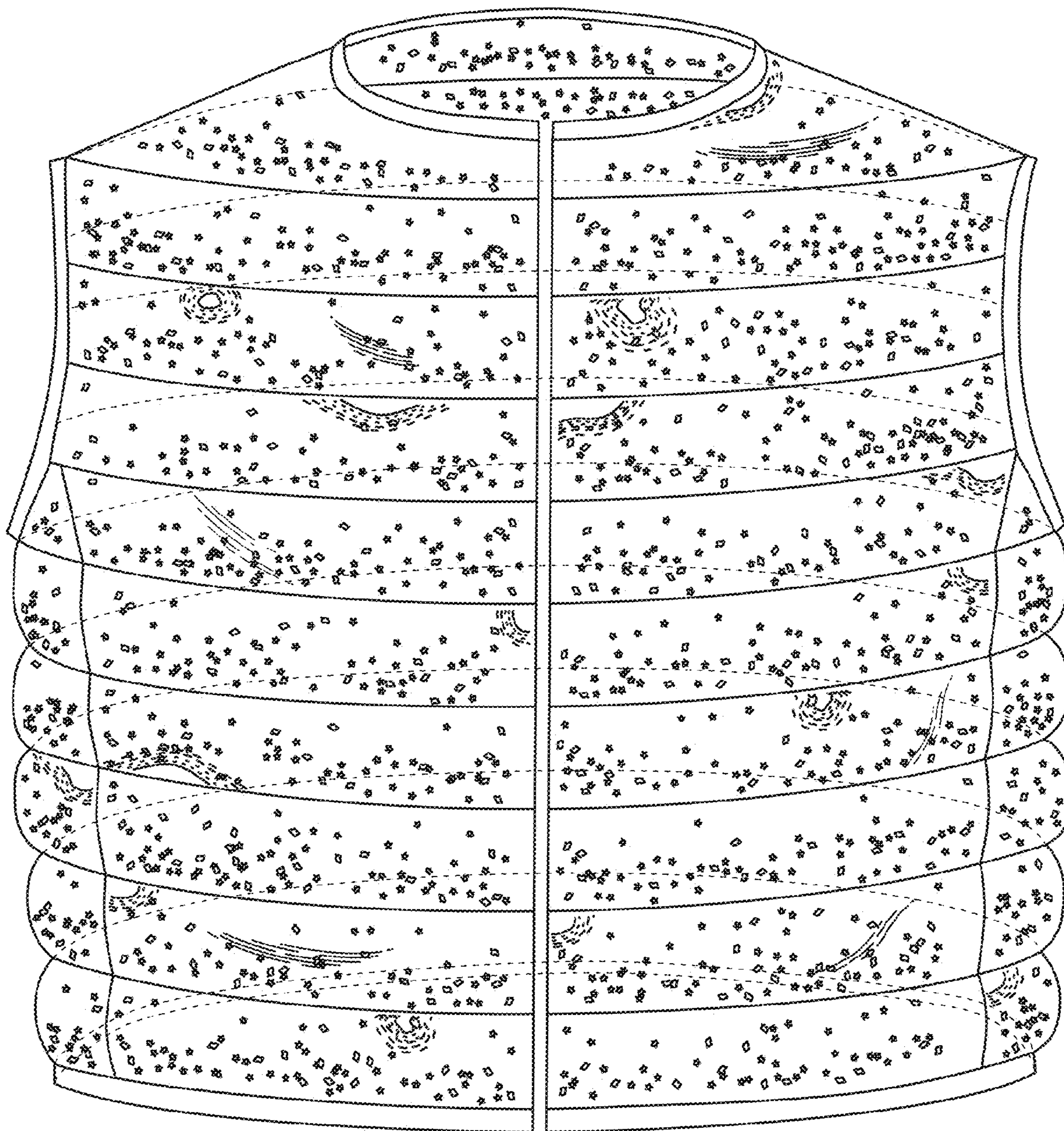

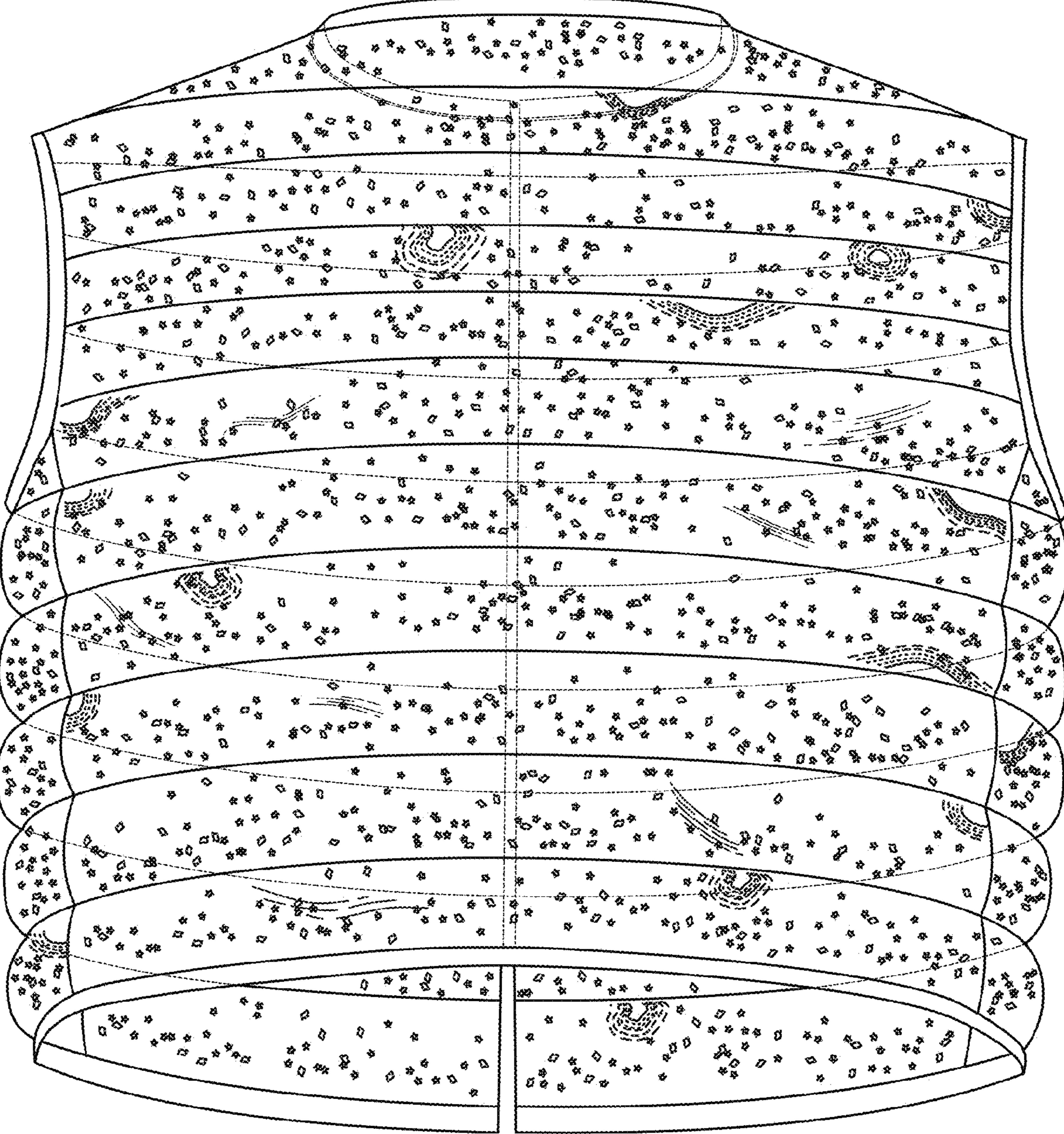

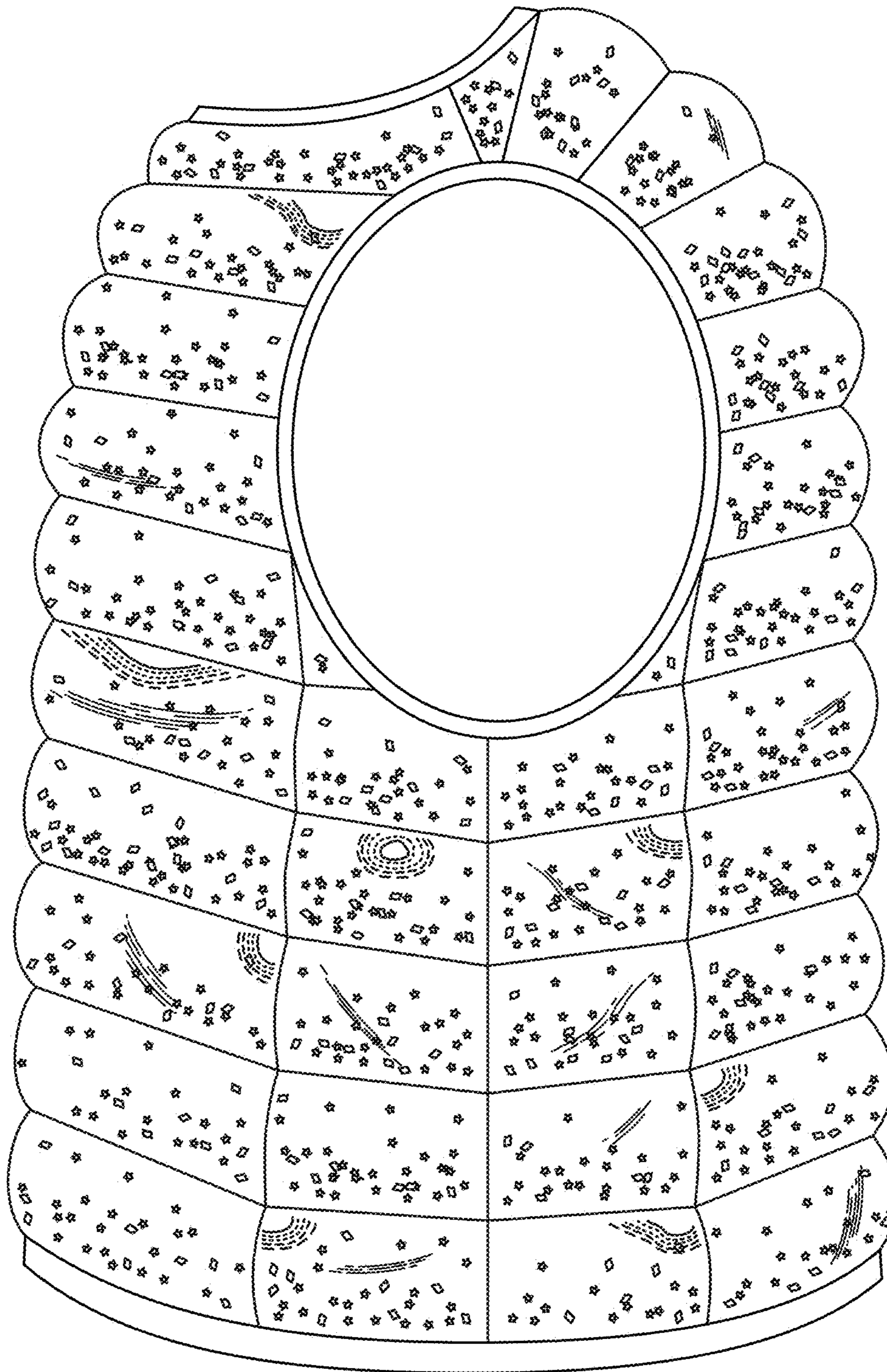

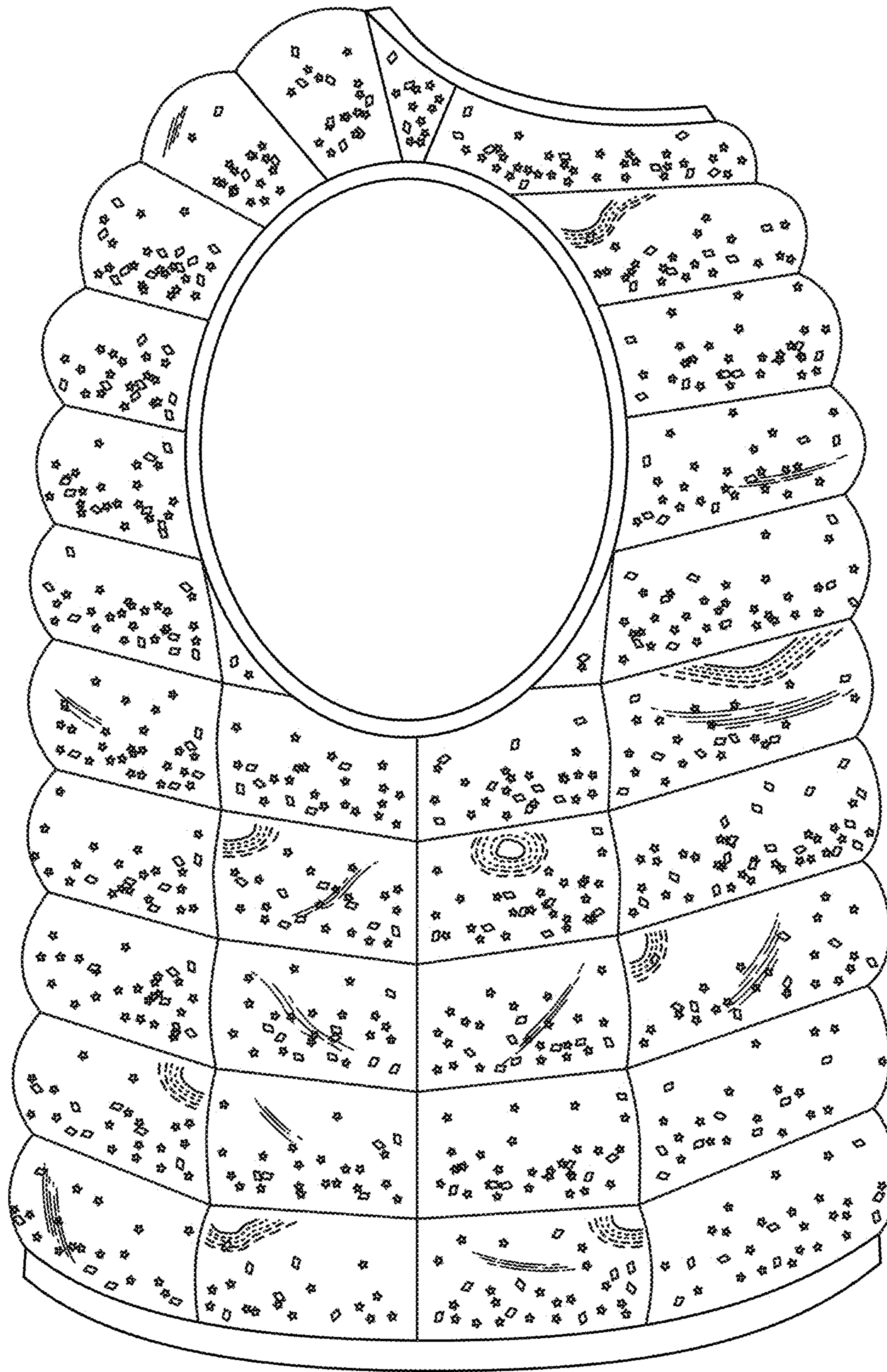
