(57) **CLAIM**

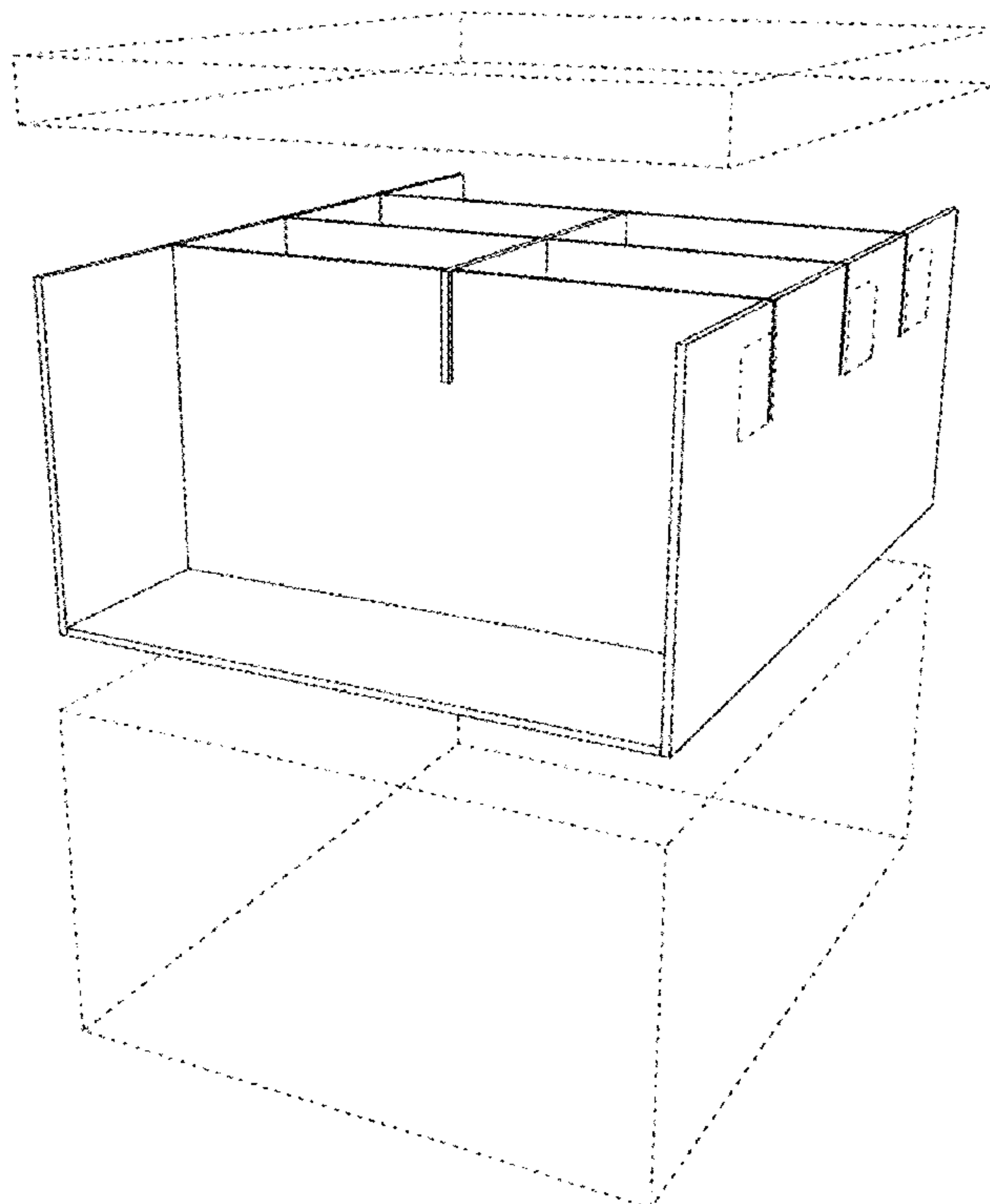
The ornamental design for a small divider system for a box is claimed, as shown and described.

DESCRIPTION

FIG. 1 is an isometric exploded view of a small divider system for a box;
FIG. 2 is a top perspective view of the small divider system in FIG. 1 being inserted into the box;
FIG. 3 is a bottom perspective view of the small divider system in FIG. 1 being inserted into the box;
FIG. 4 is a top view thereof;
FIG. 5 is a bottom view thereof;
FIG. 6 is a front side view thereof;
FIG. 7 is a rear side view thereof;
FIG. 8 is a left side view thereof; and,
FIG. 9 is a right side view thereof.

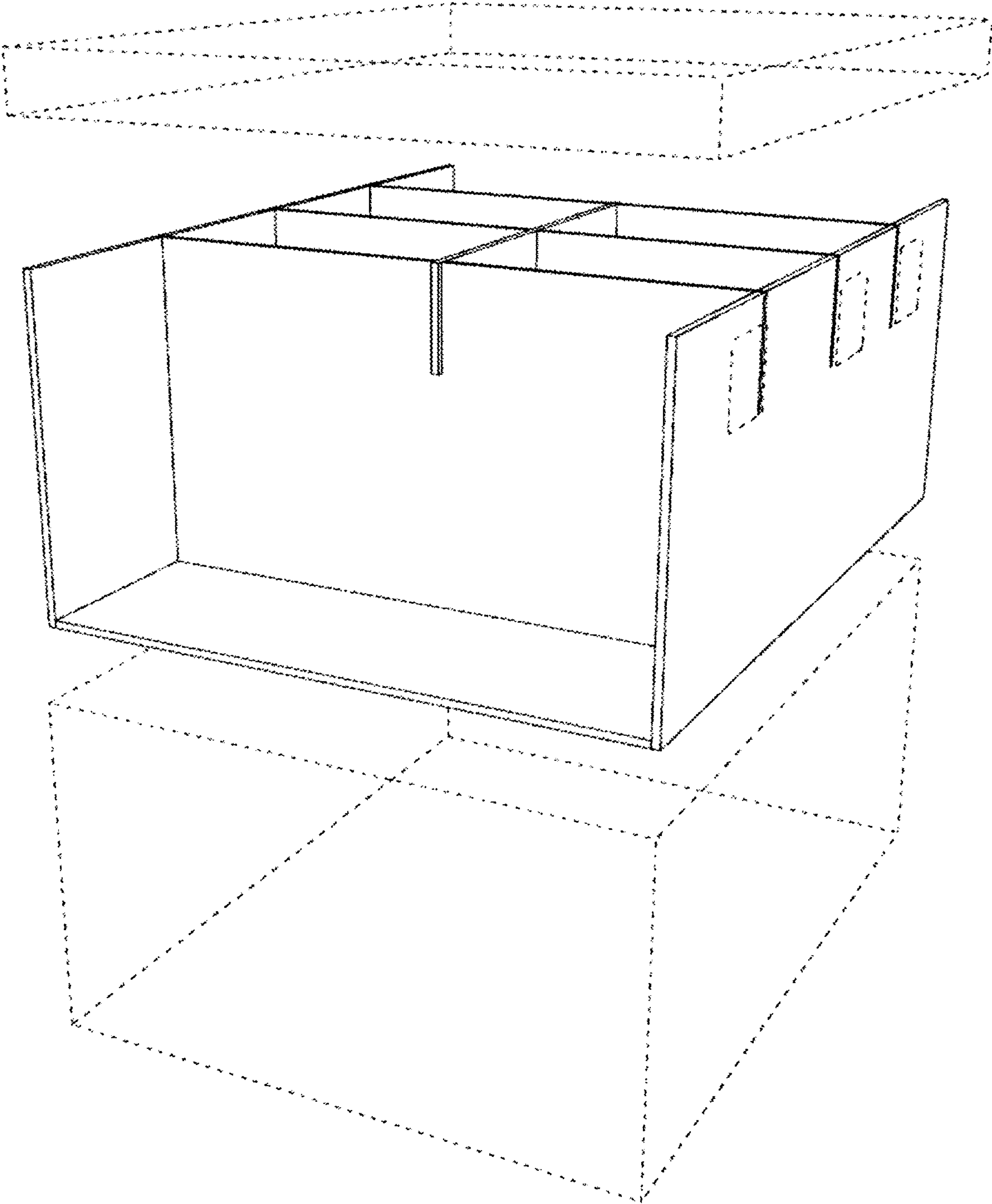

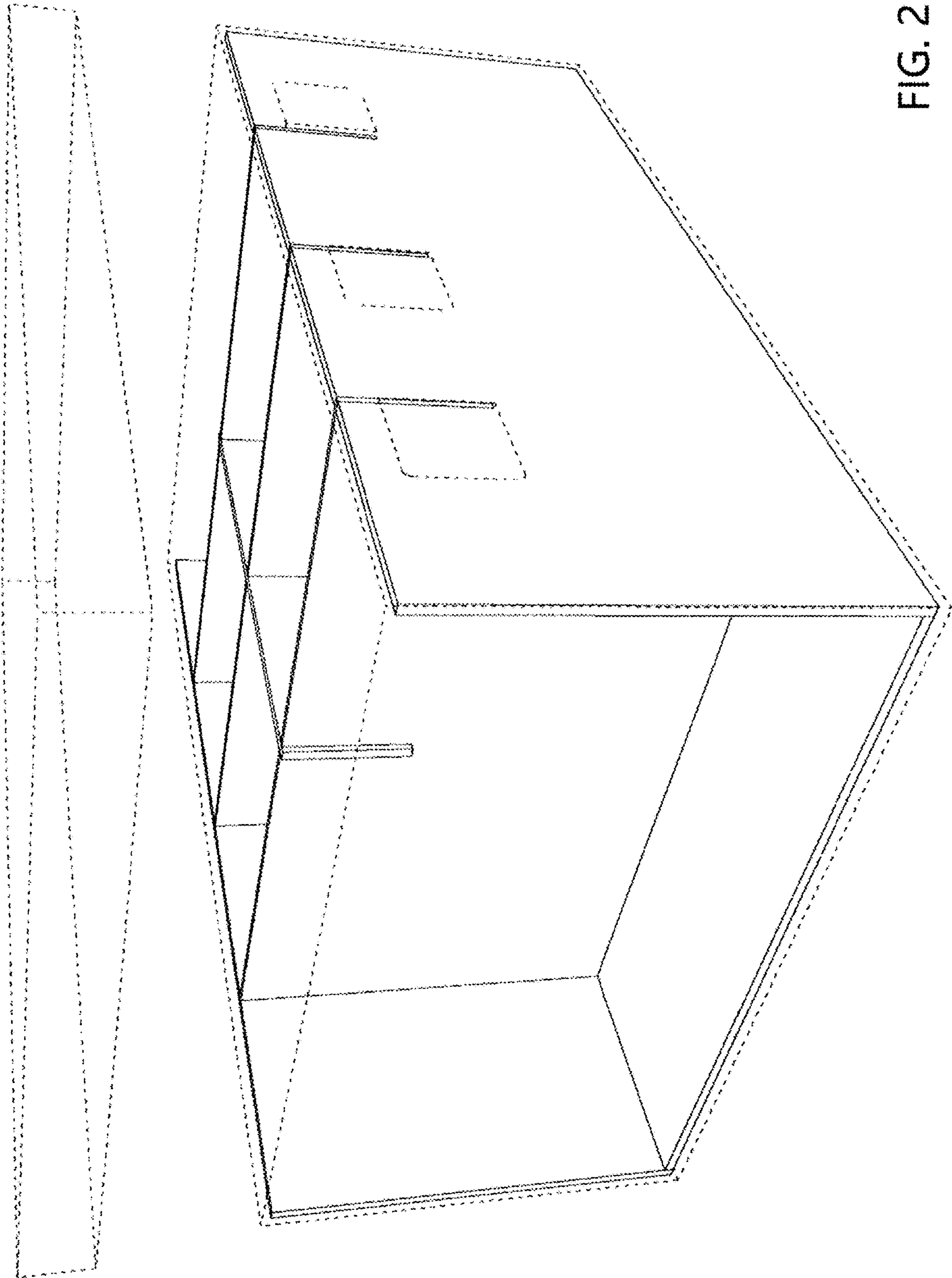

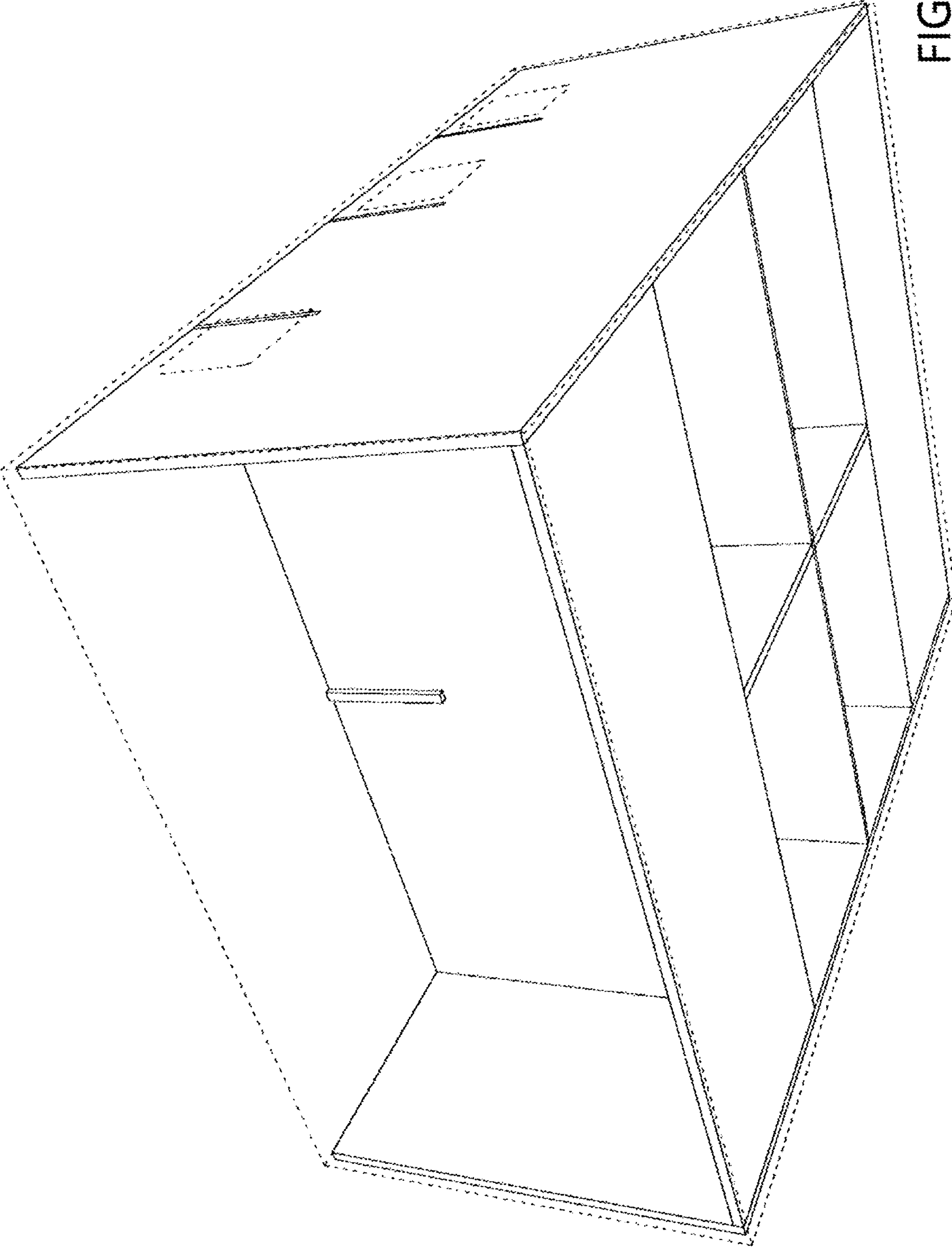

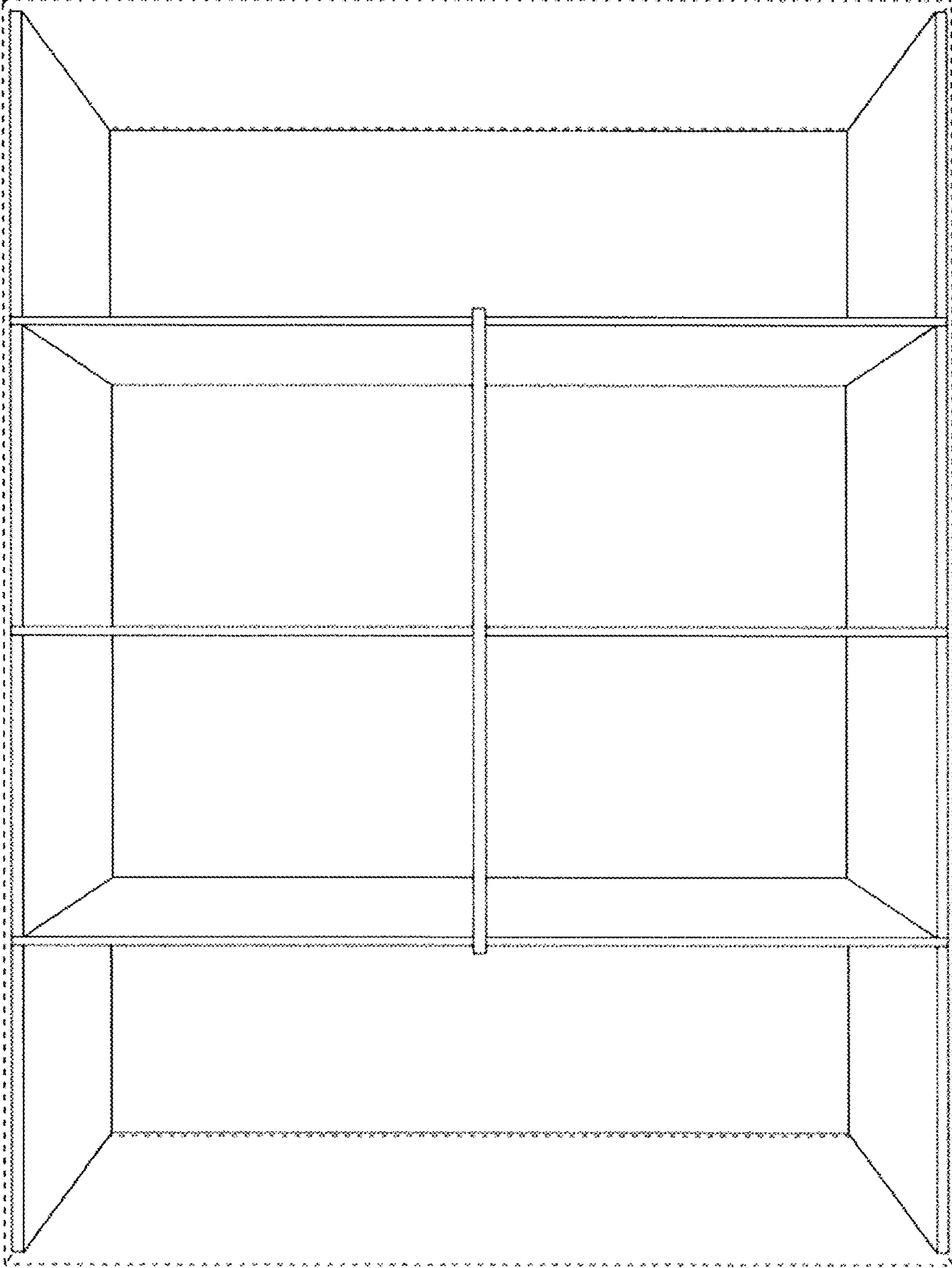

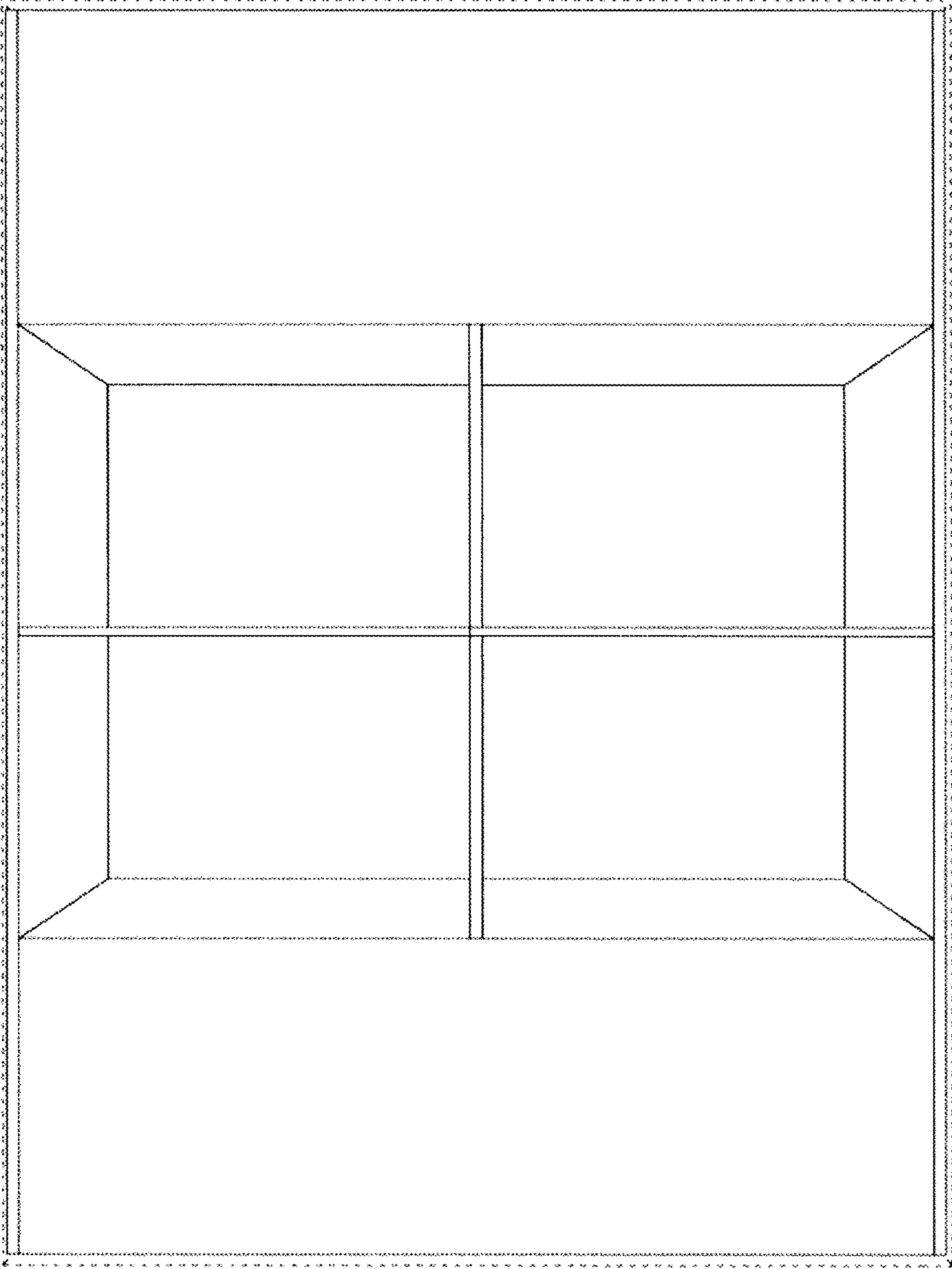

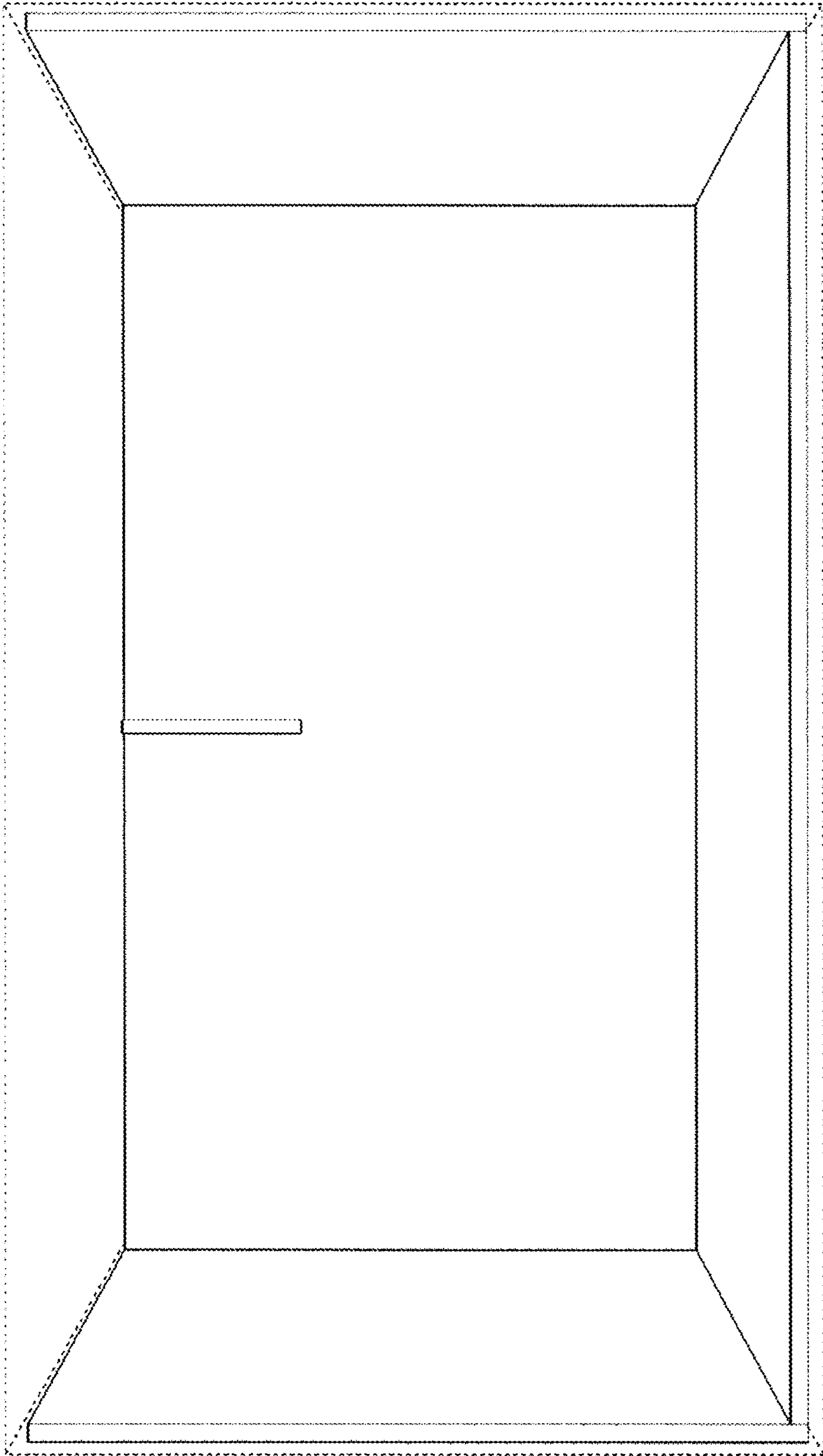

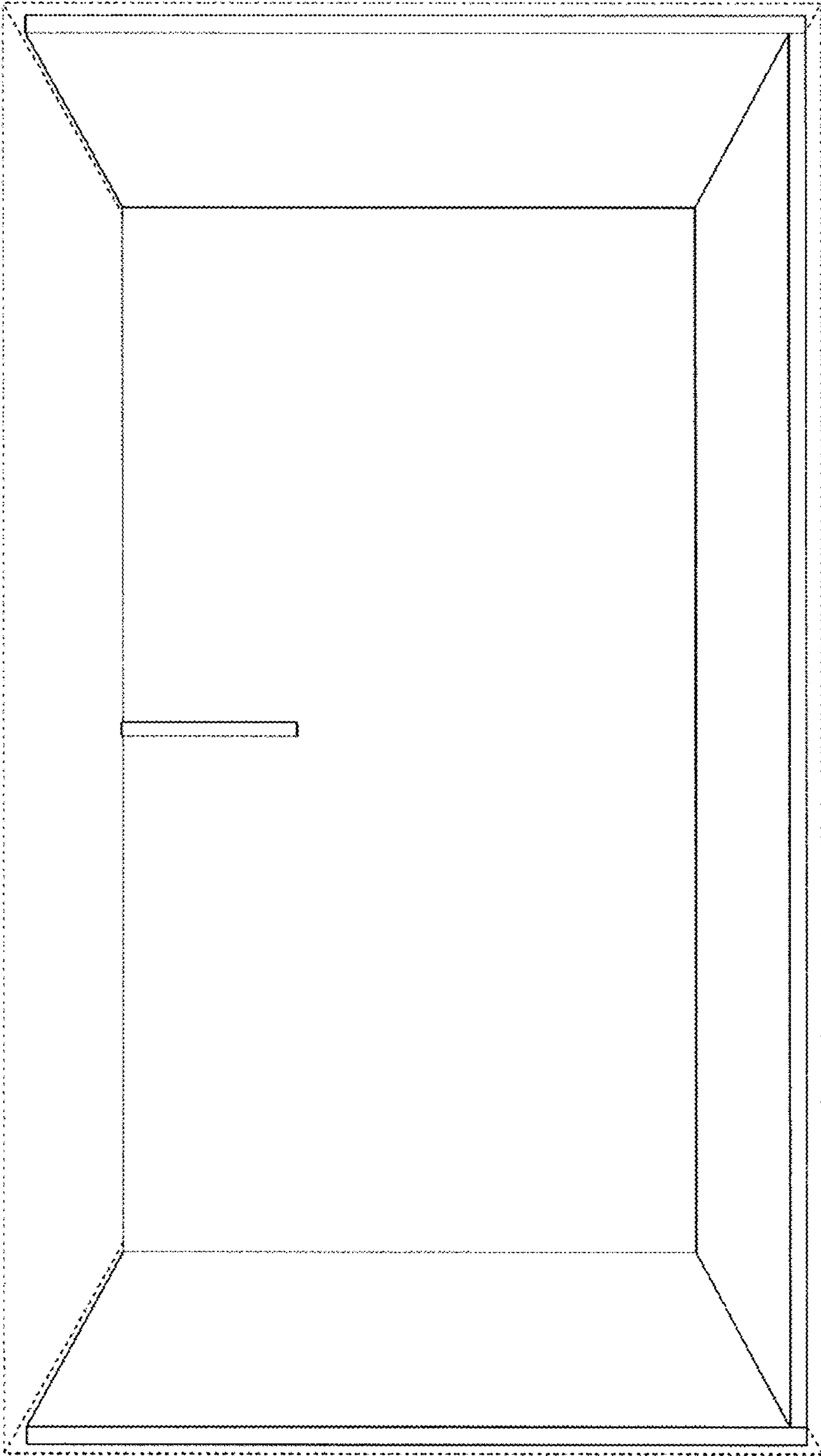

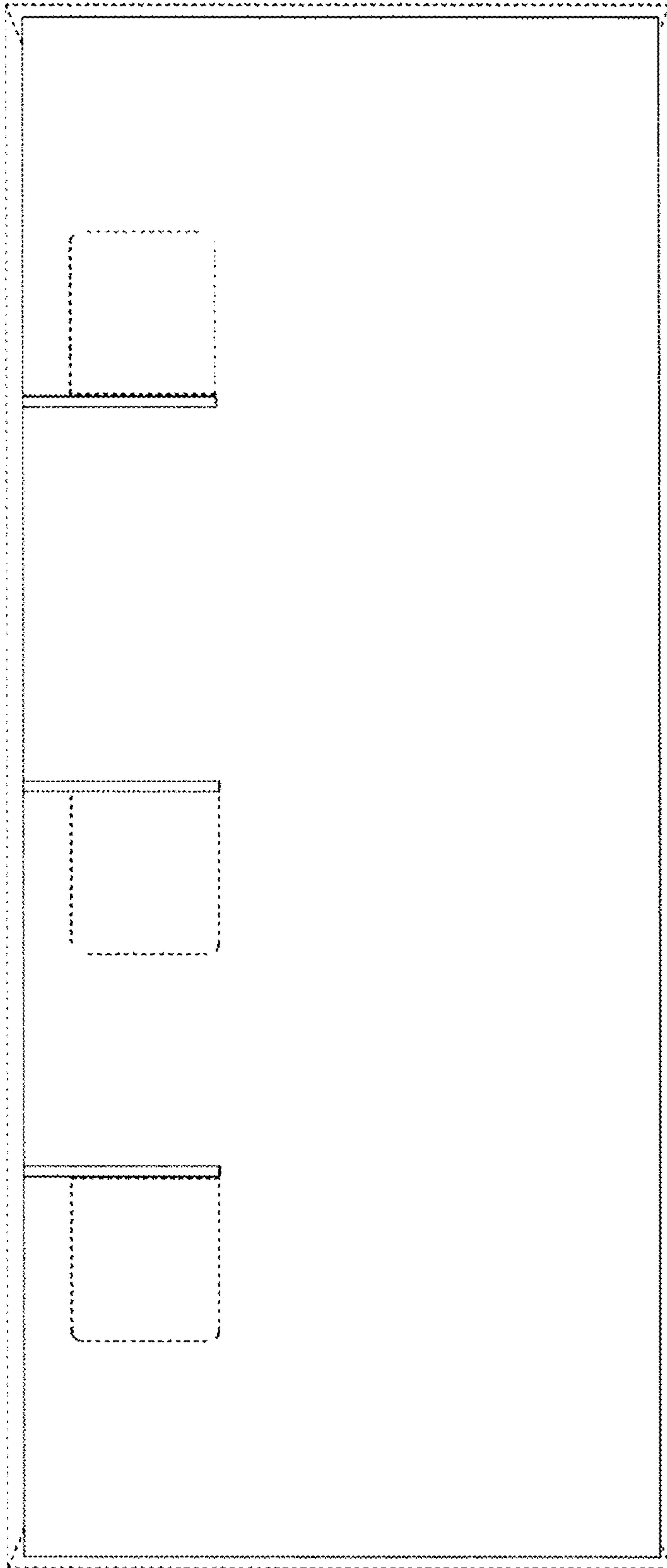

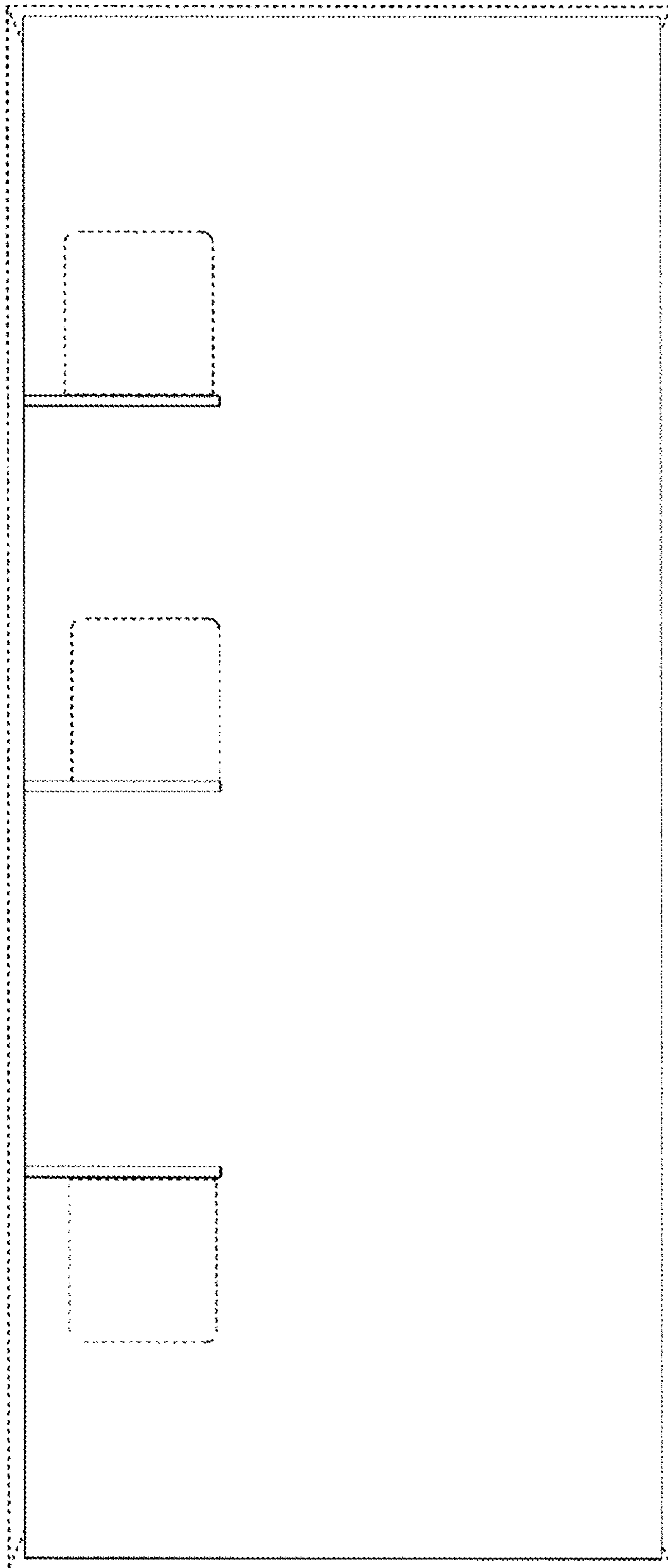
