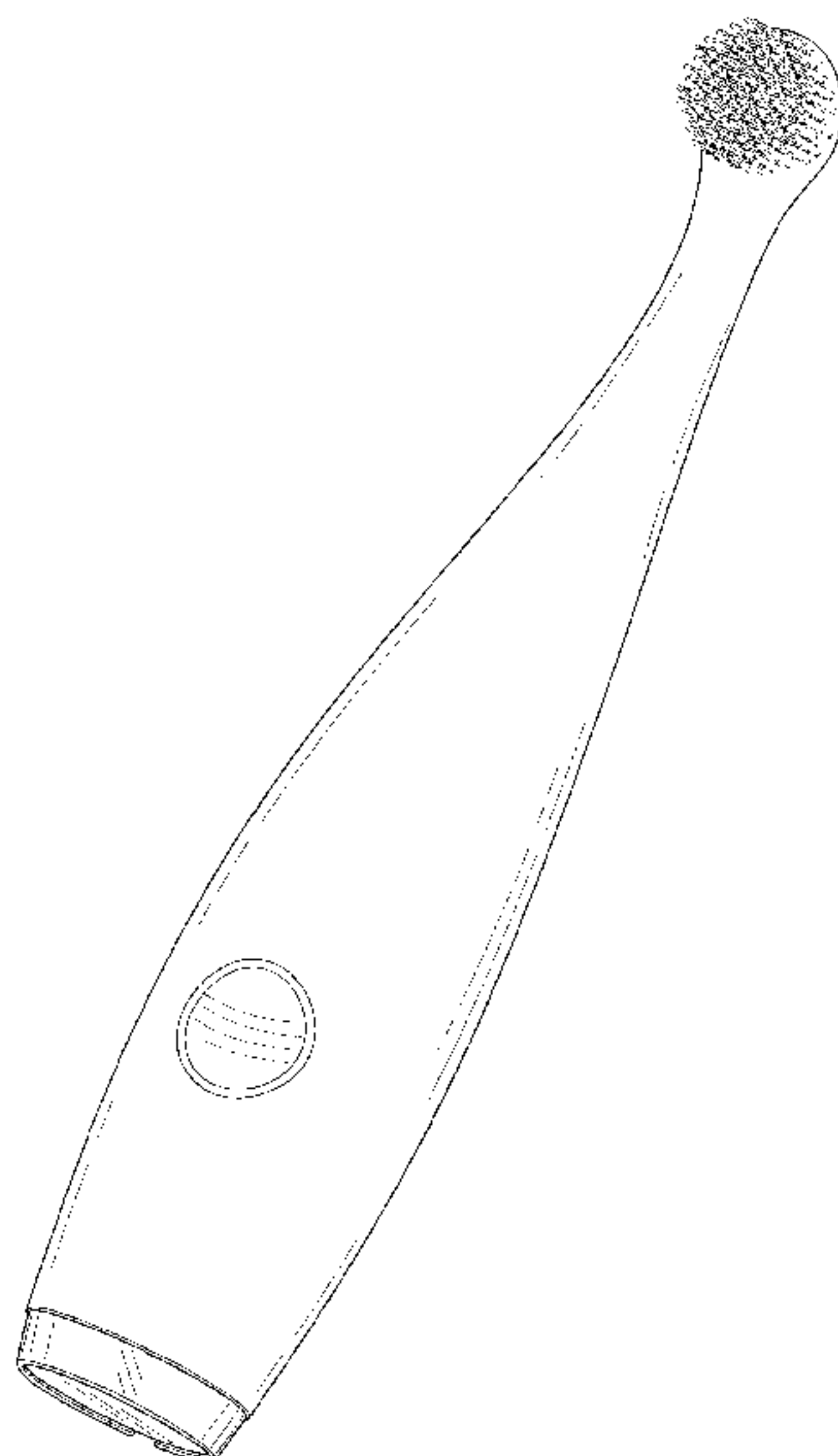
(57) **CLAIM**

I claim the ornamental design for a toothbrush, as shown and described.

**DESCRIPTION**

FIG. 4 is a left side view of the toothbrush.  
FIG. 5 is a right side view of the toothbrush.

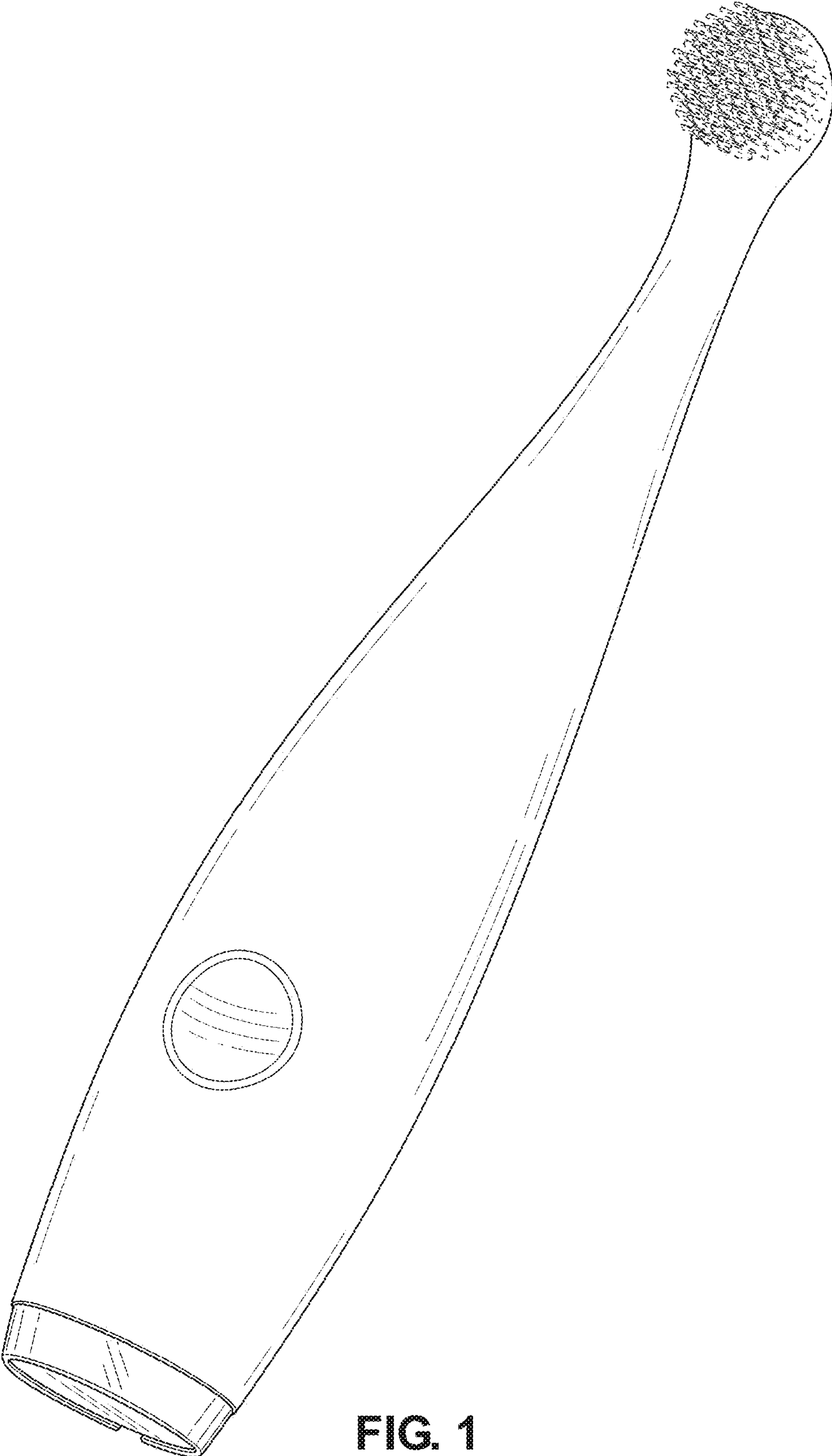

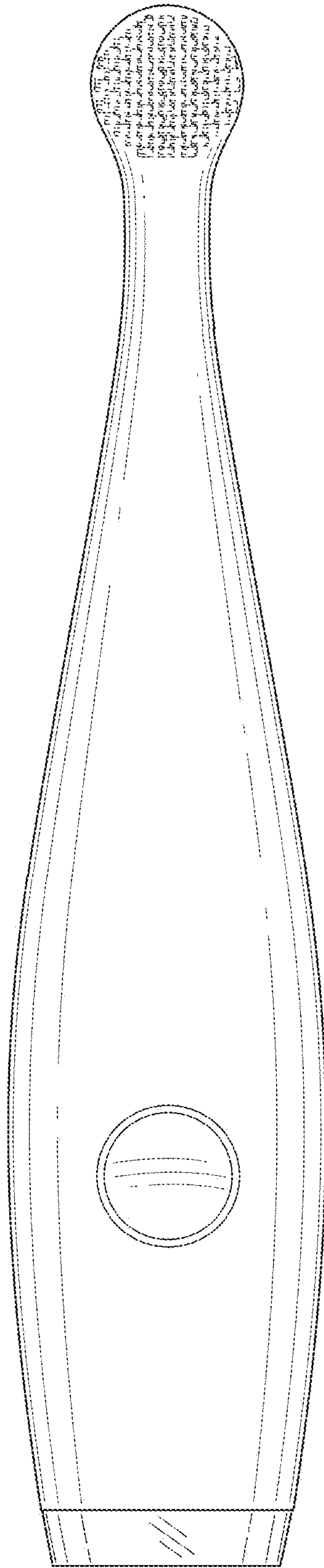

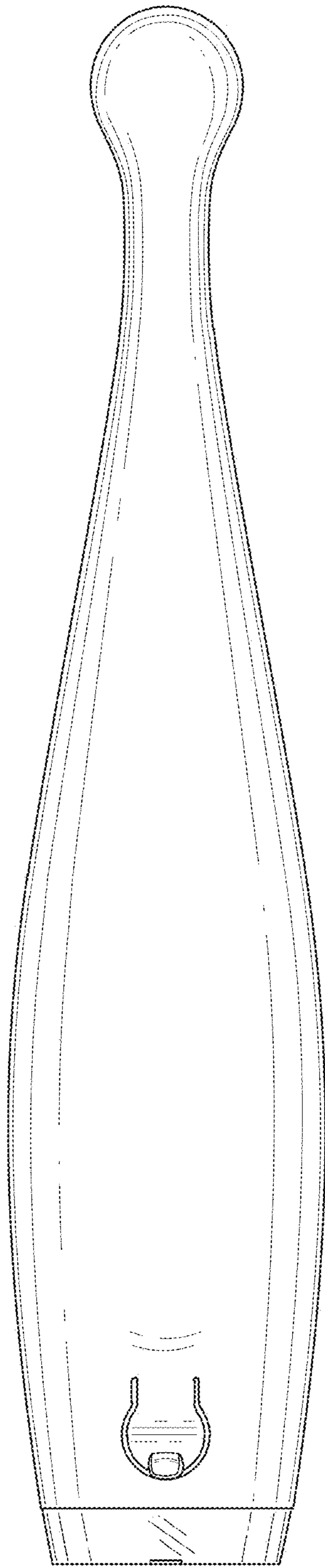

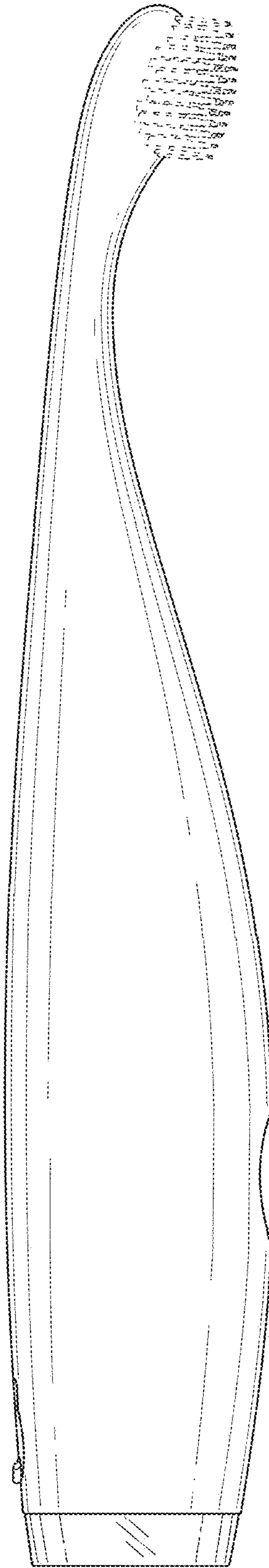
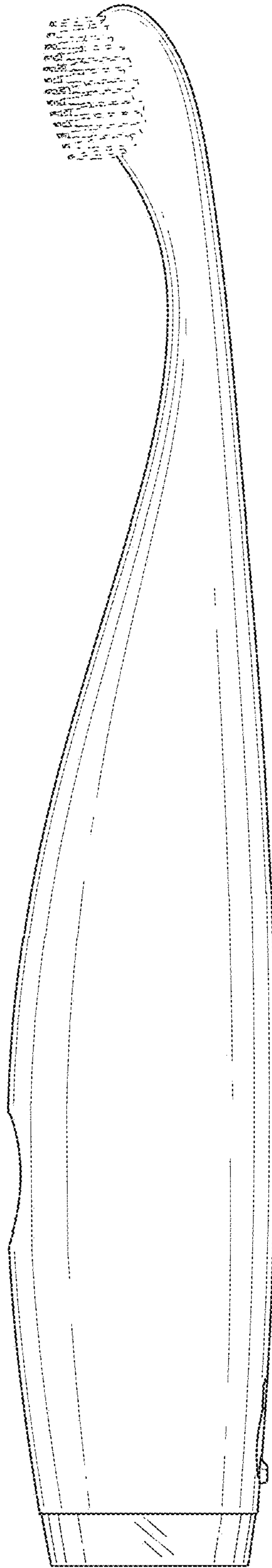
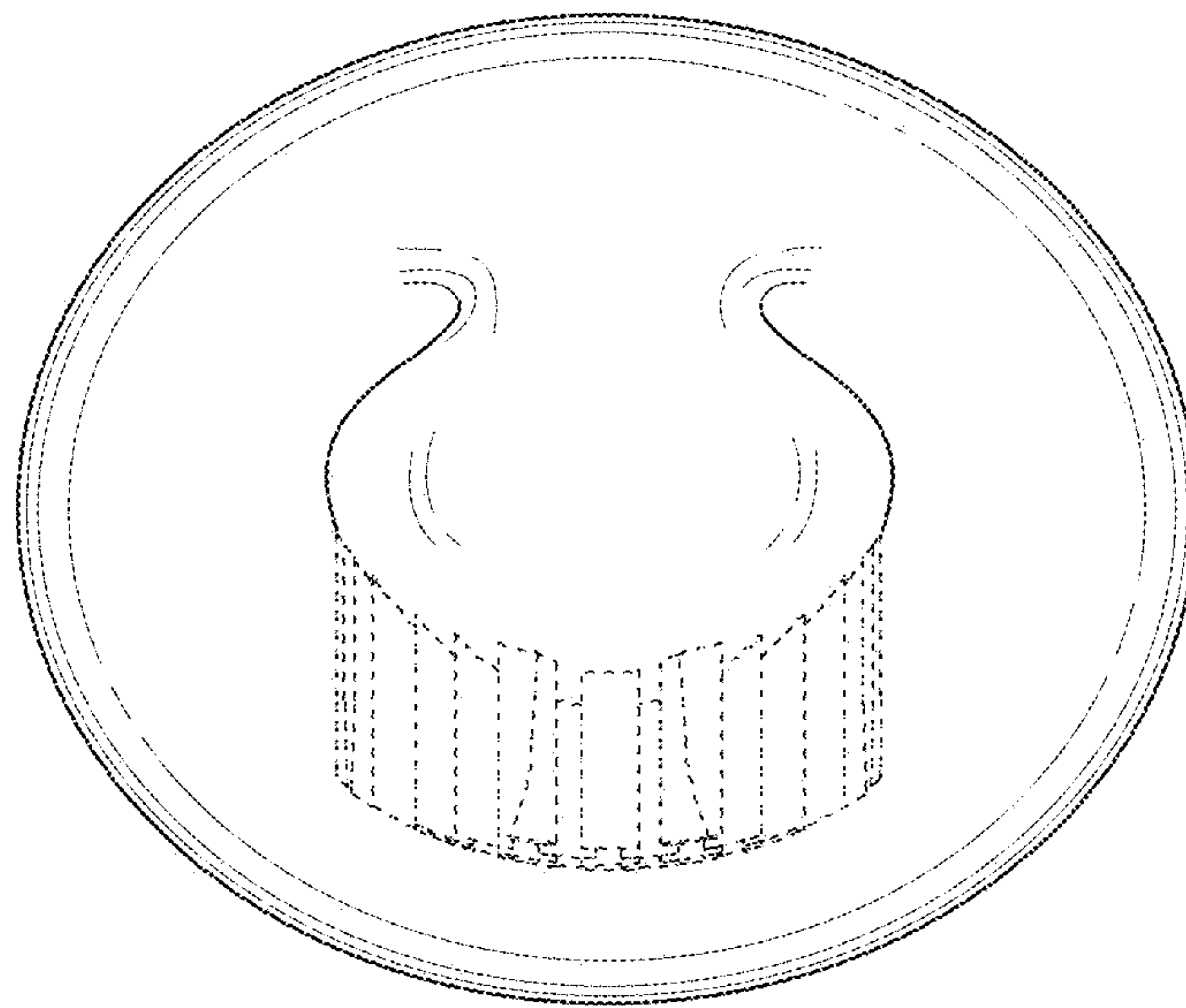

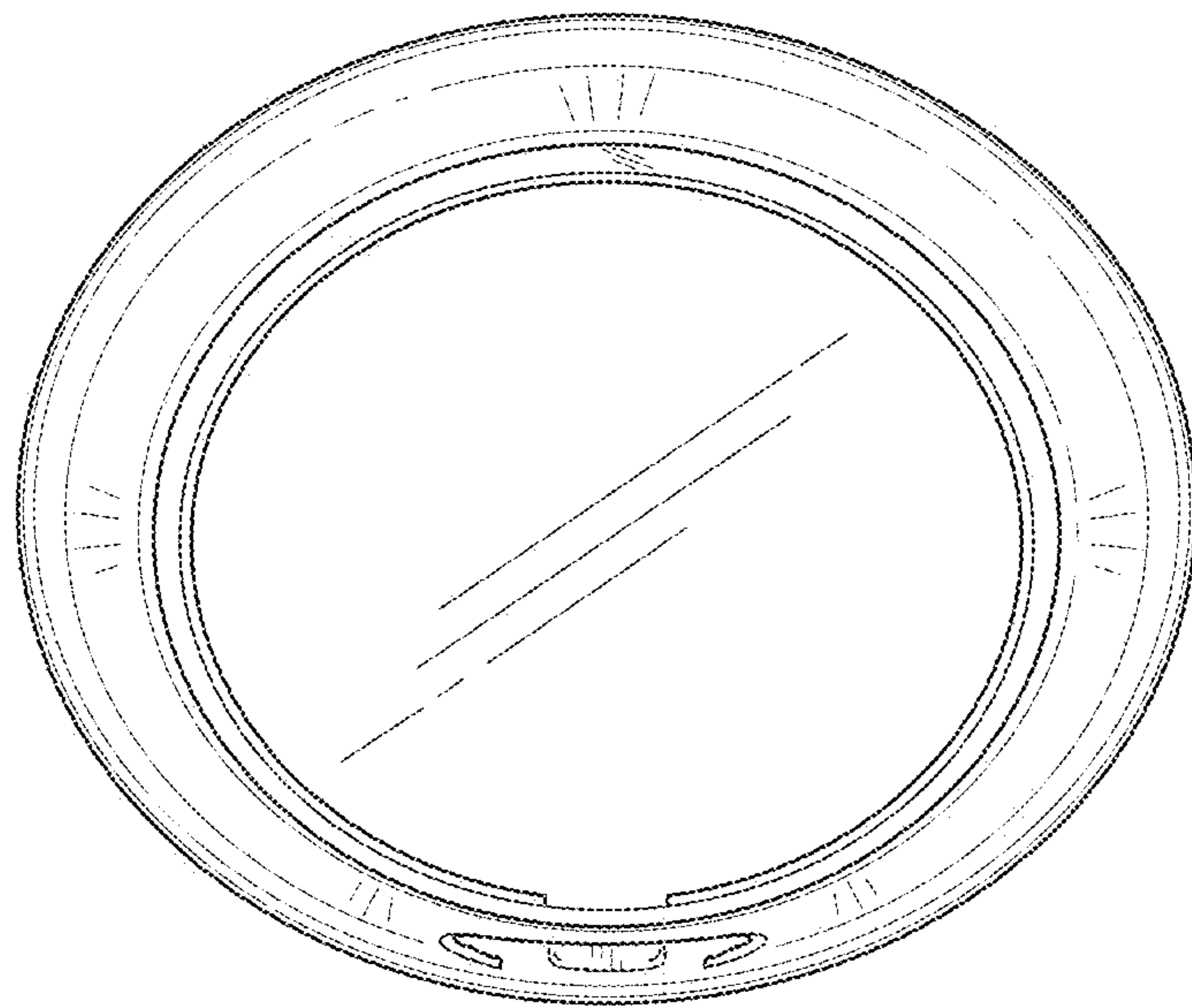
