(57) **CLAIM**

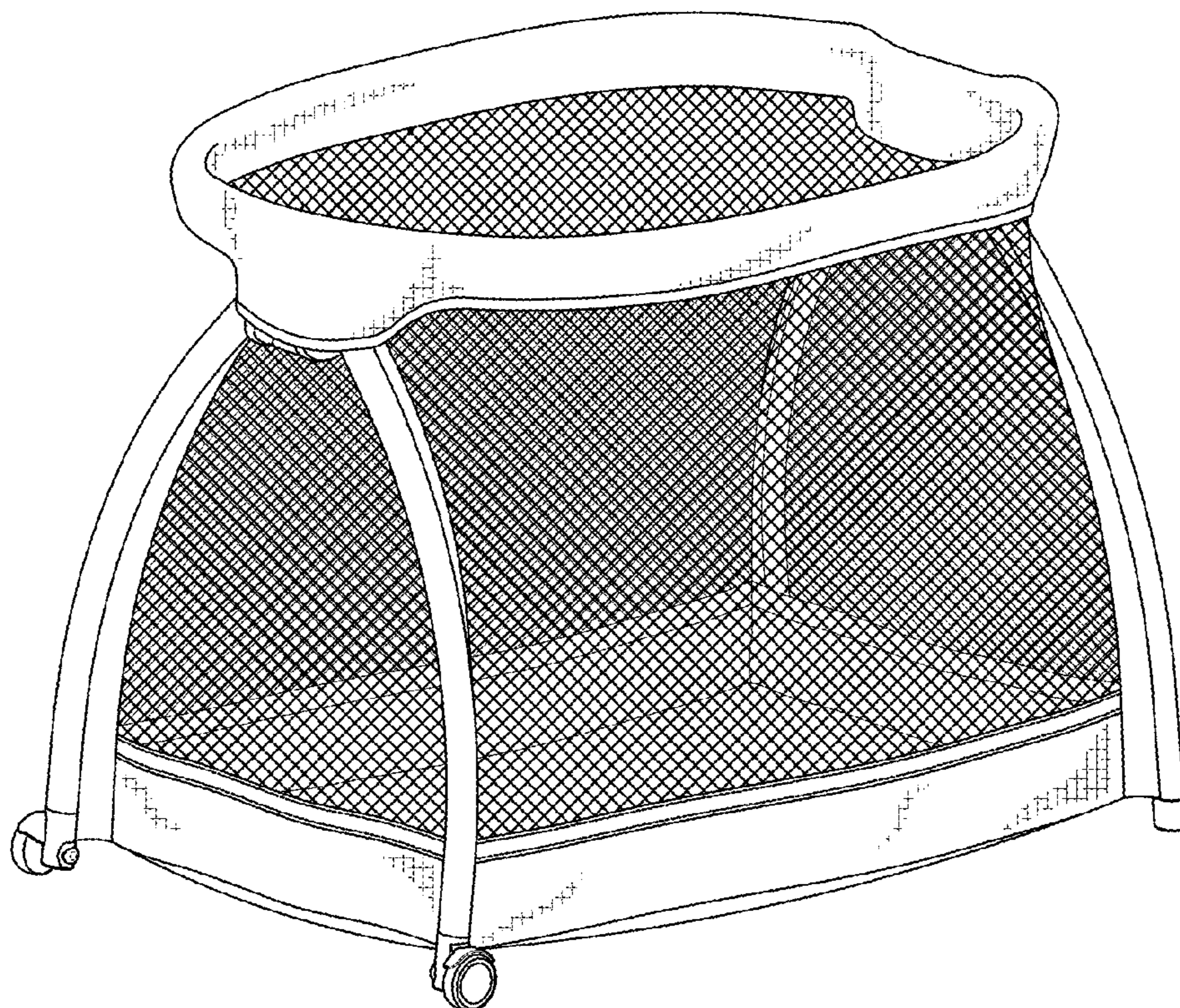
The ornamental design for a bedside bassinet, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a bedside bassinet in accordance with our new design; FIG. 2 is a front view of FIG. 1; FIG. 3 is a rear view of FIG. 1; FIG. 4 is a top view of FIG. 1; FIG. 5 is a bottom view of FIG. 1; FIG. 6 is a left side view of FIG. 1; FIG. 7 is a right side view of FIG. 1; and, FIG. 8 is a perspective view showing the bedside bassinet shown in FIG. 1 in use.

The broken lines in FIG. 8 illustrate portions of the Bedside Bassinet that form no part of the claimed design.

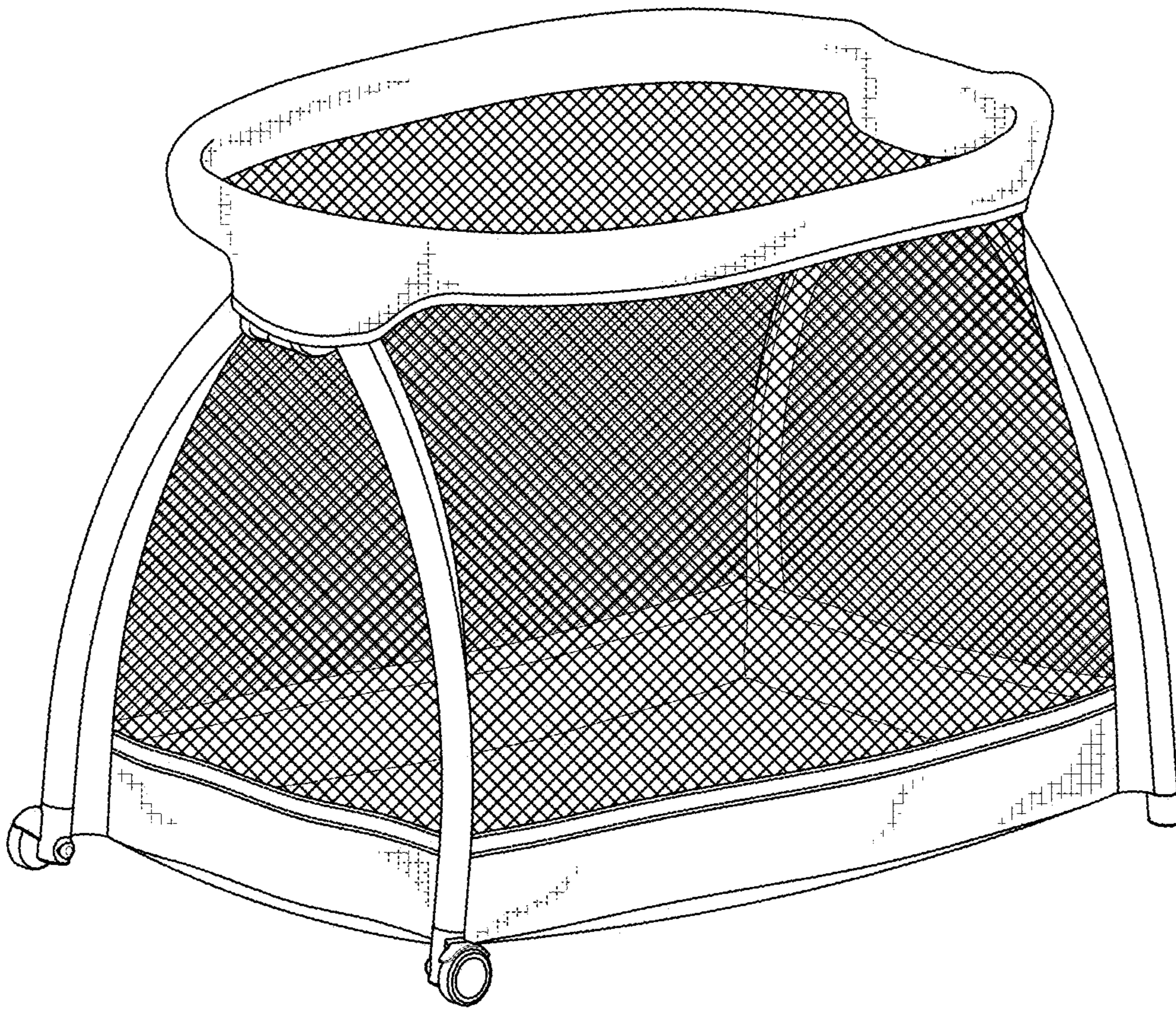

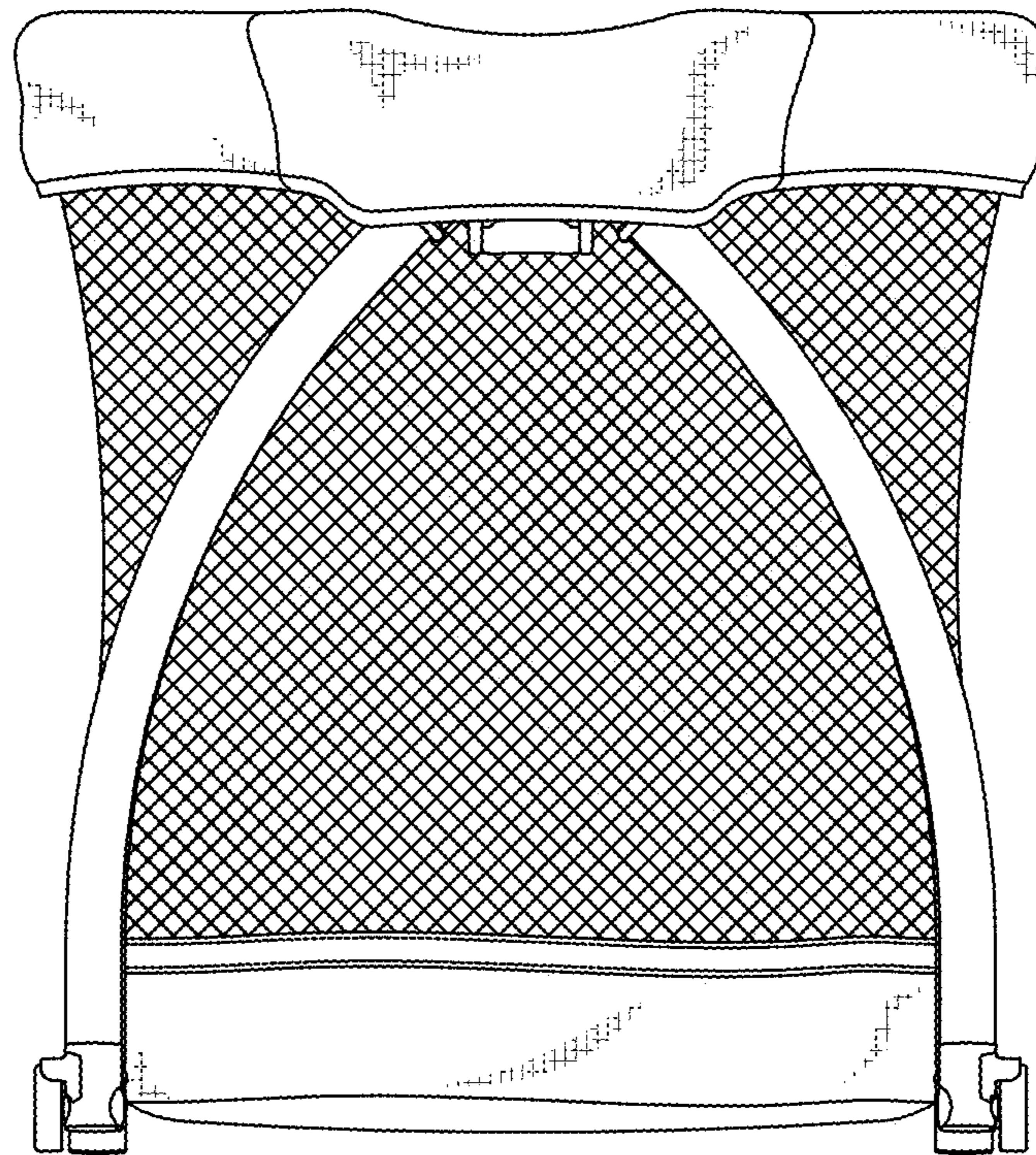

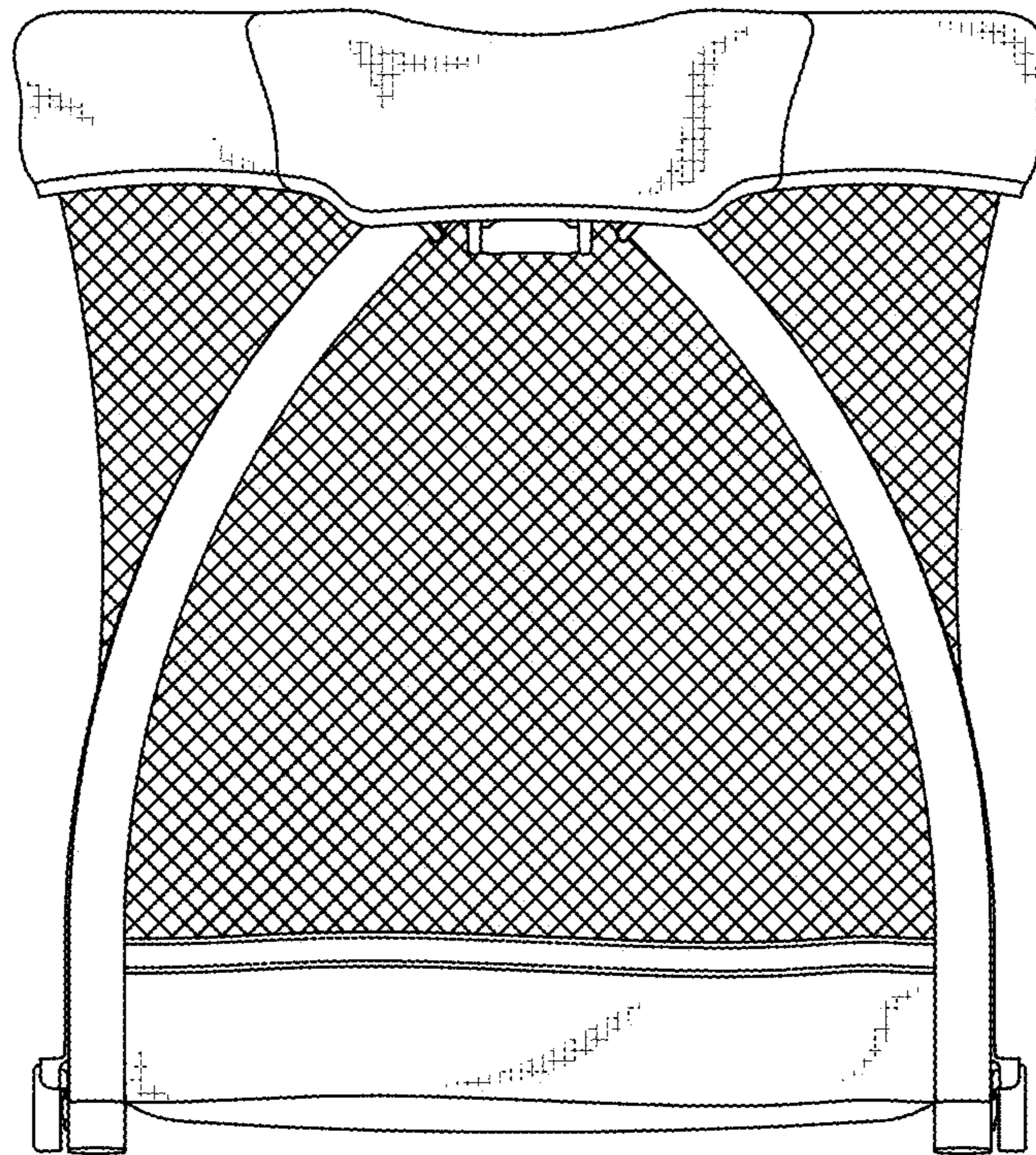

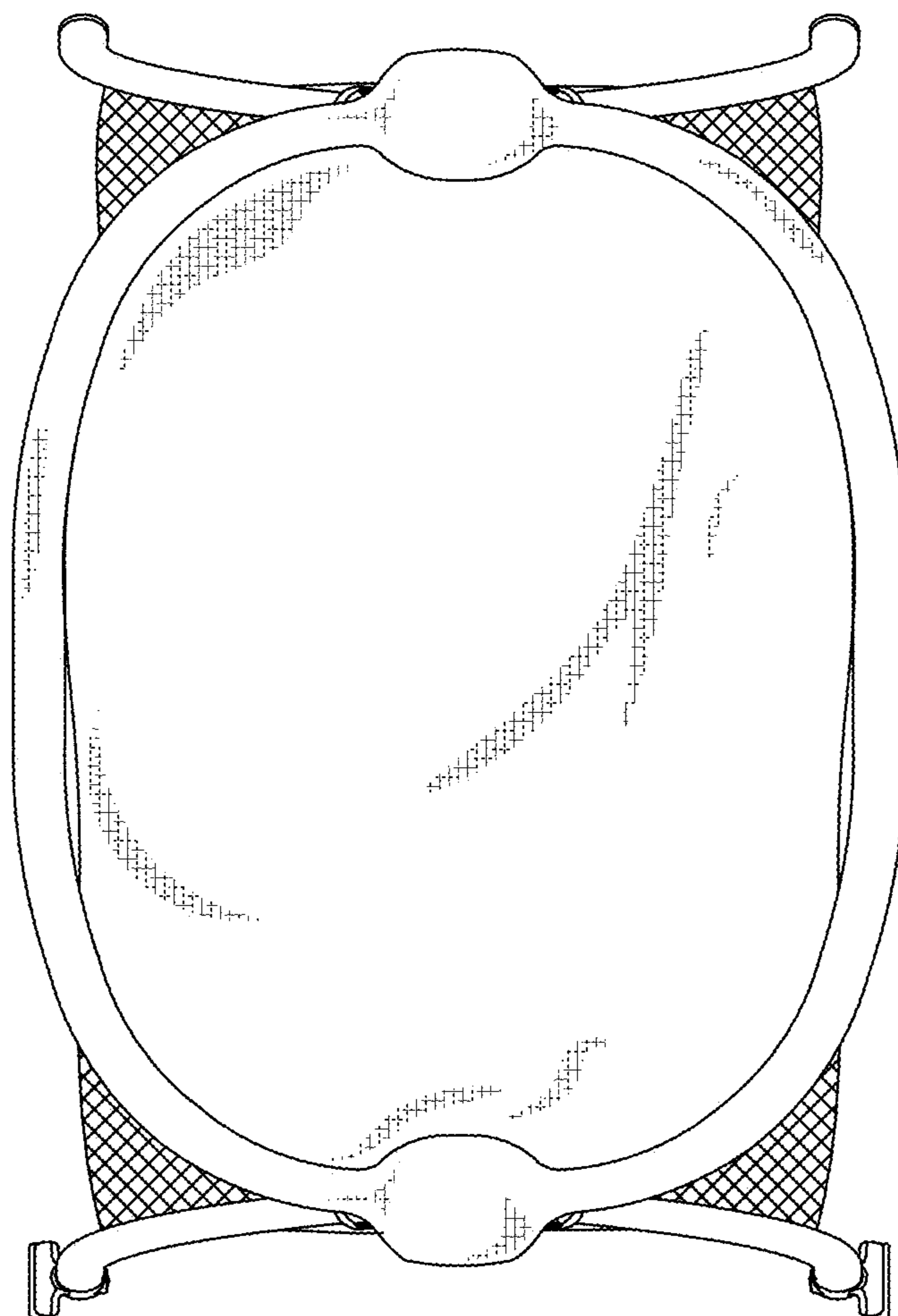

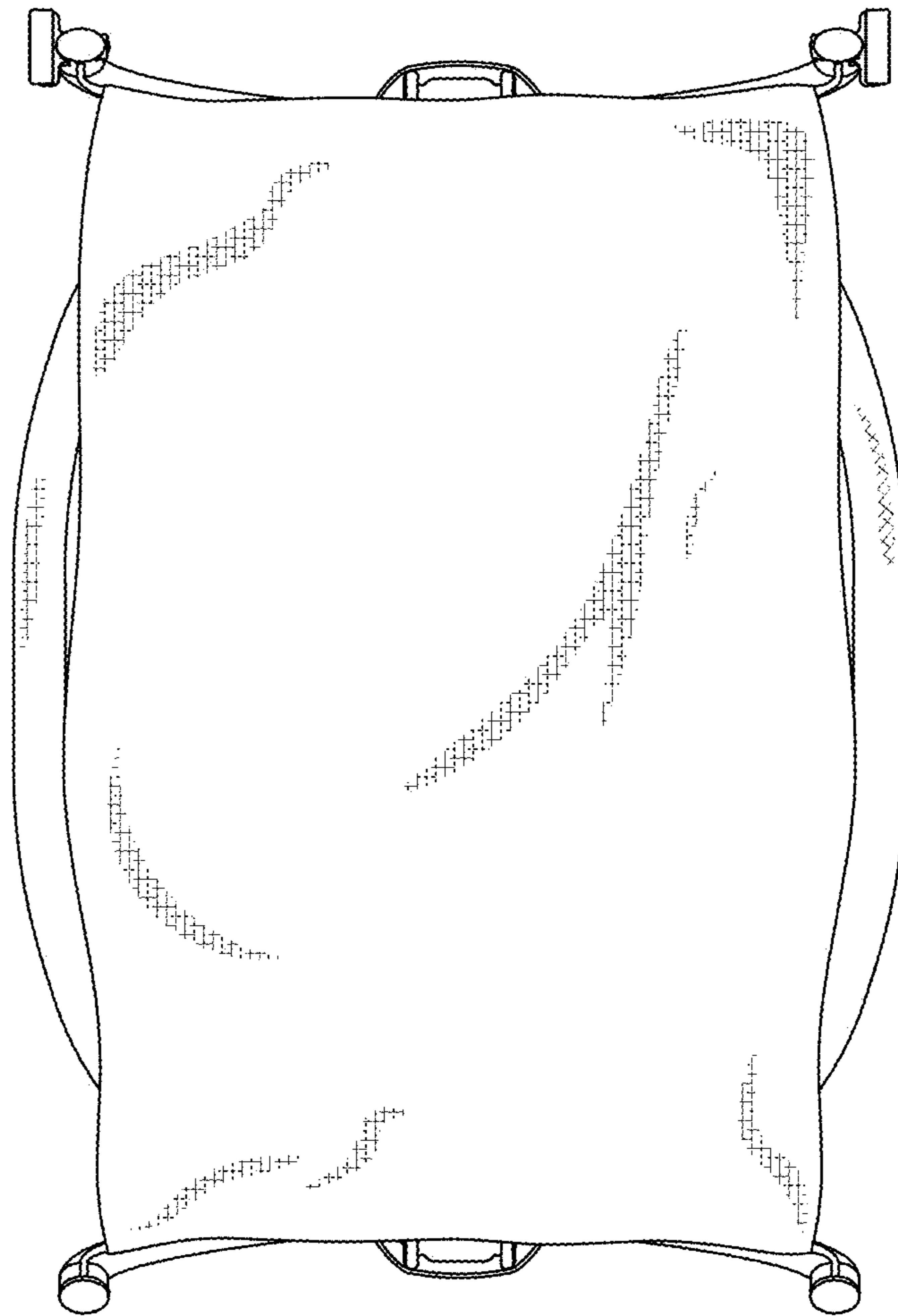

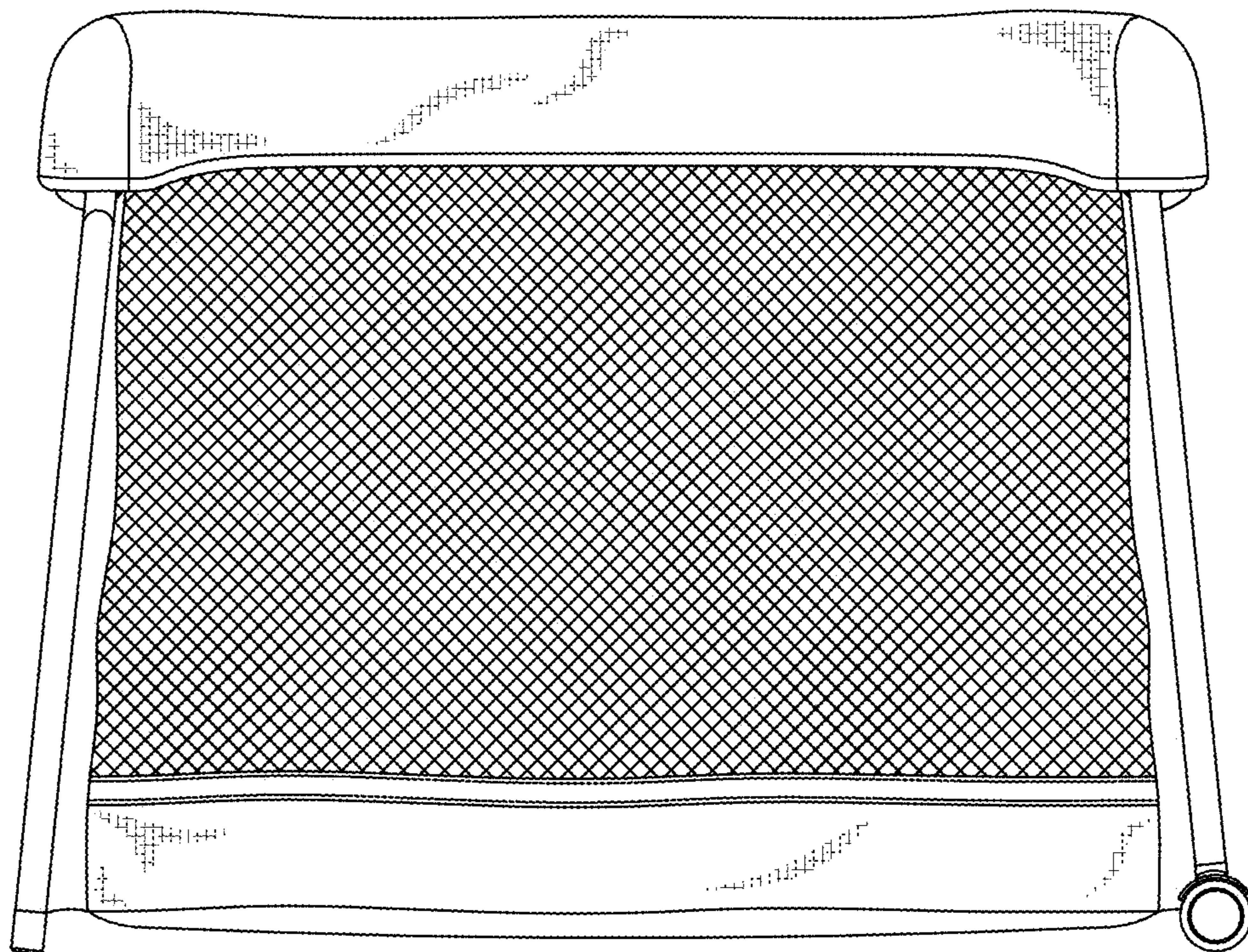

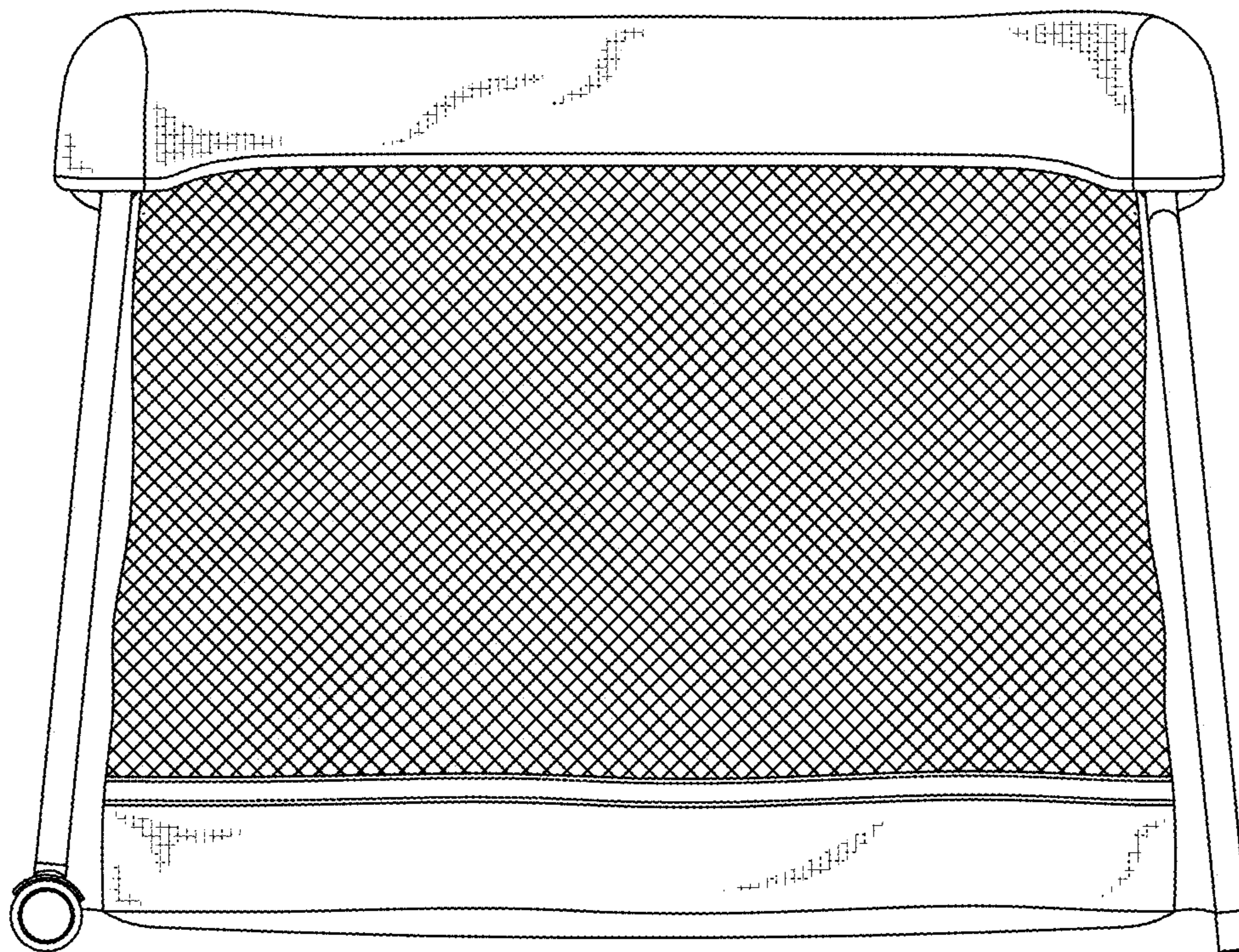
