(57) **CLAIM**

The ornamental design for a waffle iron plate, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a waffle iron plate.

FIG. 2 is a front view thereof.

FIG. 3 is another front perspective view of the waffle iron plate of FIG. 1, but shown with different broken line subject matter; and,

FIG. 4 is another front view thereof.

The dash-dash broken lines illustrate an environmental structure. The dash-dot broken lines represent the bounds of the claim. The broken lines form no part of the claimed design.

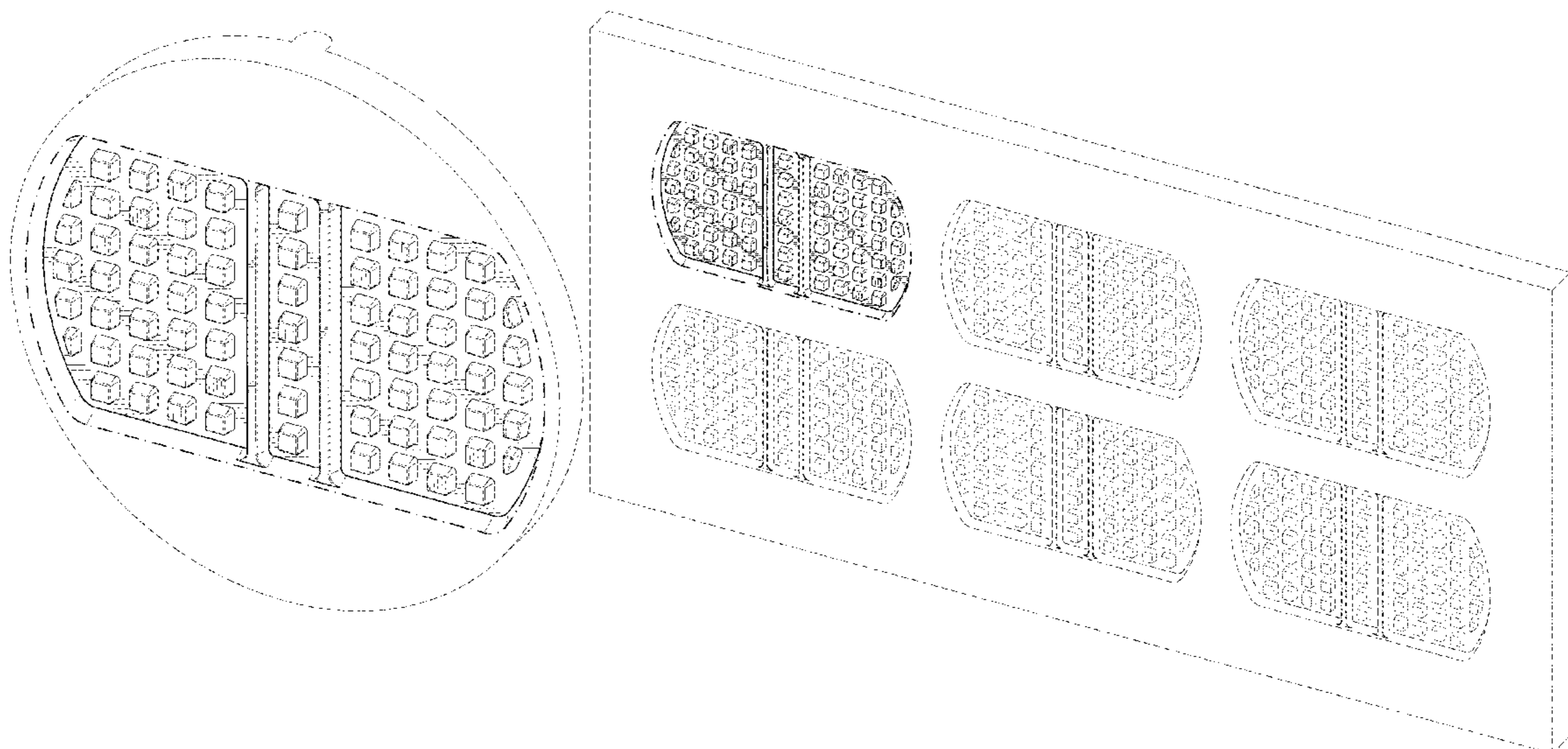
The light, evenly spaced and diagonally arranged lines shown within the recessed grid features represent surface shade and not surface ornamentation.

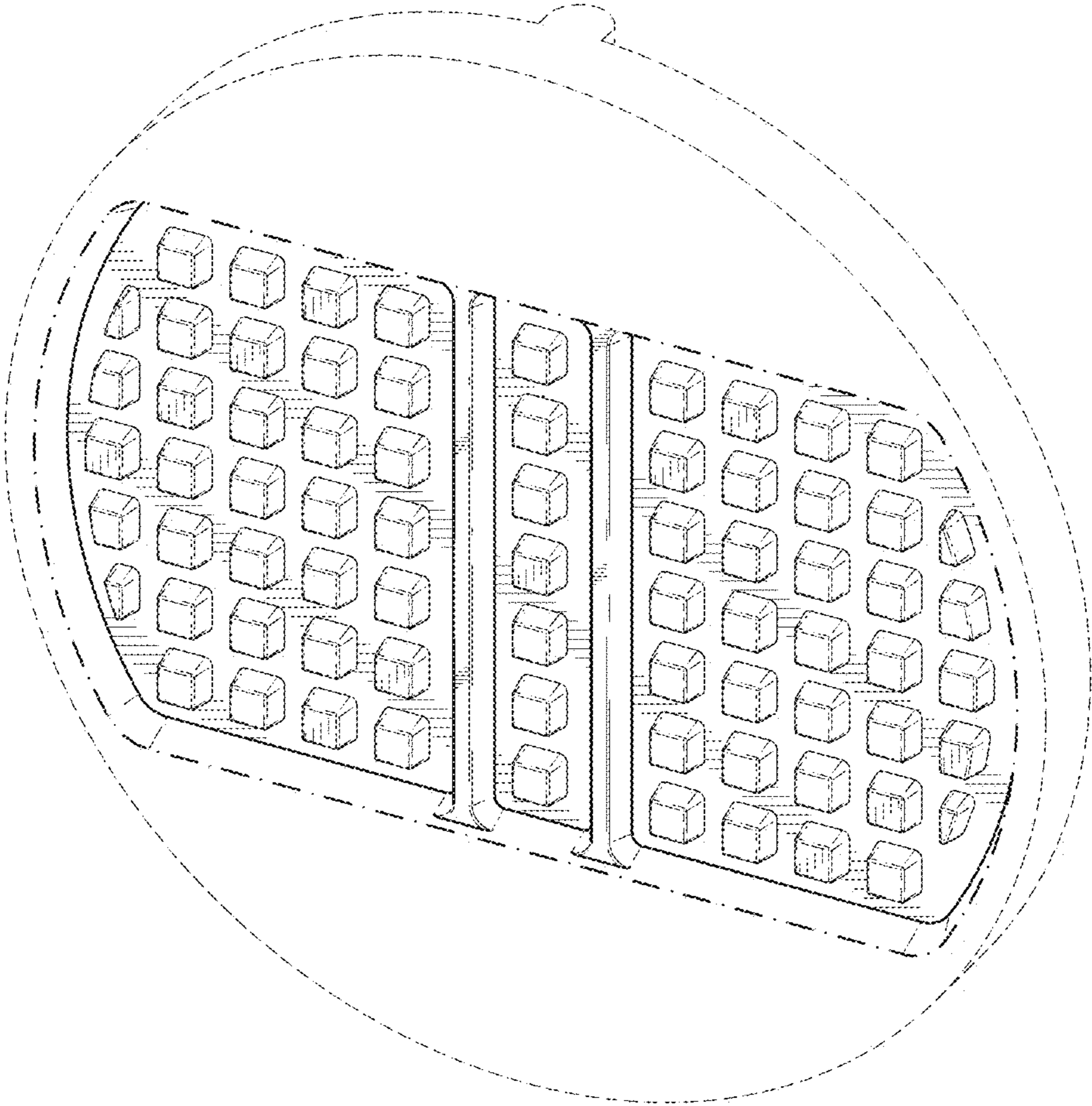

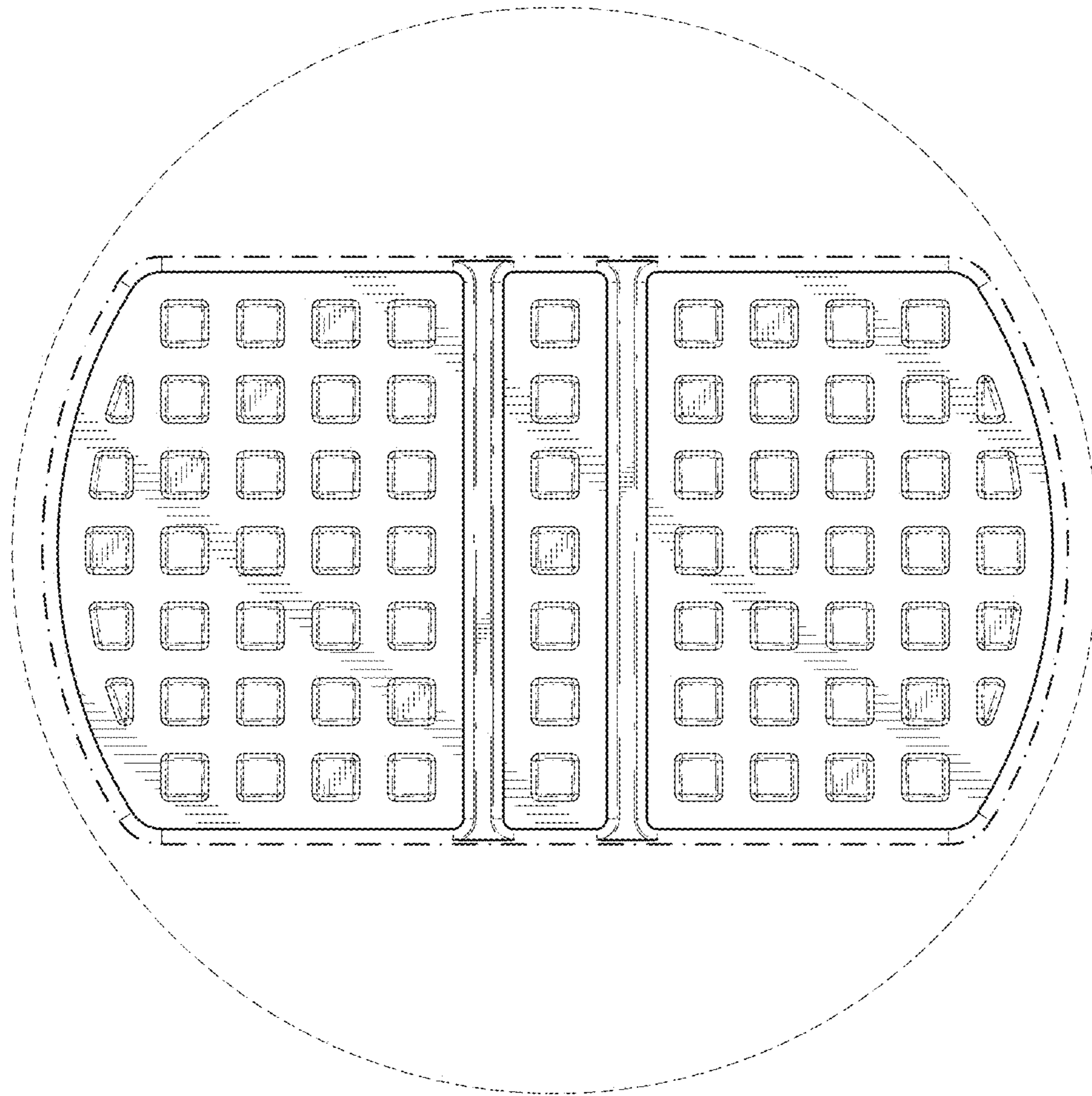

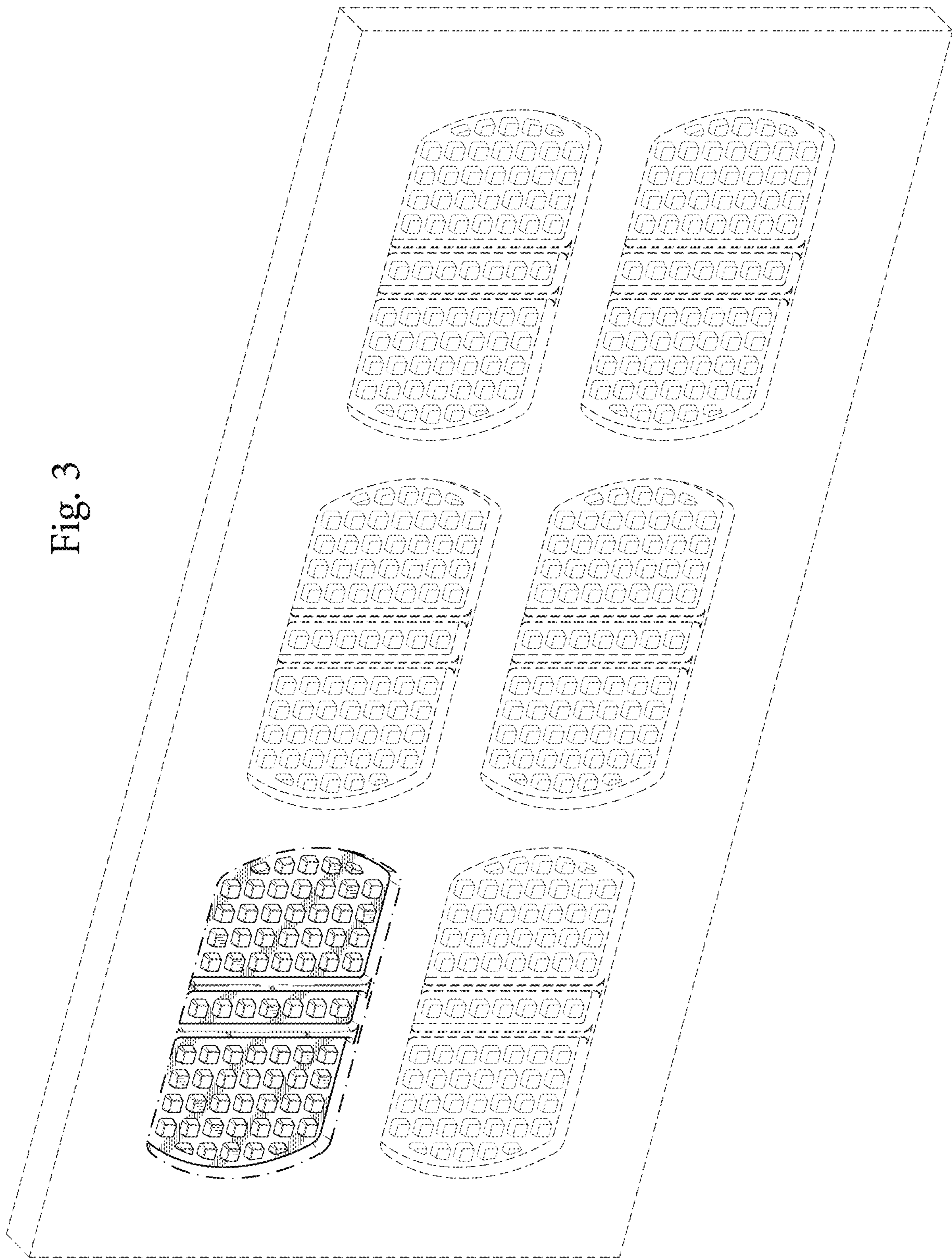
