FIG. 1 is a top perspective view of a first embodiment of the food product tray of our new design, the tray being at least partially transparent and having a blue color, where a representative food product (a fish food product) sealed in position under a clear and non-colored transparent film generally conforming to the peripheral shape of the food product is provided for illustrative purposes and forms no part of the claimed design;

FIG. 2 is a bottom perspective view of the food product tray of FIG. 1;

FIG. 3 is a left side elevation view of the food product tray of FIG. 1;

FIG. 4 is a right side elevation view of the food product tray of FIG. 1;

FIG. 5 is a front end elevation view of the food product tray of FIG. 1;

FIG. 6 is a rear end elevation view of the food product tray of FIG. 1;

FIG. 7 is a top plan view of the food product tray of FIG. 1; and,

FIG. 8 is a bottom plan view of the food product tray of FIG. 1.

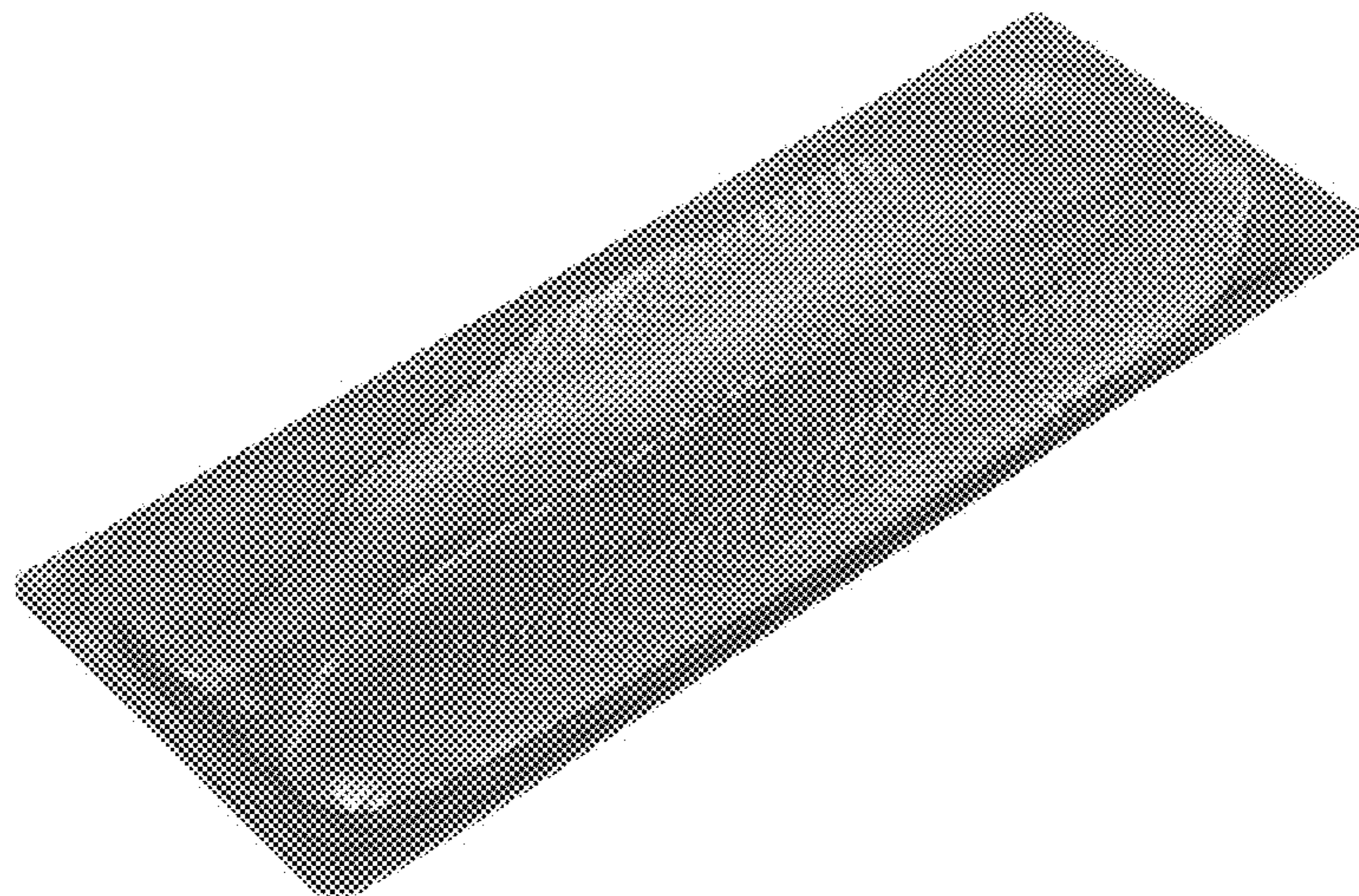

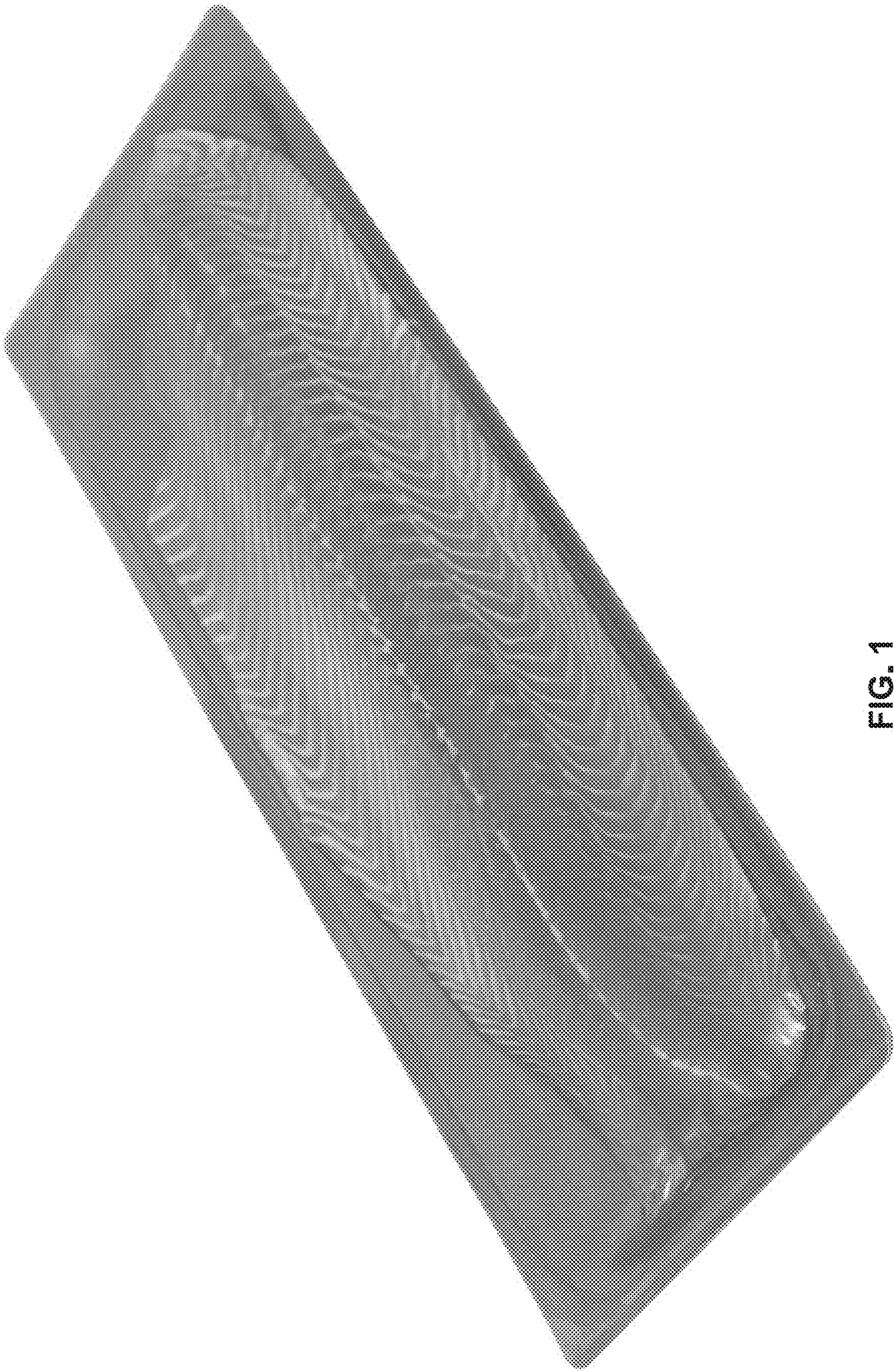

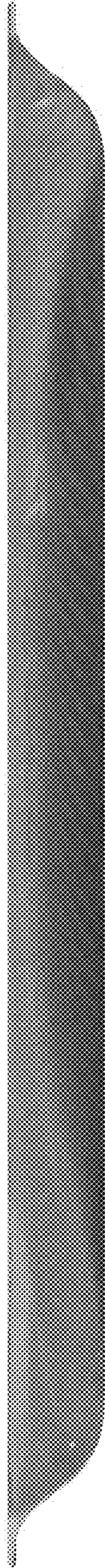

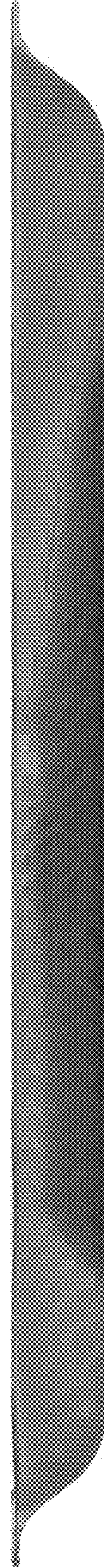

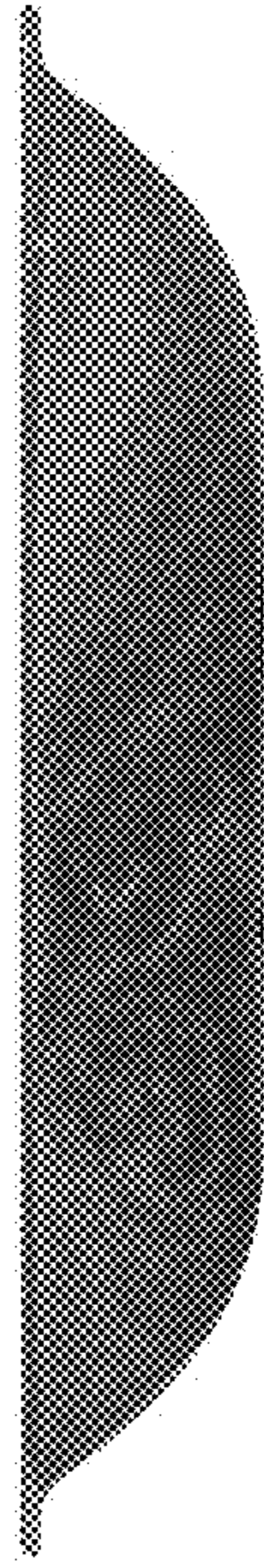

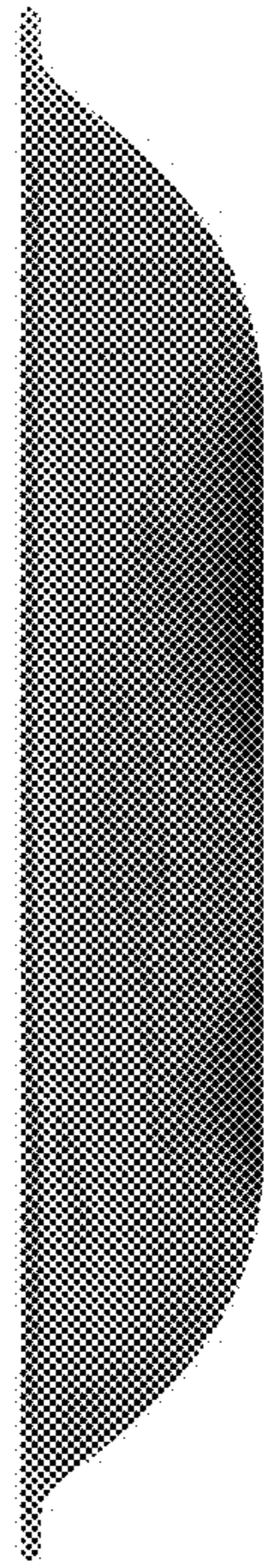

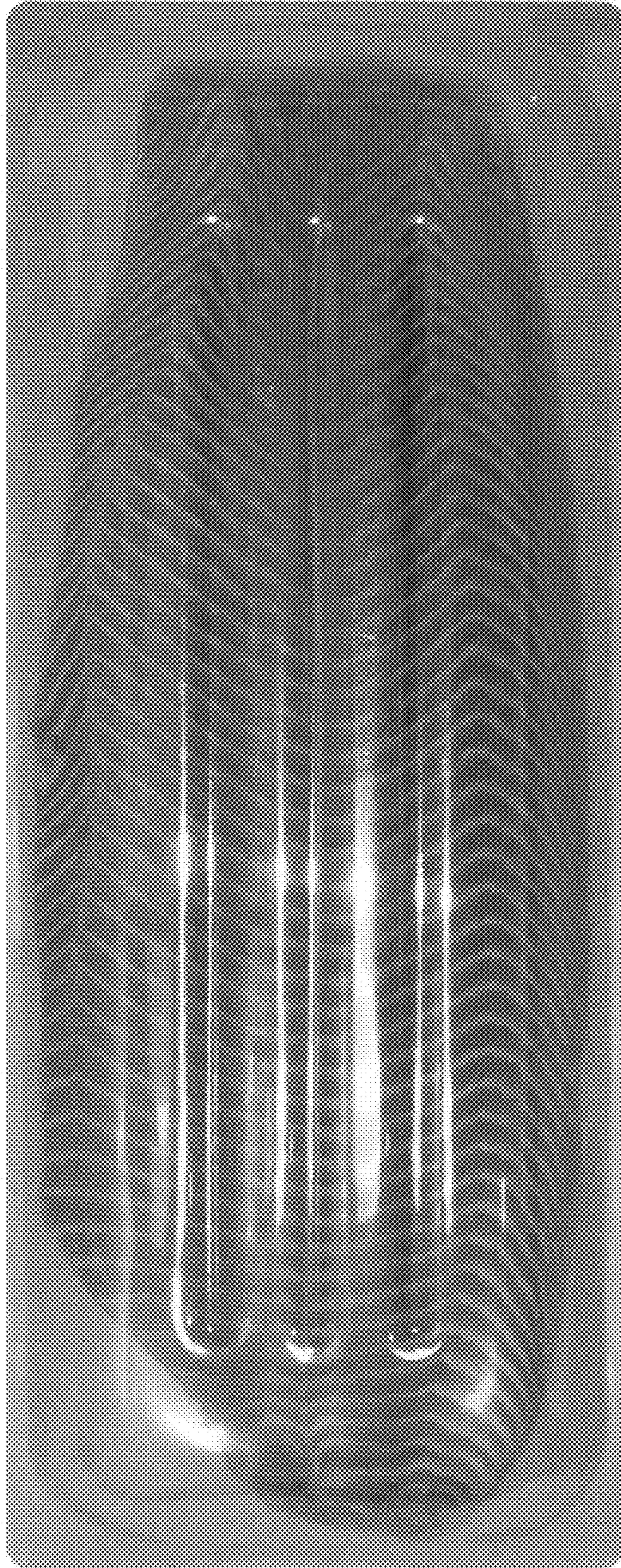
