DESCRIPTION

FIG. 1 is a perspective view of a notification appliance, showing our new design;

FIG. 2 is a front view of the notification appliance of FIG. 1;

FIG. 3 is a left side view of the notification appliance of FIG. 1, the right side view being a mirror image of the left side view shown;

FIG. 4 is a first end view of the notification appliance of FIG. 1;

FIG. 5 is a second end view of the notification appliance of FIG. 1; and,

FIG. 6 is a back view of the notification appliance of FIG. 1.

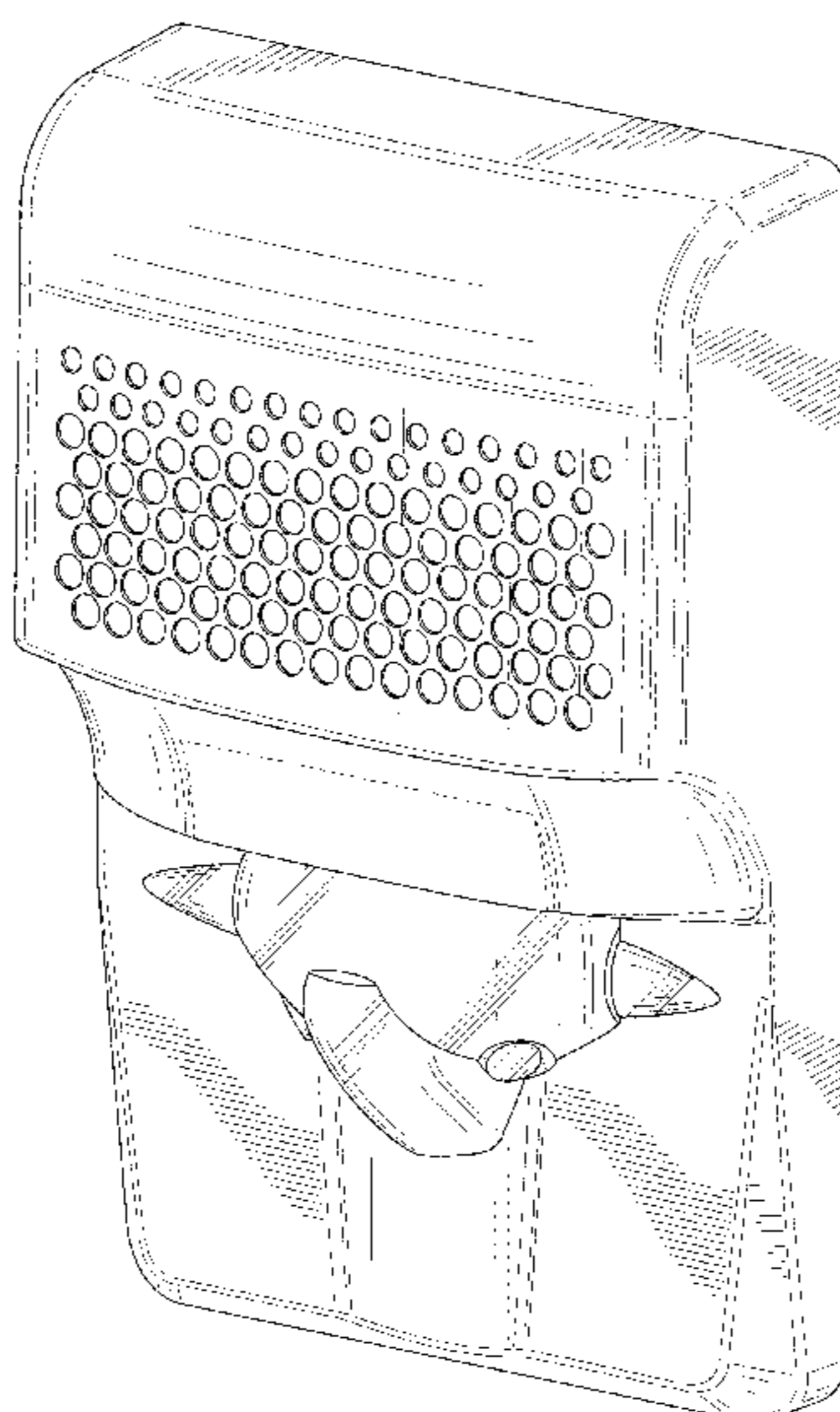
The broken lines illustrate portions of the notification appliance that form no part of the claimed design.

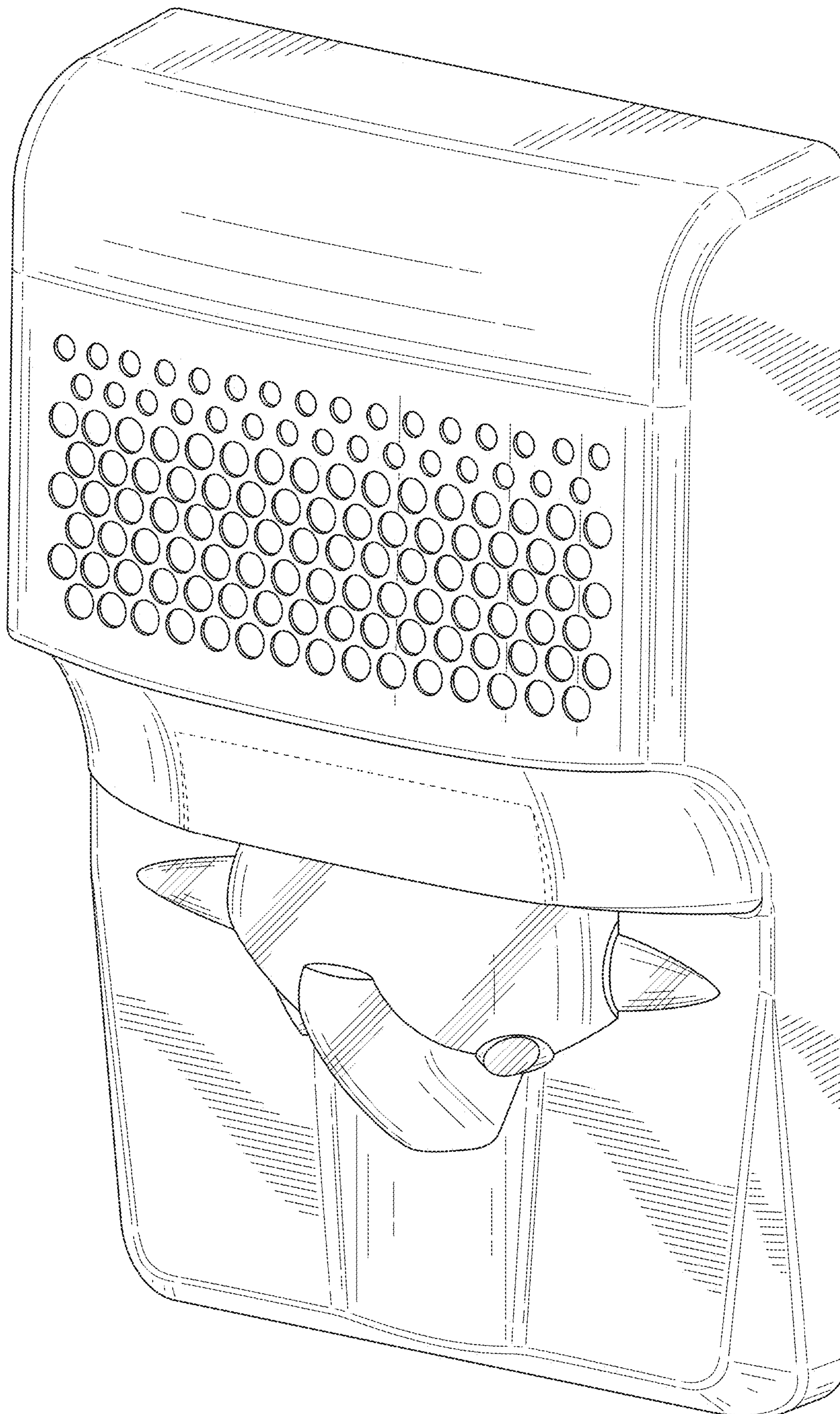

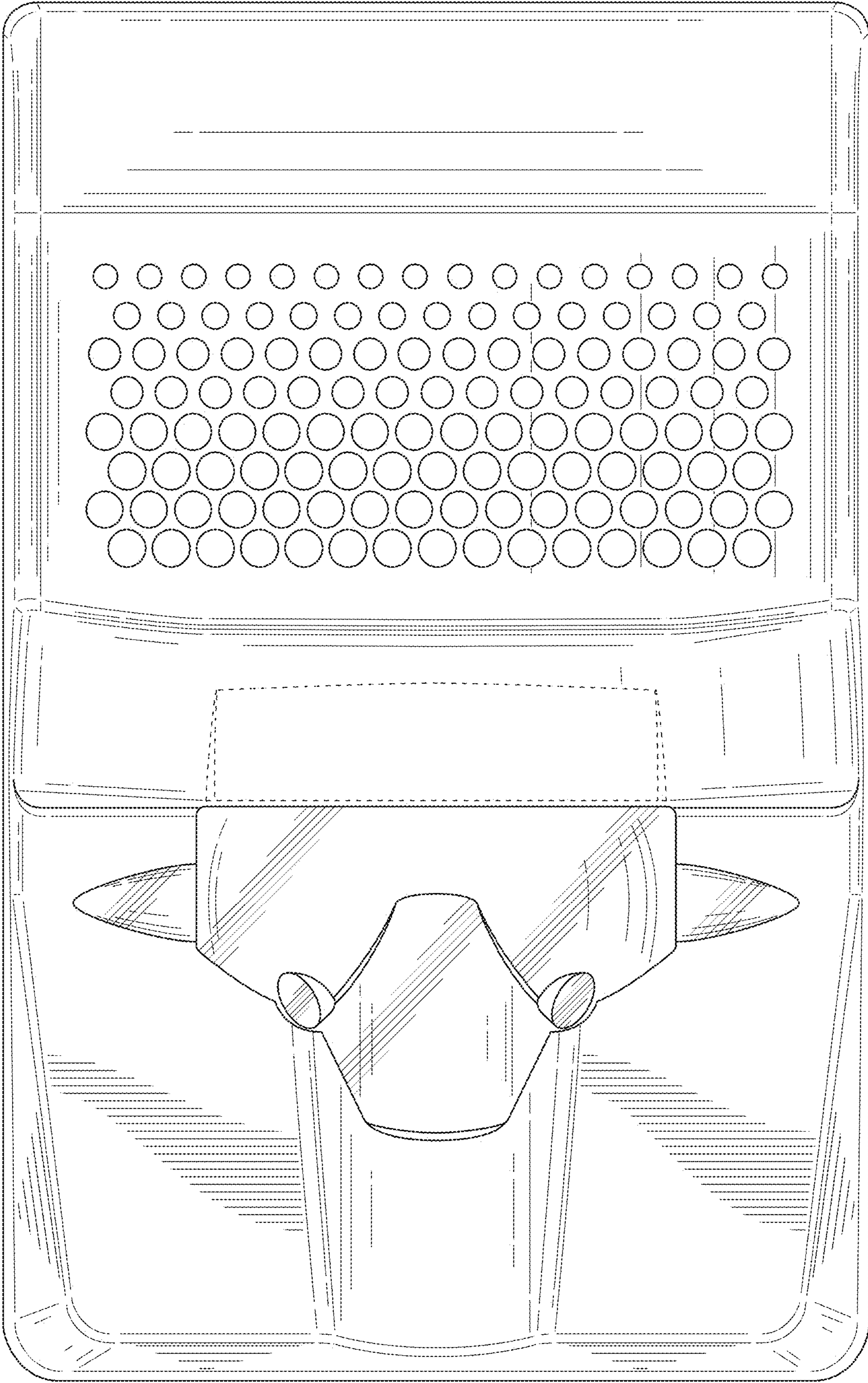

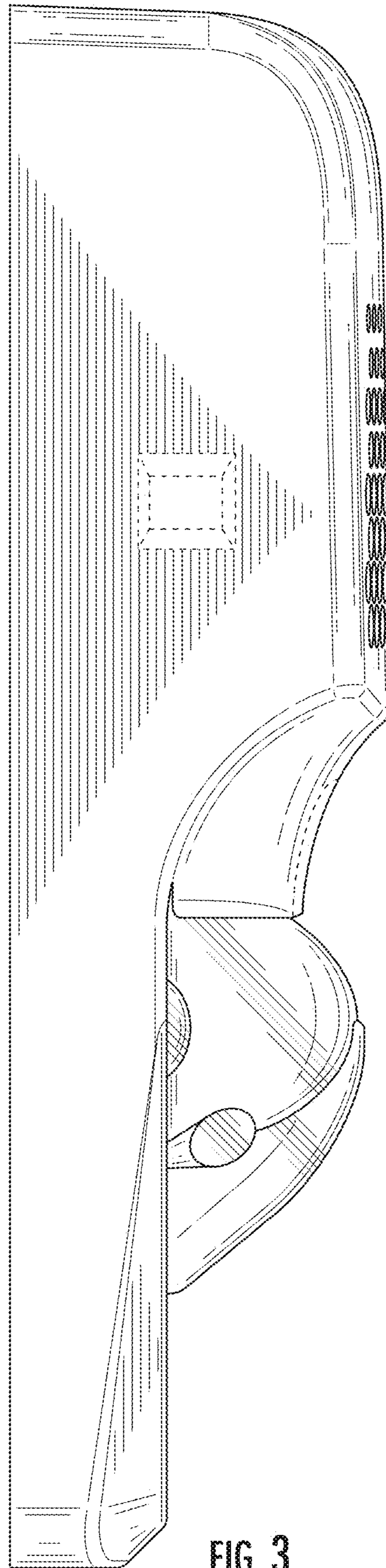

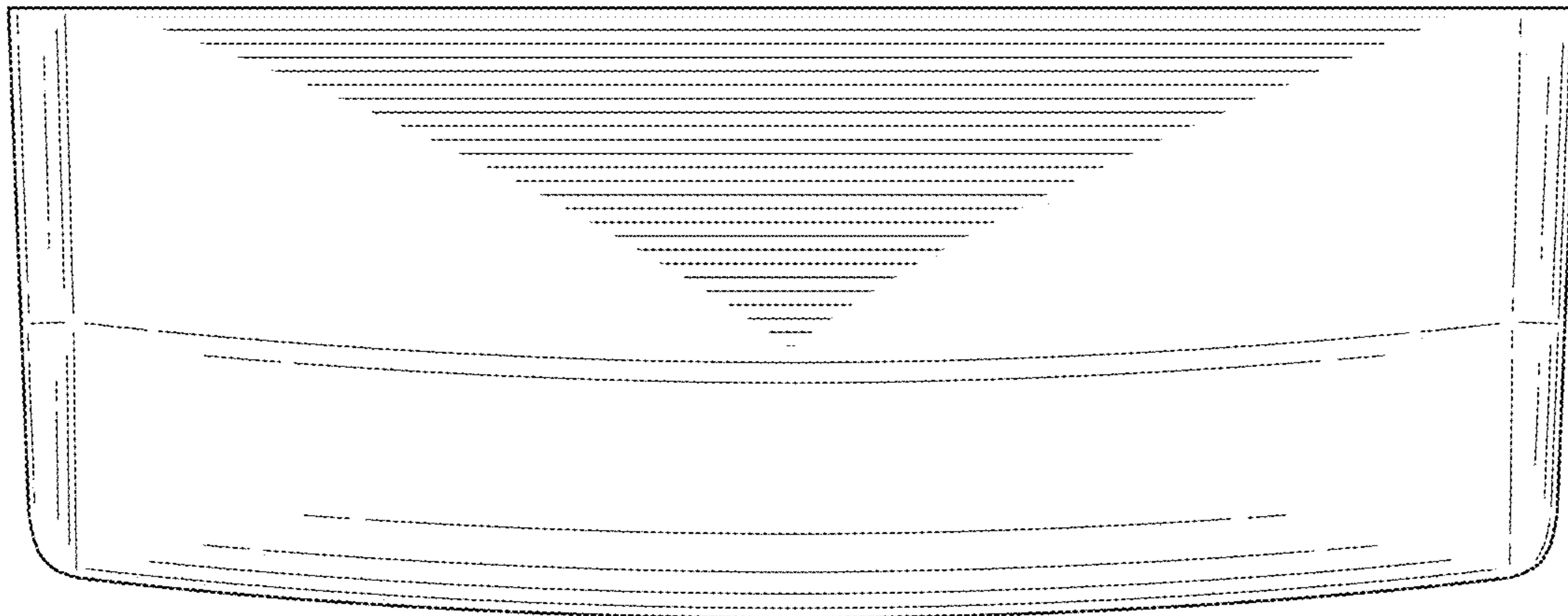

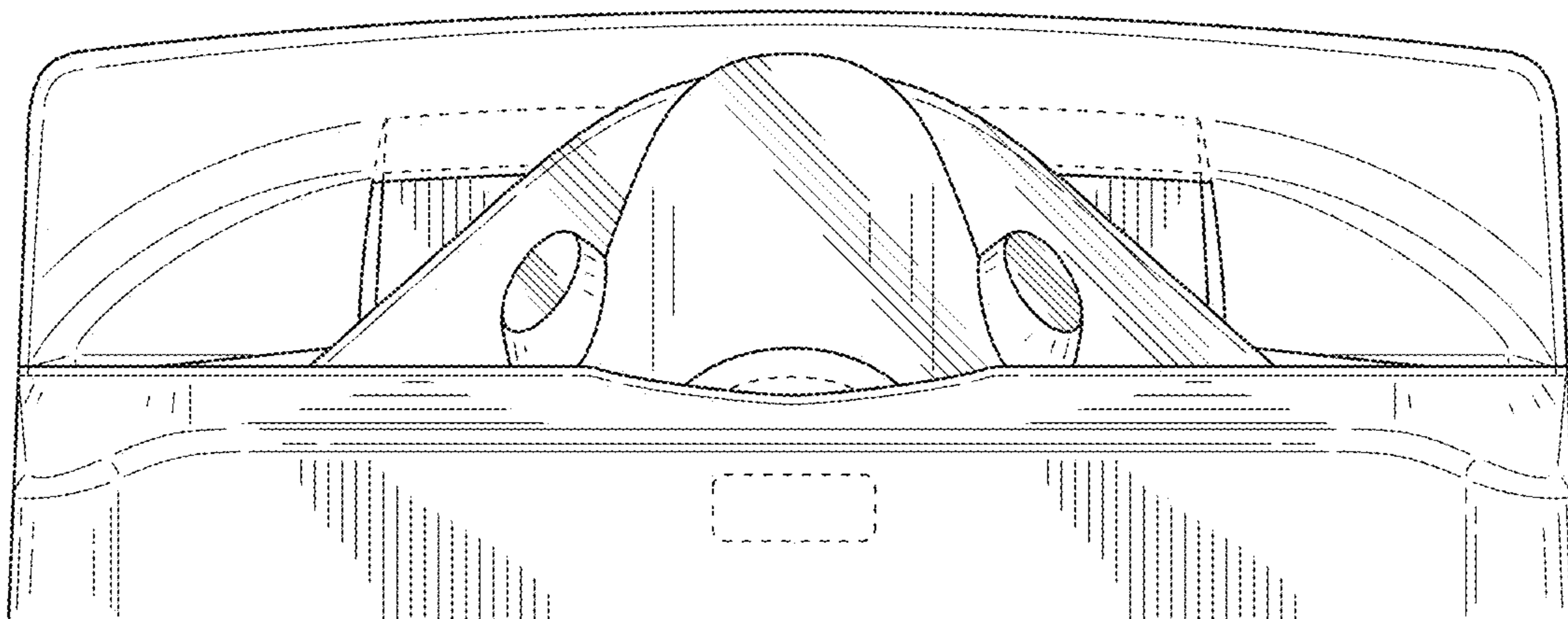

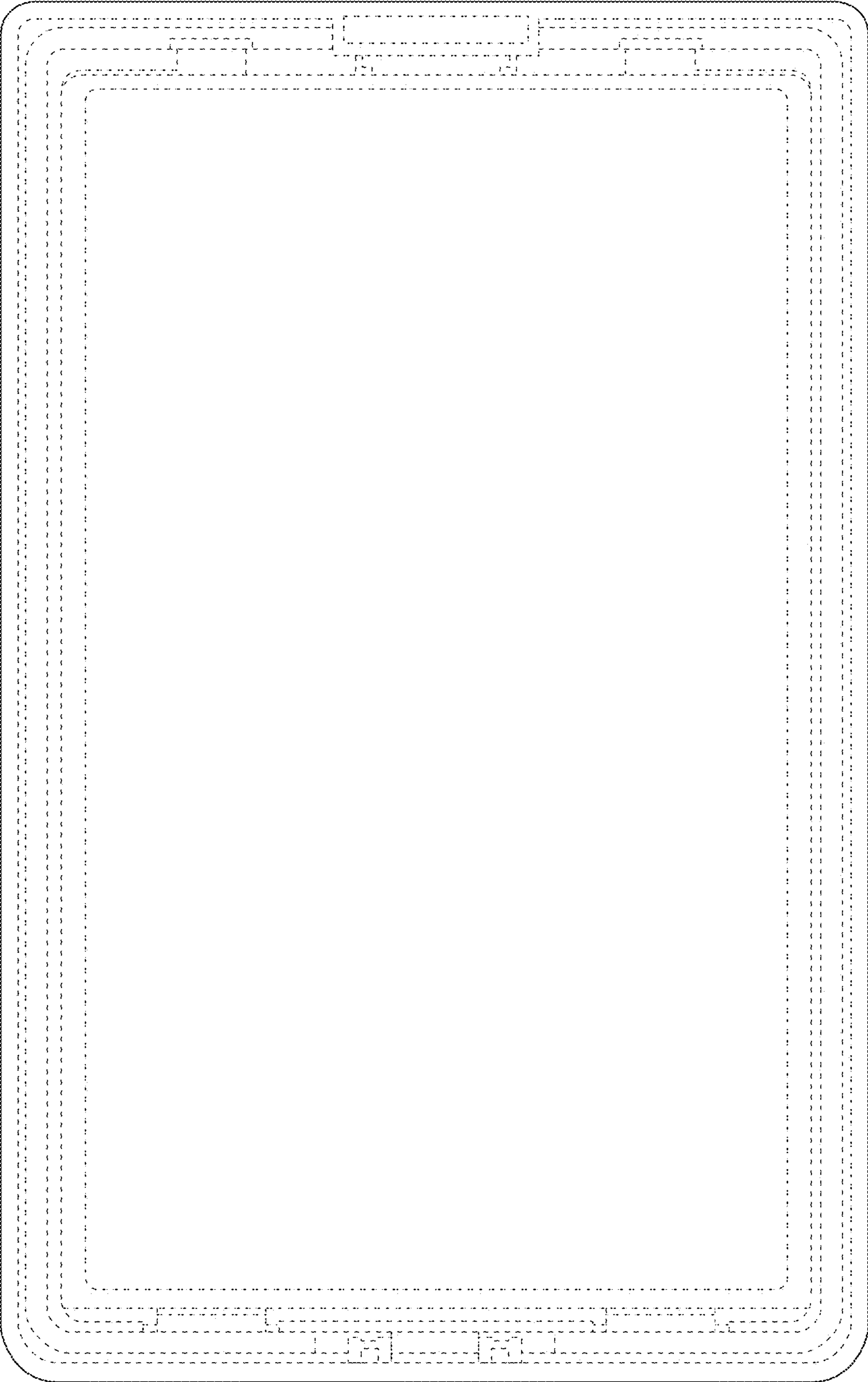
