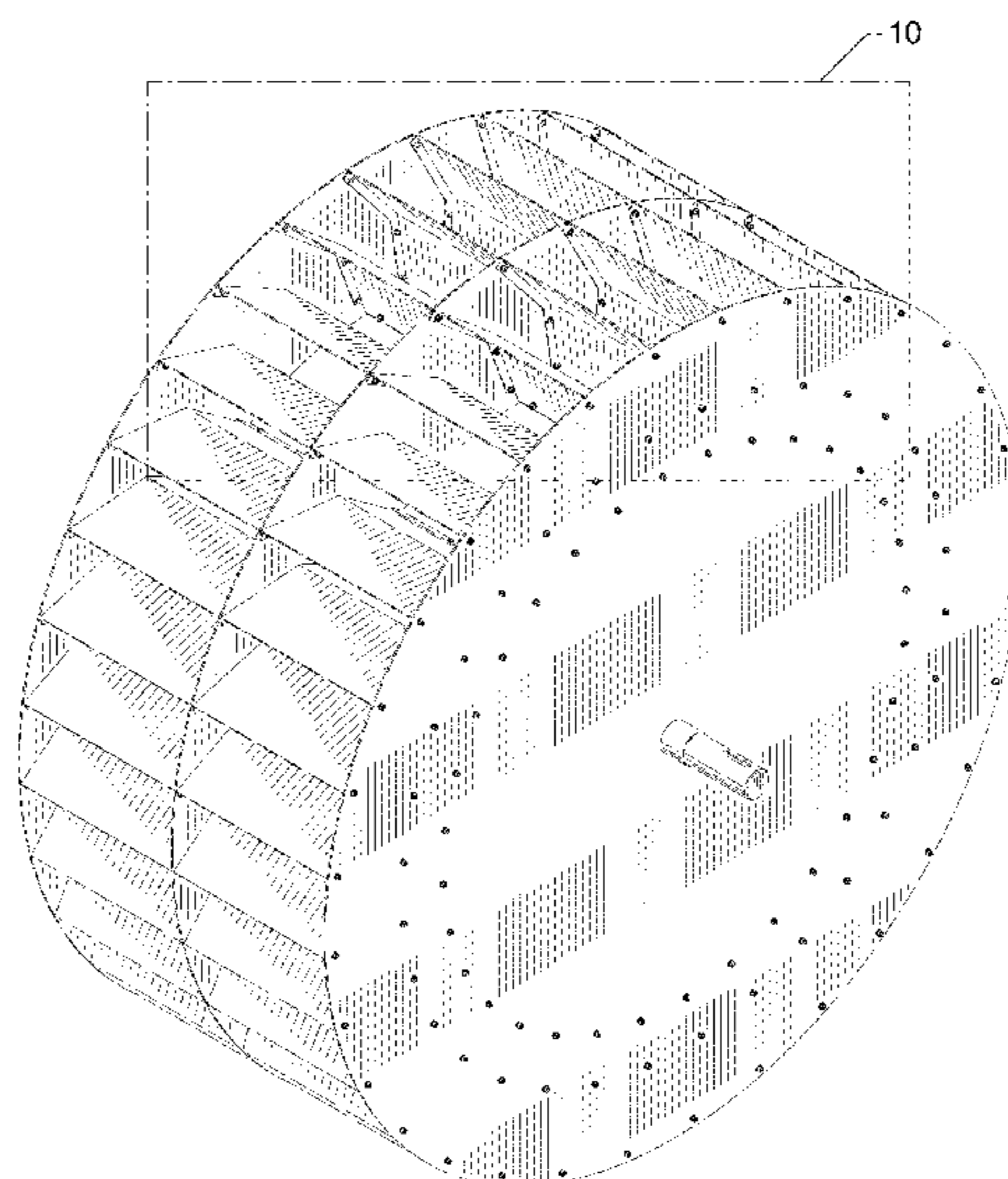
FIG. 1 is a front view of an impeller of waterwheel showing our new design;

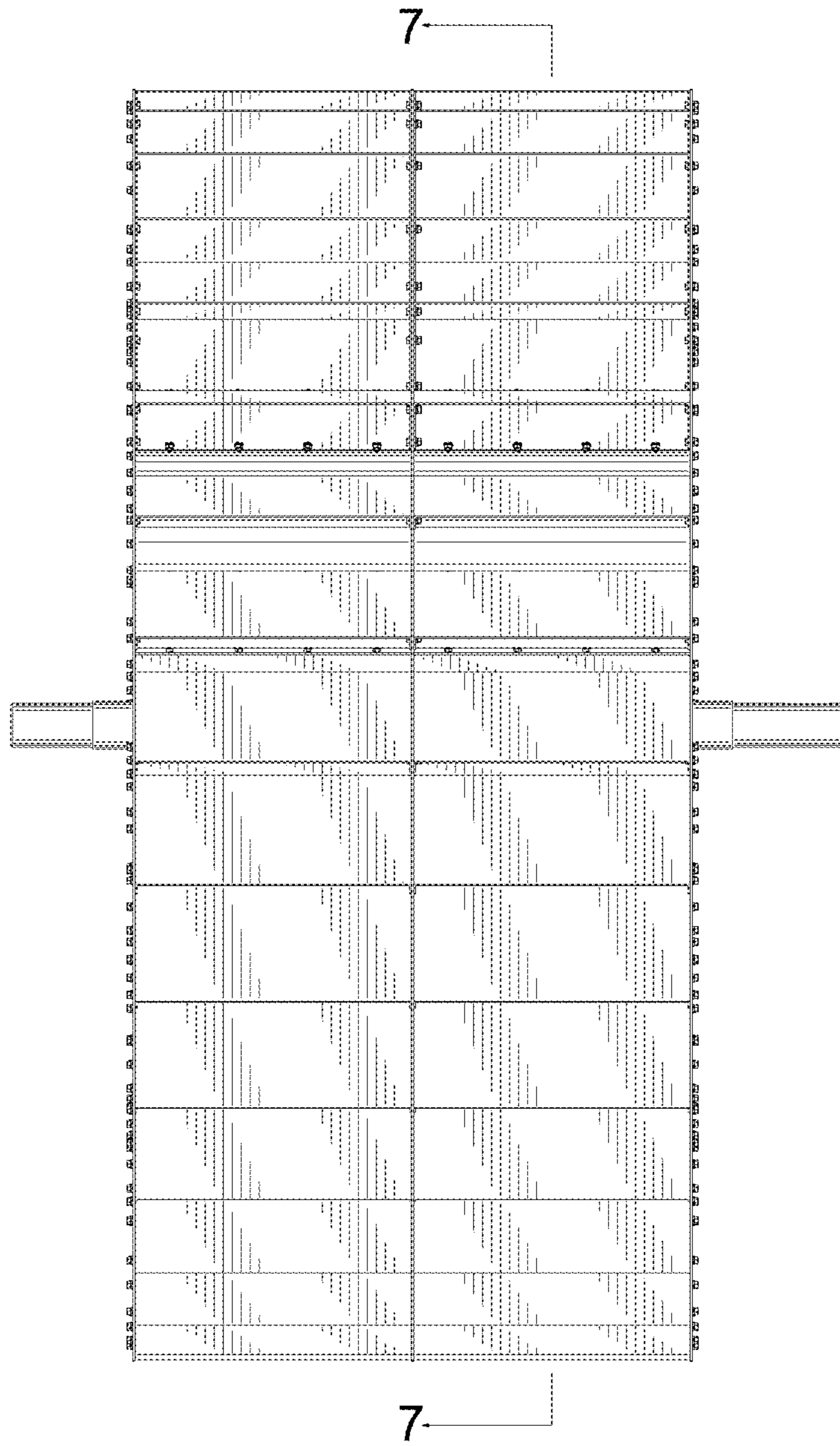

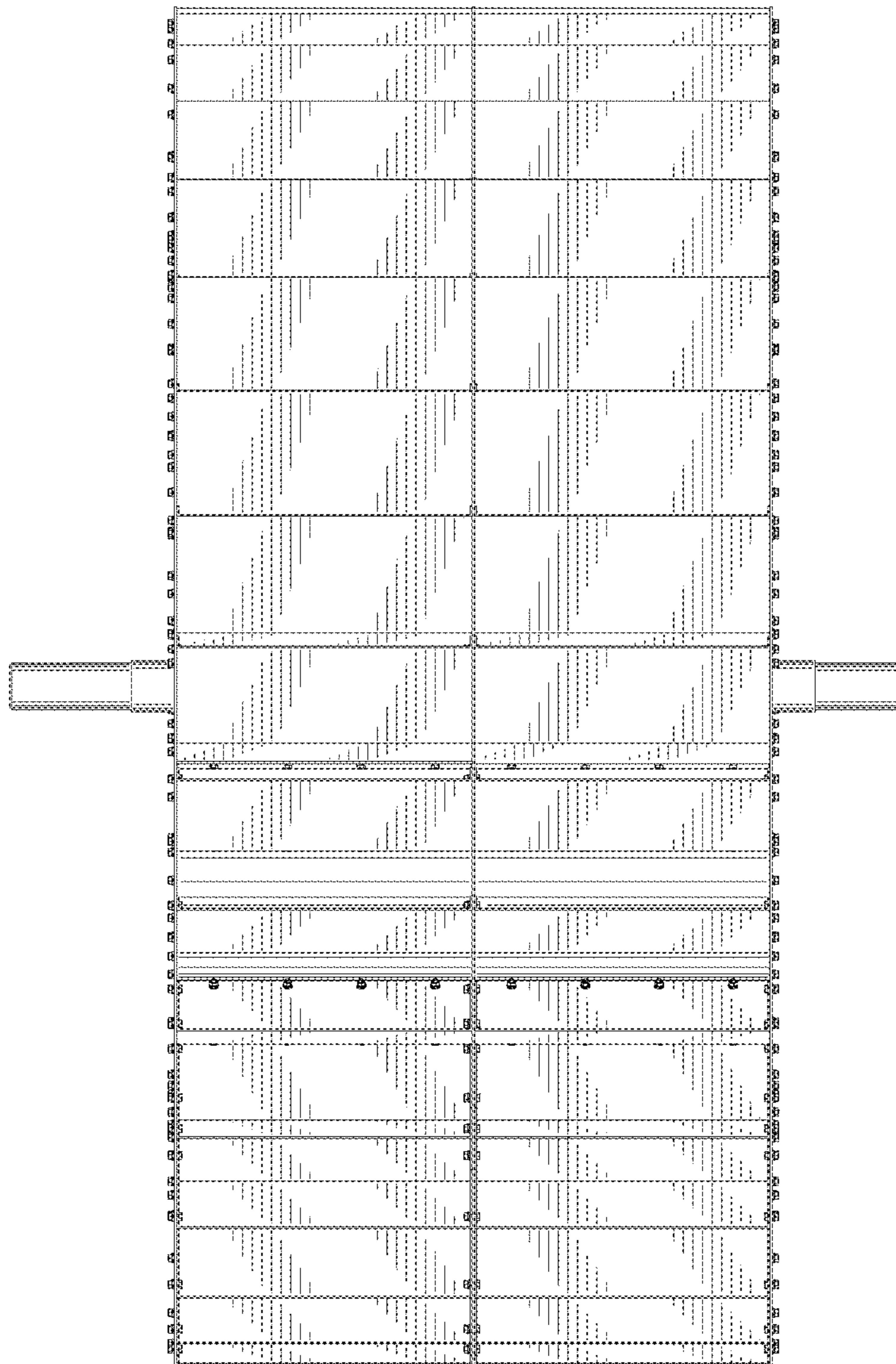

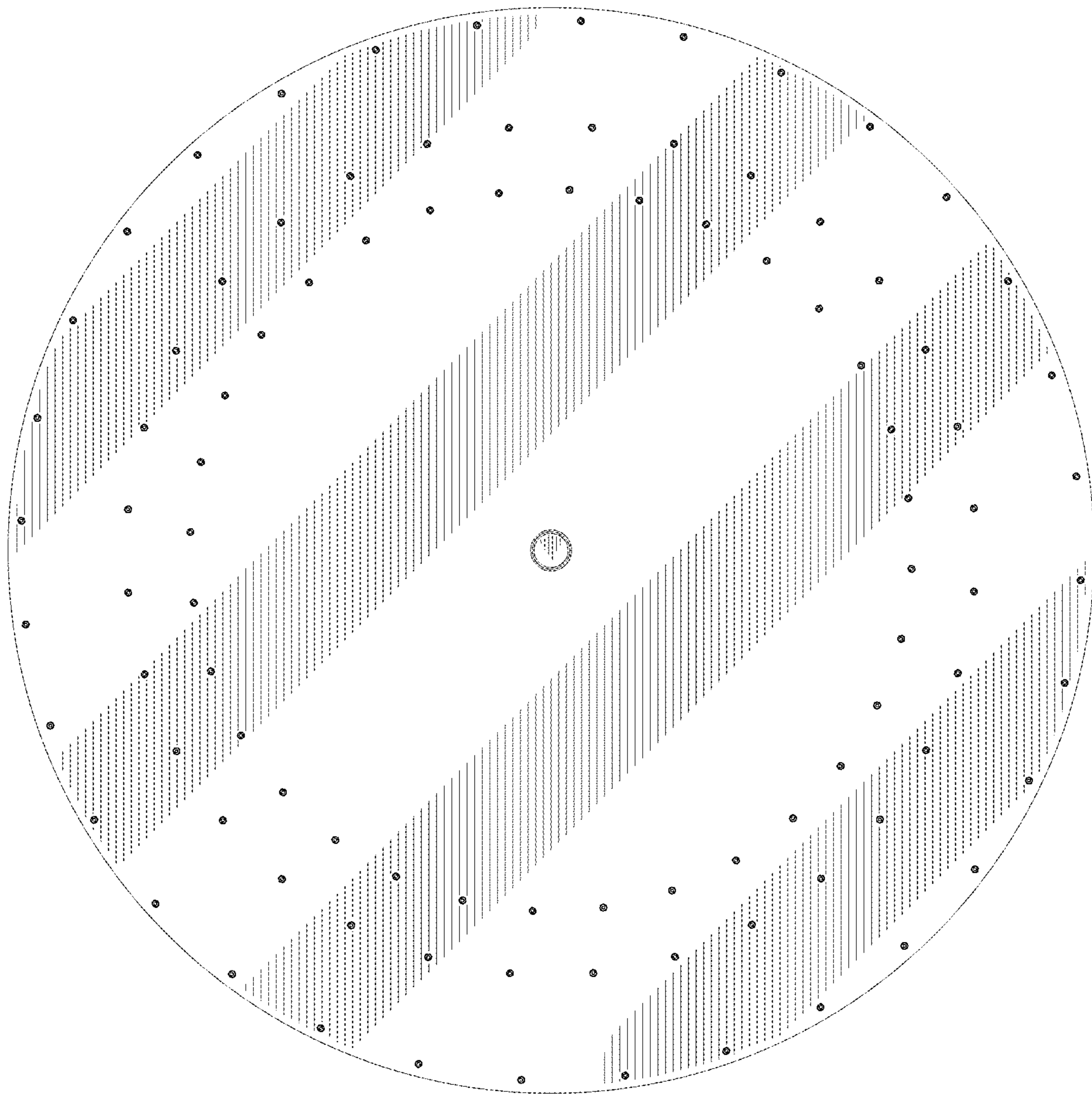

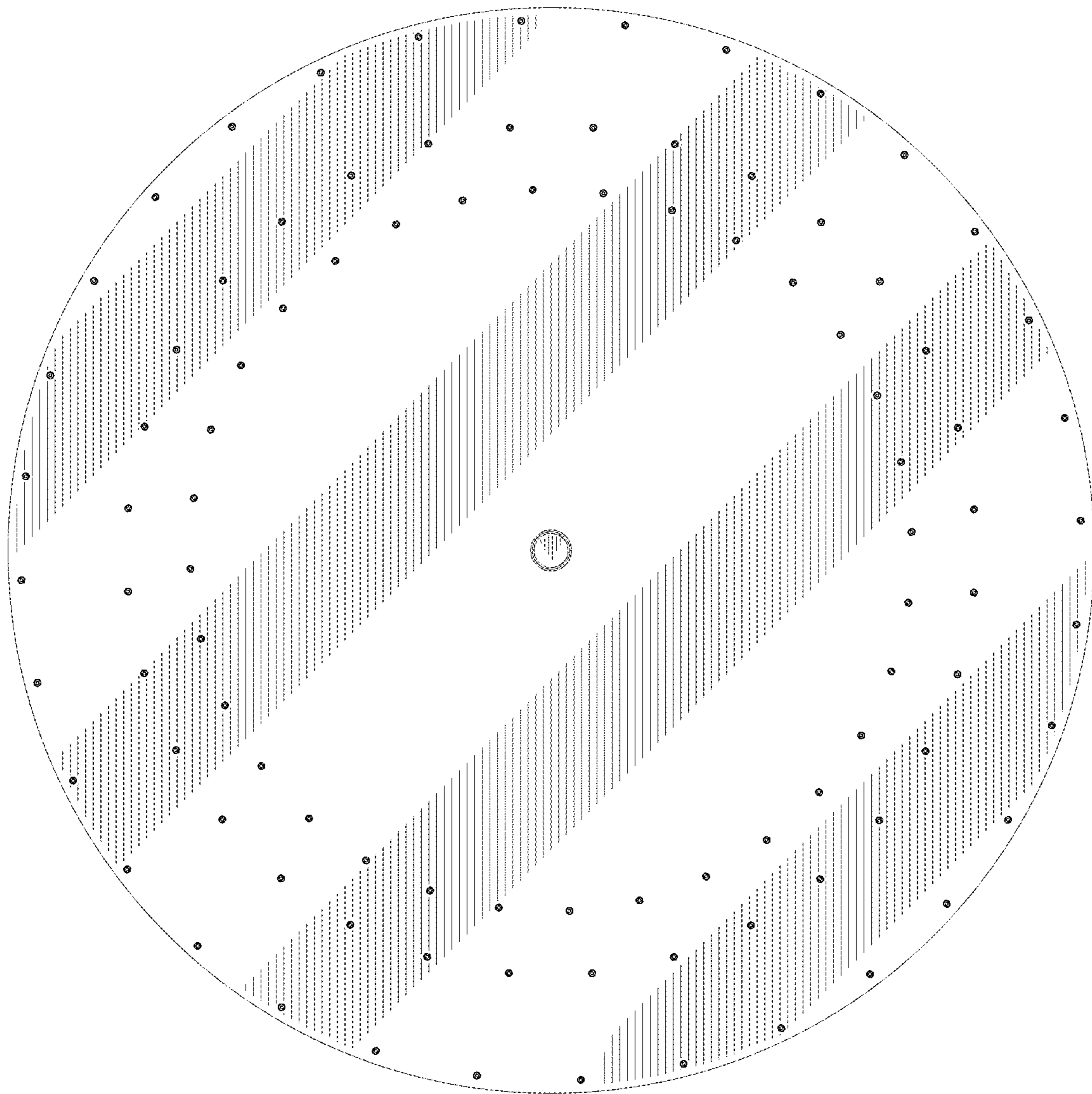

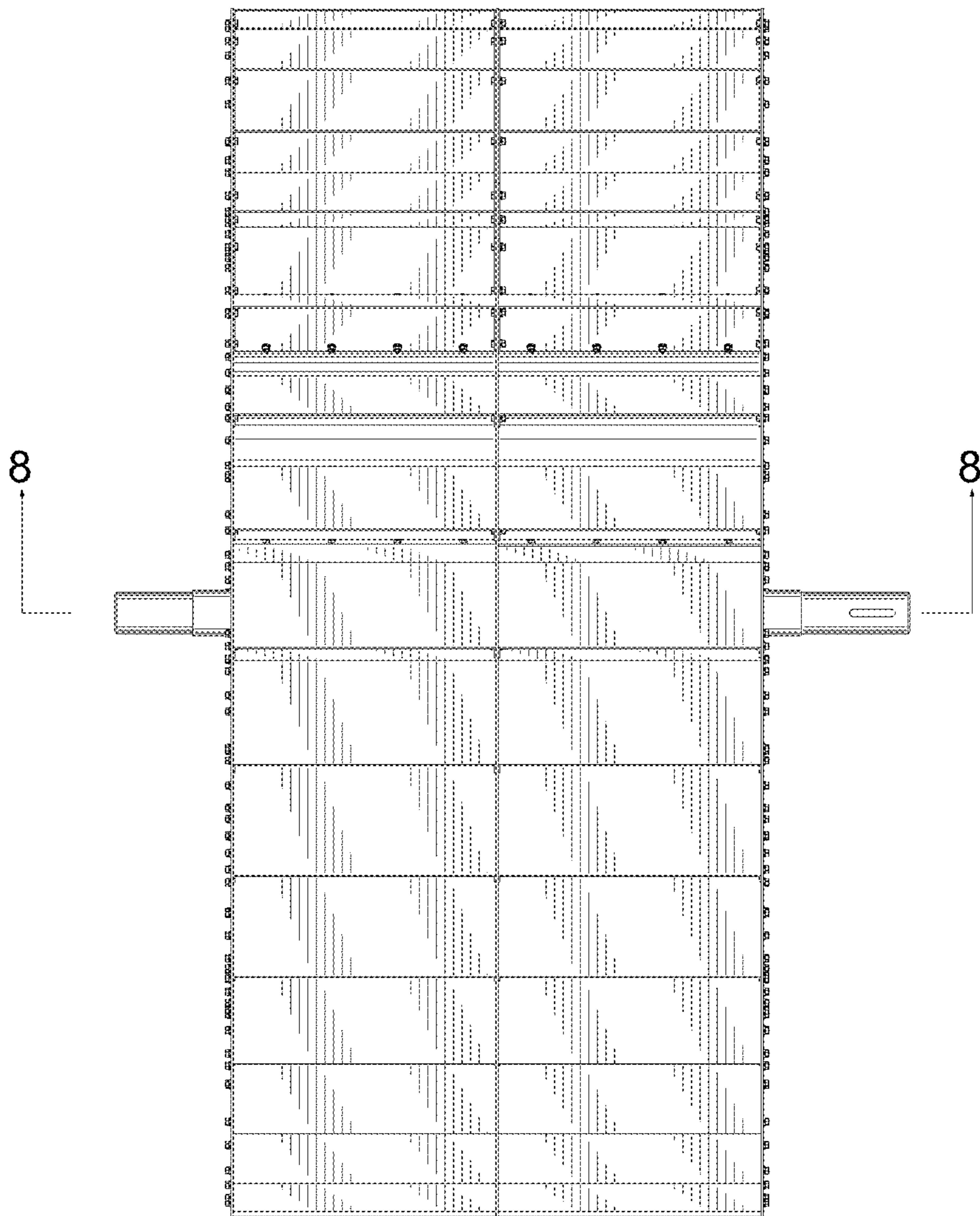

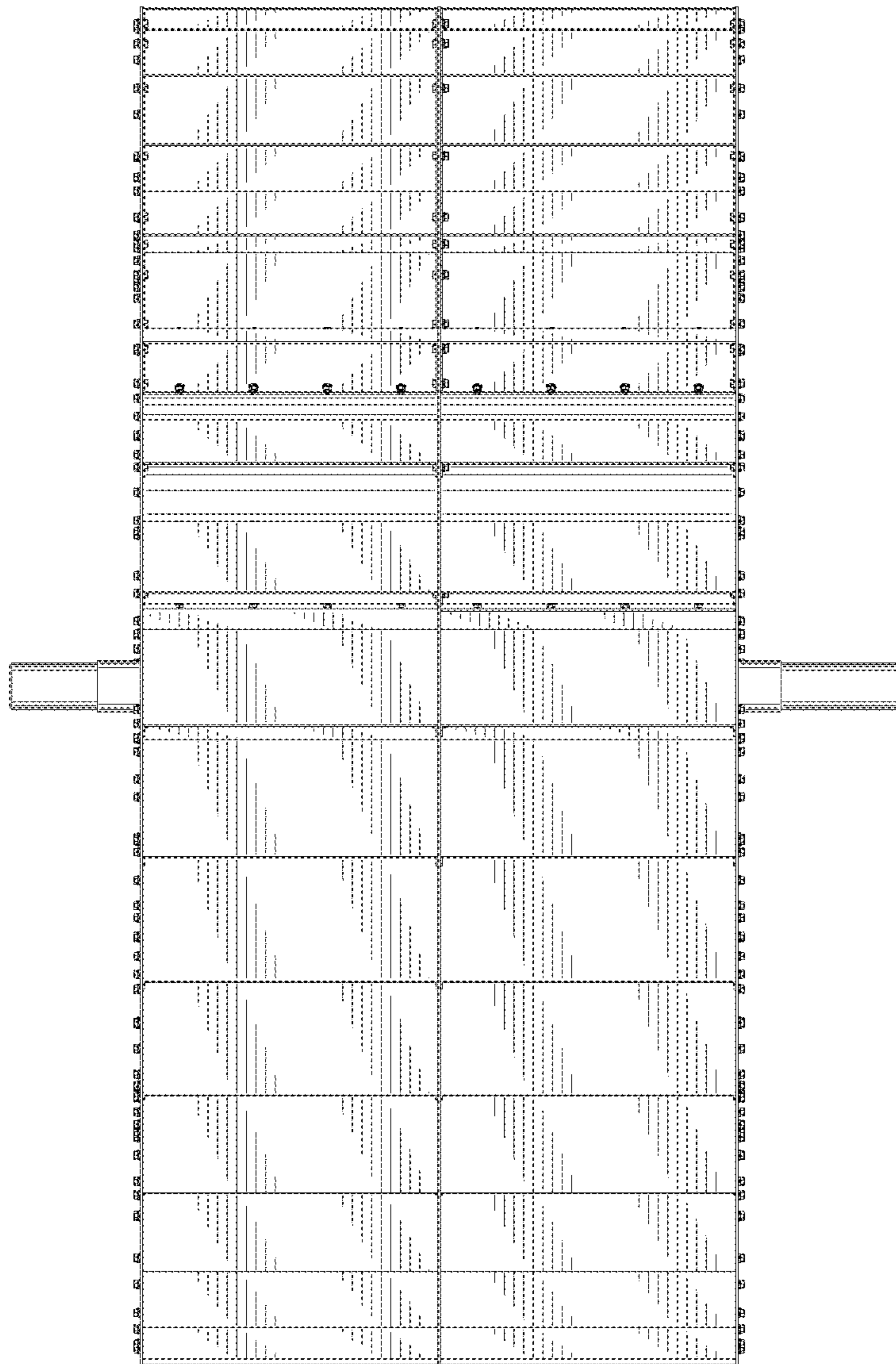

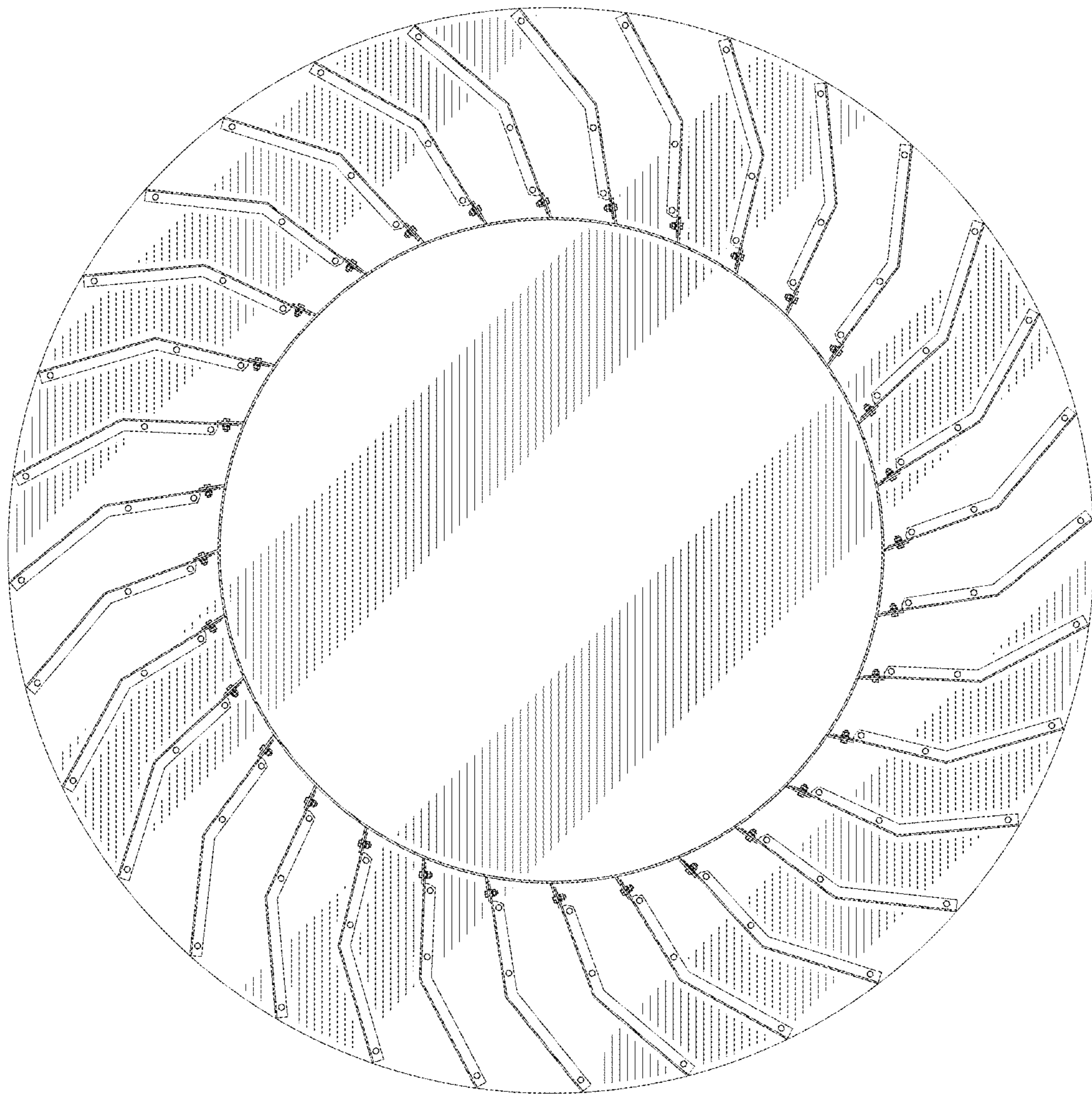

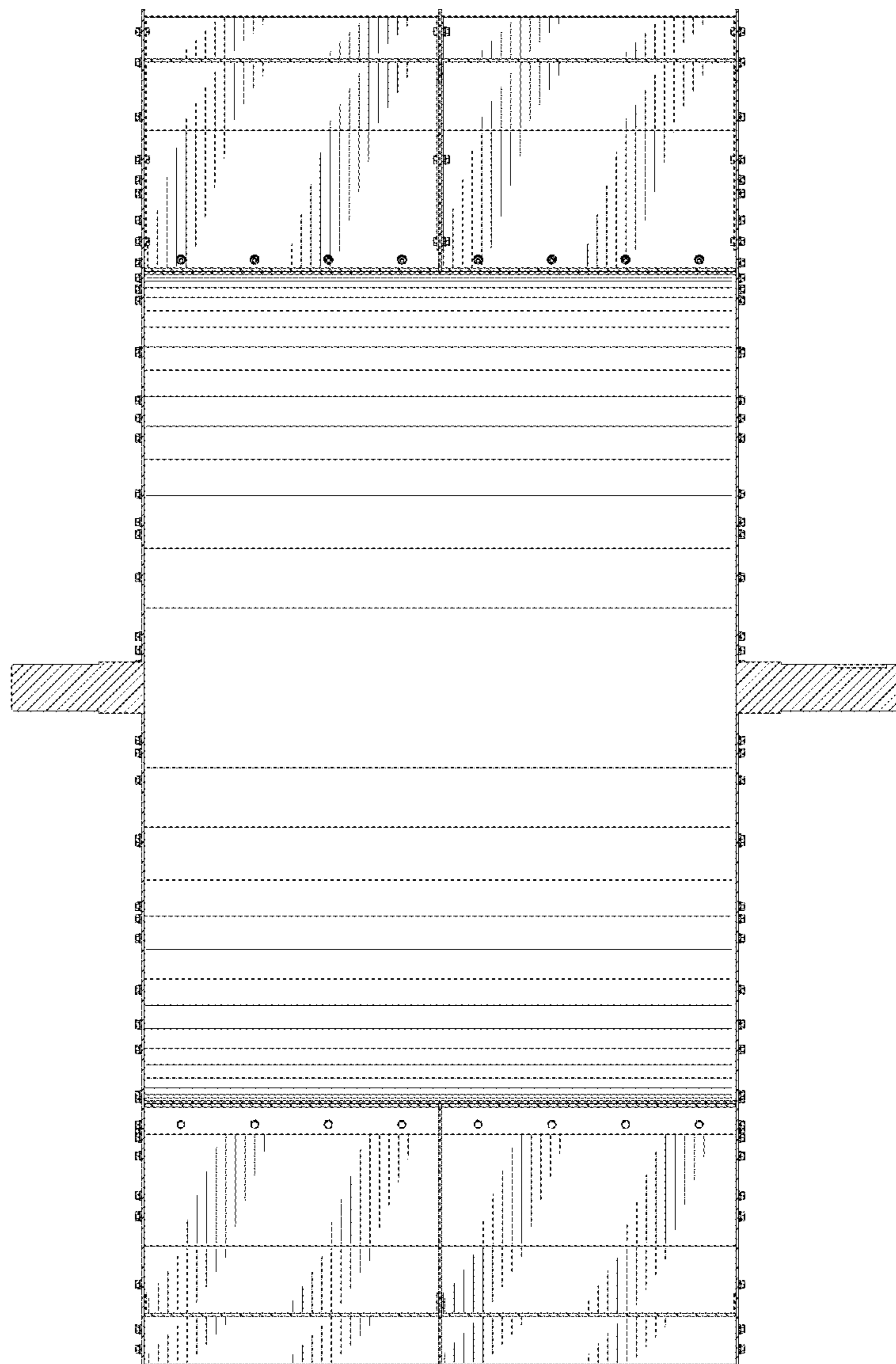

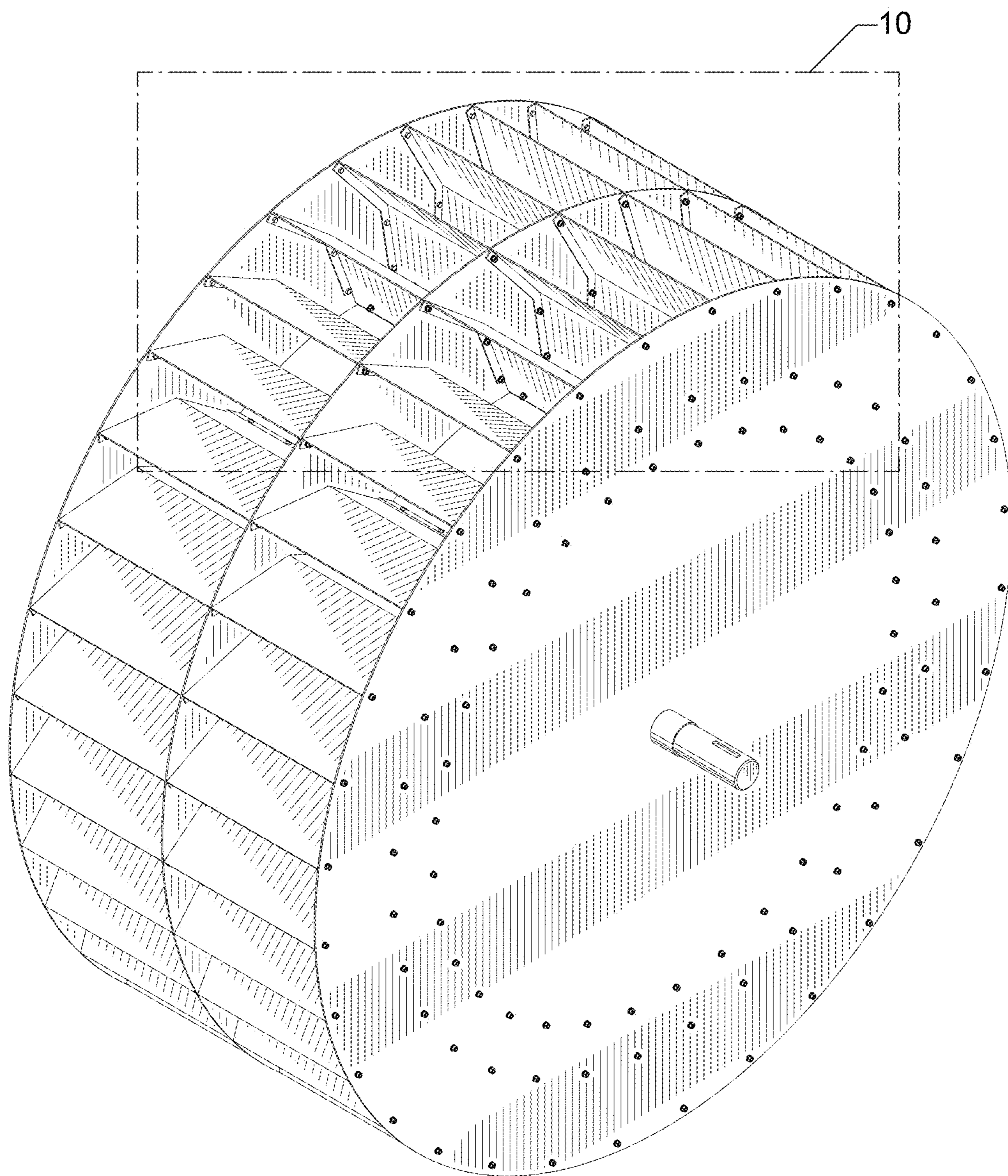

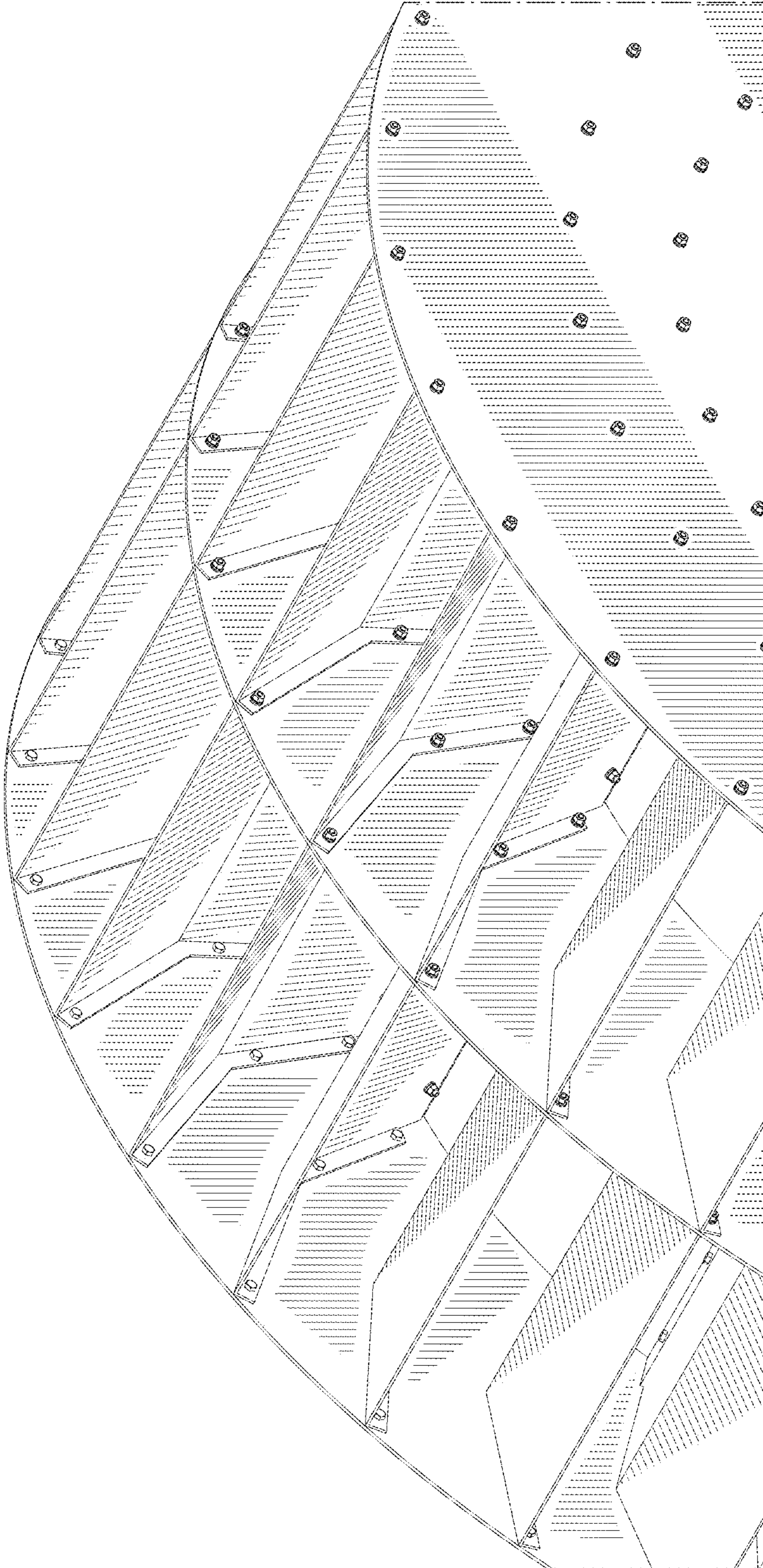
