(57) **CLAIM**

The ornamental design for a phone case, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view showing the top, front, and right sides as well as the inner left interior surface of a phone case;

FIG. 2 is a bottom perspective view showing the bottom, front, and left sides as well as the inner right interior surface of the phone case;

FIG. 3 is a further bottom perspective view showing the bottom, front, and right sides as well as the inner left interior surface of the phone case;

FIG. 4 is a further bottom perspective view showing the bottom, left, and back sides of the phone case;

FIG. 5 is a front elevation view of the phone case;

FIG. 6 is a rear elevation view of the phone case;

FIG. 7 is a left side elevation view of the phone case;

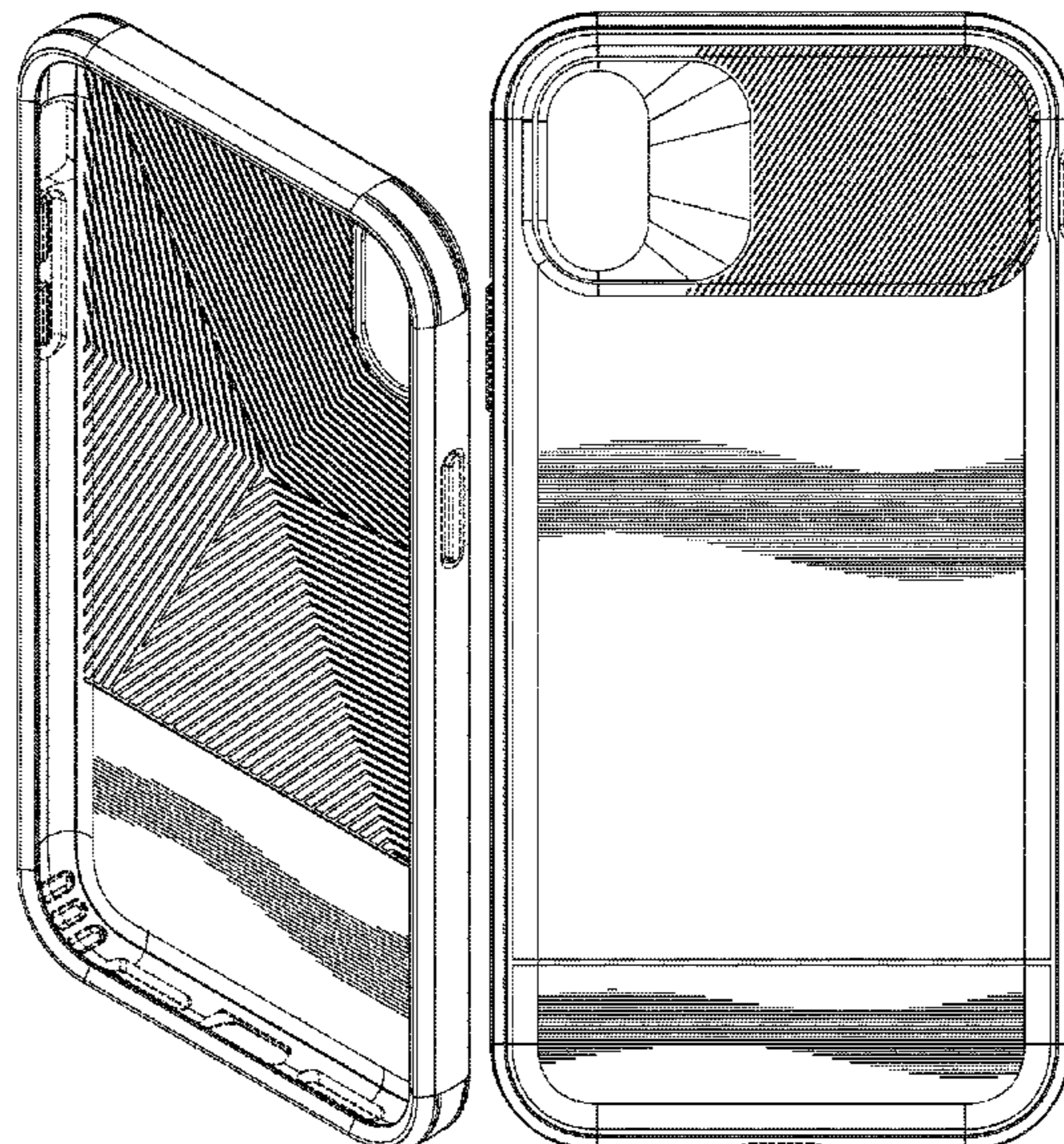
FIG. 8 is a right side elevation view of the phone case;

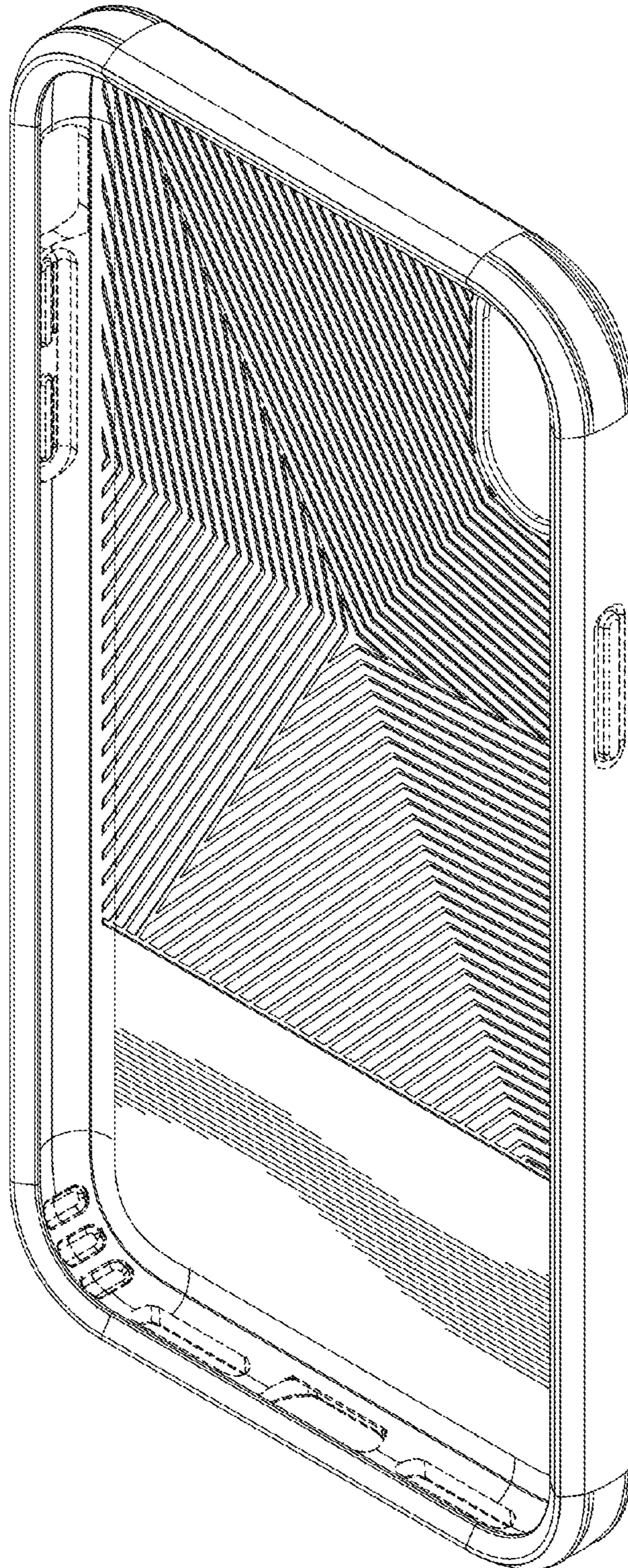

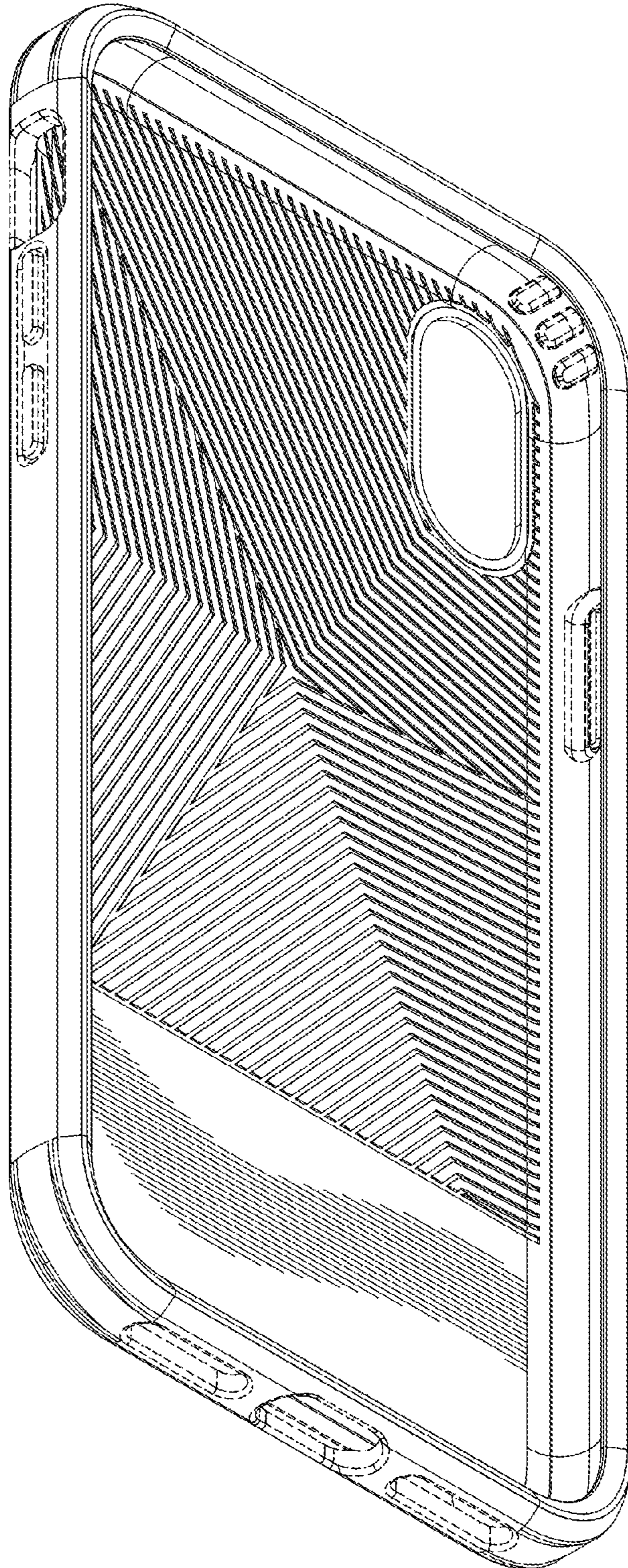

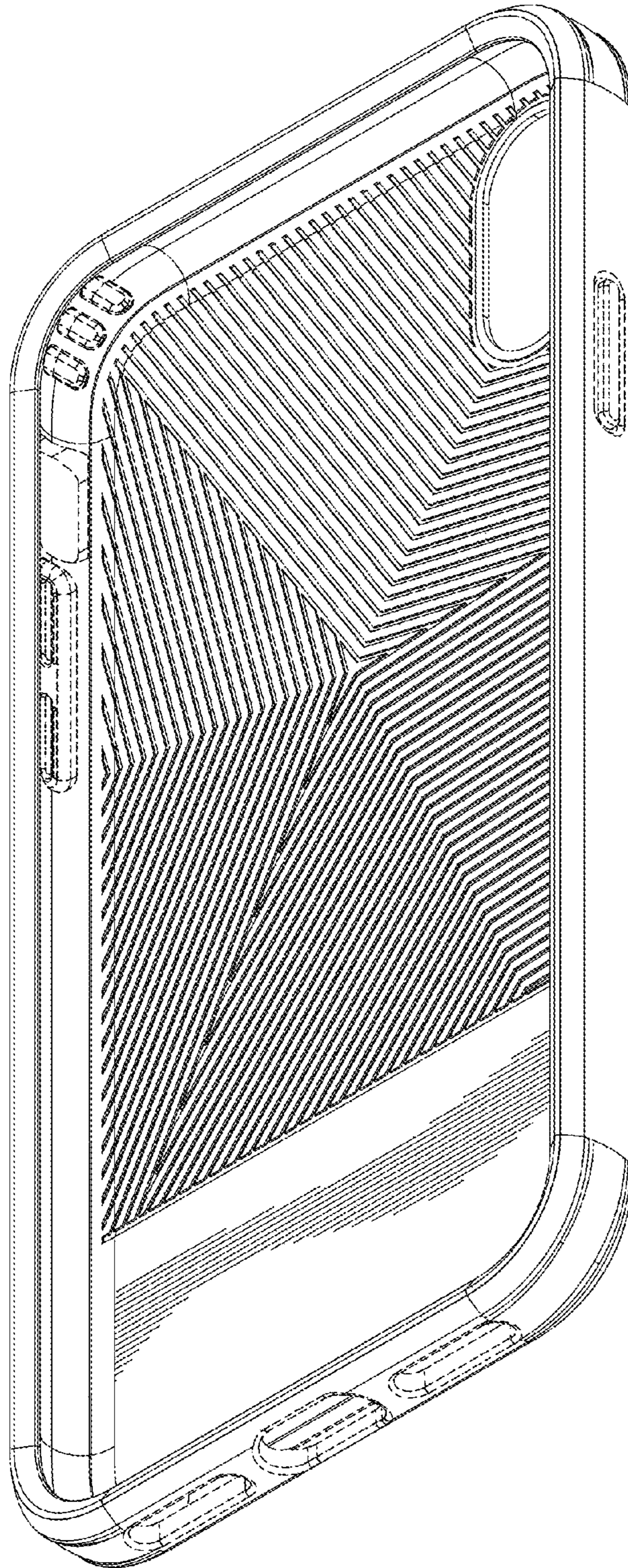

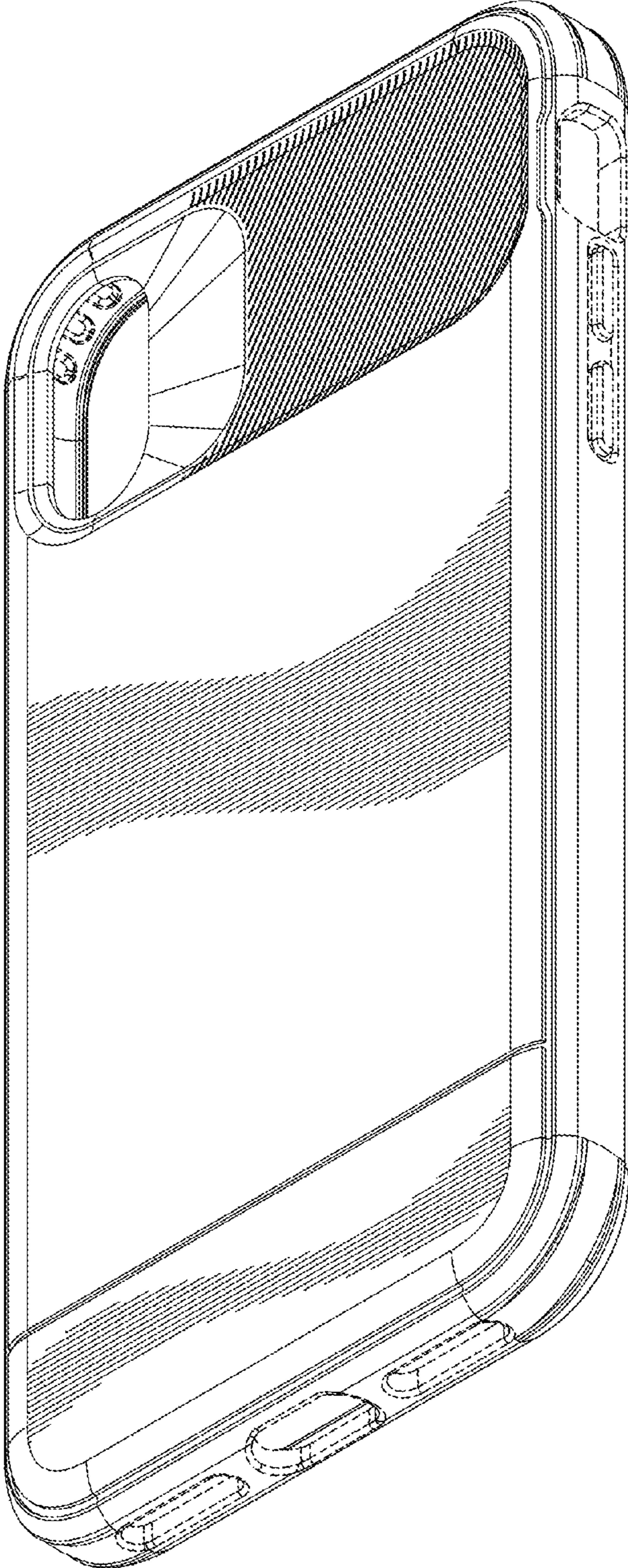

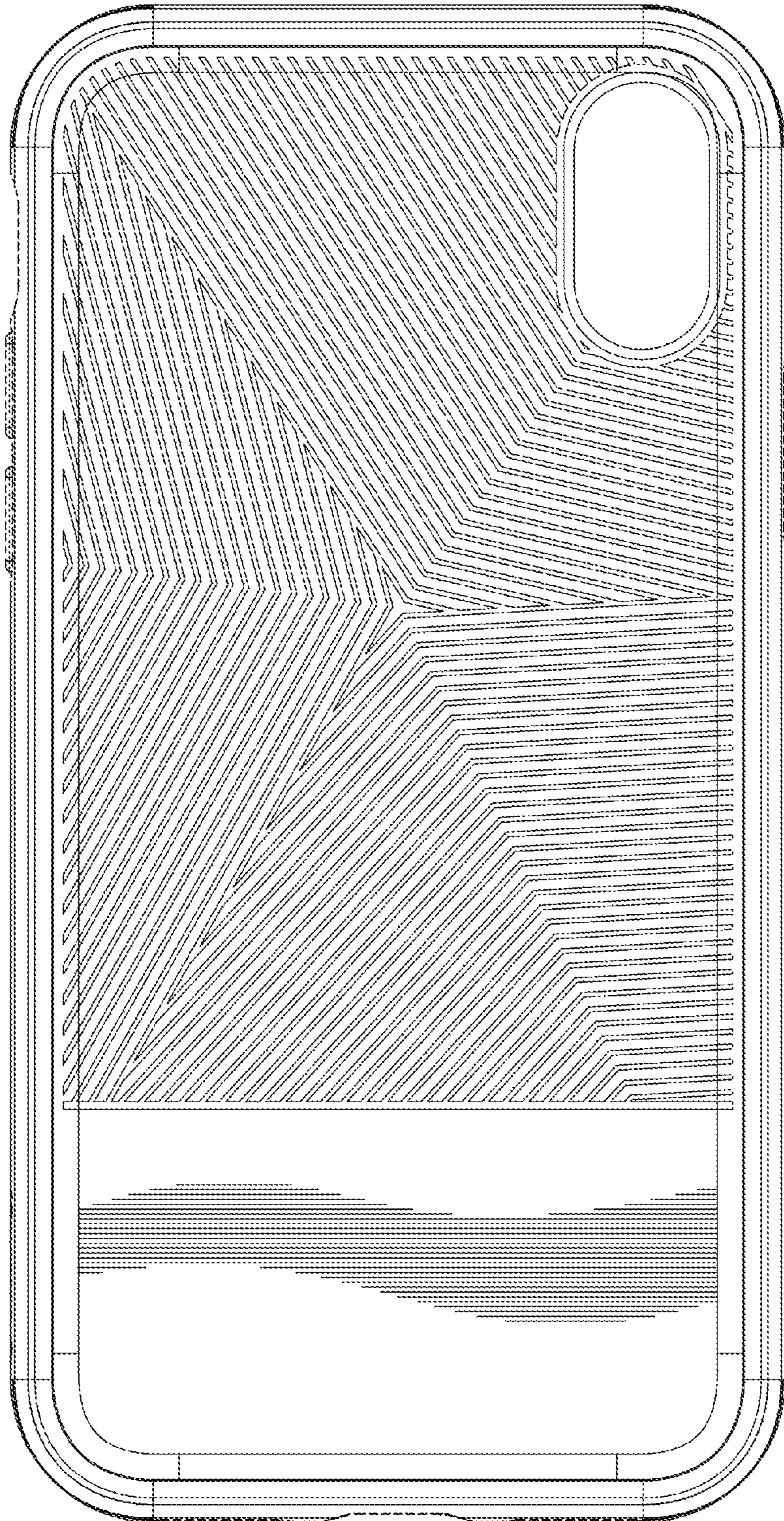

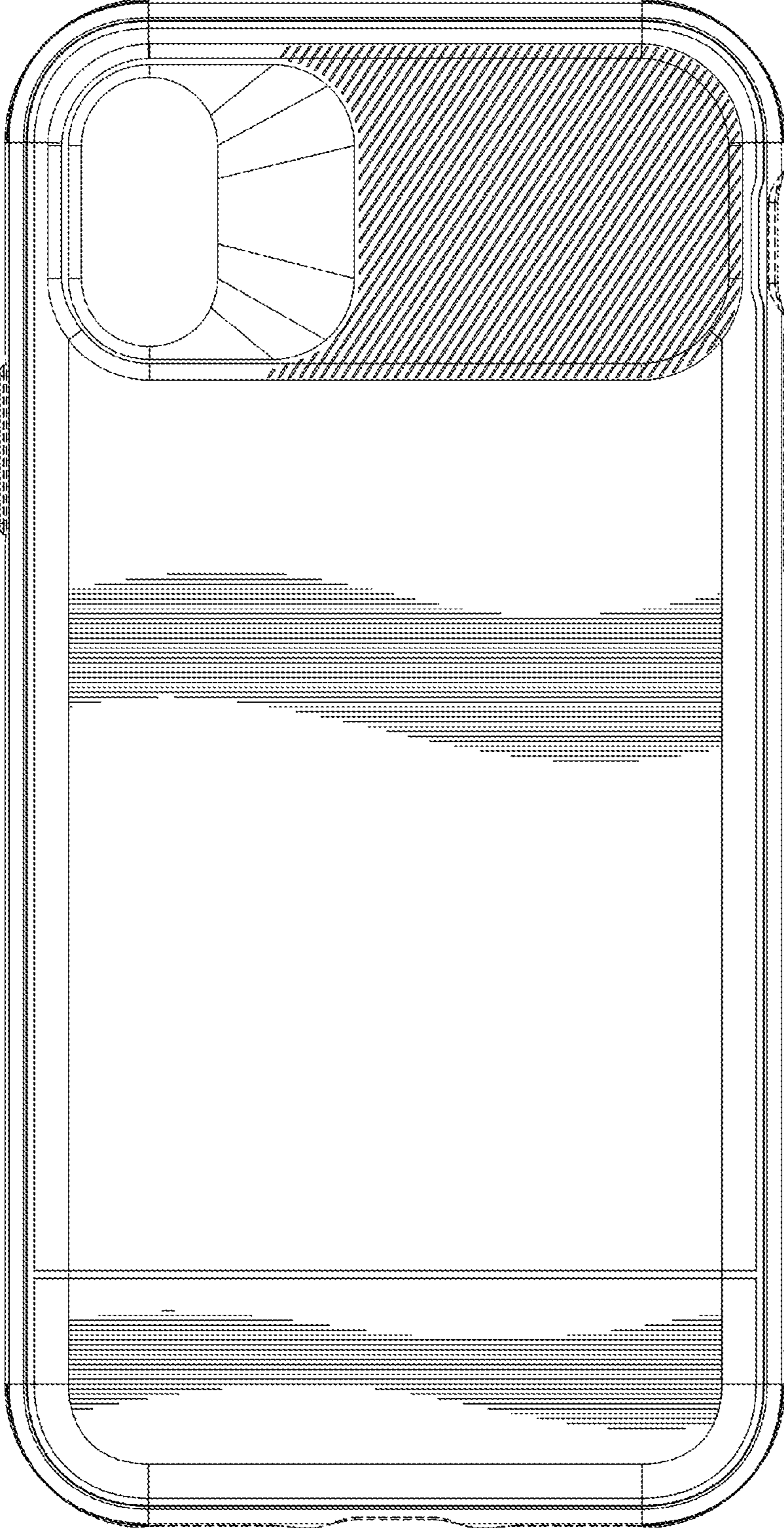

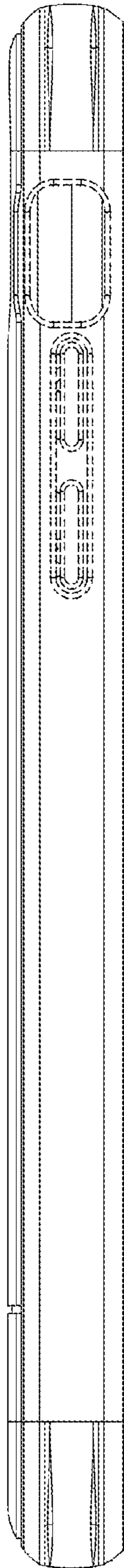

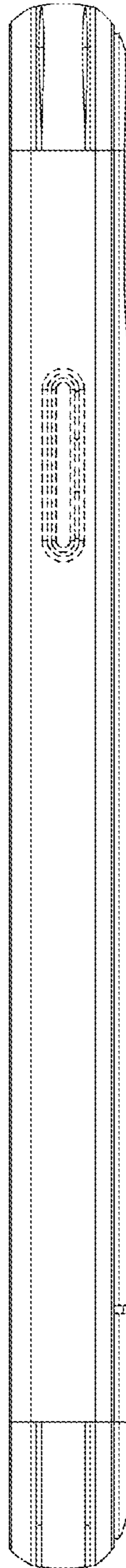

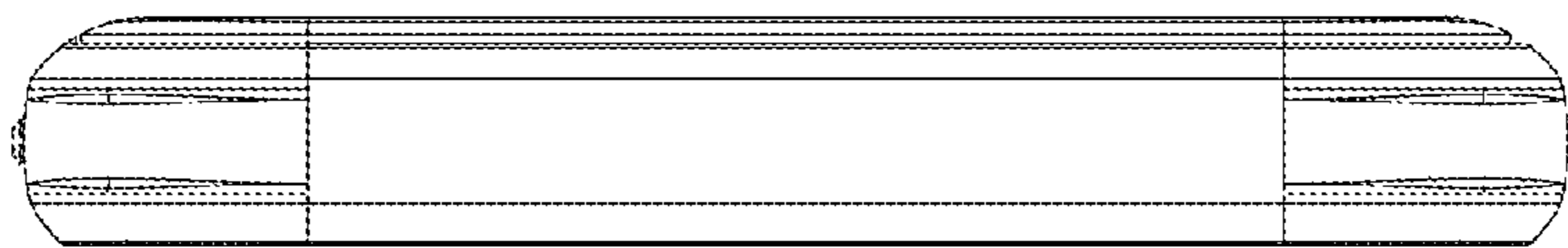
