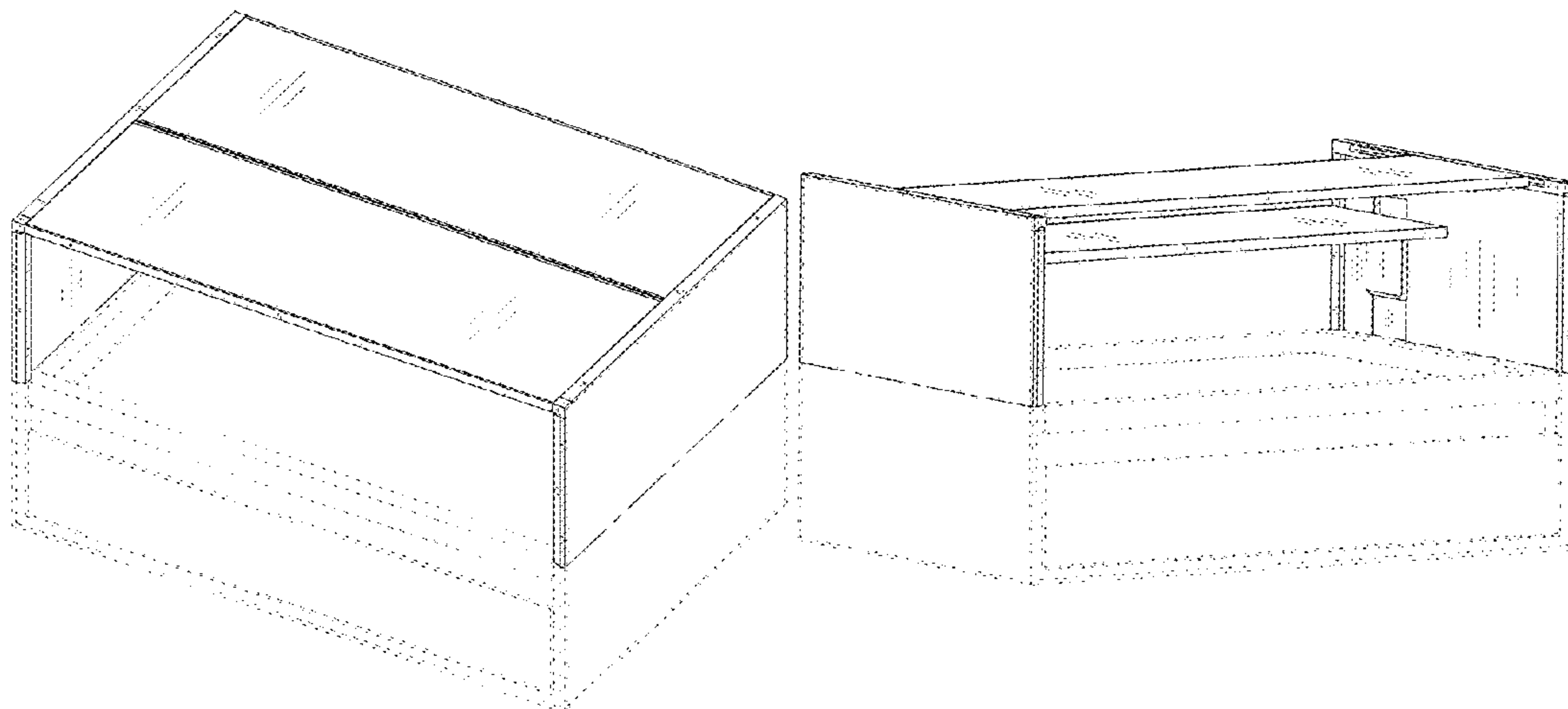
(57) **CLAIM**

We claim the ornamental design for a shelf for refrigerator,
as shown and described.

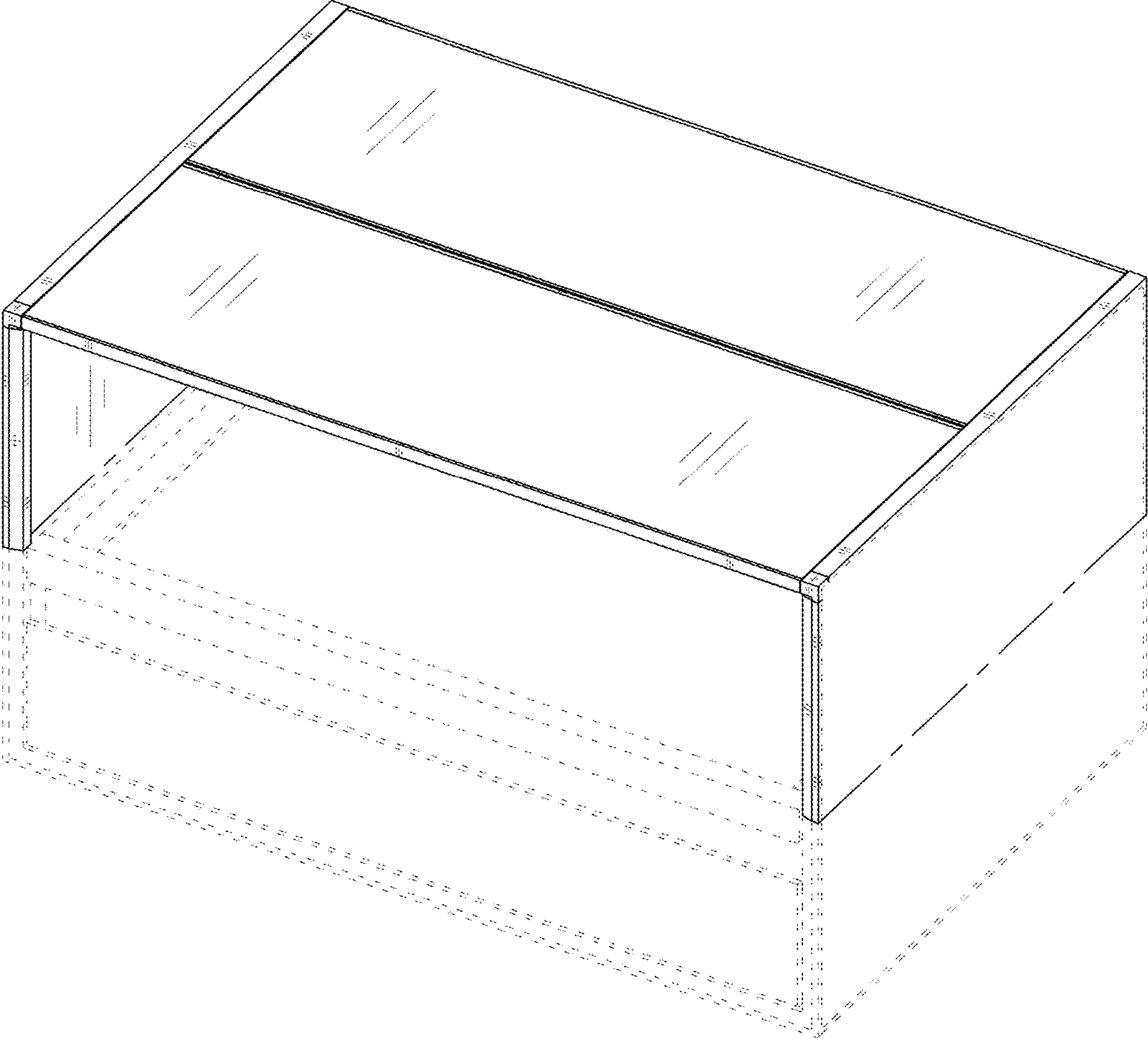

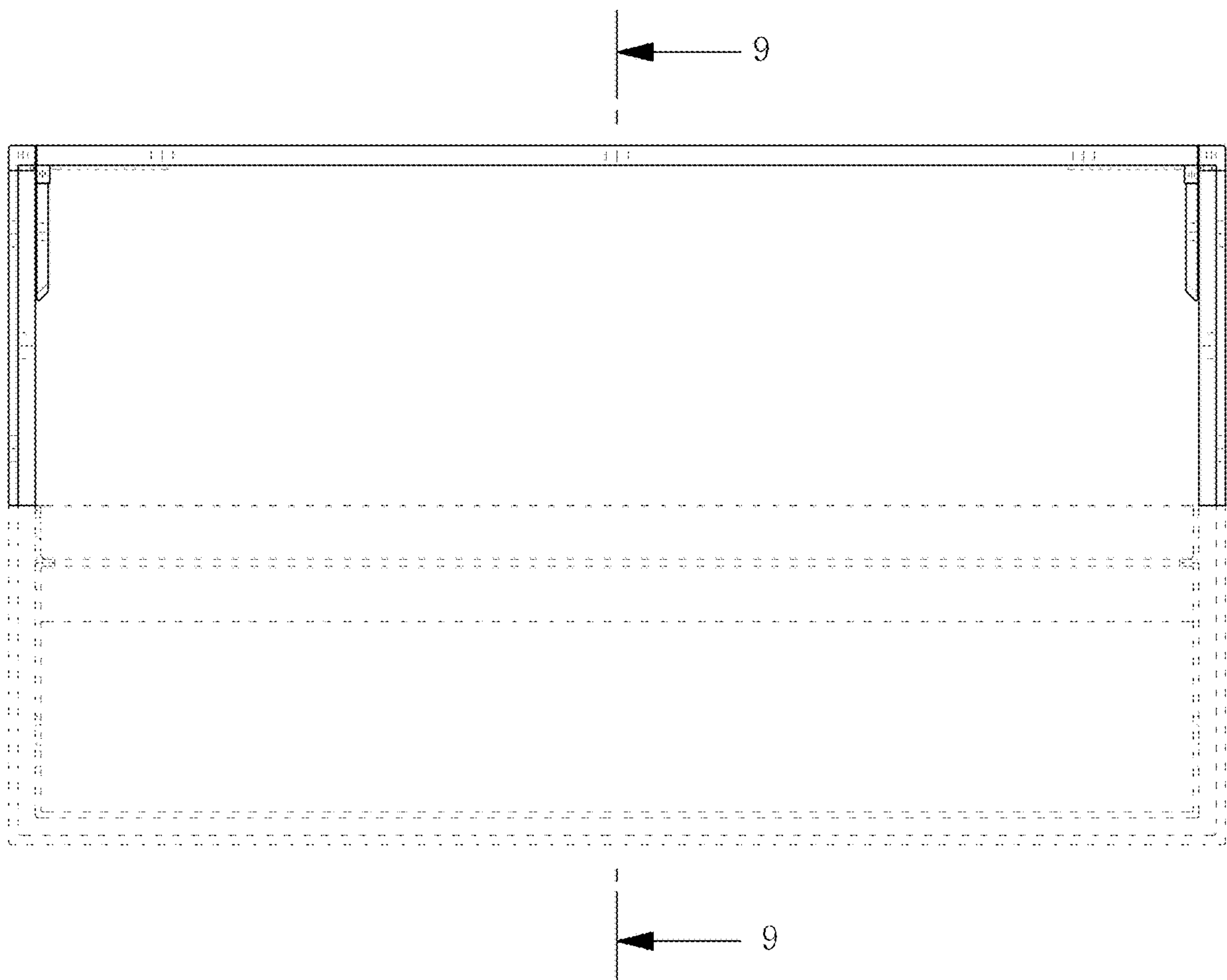

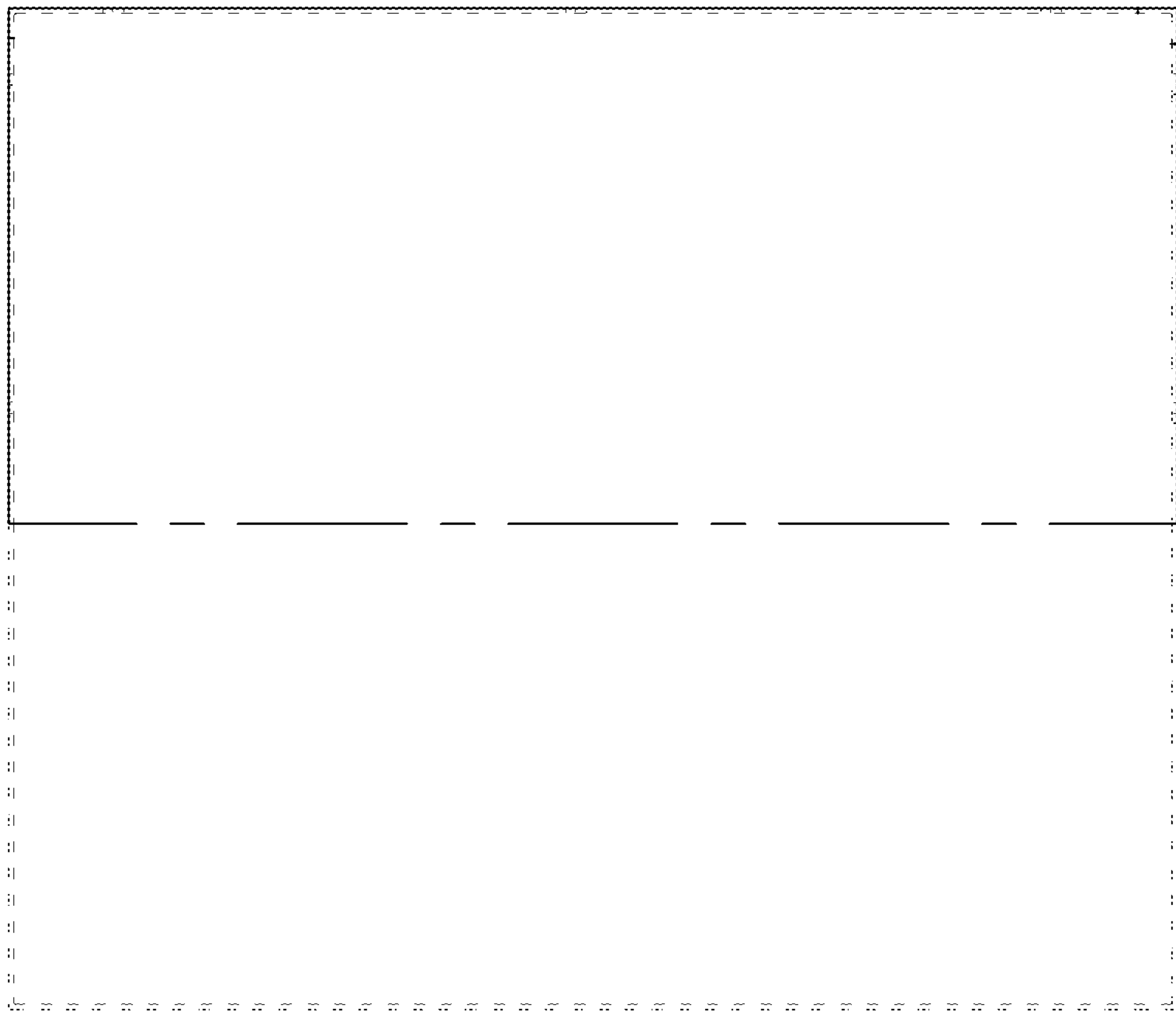

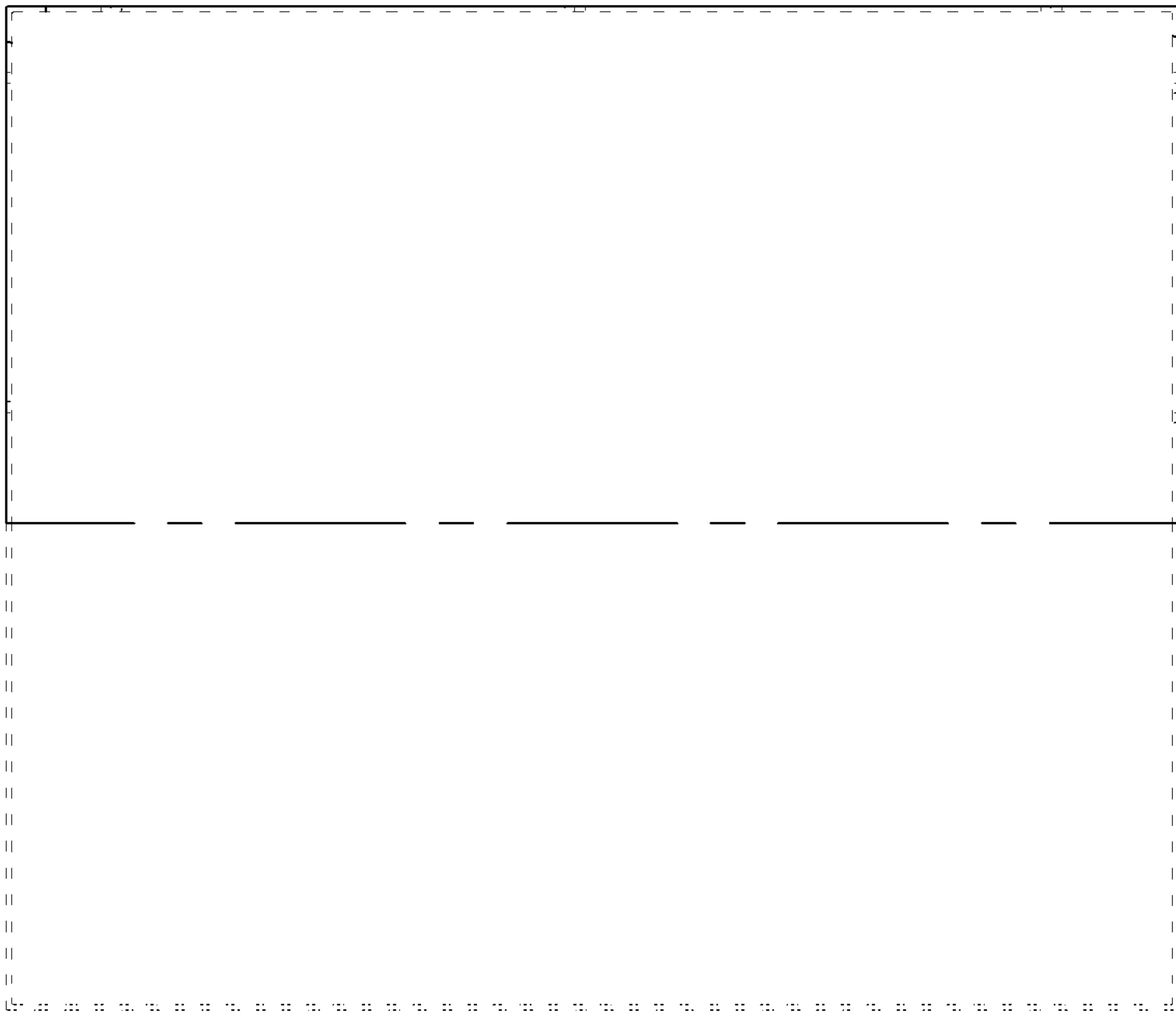

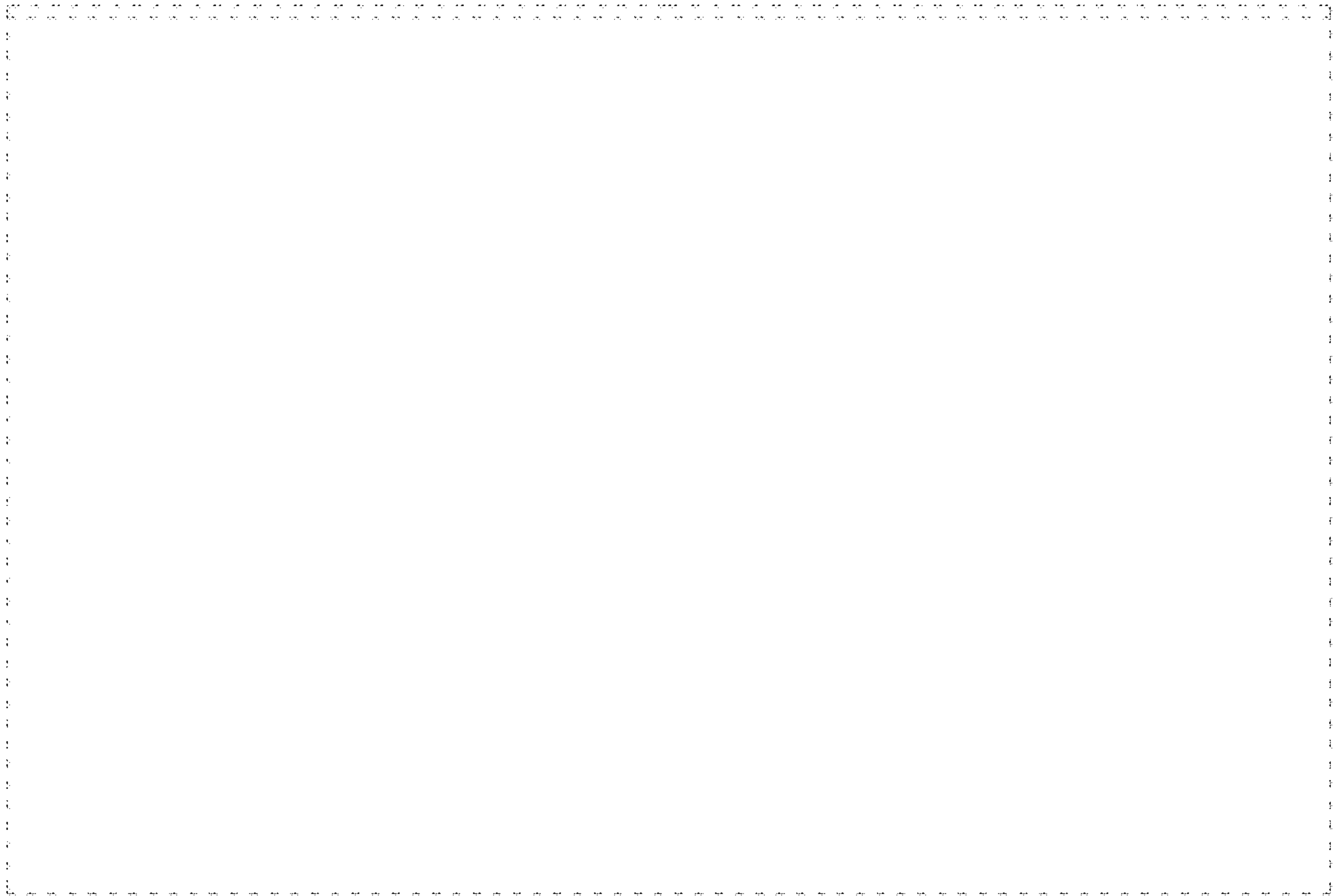

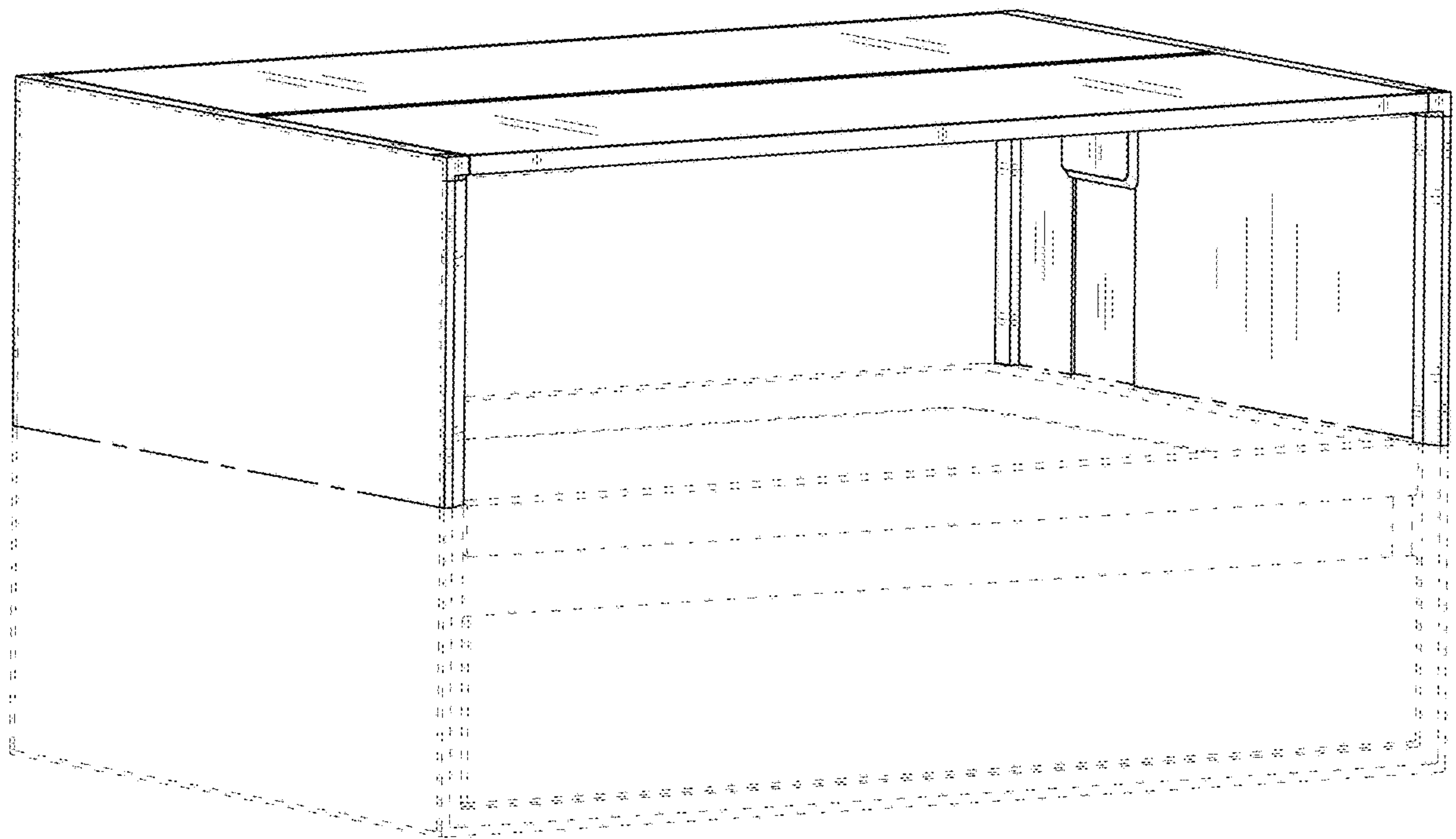

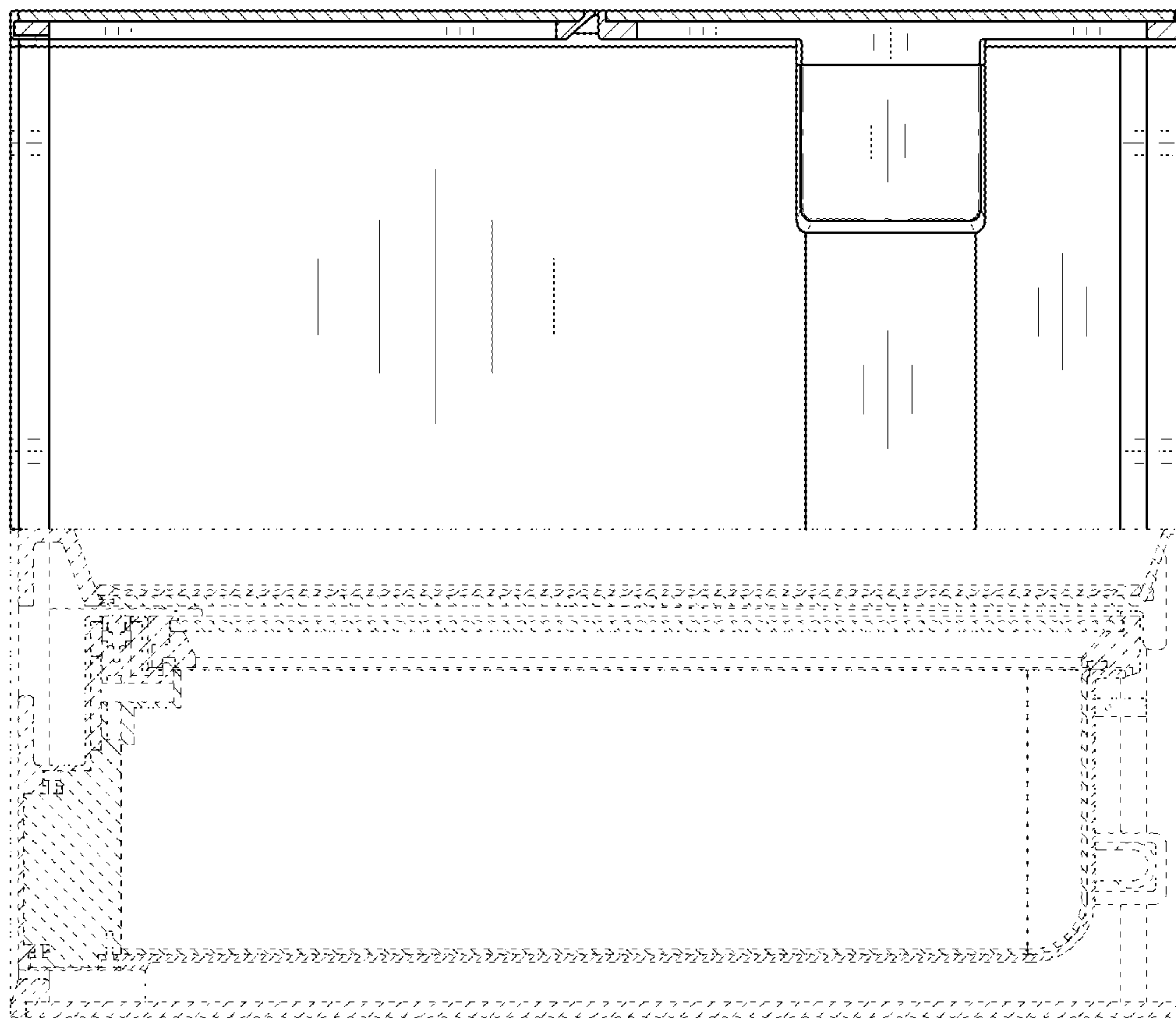

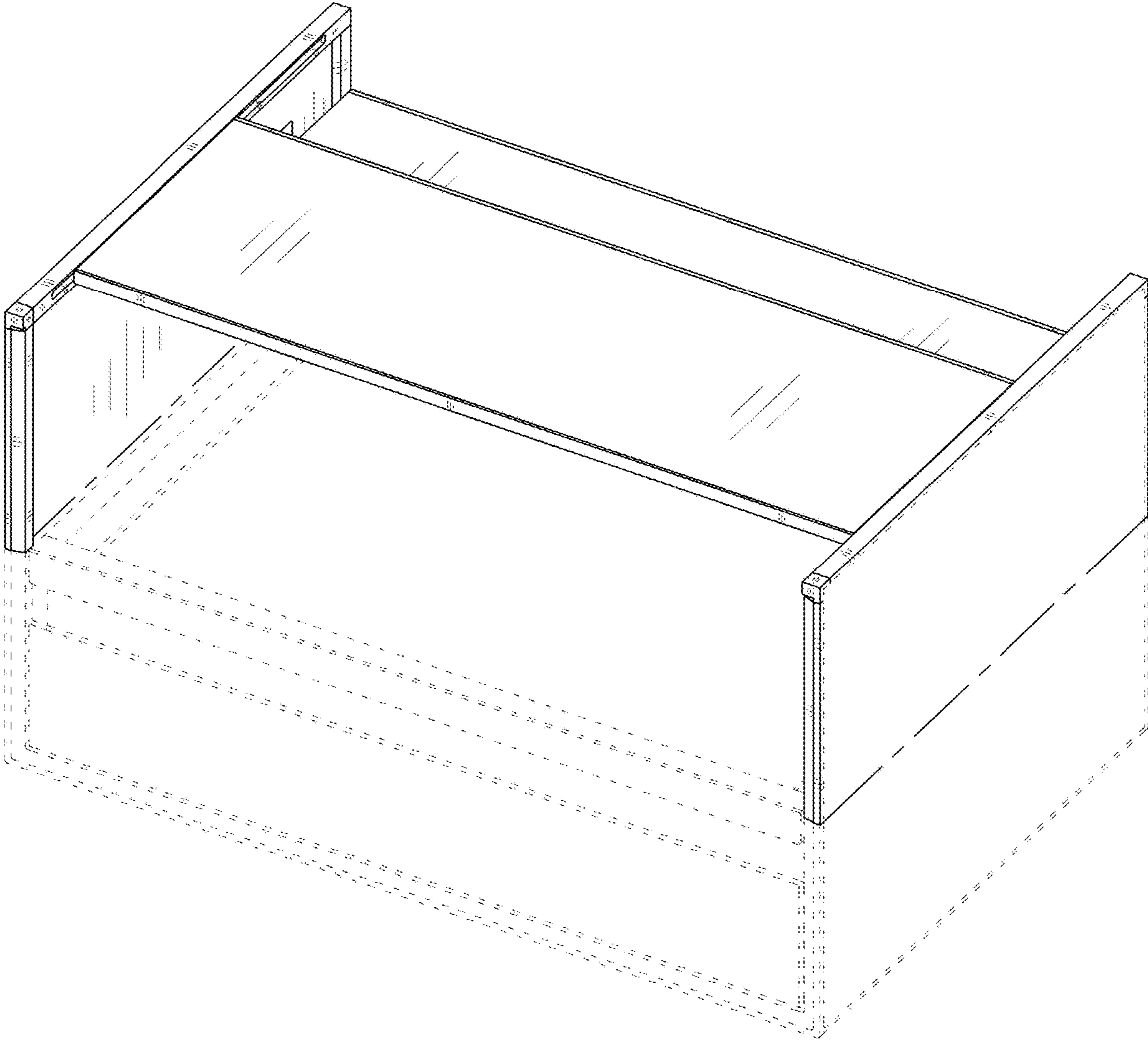

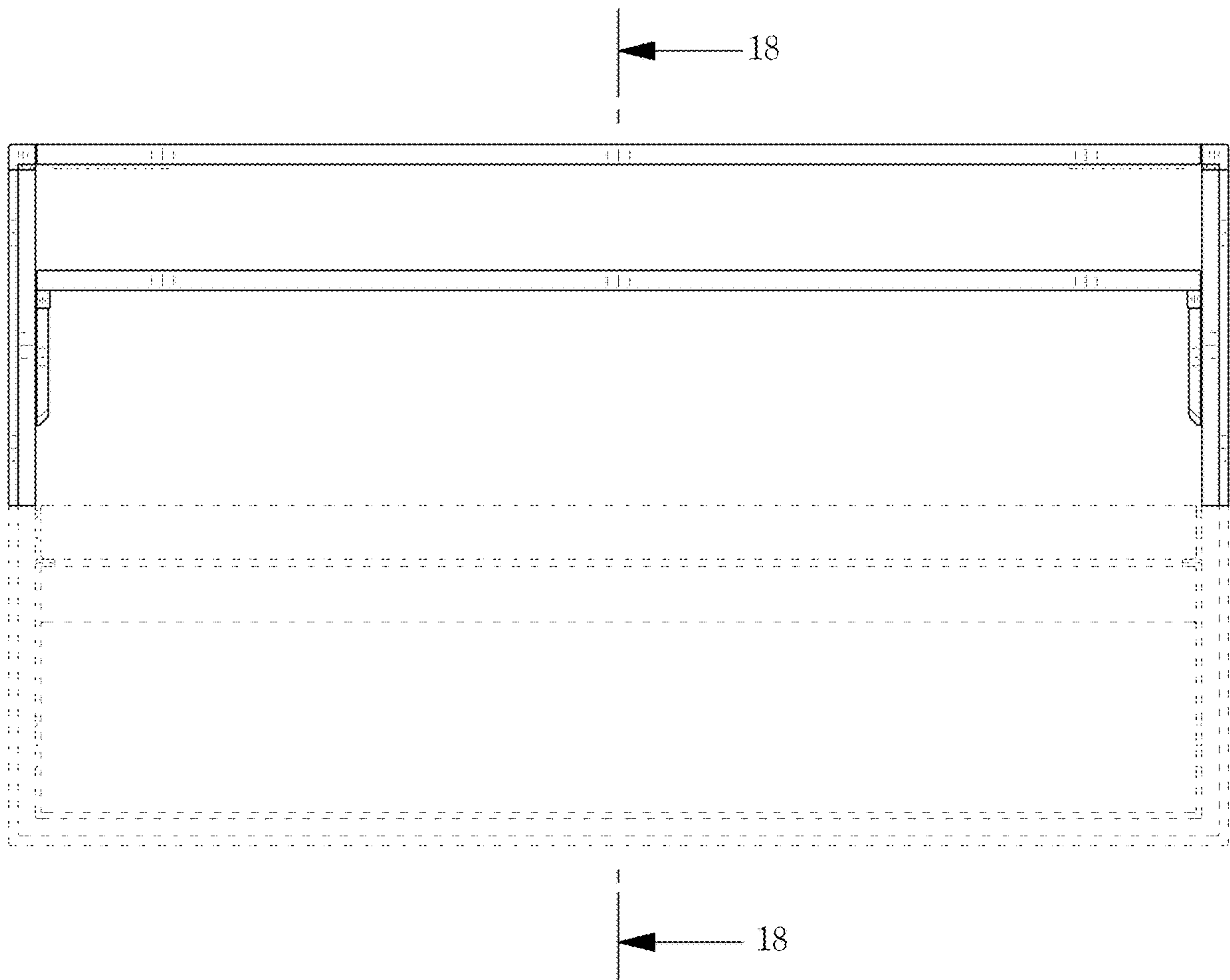

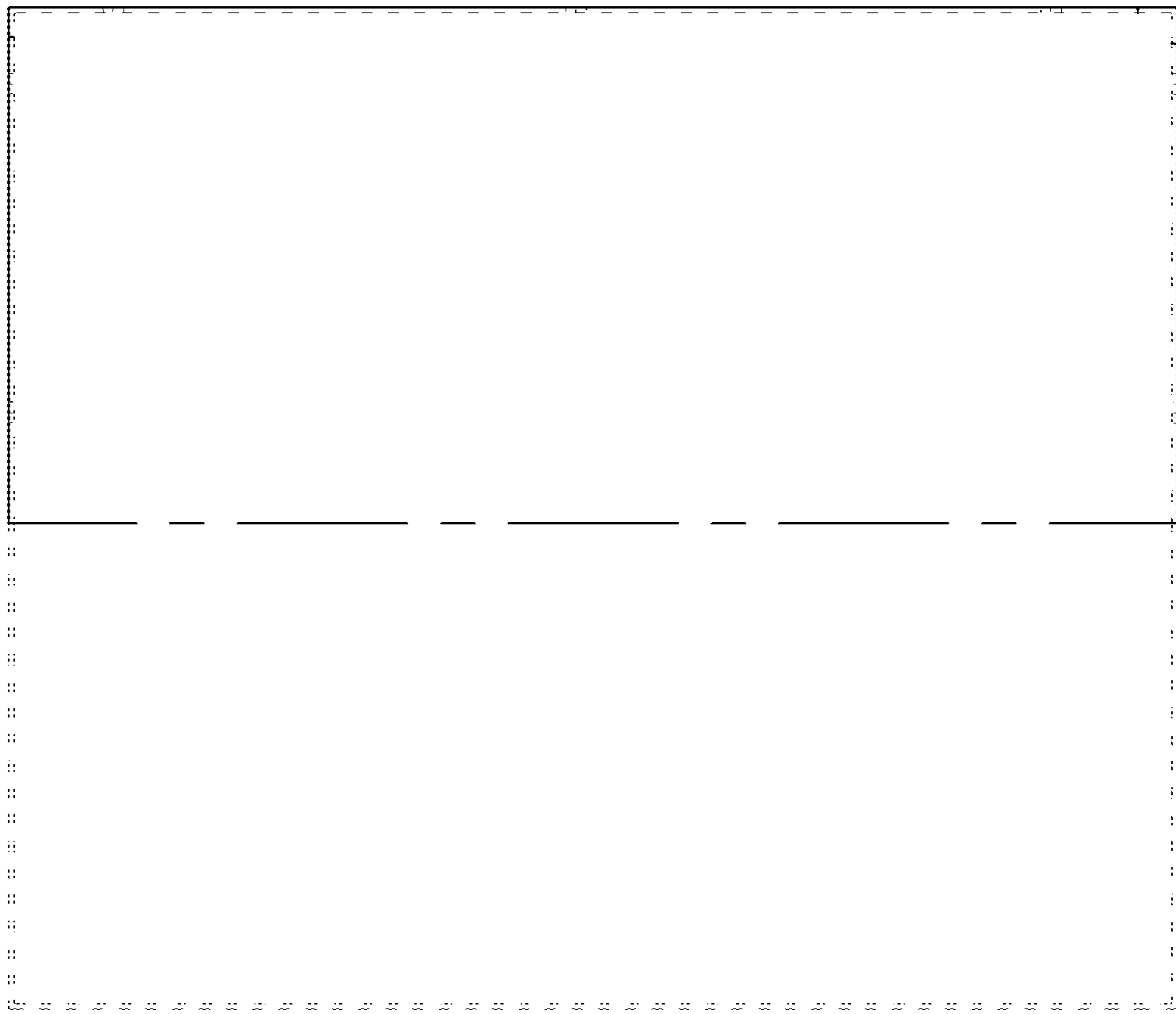

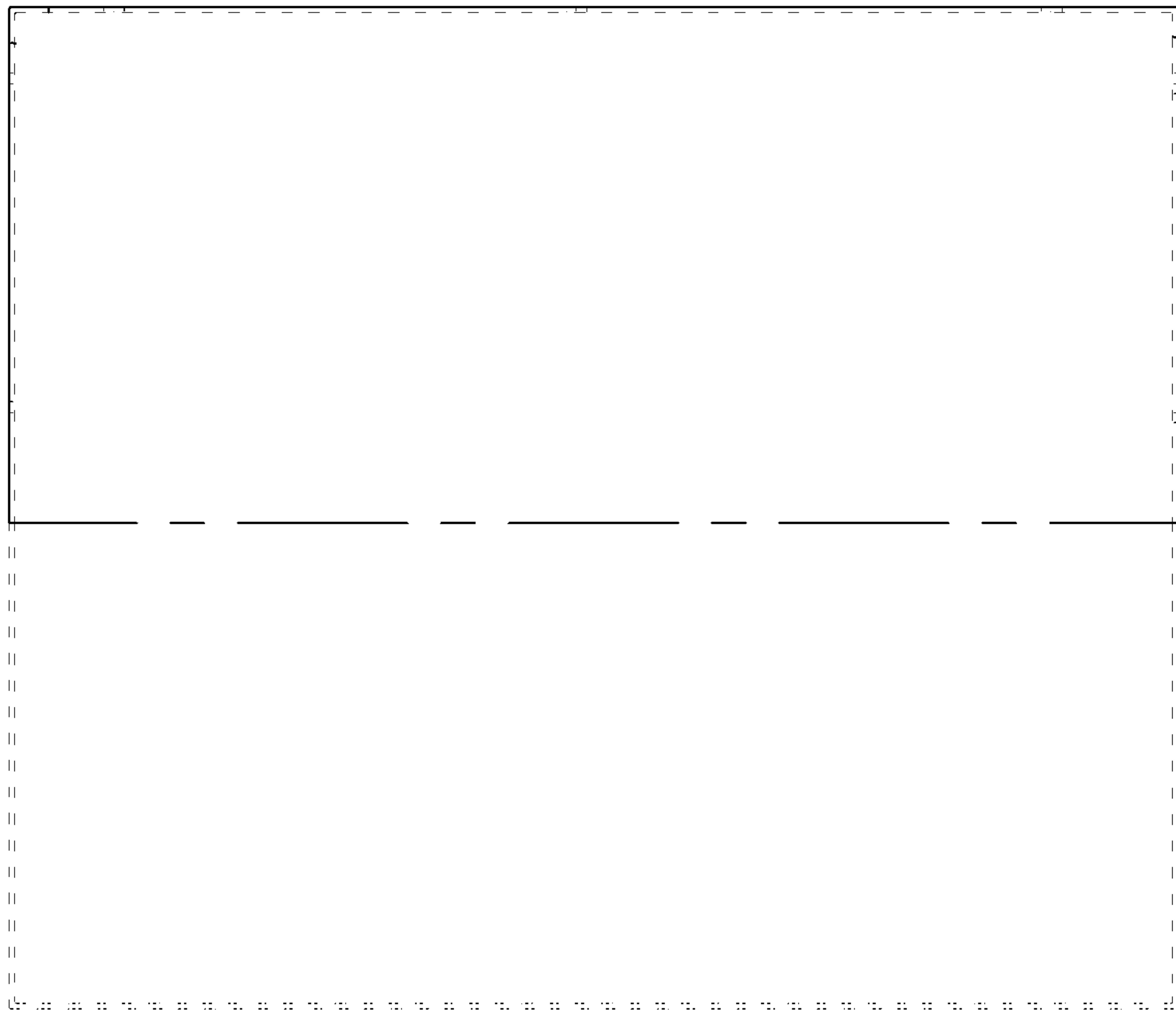

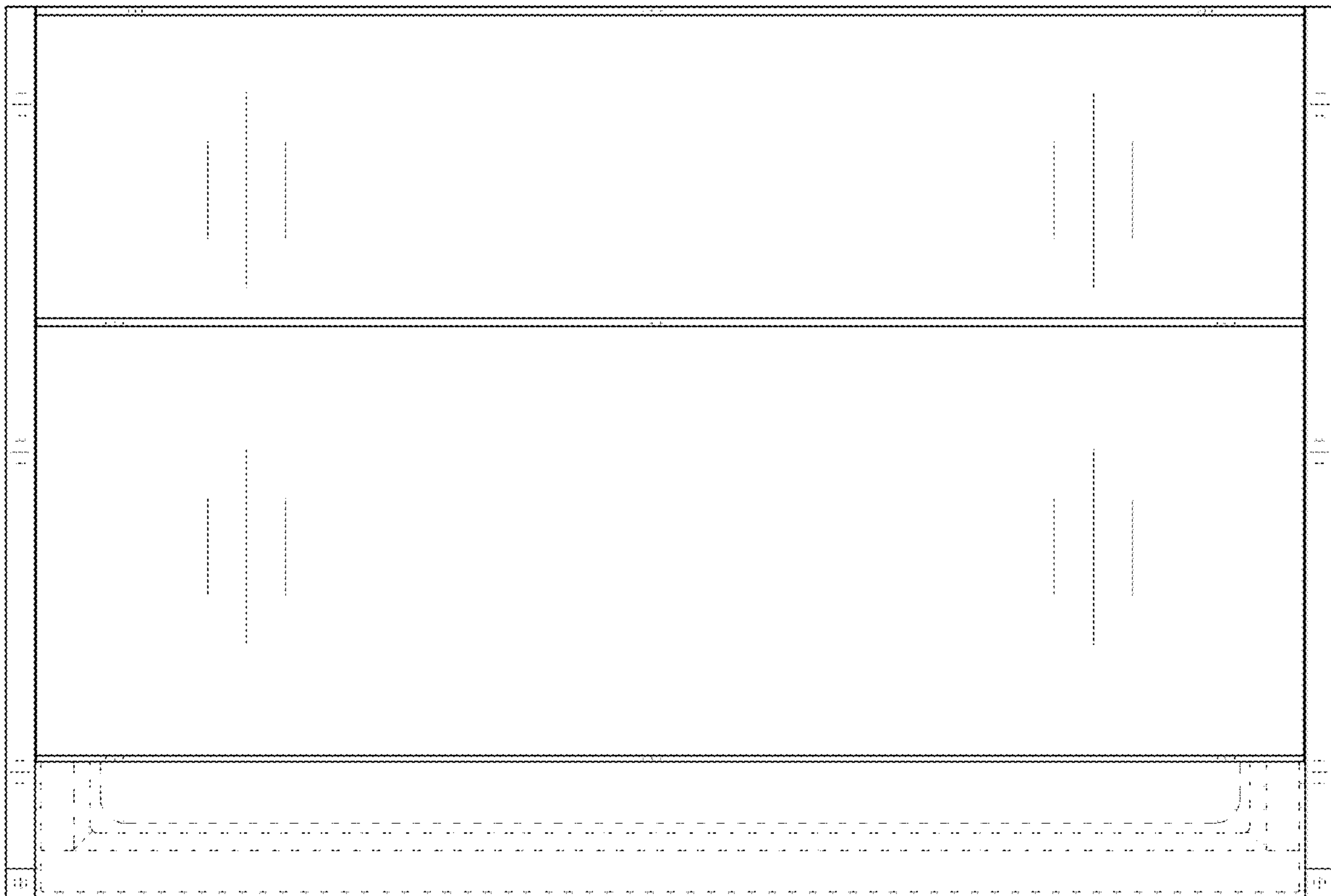

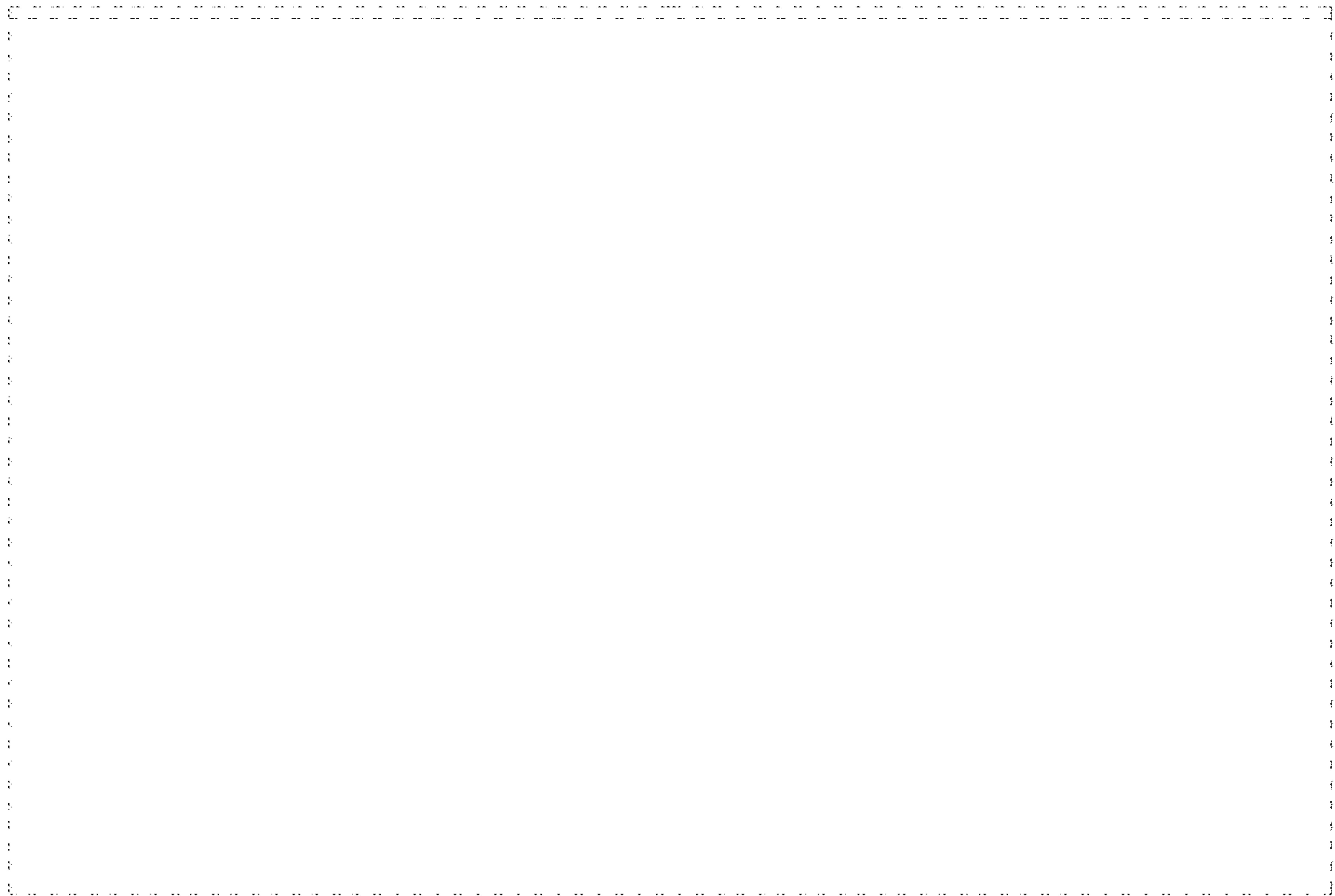

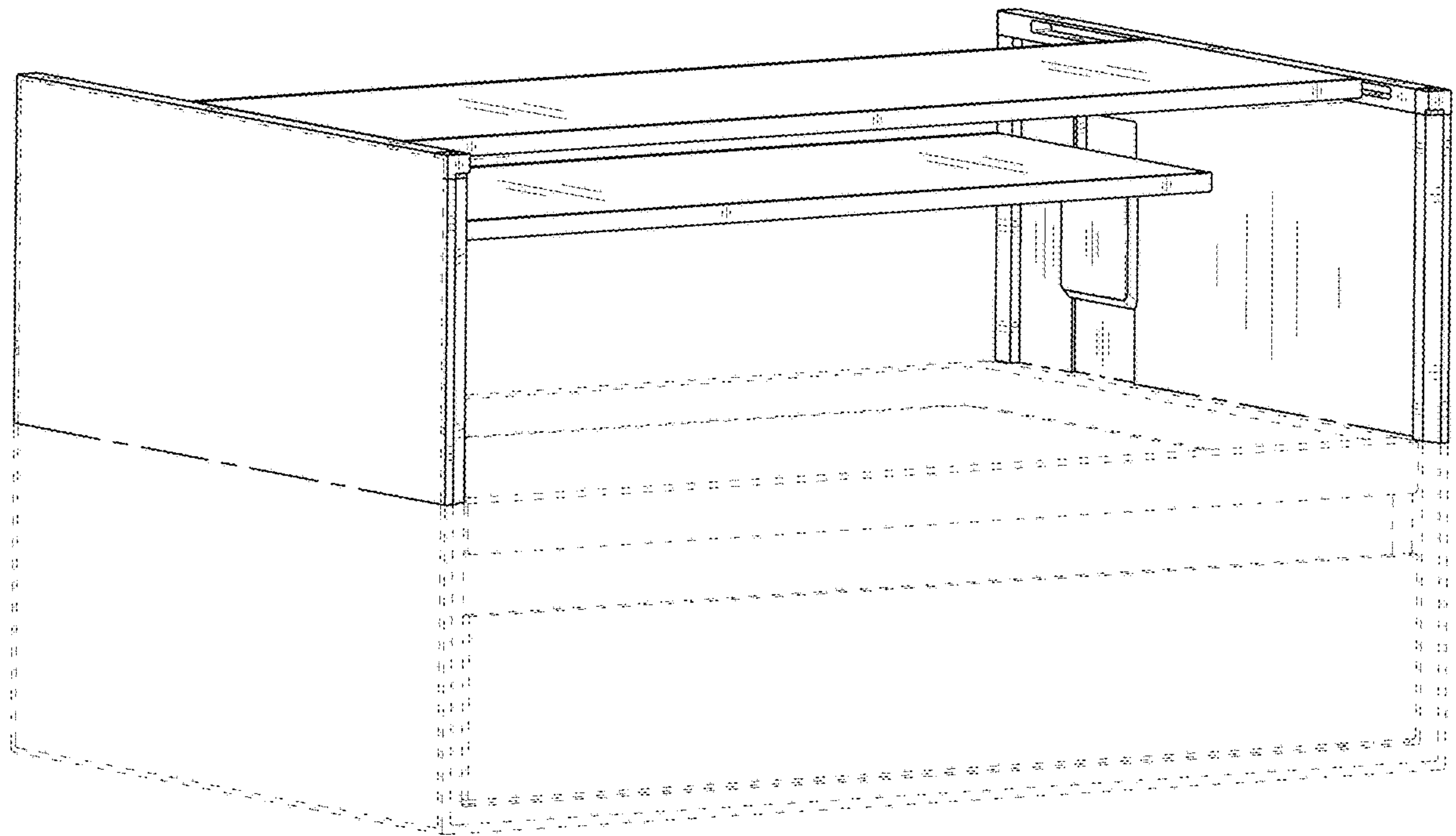

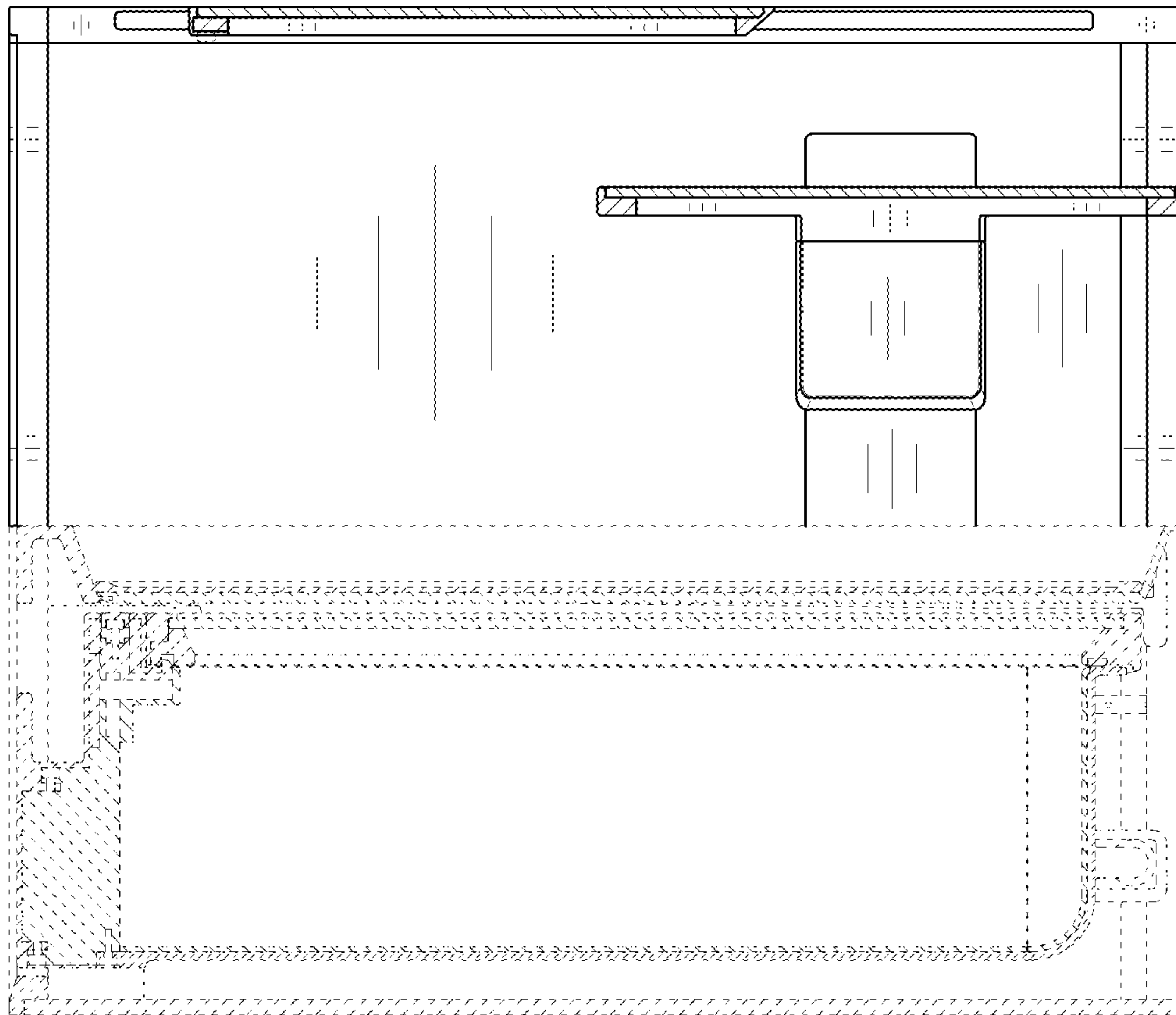

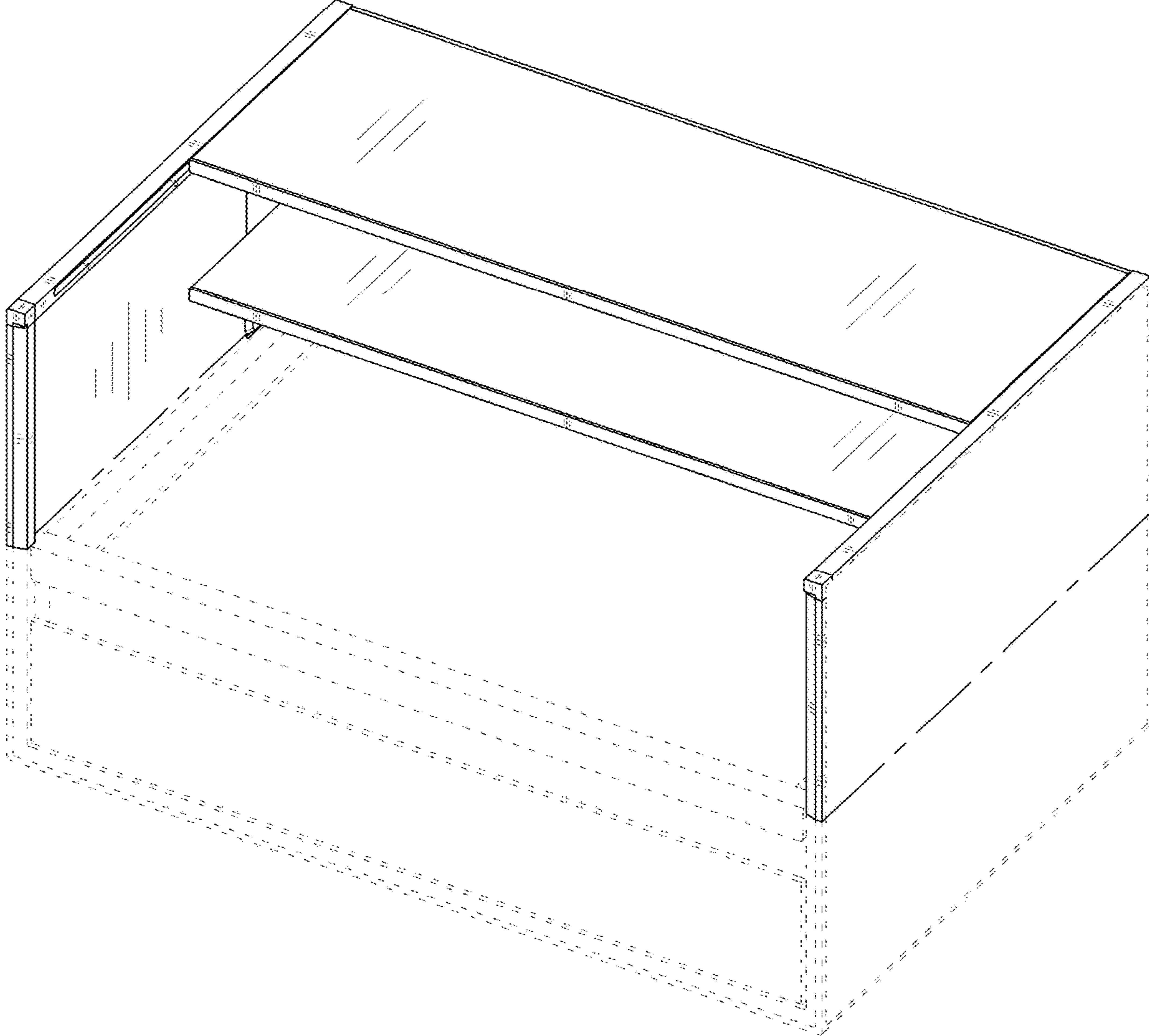

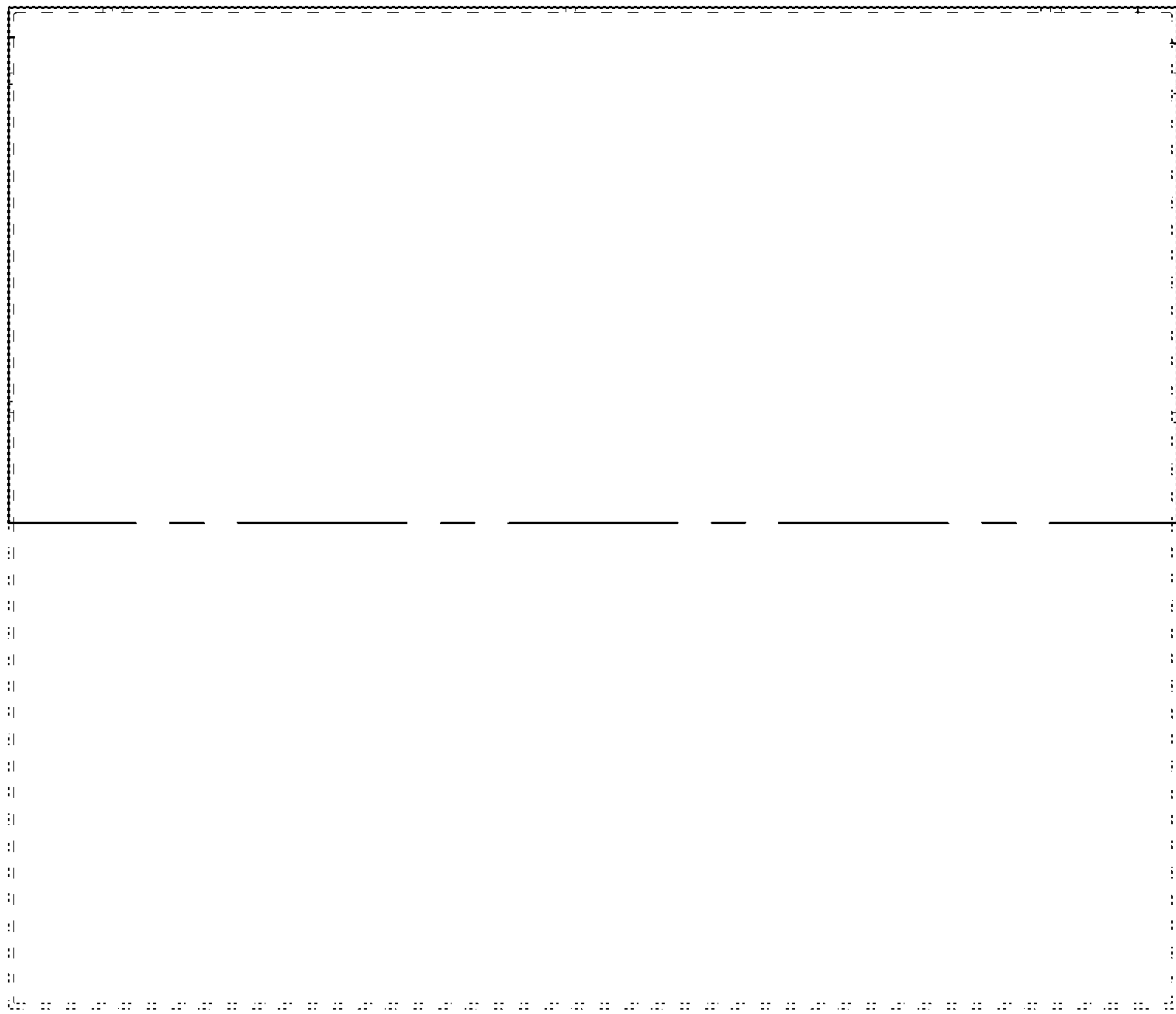

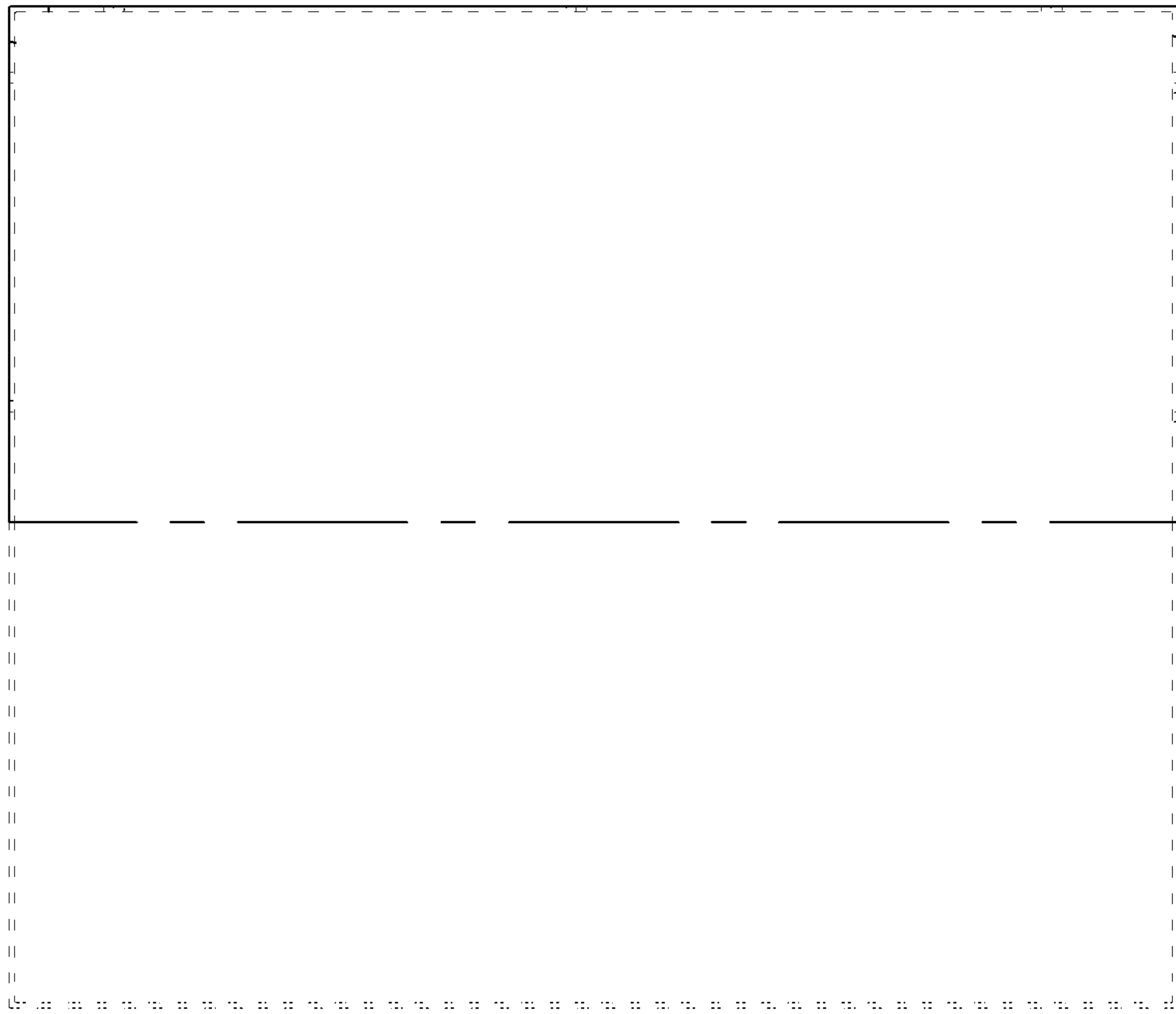

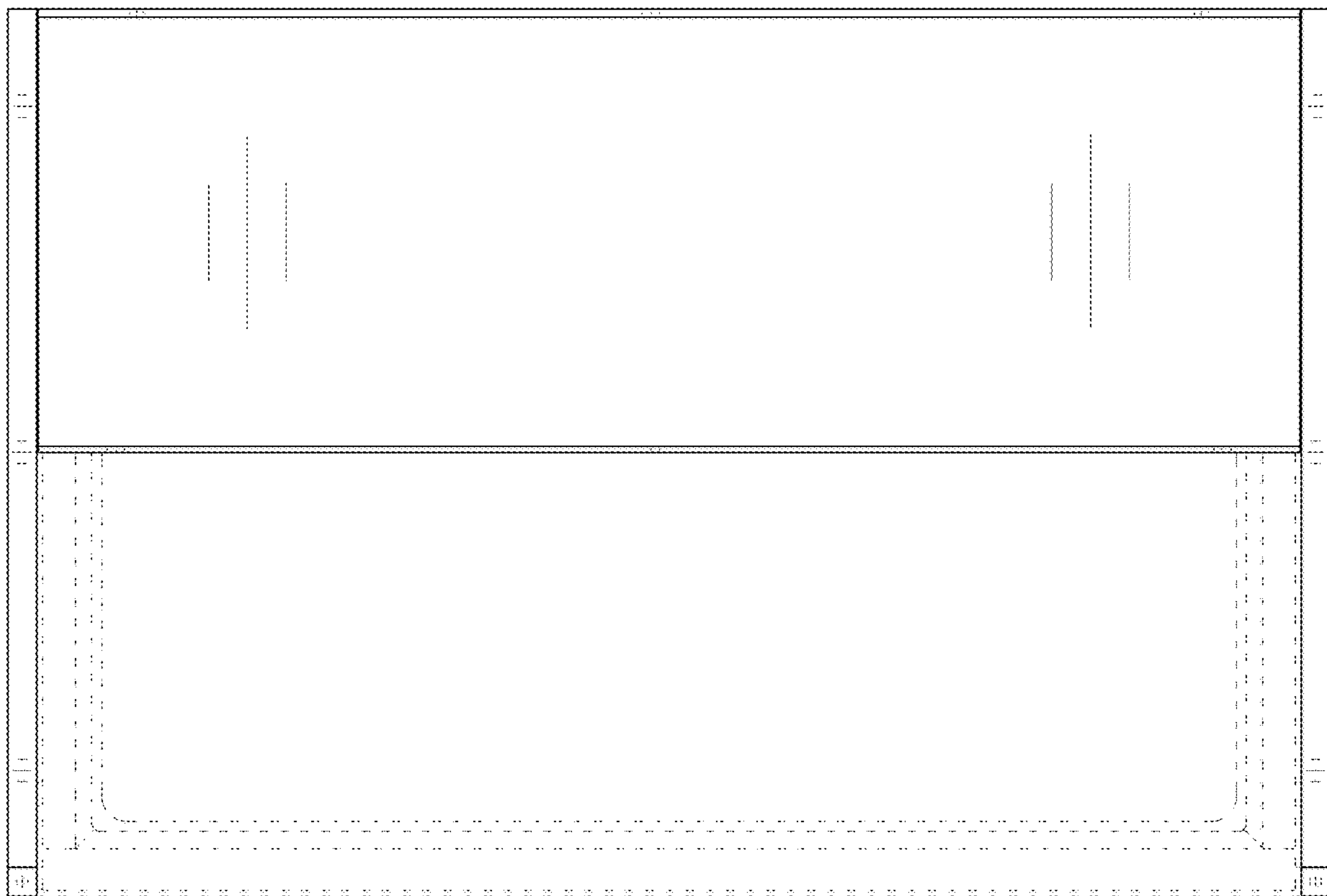

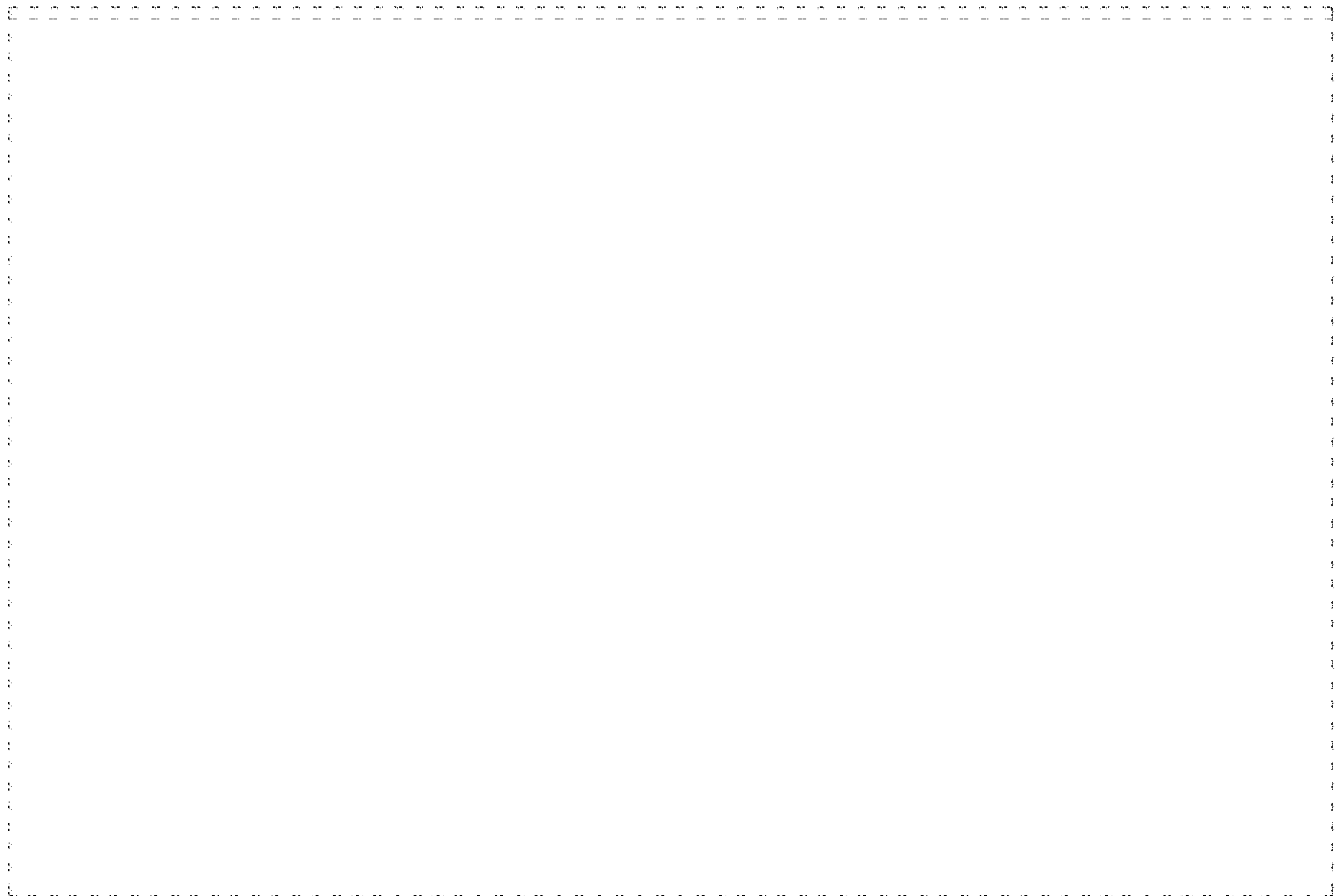

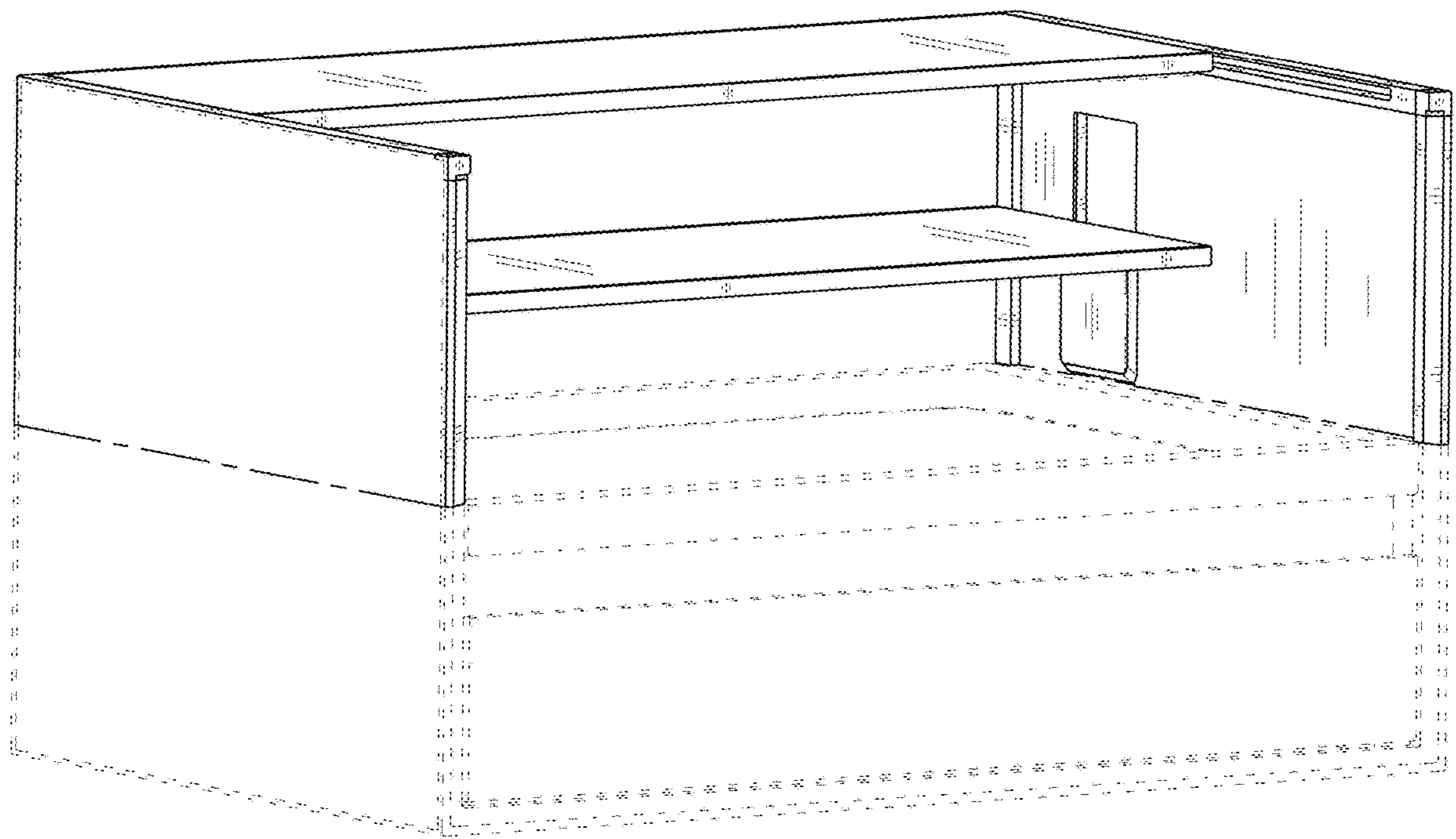
