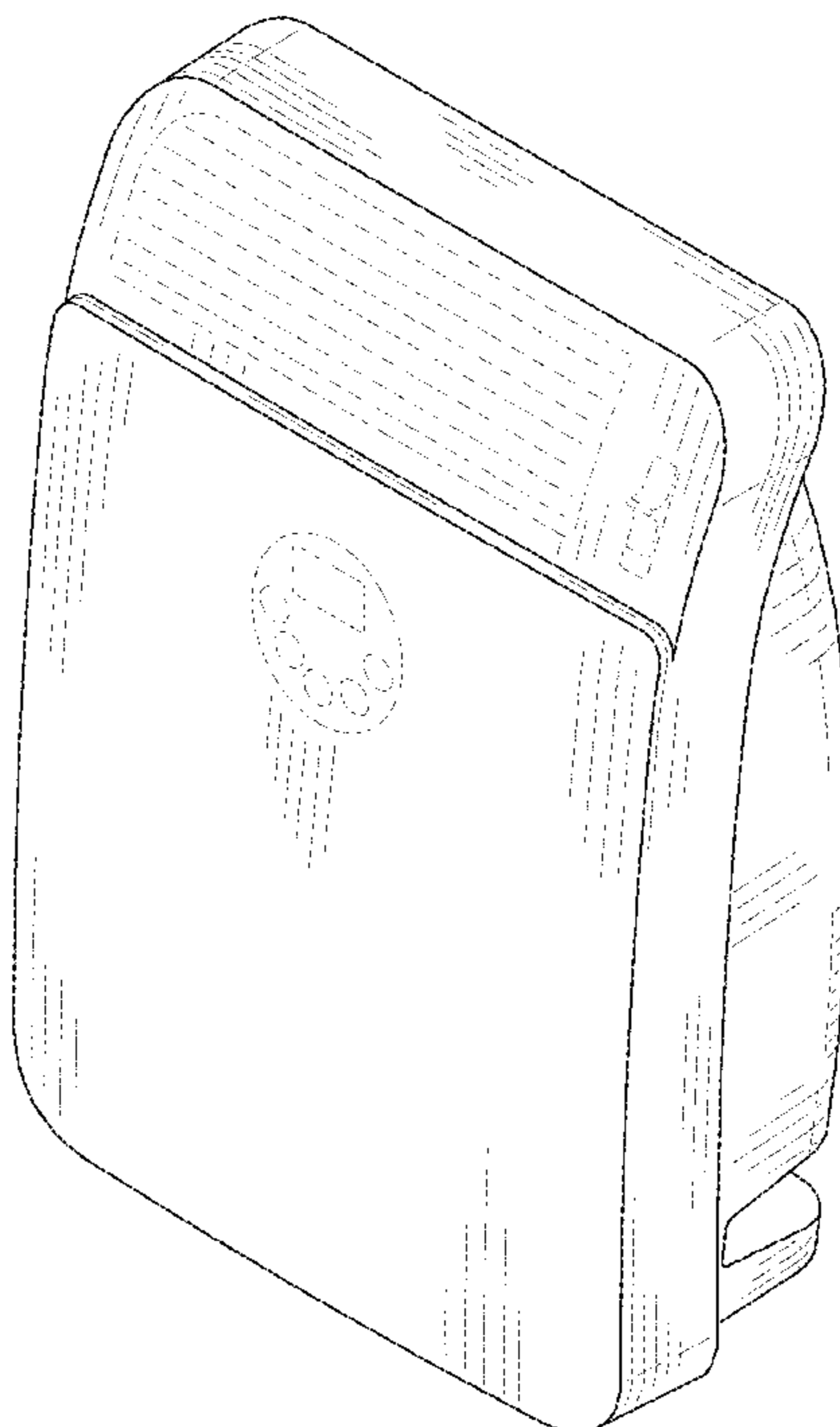
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a right side front perspective view of a portable heater showing my new design;
FIG. 2 is a left side rear perspective view thereof;

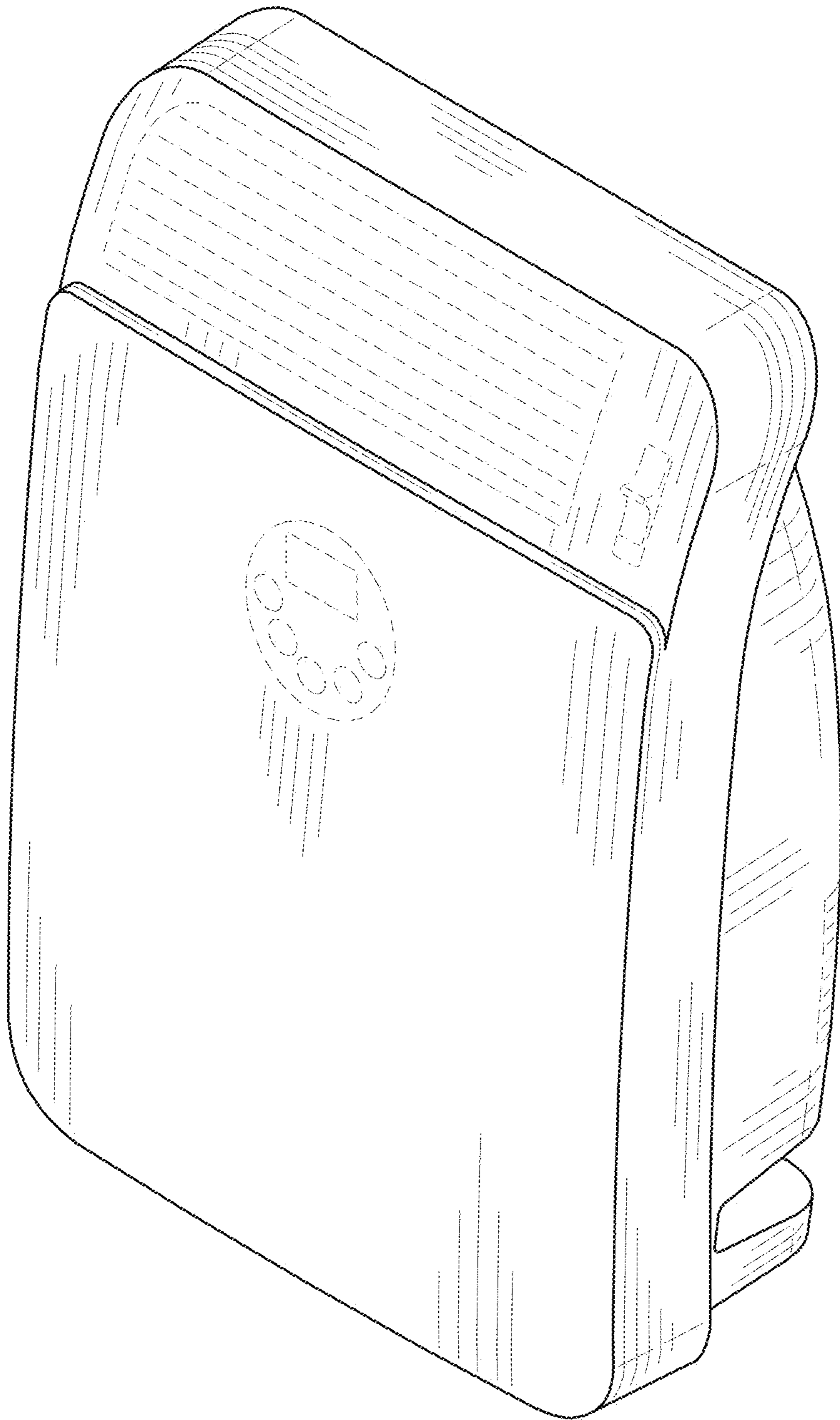

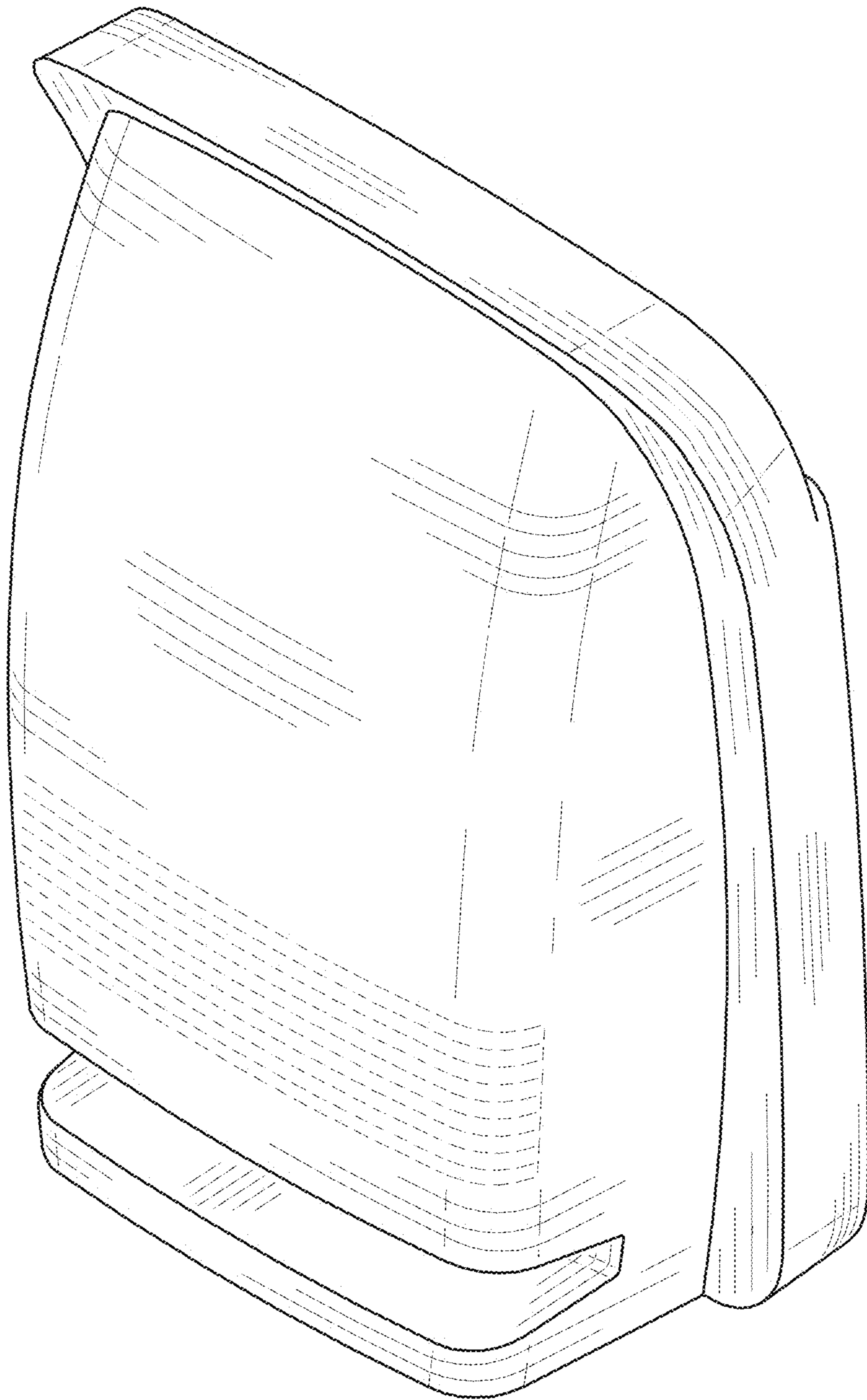

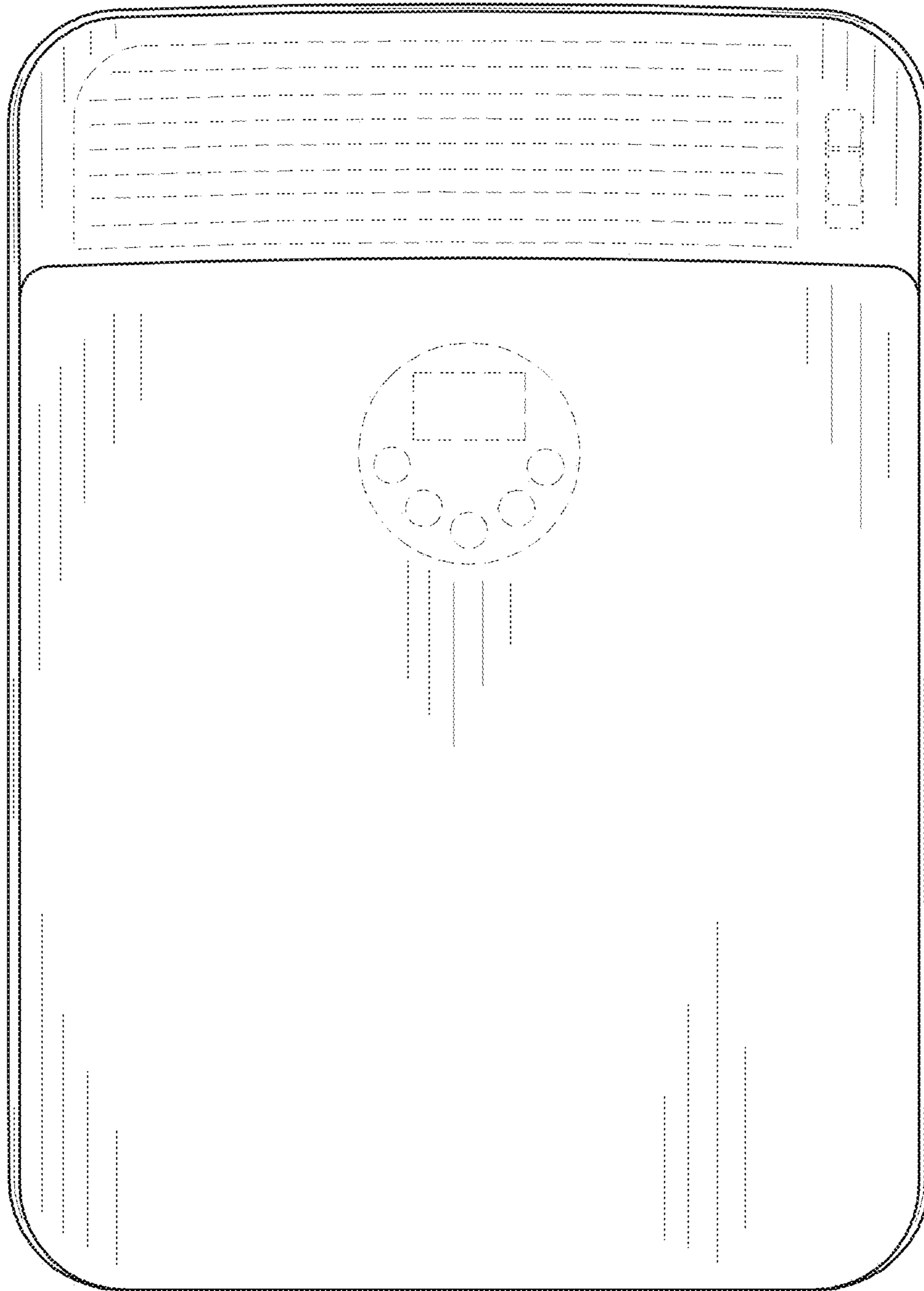

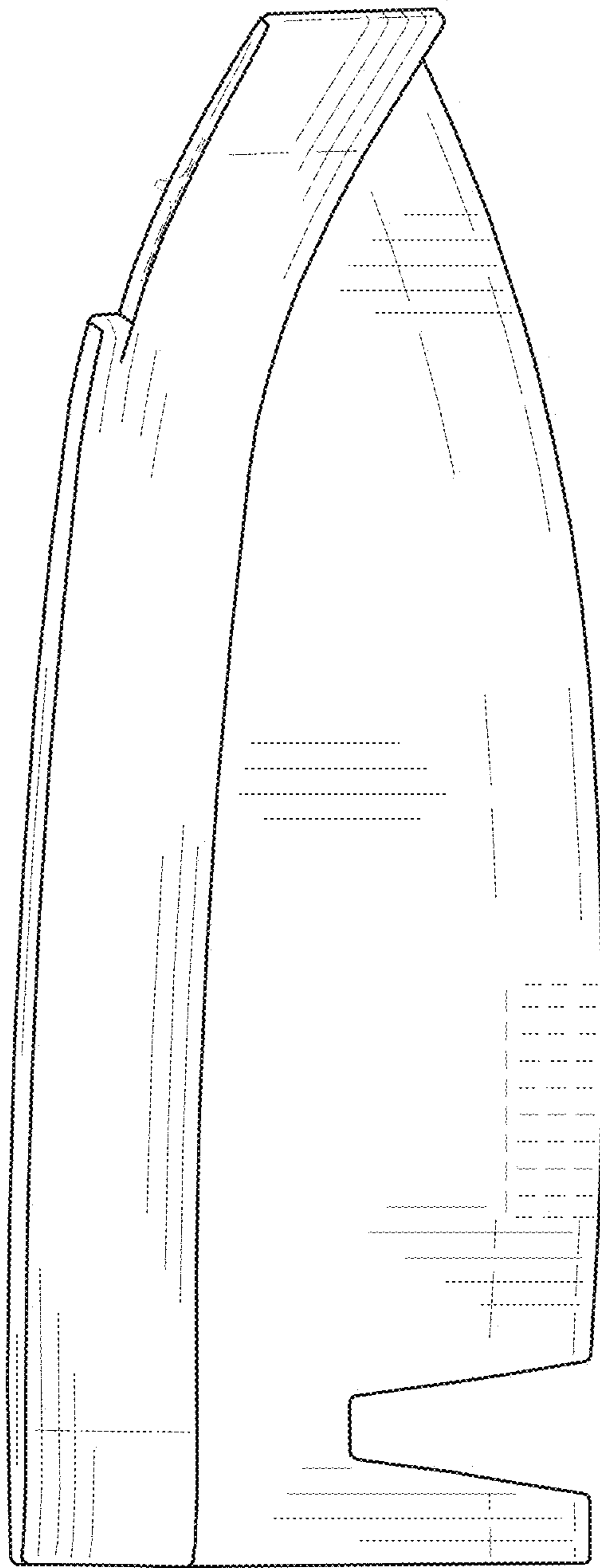

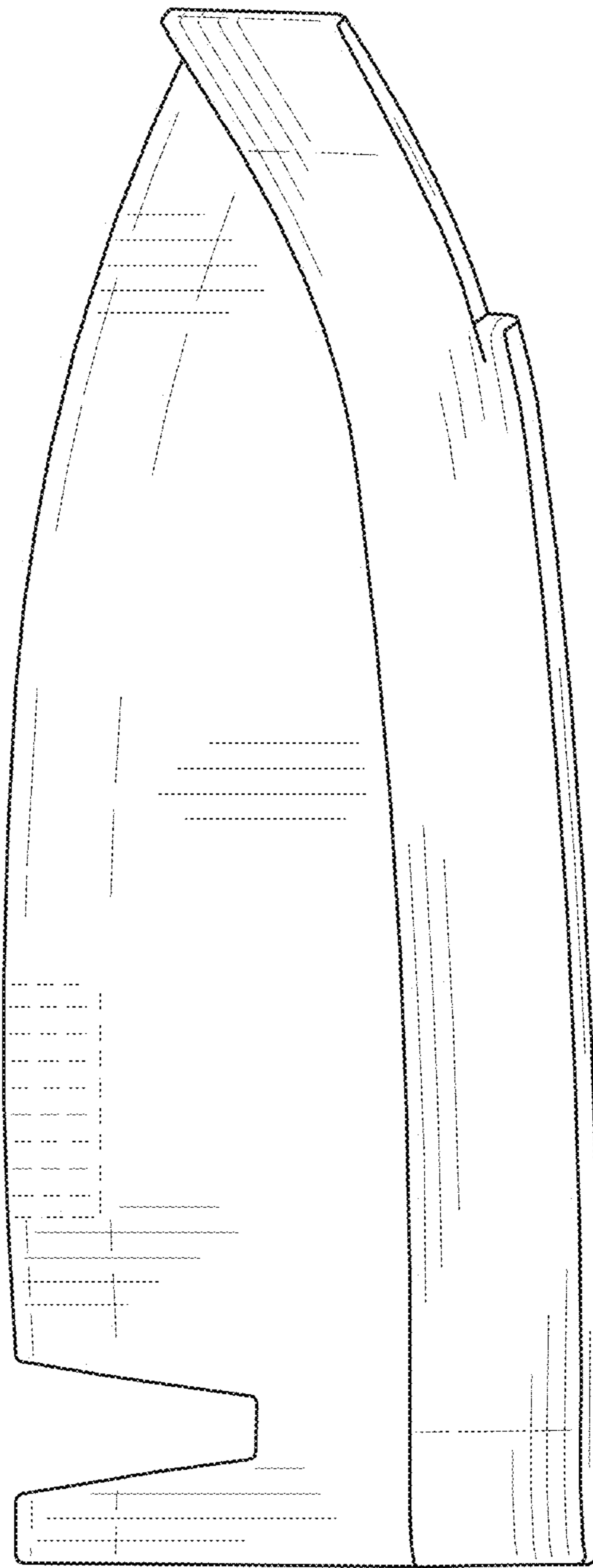

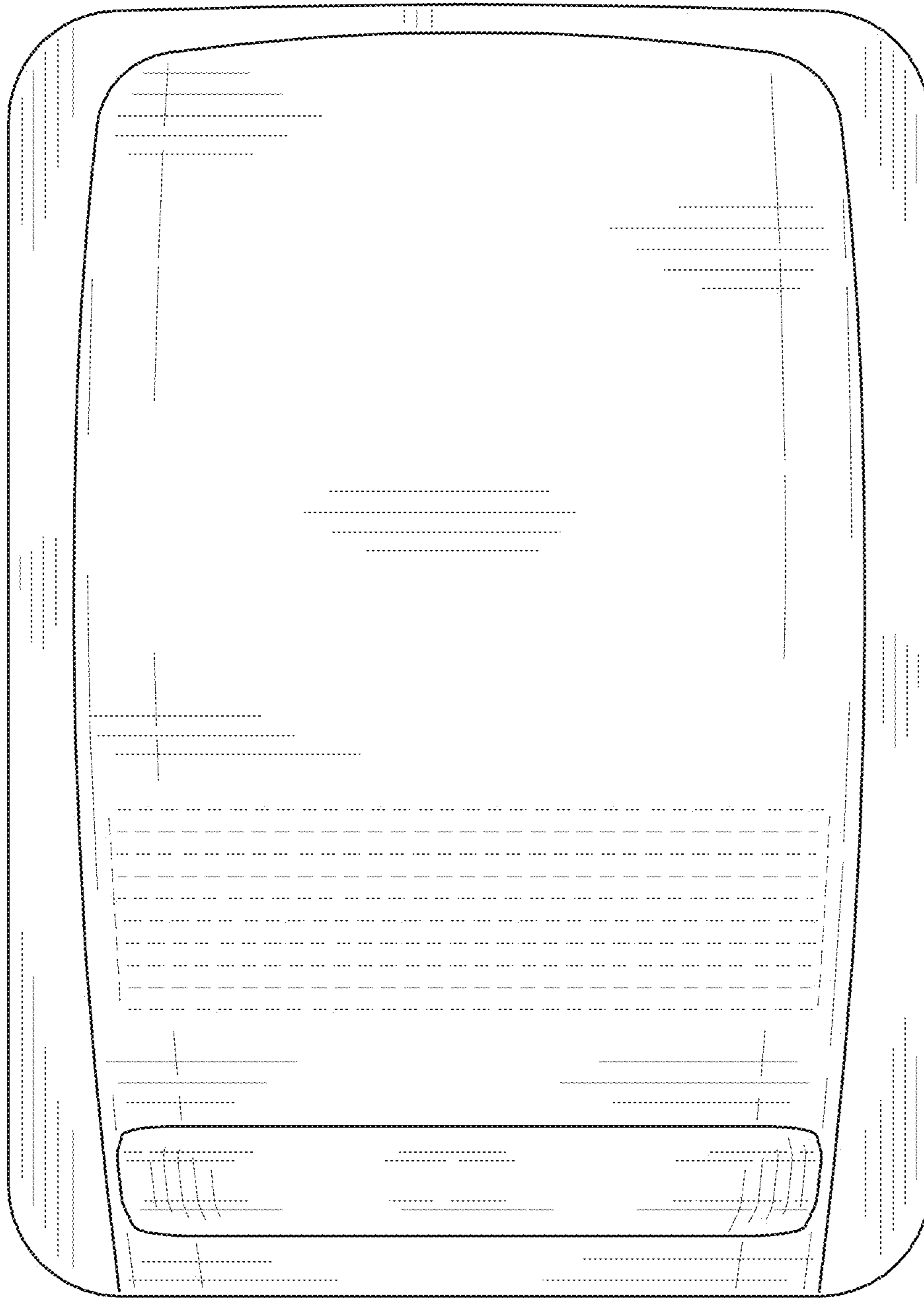

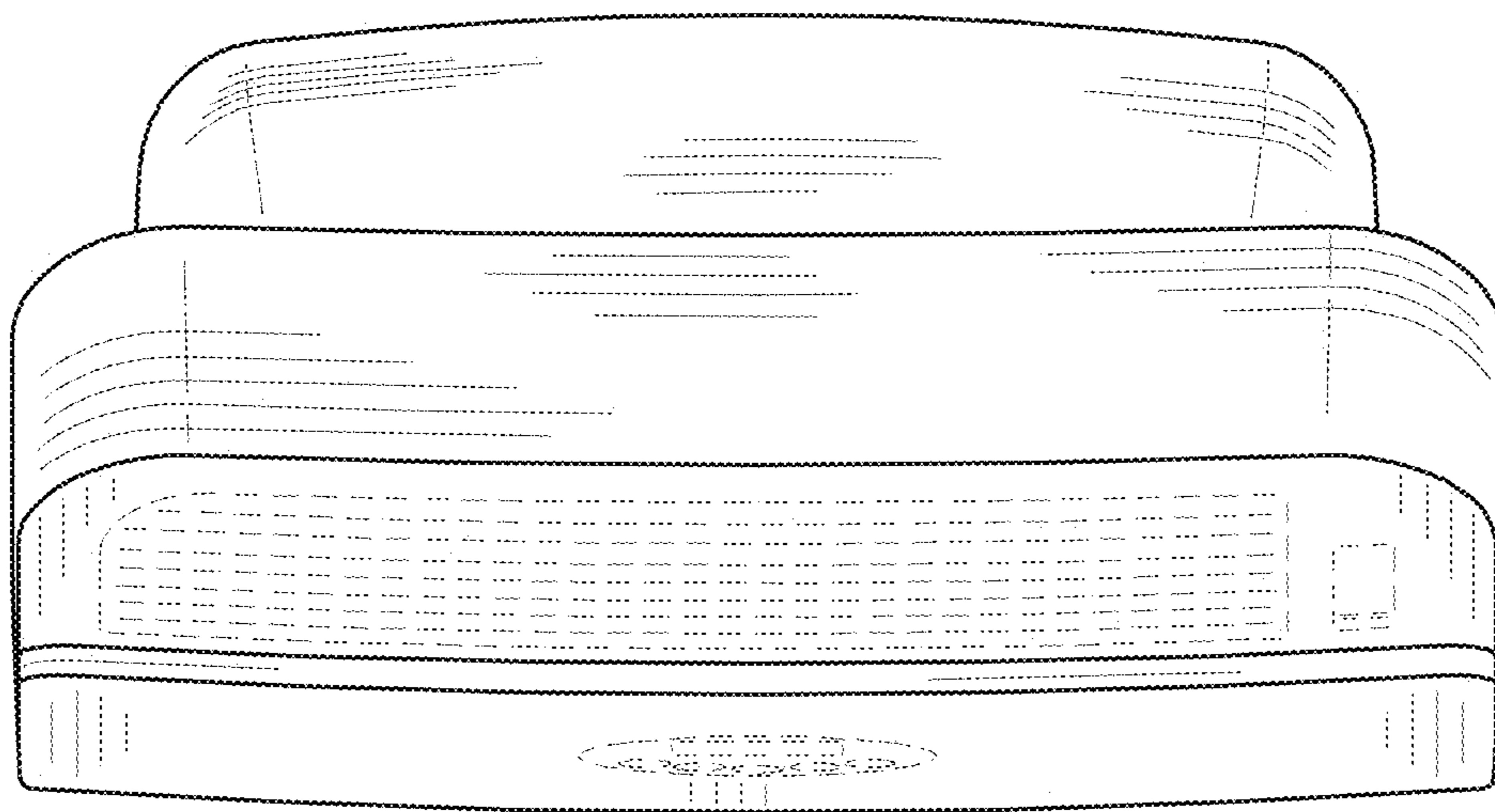
