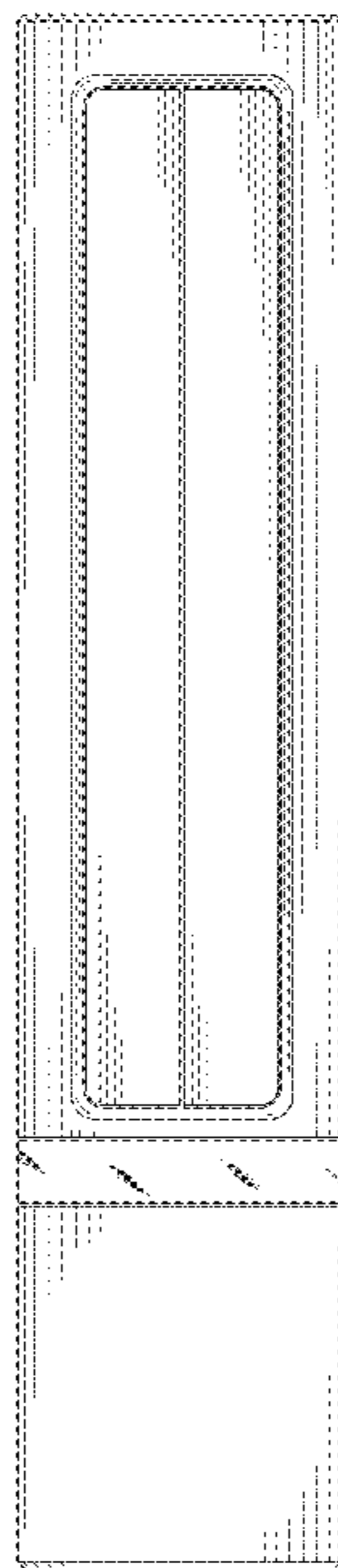
(57) **CLAIM**

The ornamental design of an air conditioner indoor unit, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of an air conditioner indoor unit, showing my new design;
FIG. 2 is a rear elevation view thereof;
FIG. 3 is a left side elevation view thereof;
FIG. 4 is a right side elevation view thereof;
FIG. 5 is a top plan view thereof;

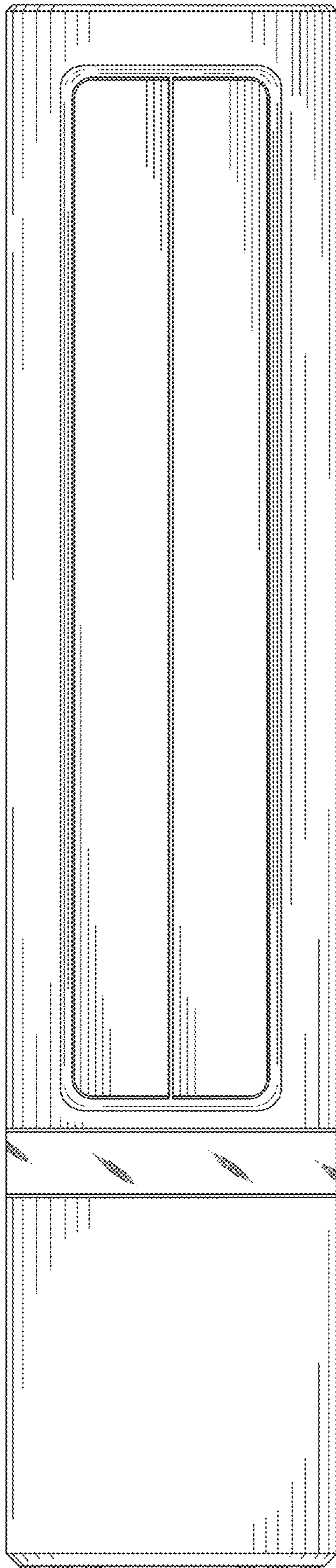

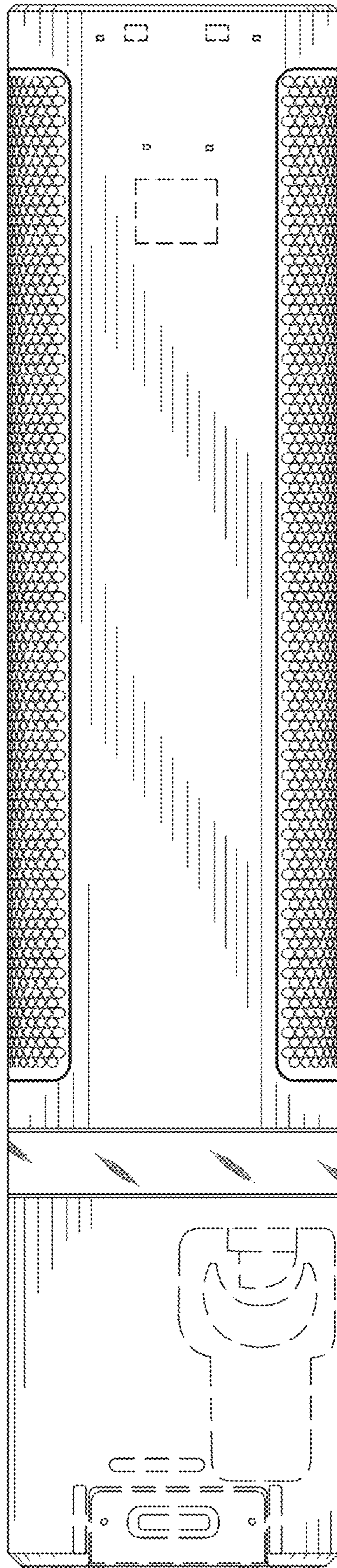

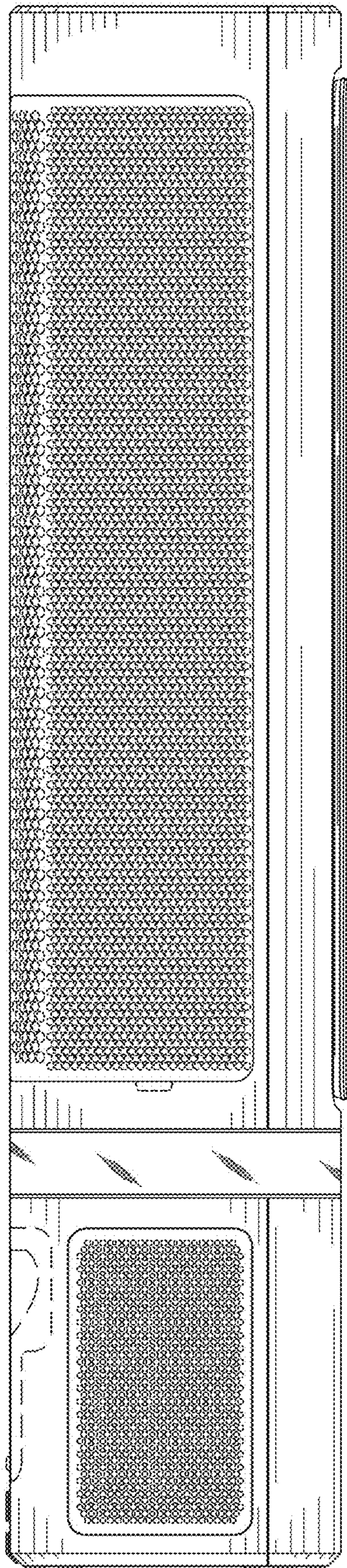

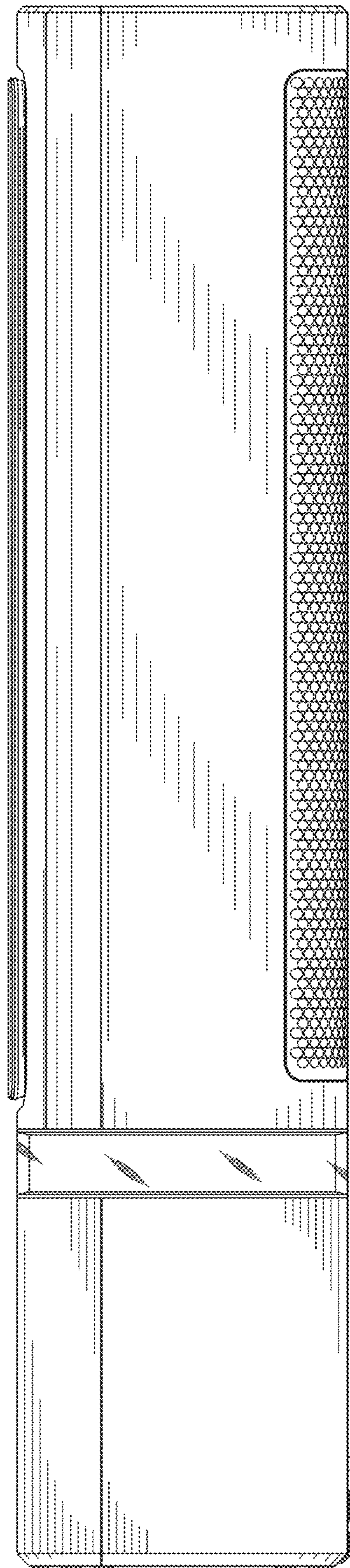

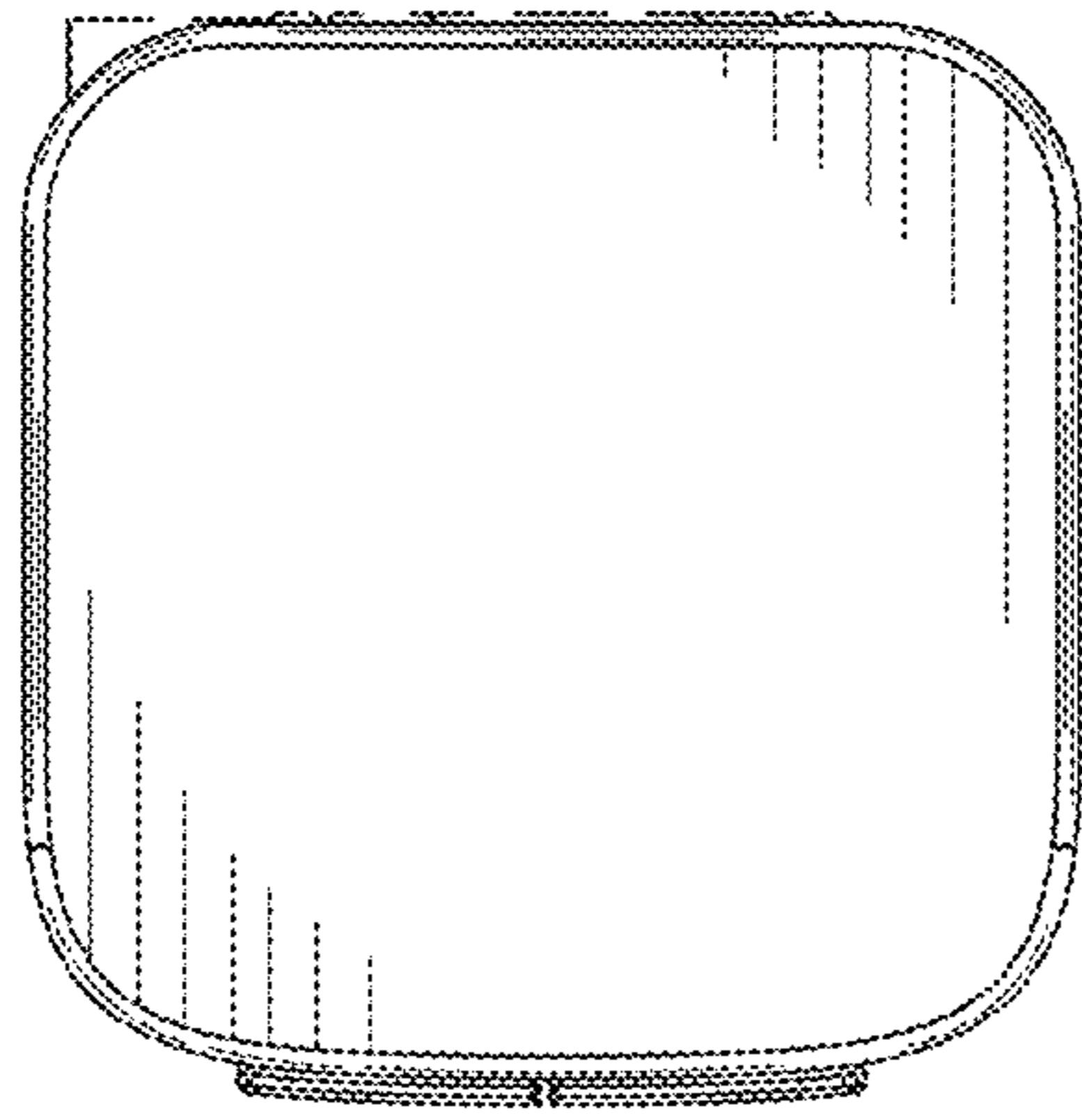

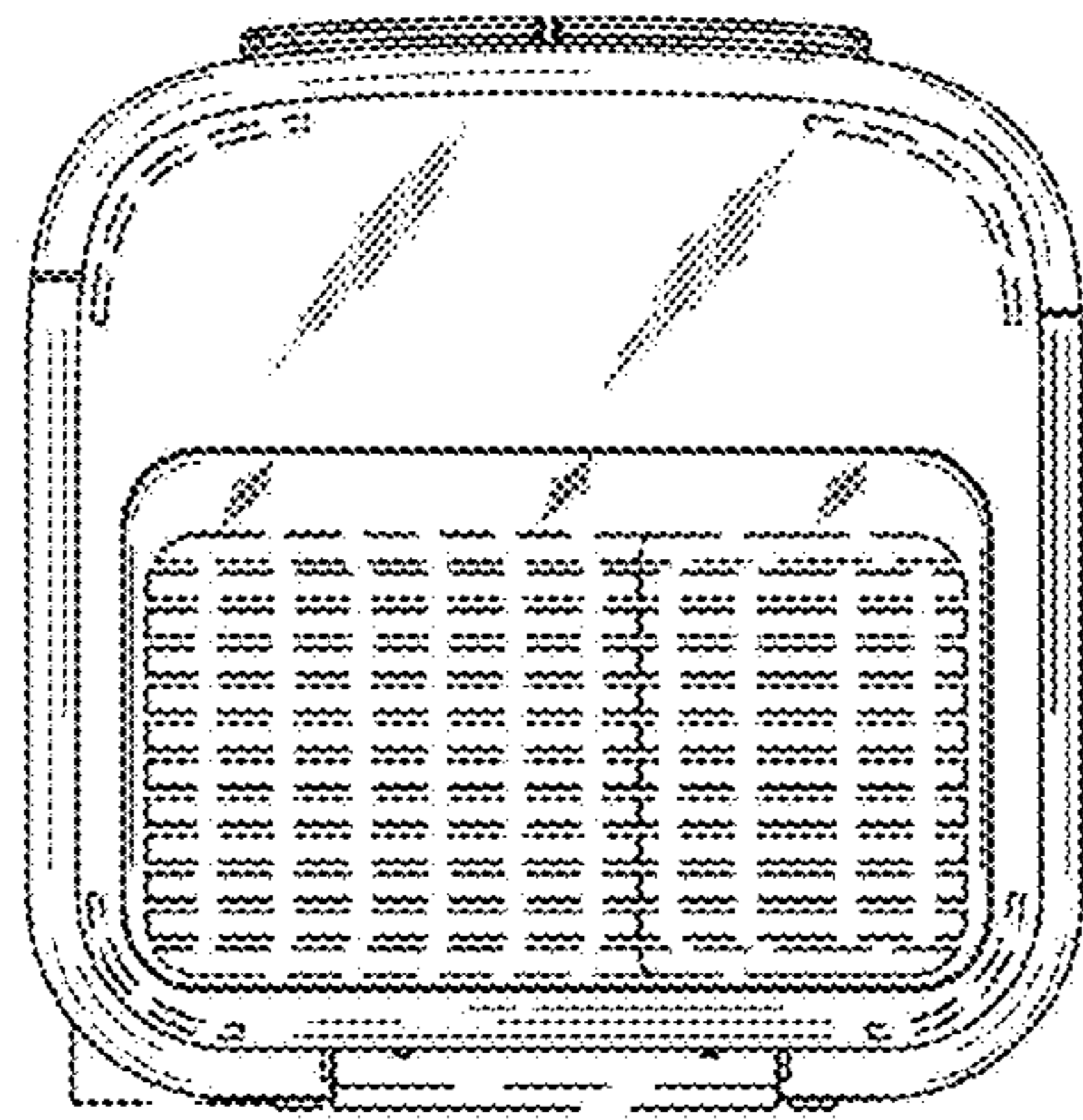

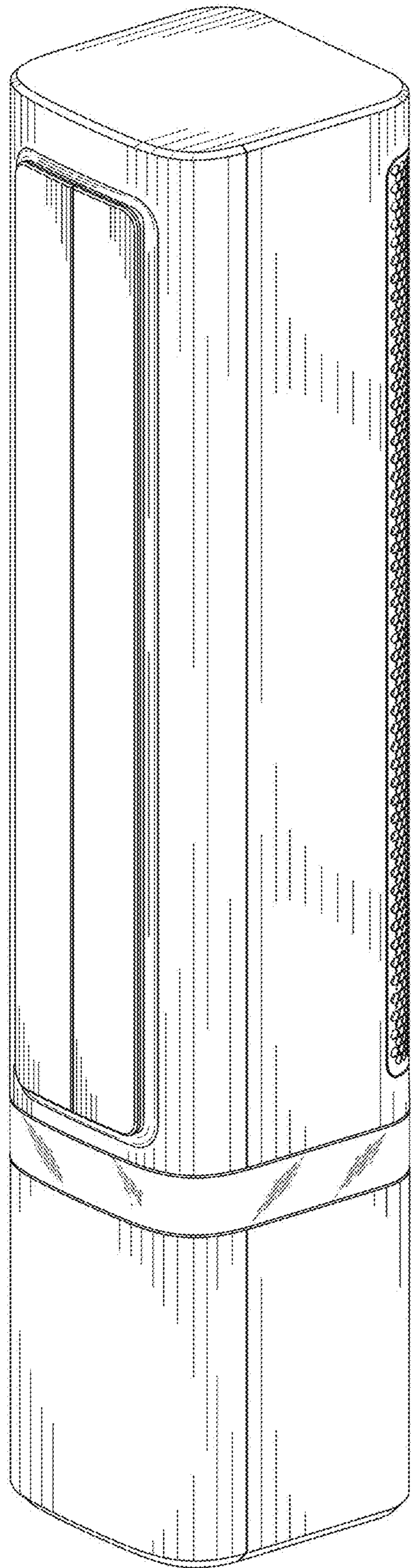

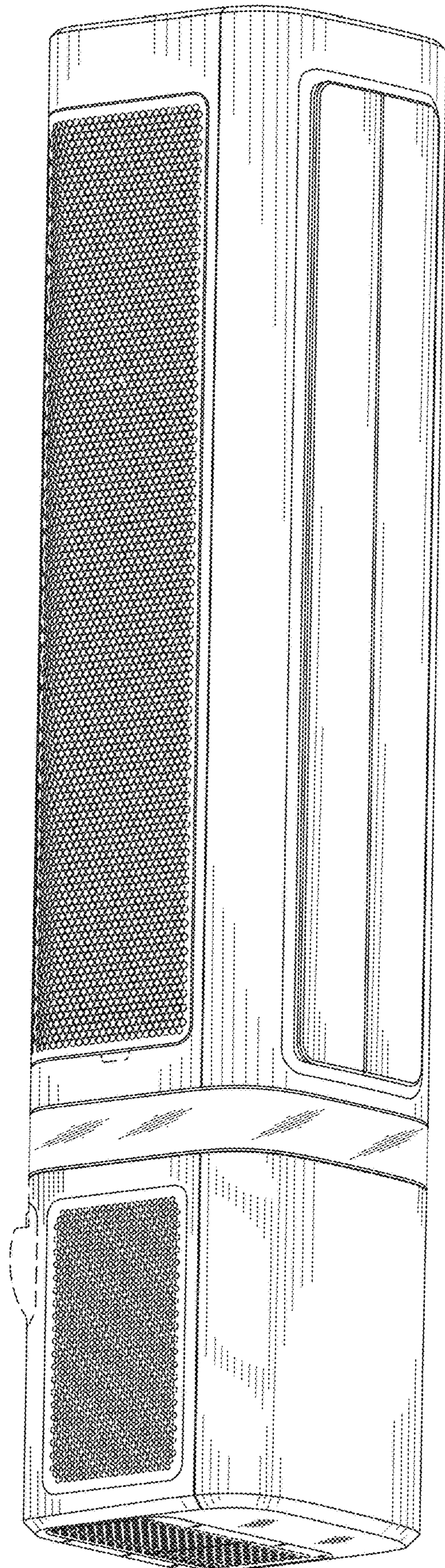
