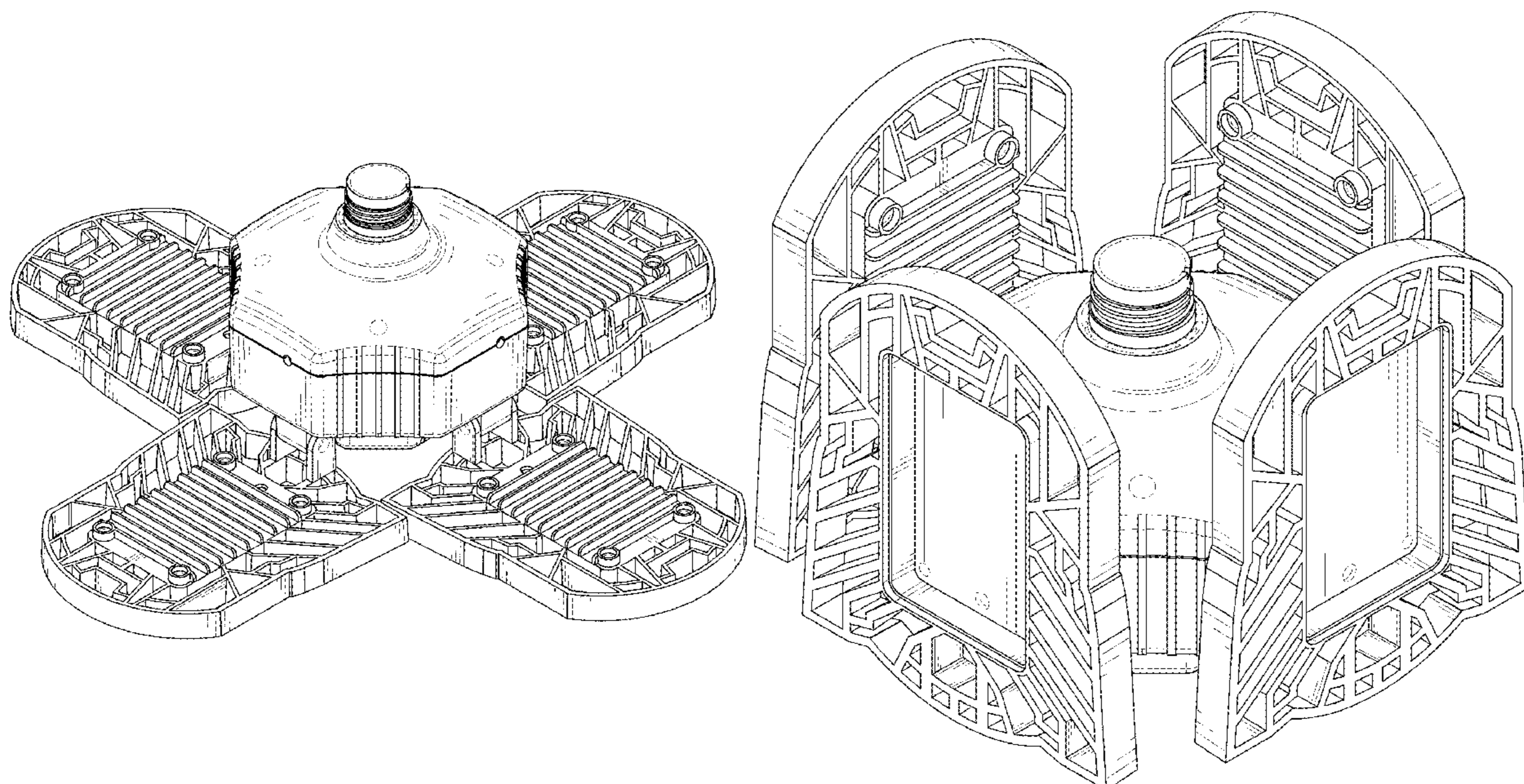
(57) **CLAIM**

The ornamental design for an LED garage light, as shown and described.

DESCRIPTION

FIG. 1 is a front and top perspective view of an LED garage light, showing my new design;
 FIG. 2 is a rear and bottom perspective view thereof,
 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is a left side elevational view thereof;
 FIG. 6 is a right side elevational view thereof;
 FIG. 7 is a top plan view thereof;
 FIG. 8 is a bottom plan view thereof; and,
 FIG. 9 is a perspective view thereof, showing the LED garage light in a folded position.
 The broken lines in the figures illustrate portions of the LED garage light that form no part of the claimed design.

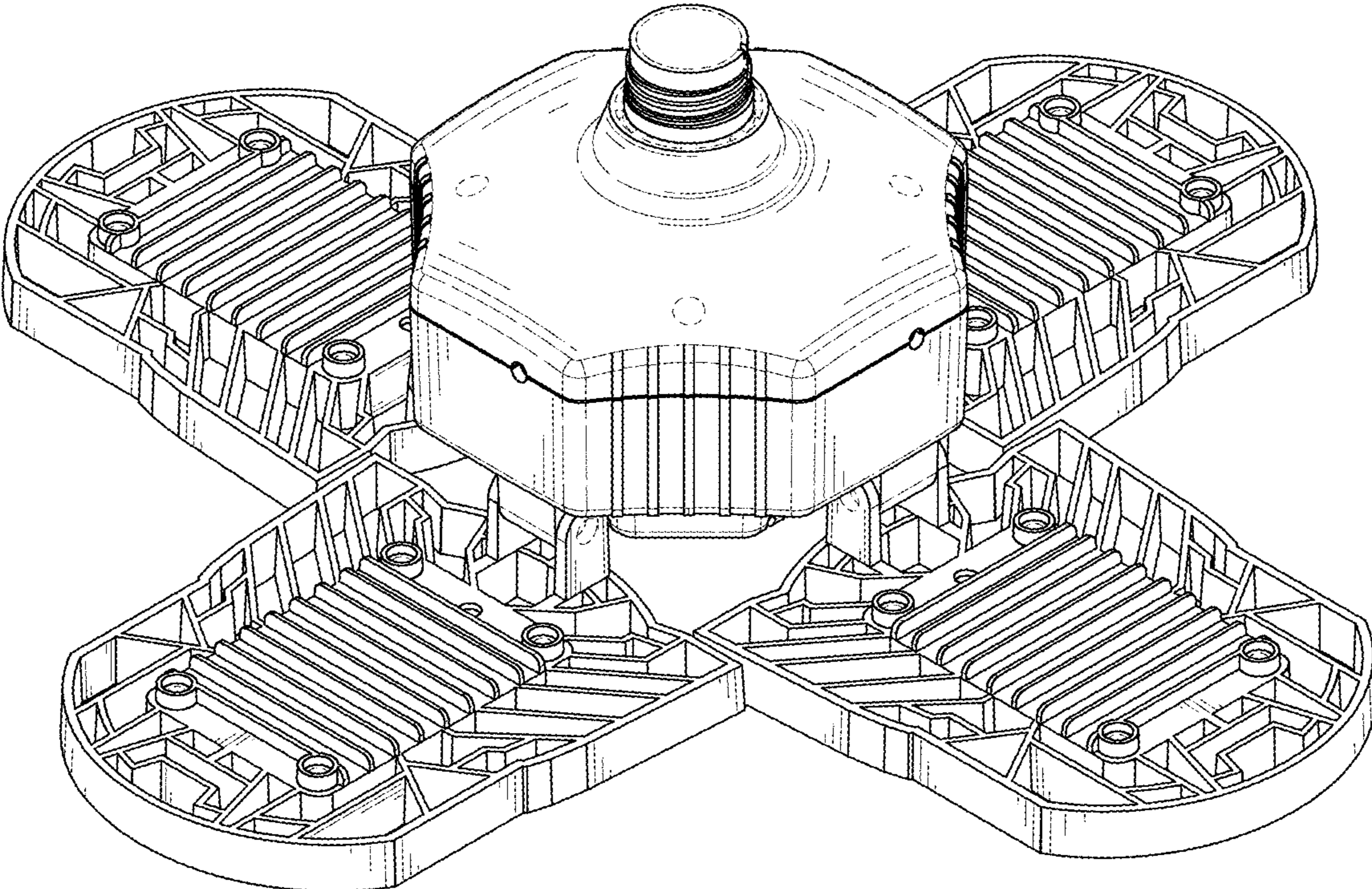

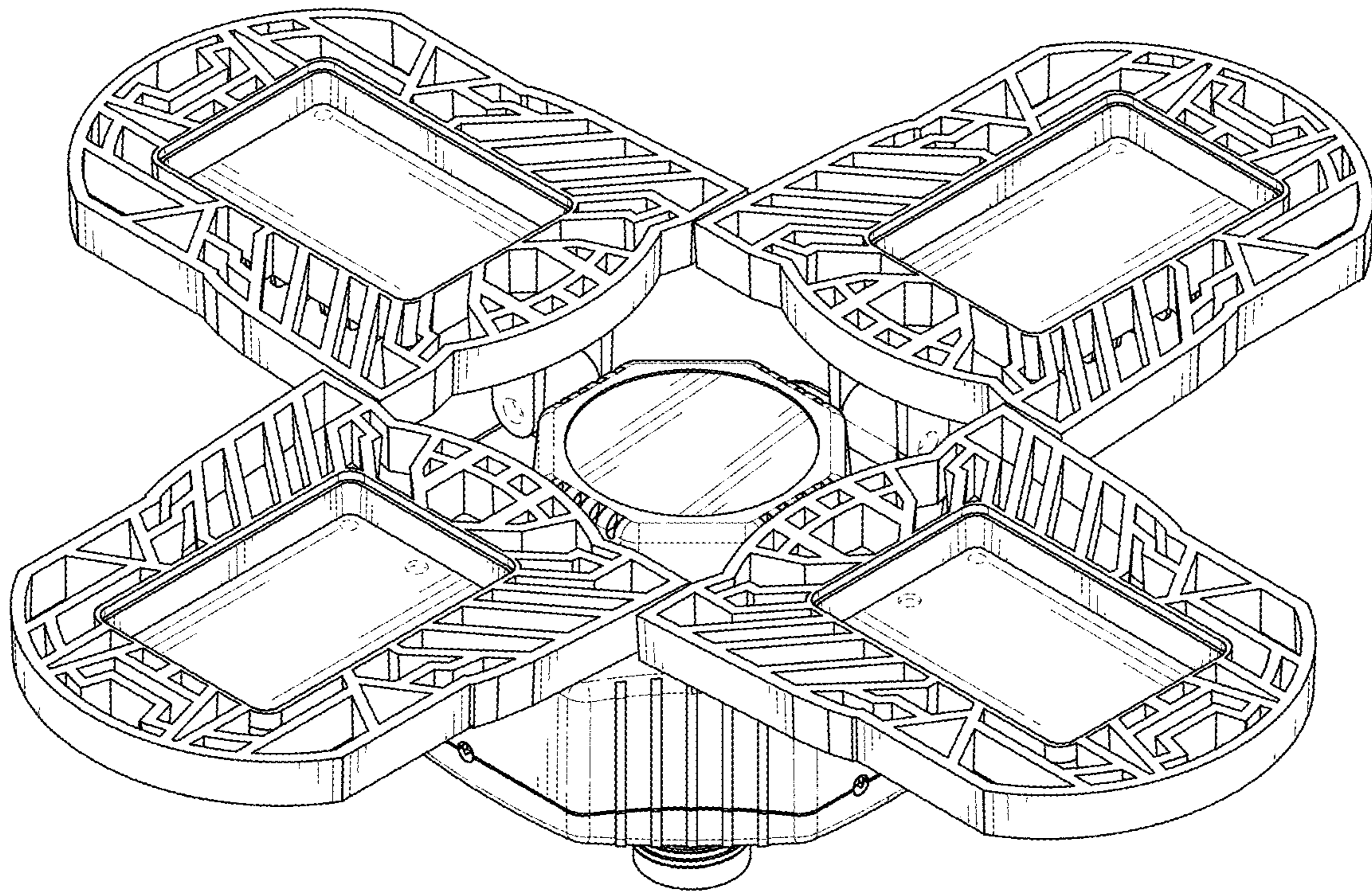

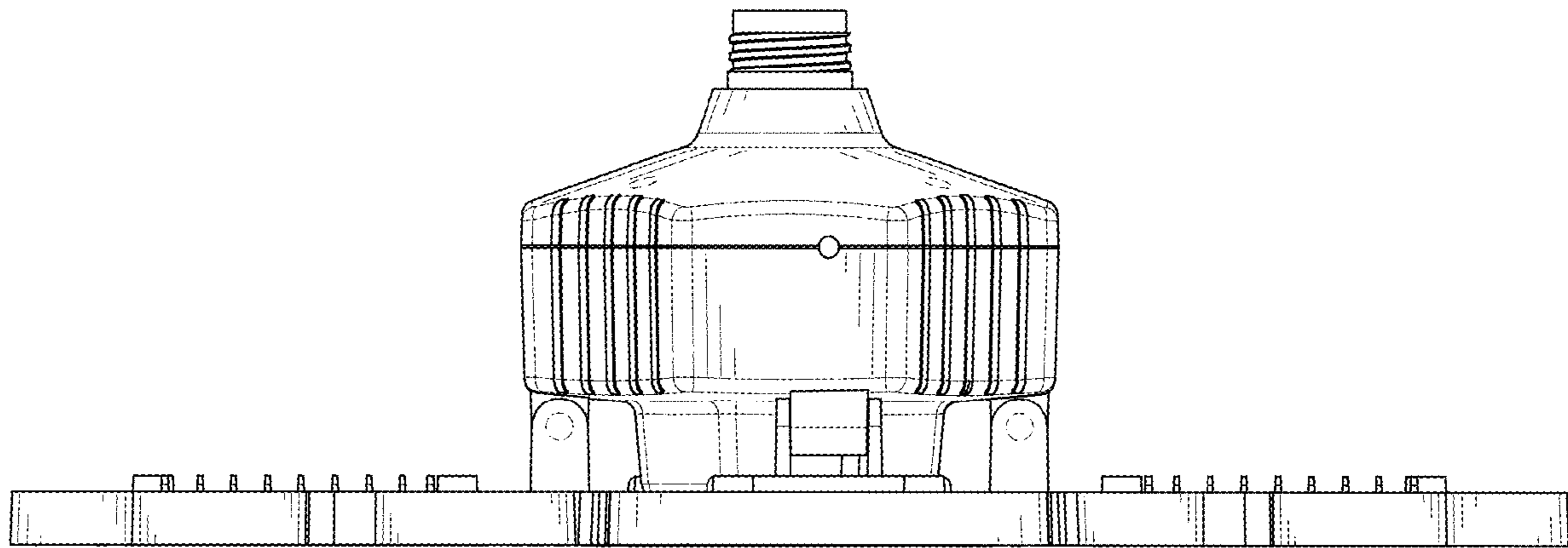

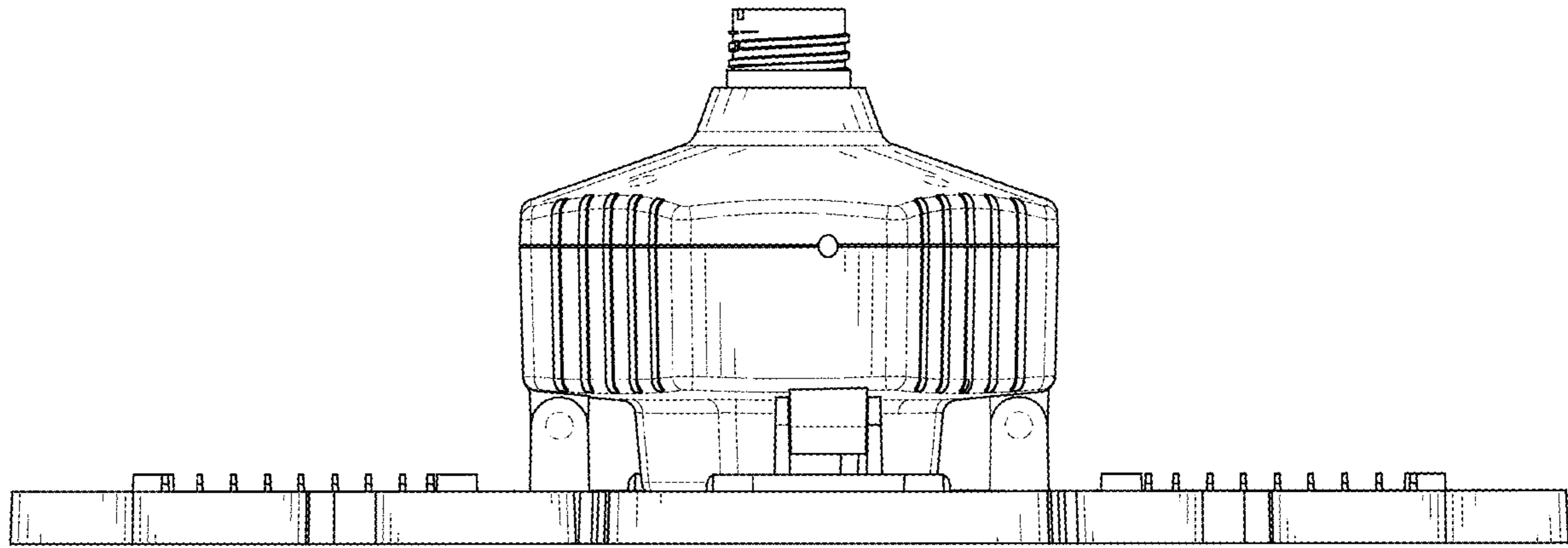

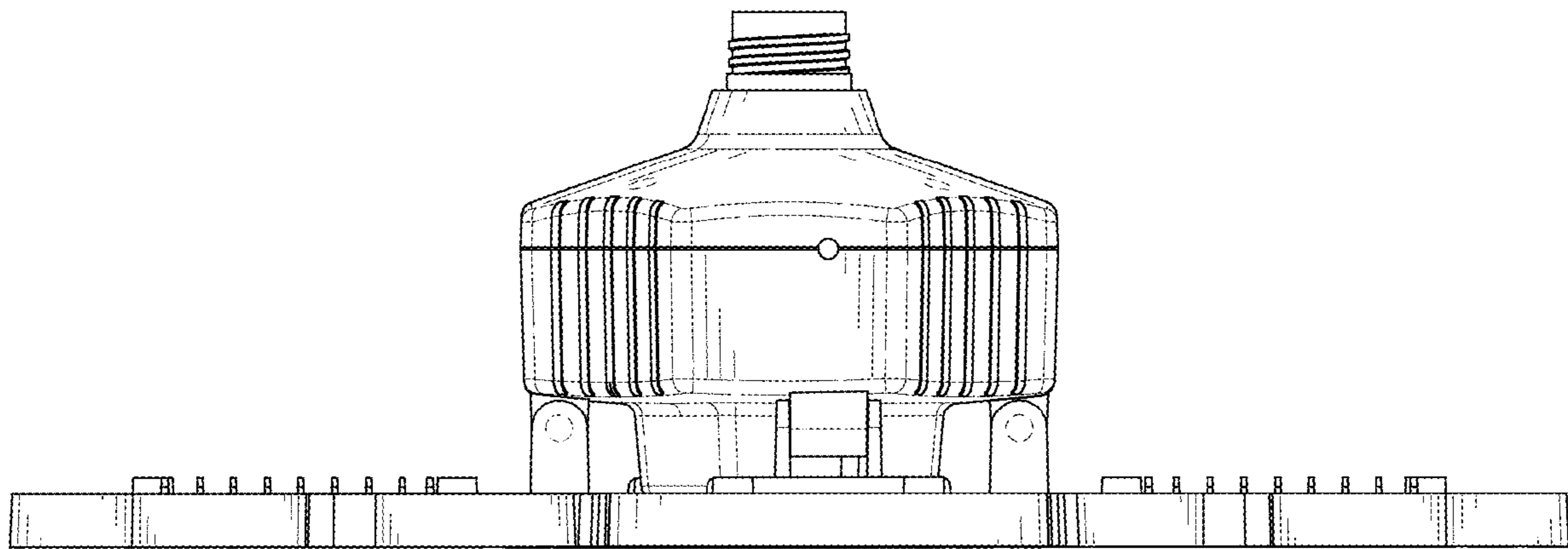

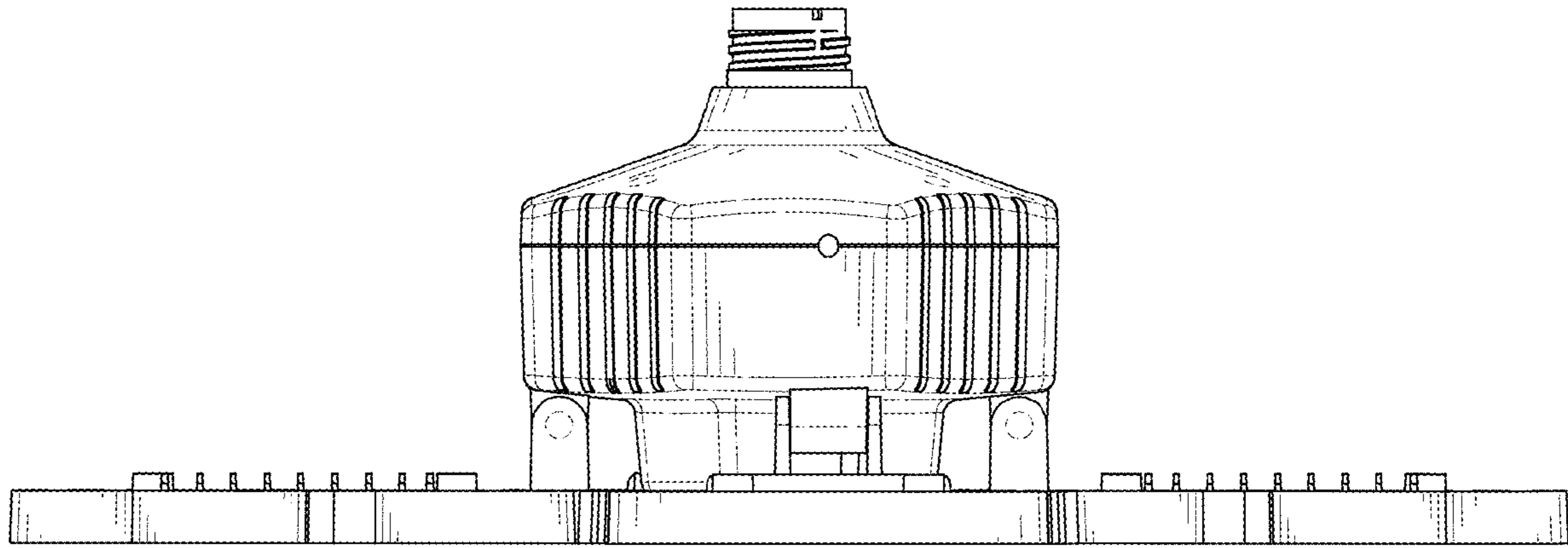

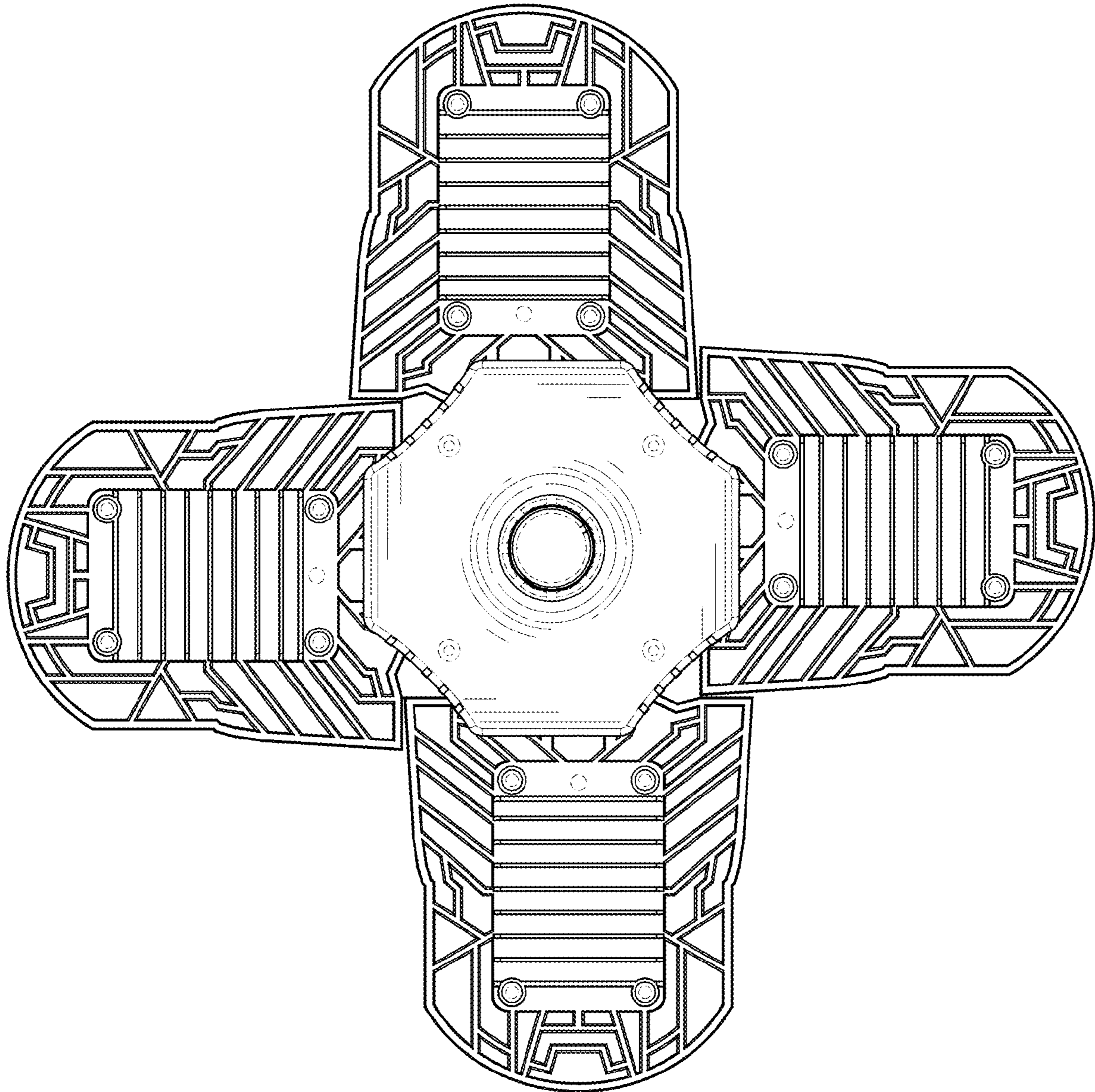

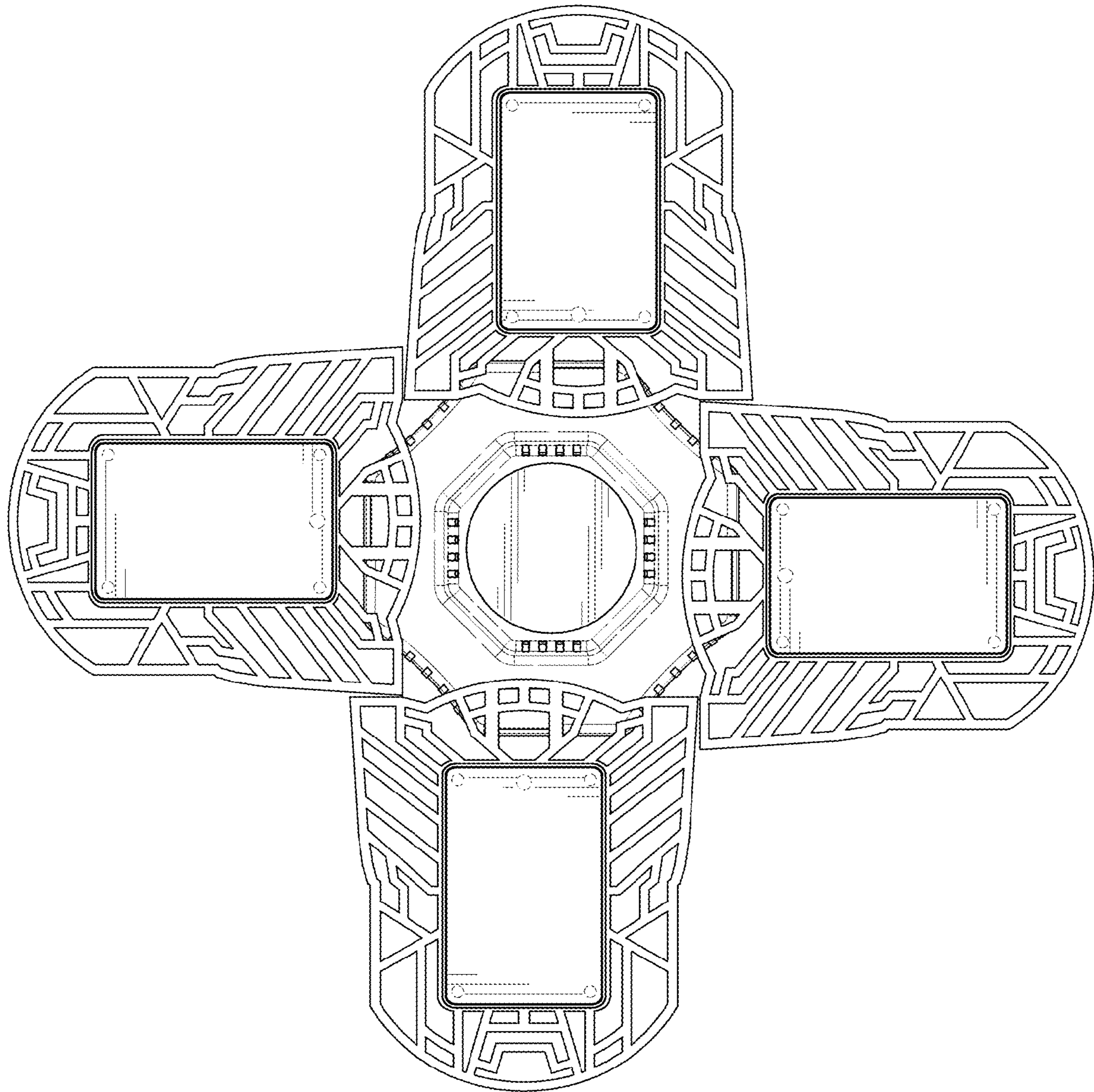

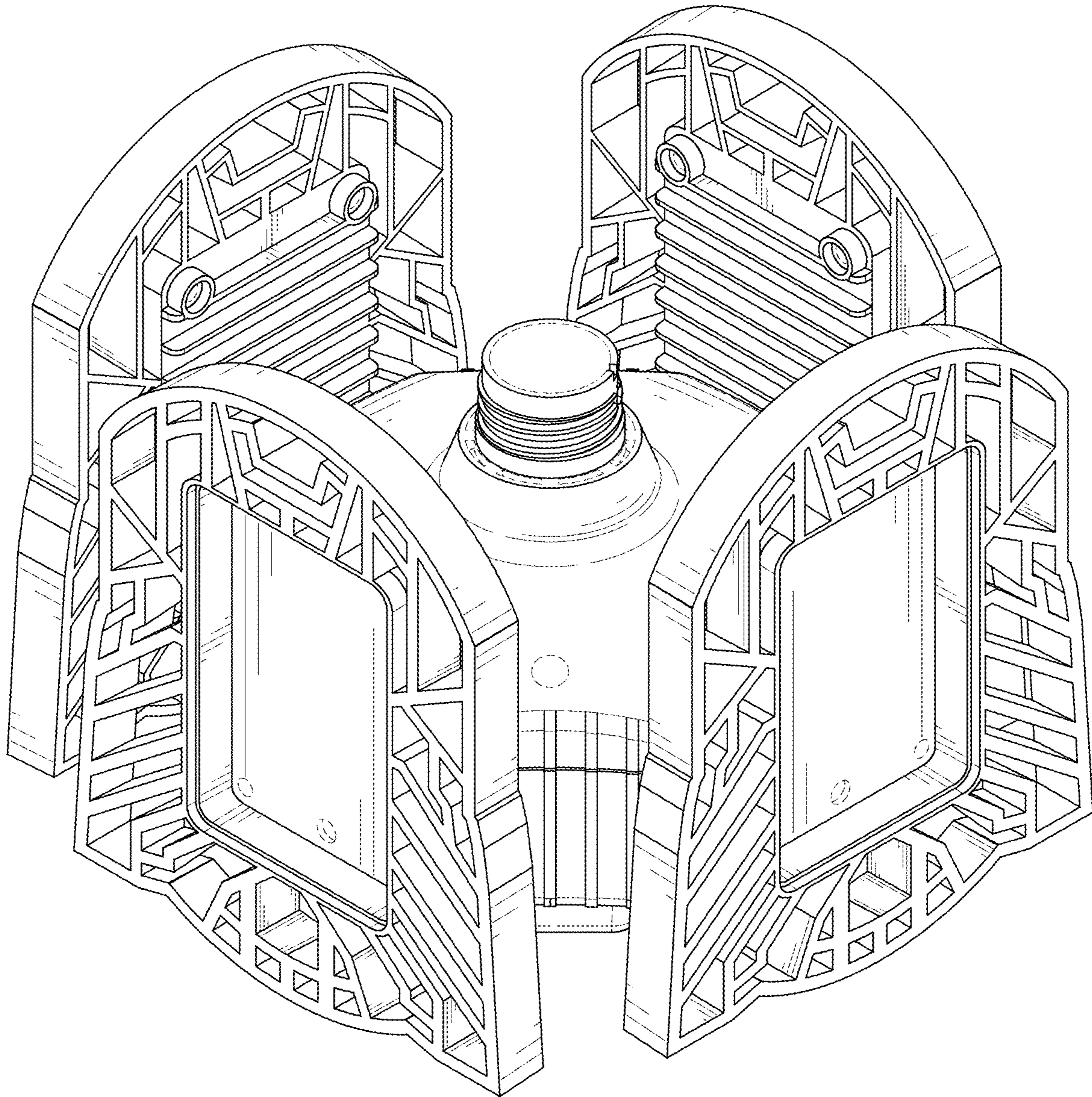
