(57) **CLAIM**

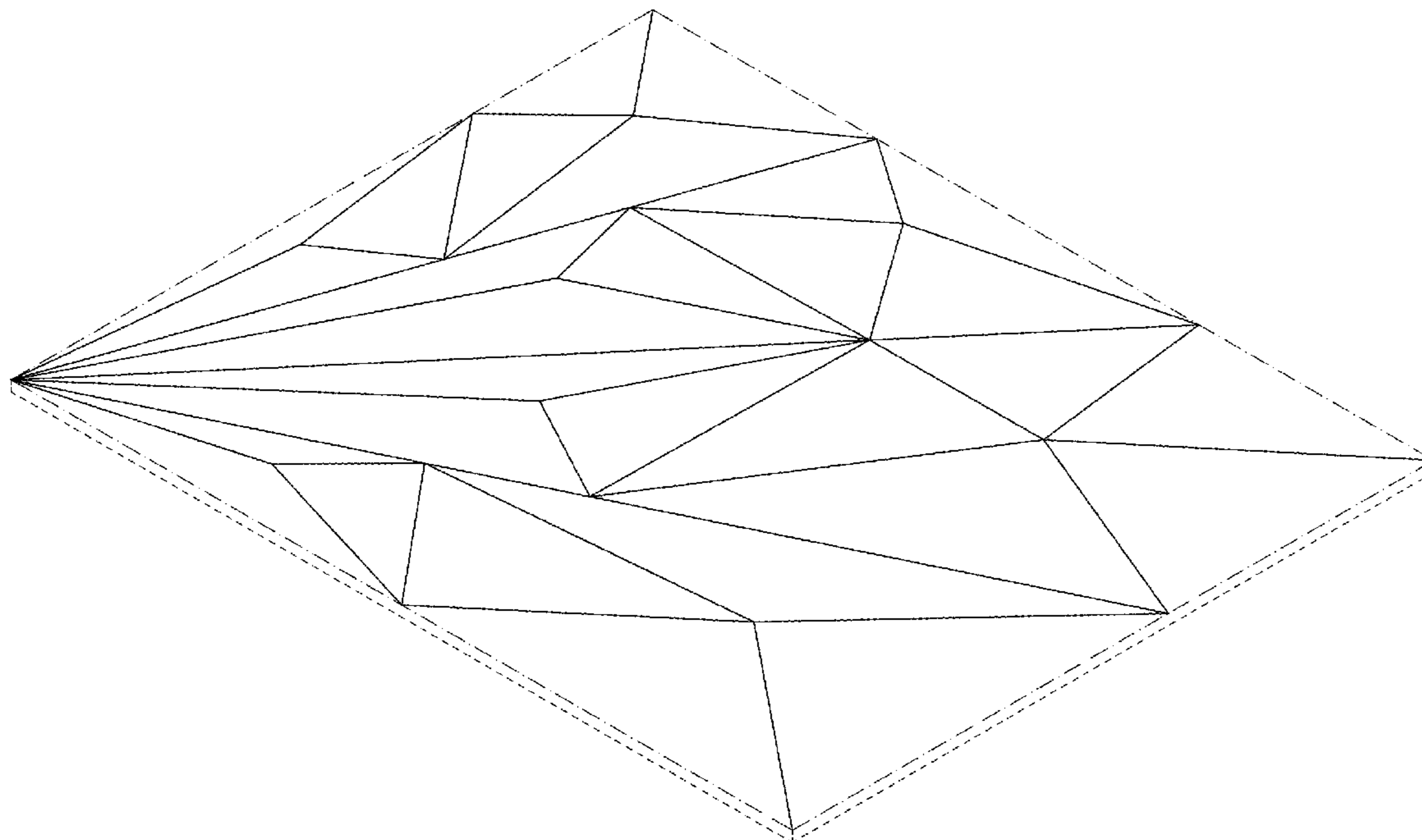
The ornamental design for a cosmetic shell, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cosmetic shell showing my design;
FIG. 2 is a top view thereof;
FIG. 3 is a bottom view thereof;

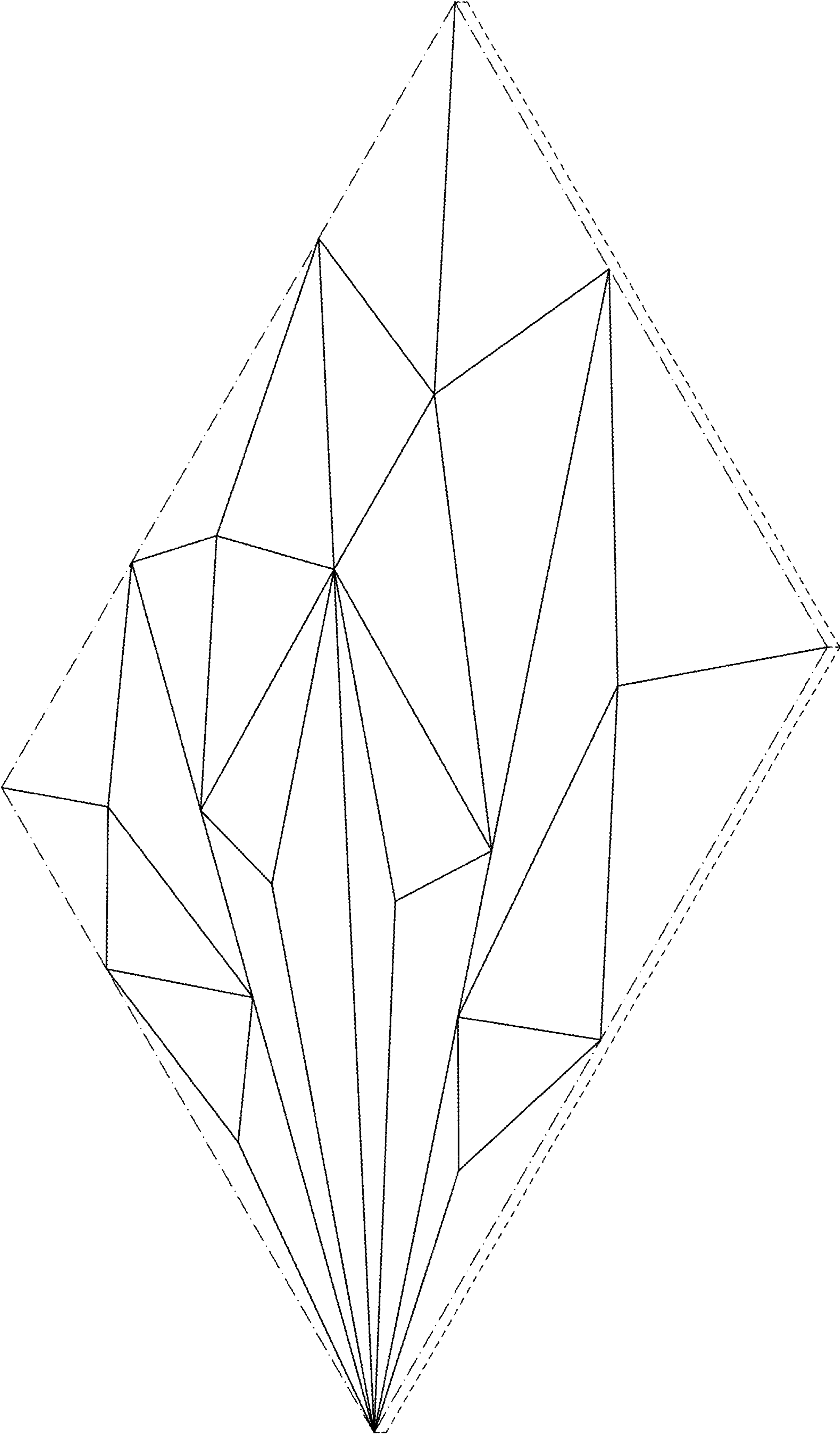

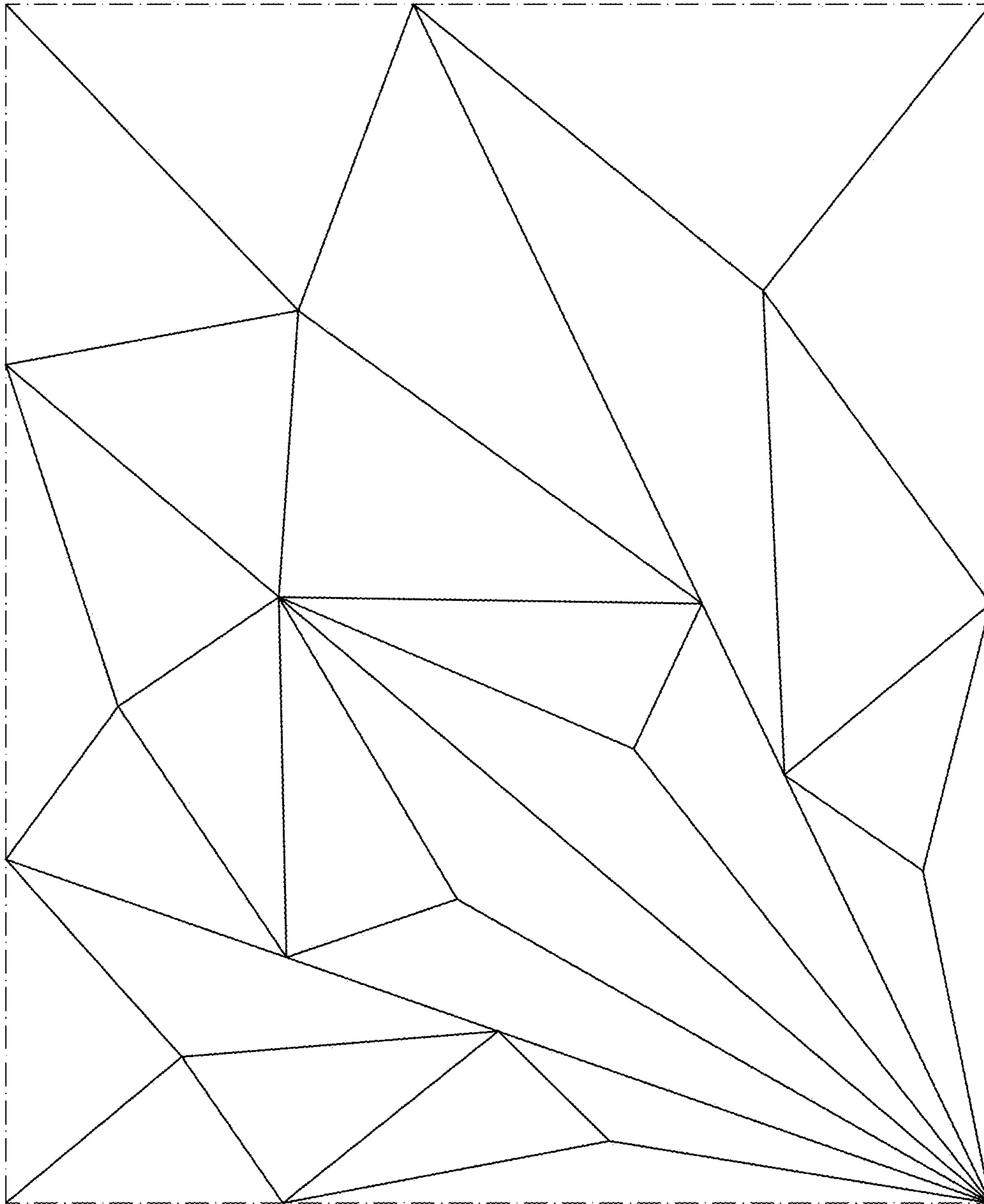

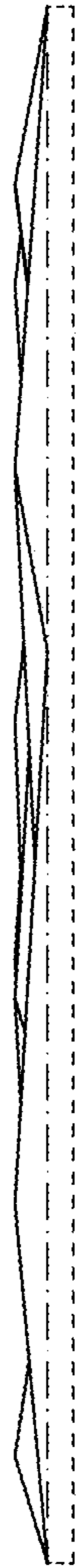

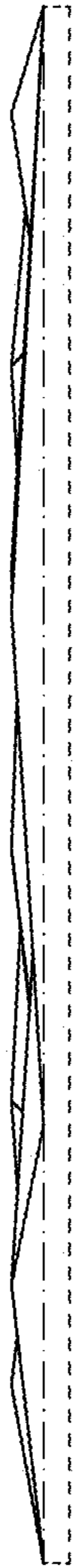

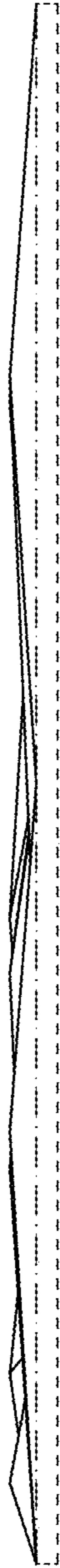

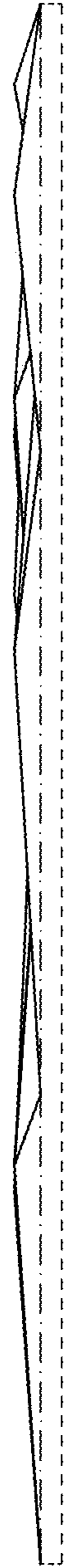
