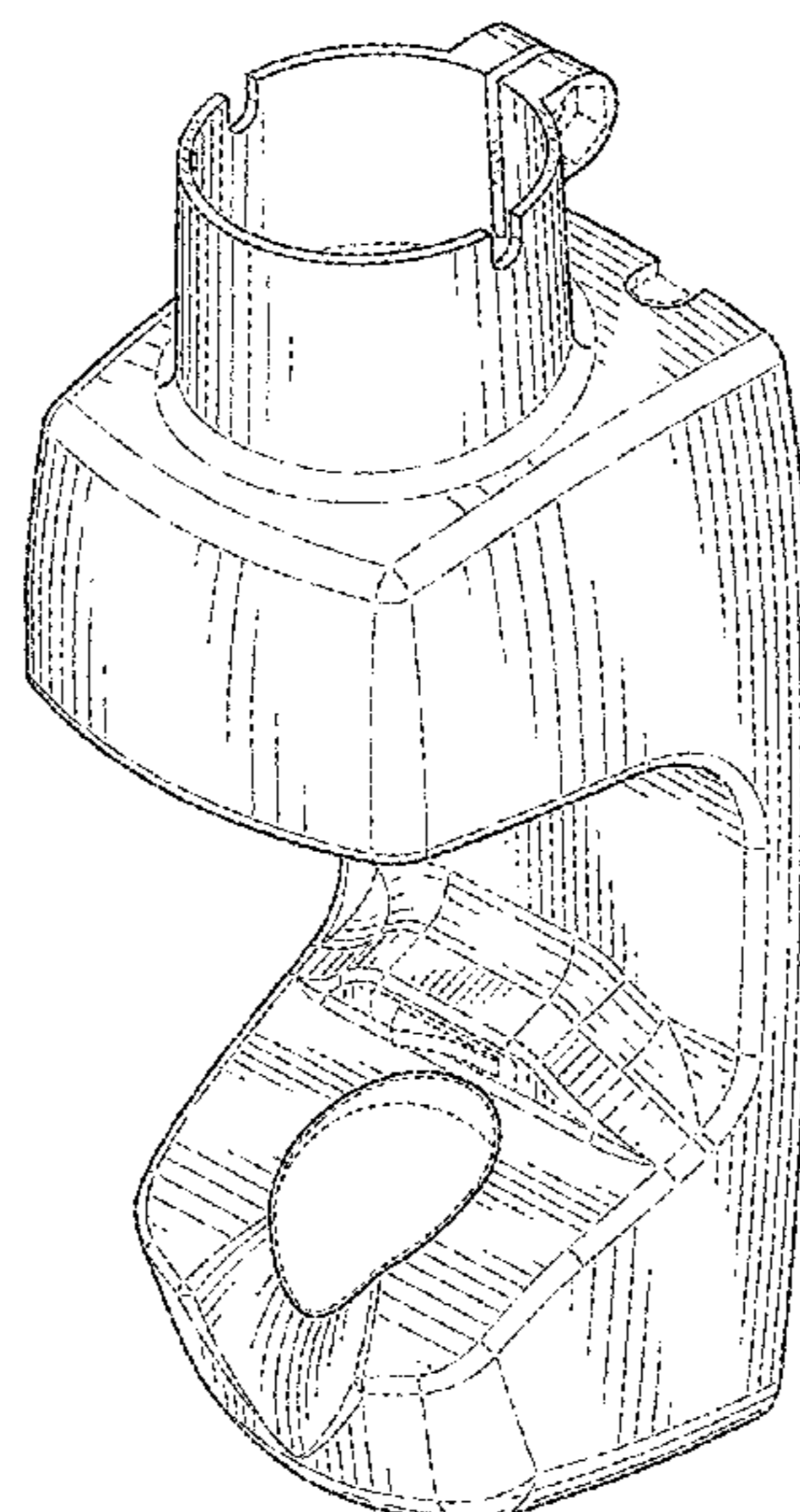
(57) **CLAIM**

The ornamental design for a hose valve assembly for vacuum cleaning device, as shown and described.

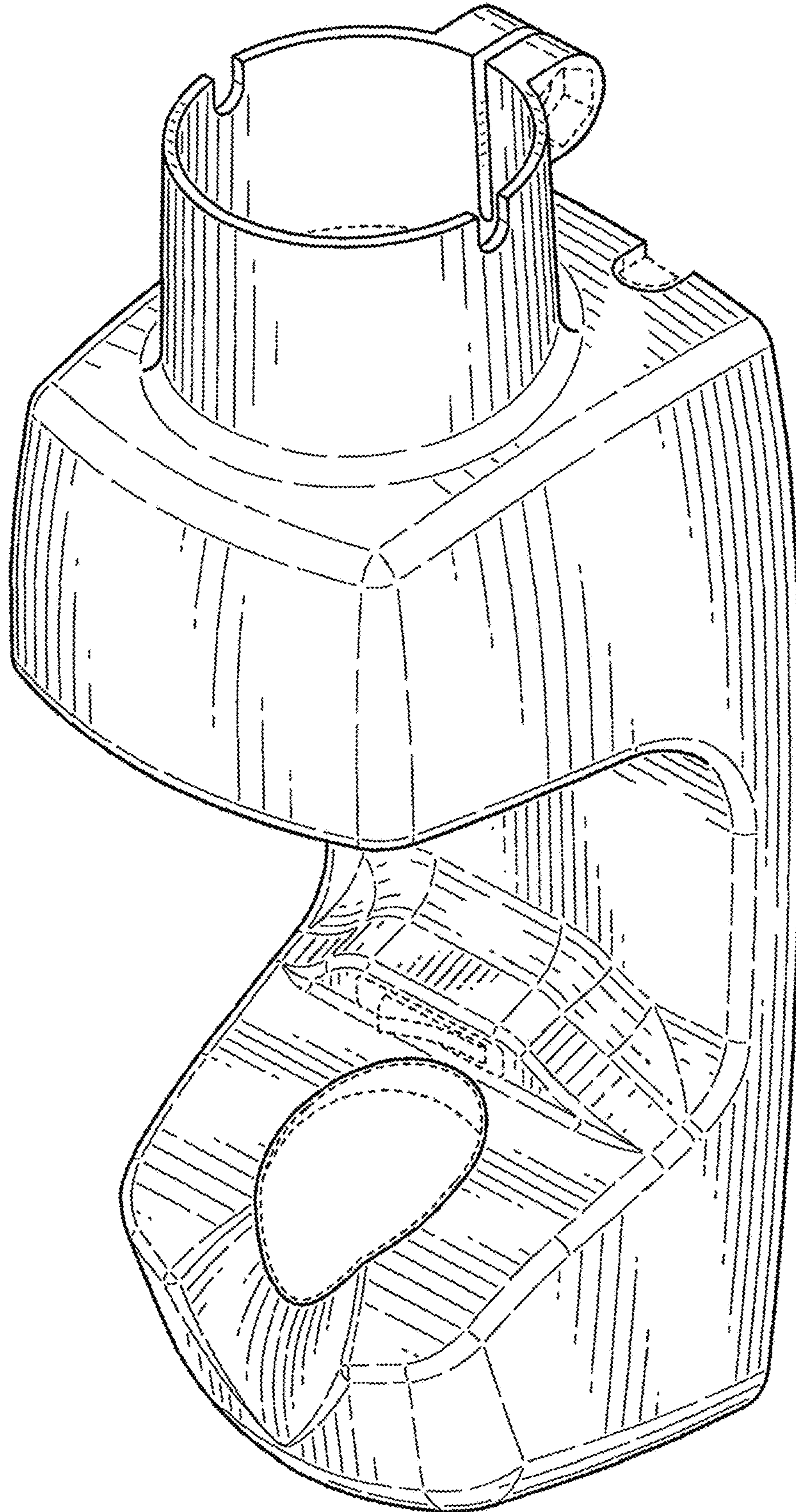
DESCRIPTION

1. Hose valve assembly for vacuum cleaning device
1.1 : Front, top, right
1.3 : Rear
Fig. **1.1** is a front, top, right side isometric view of a hose valve assembly for vacuum cleaning device in accordance with our design; fig. **1.2** is a front elevation view thereof; fig. **1.3** is a rear elevation view thereof; fig. **1.4** is a left side elevation view thereof; fig. **1.5** is a right side elevation view thereof; fig. **1.6** is a top plan view thereof; and fig. **1.7** is a bottom plan view thereof; the broken lines illustrate portions of the hose valve assembly for vacuum cleaning device which form no part of the claimed design.

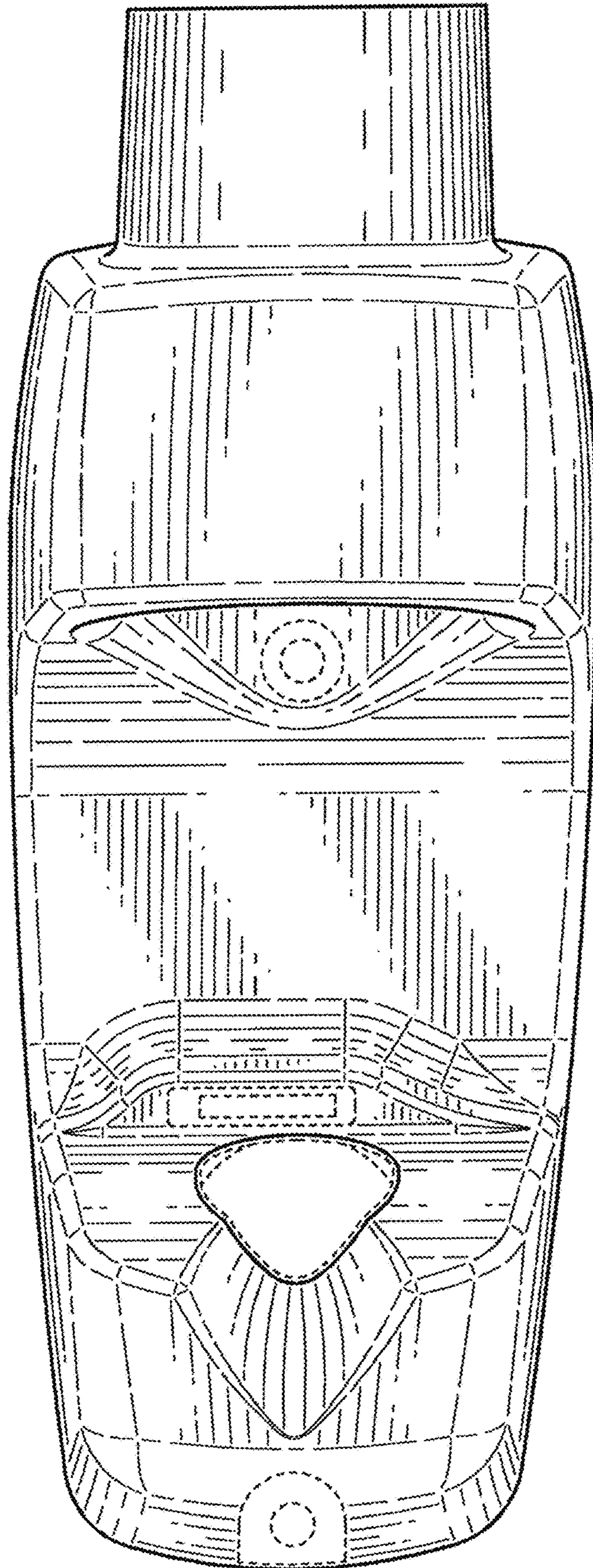

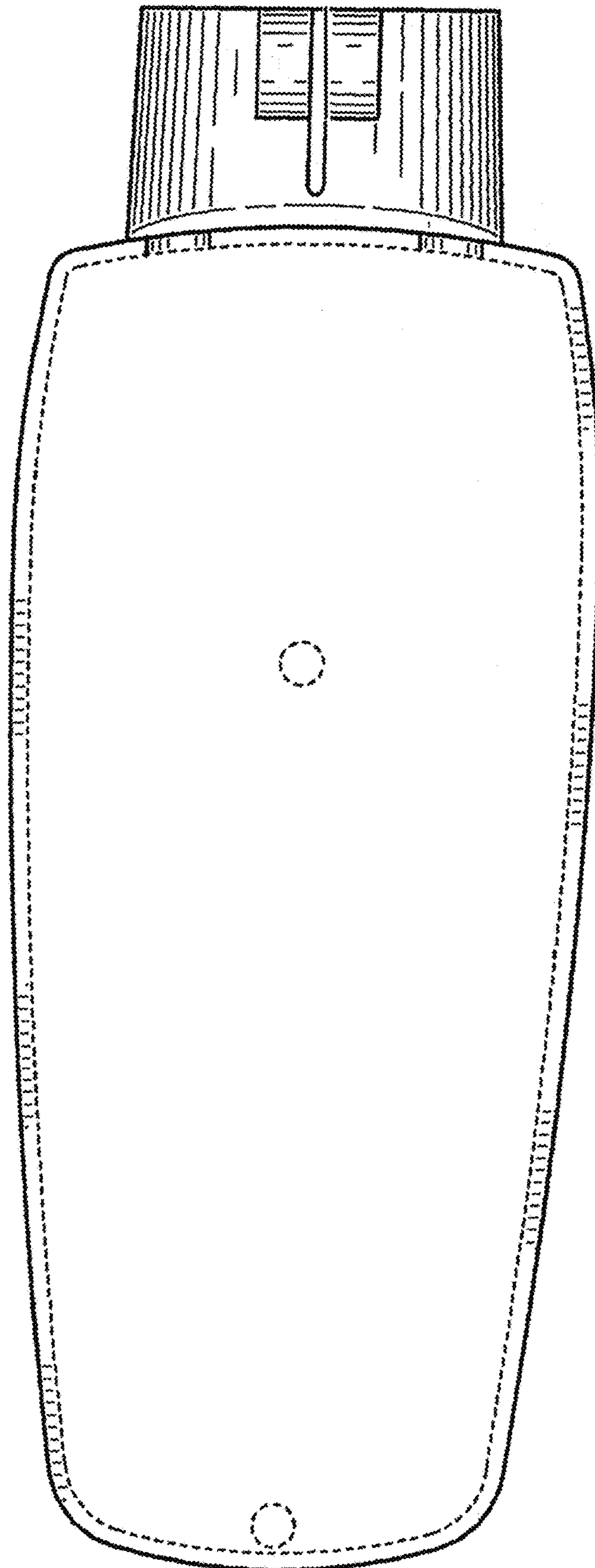

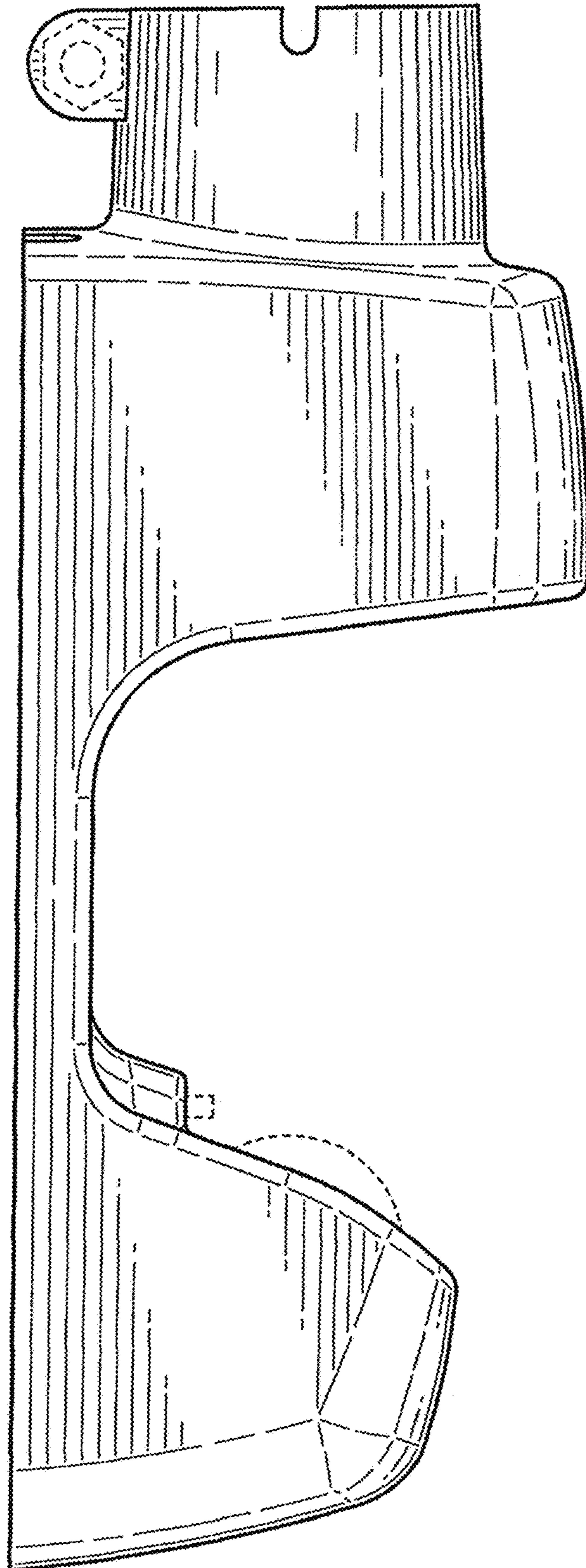

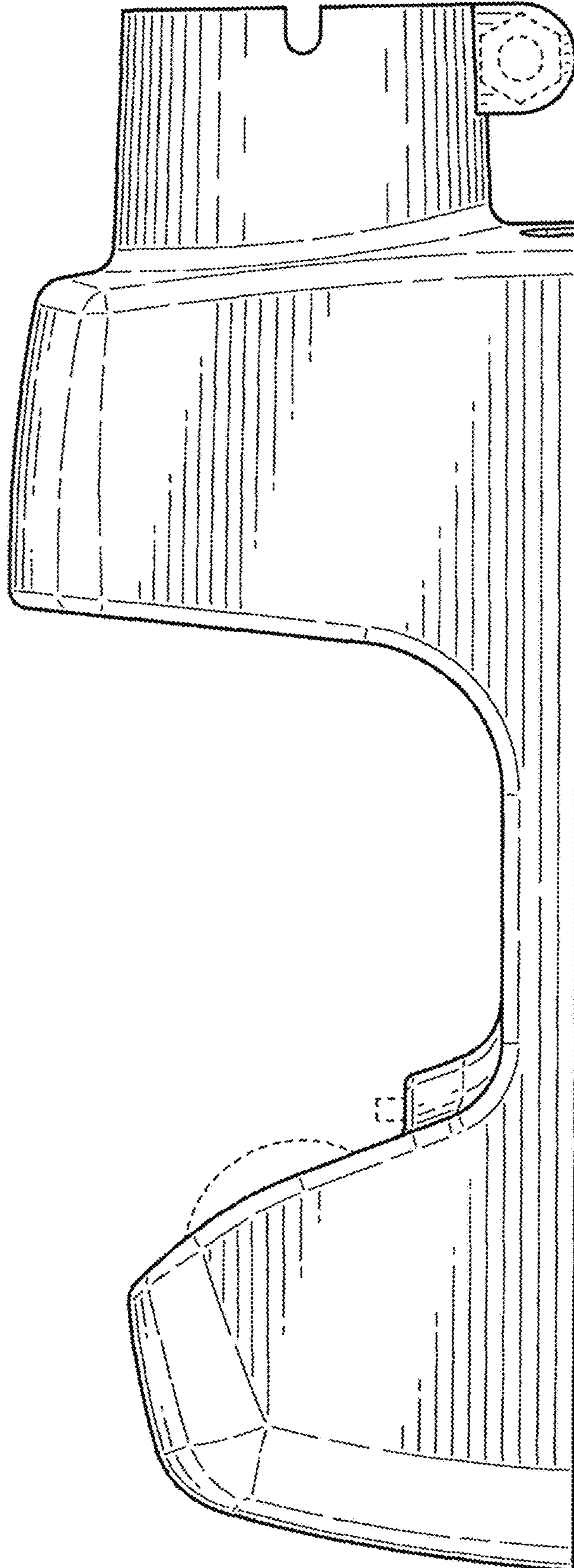

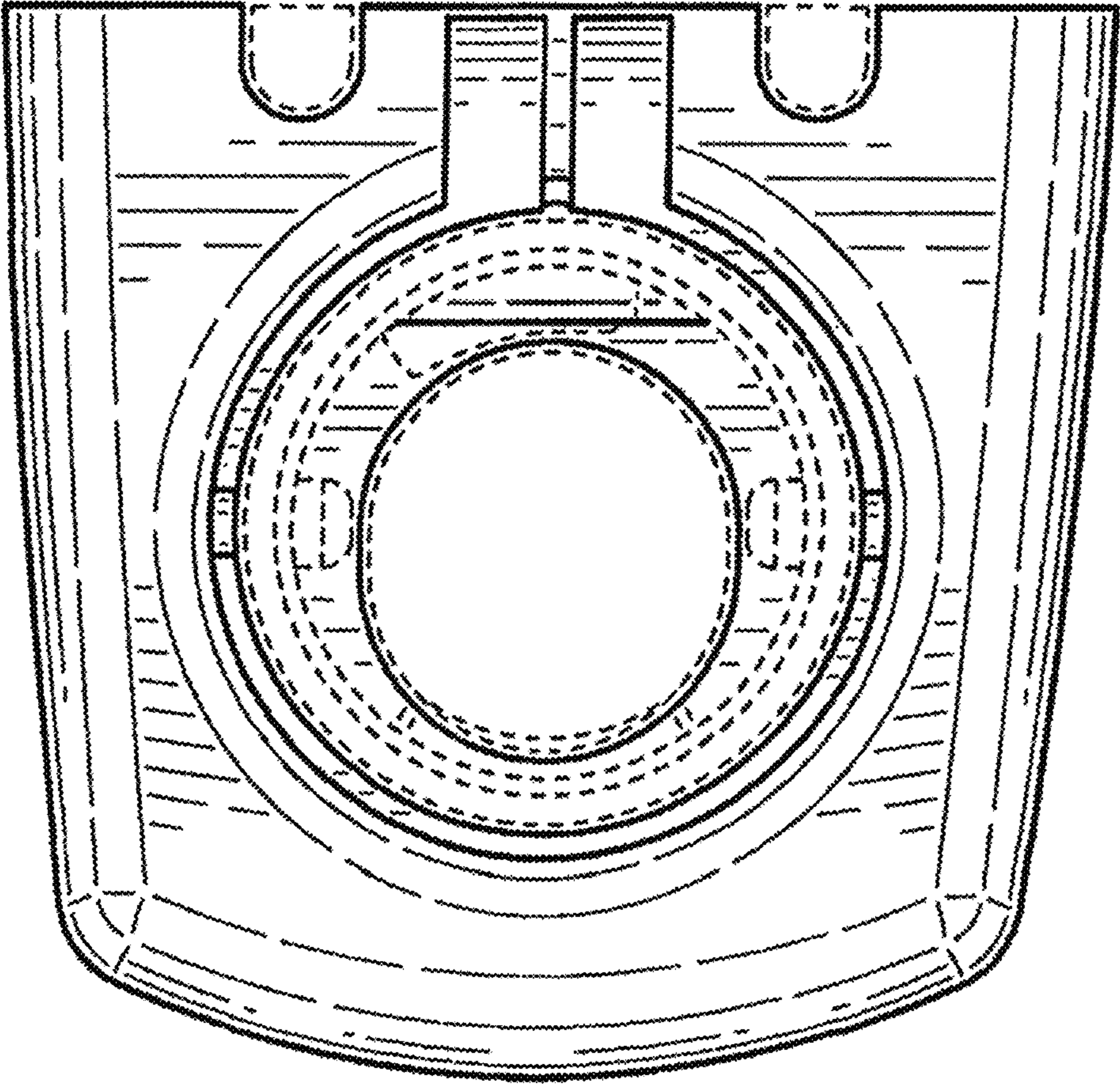
