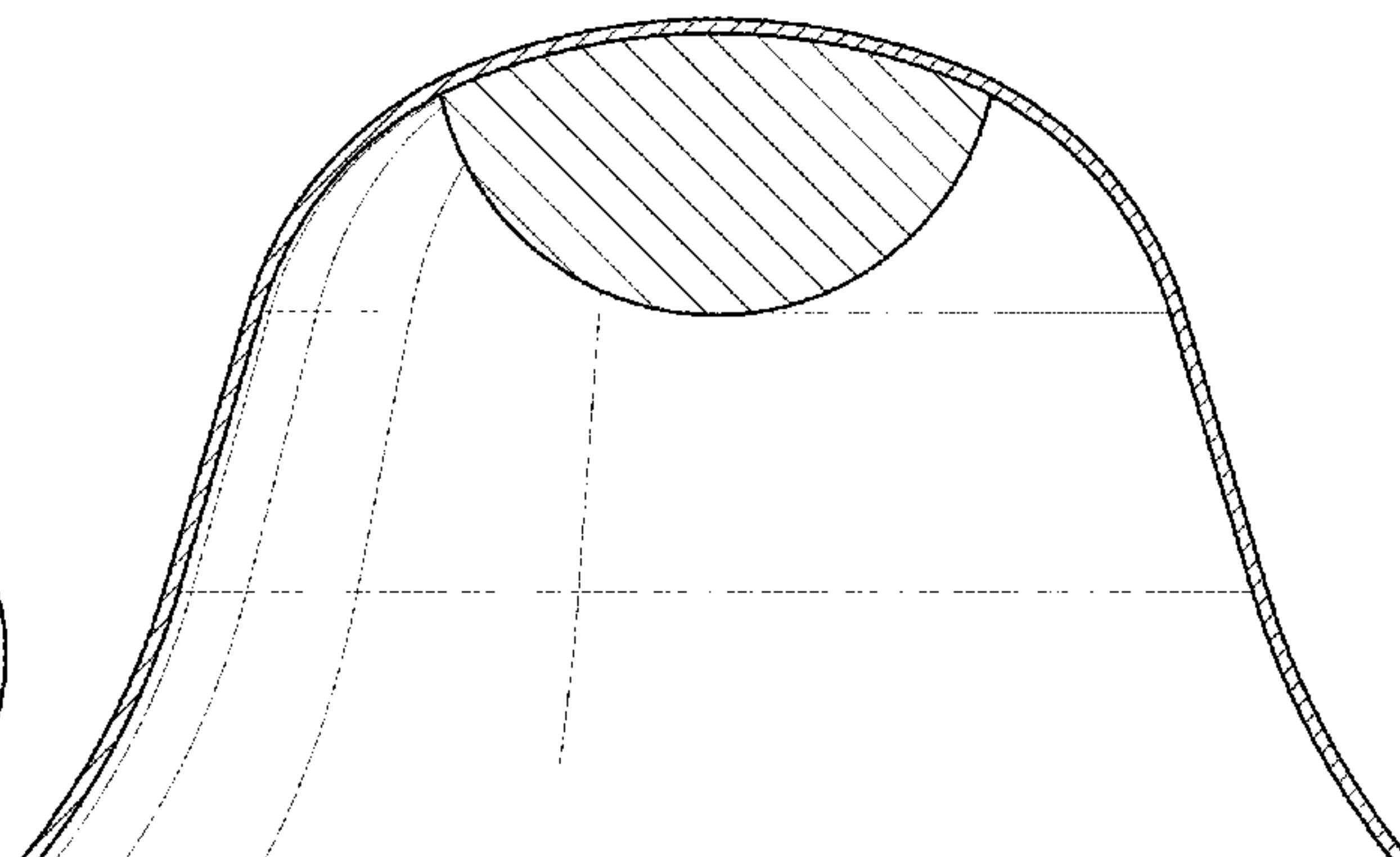
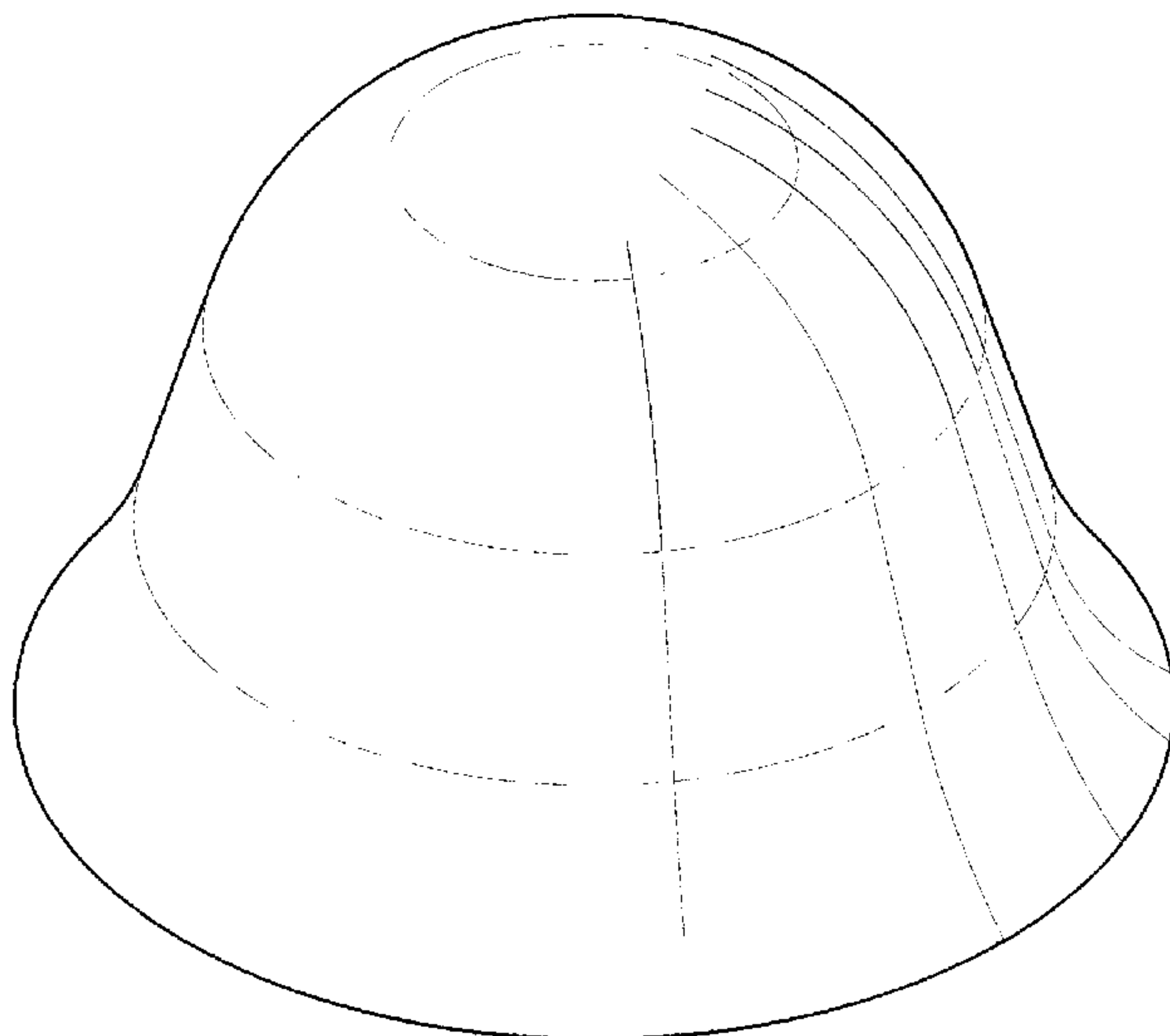
(57) **CLAIM**

I claim the ornamental design for a wipe, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view for a wipe showing my new design;
FIG. 2 is a side elevation view thereof;

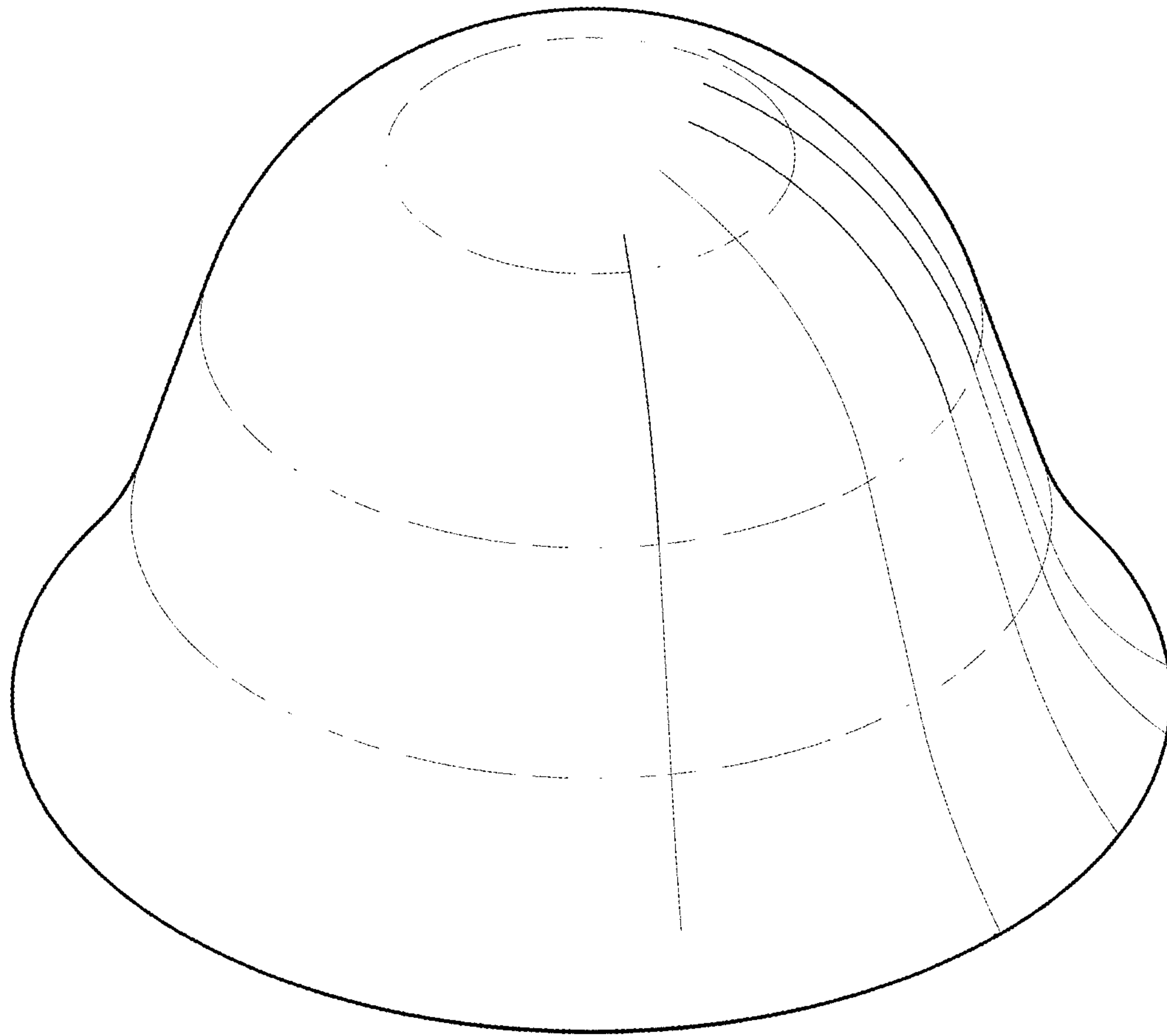

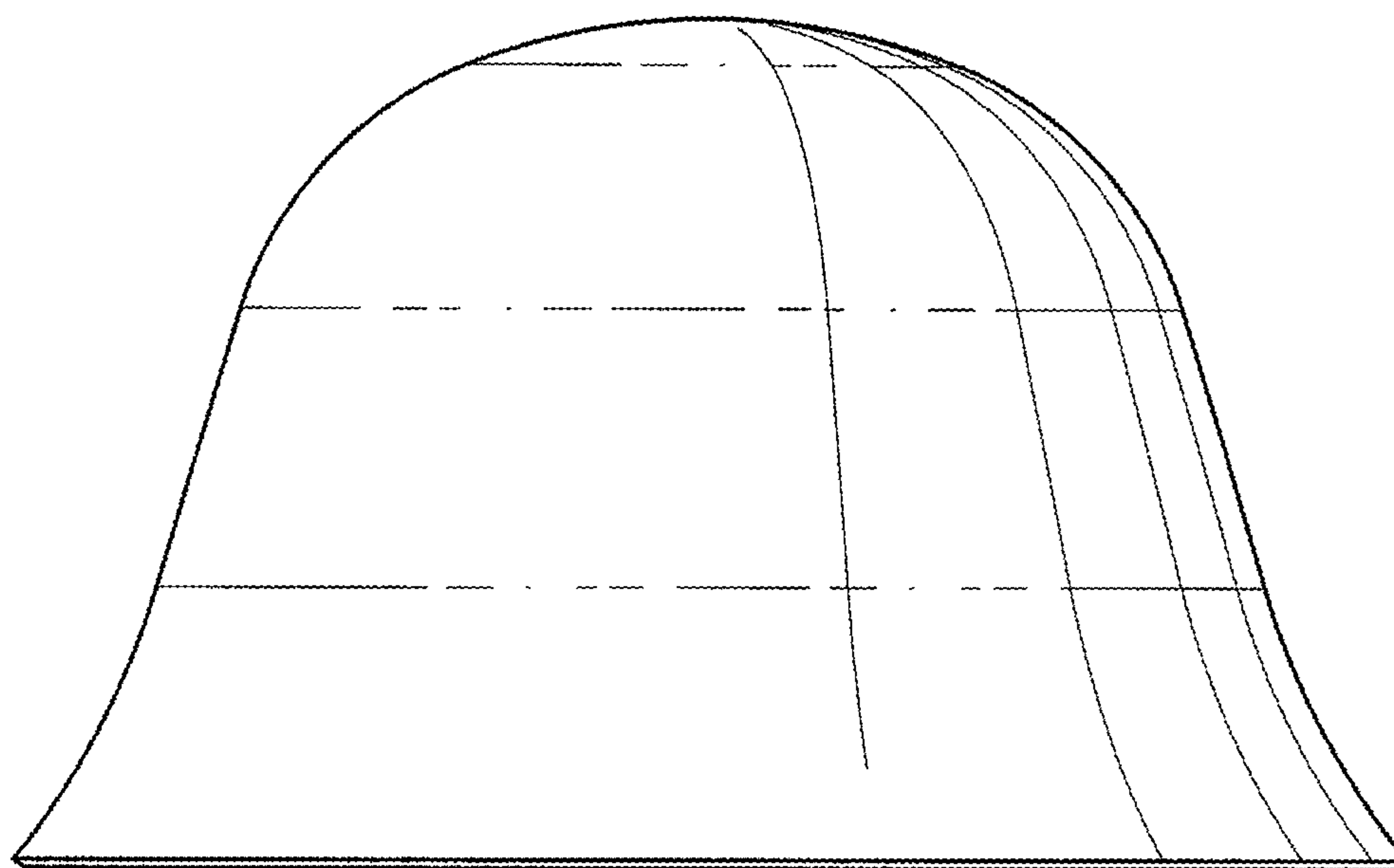

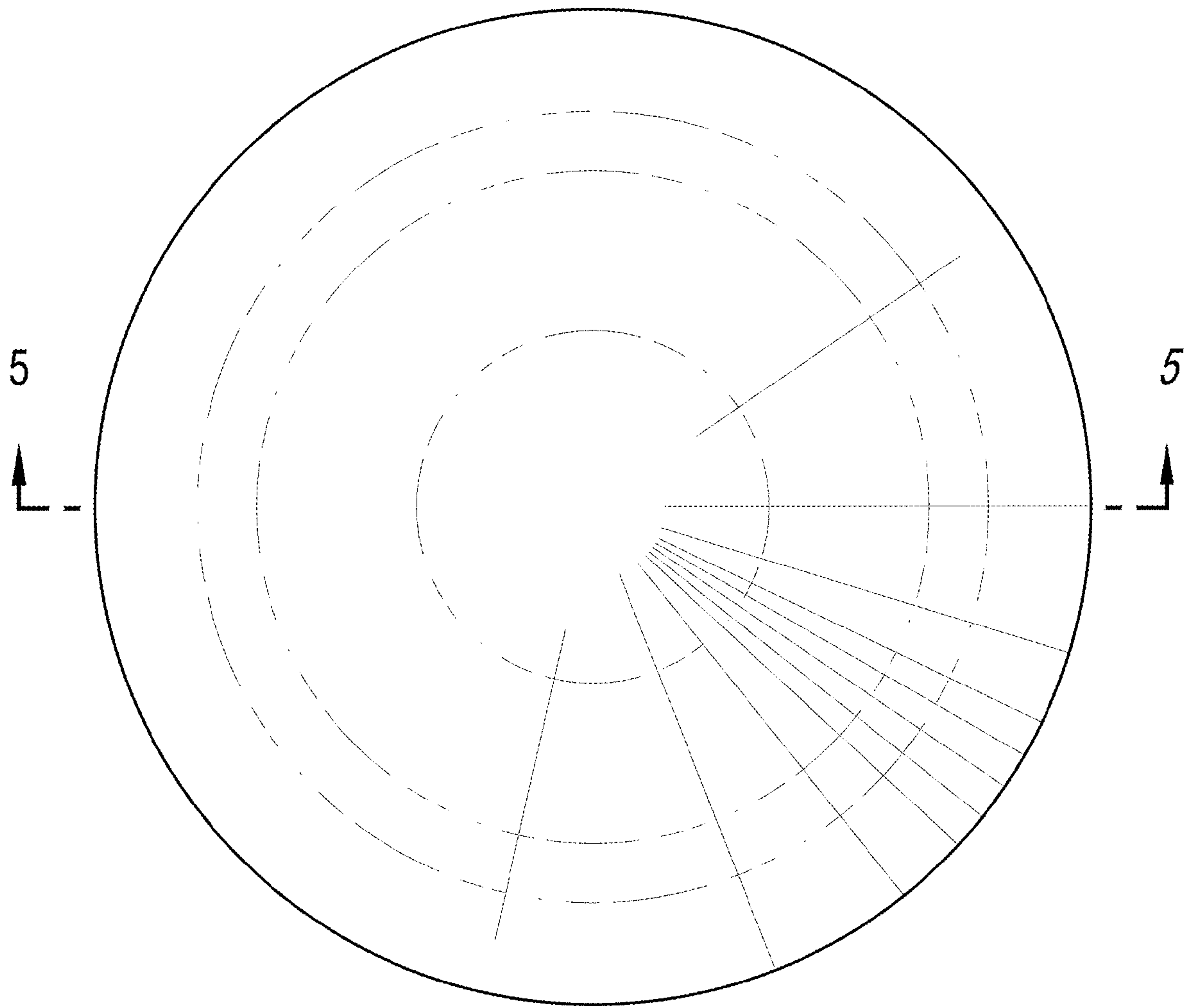

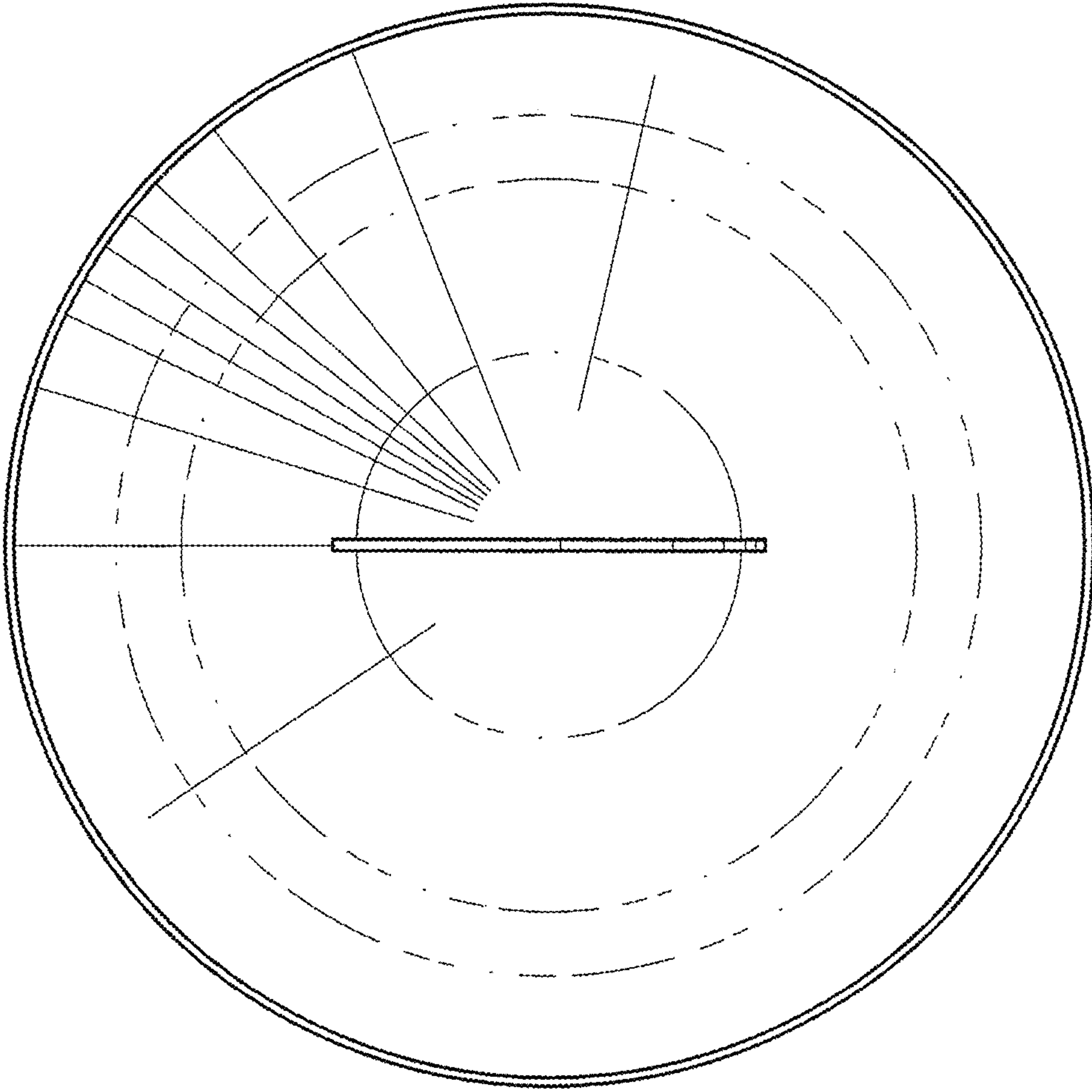

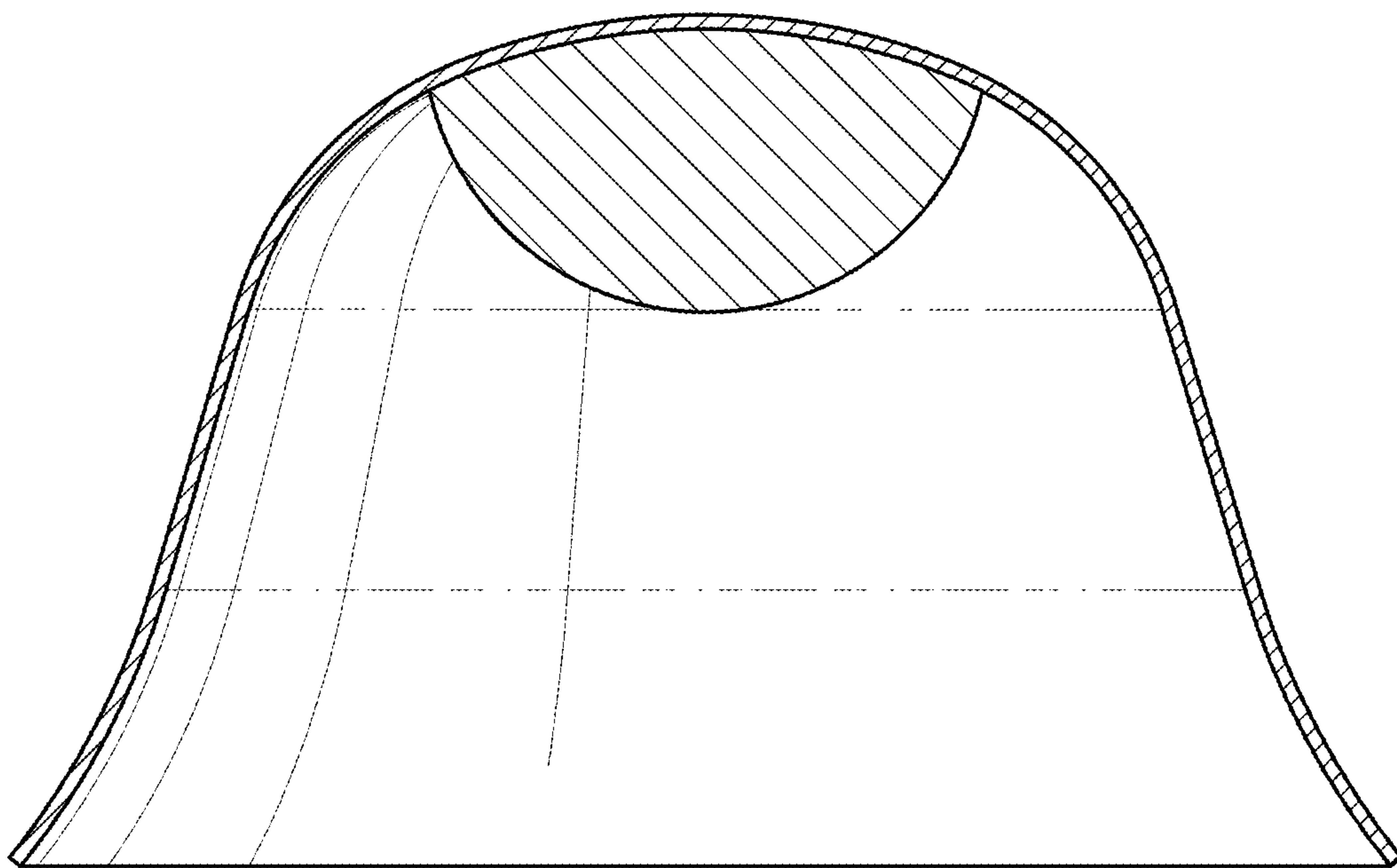
