FIG. 6 shows a rear elevation view thereof.

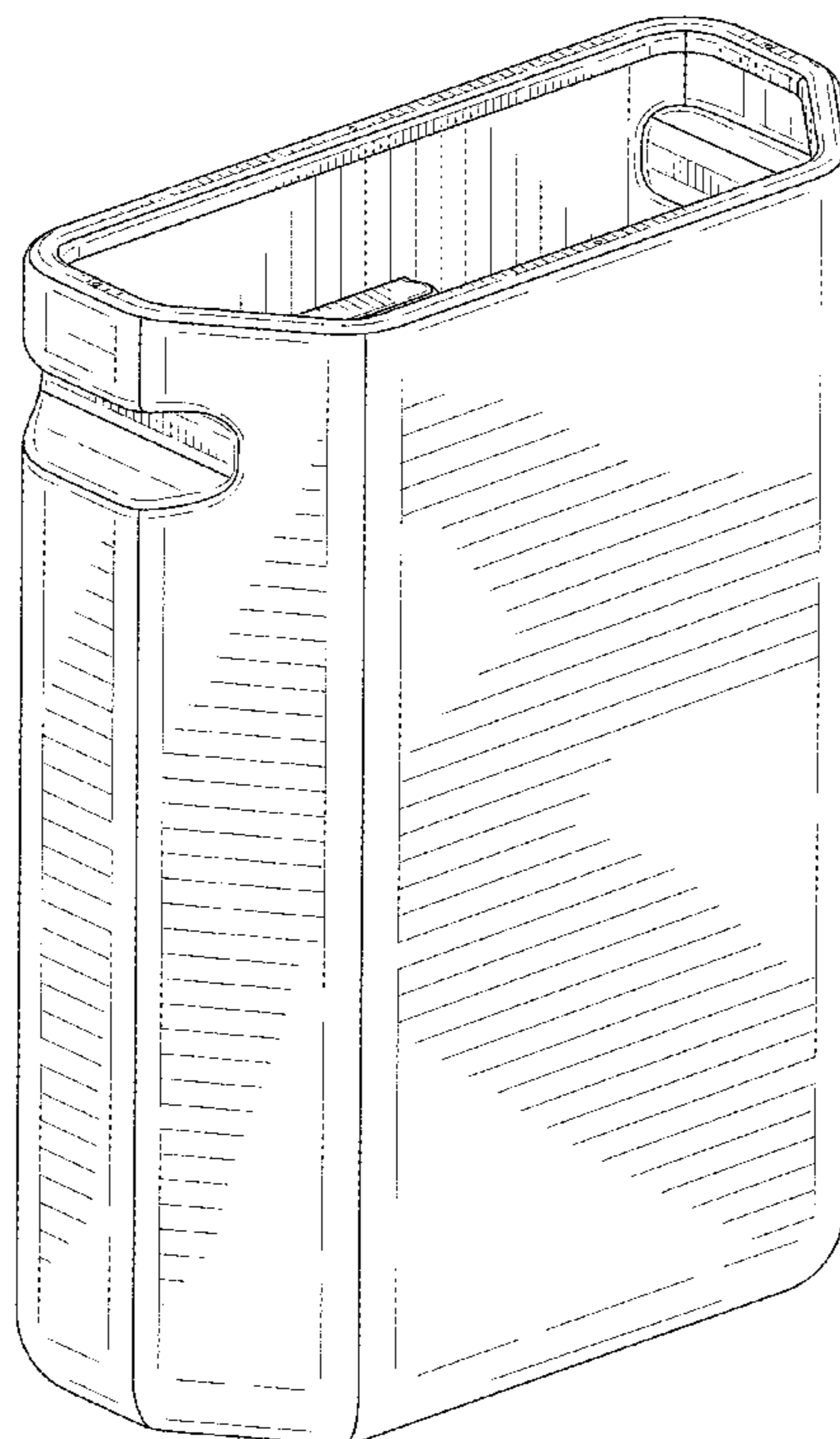
FIG. 7 shows a bottom plan view thereof.

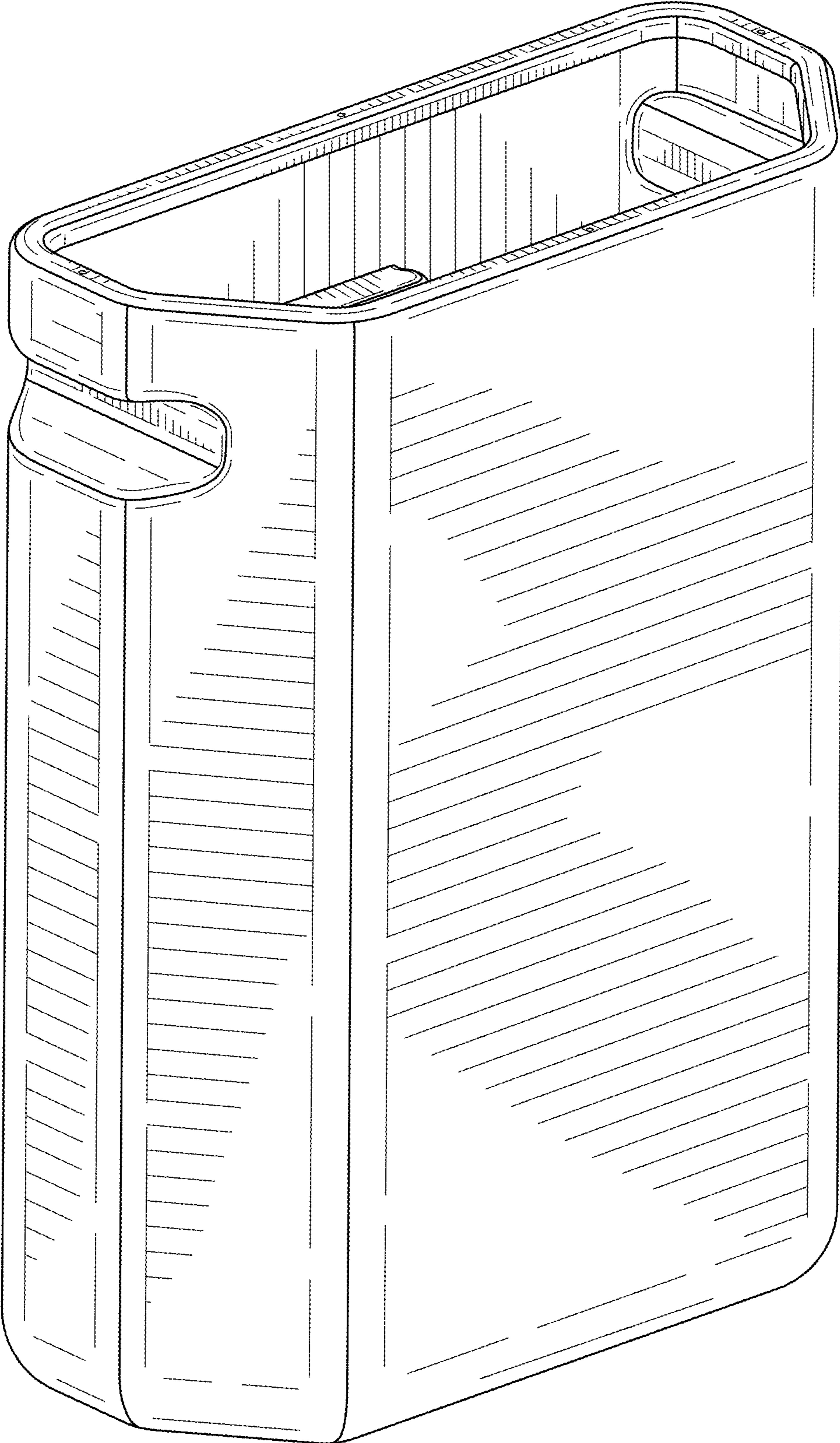

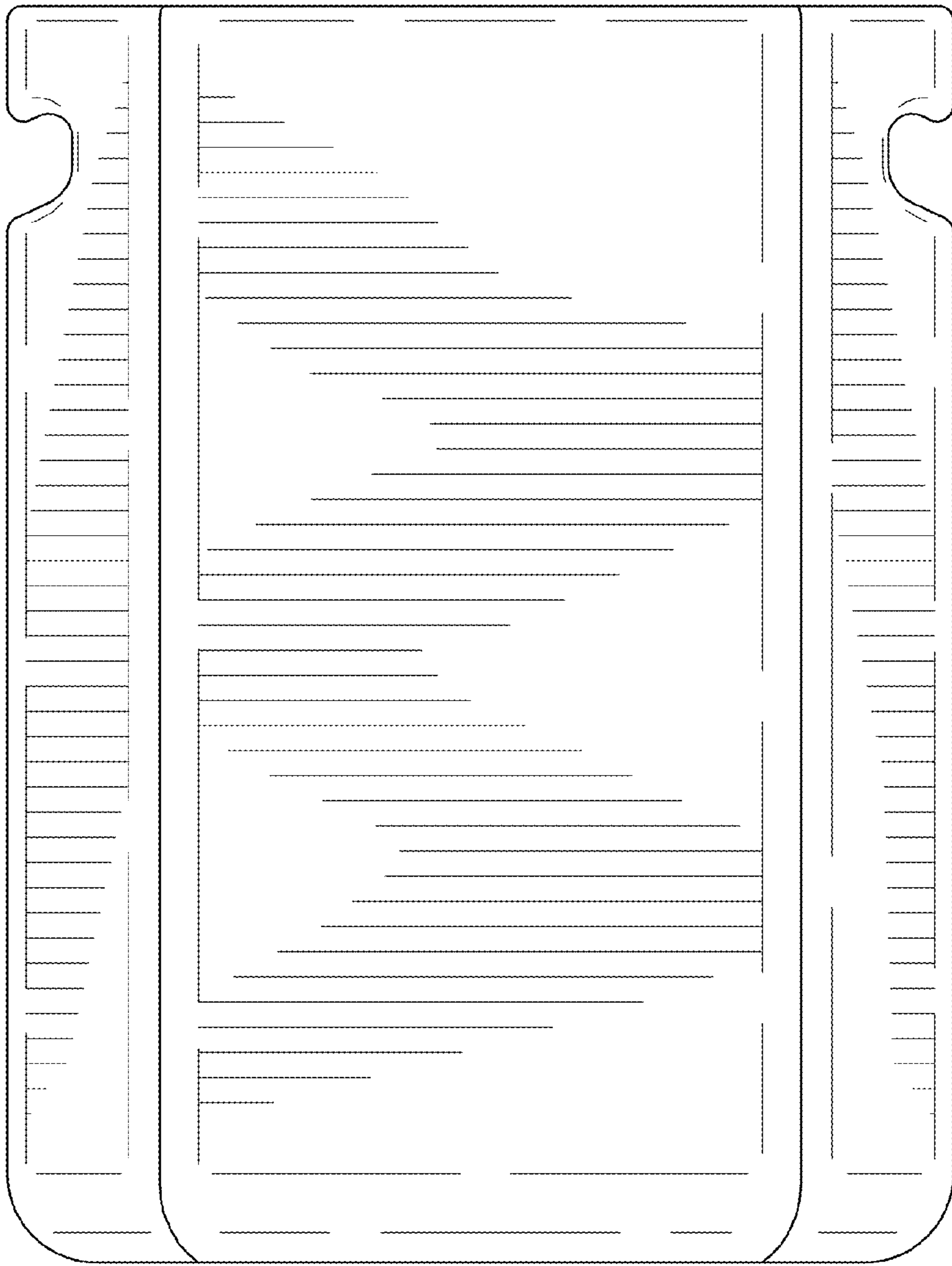
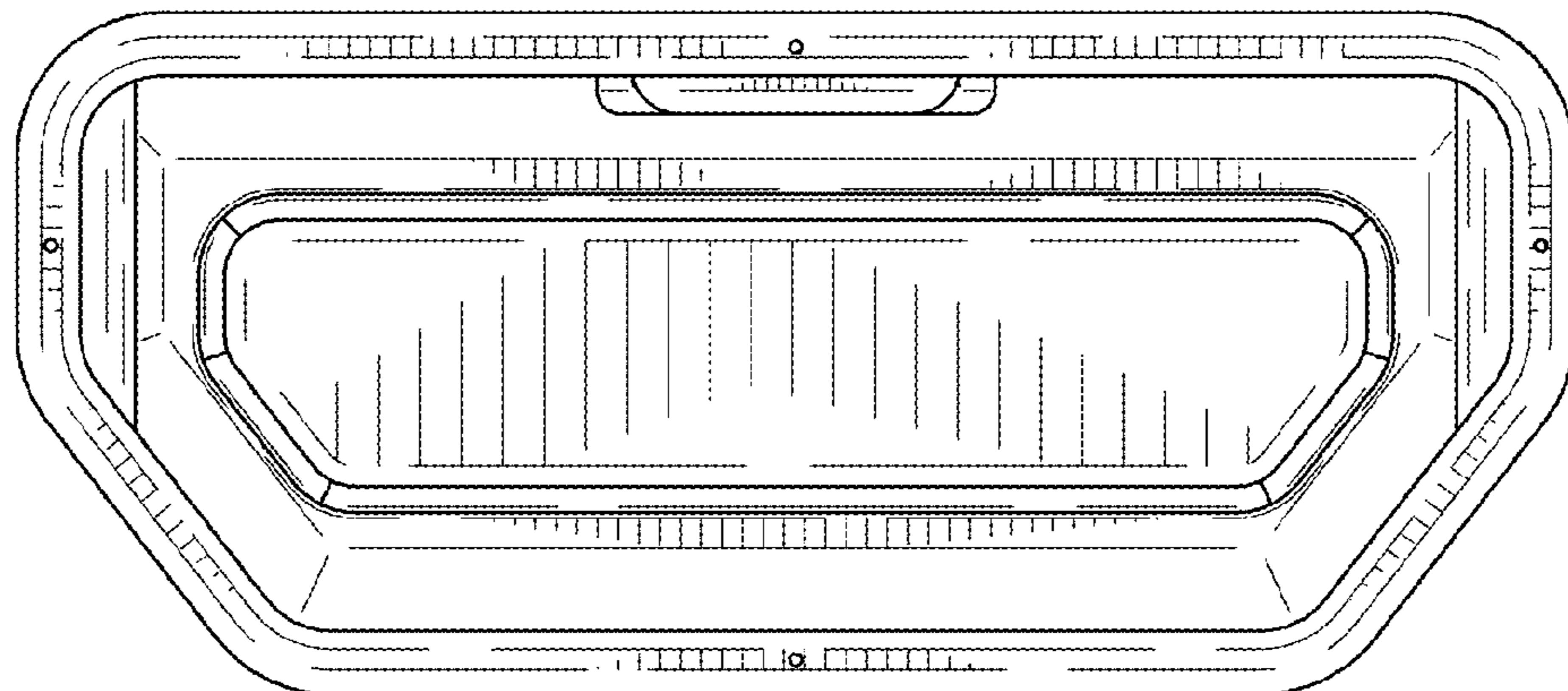

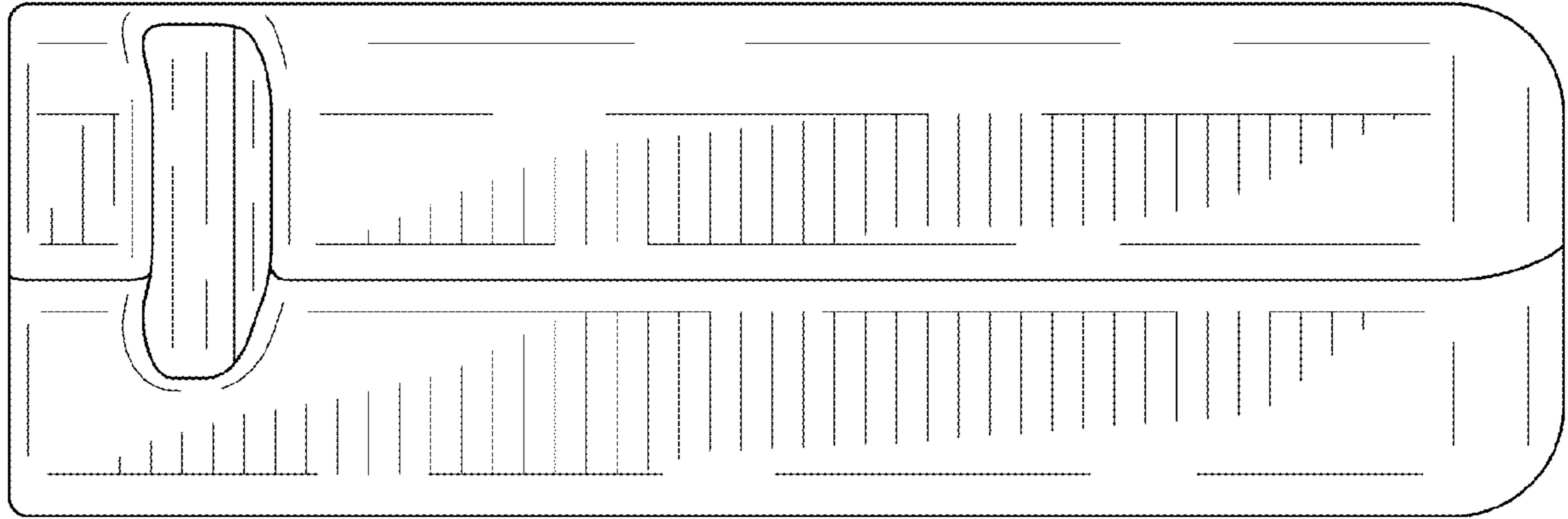

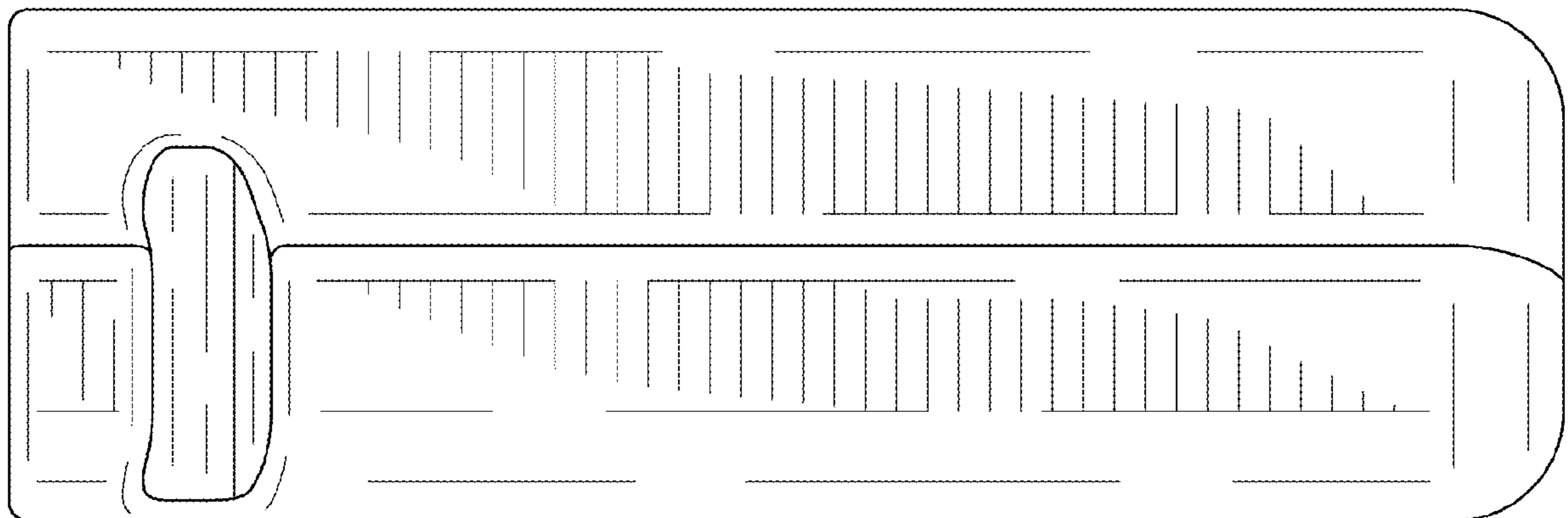

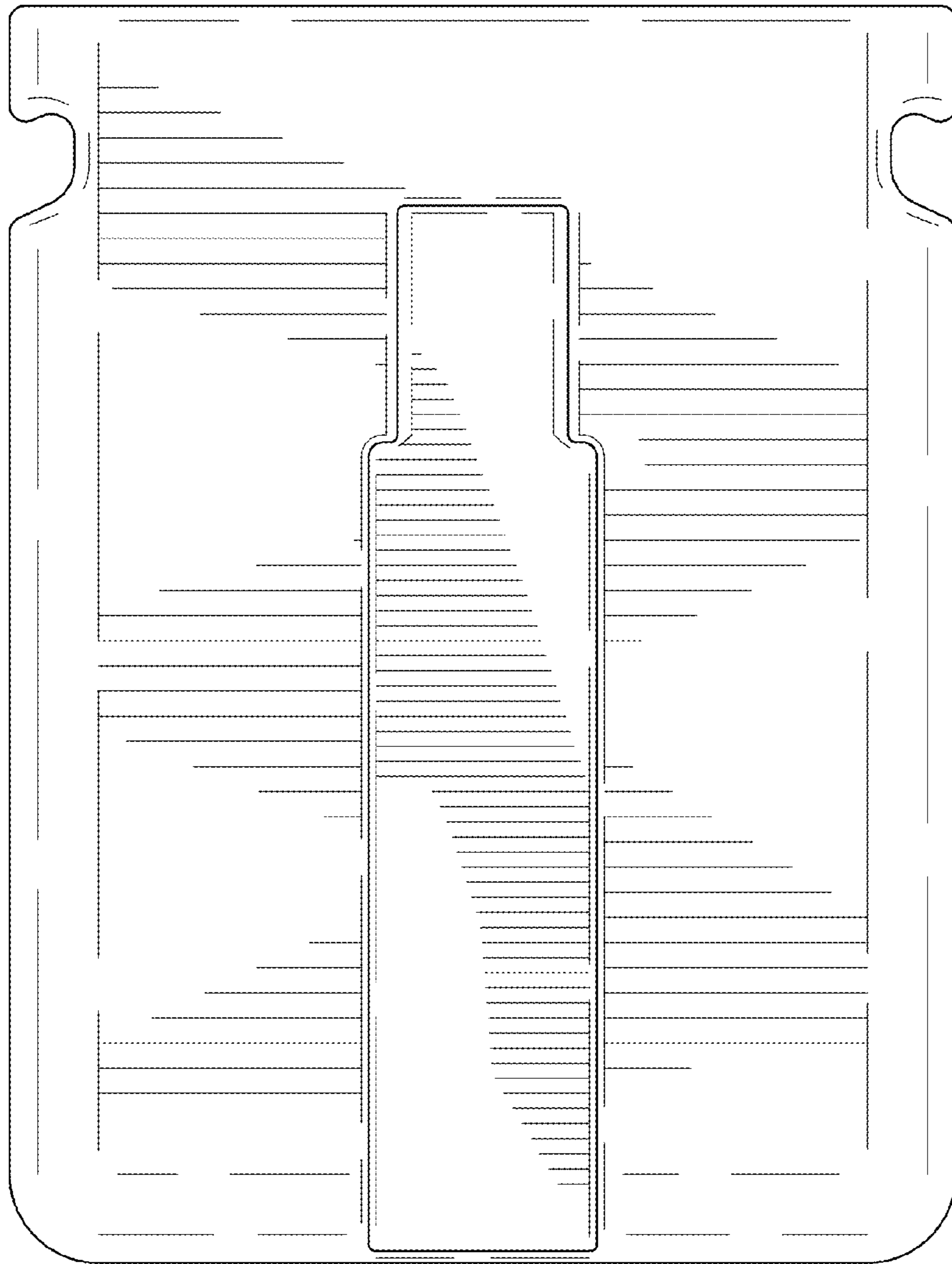
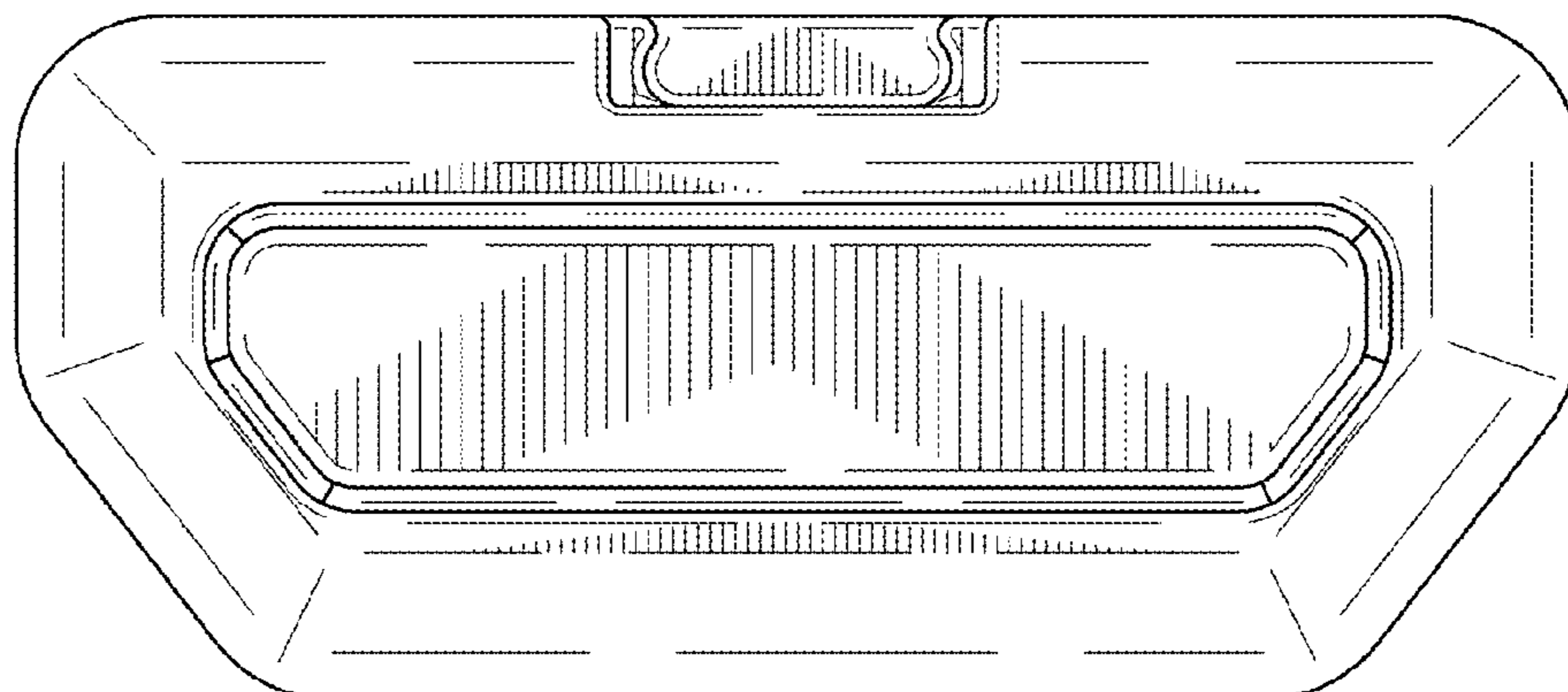

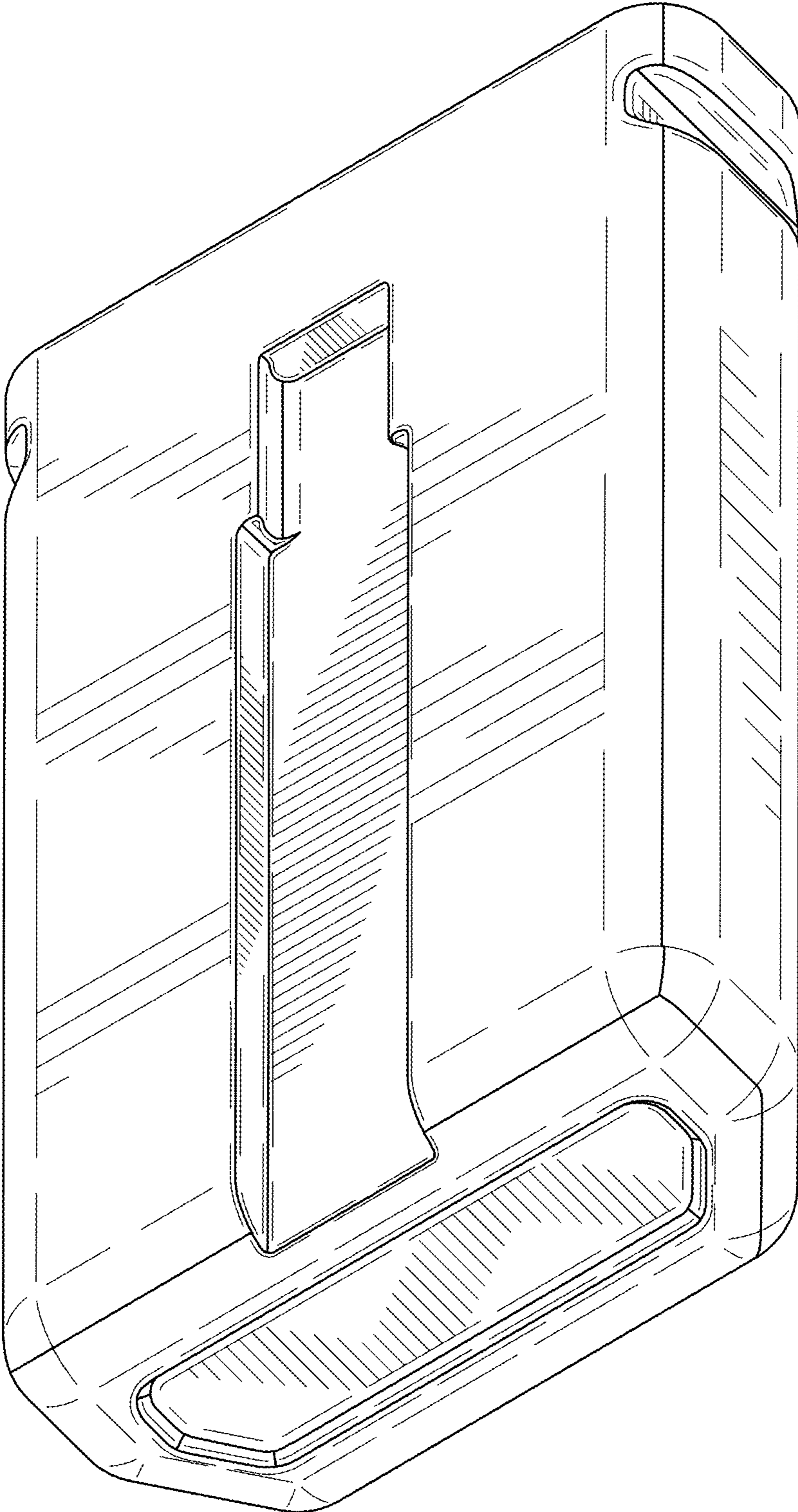

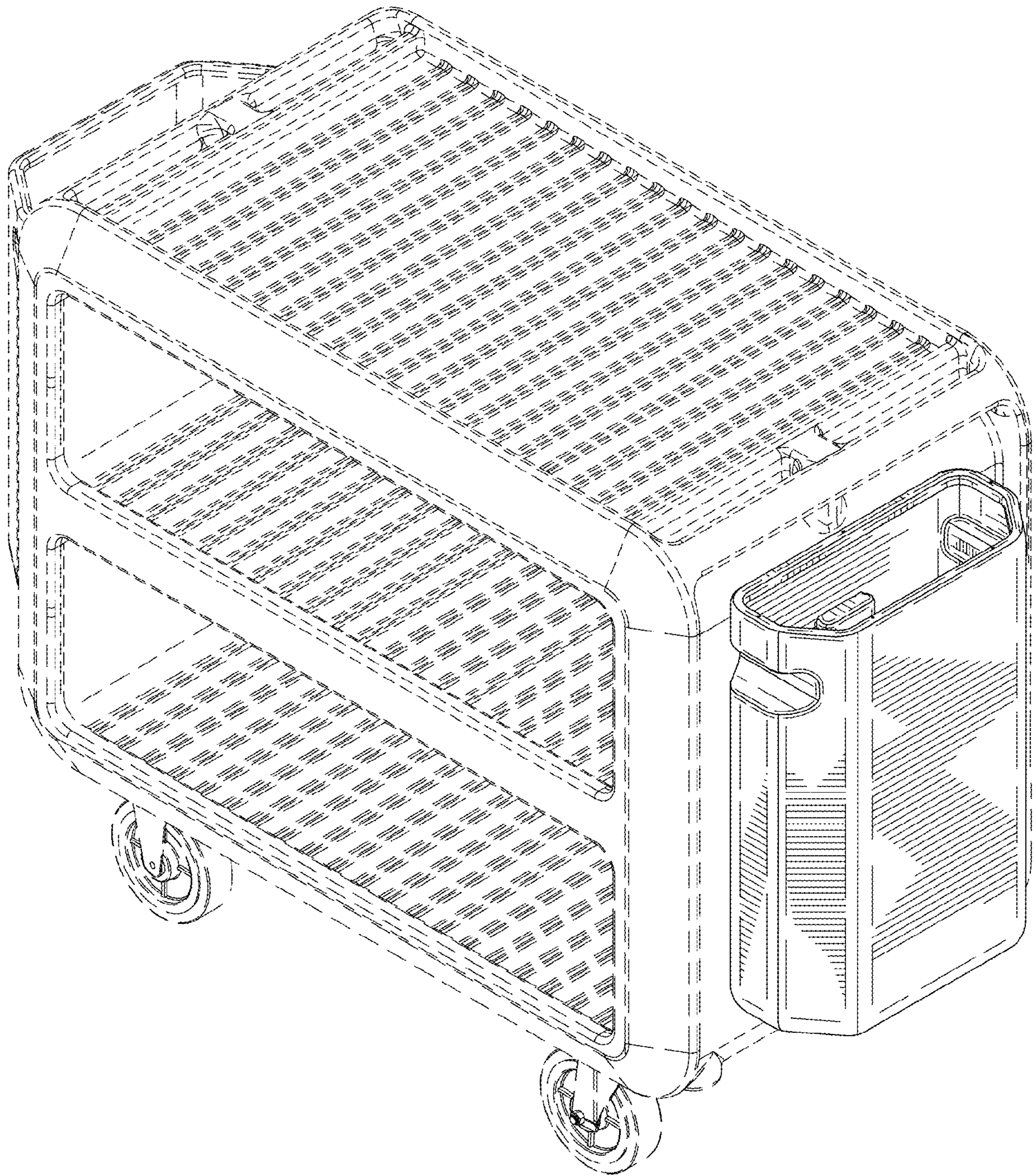
