The ornamental design for pants, as shown and described.

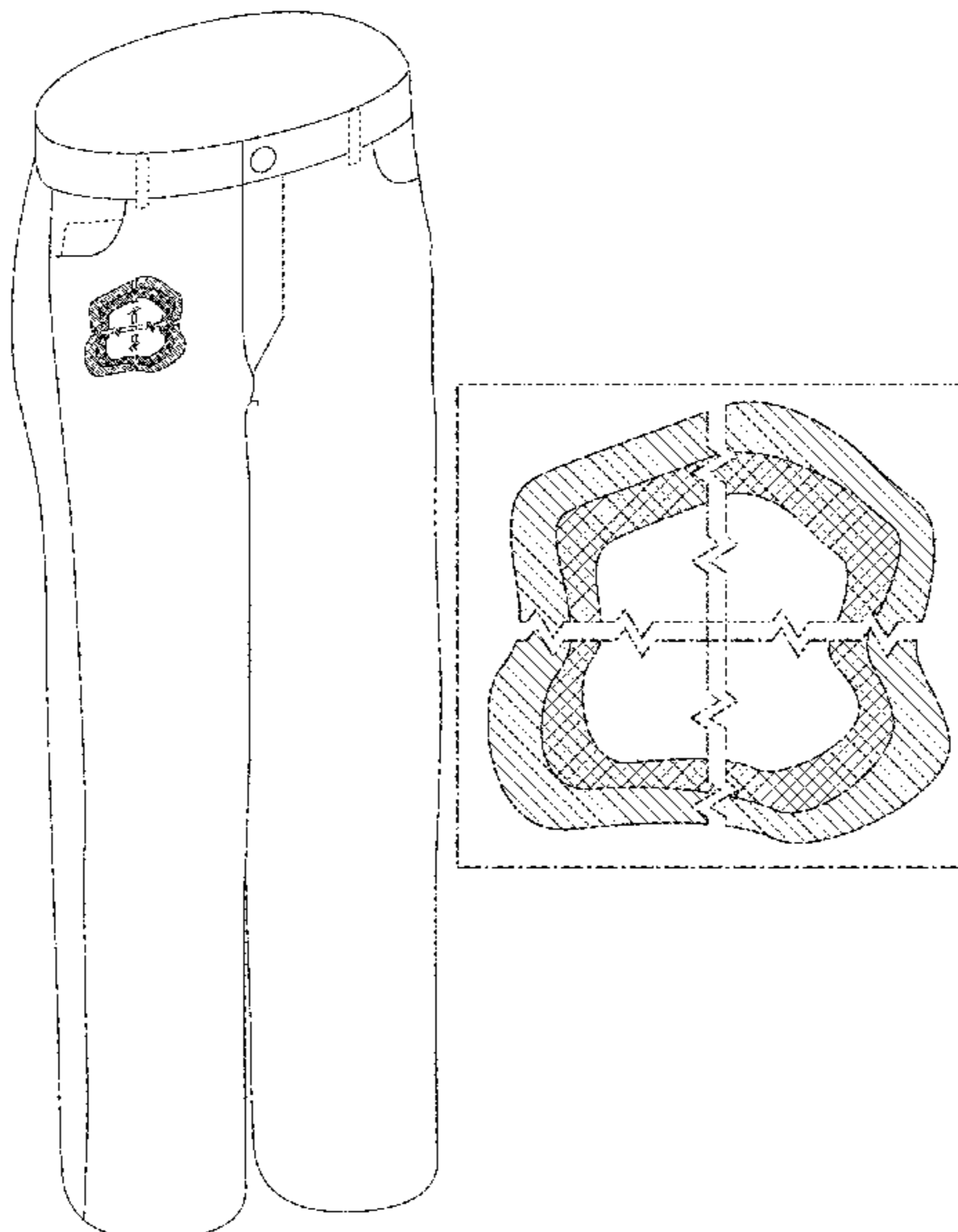
DESCRIPTION

FIG. 1 is a front perspective view of pants showing my new design in a first embodiment;

The evenly spaced broken lines shown in the drawings depict portions of the pants. The long-dash short-dash broken lines depict enlargements. The broken lines form no part of the claimed design.

The pants in FIGS. 1, 2, 3, 5, 7, 8, 10, 11, 13, 14, 16 and 17 are shown with a symbolic break in their length. The appearance of any portion of the article between the break lines forms no part of the claimed design.

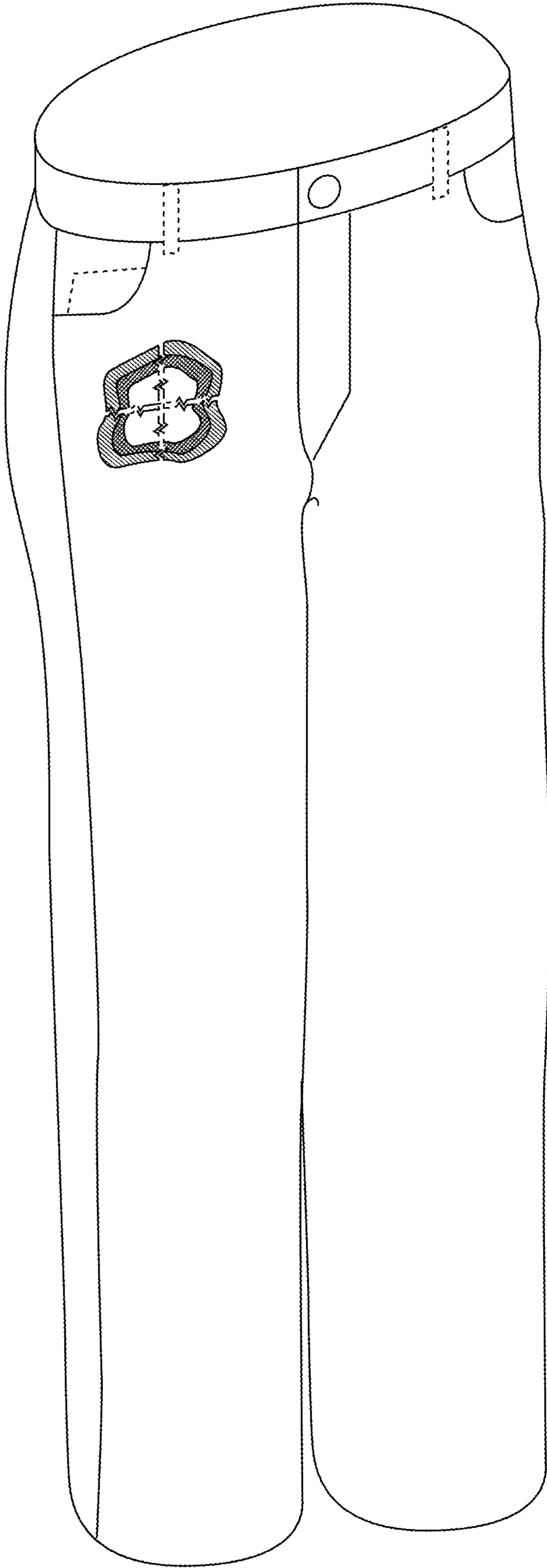

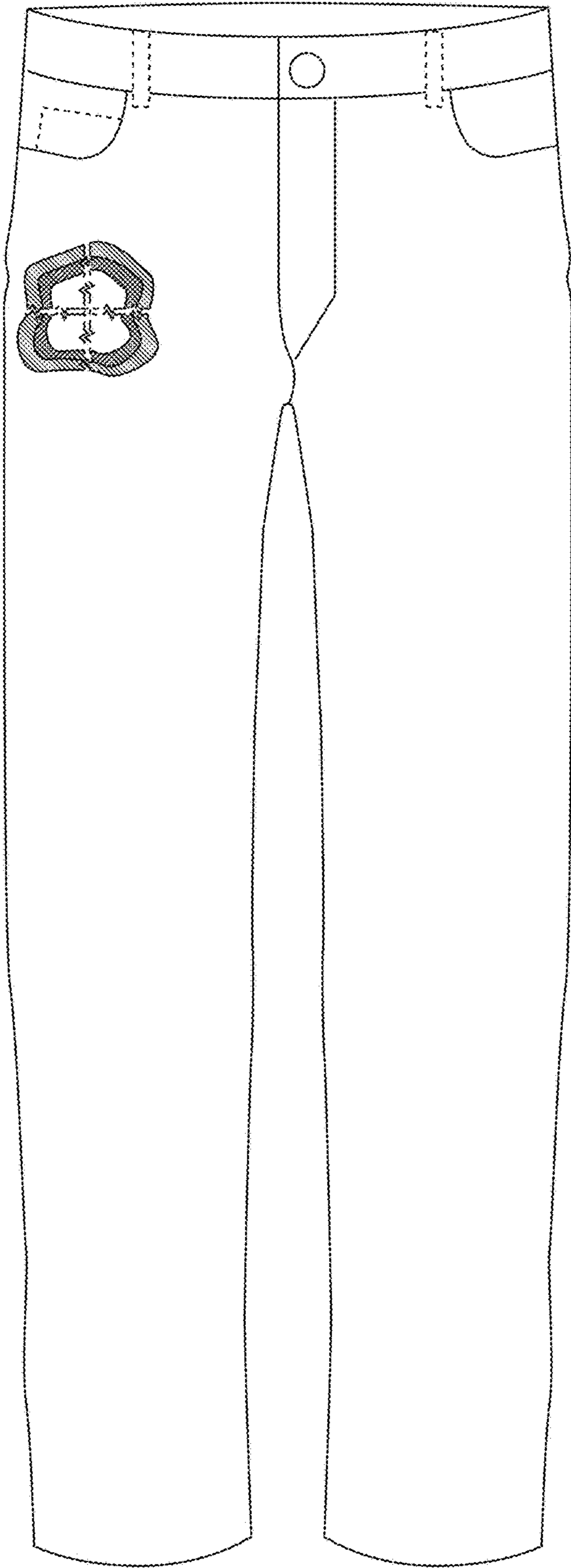

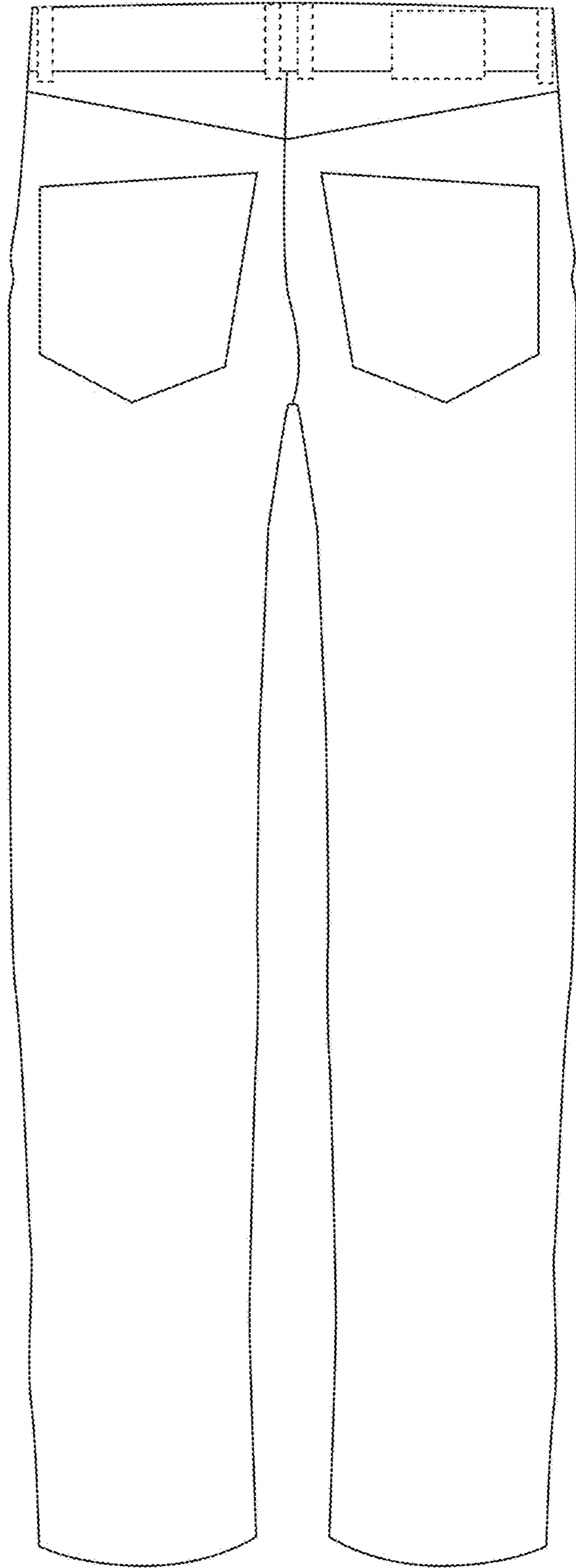

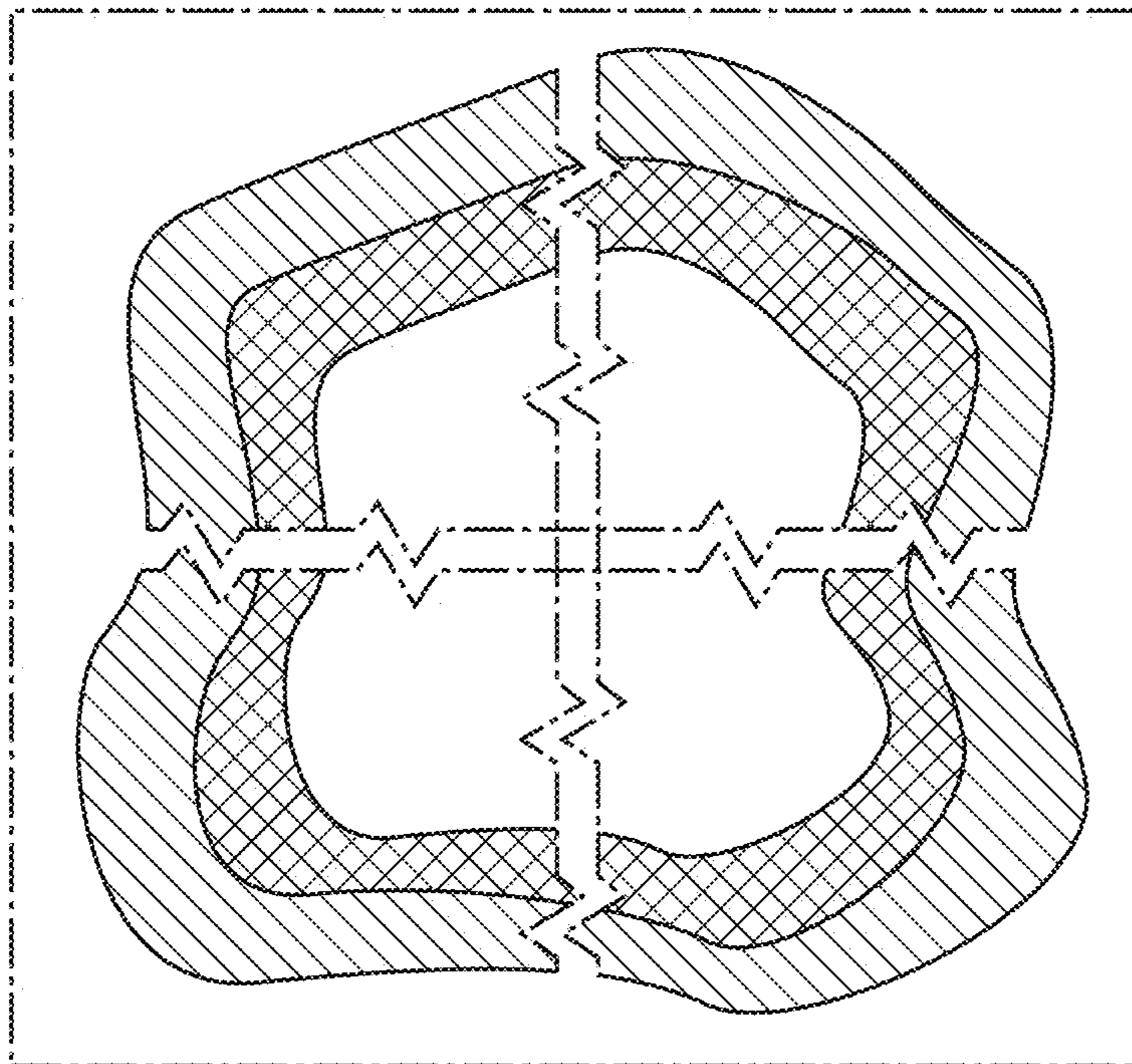

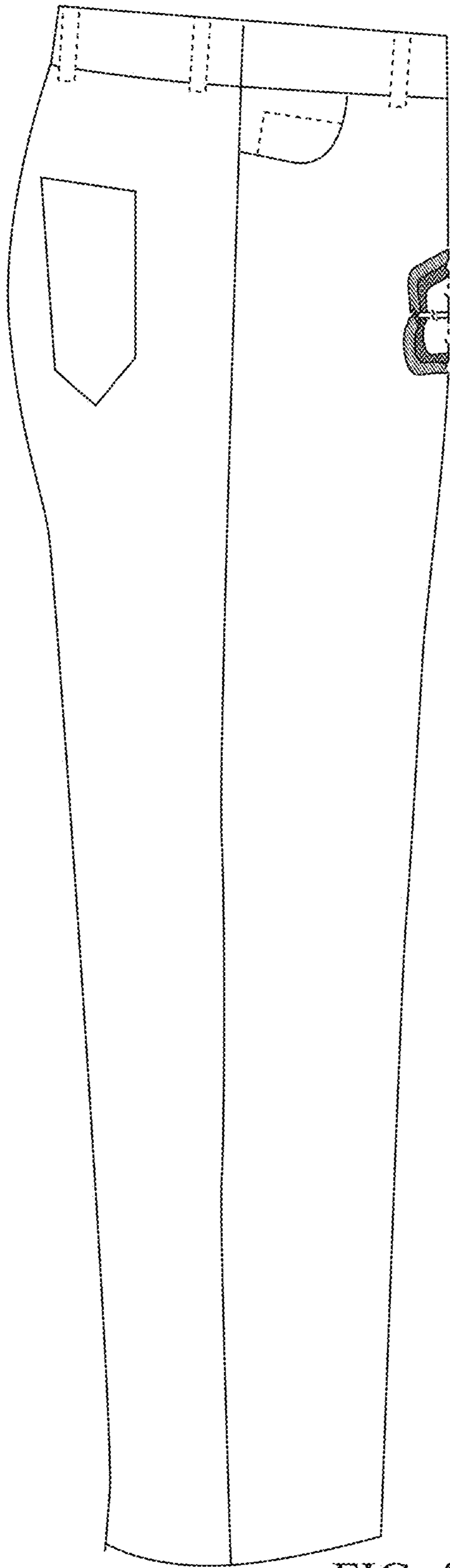

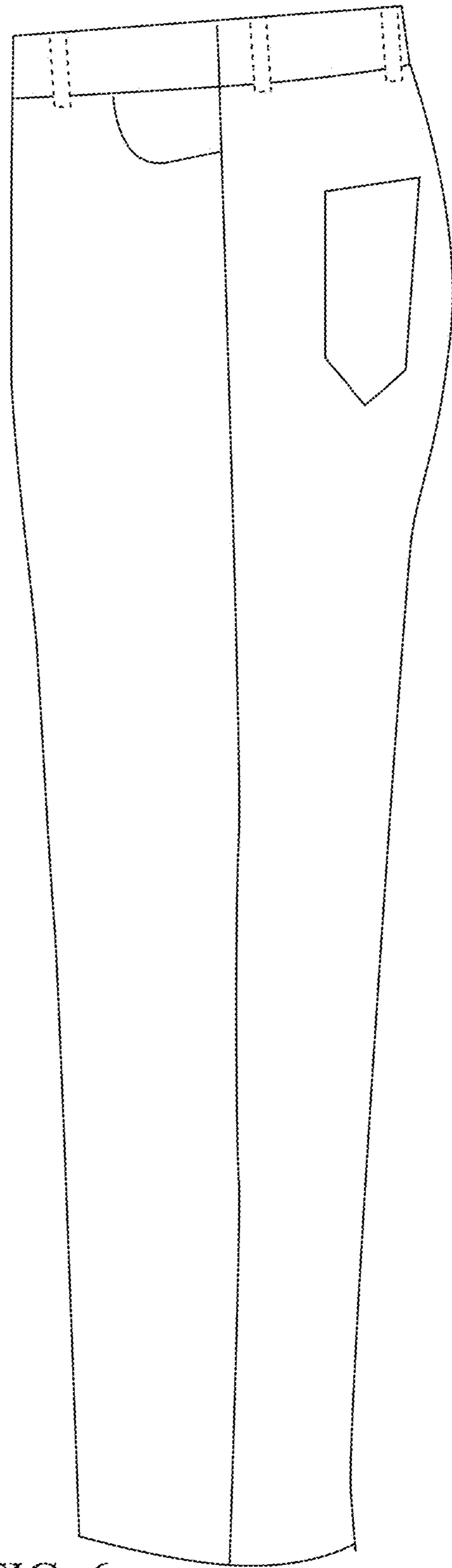

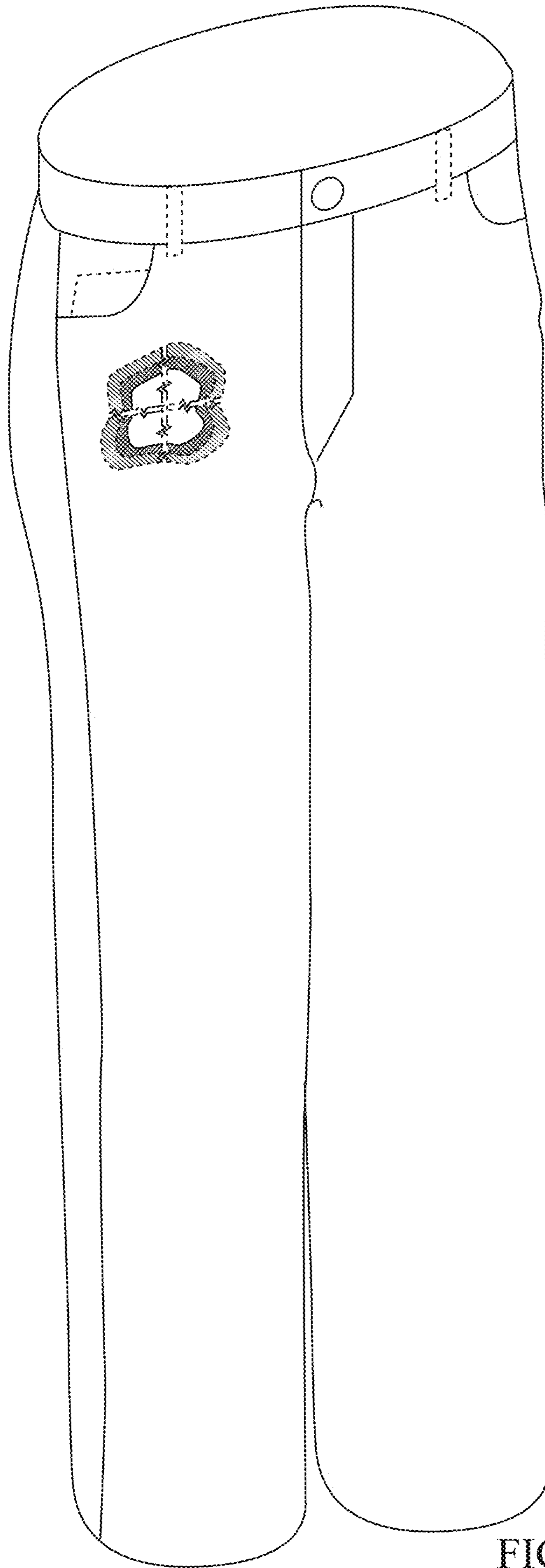

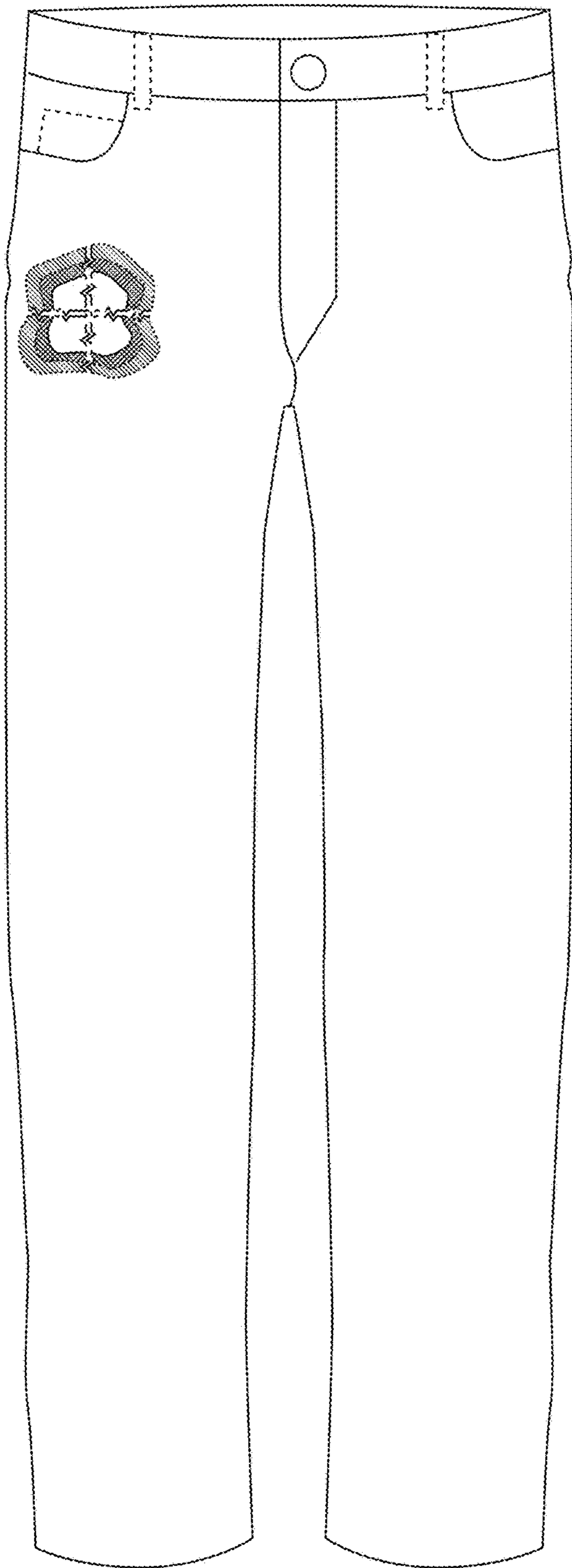

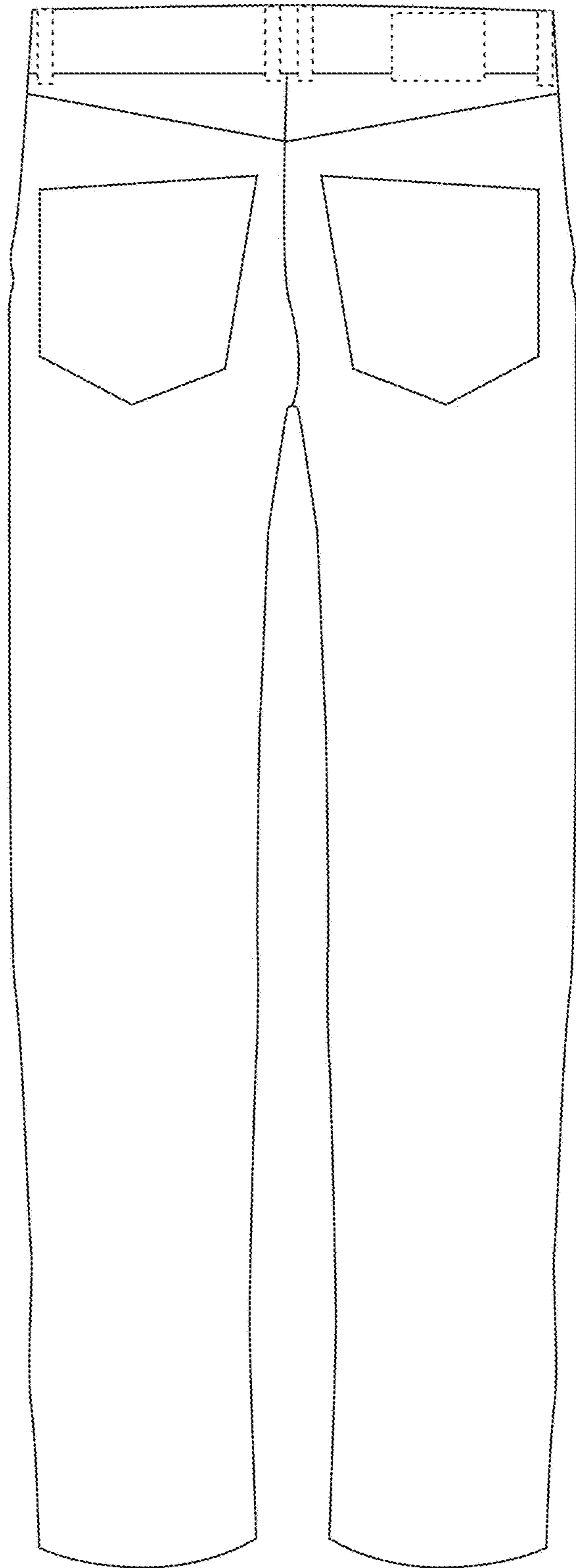

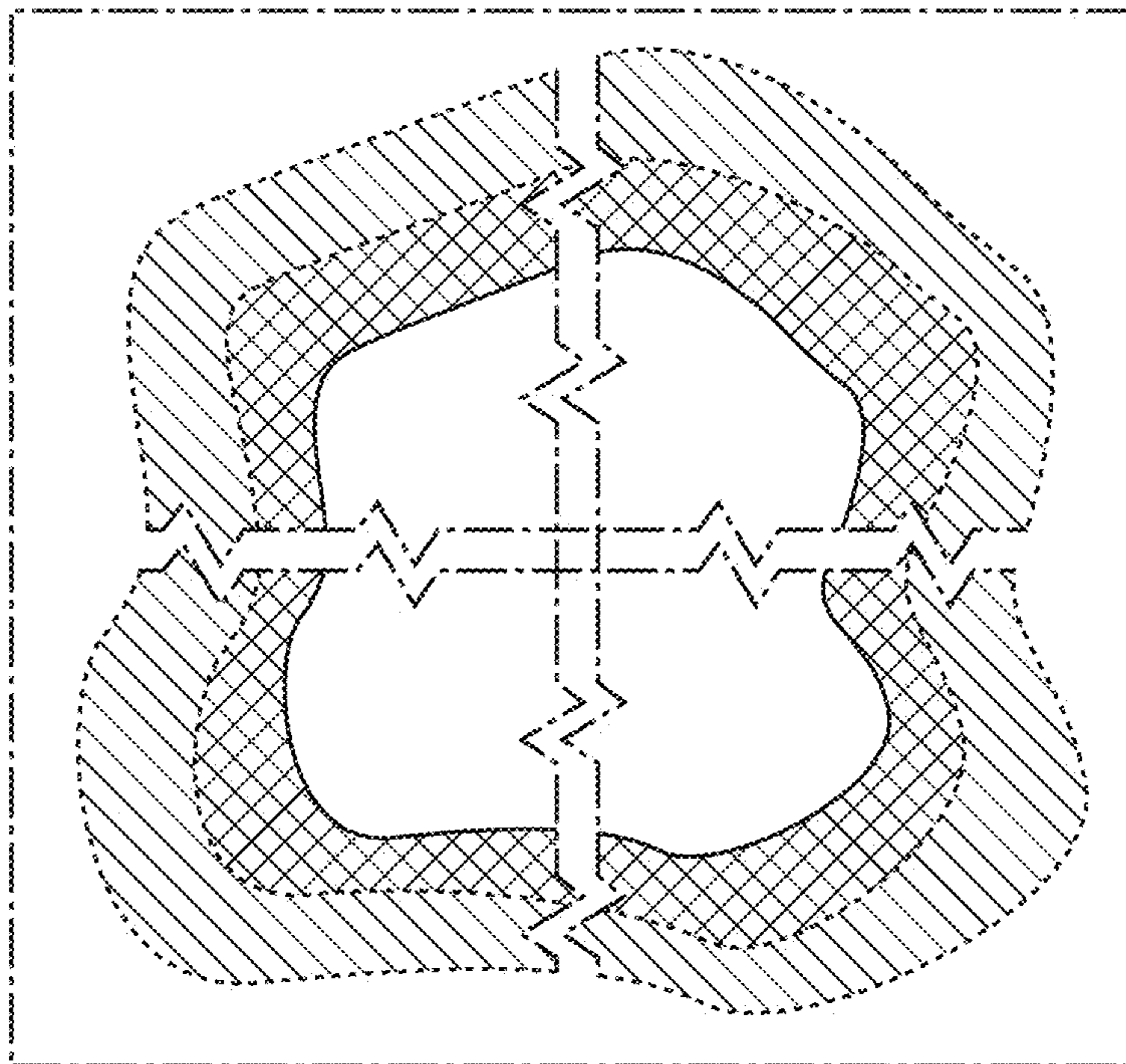

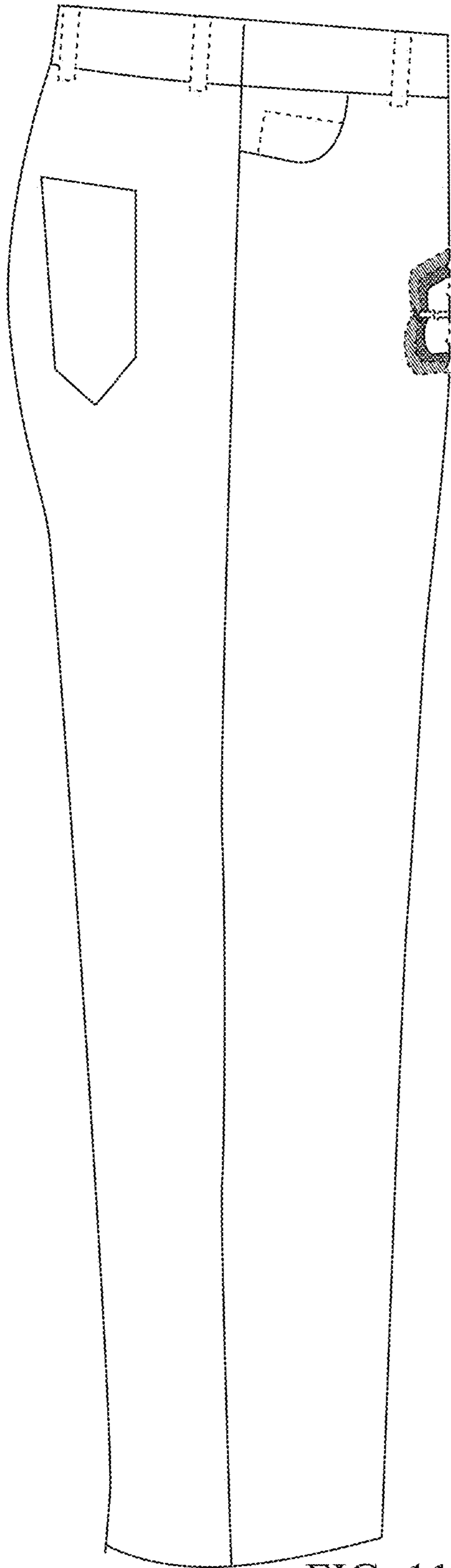

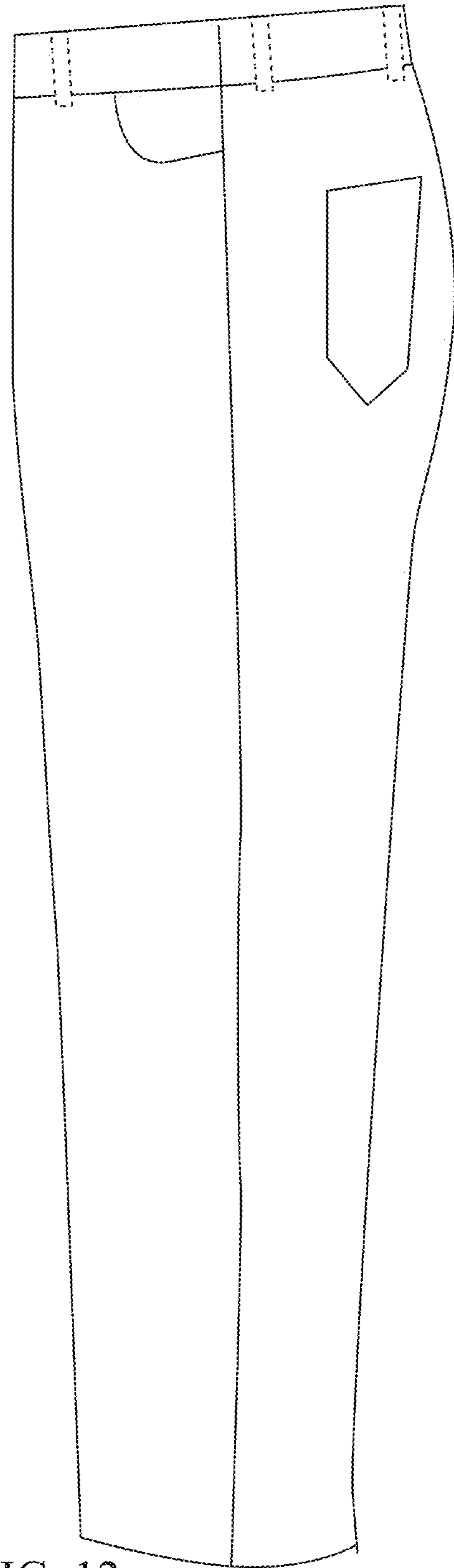

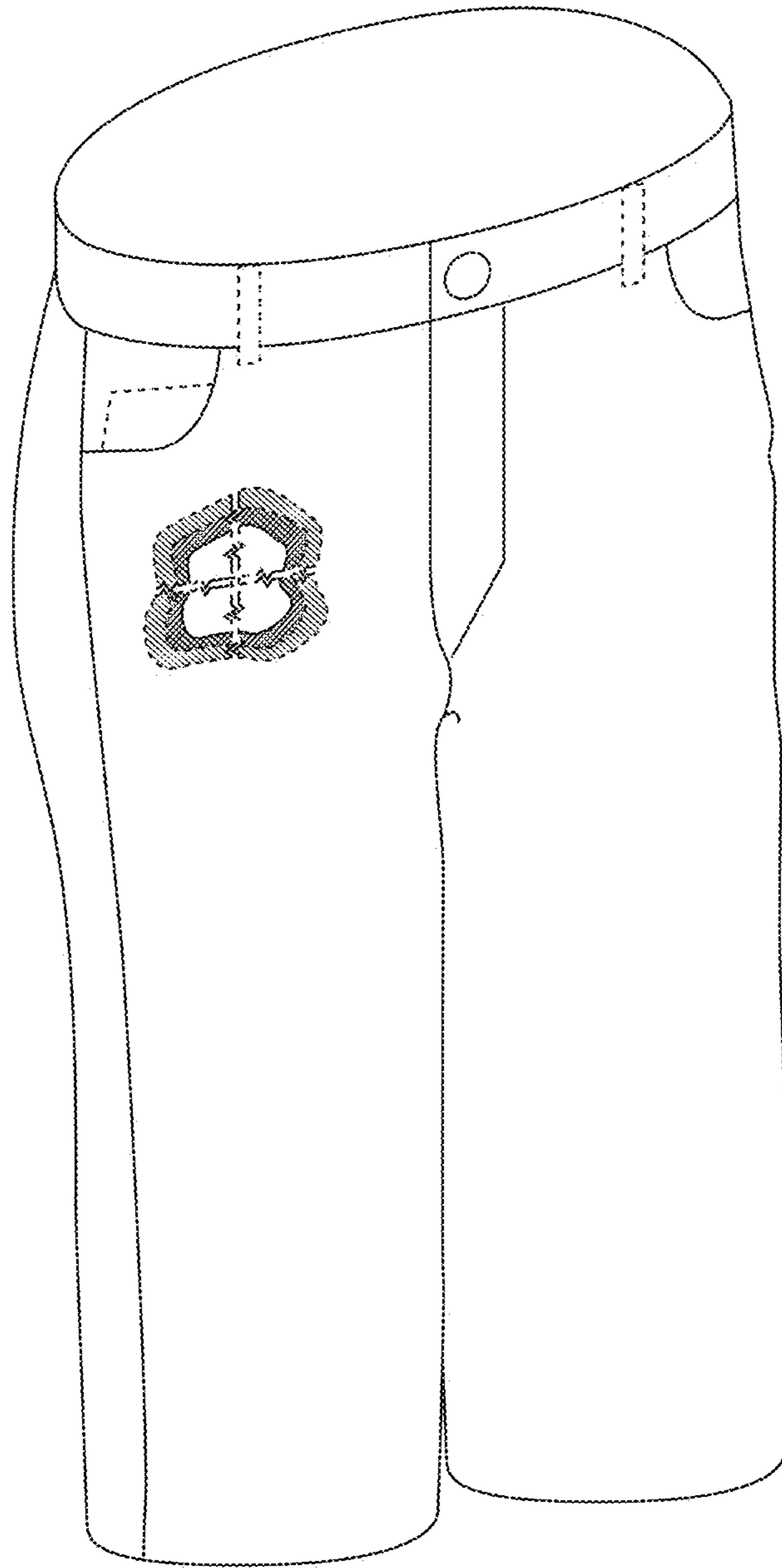

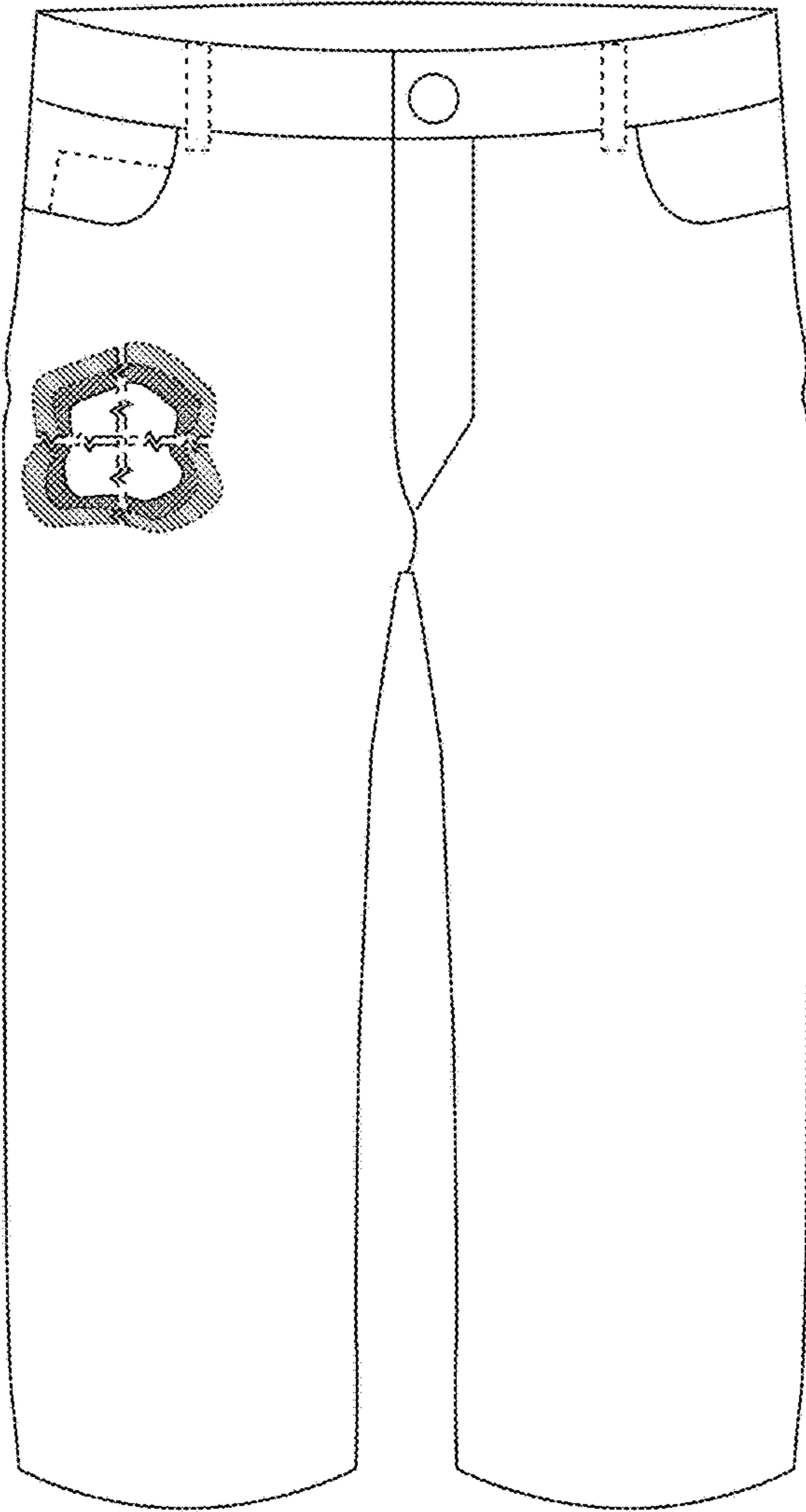

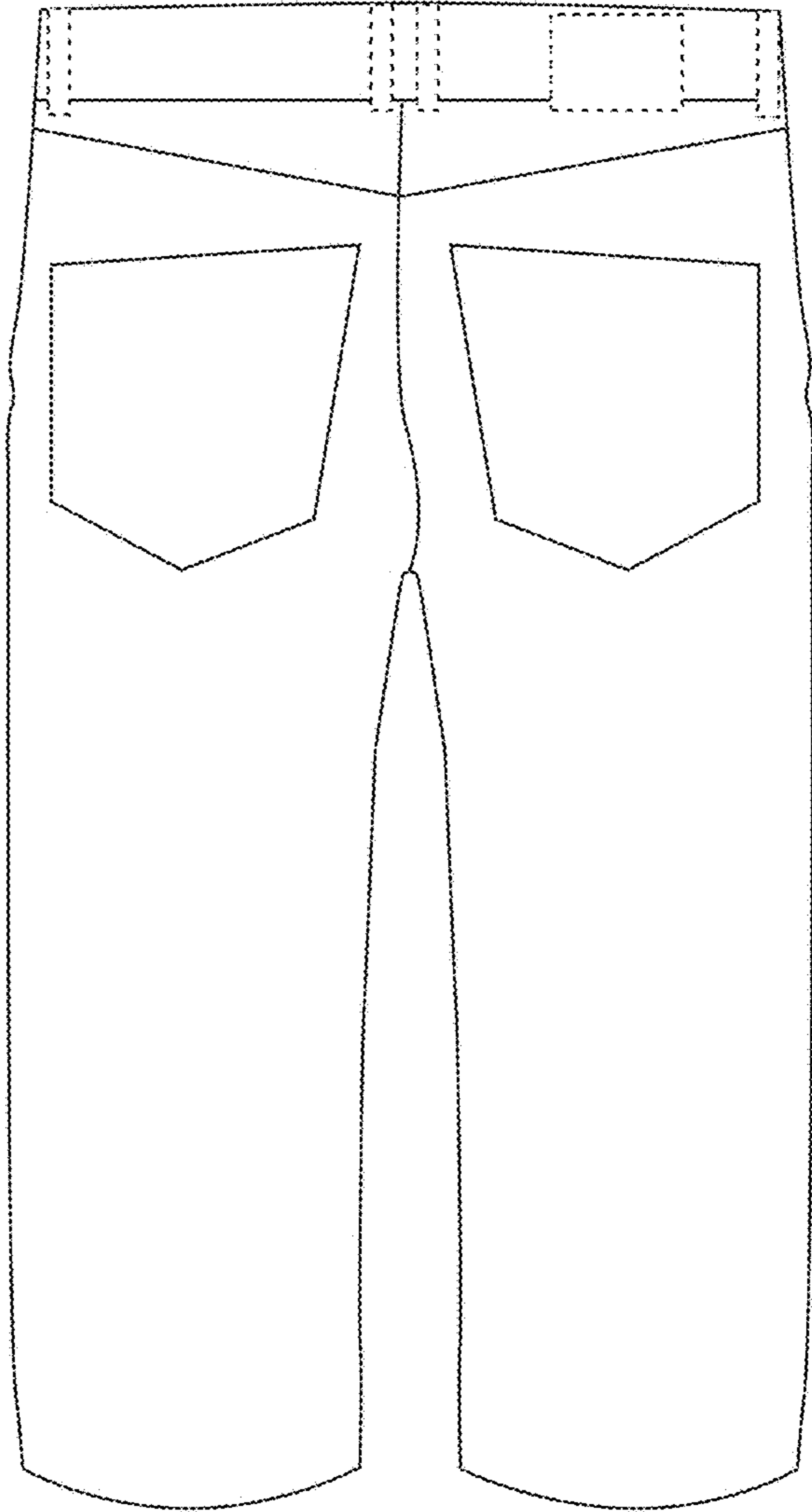

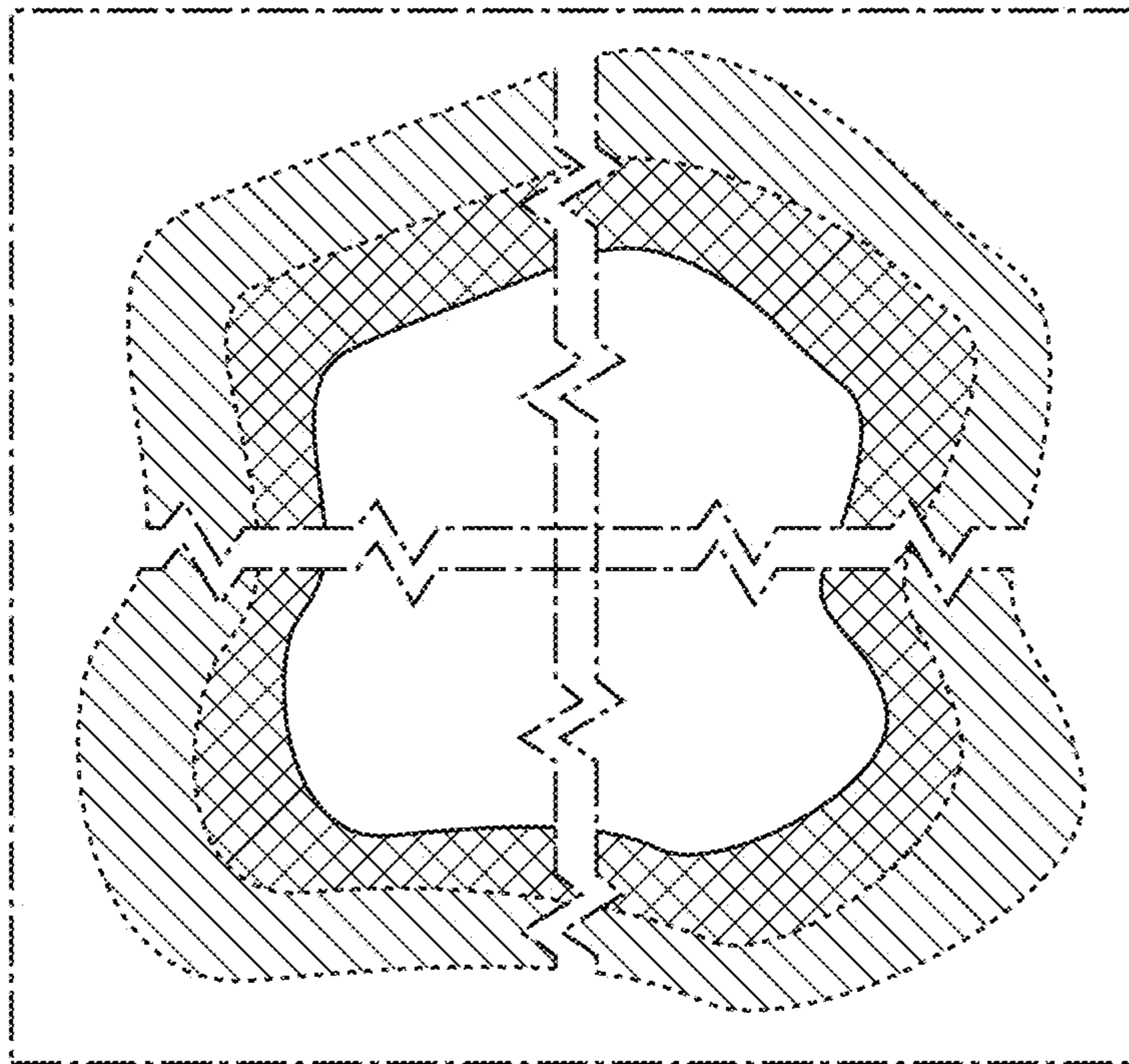

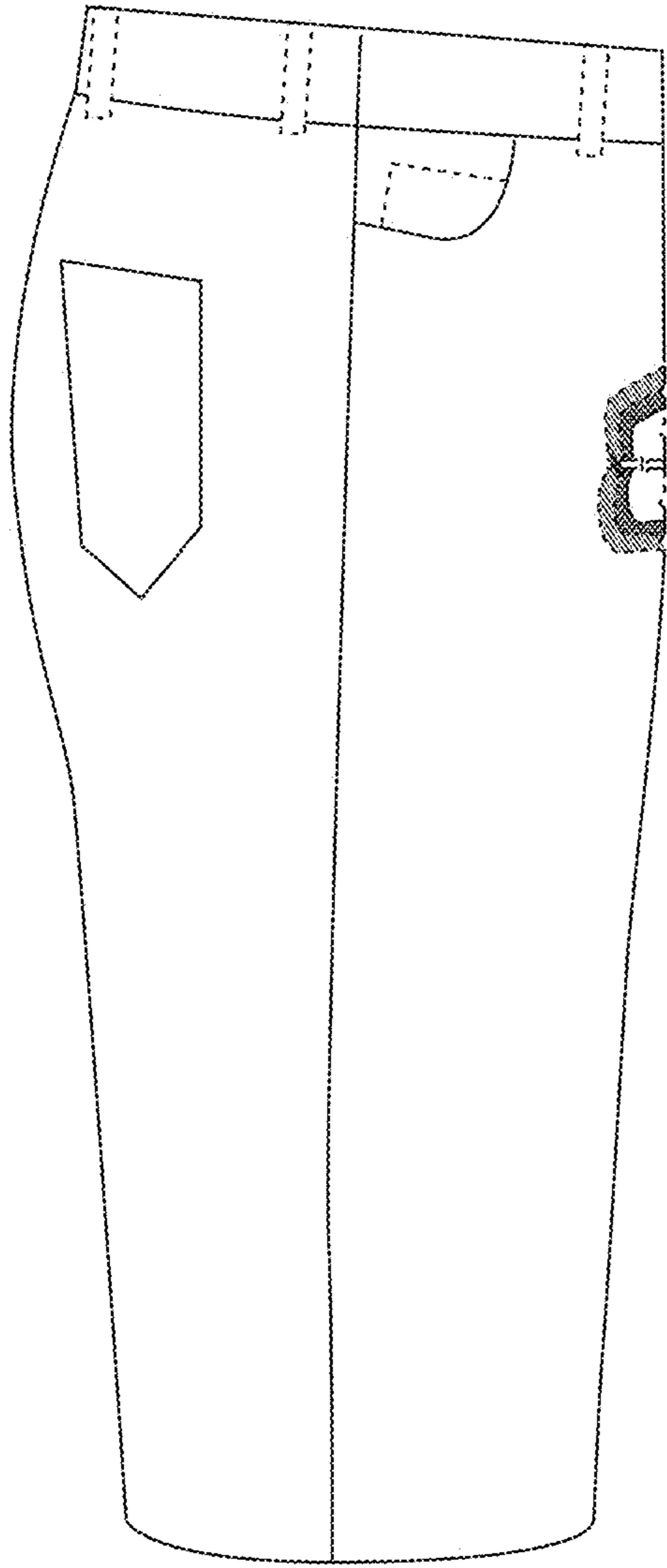

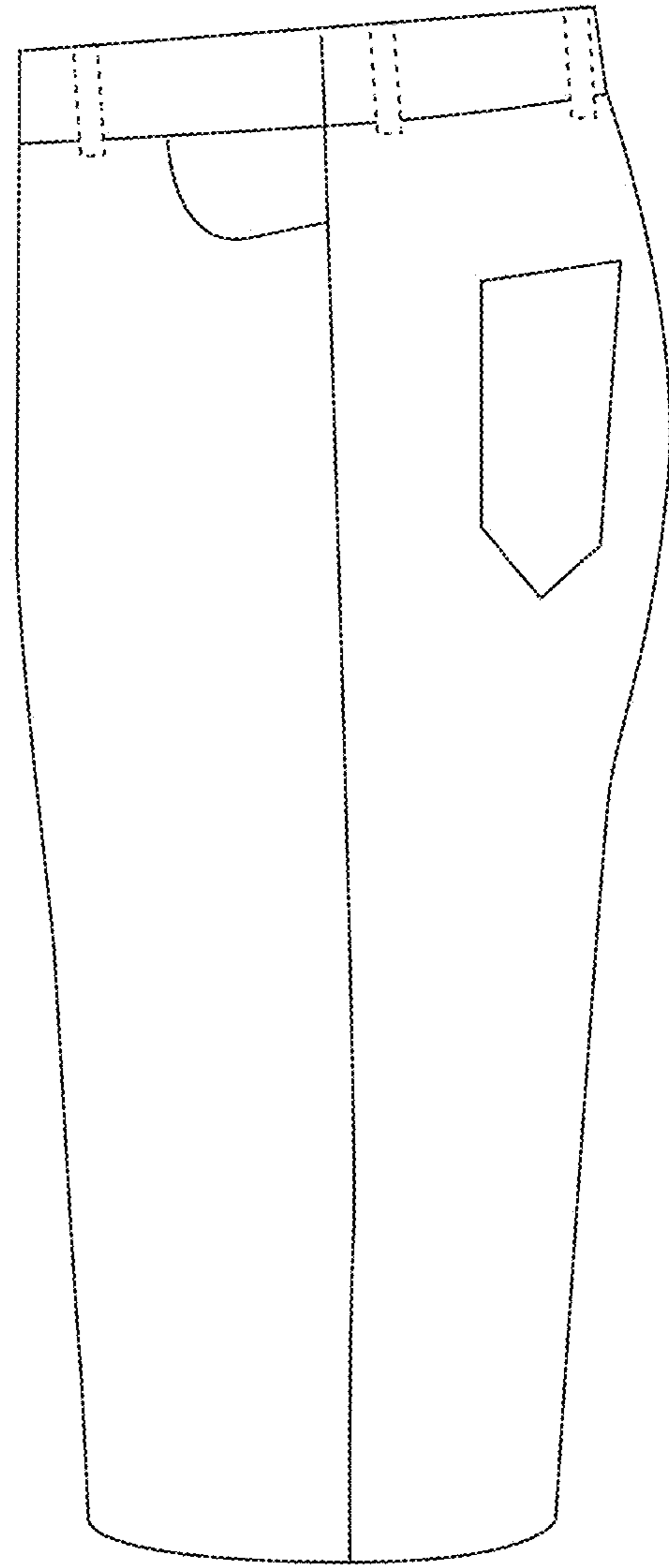
