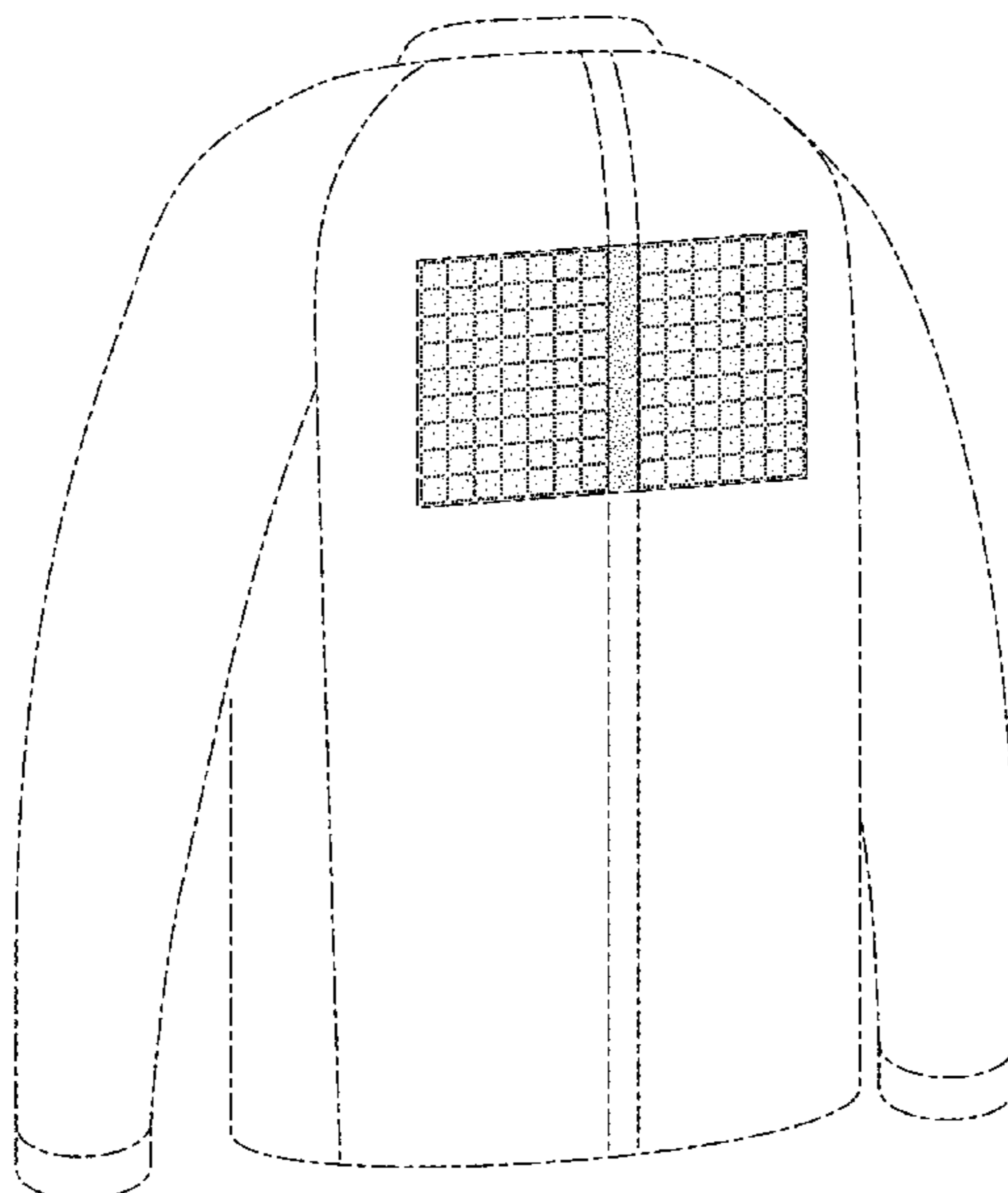
(57) **CLAIM**

The ornamental design for a jacket, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a jacket showing our new design;
FIG. 2 is a rear view thereof; and,
FIG. 3 is an enlarged view of the design of FIG. 2 with environment removed for clarity purposes.
The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The broken lines depicting the remainder of the jacket show features that form no part of the claimed design.

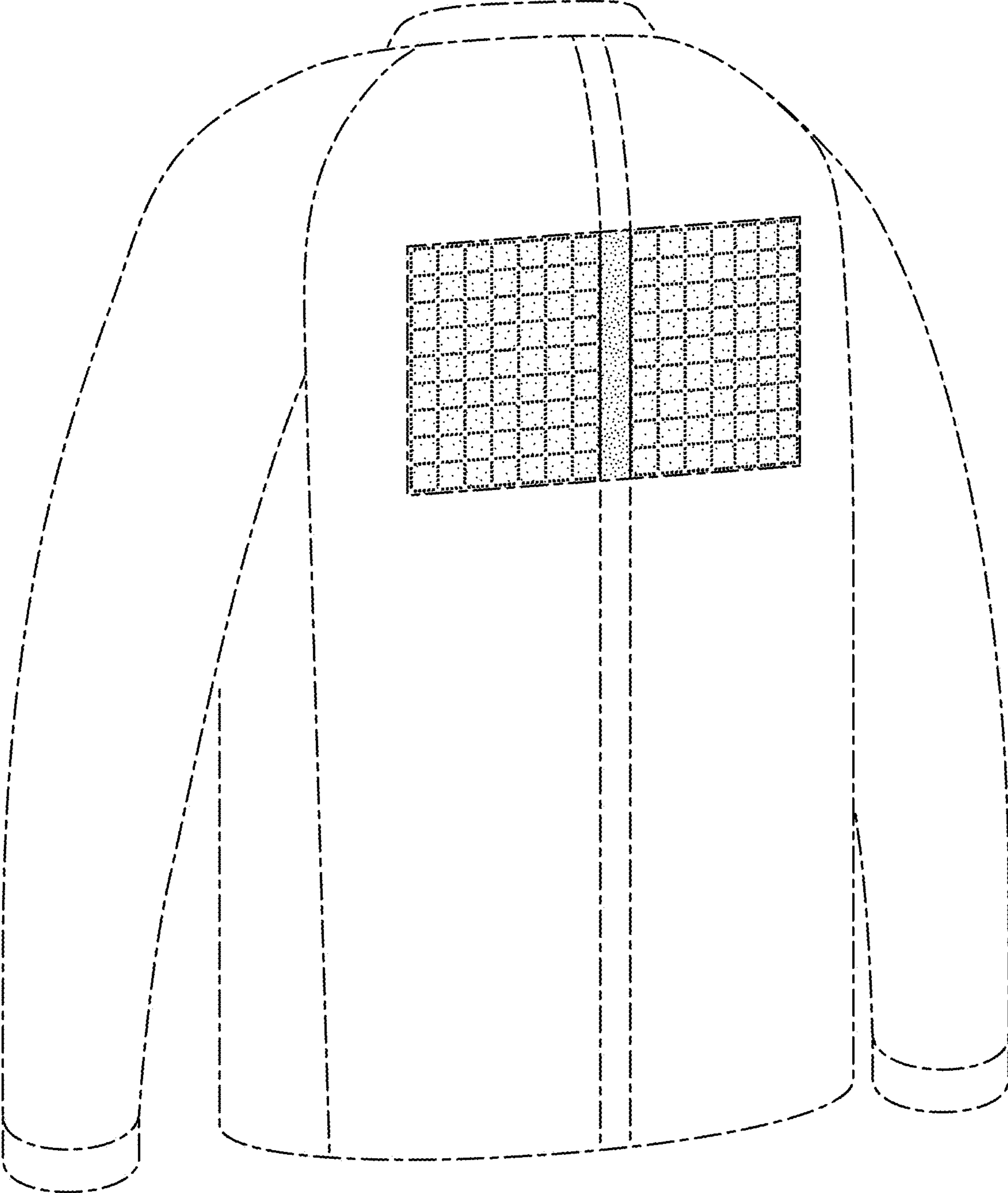

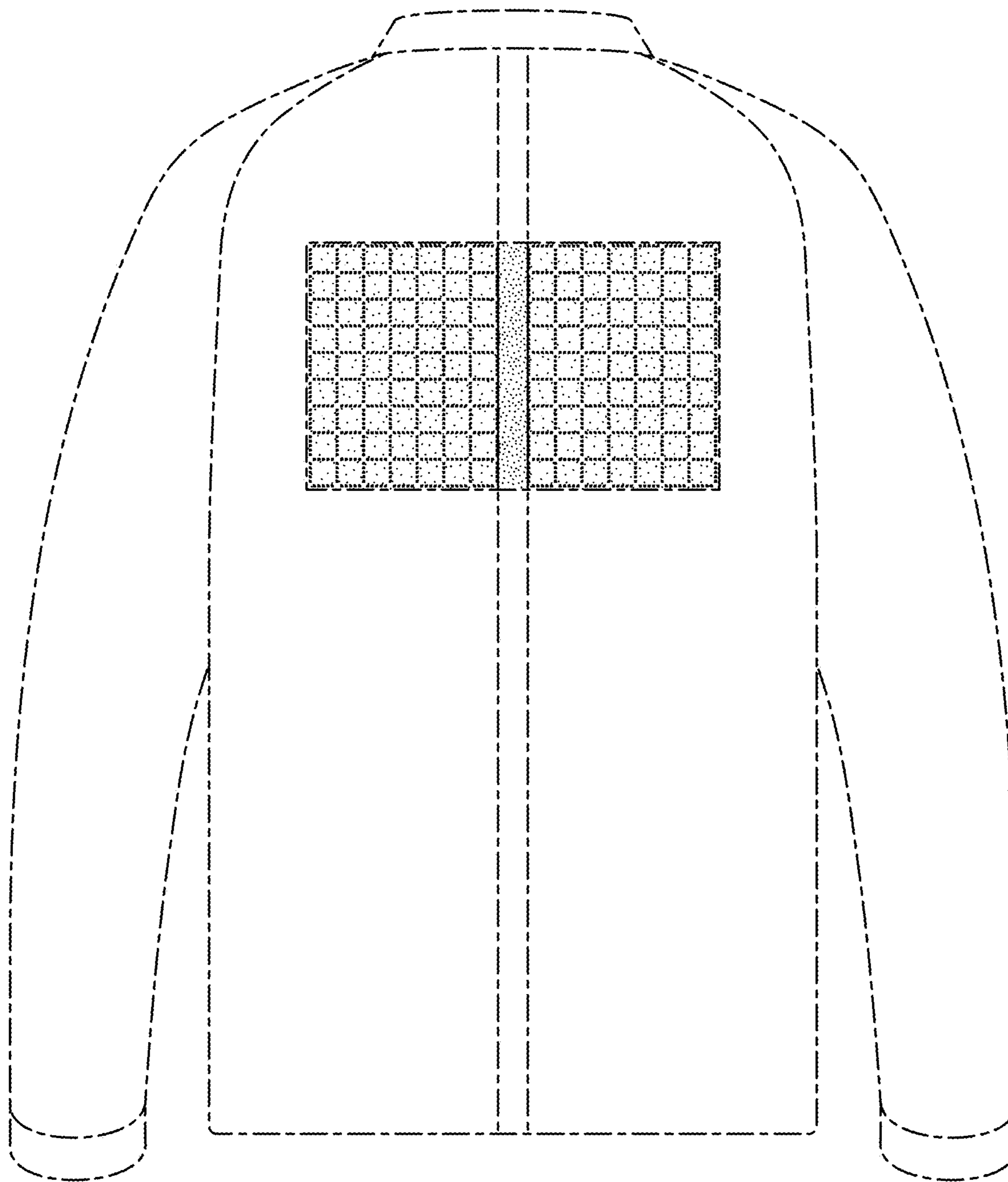

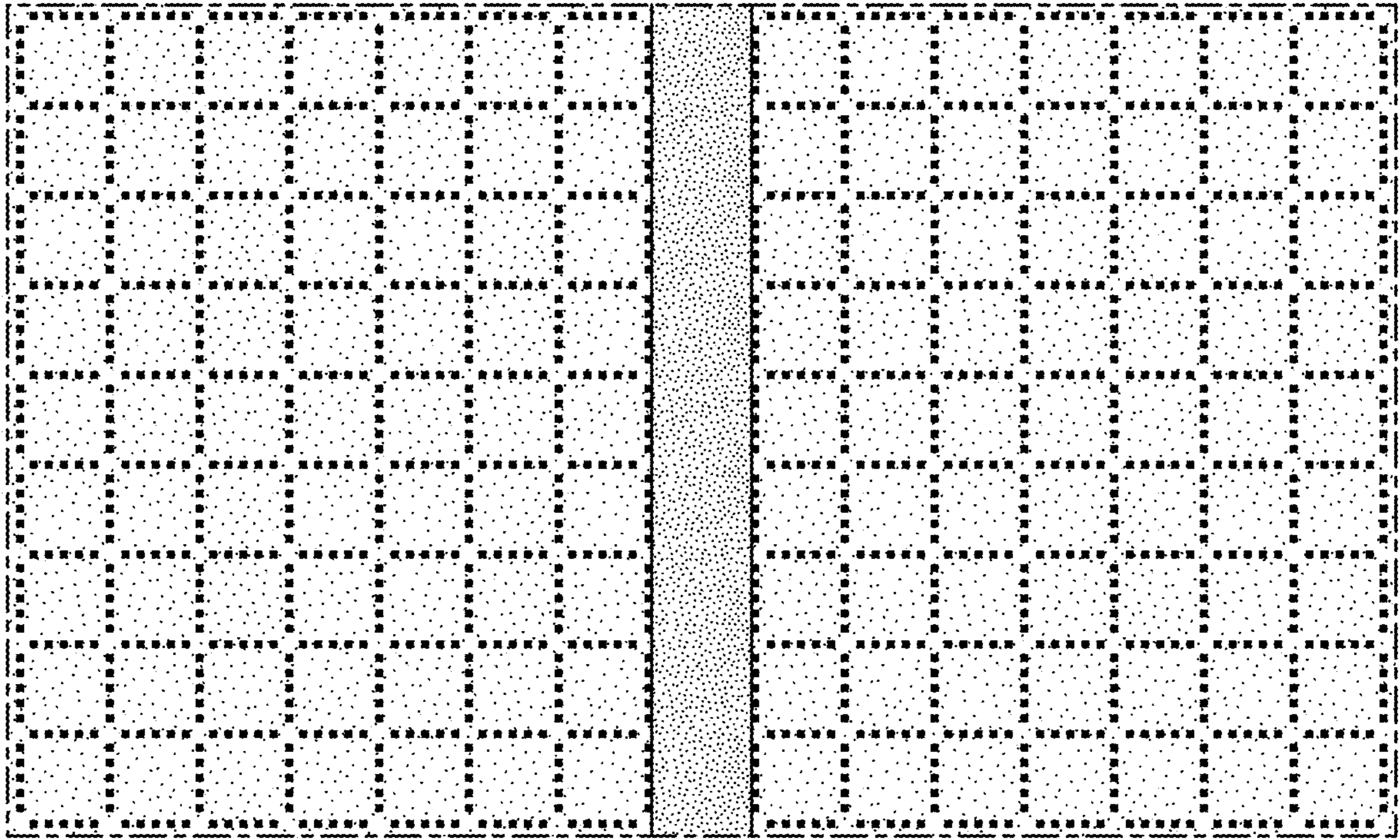
