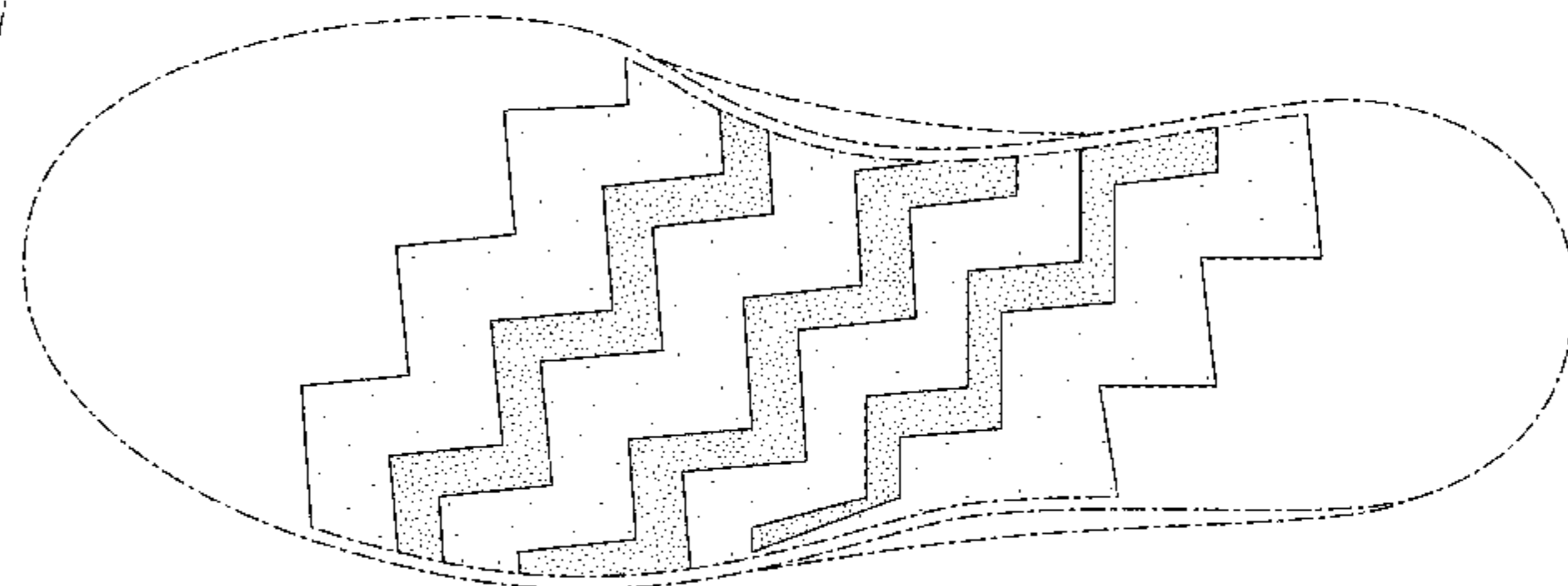
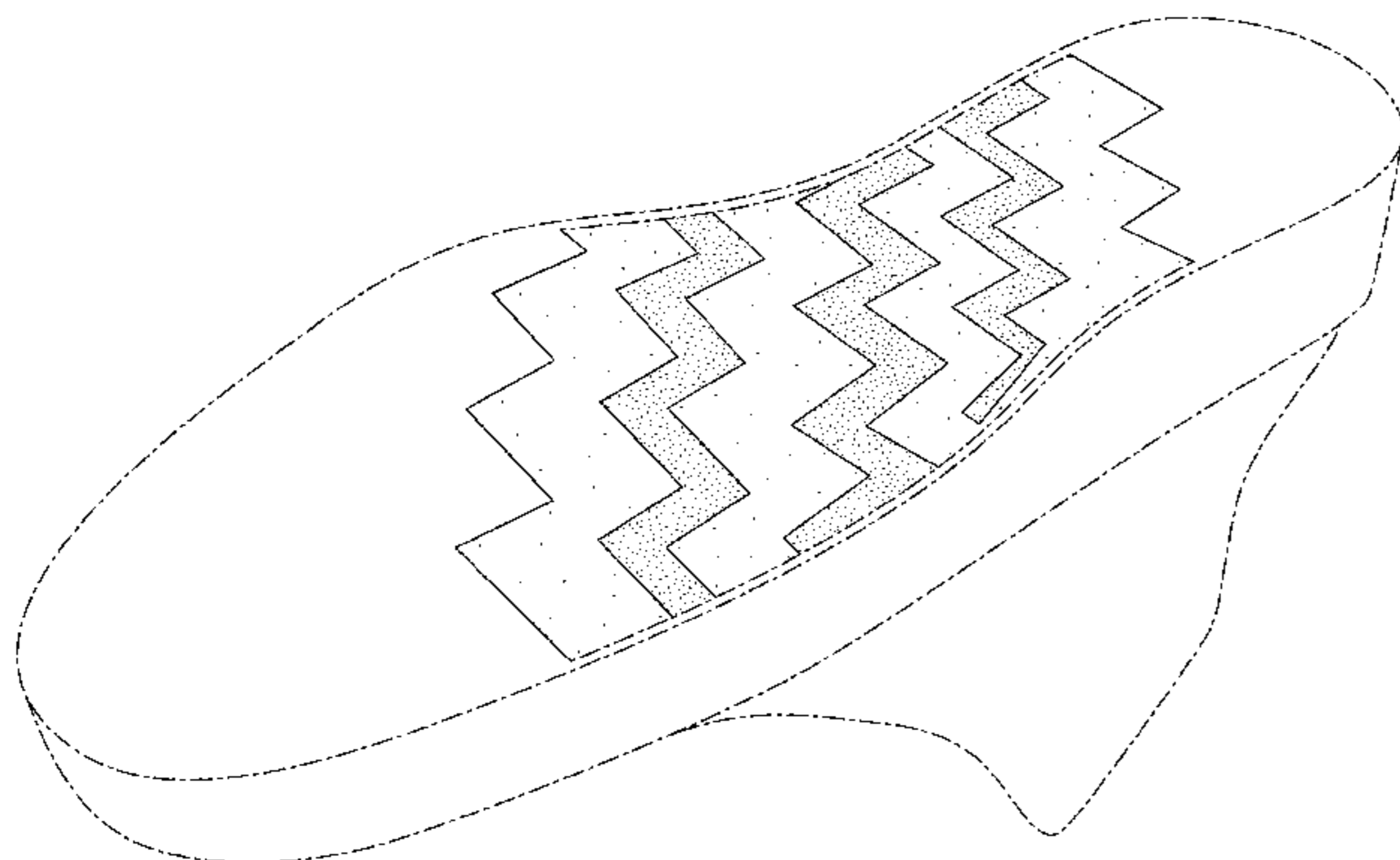
(57) **CLAIM**

The ornamental design for a shoe with outsole surface ornamentation, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe with outsole surface ornamentation showing my new design;  
FIG. 2 is a bottom view thereof;  
FIG. 3 is a rear perspective view thereof; and,  
FIG. 4 is an opposite rear perspective view thereof.  
The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The contrast in shading represents a contrast in color. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

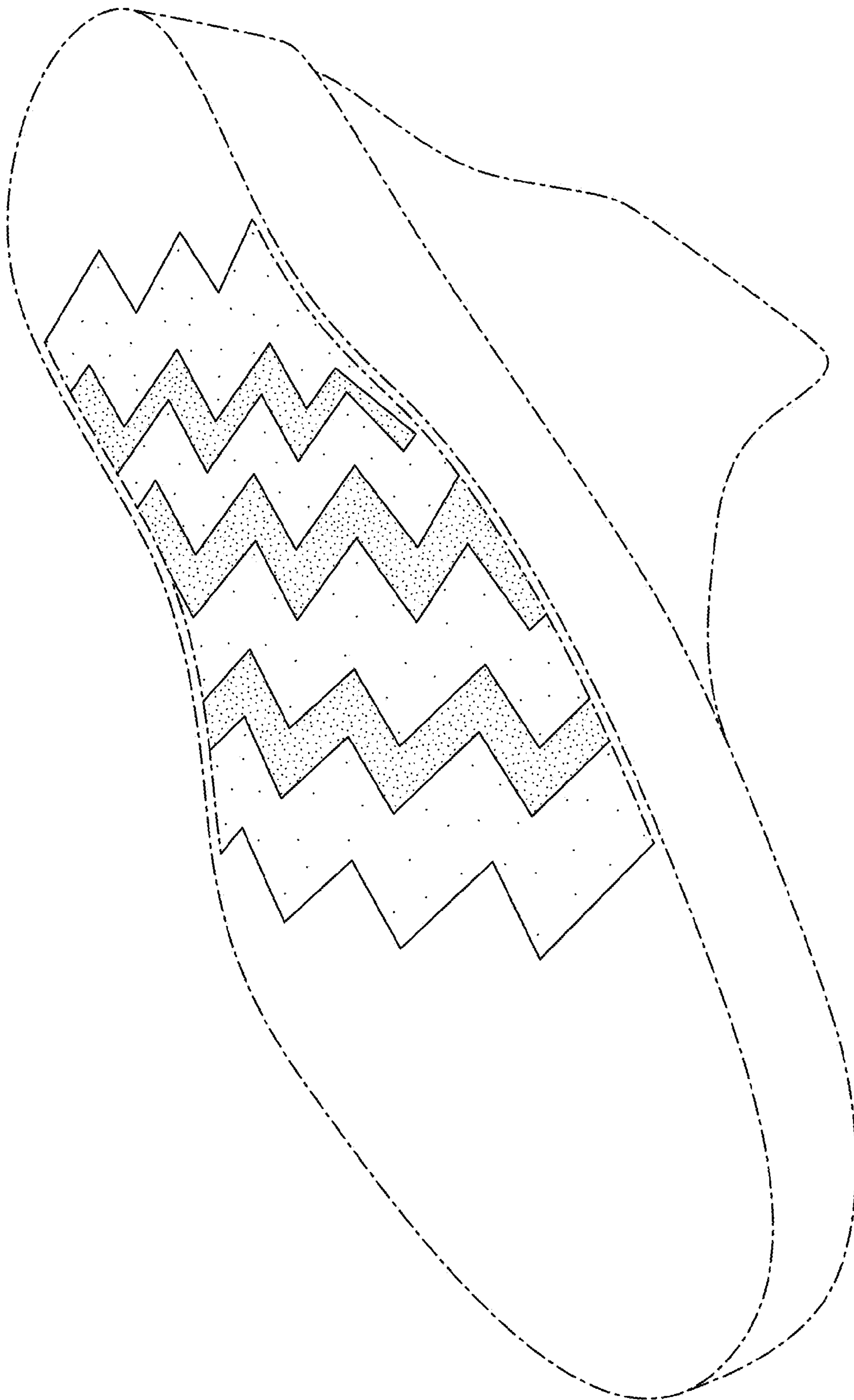

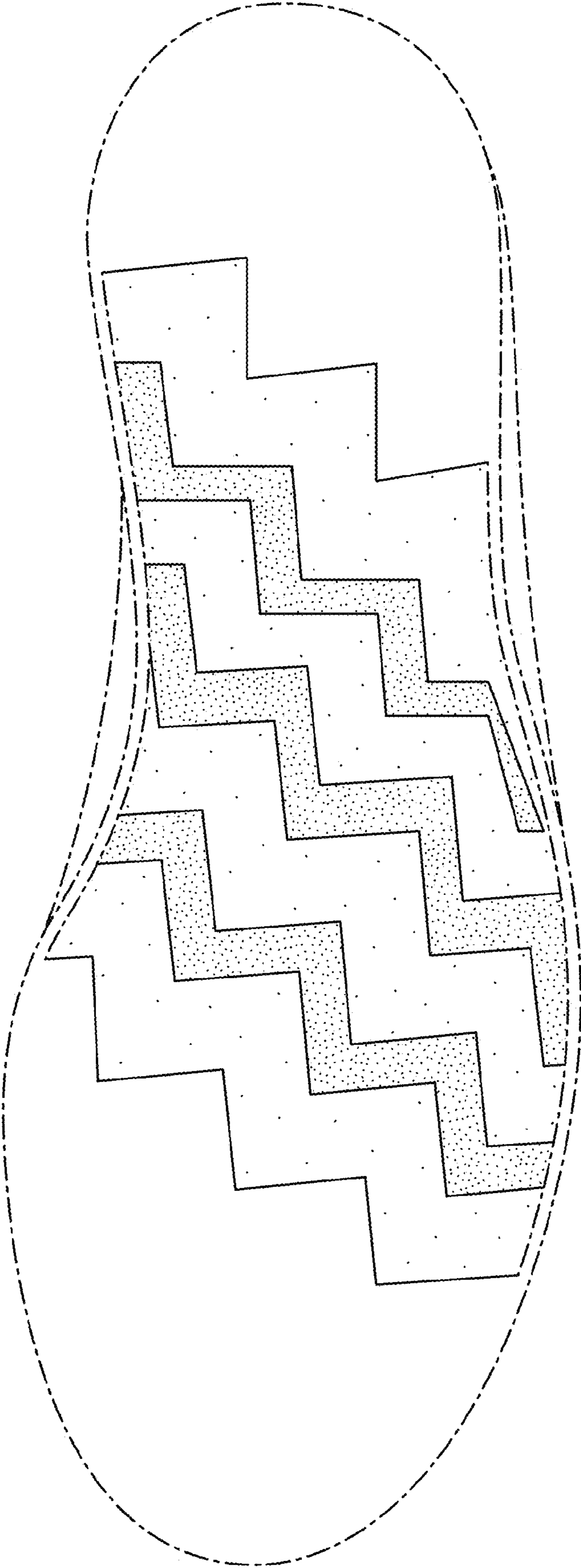

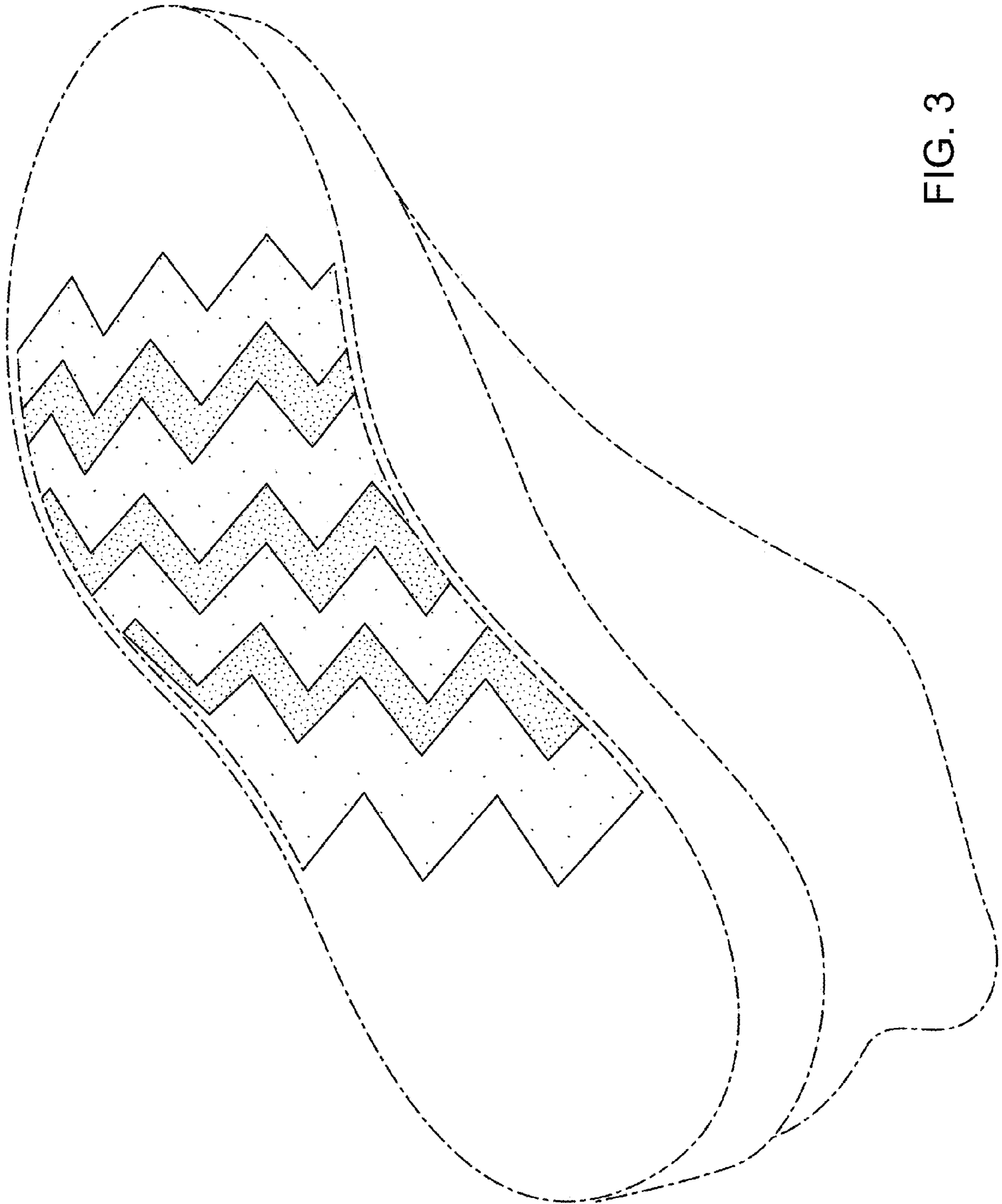

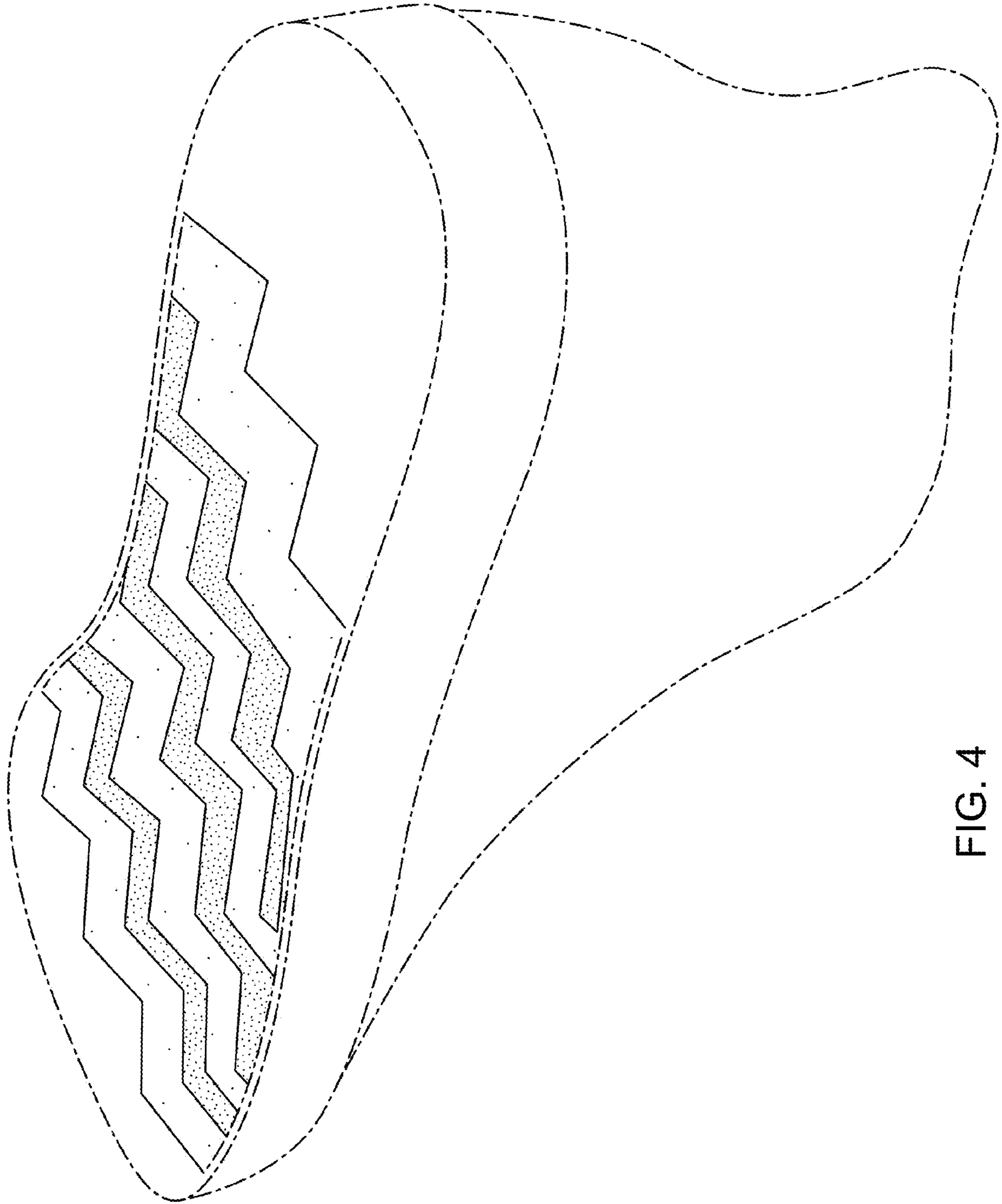
