(57) **CLAIM**

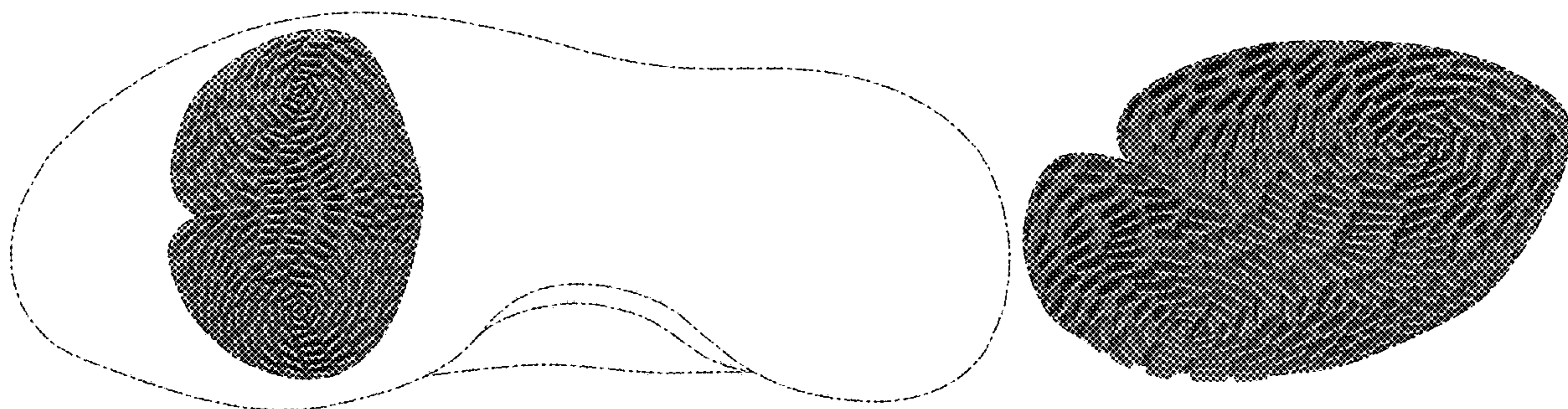
The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is bottom view of a shoe showing my new design; FIG. 2 is a rear bottom perspective view thereof; FIG. 3 is a front bottom perspective view thereof; and, FIG. 4 is an enlarged partial view of FIG. 3.

The broken lines immediately adjacent to the photographic area define the bounds of the claimed design and form no part thereof. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

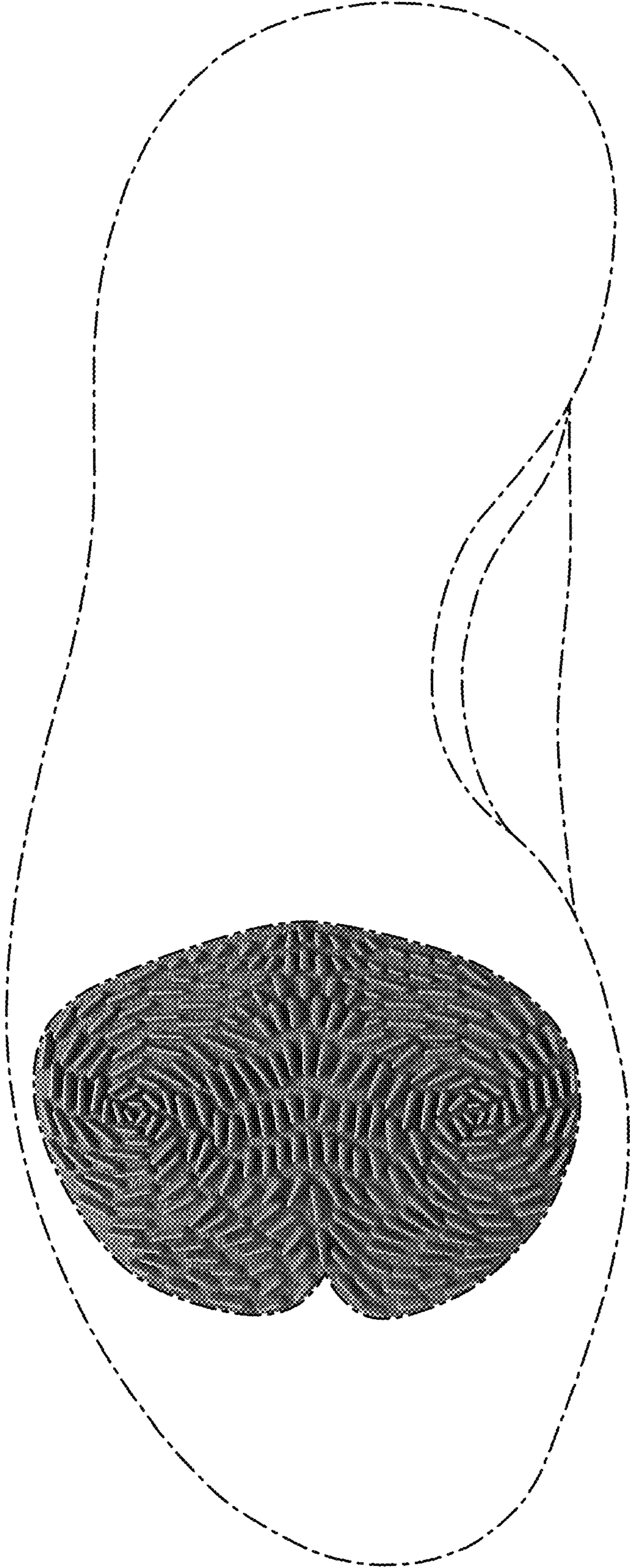

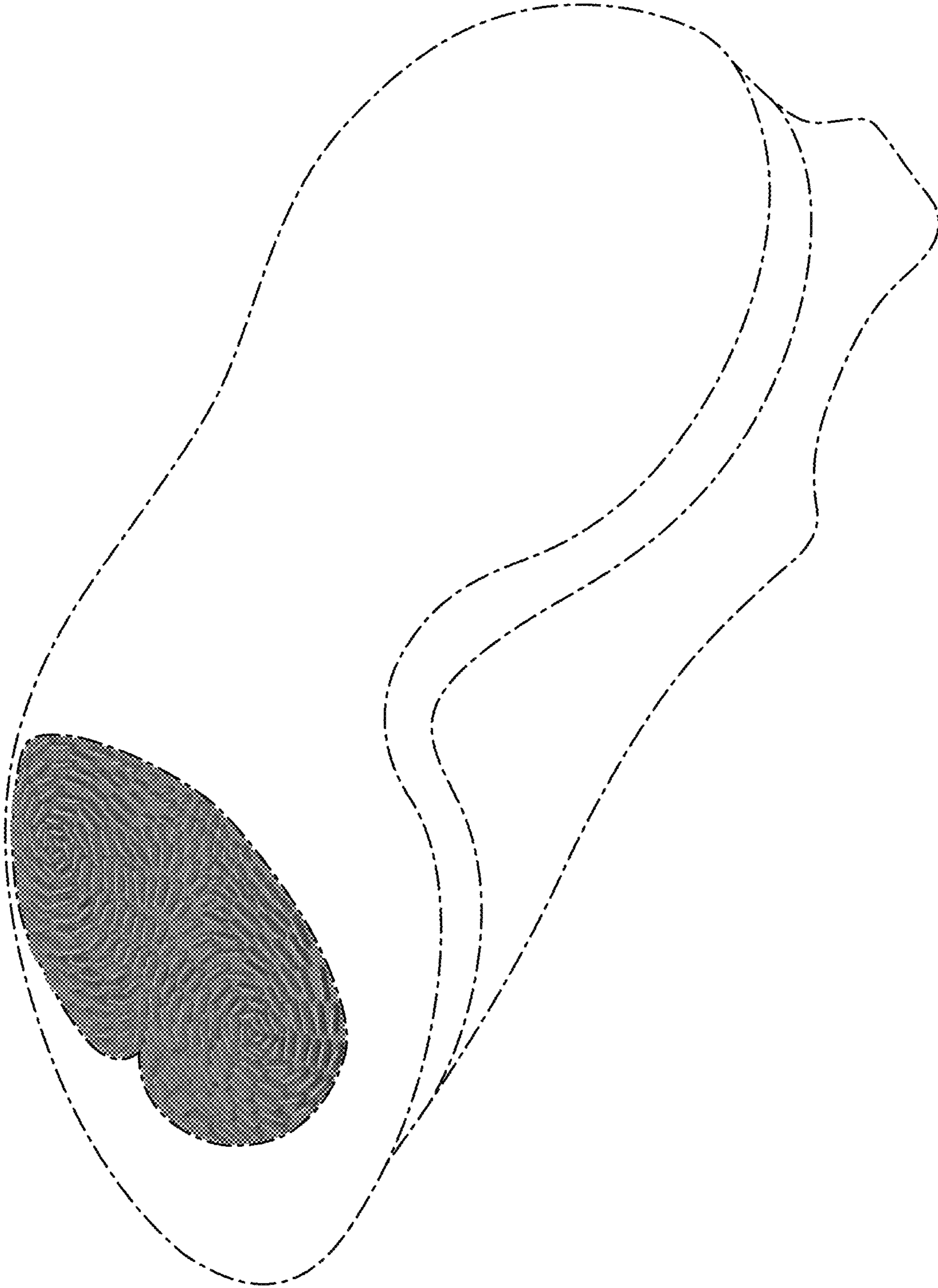

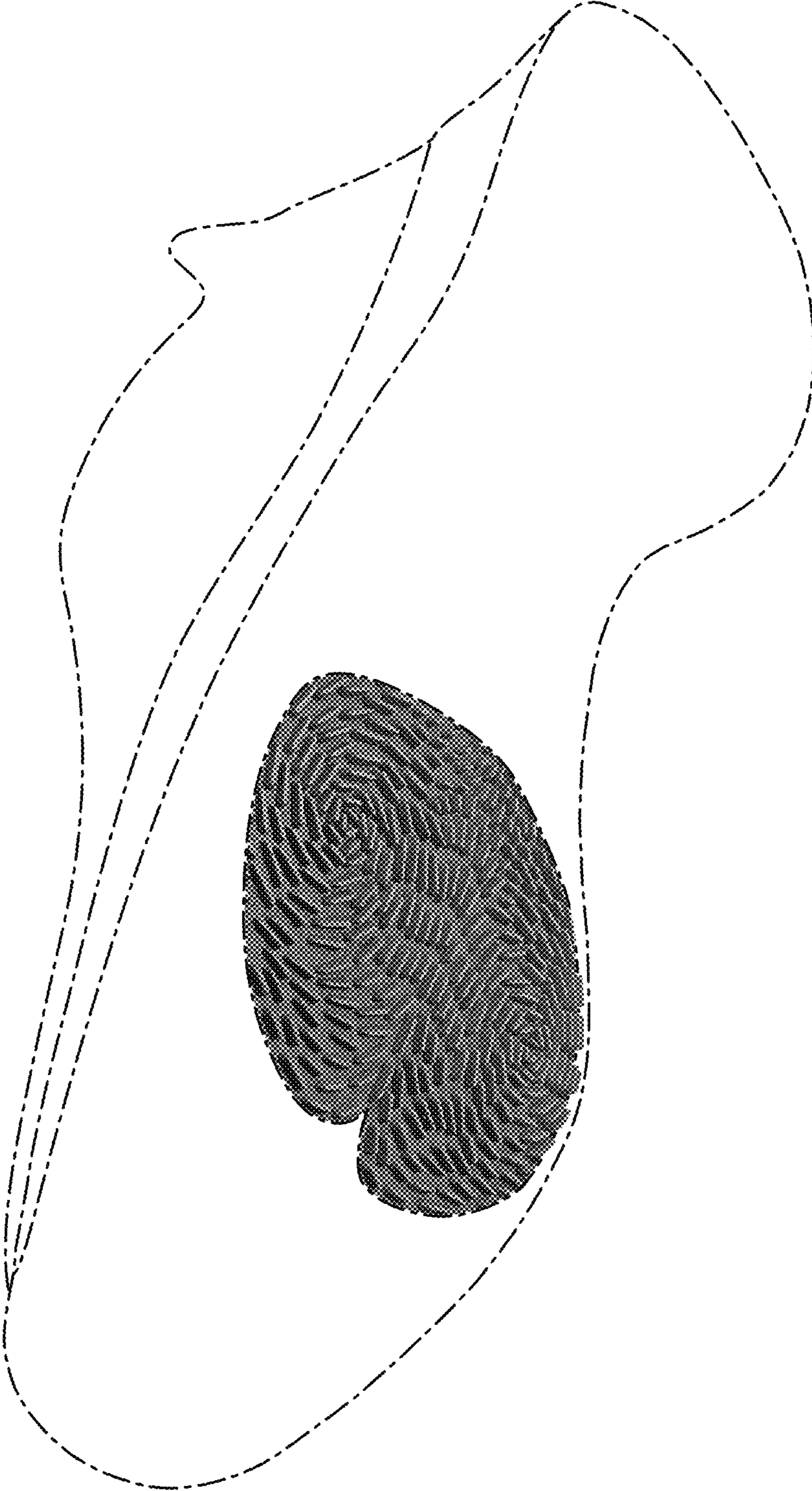
