(57) **CLAIM**

The ornamental design for a vapor barrier wrap, as shown and described.

DESCRIPTION

FIG. 1 is a plan view of a first embodiment of a vapor barrier wrap.

FIG. 2 is an enlarged detail view of the area marked 2 circumscribed within FIG. 1.

FIG. 3 is an enlarged detail view of the area 3 circumscribed within FIG. 2.

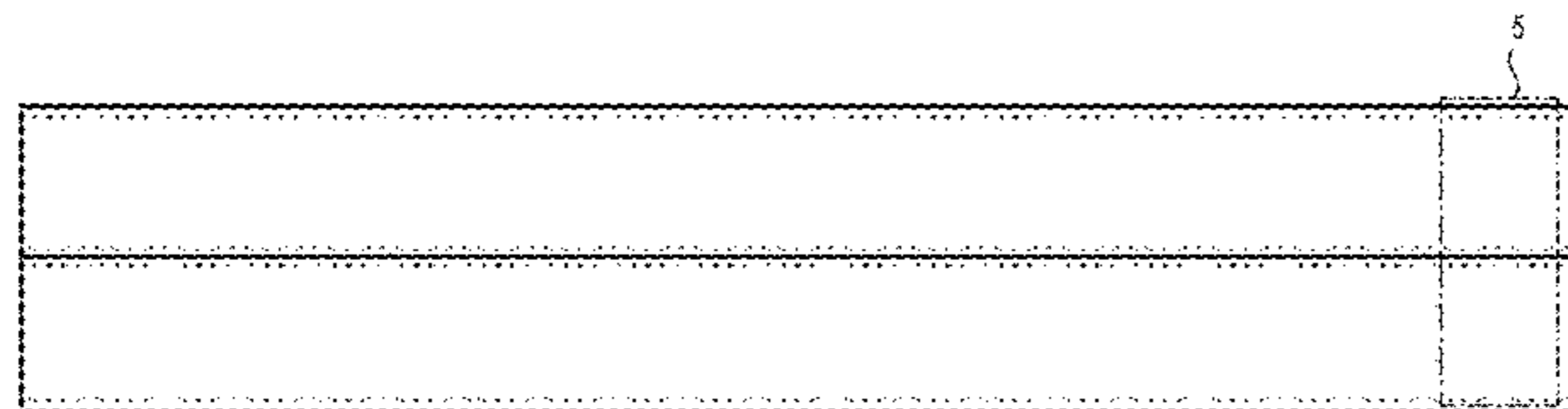
FIG. 4 is a plan view of a second embodiment of a vapor barrier wrap.

FIG. 5 is an enlarged detail view of the area marked 5 circumscribed within FIG. 4; and,

FIG. 6 is an enlarged detail view of the area marked 6 circumscribed within FIG. 5.

The evenly spaced broken lines depict portions of the vapor barrier wrap that form no part of the claimed design. The dot dashed broken lines surrounding the inner areas of FIGS. 1, 2, 4 and 5 and forming a perimeter around FIGS. 2, 3, 5 and 6 denote boundaries of detail areas and form no part of the claimed design.

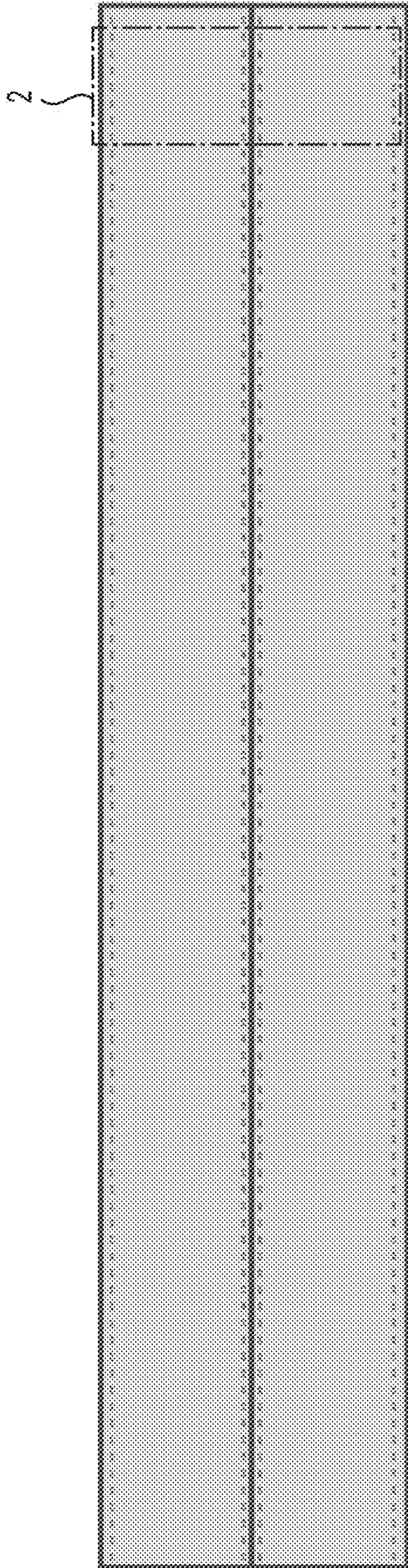
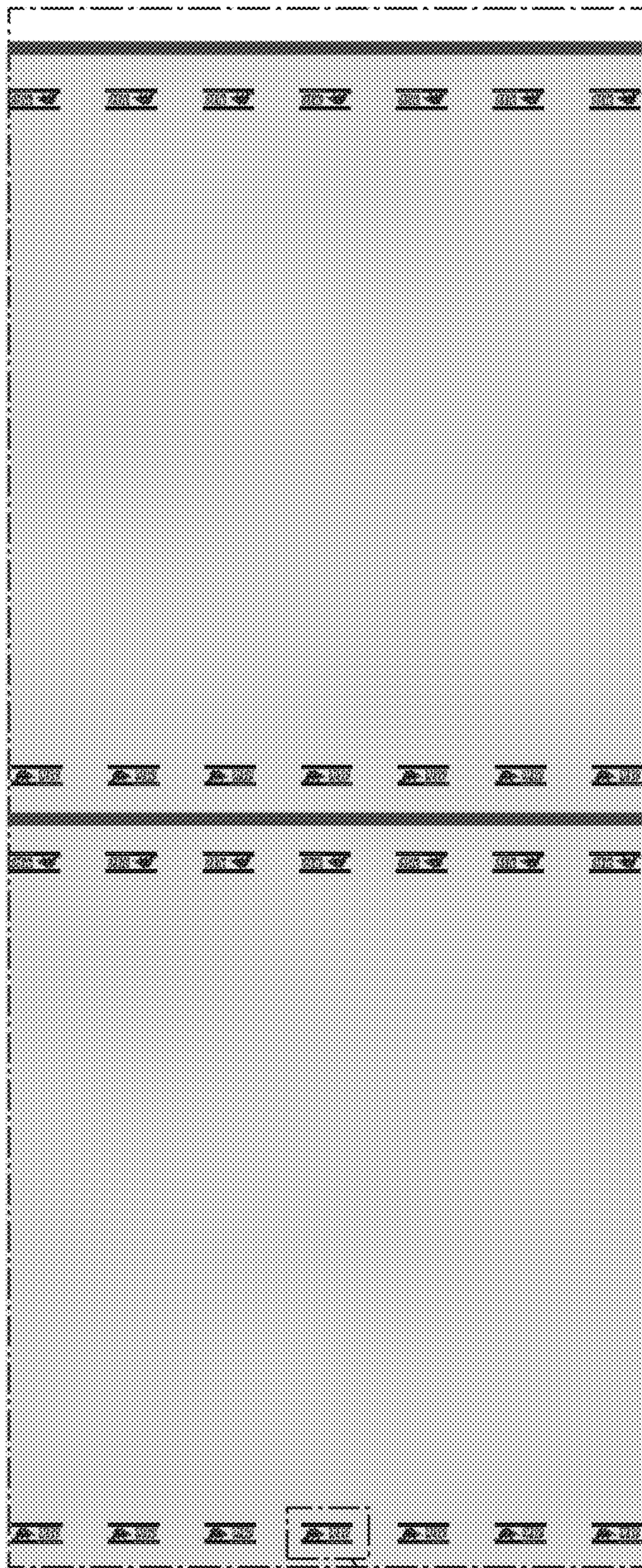

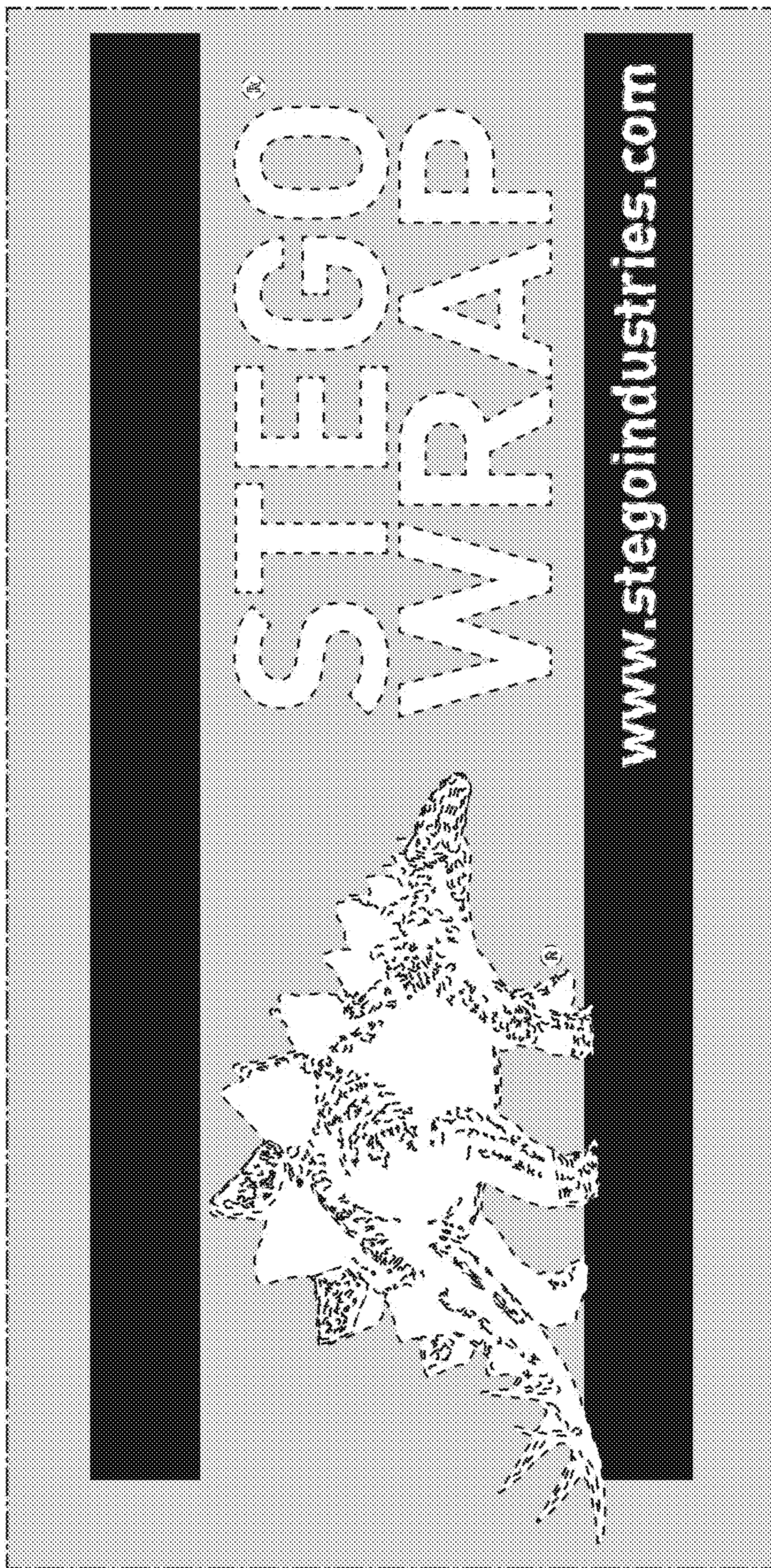

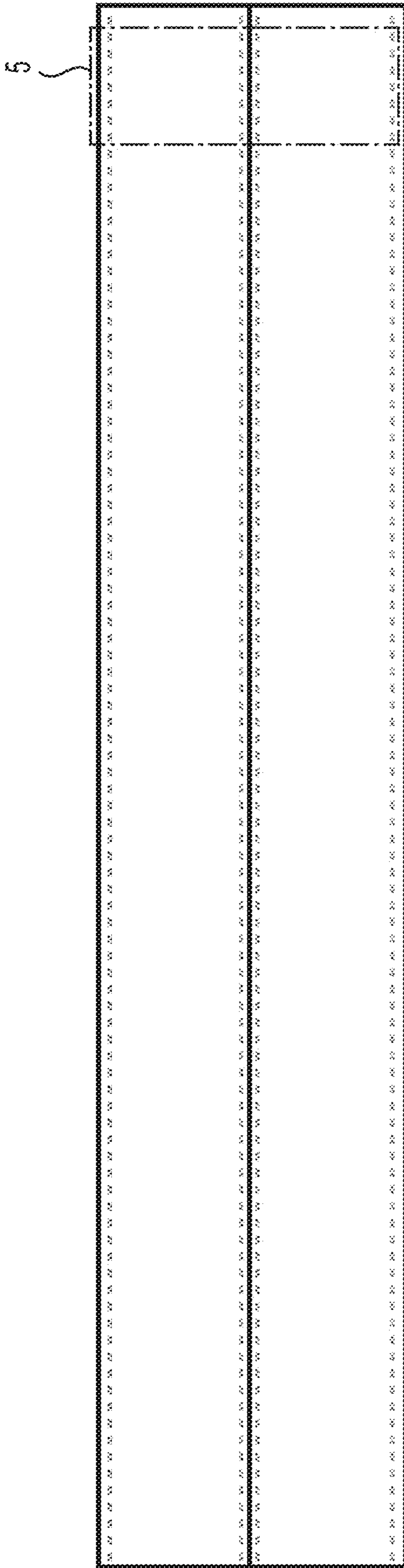

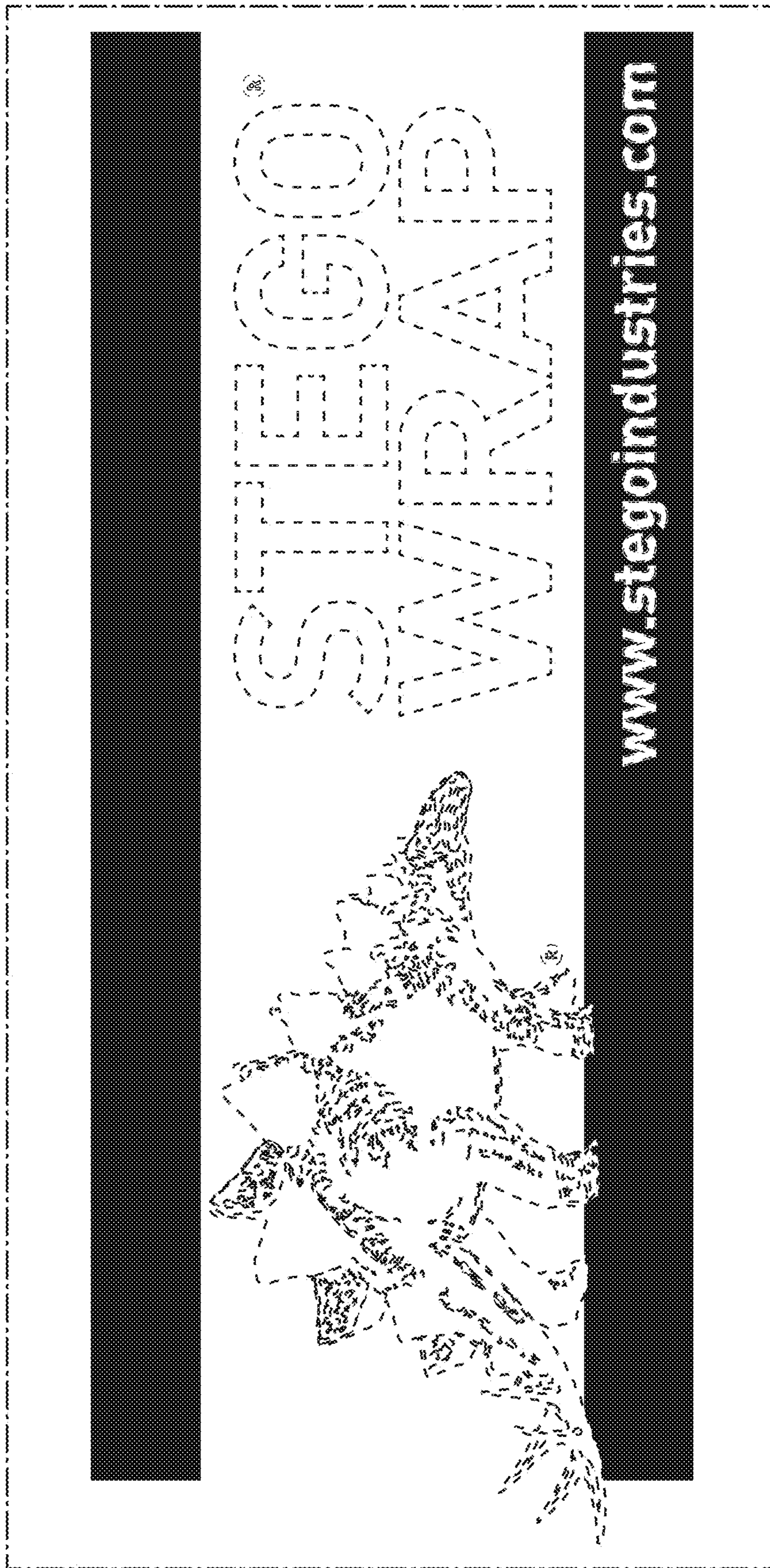
