DESCRIPTION

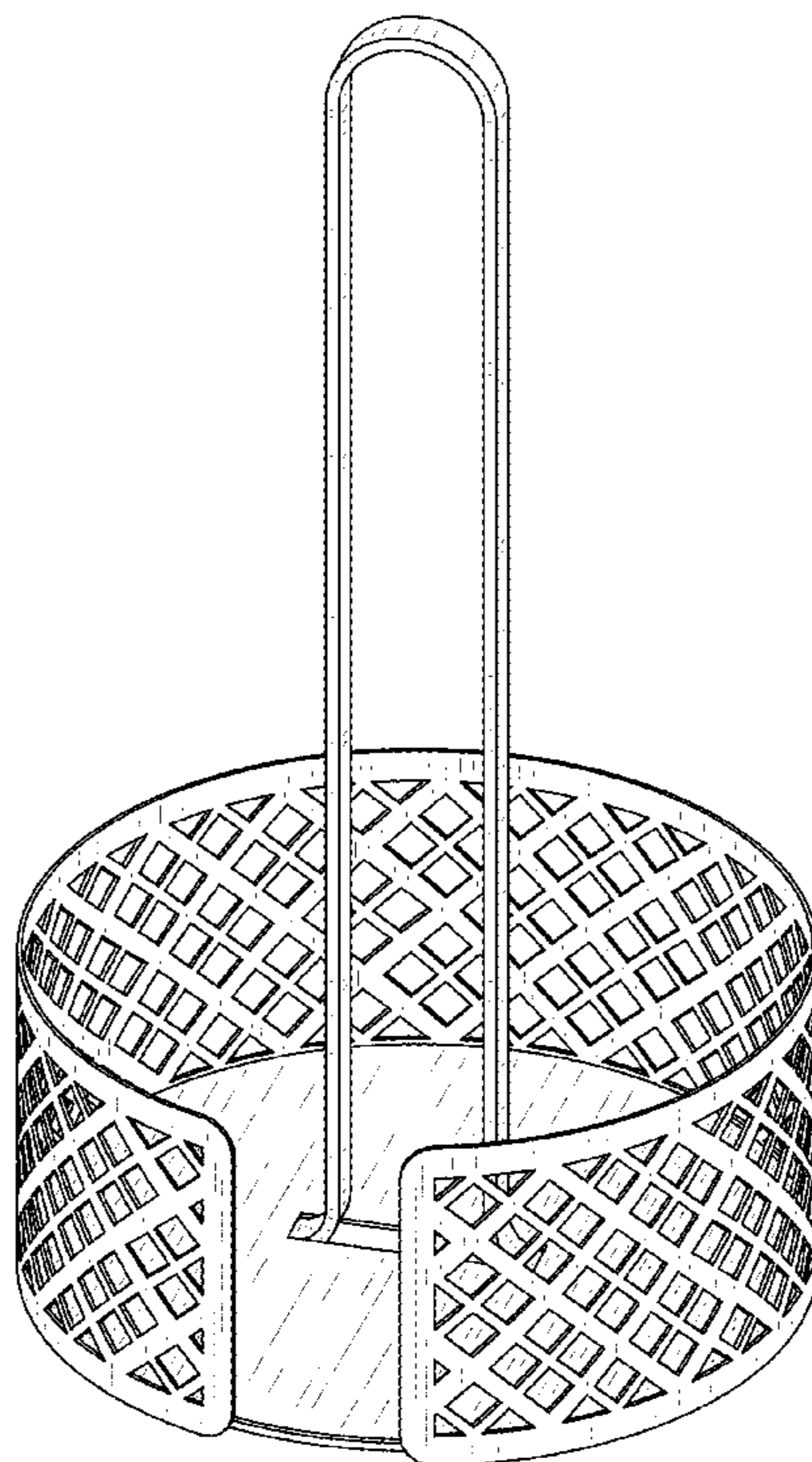
FIG. 1 is a perspective view of a paper towel holder showing our new design.

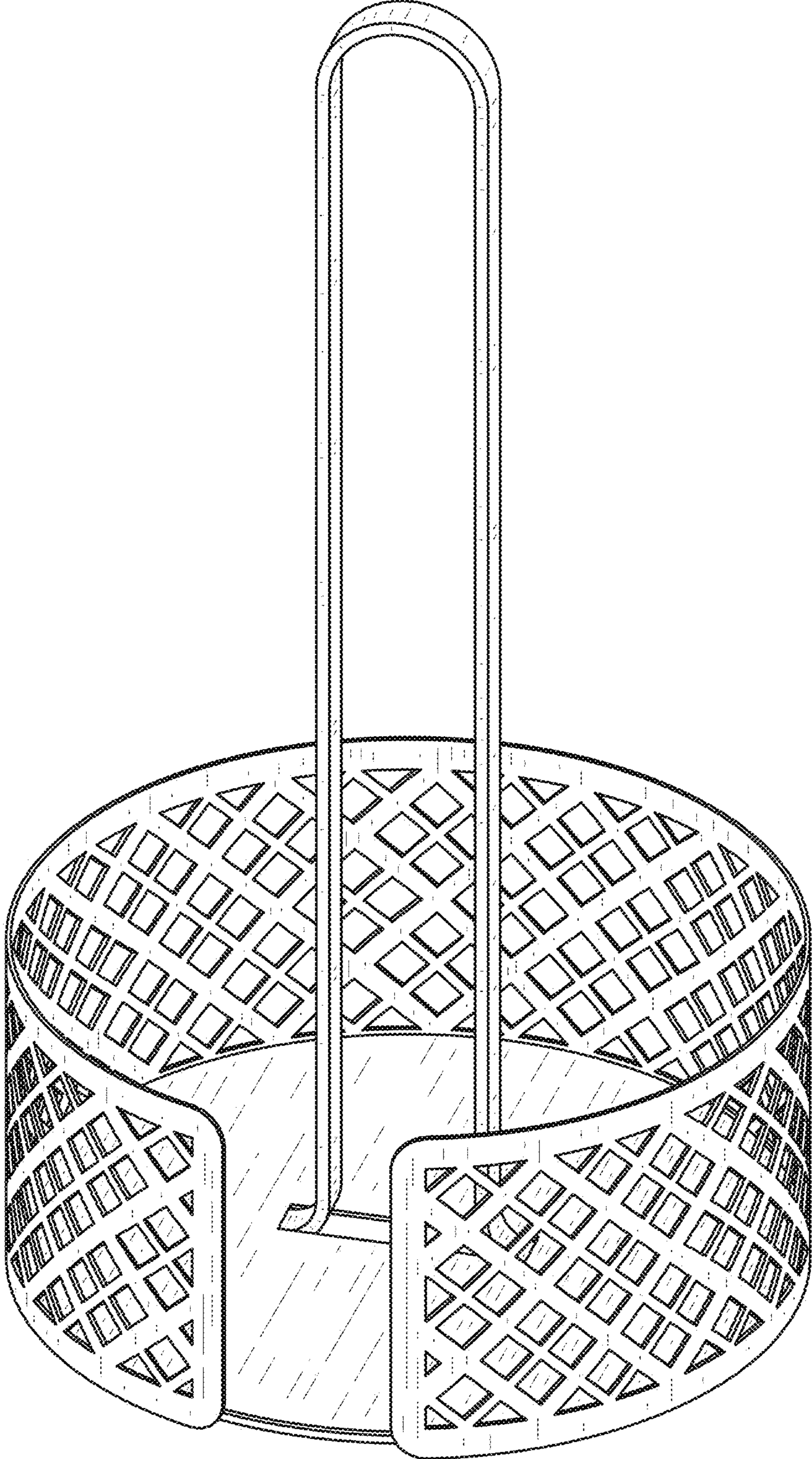

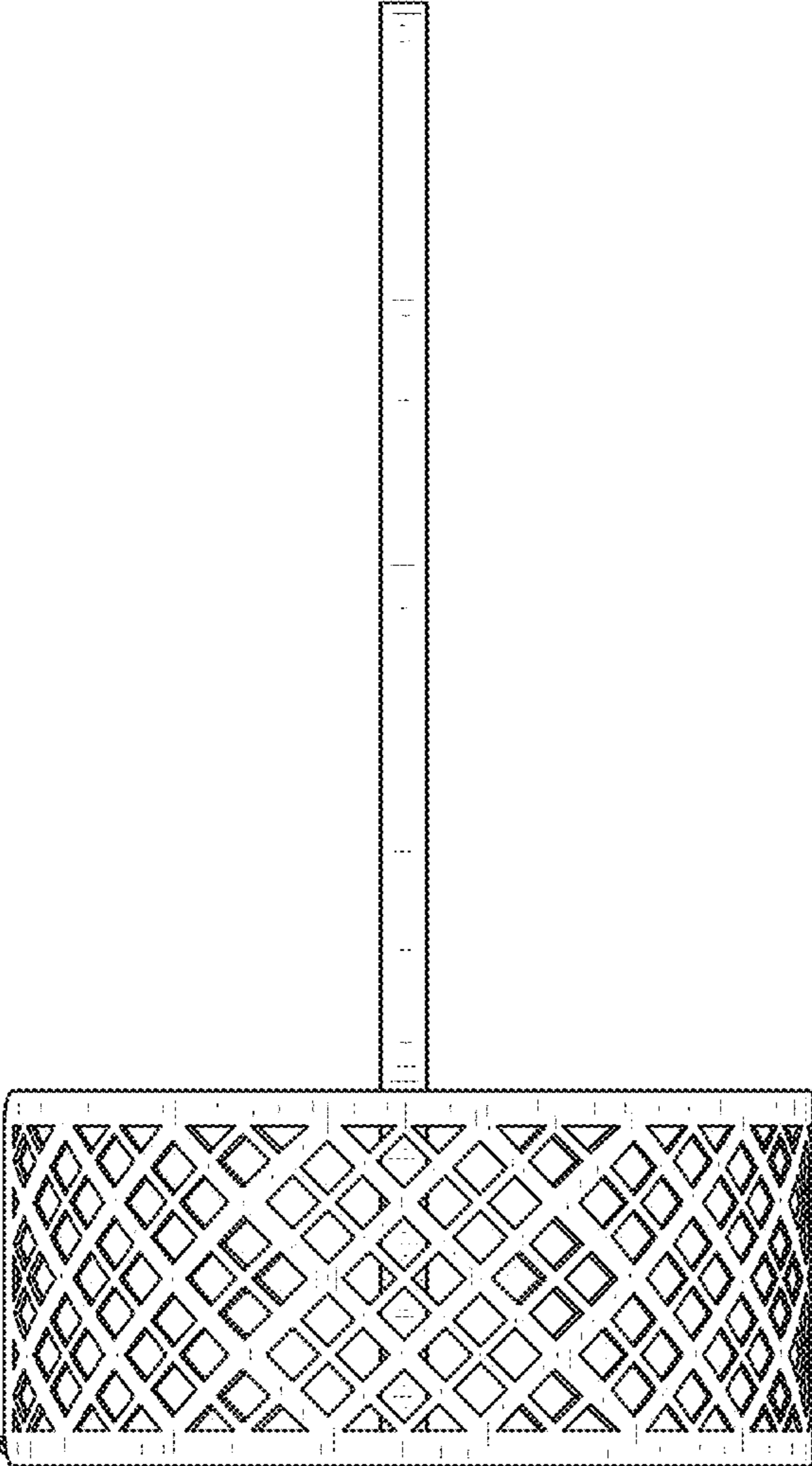

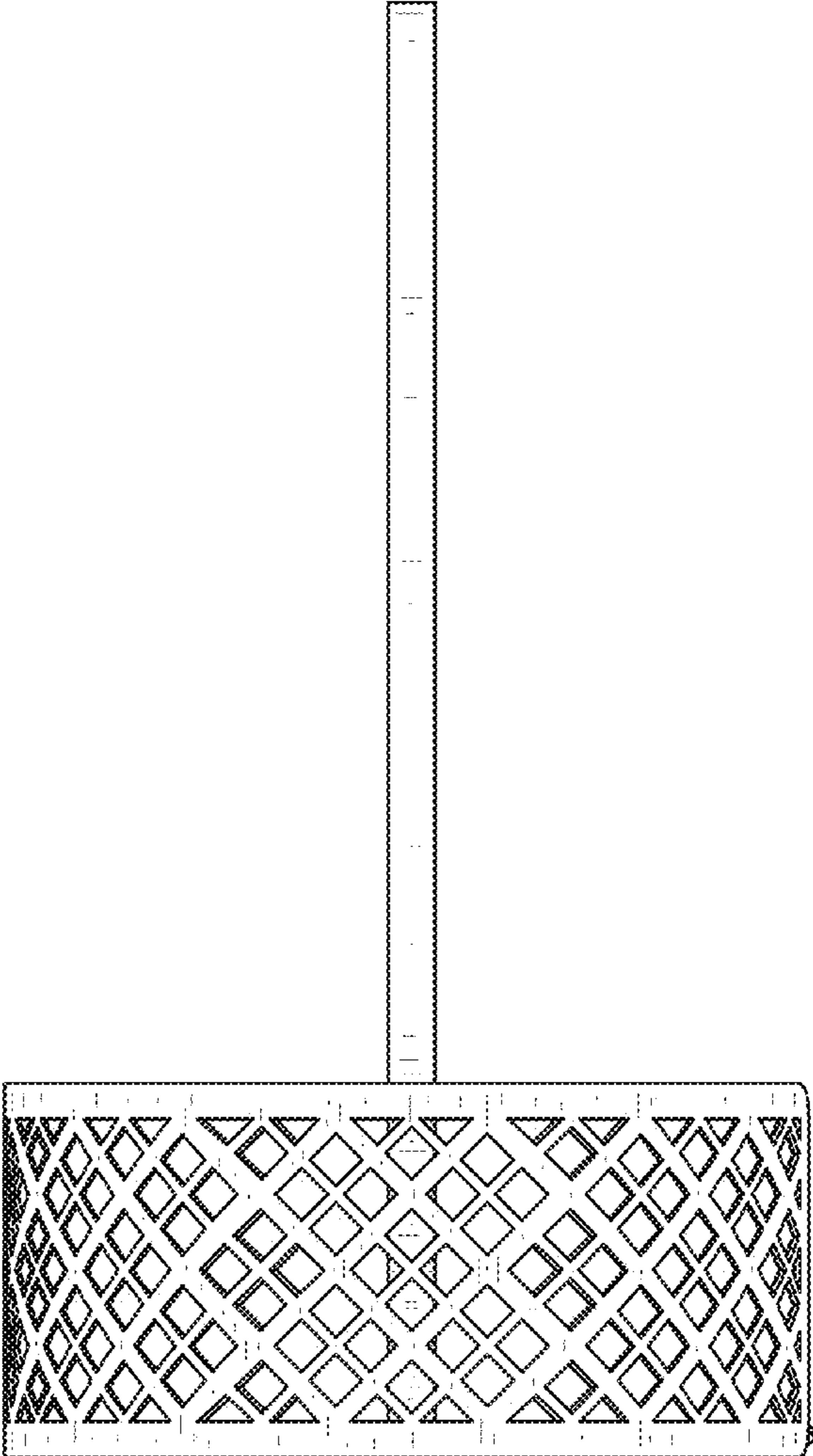

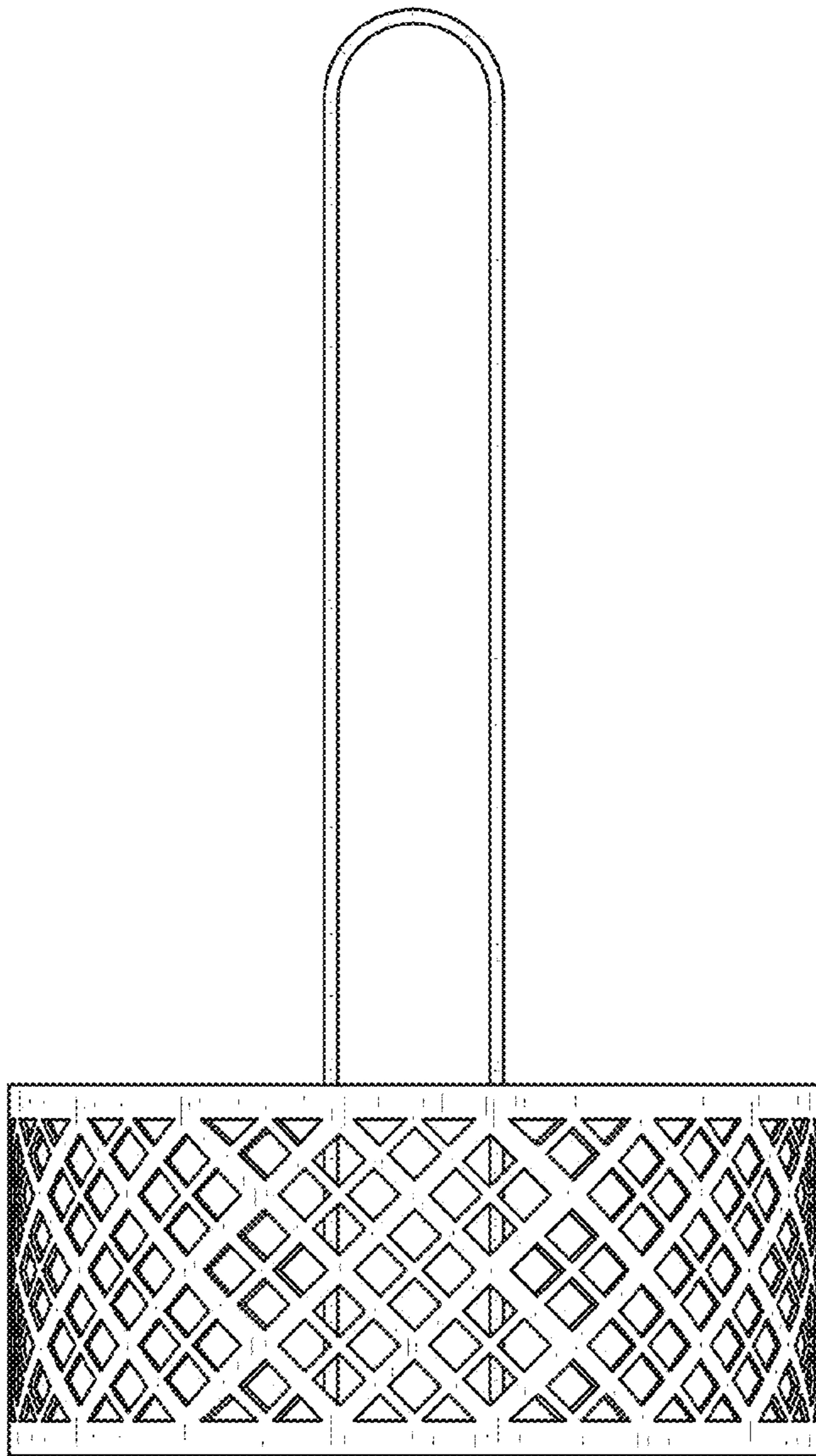

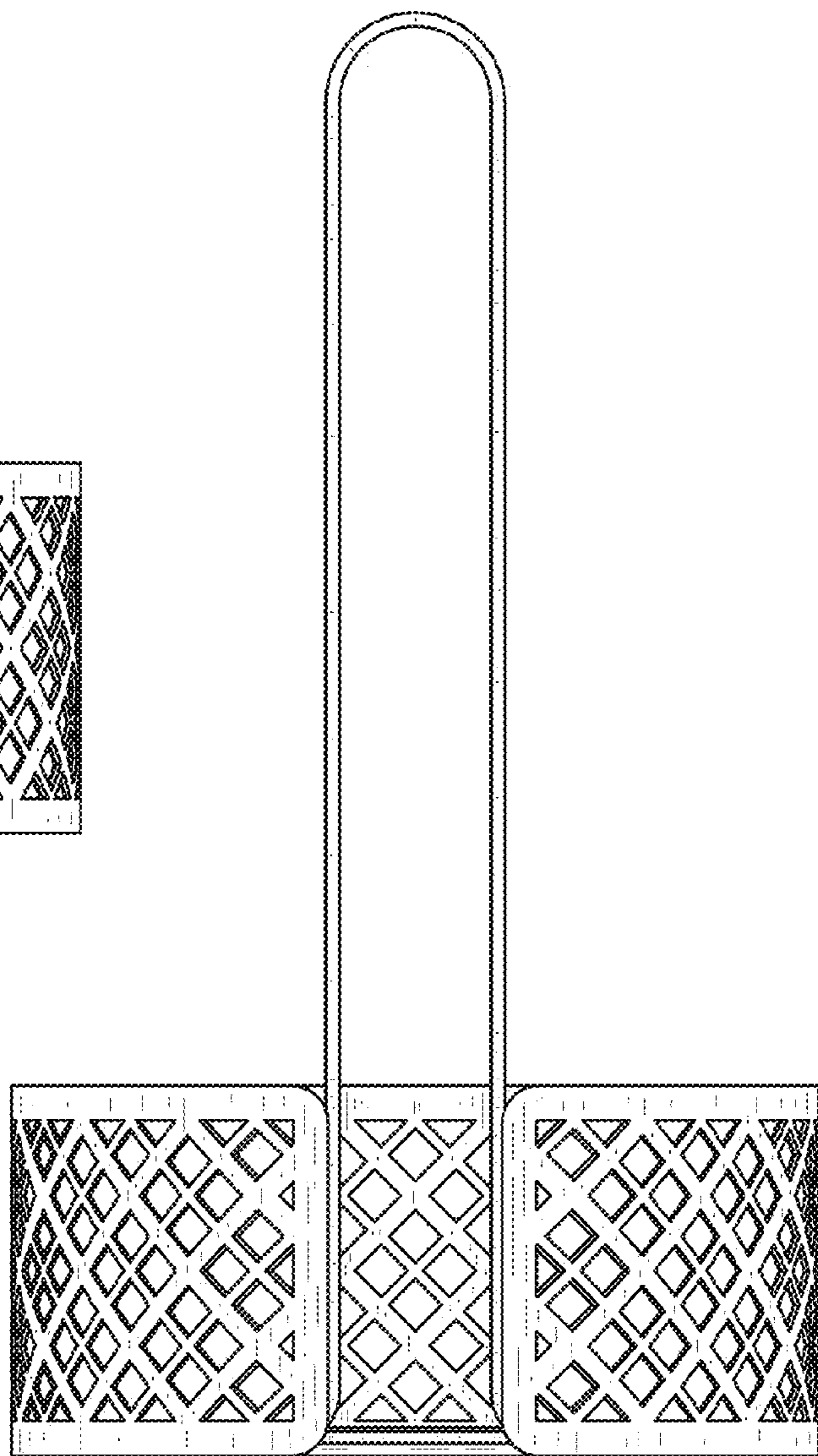

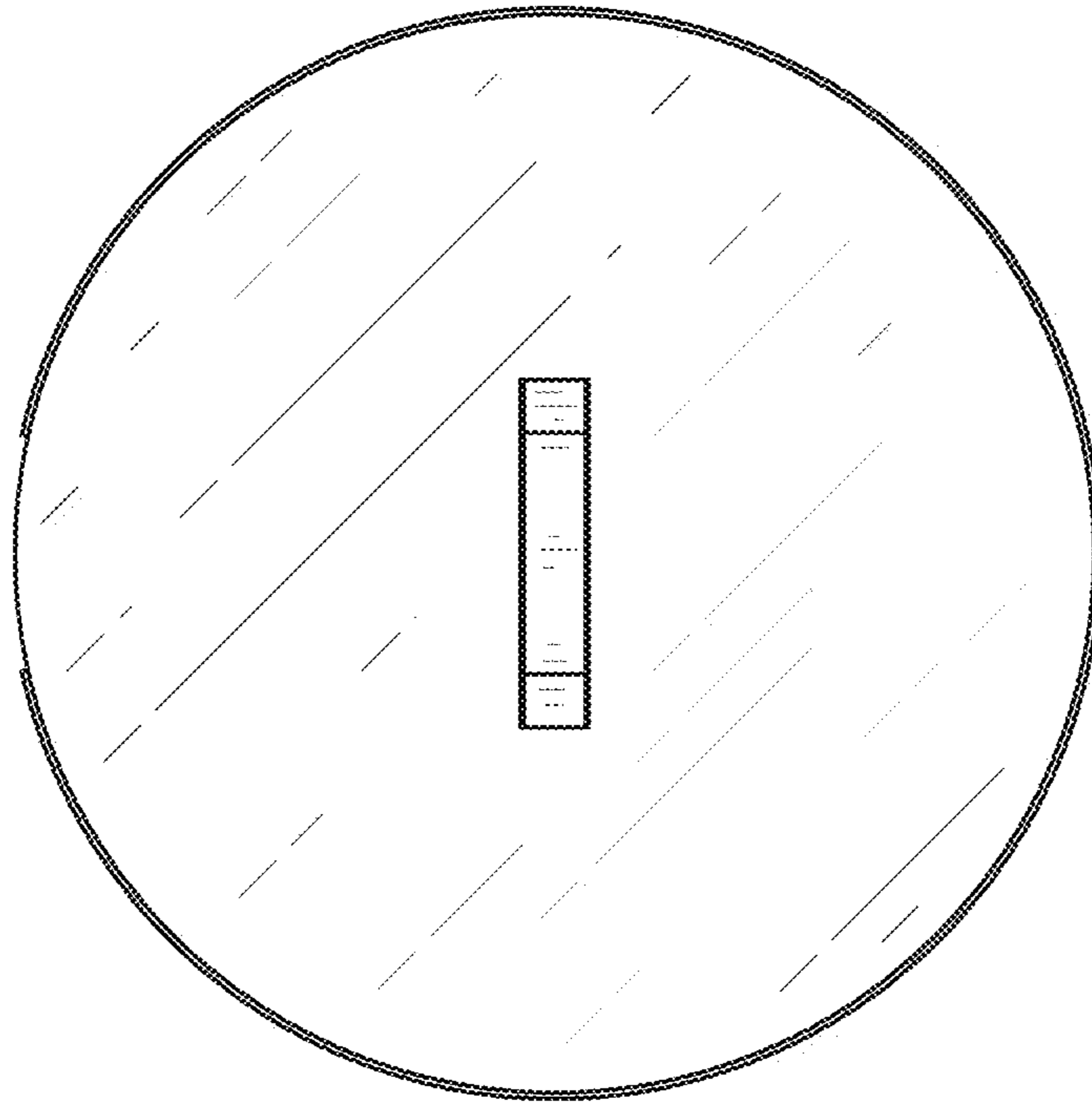

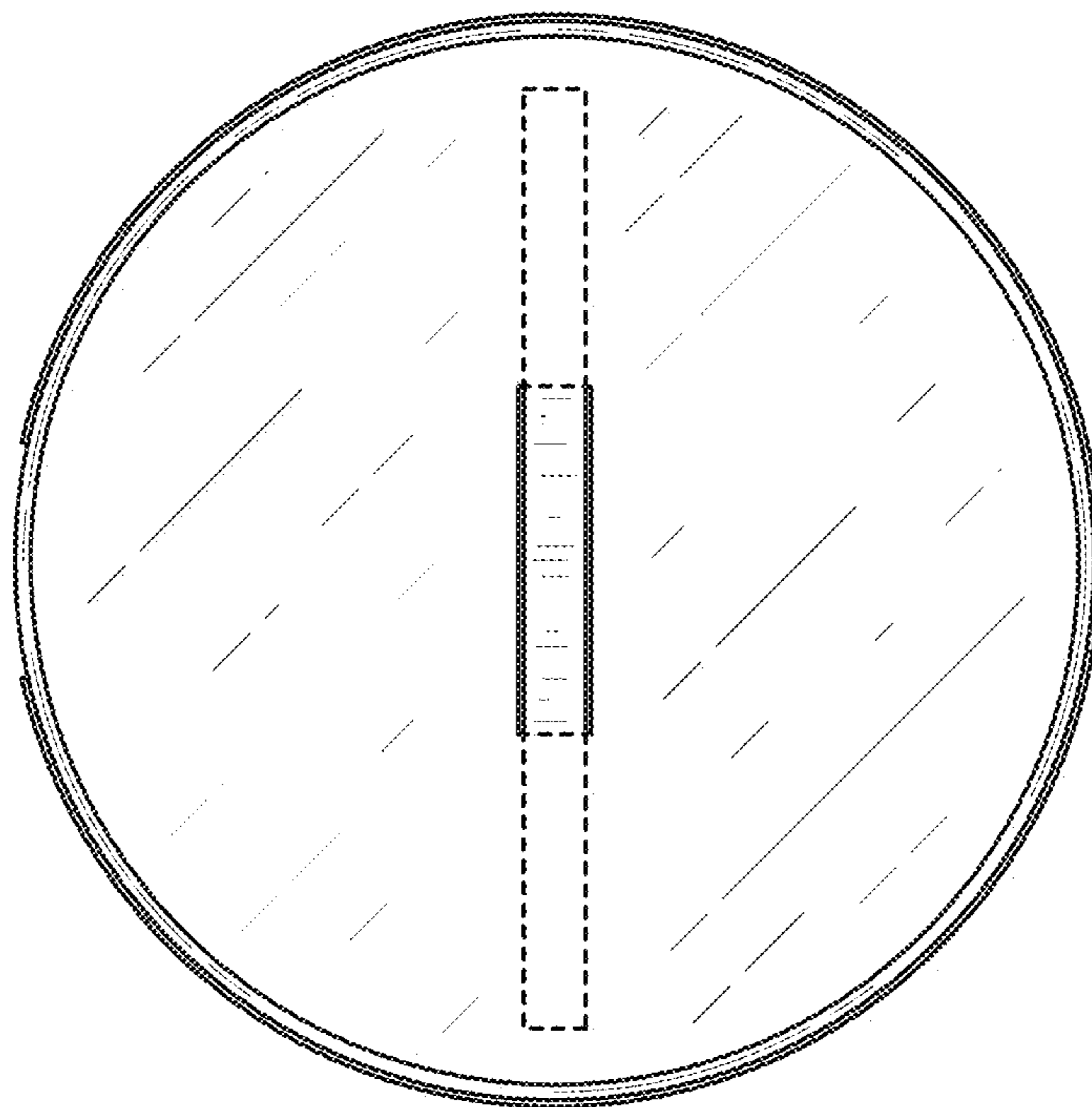
