We claim the ornamental design for a chair, as shown and described.

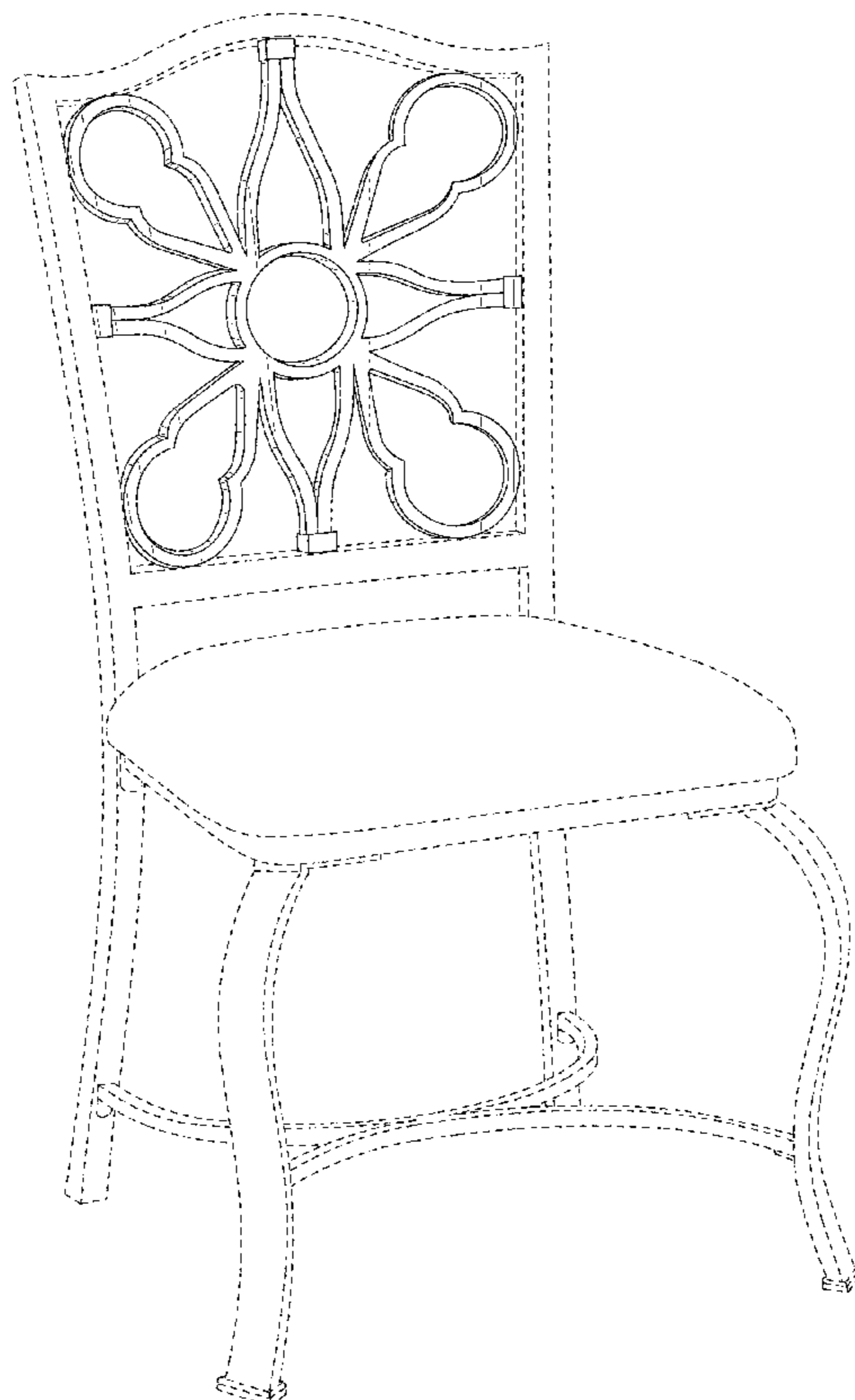
DESCRIPTION

FIG. 1 is a front perspective view of a chair.
FIG. 2 is a front view of the chair shown in FIG. 1.
FIG. 3 is a rear view of the chair shown in FIG. 1.
FIG. 4 is a left side view of the chair shown in FIG. 1, the right side view being a mirror image thereof; and,
FIG. 5 is a top view of the chair shown in FIG. 1.

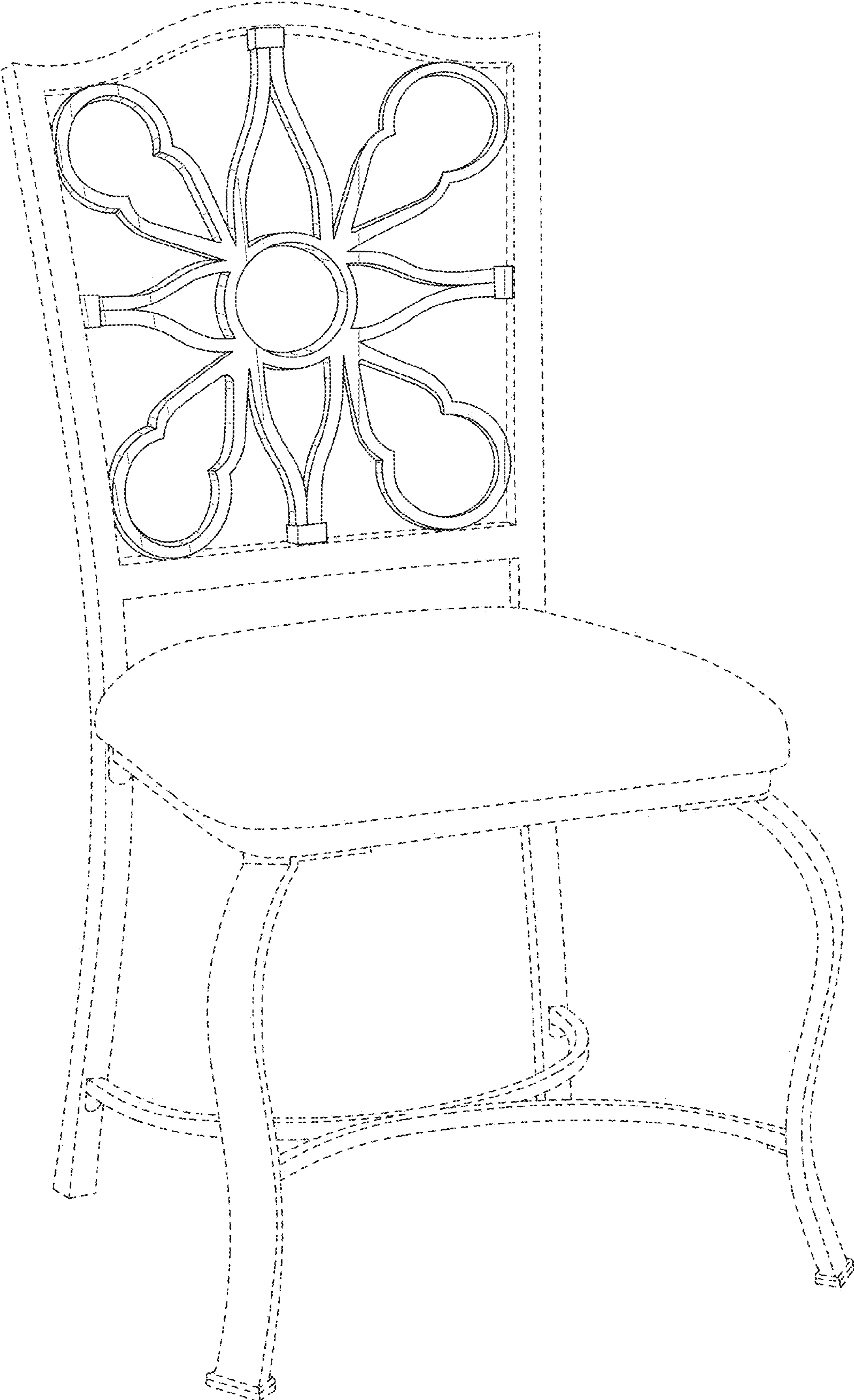

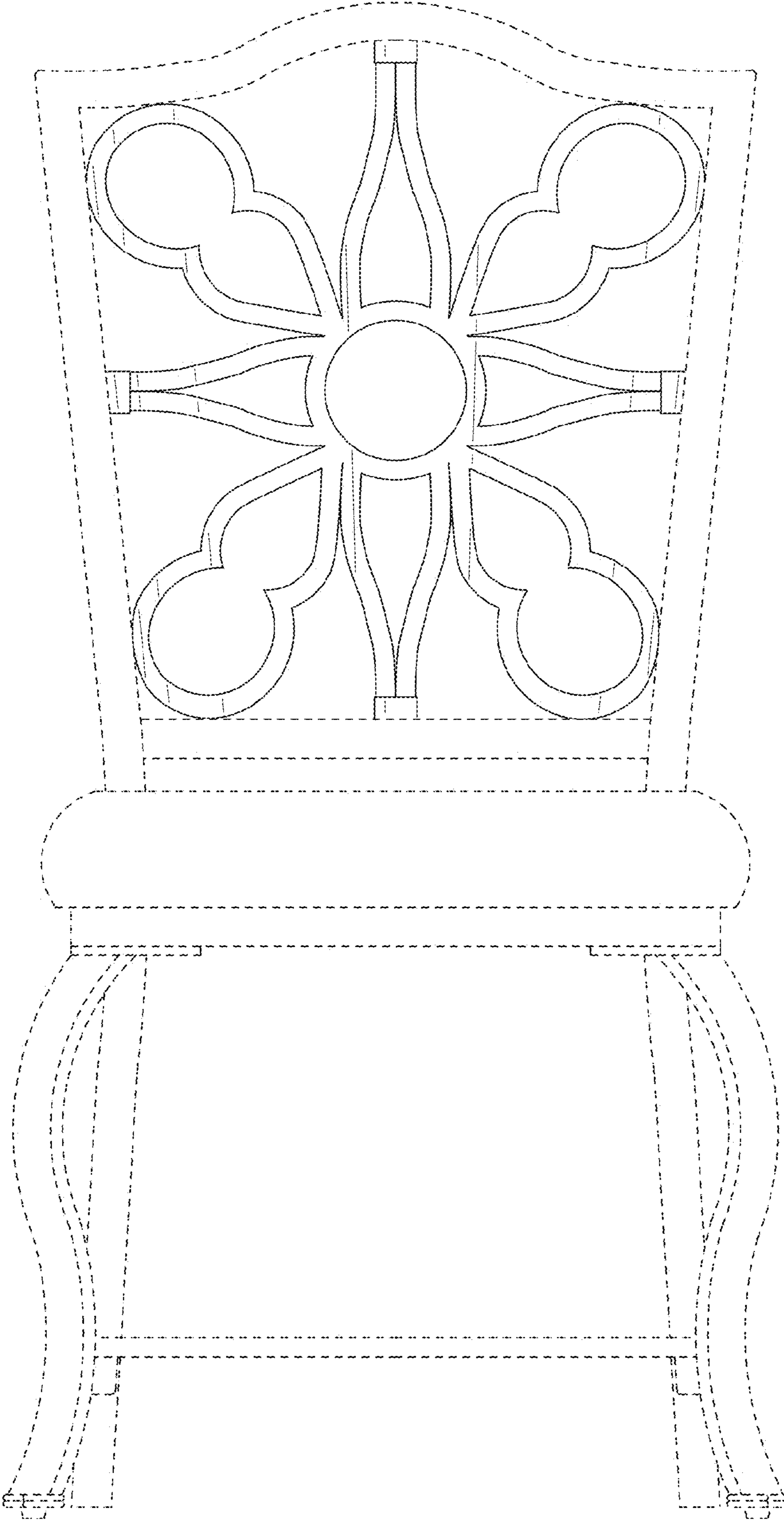

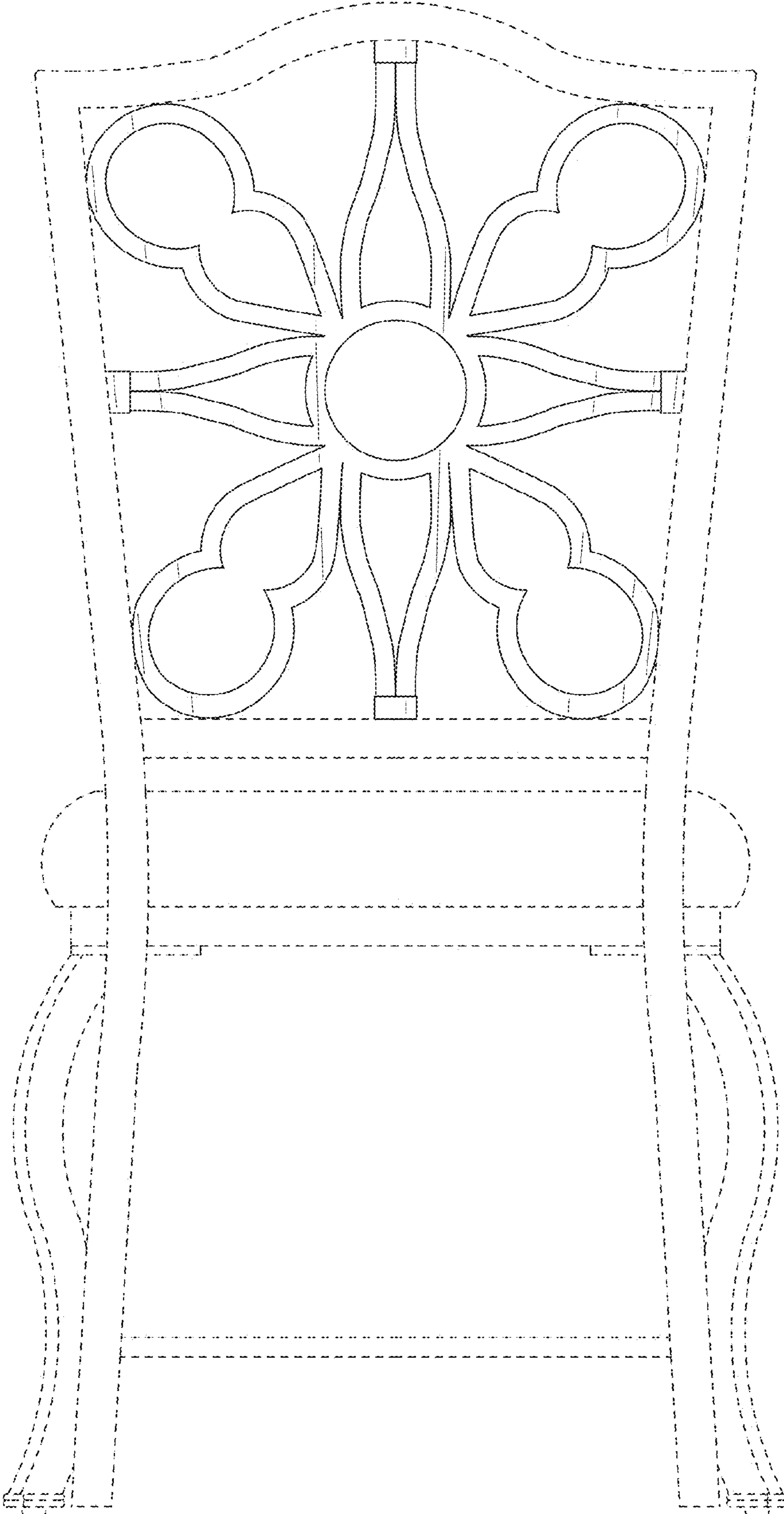

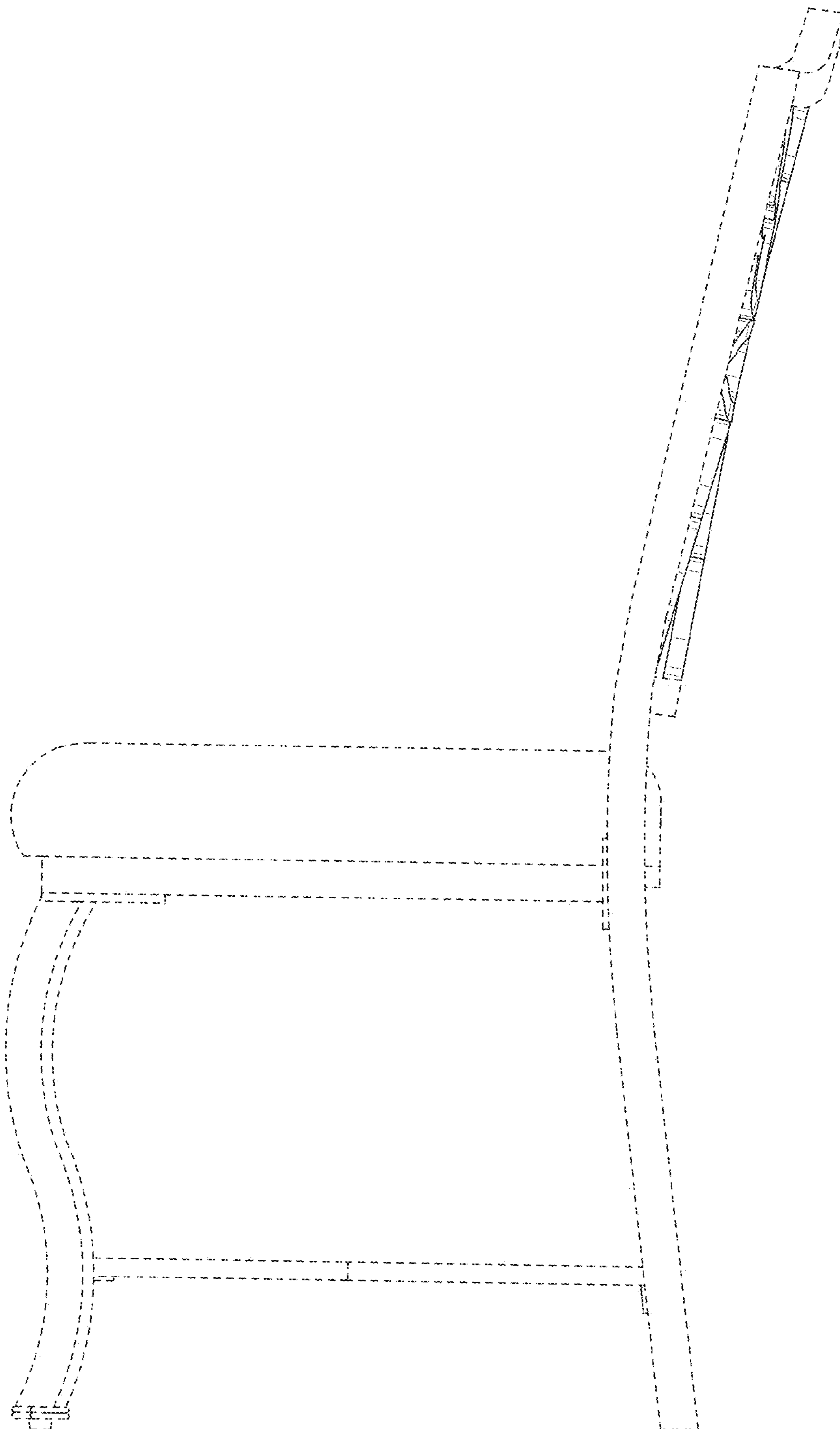

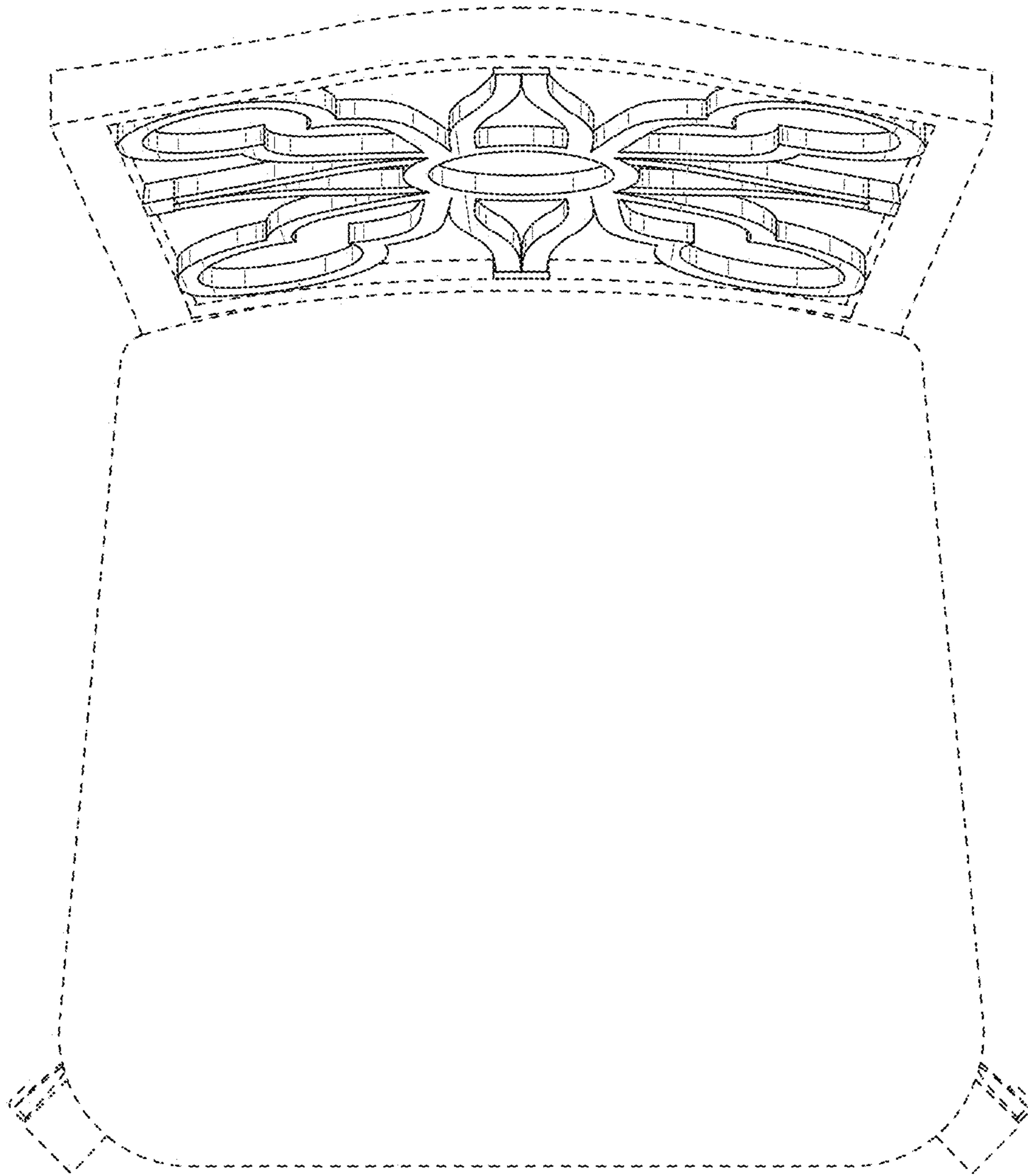
