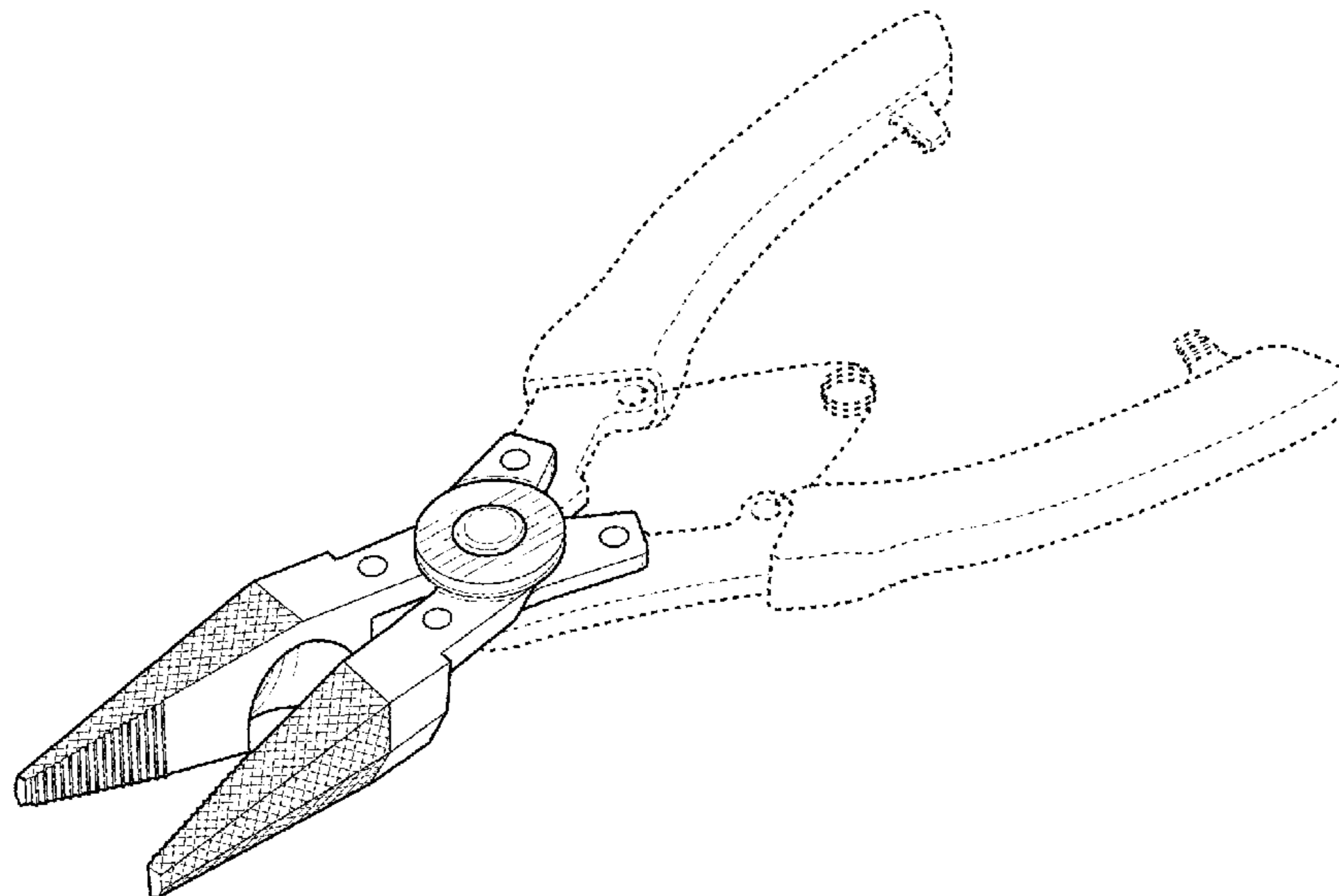
(57) **CLAIM**

The ornamental design for a multifunctional tool with interchangeable head, as shown and described.

**DESCRIPTION**

FIG. 1 shows a perspective view of a multifunctional tool with interchangeable head;  
 FIG. 2 shows a front view thereof;  
 FIG. 3 shows a rear view thereof wherein a portion of the broken line subject matter has been removed for ease of illustration;  
 FIG. 4 shows a right side view thereof;  
 FIG. 5 shows a left side view thereof;  
 FIG. 6 shows a top plan view thereof; and,  
 FIG. 7 shows a bottom plan view thereof.  
 The shade lines in the Figures show contour and not surface ornamentation.  
 The broken lines in the drawings illustrate portions of the multifunctional tool with interchangeable head and form no part of the claimed design.

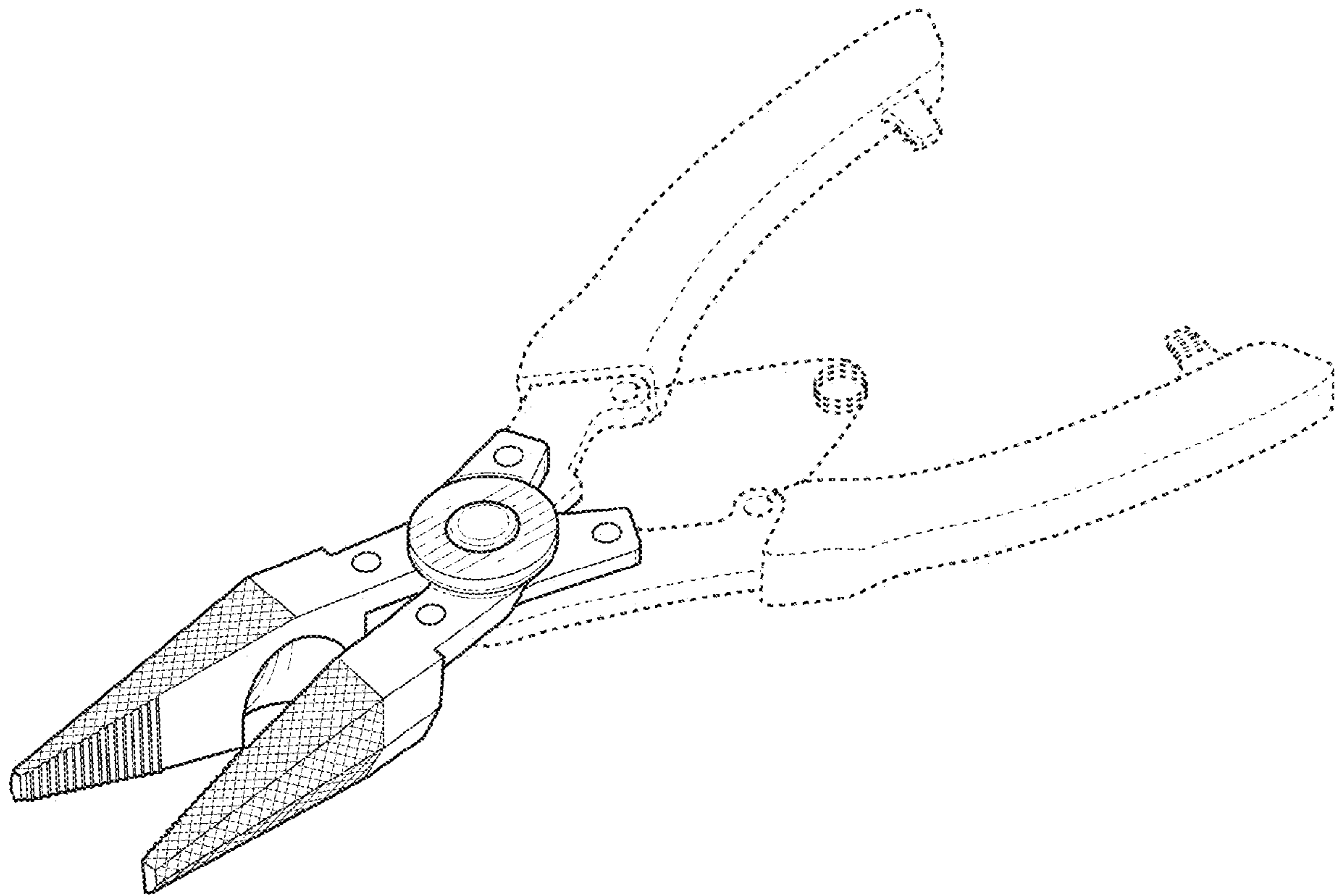

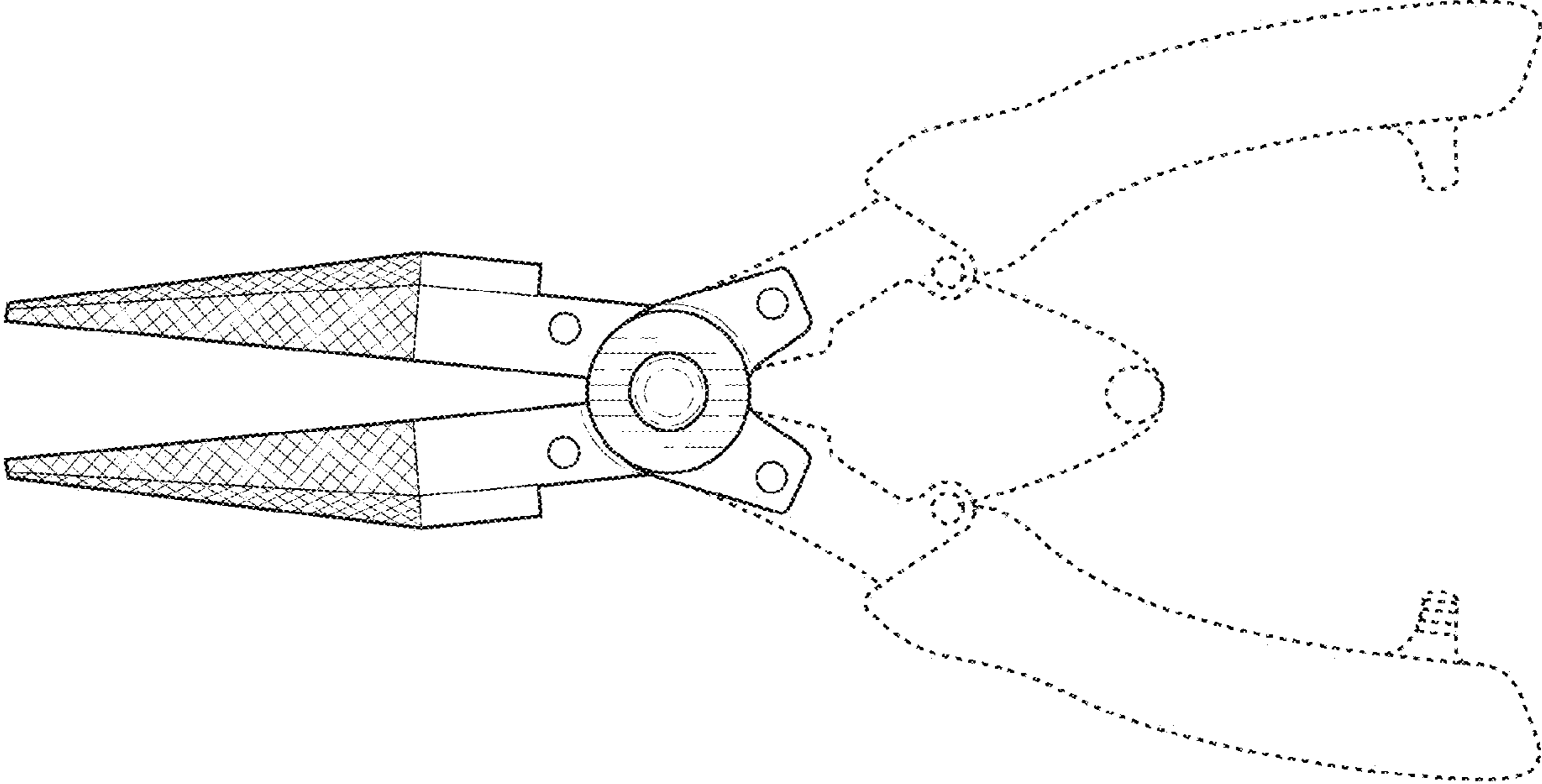

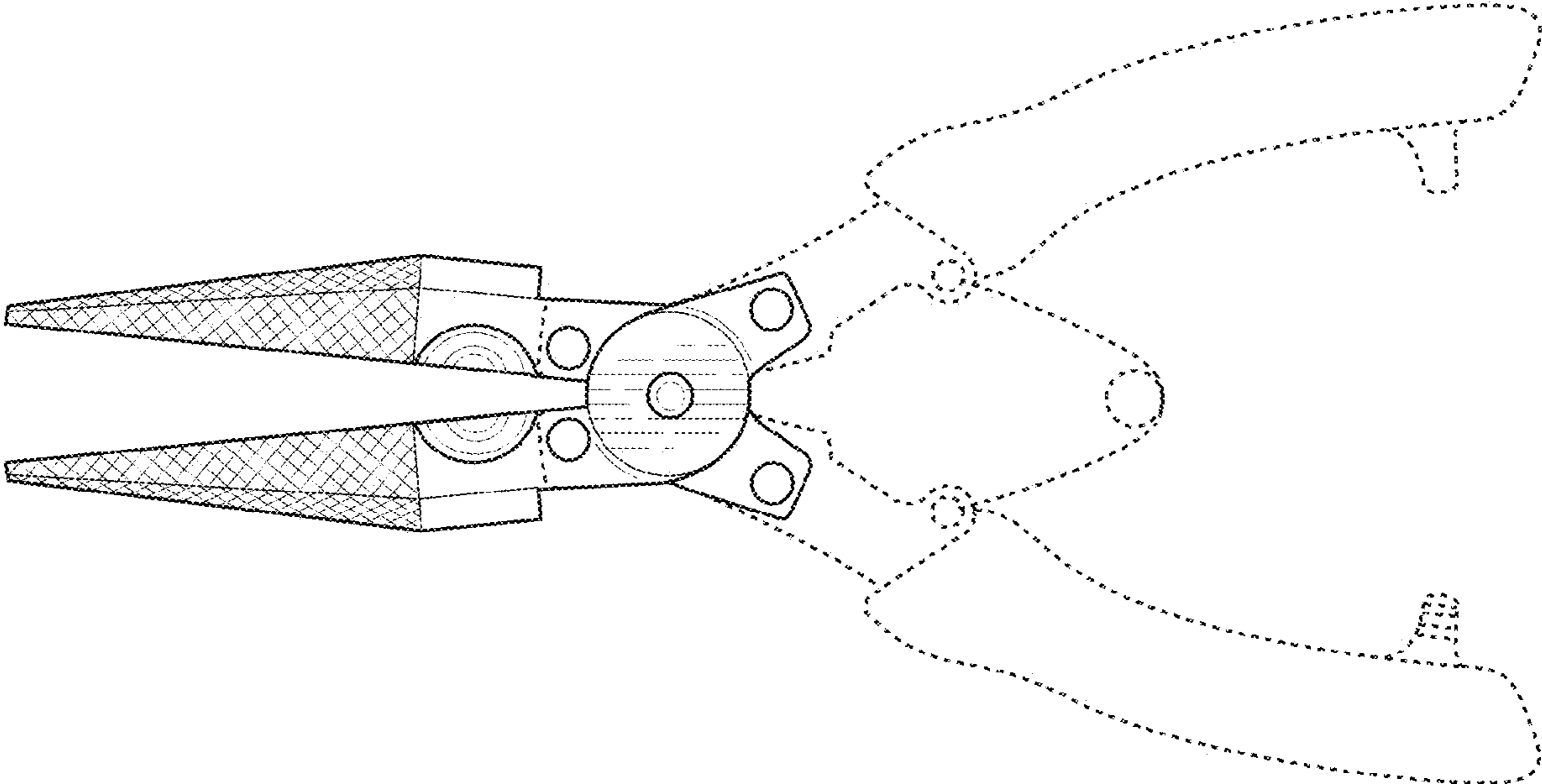

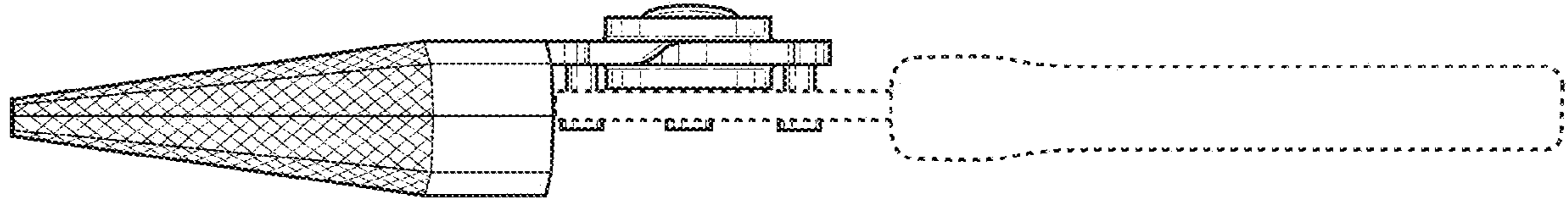

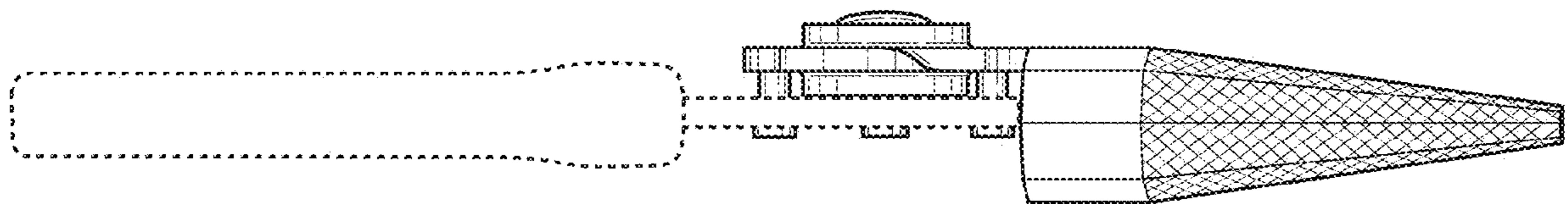

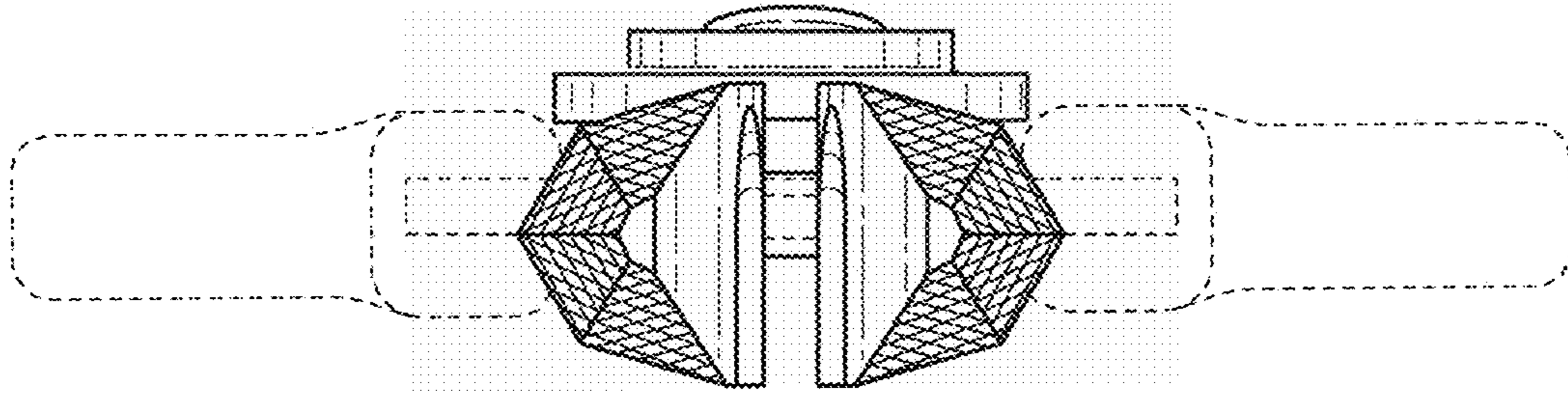

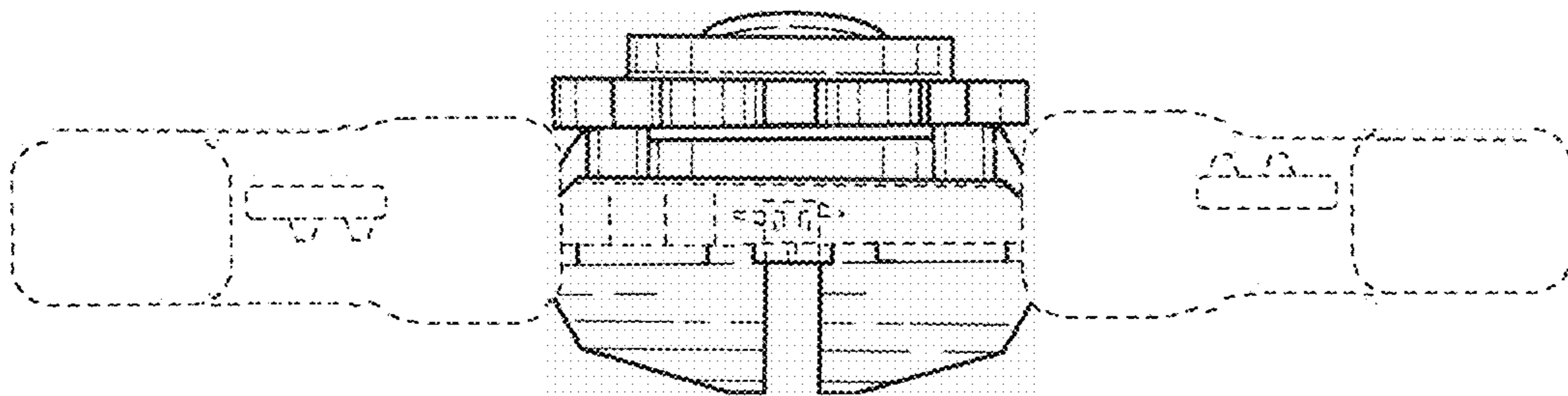
