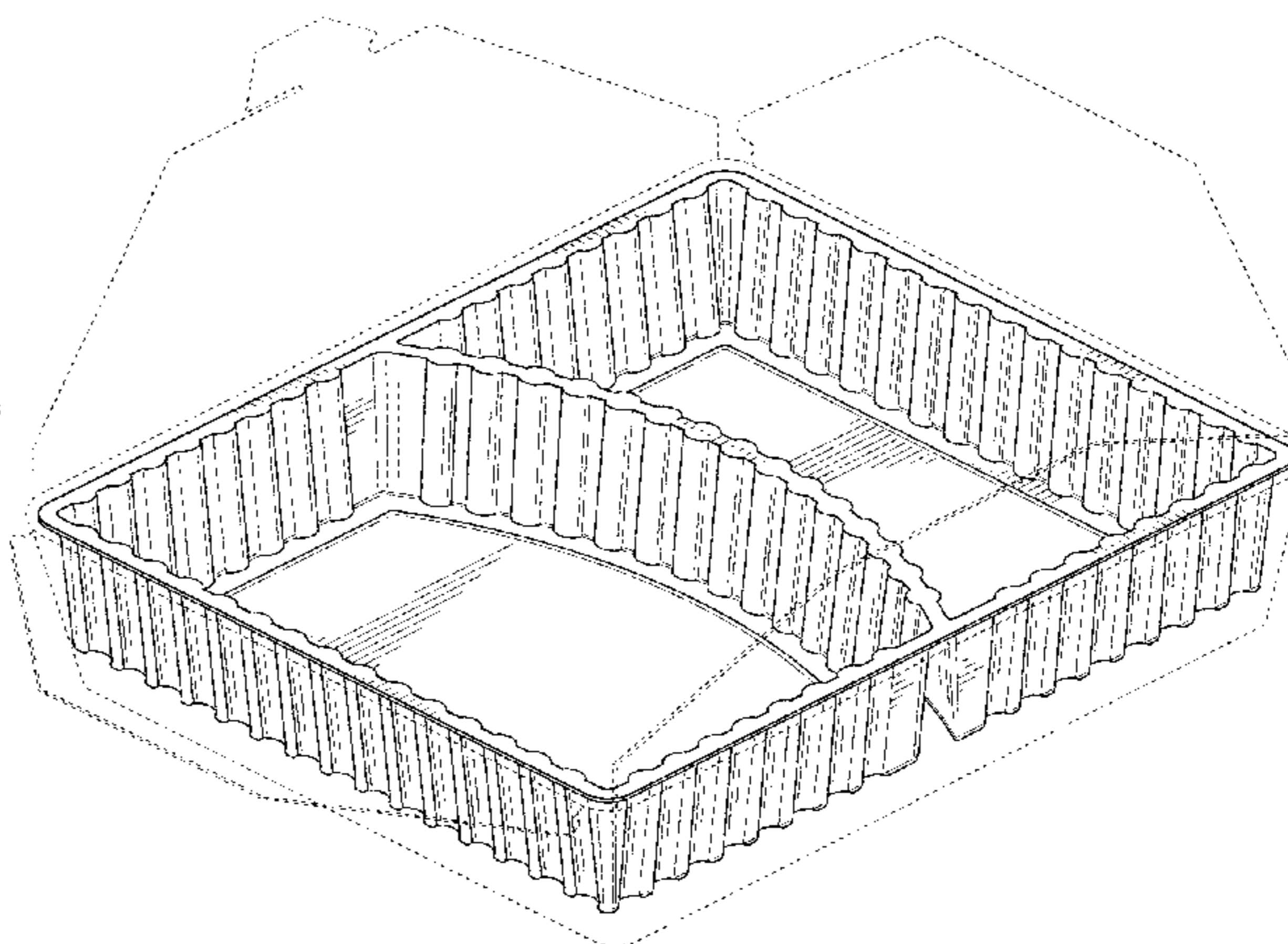
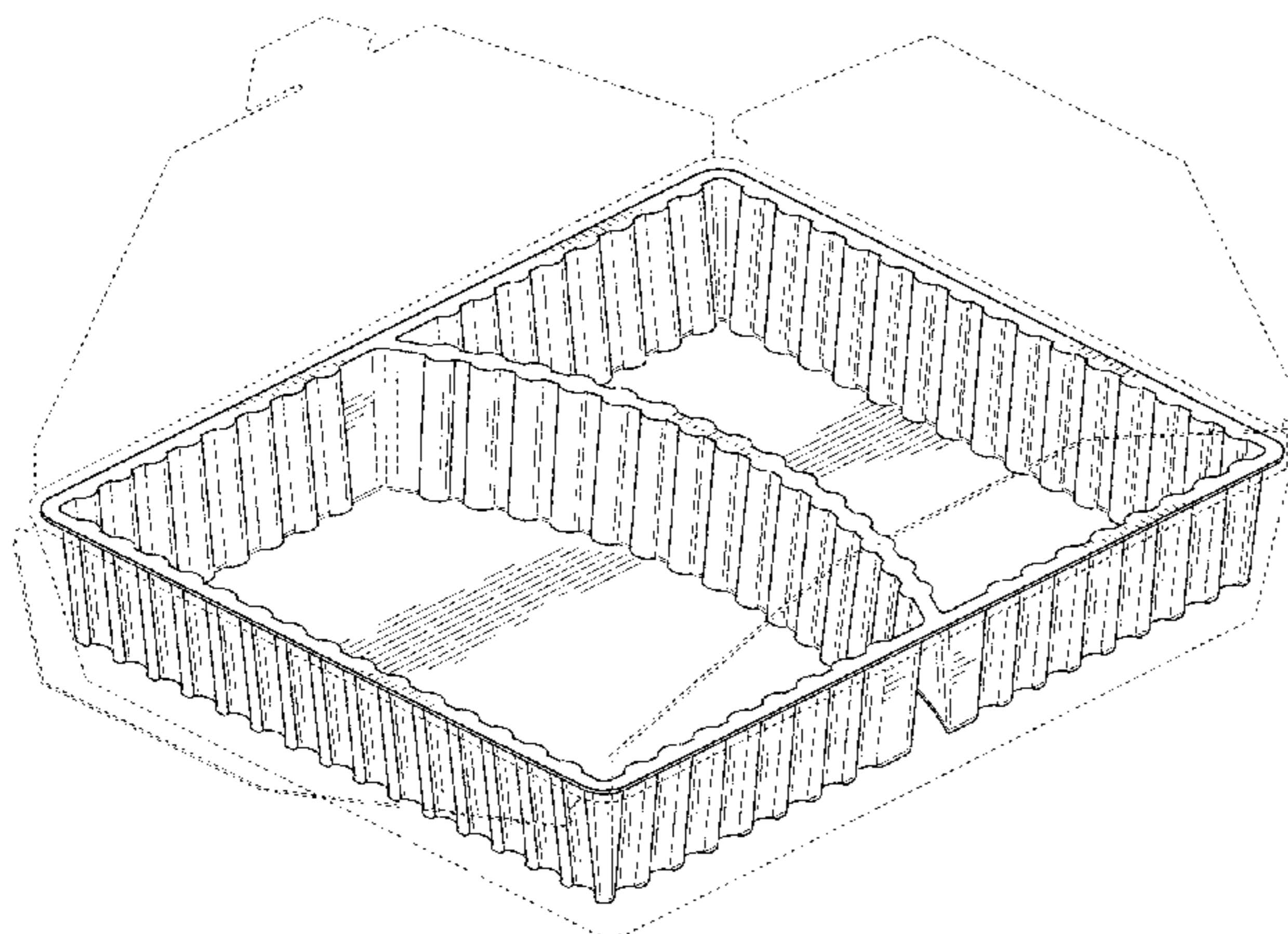

(57) **CLAIM**

The ornamental design for a compartmented carton insert, as shown and described.

**DESCRIPTION**

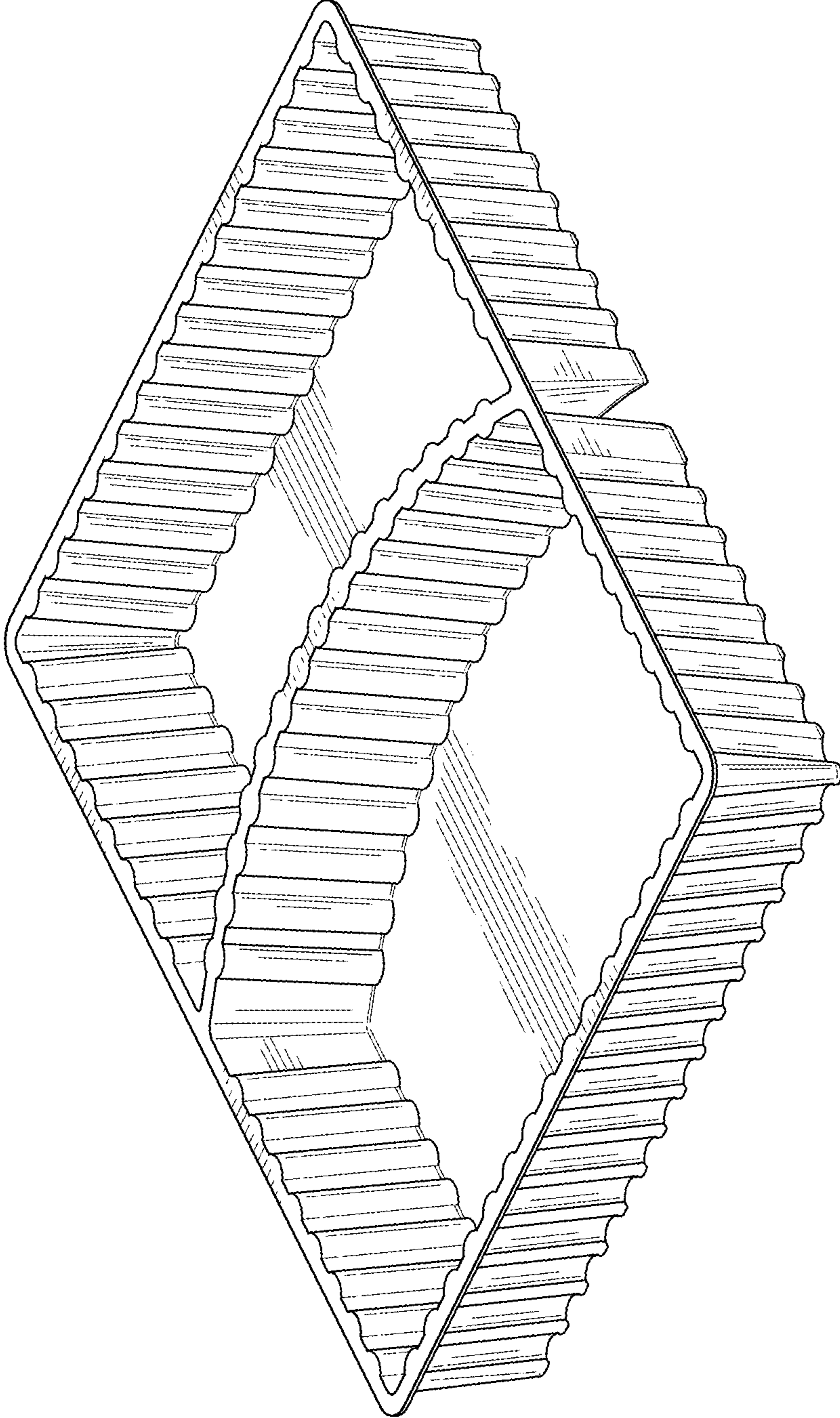

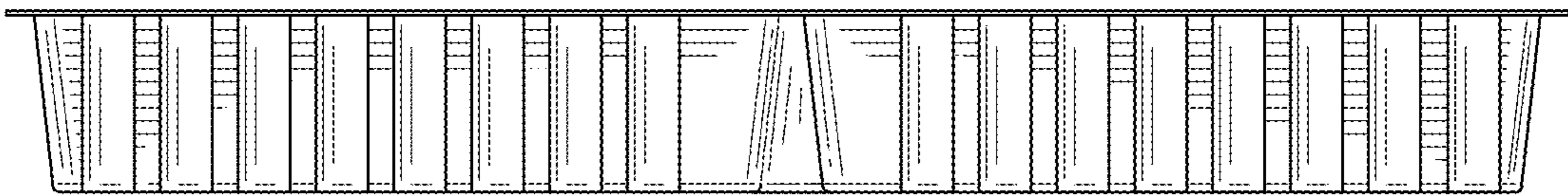

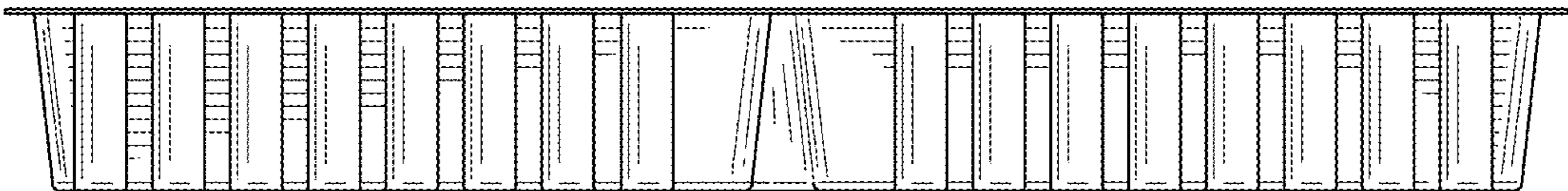

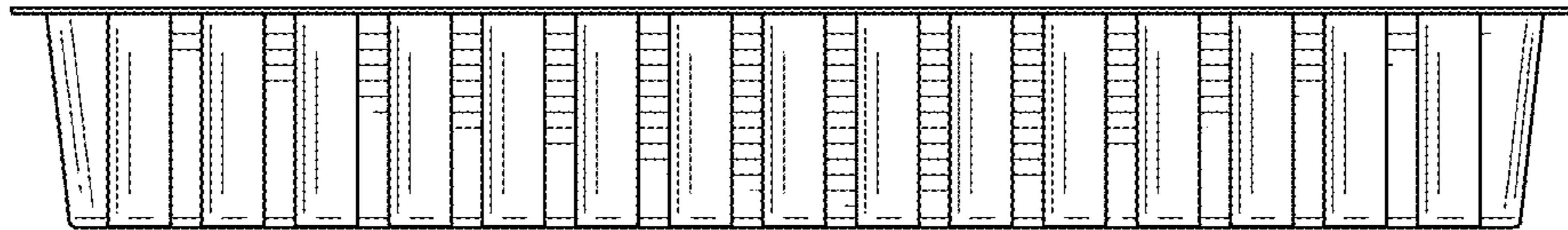

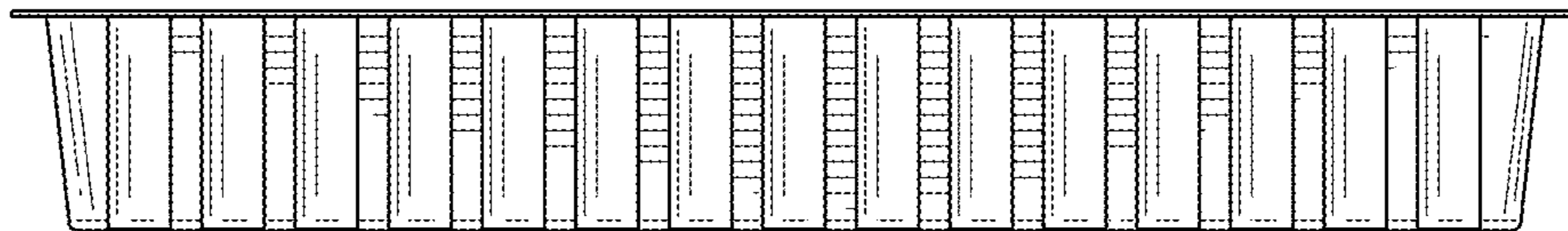

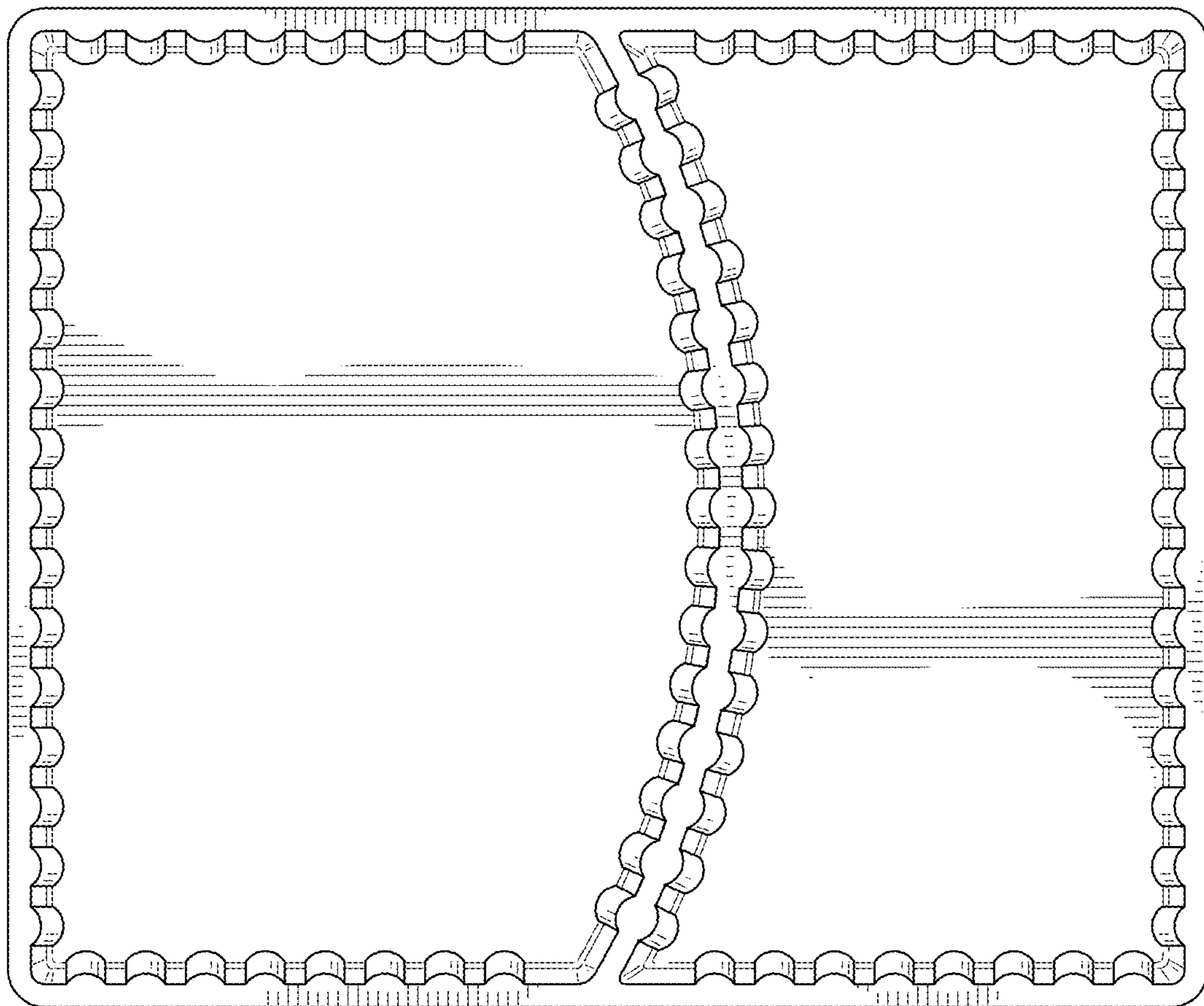

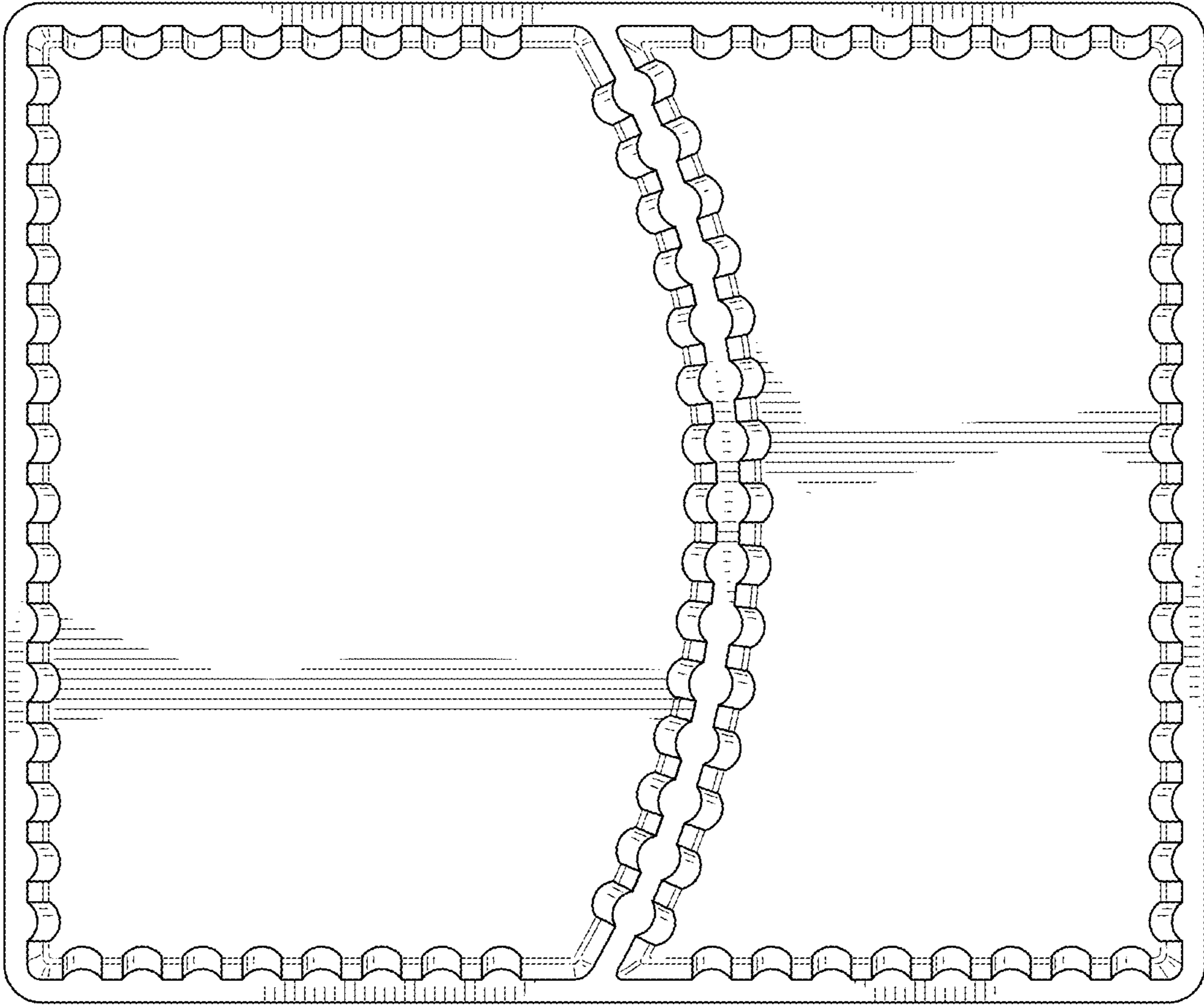

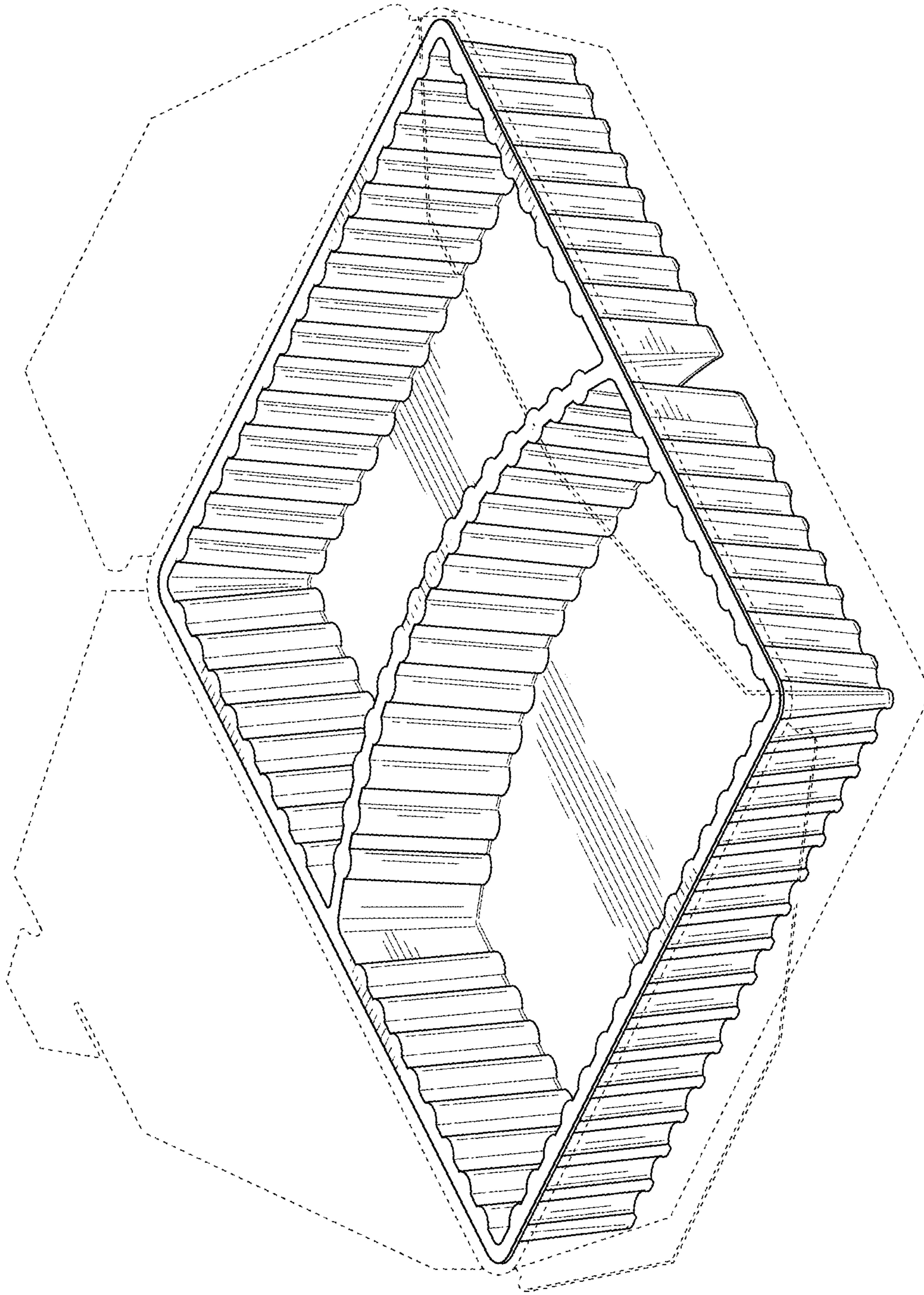

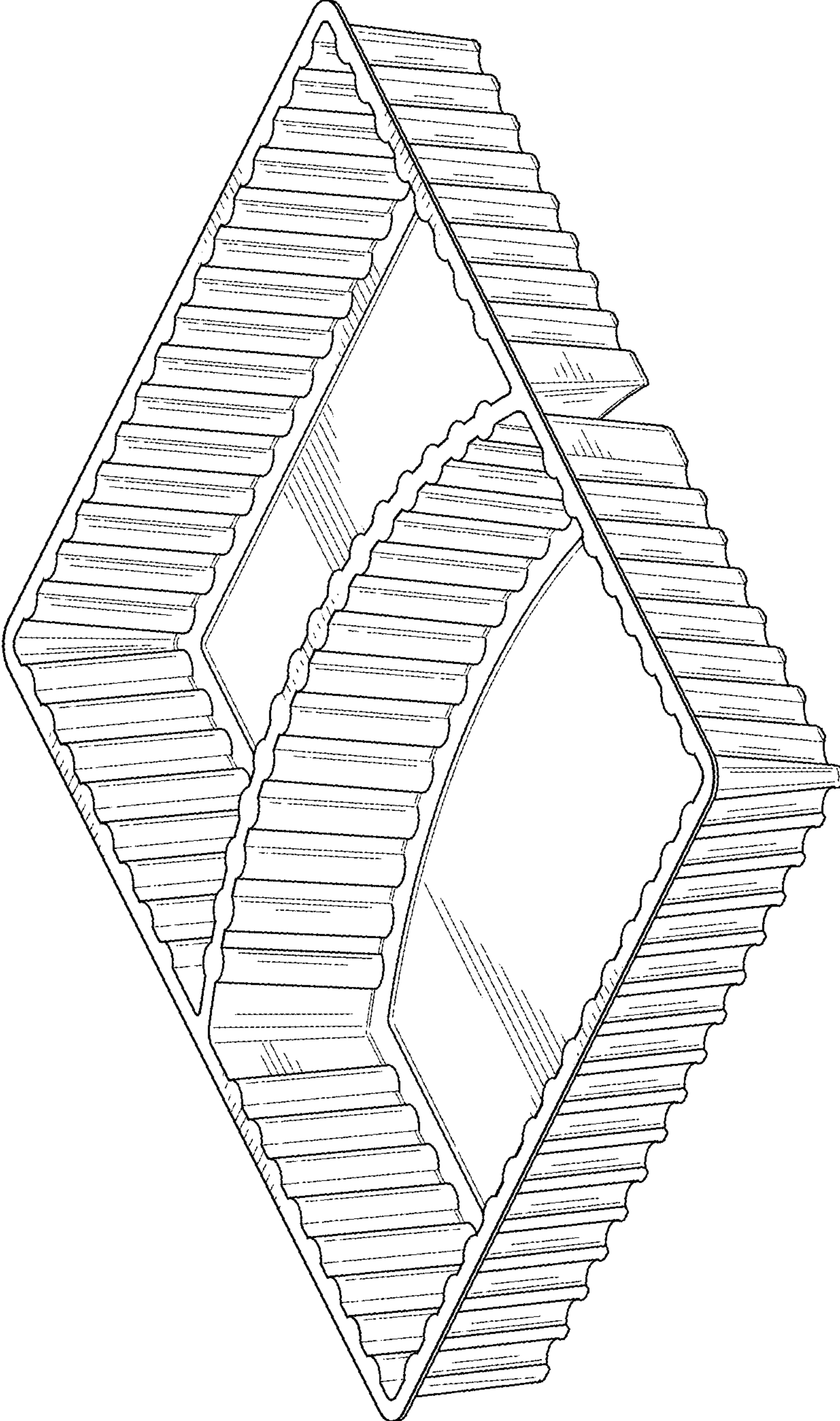

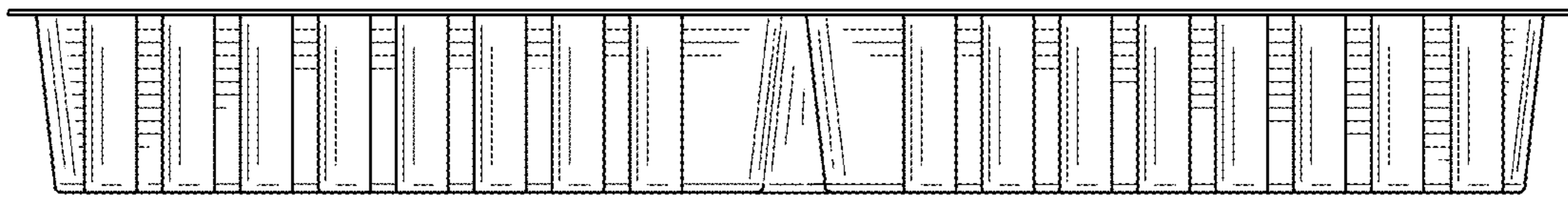

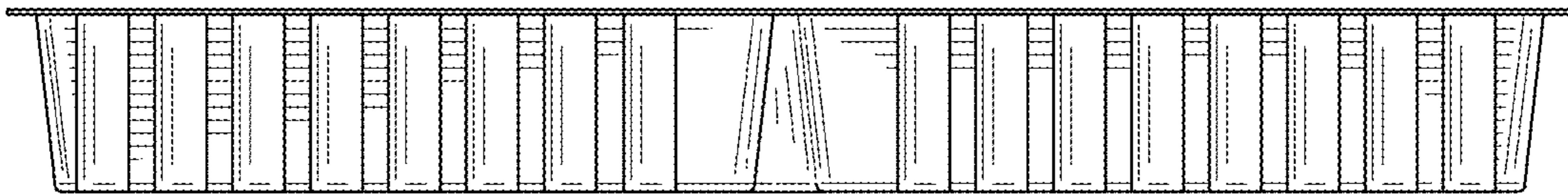

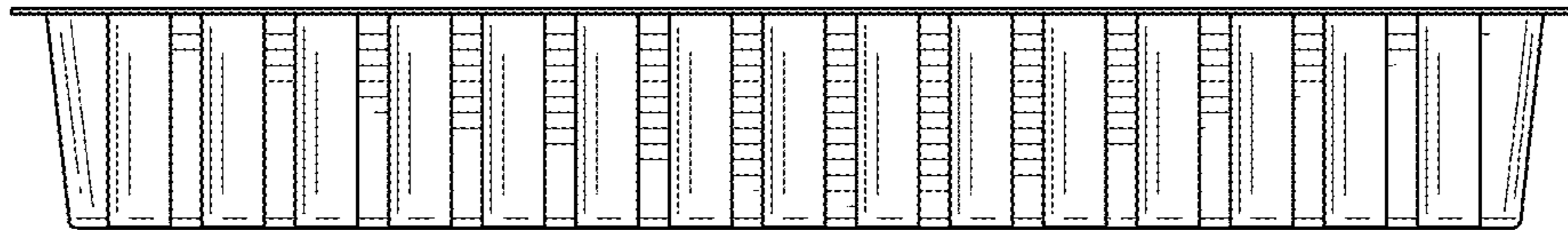

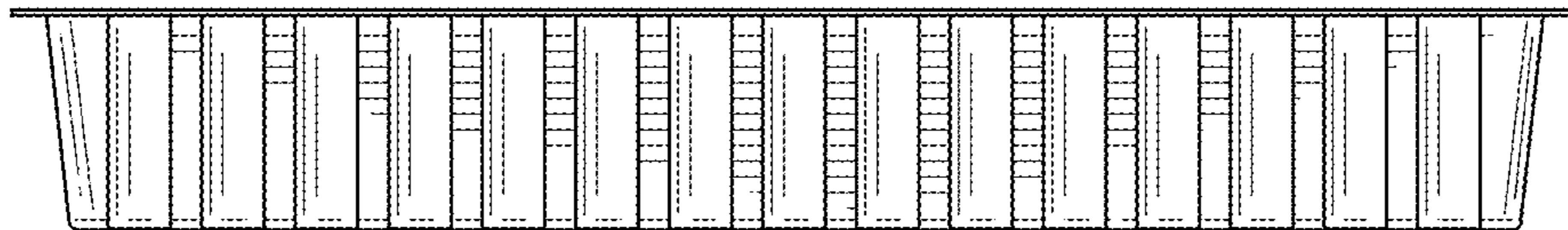

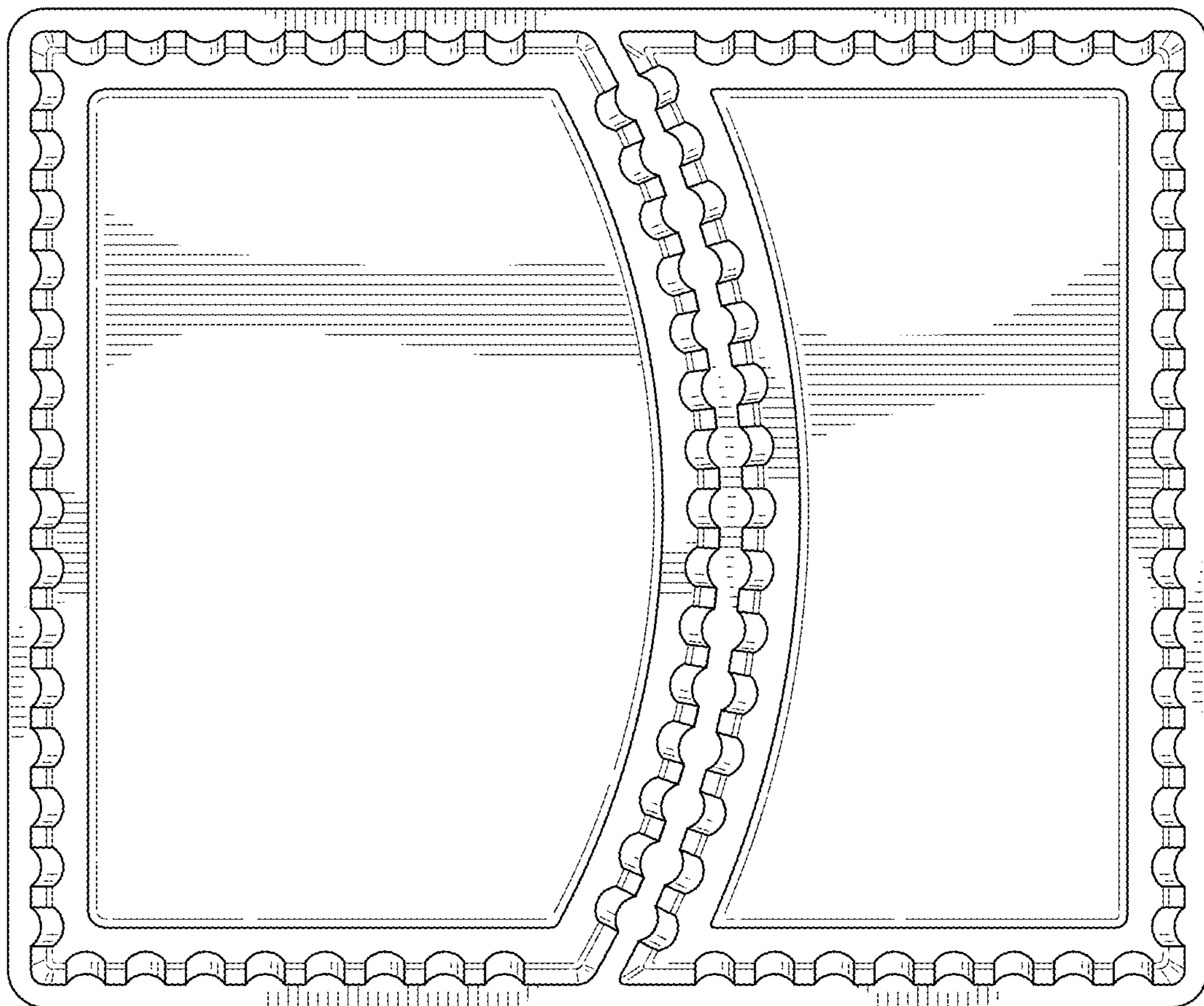

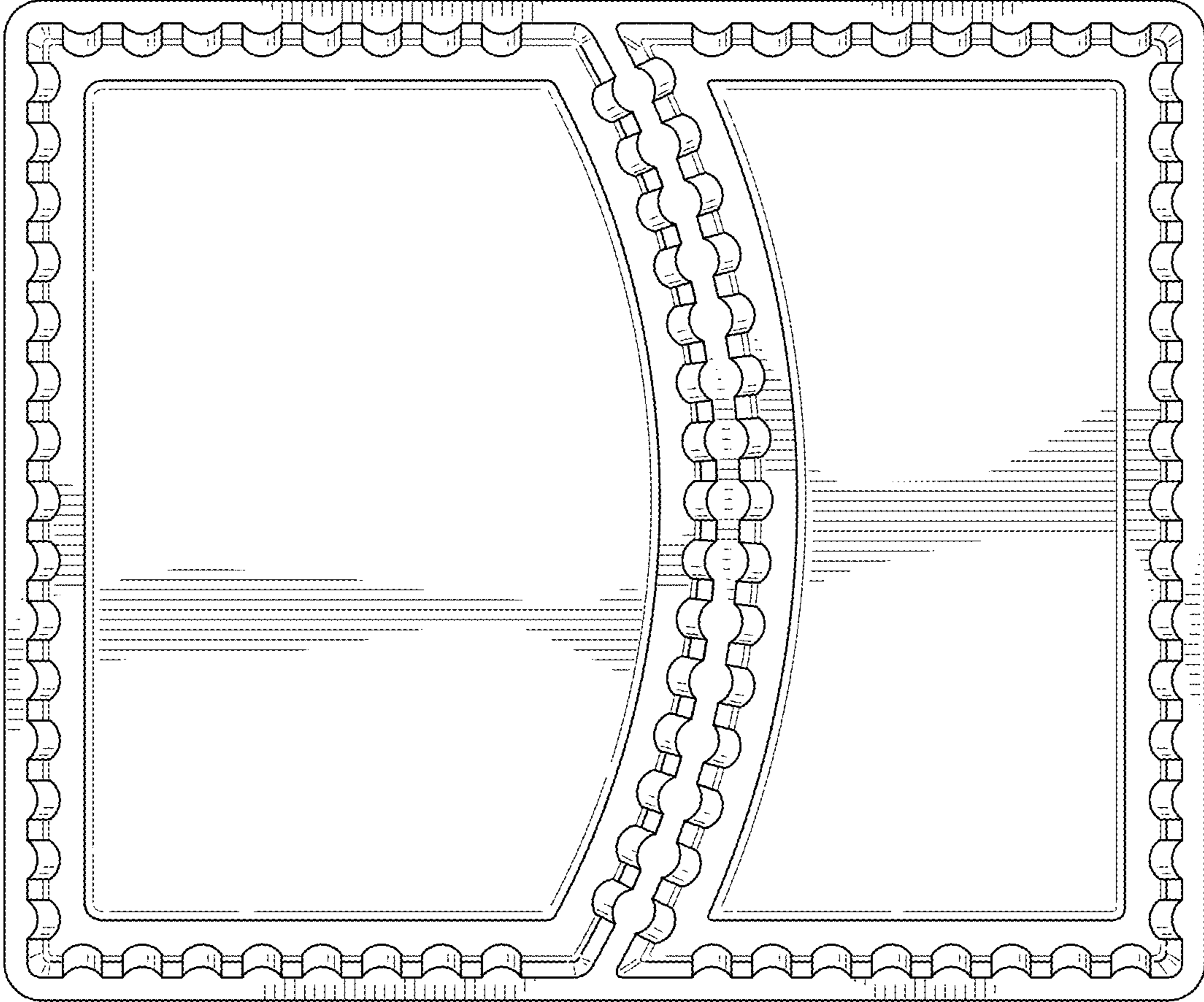

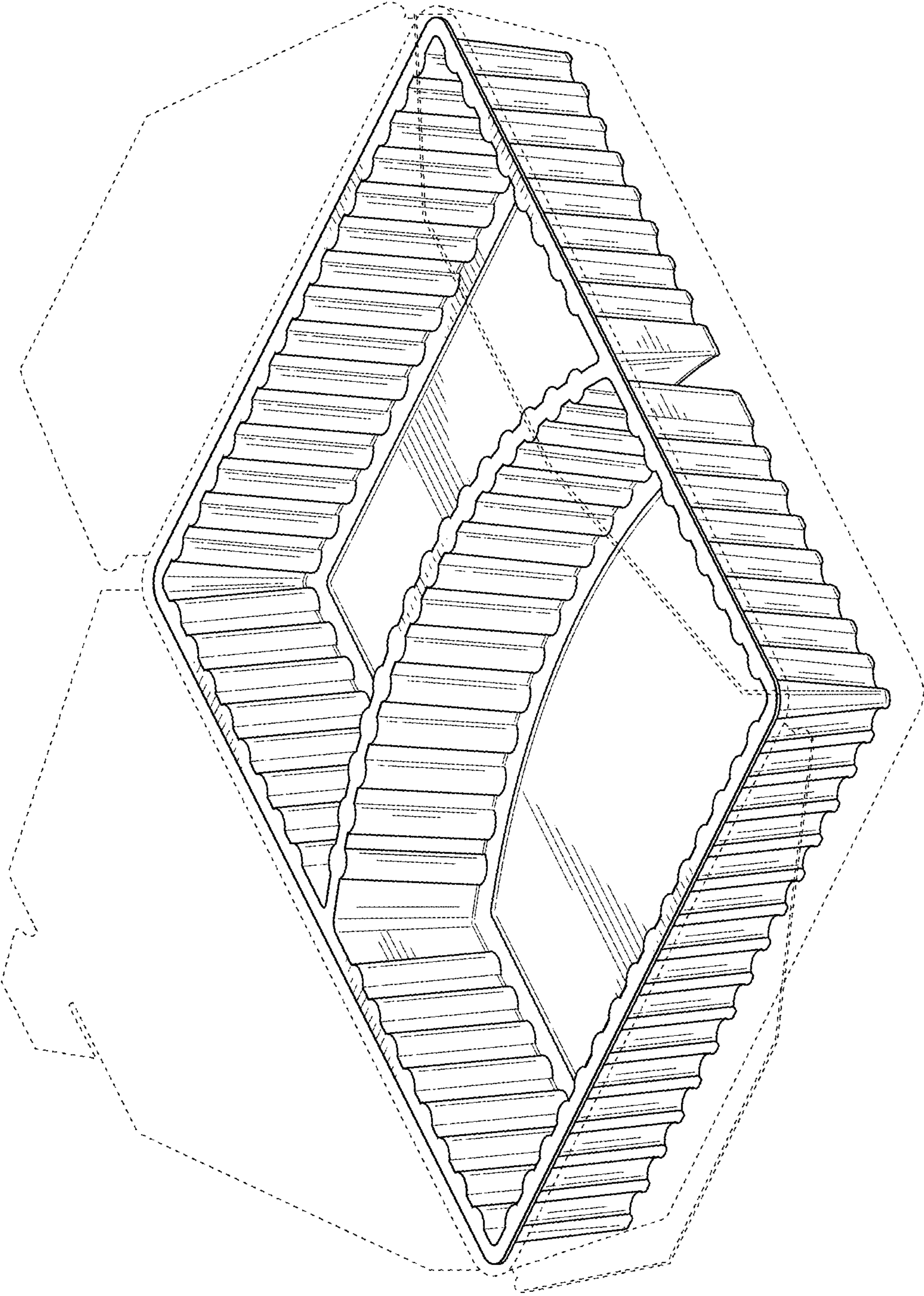

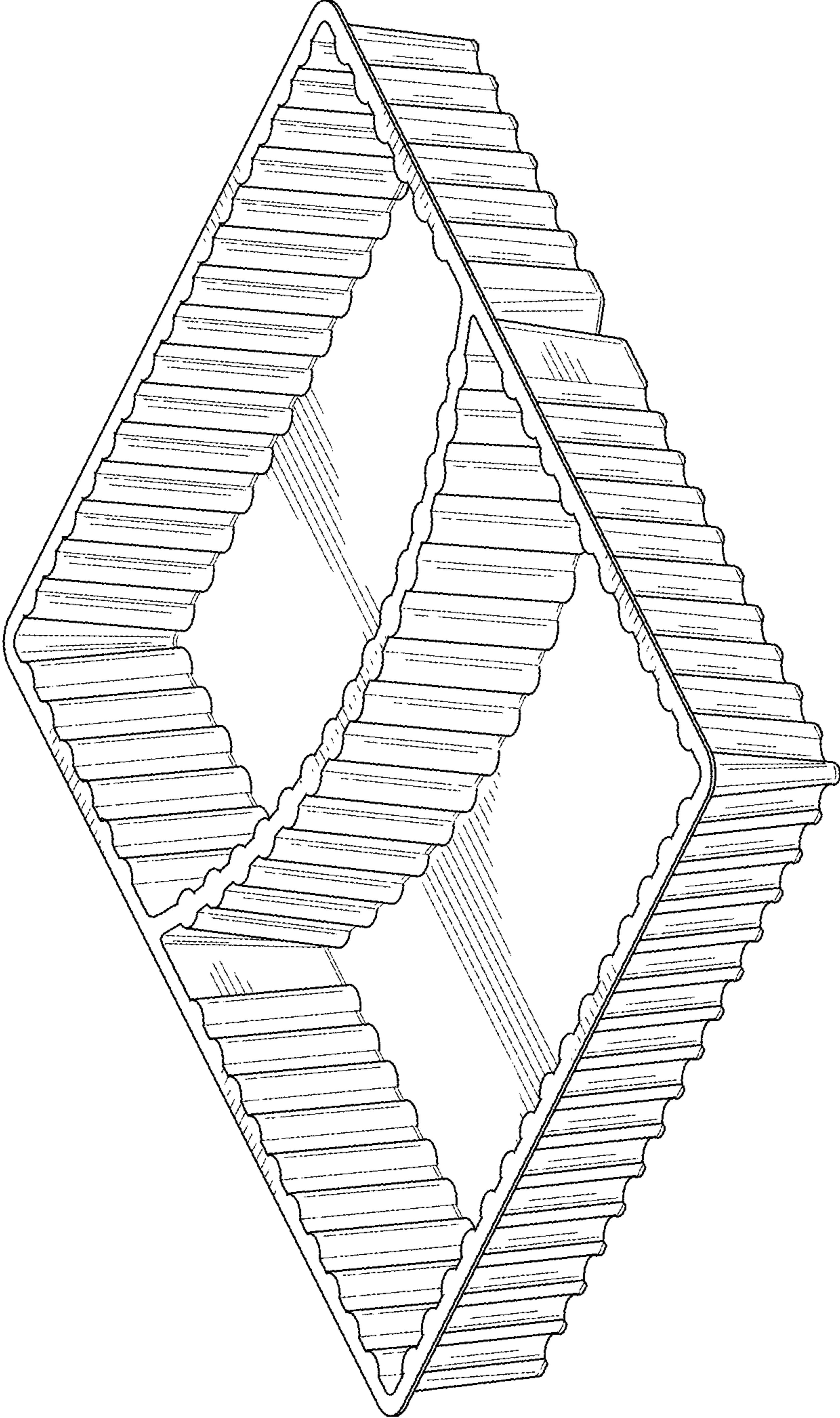

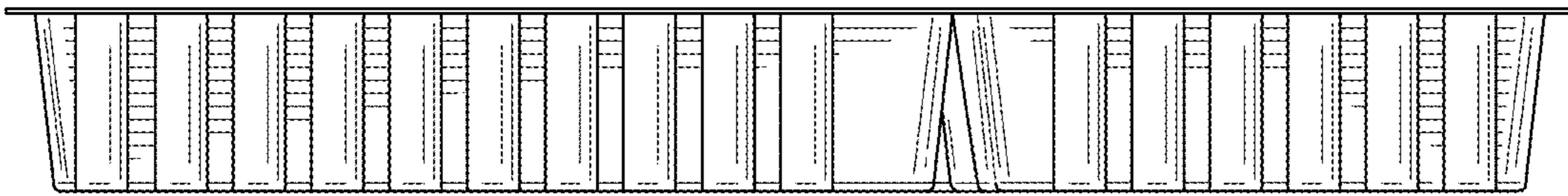

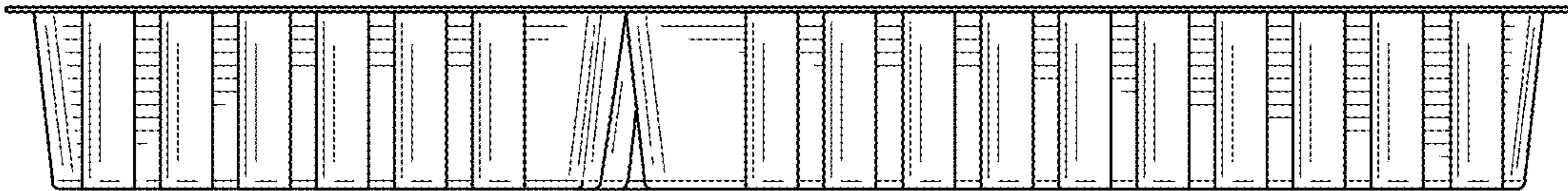

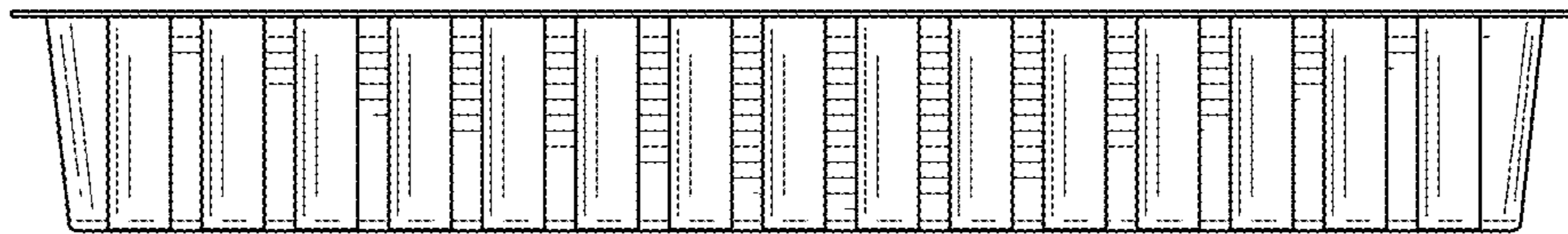

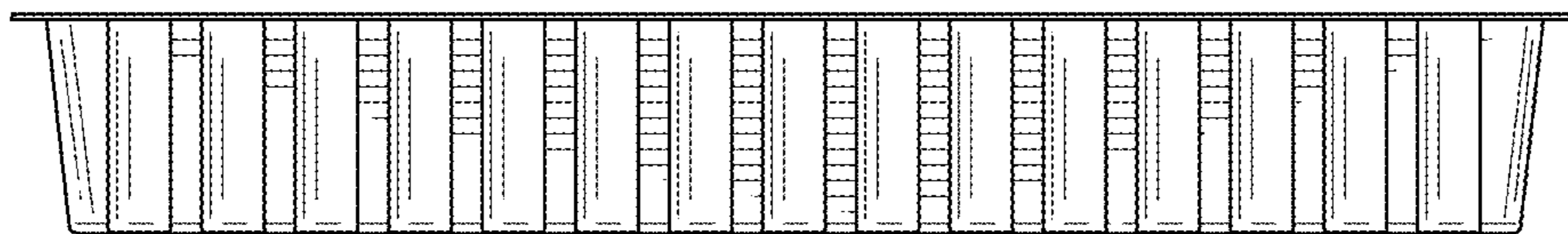

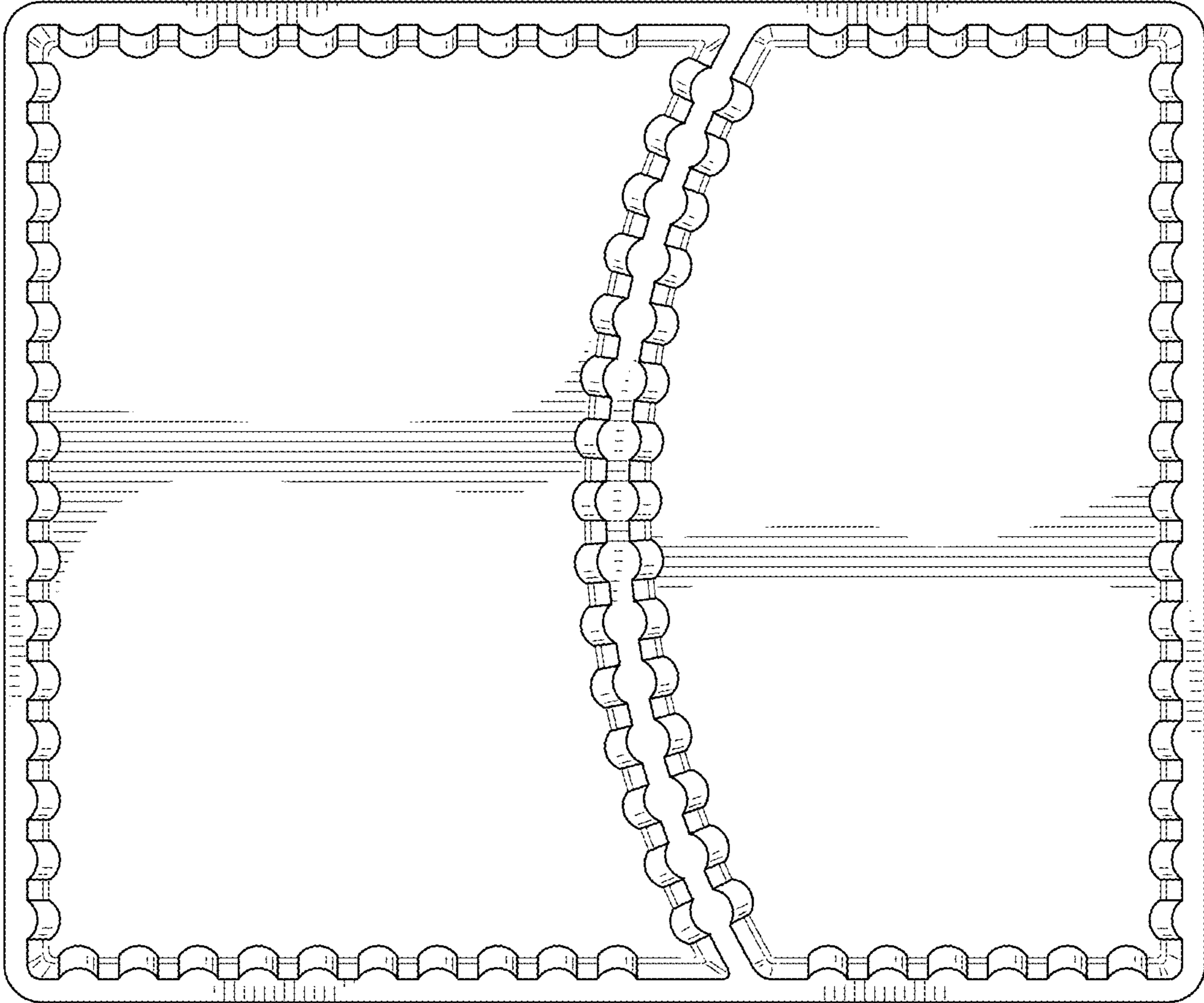

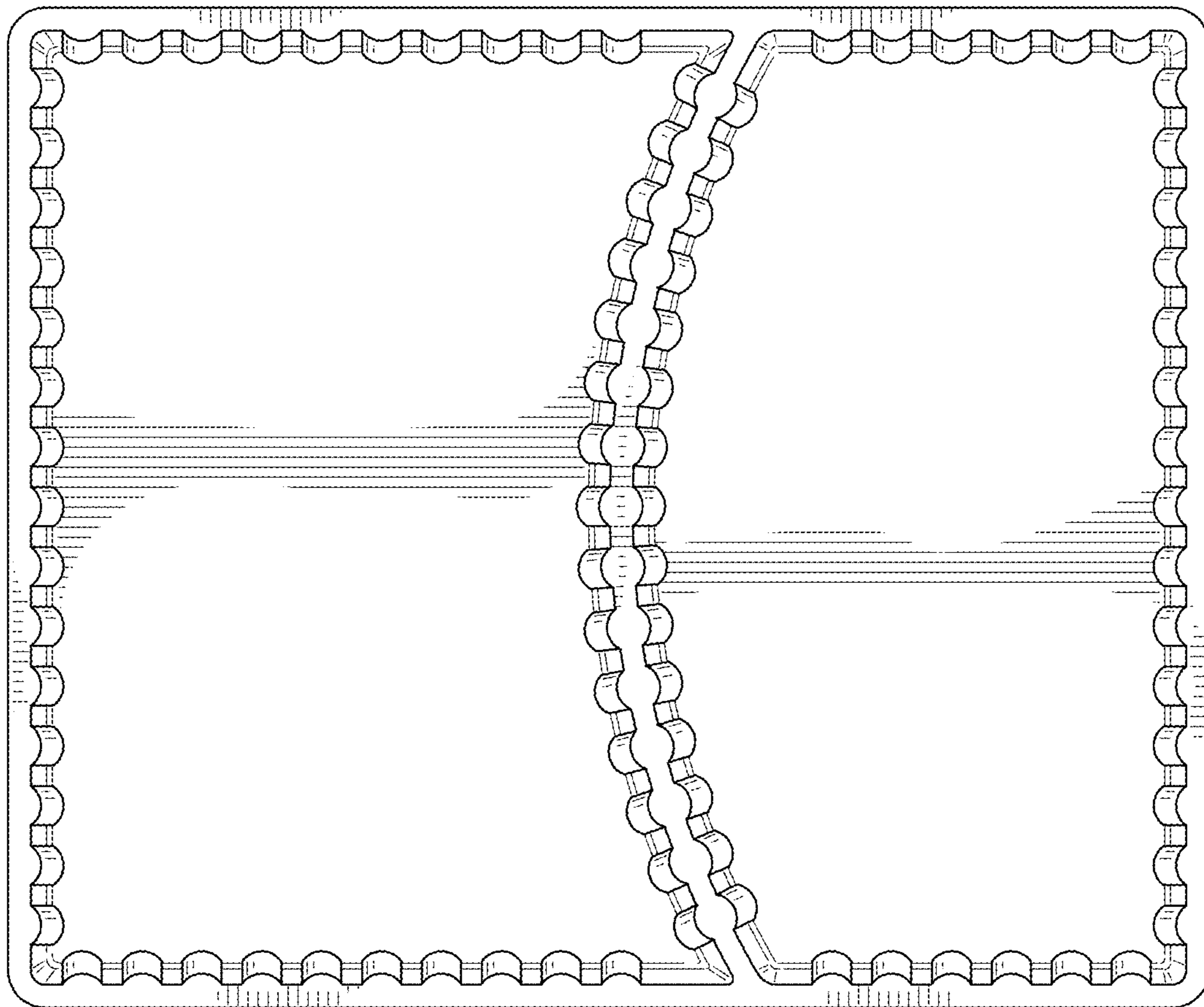

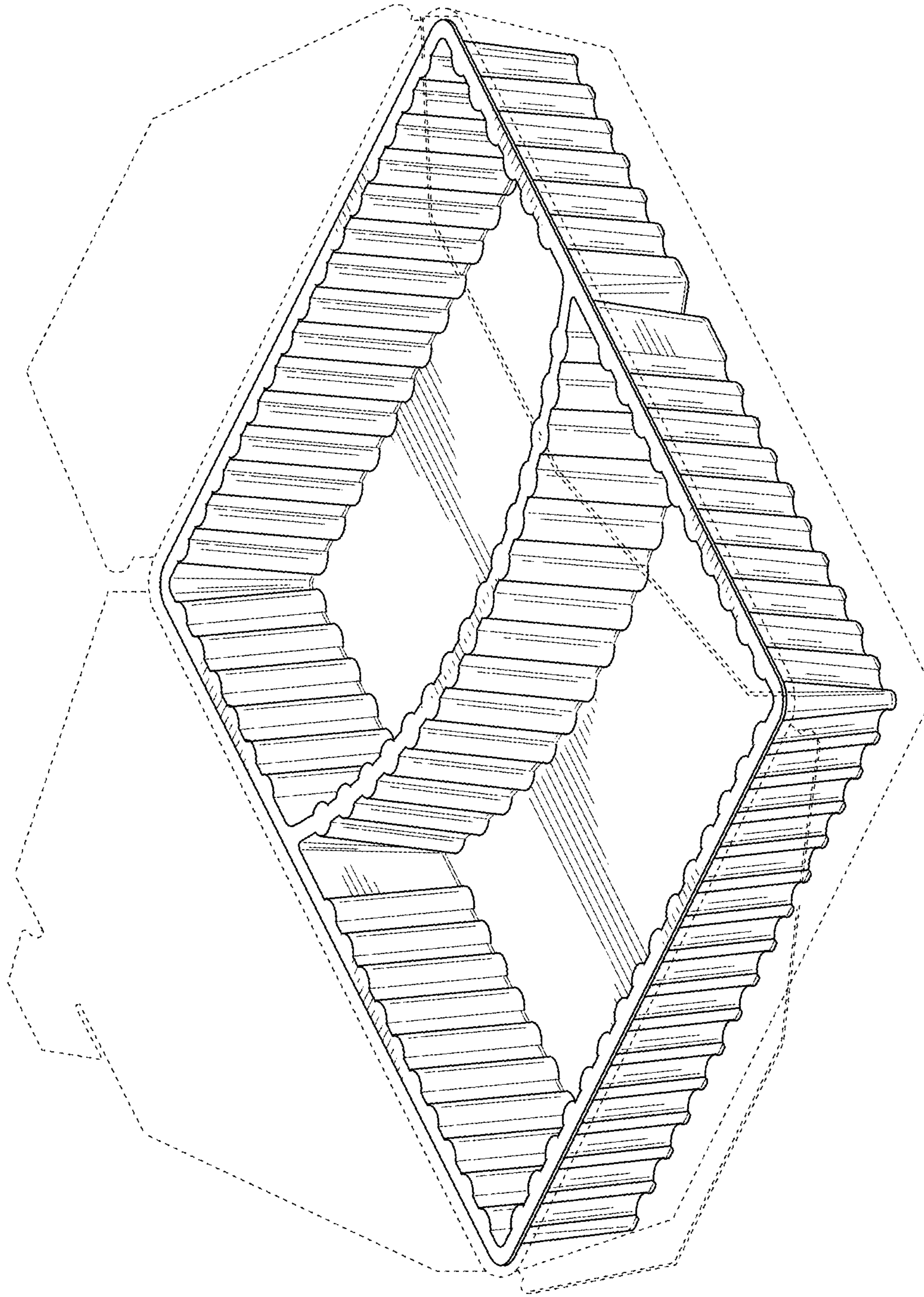

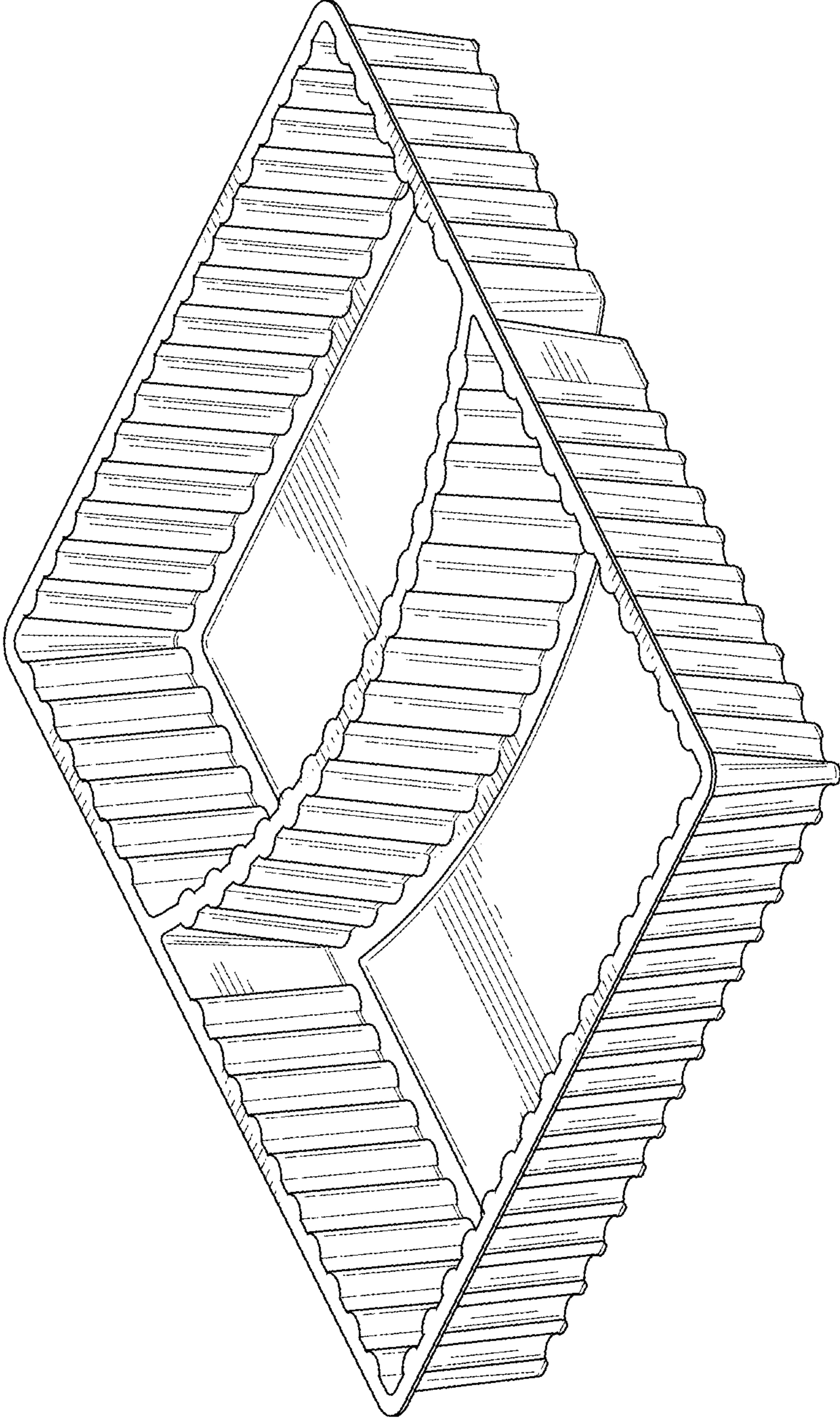

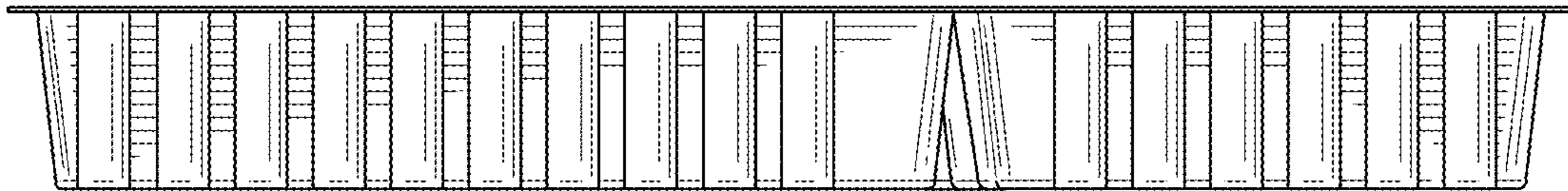

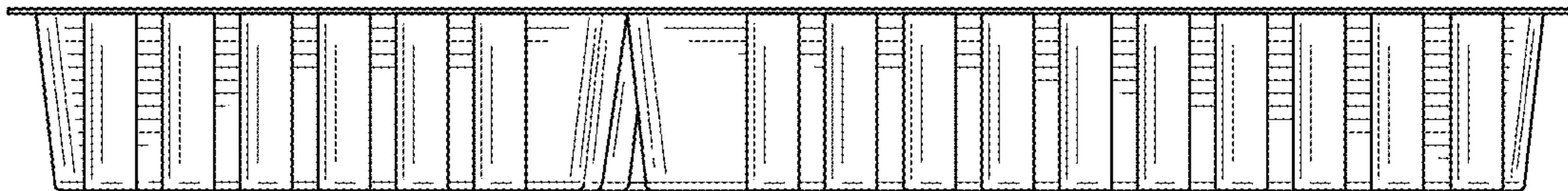

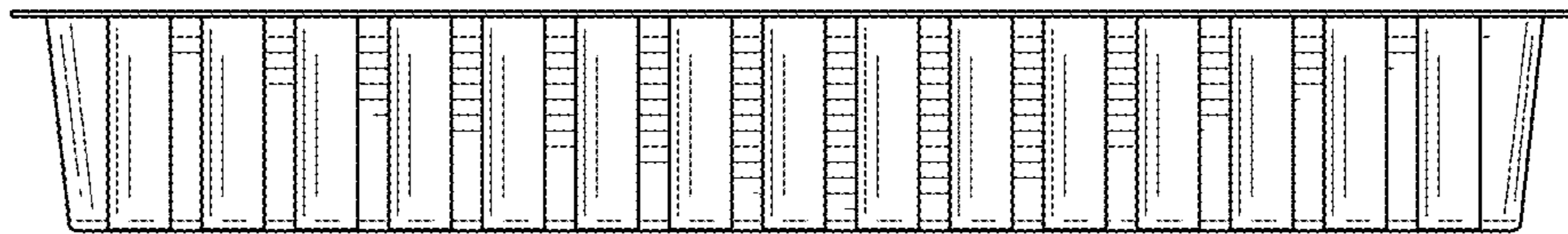

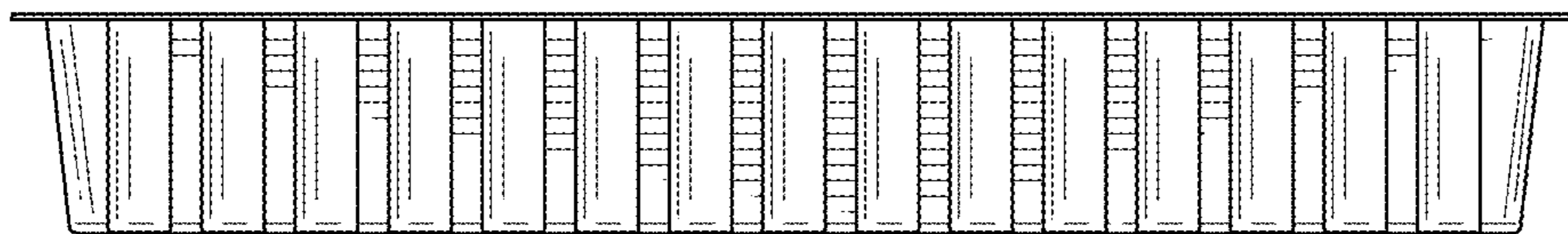

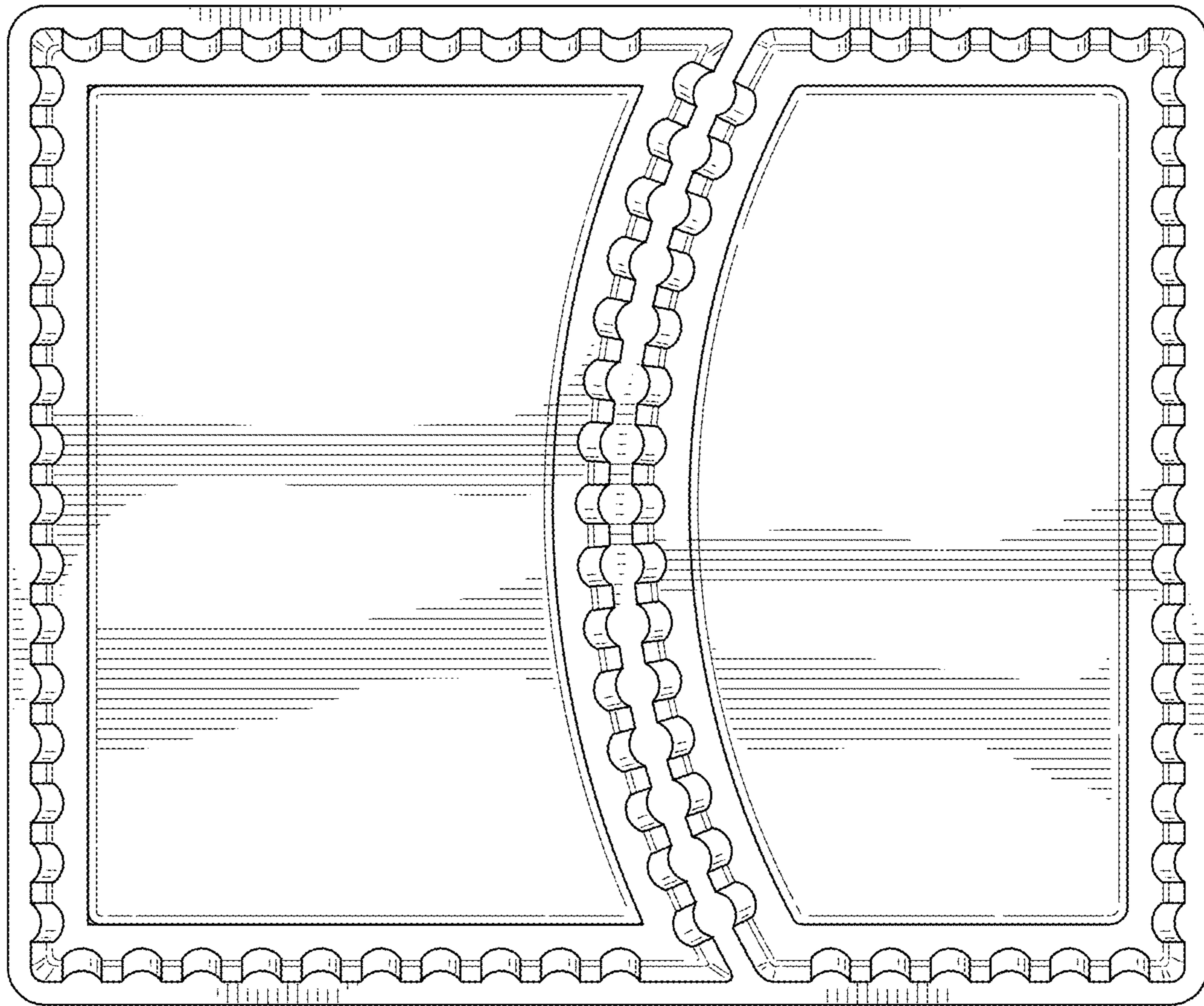

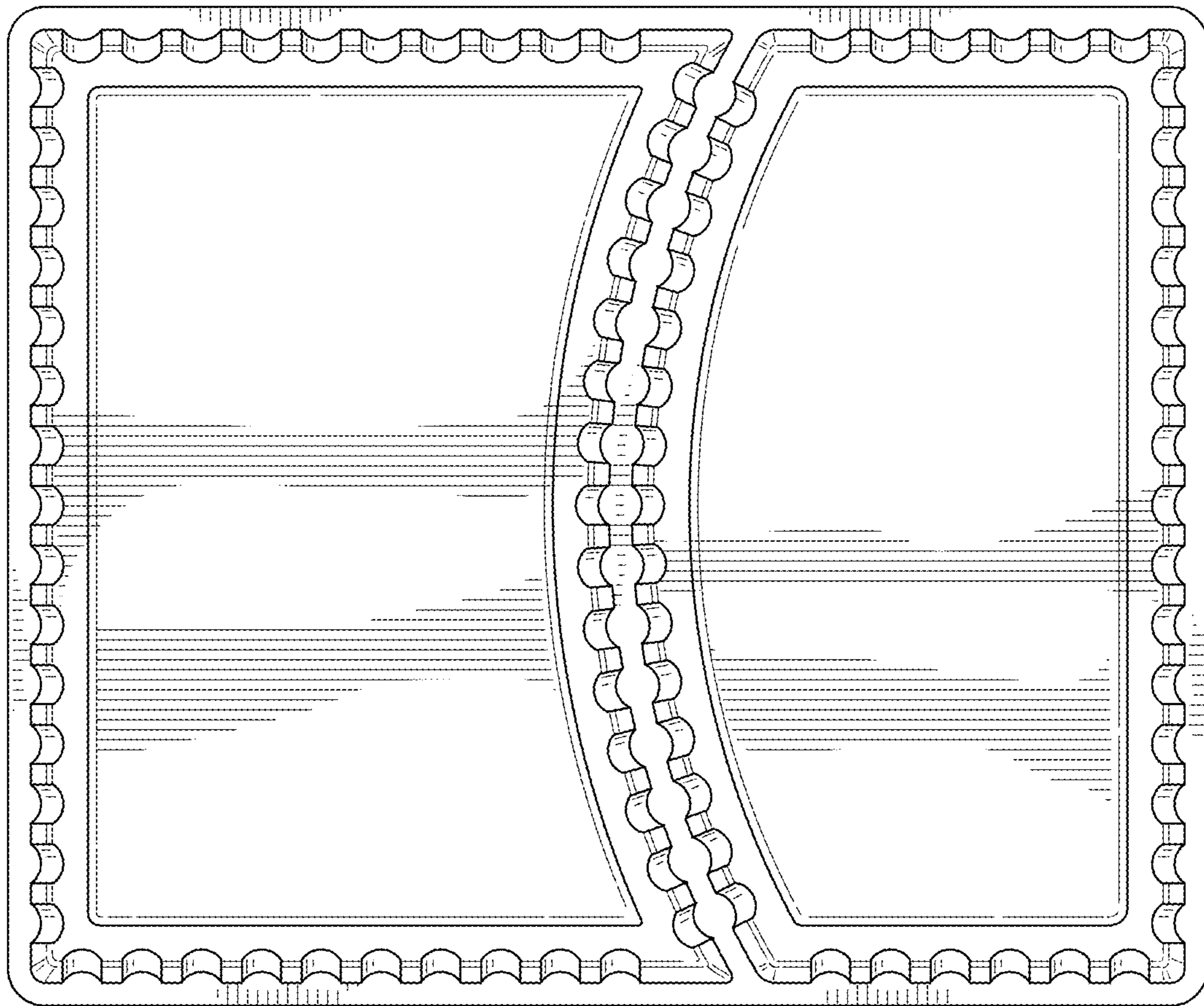

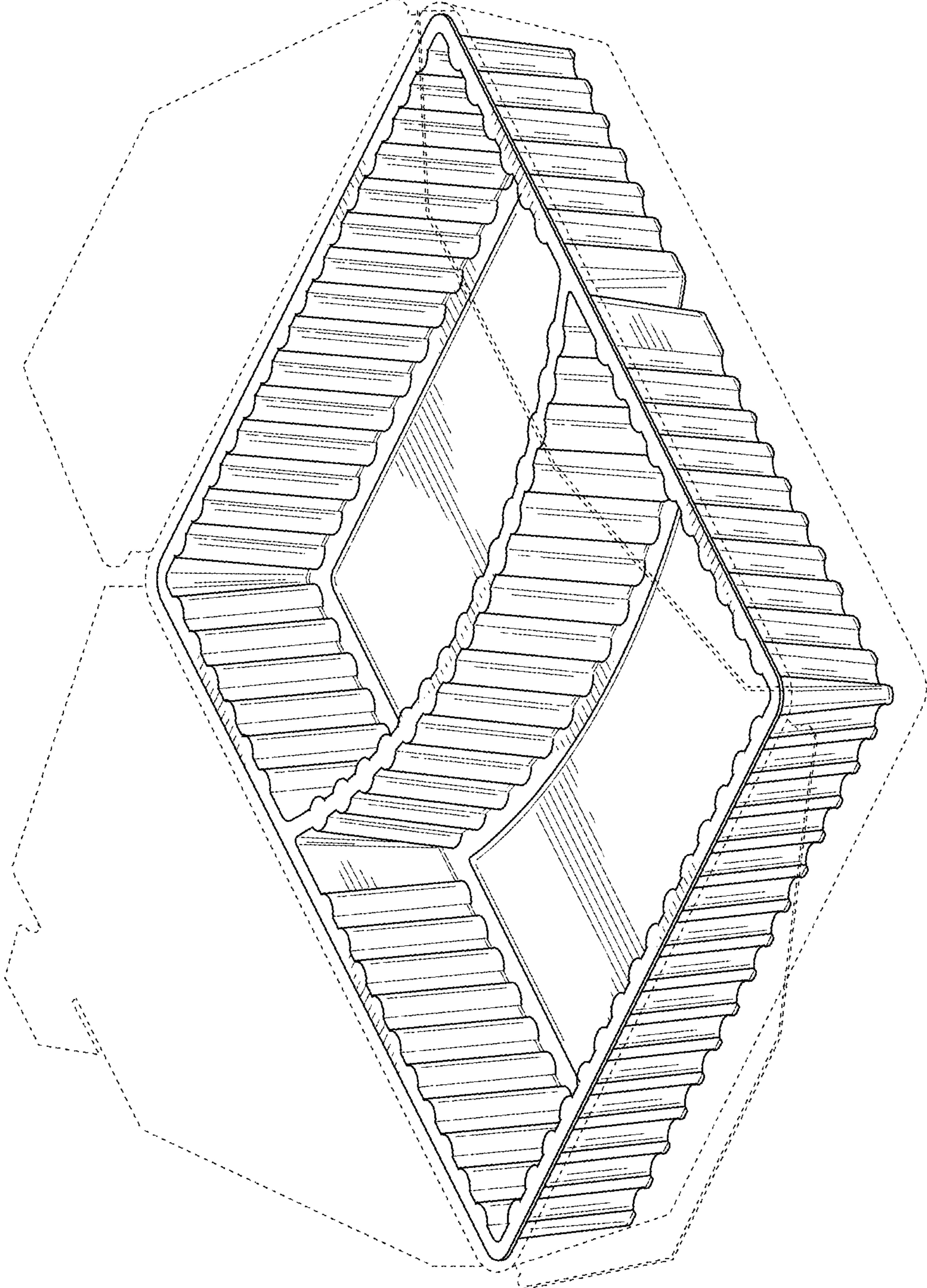
