(57) **CLAIM**

The ornamental design for a packaging tray, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a packaging tray showing our new design;

FIG. 4 is a left side view thereof;

FIG. 5 is a front view thereof;

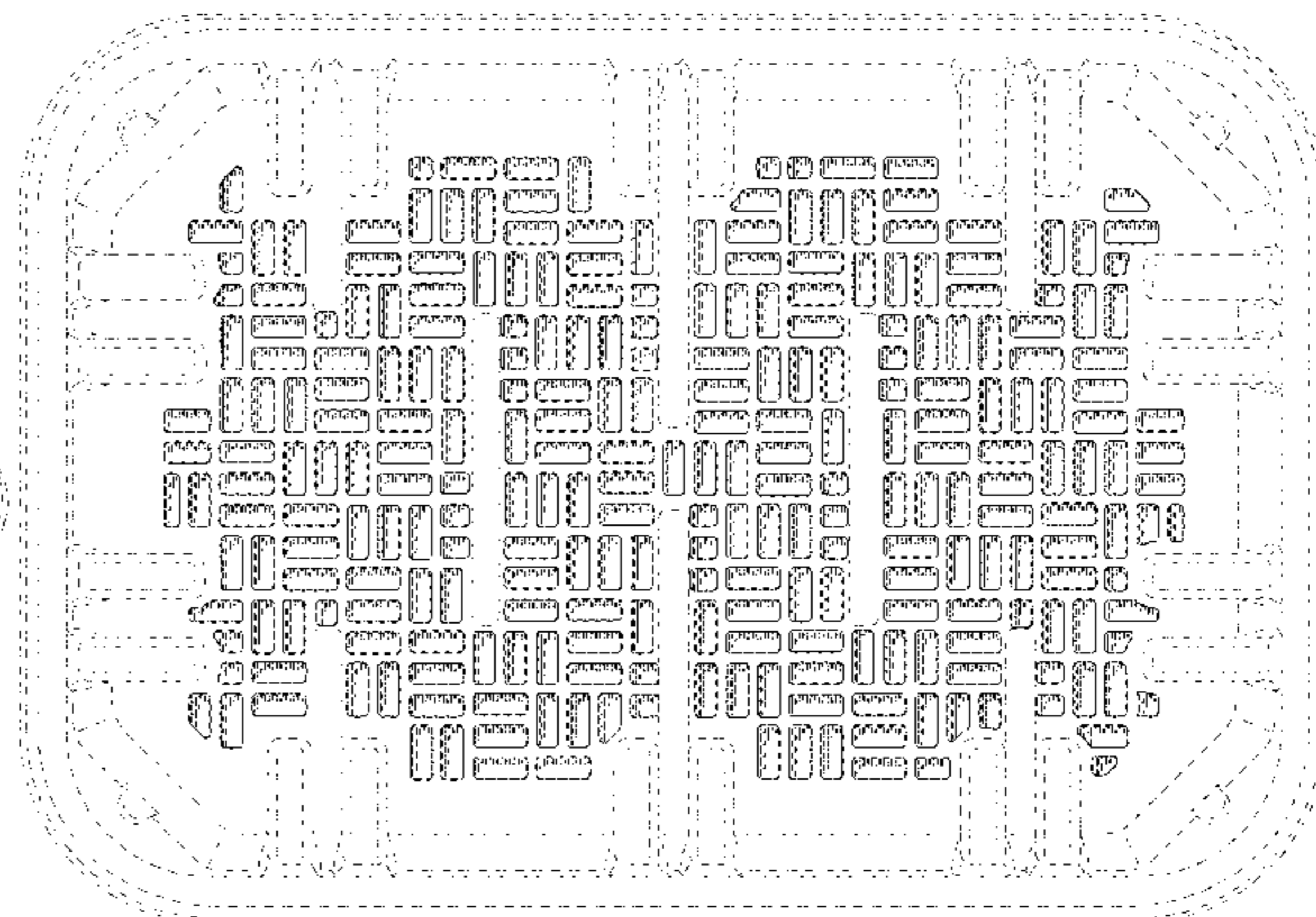
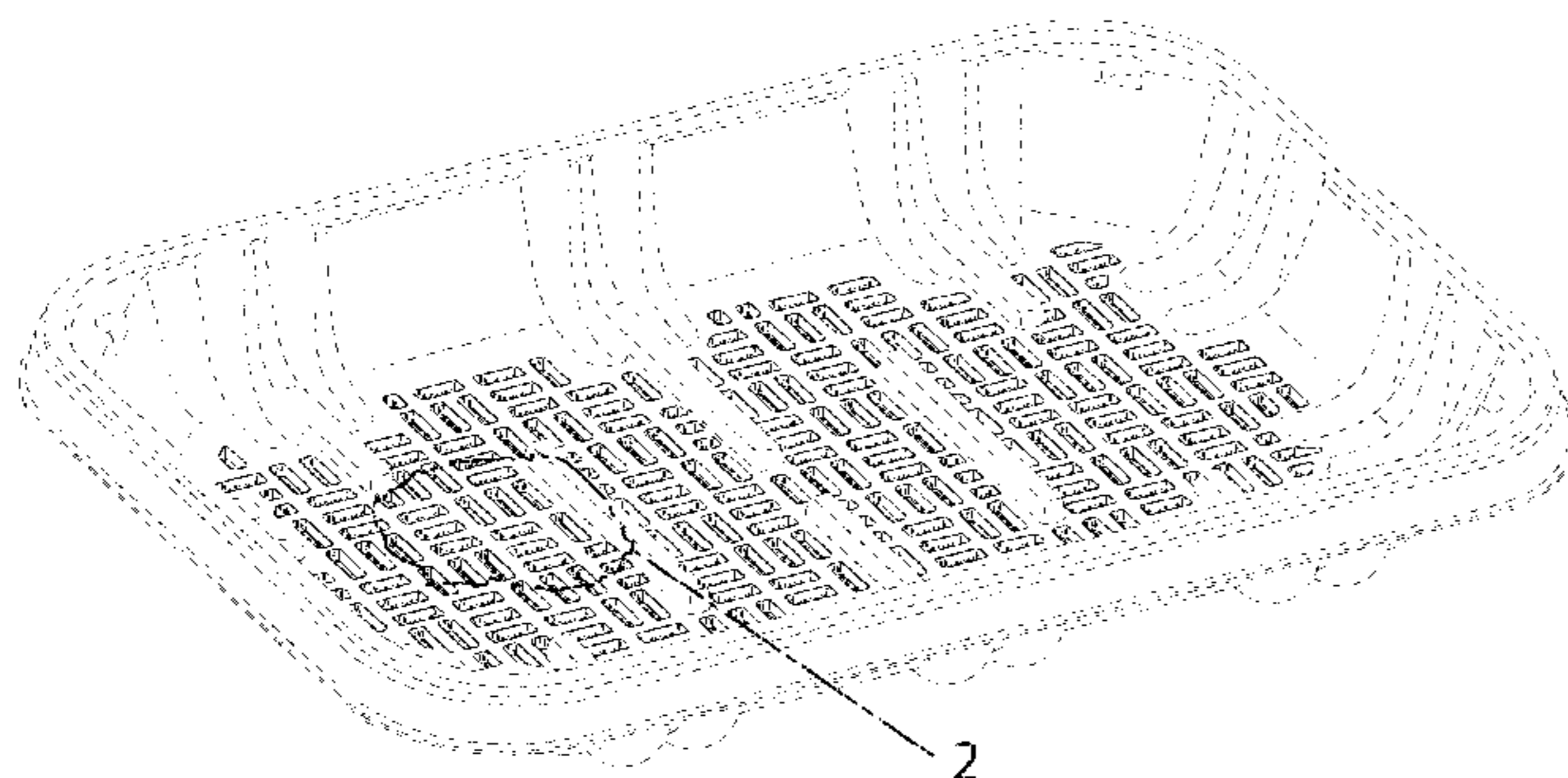
FIG. 6 is a rear view thereof;

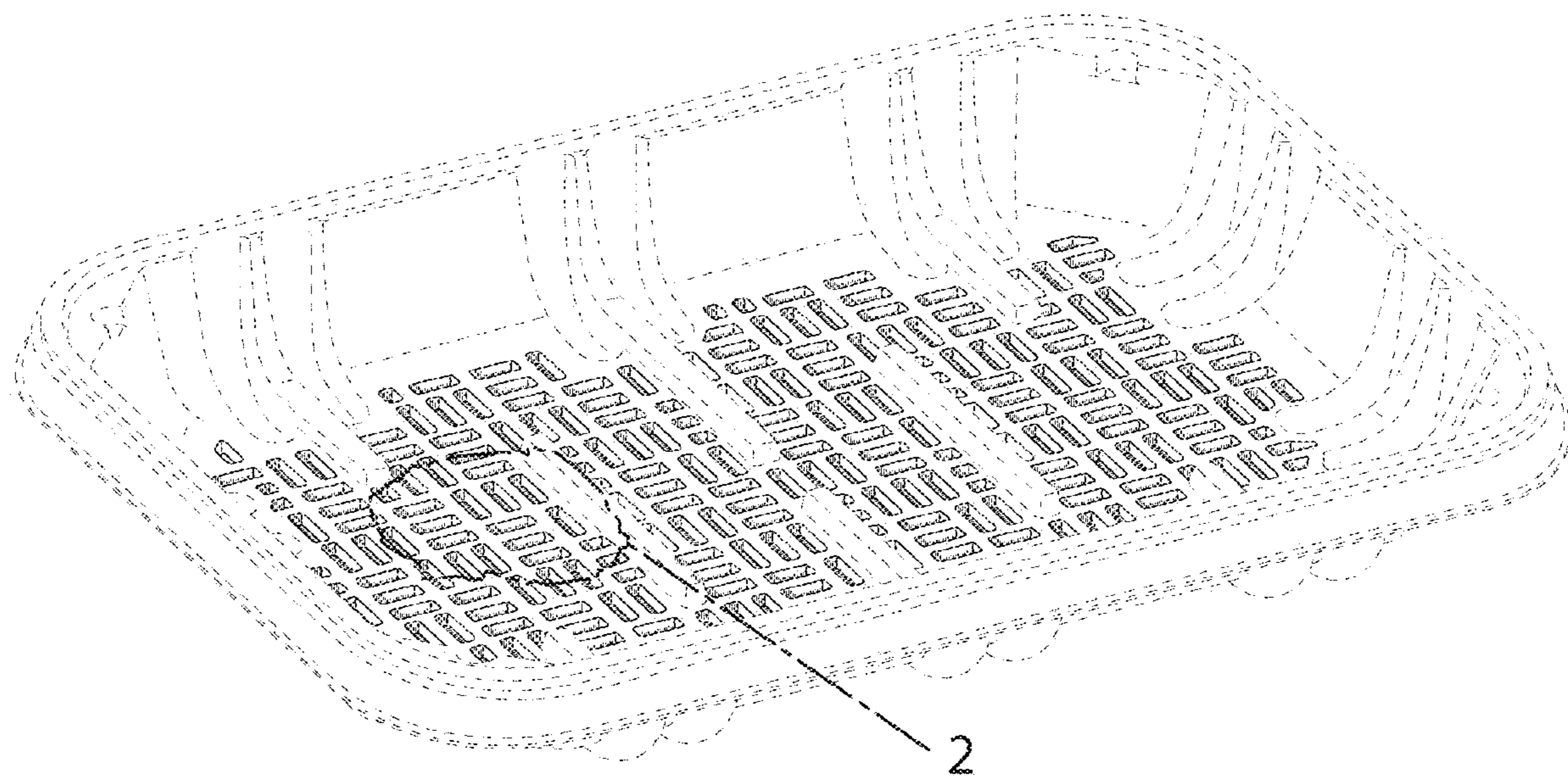

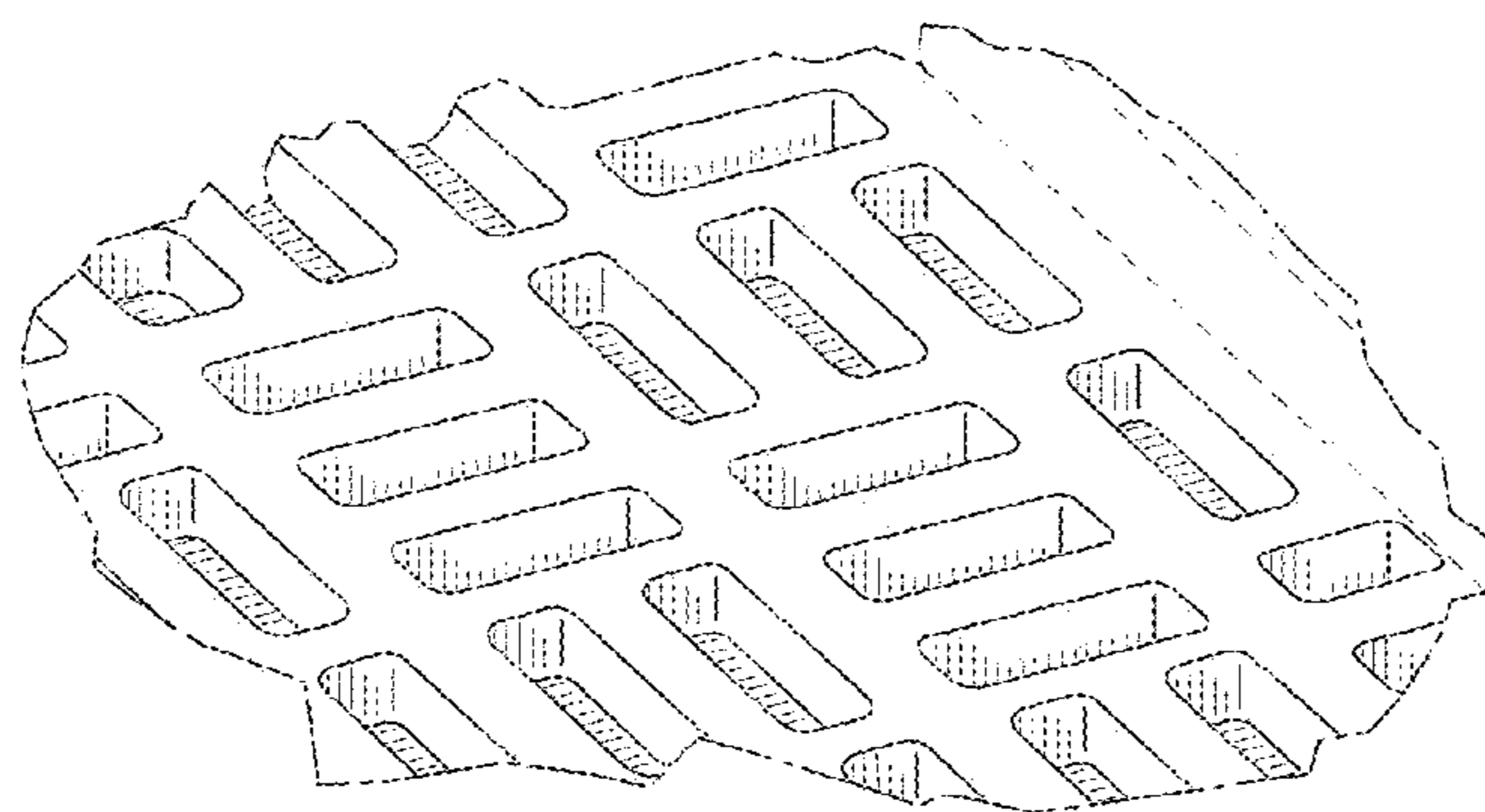

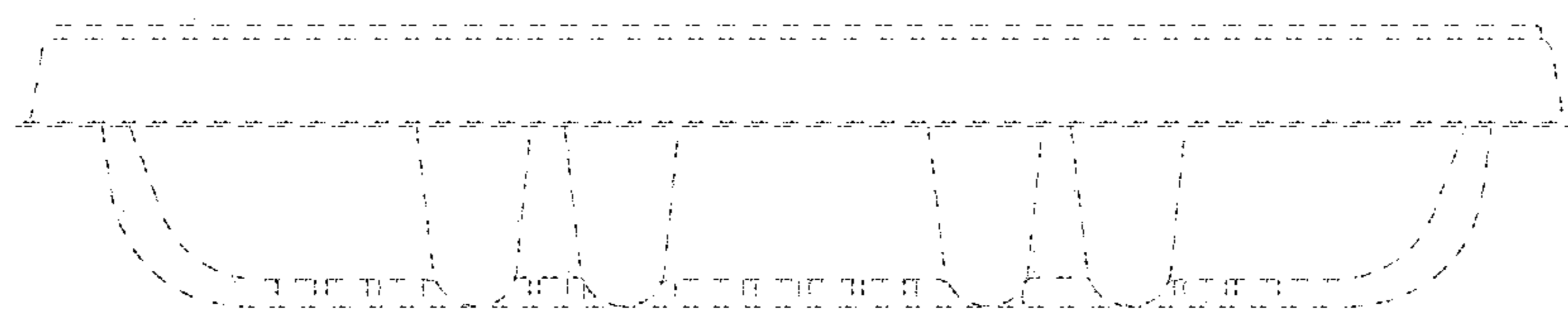

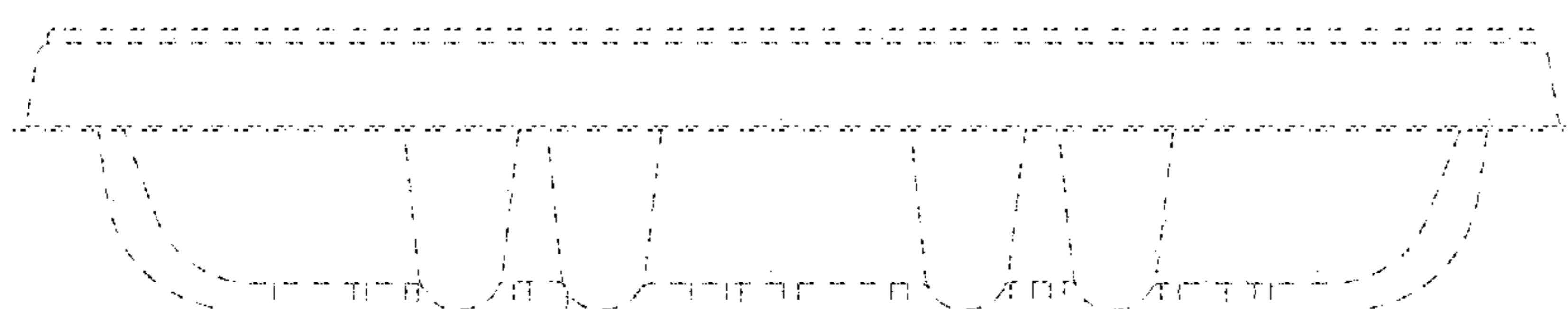

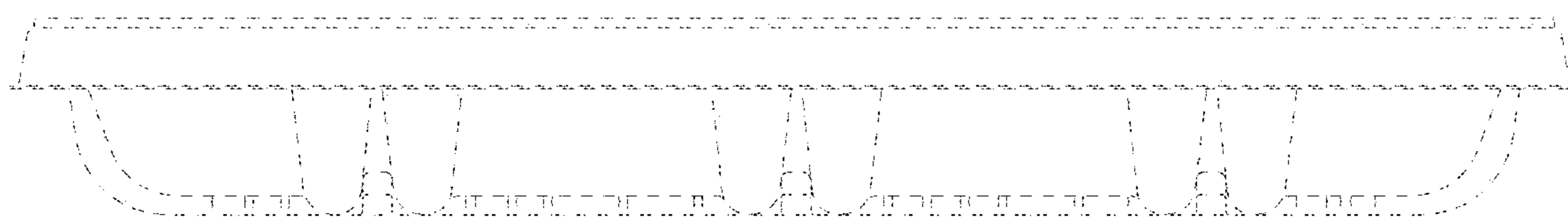

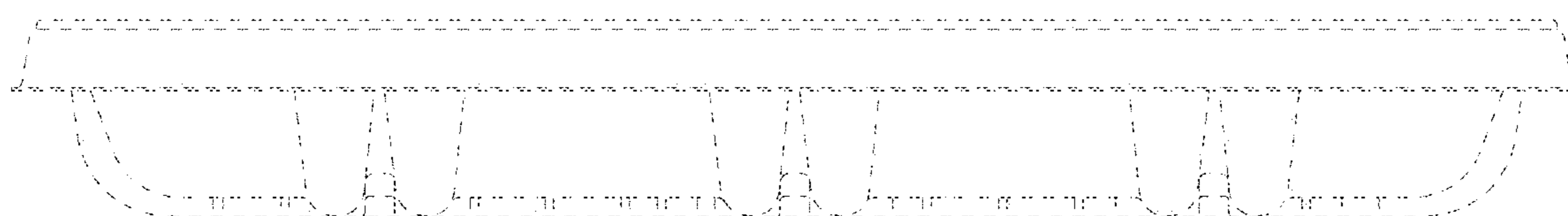

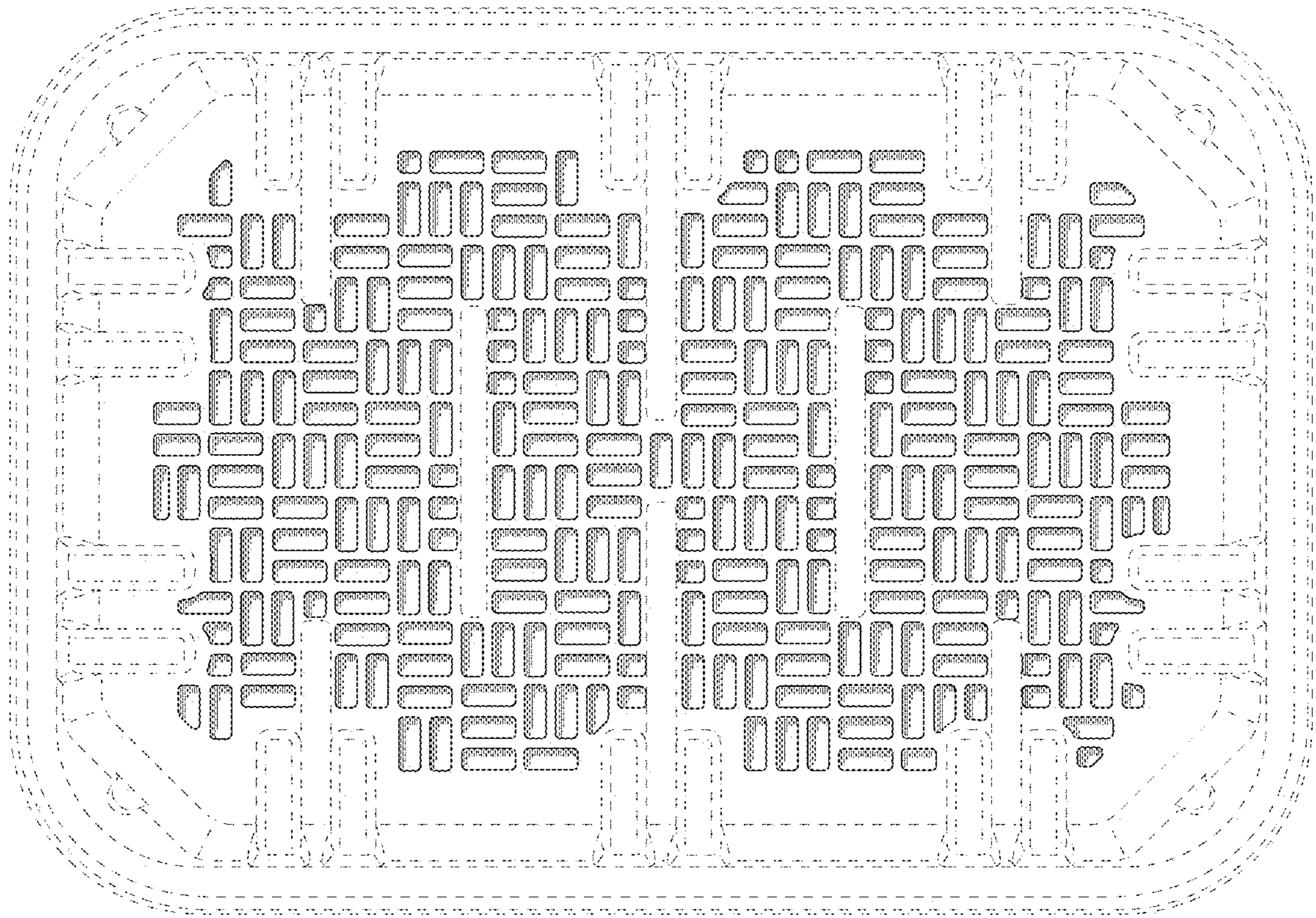

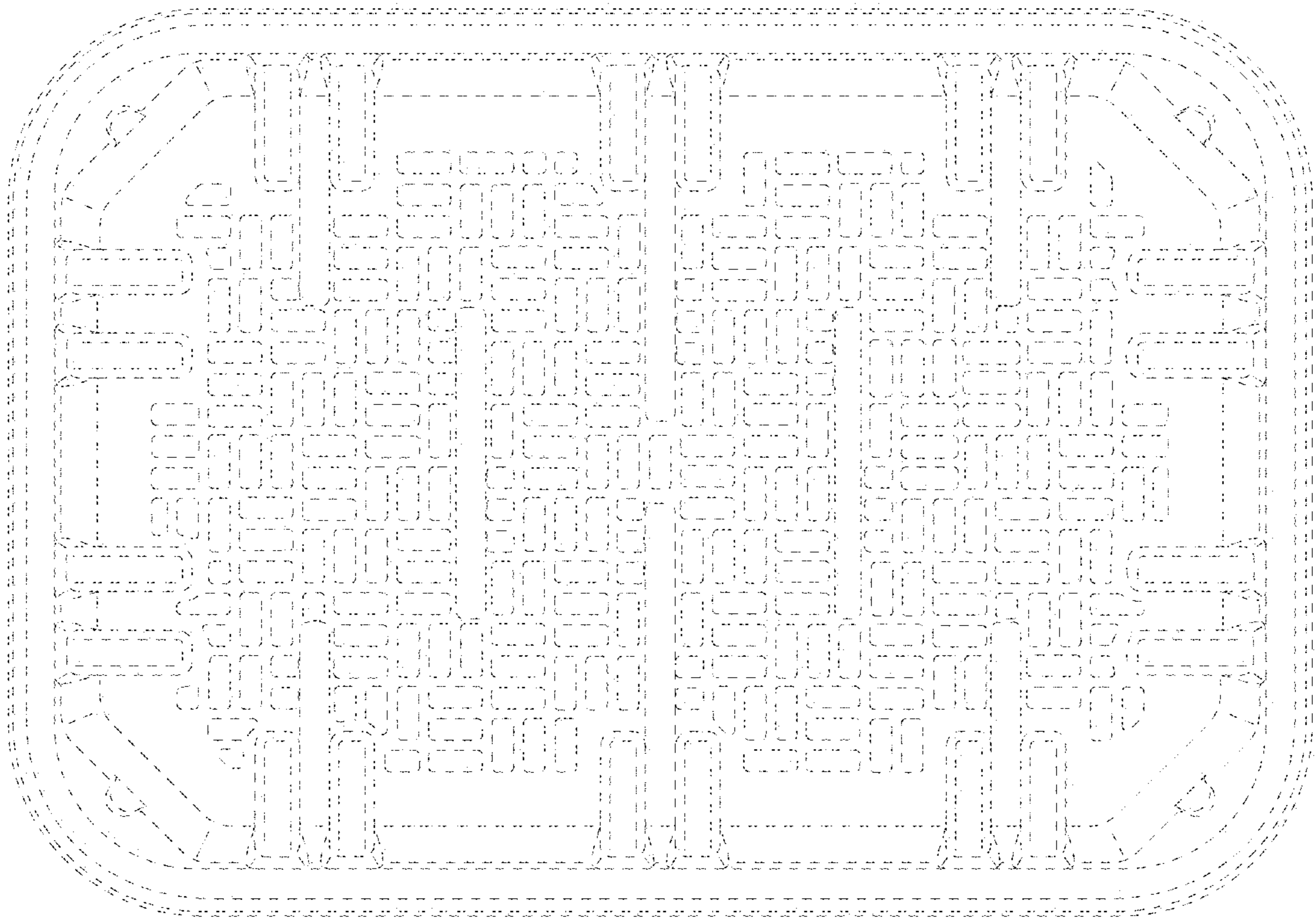
